FIG. 4 is a Front view thereof;

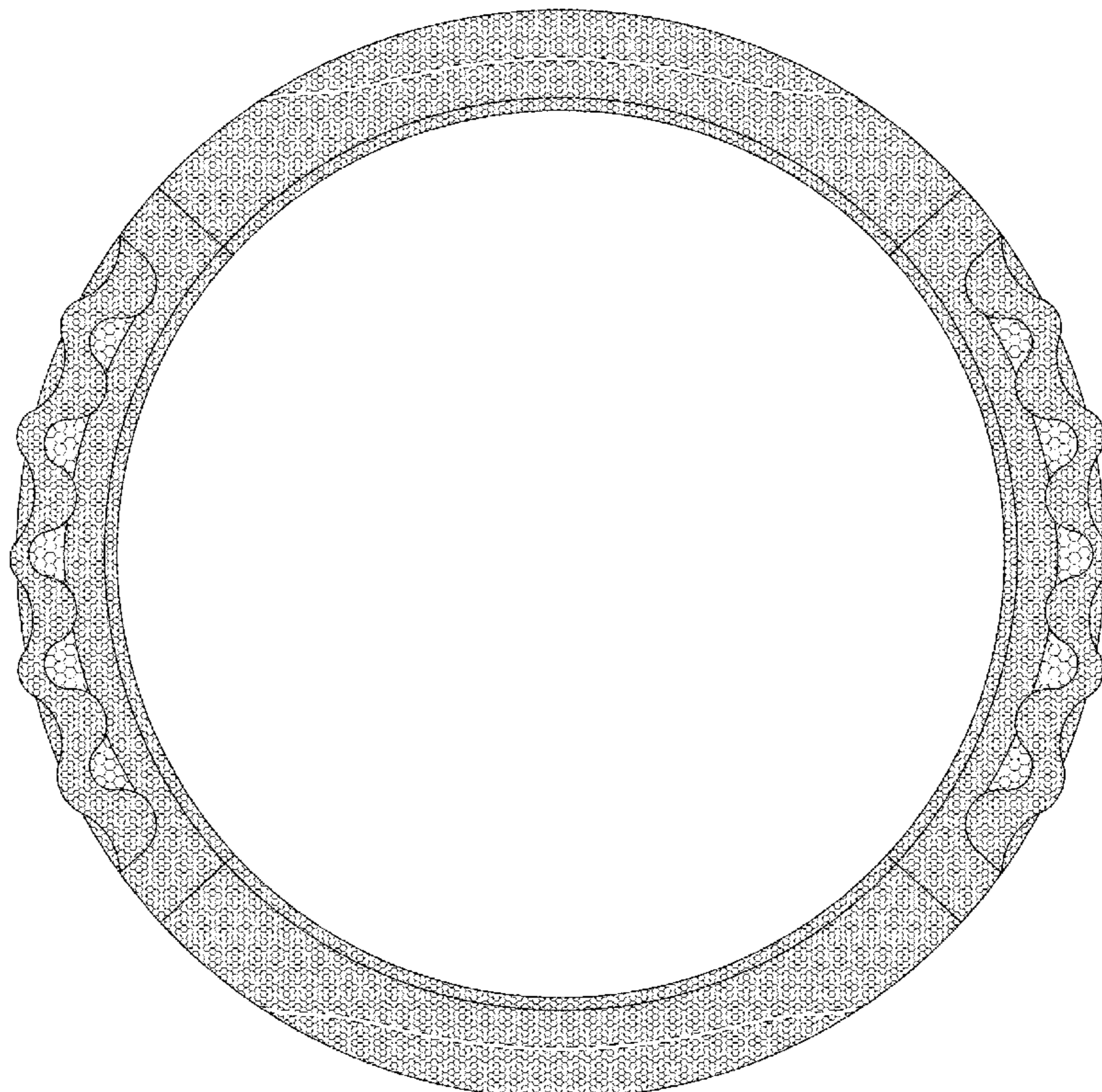
FIG. 5 is a Back view thereof;

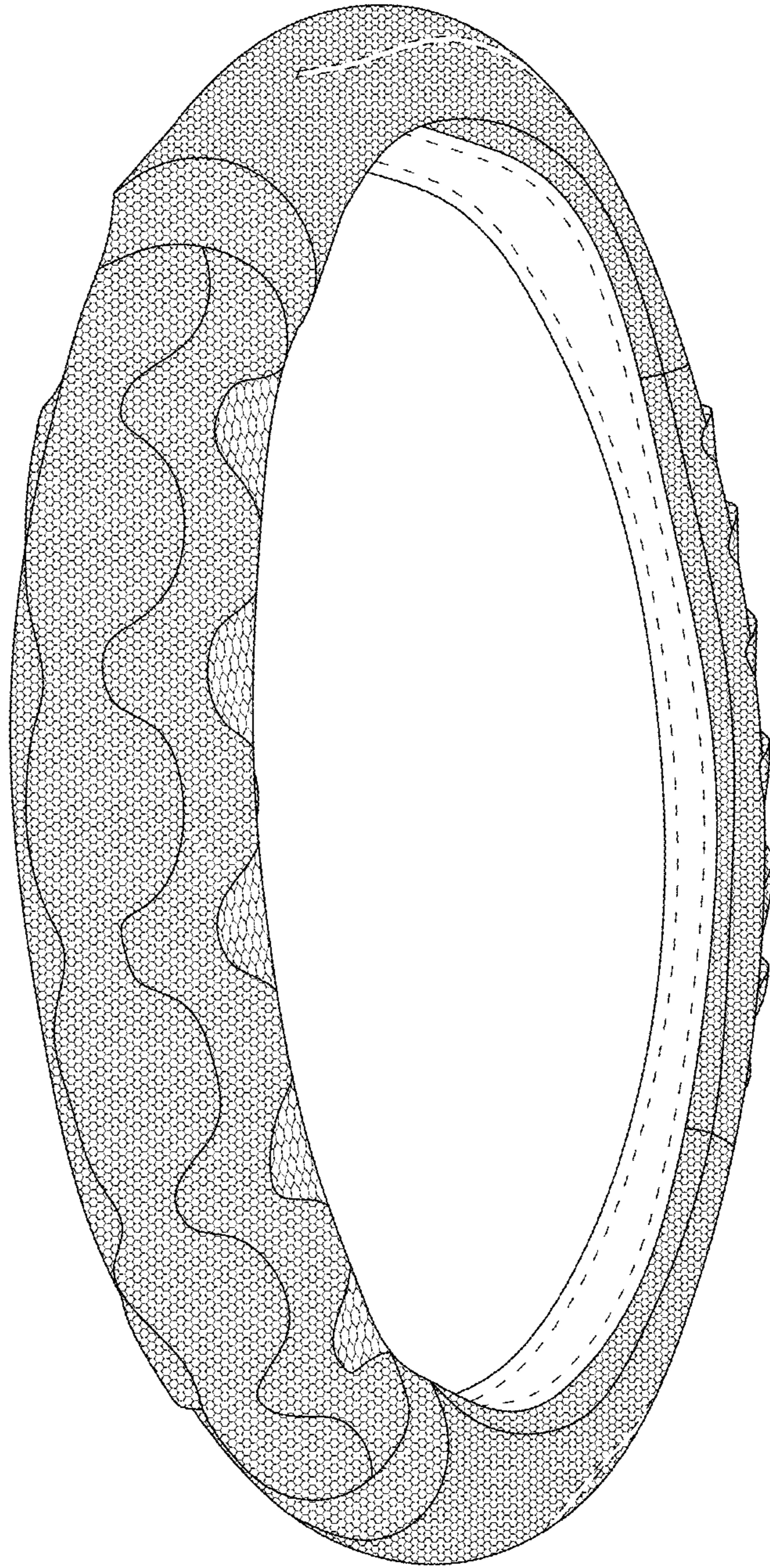

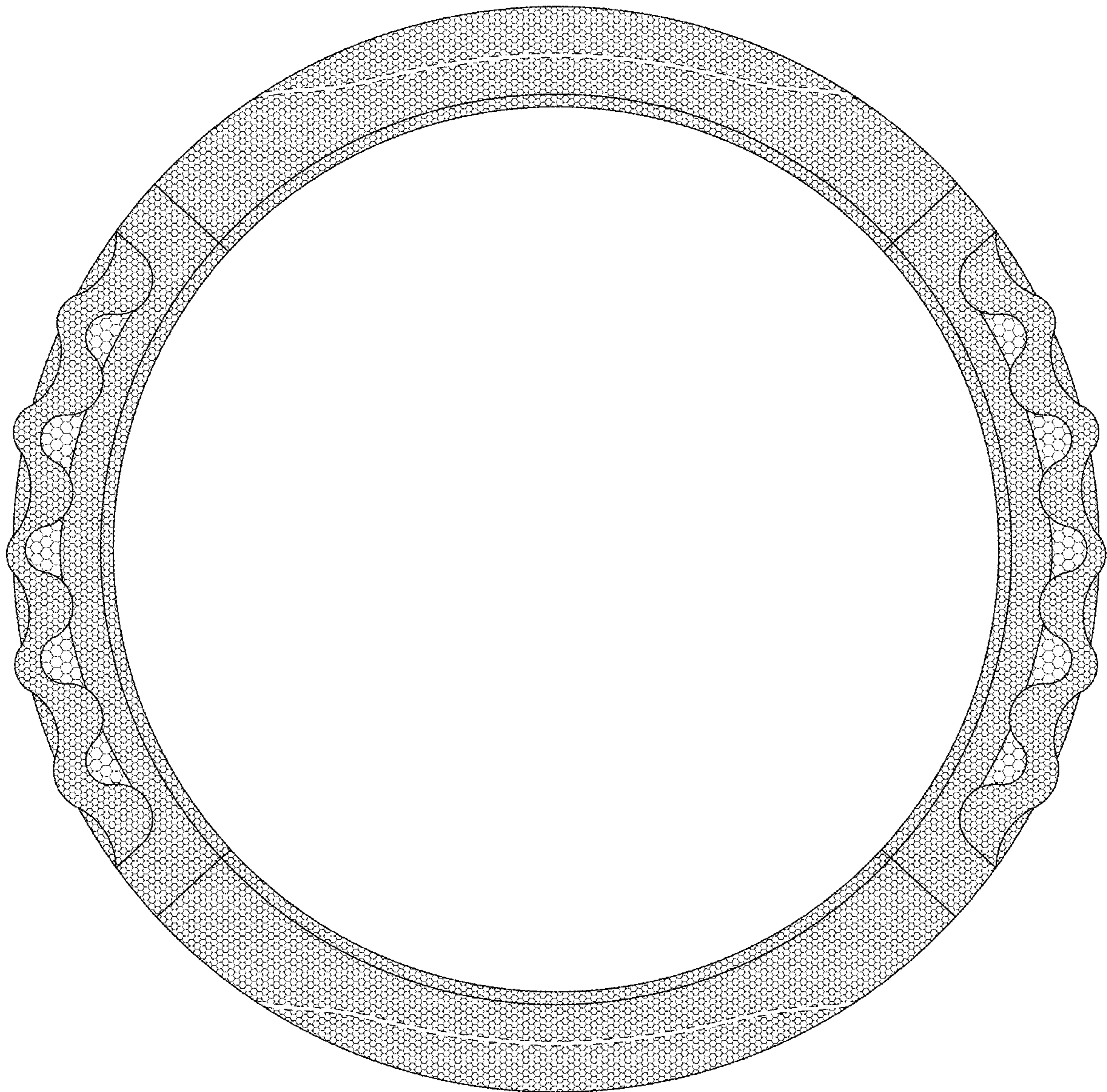

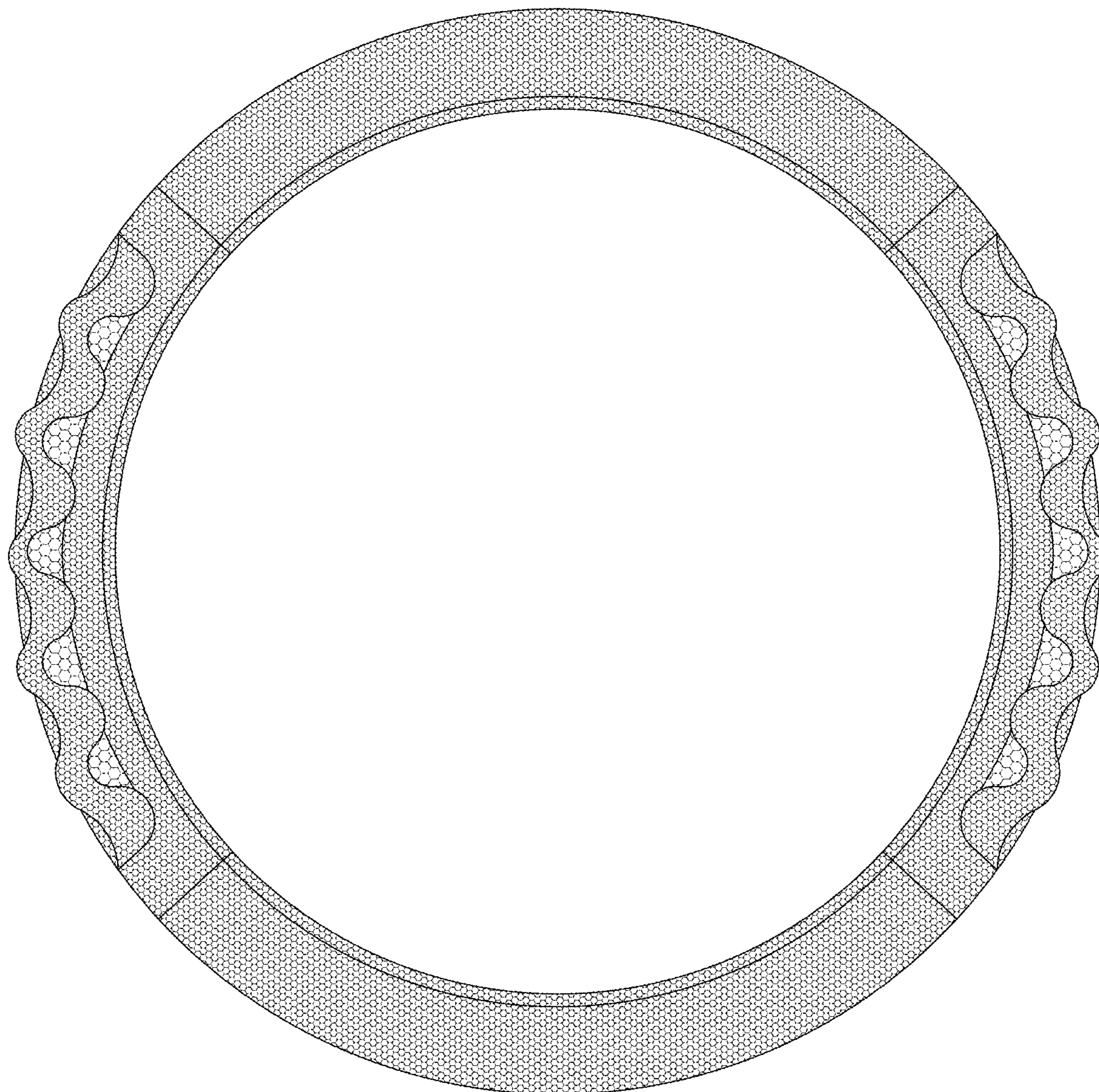

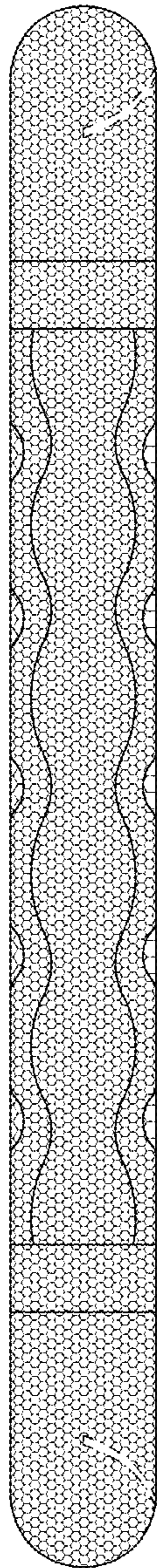

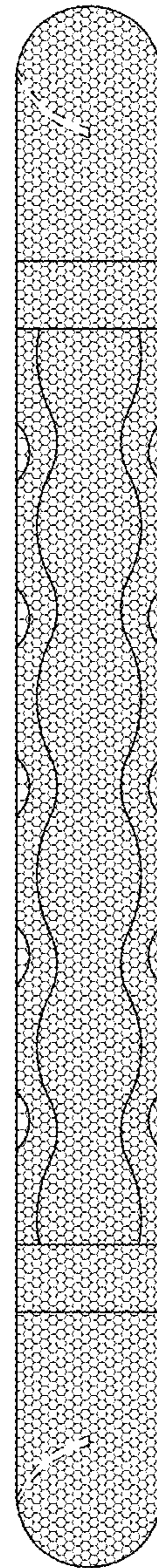

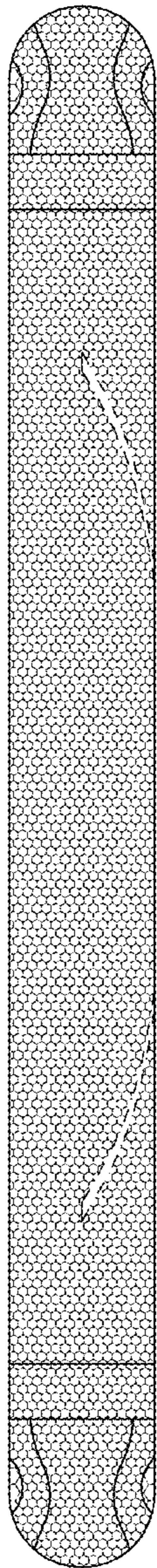

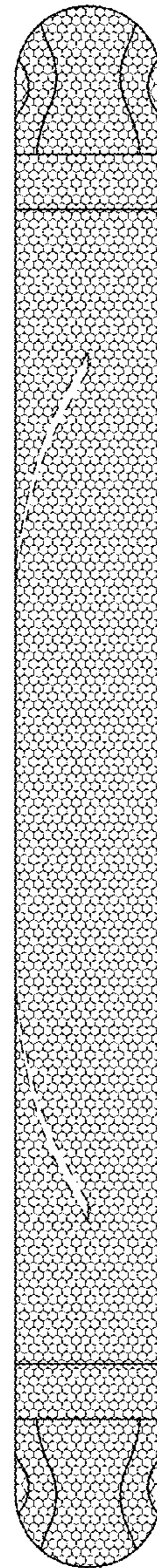
