(57) **CLAIM**

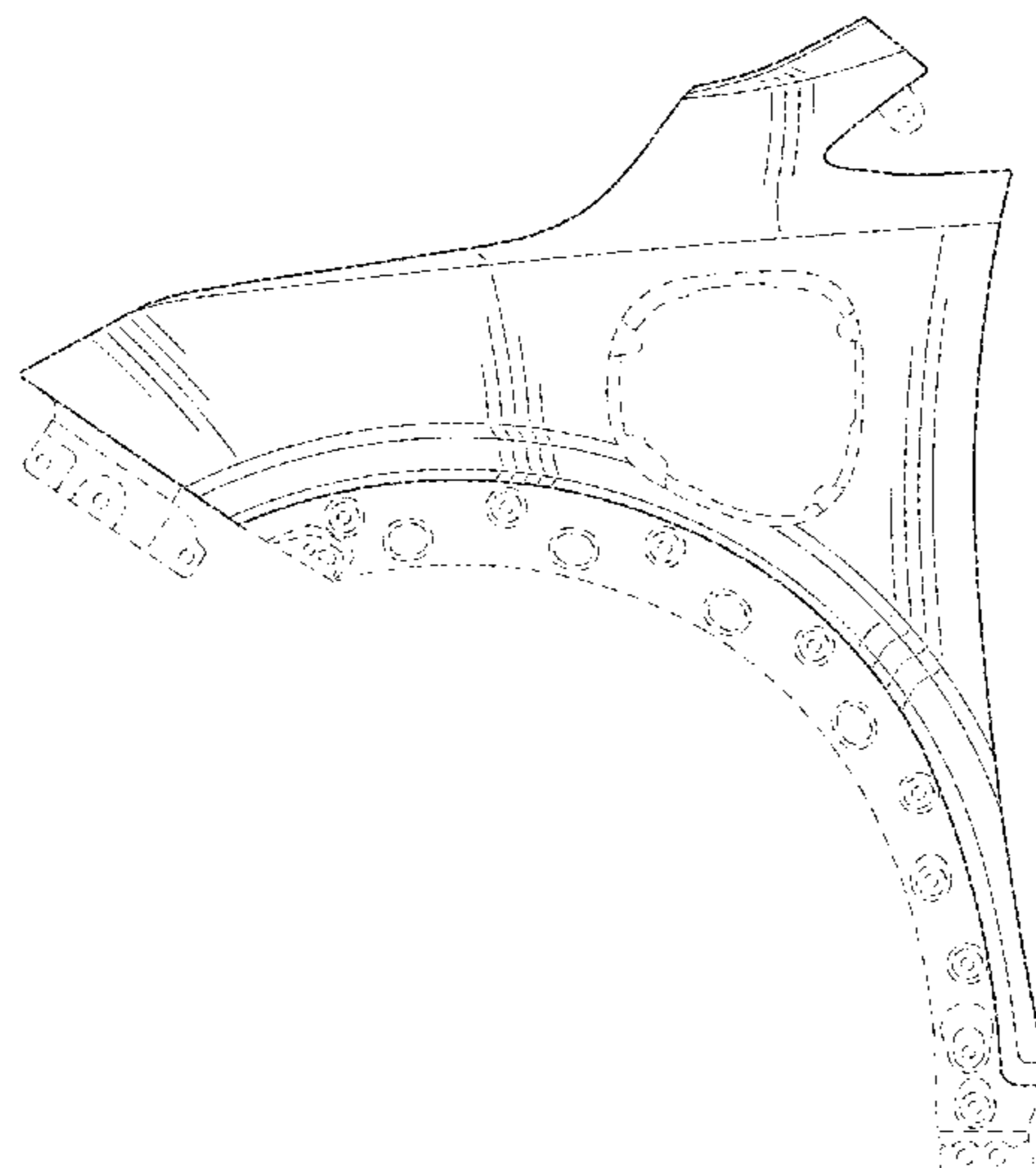
The ornamental design for a vehicle fender, as shown and described.

**DESCRIPTION**

FIG. 1 is a front and left perspective view of a vehicle fender showing our new design; a vehicle fender that is the mirror image of FIGS. 1-7 is also claimed, but not shown; FIG. 2 is a front elevation view of the vehicle fender of FIG. 1; FIG. 3 is a left elevation view thereof; FIG. 4 is a right elevation view thereof; FIG. 5 is a top view thereof; FIG. 6 is a back elevation view thereof; and, FIG. 7 is a bottom view thereof.

The broken lines in the drawings depict portions of the vehicle fender that form no part of the claimed design.

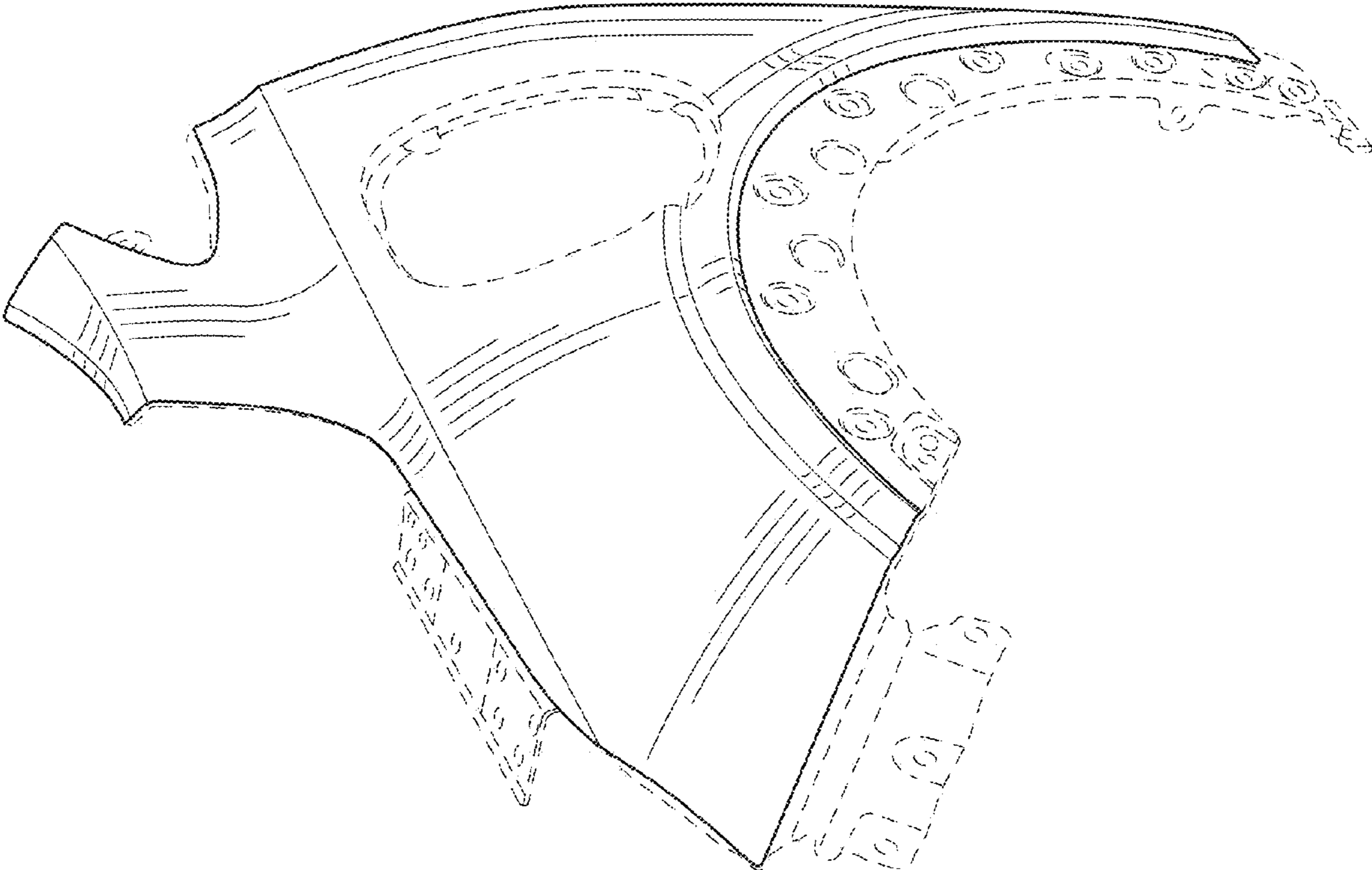
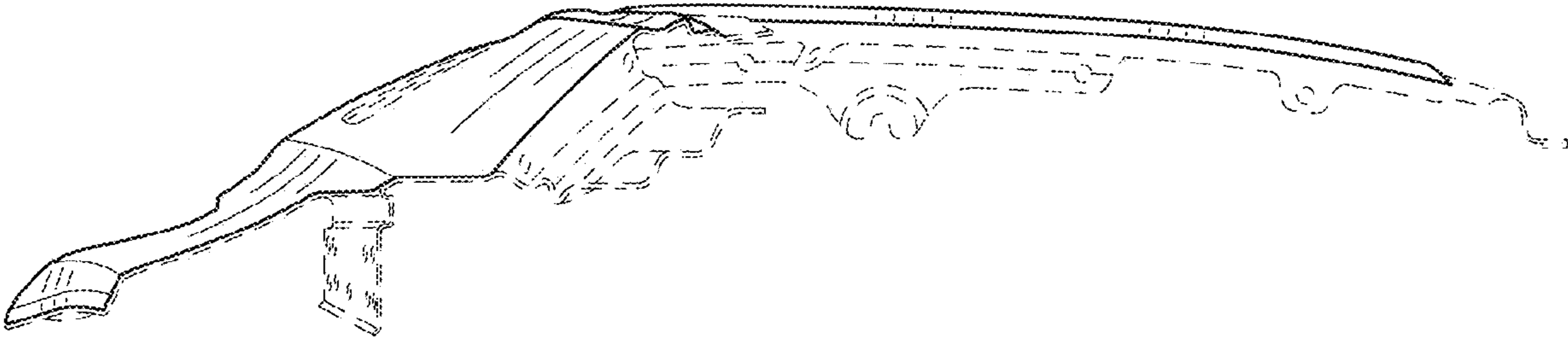

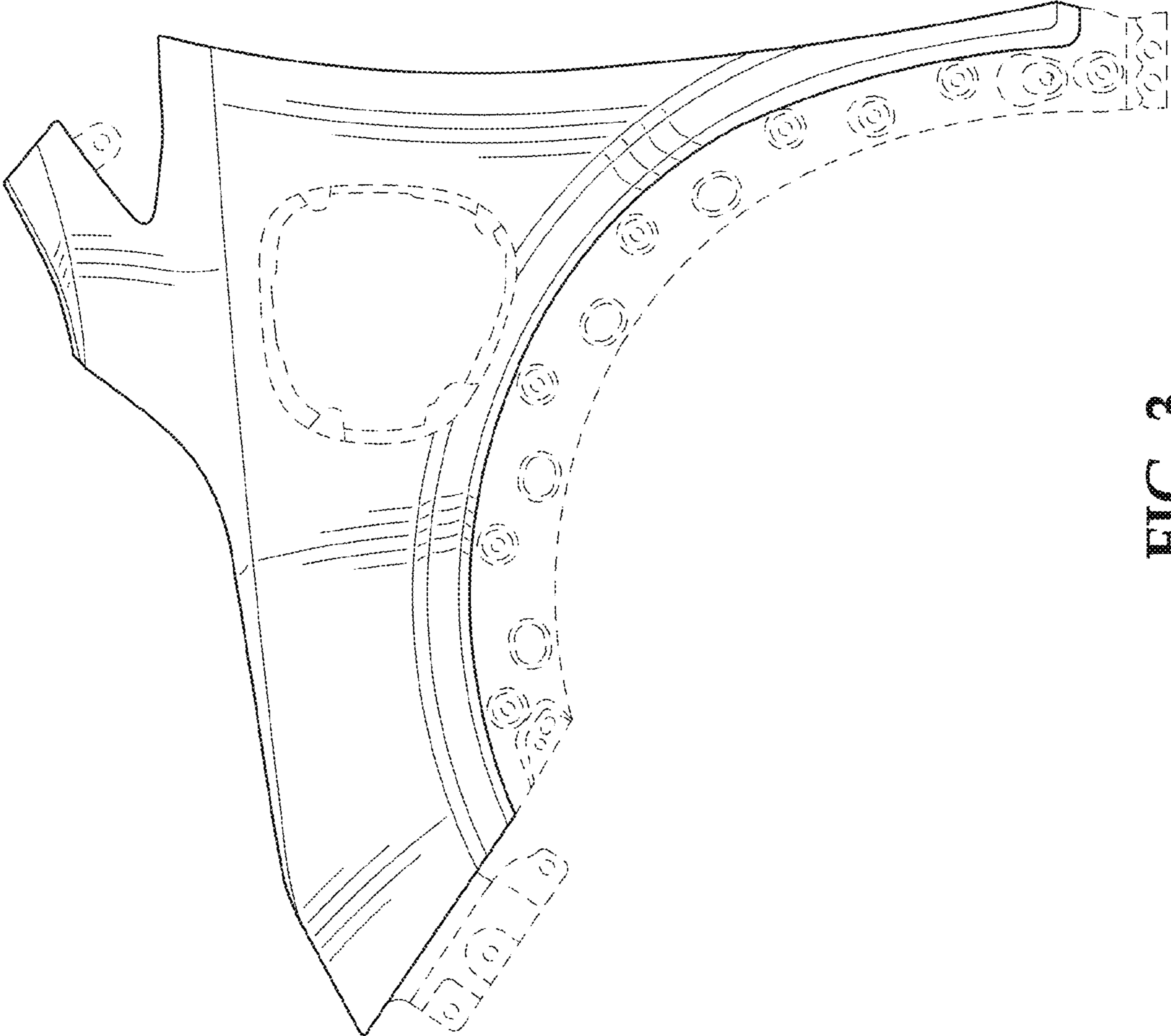

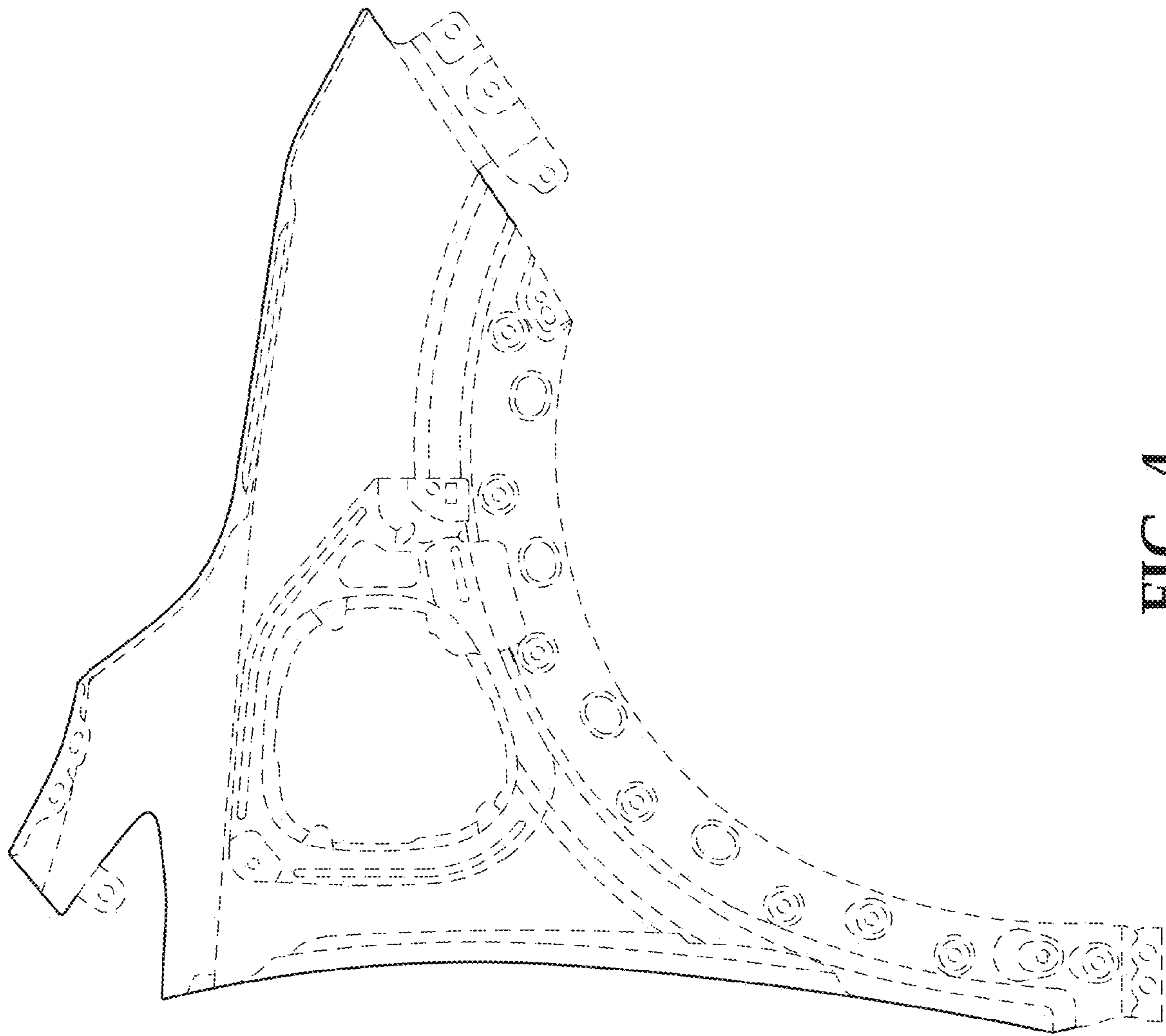

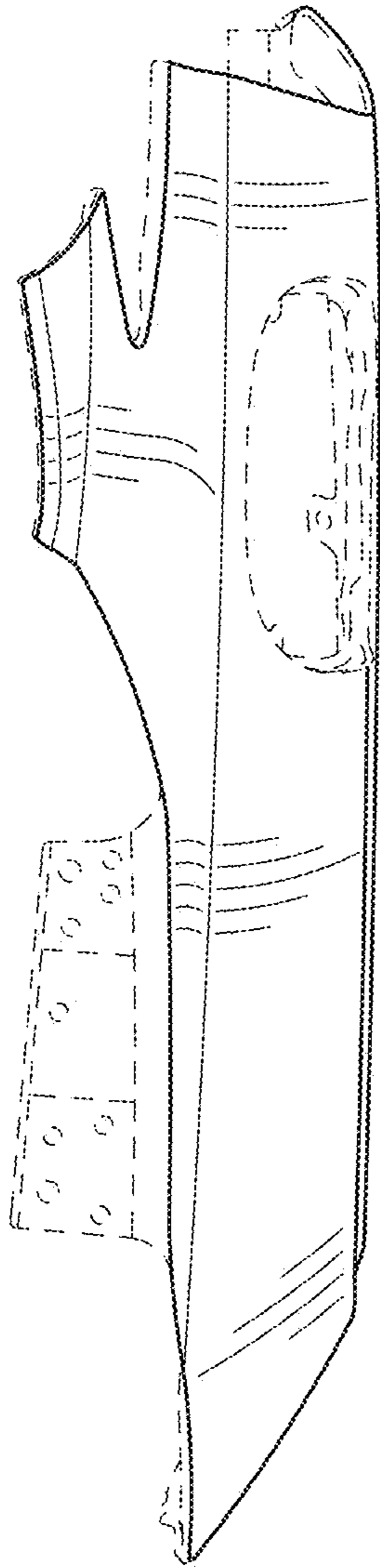
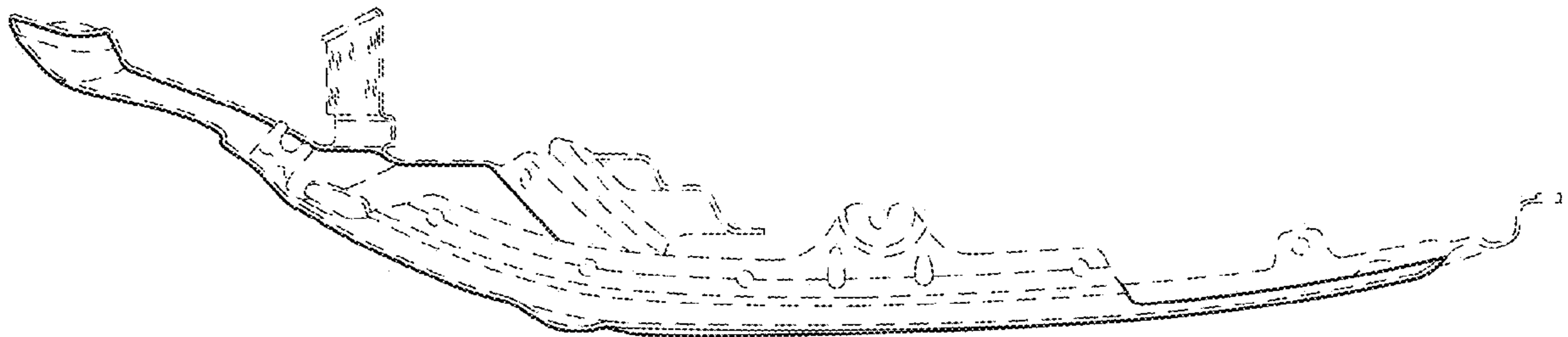

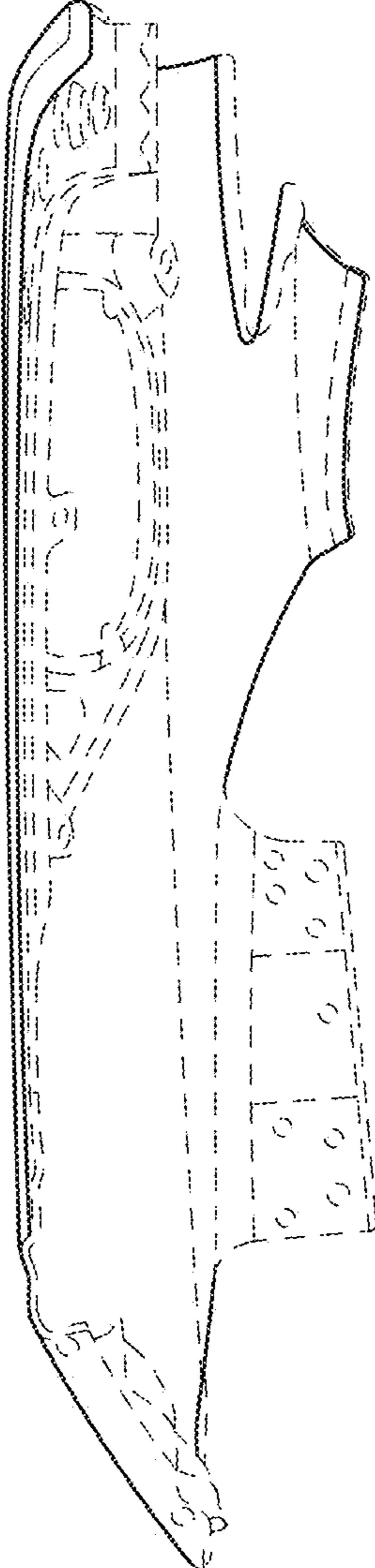
