(57) **CLAIM**

The ornamental design for a router, as shown and described.

DESCRIPTION

1. Router

FIG. 1.1 is a front elevation view of a router showing our new design;

FIG. 1.2 is a back elevation view thereof;

FIG. 1.4 is a right side elevation view thereof;

FIG. 1.5 is a top plan view thereof;

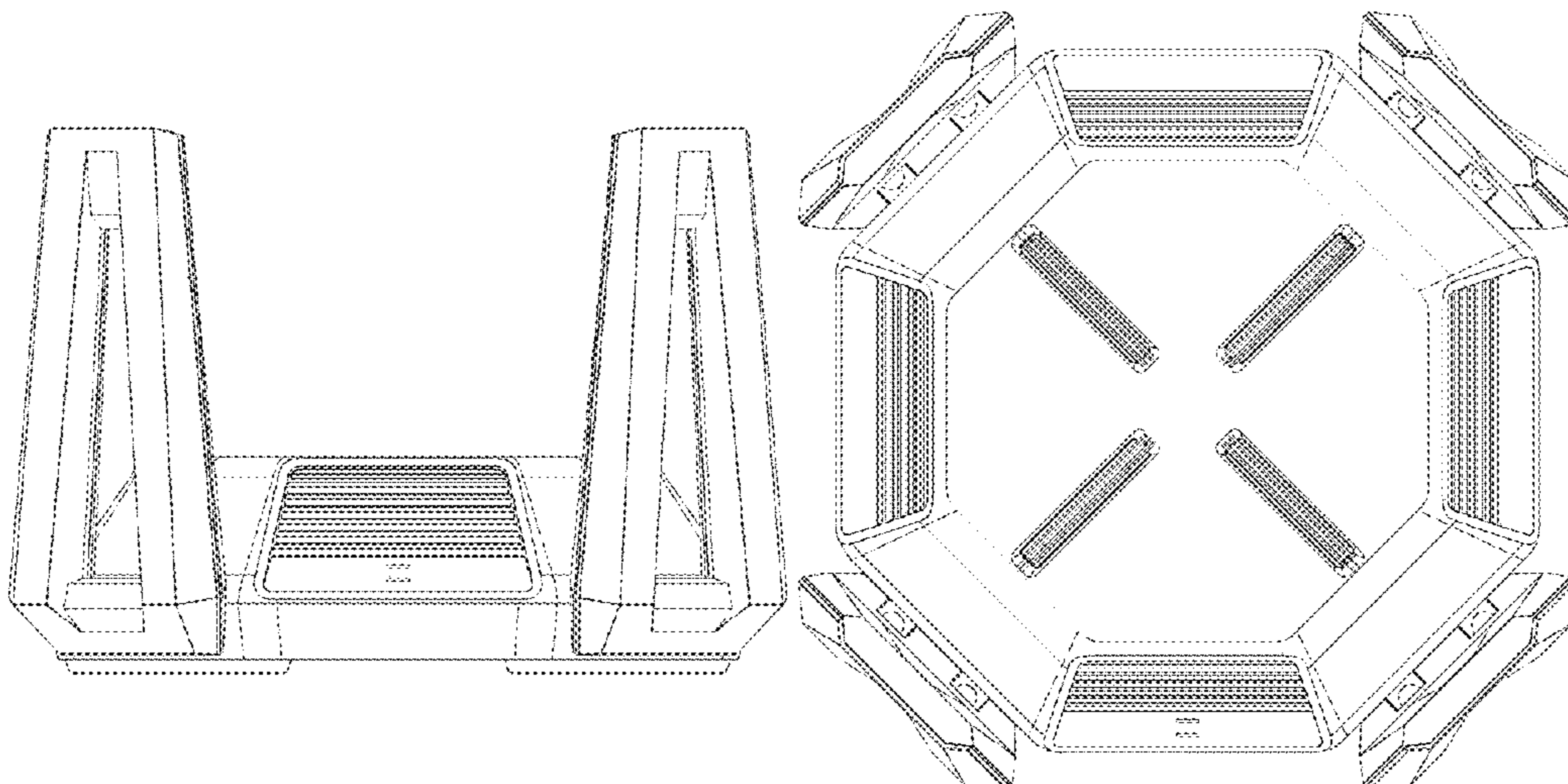
FIG. 1.6 is a bottom plan view thereof;

FIG. 1.7 is a top perspective view thereof; and

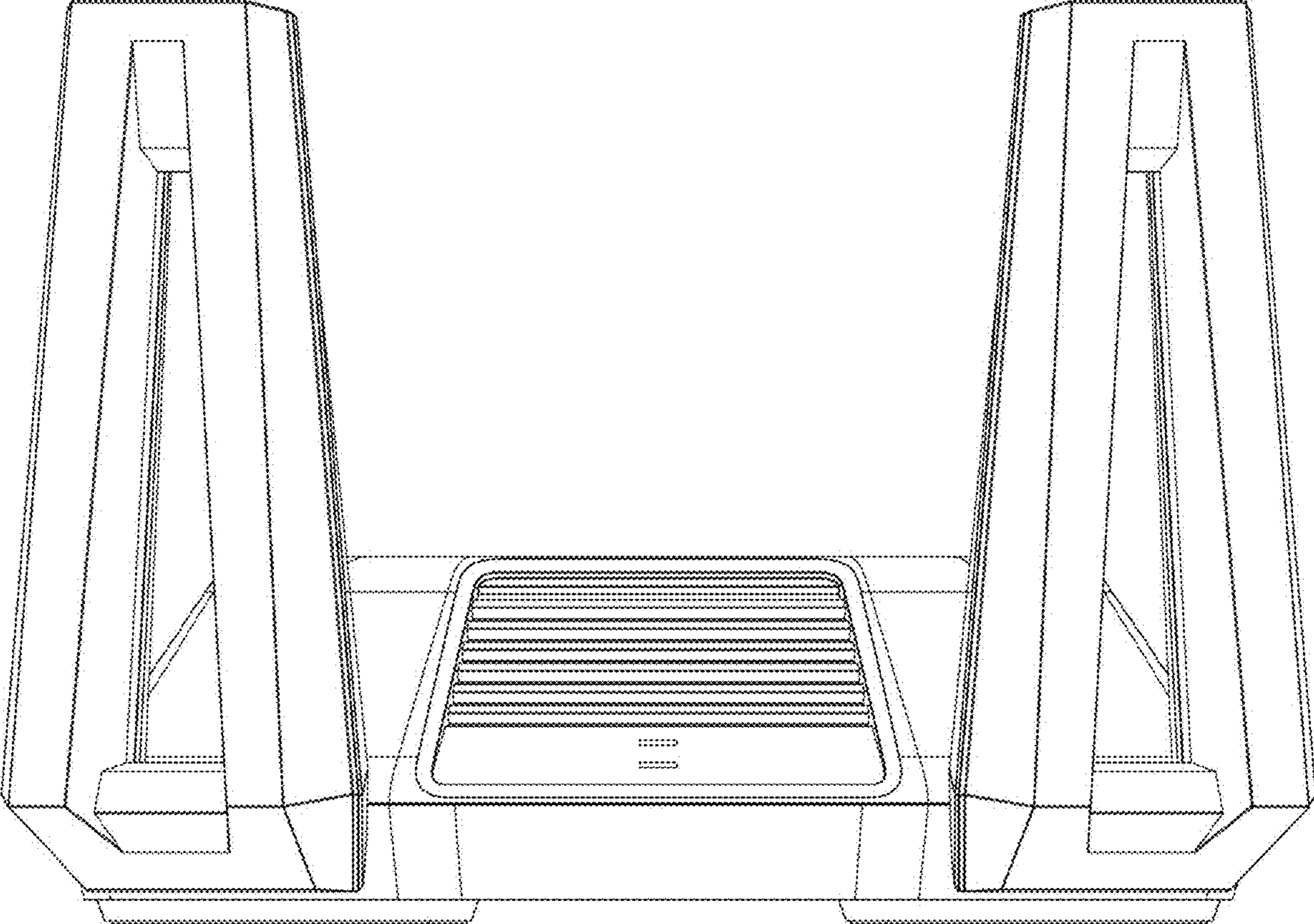
FIG. 1.8 is a bottom perspective view thereof.

The product consists of an octagonal conical platform body and four rectangular ring antennas; four antennas are mounted on four sides of the body at intervals; on the top surface of the body, there are four cross distributed rectangular heat sinks.

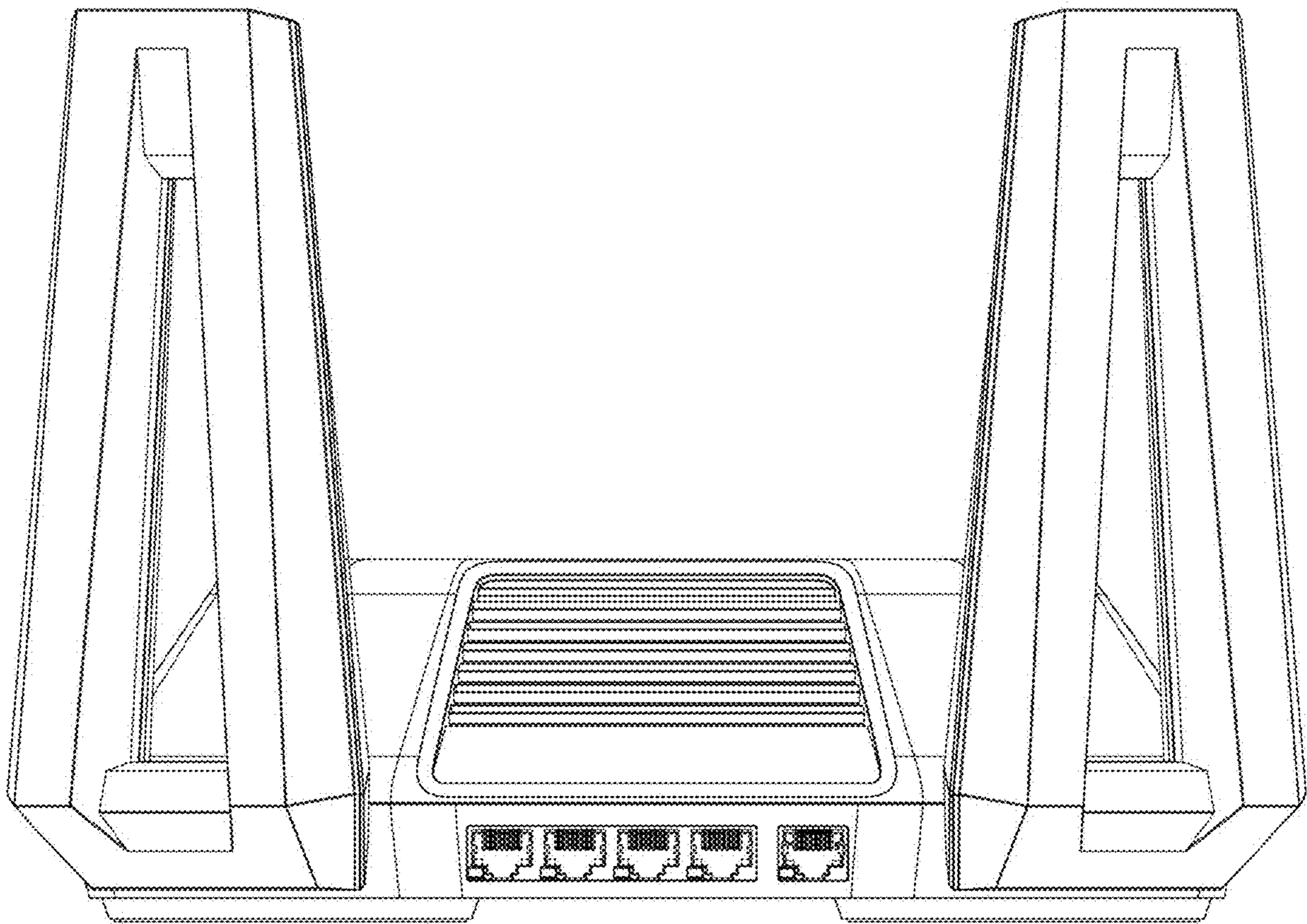

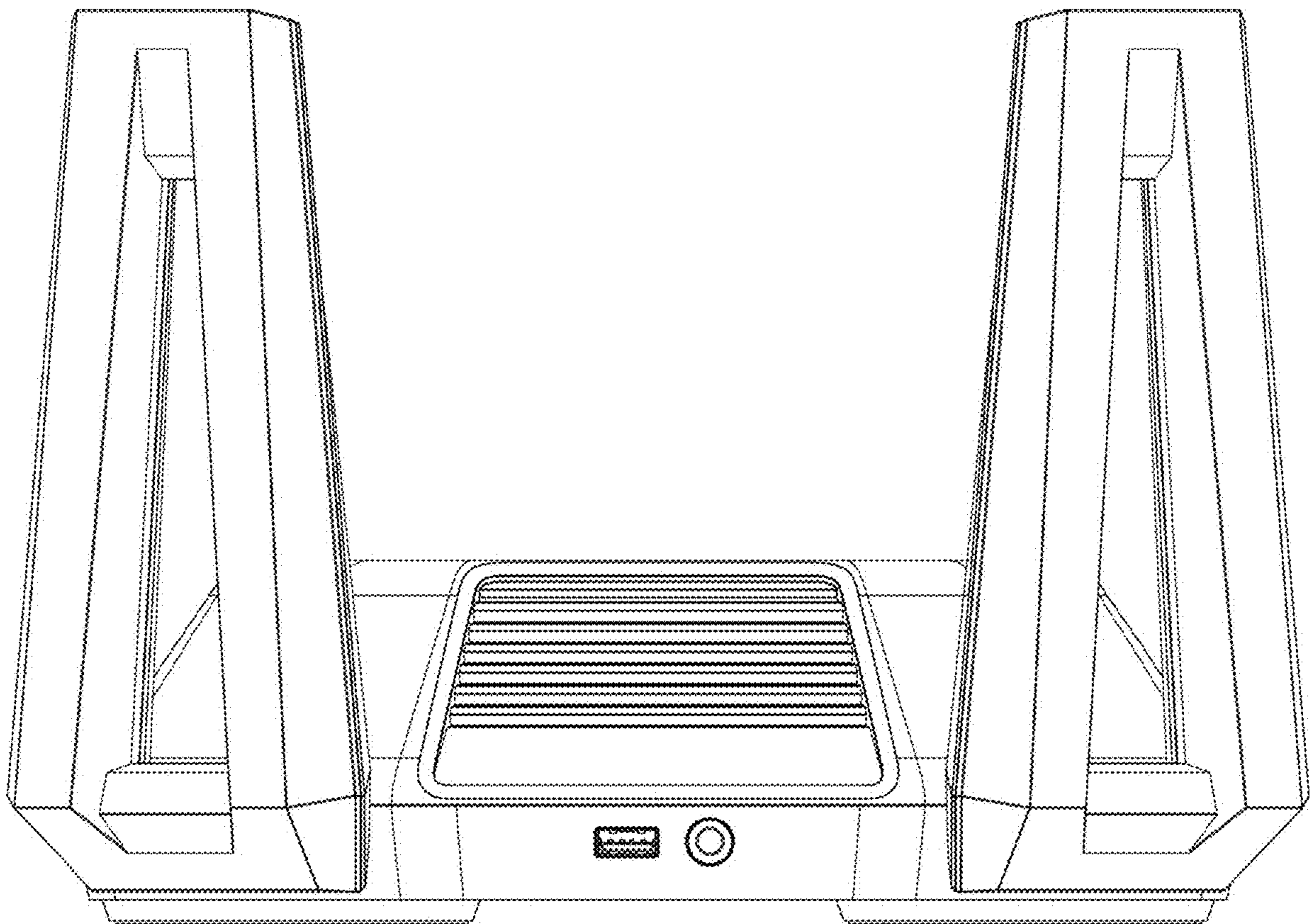

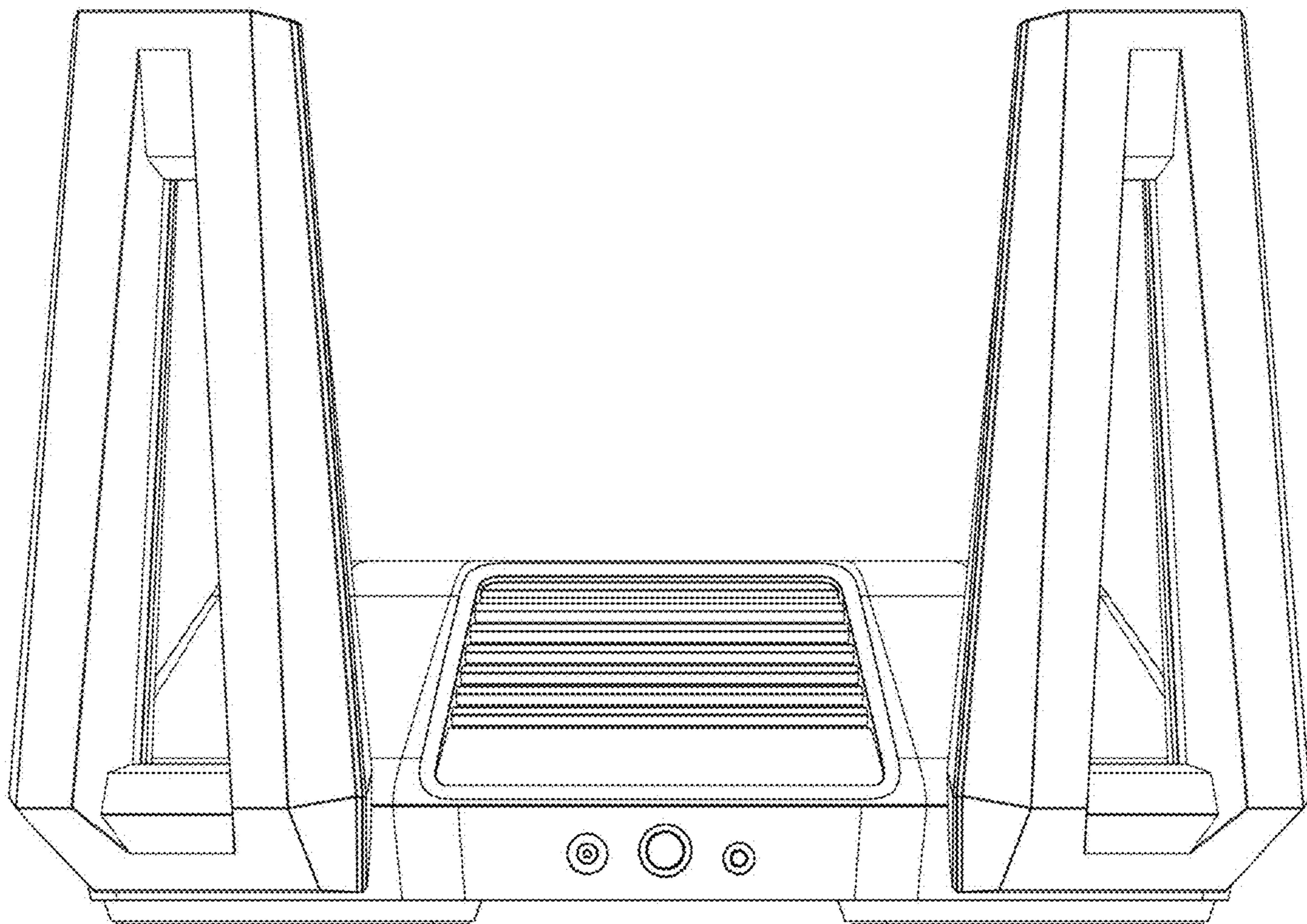

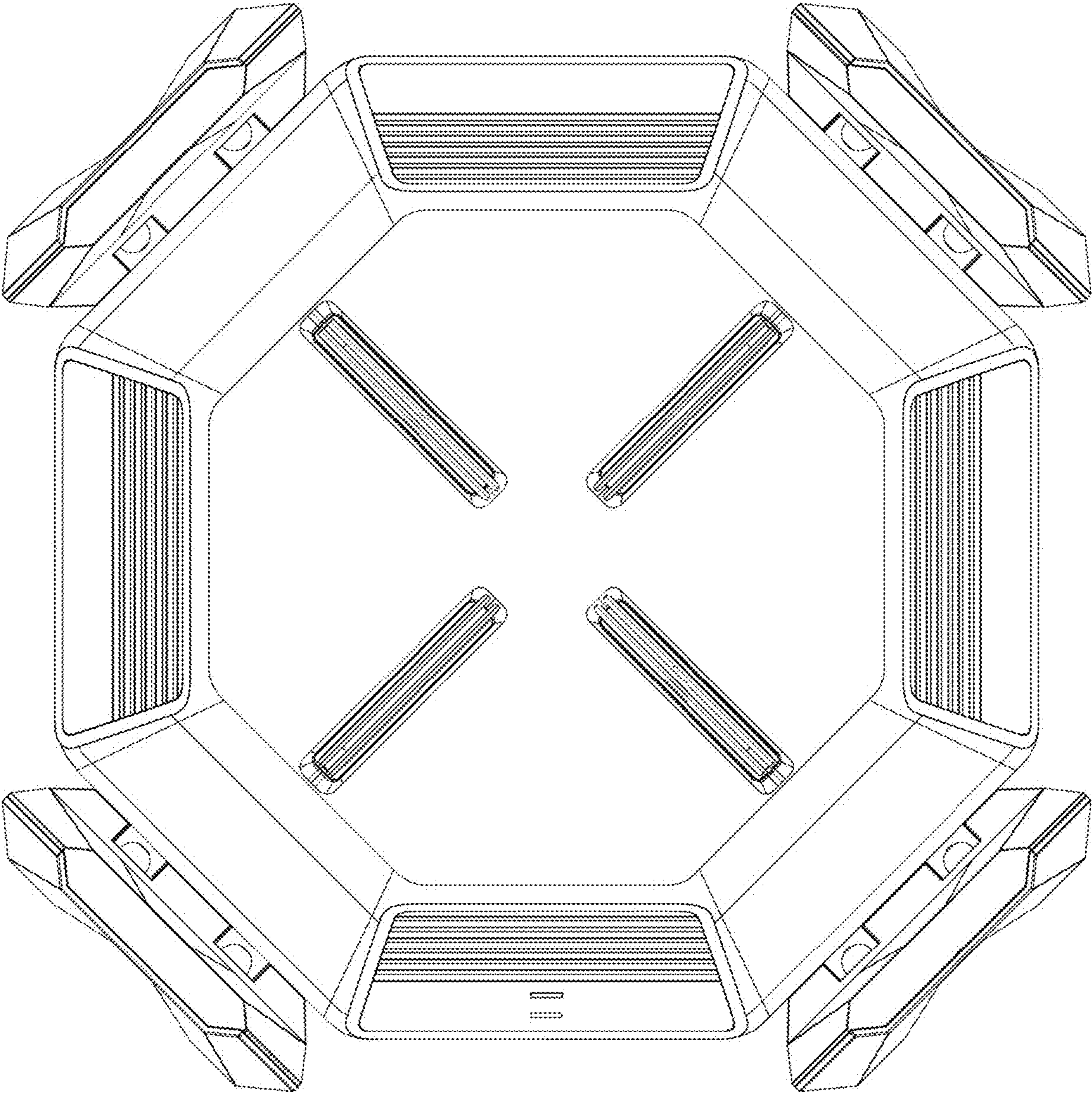

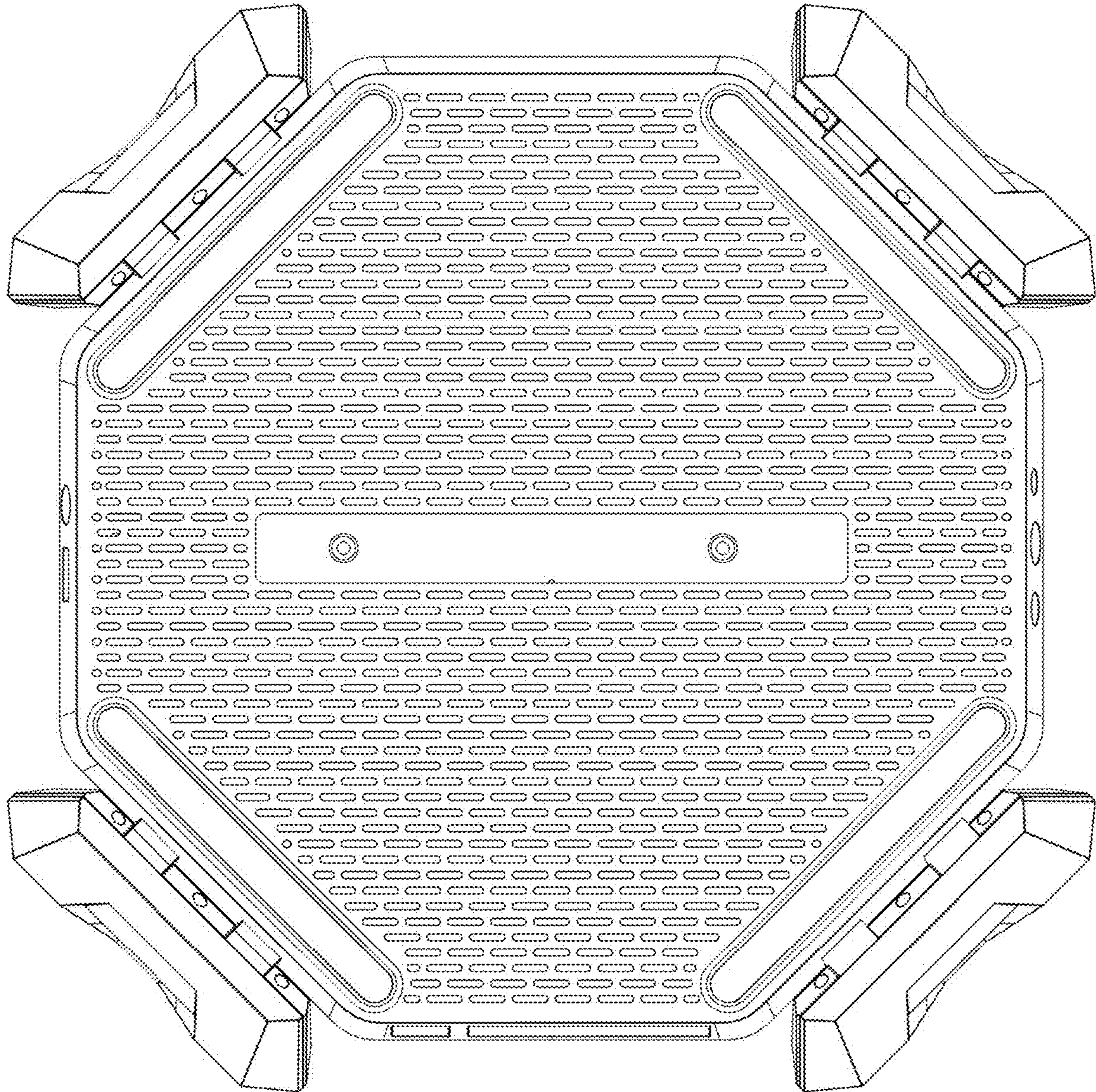

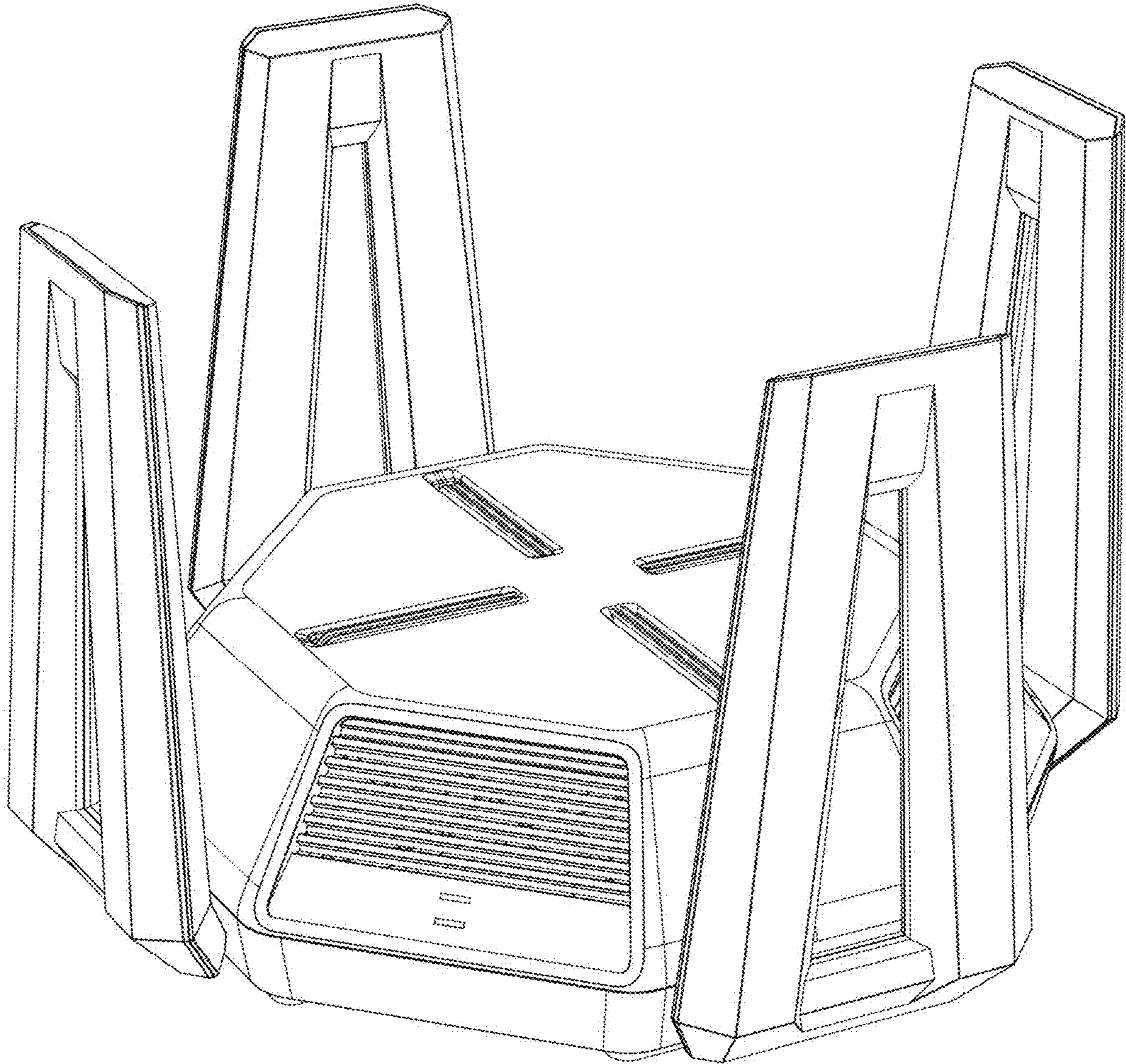
