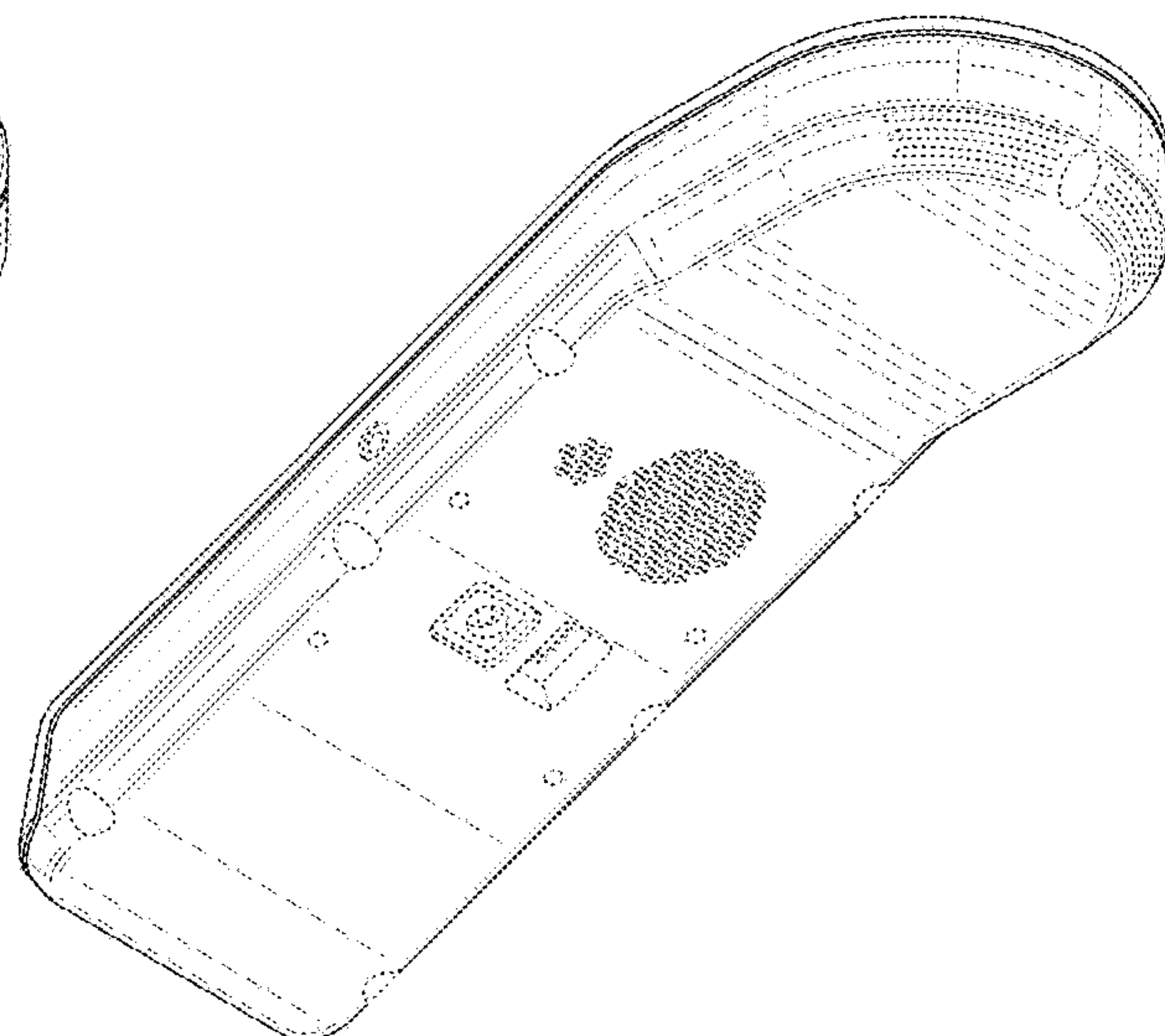
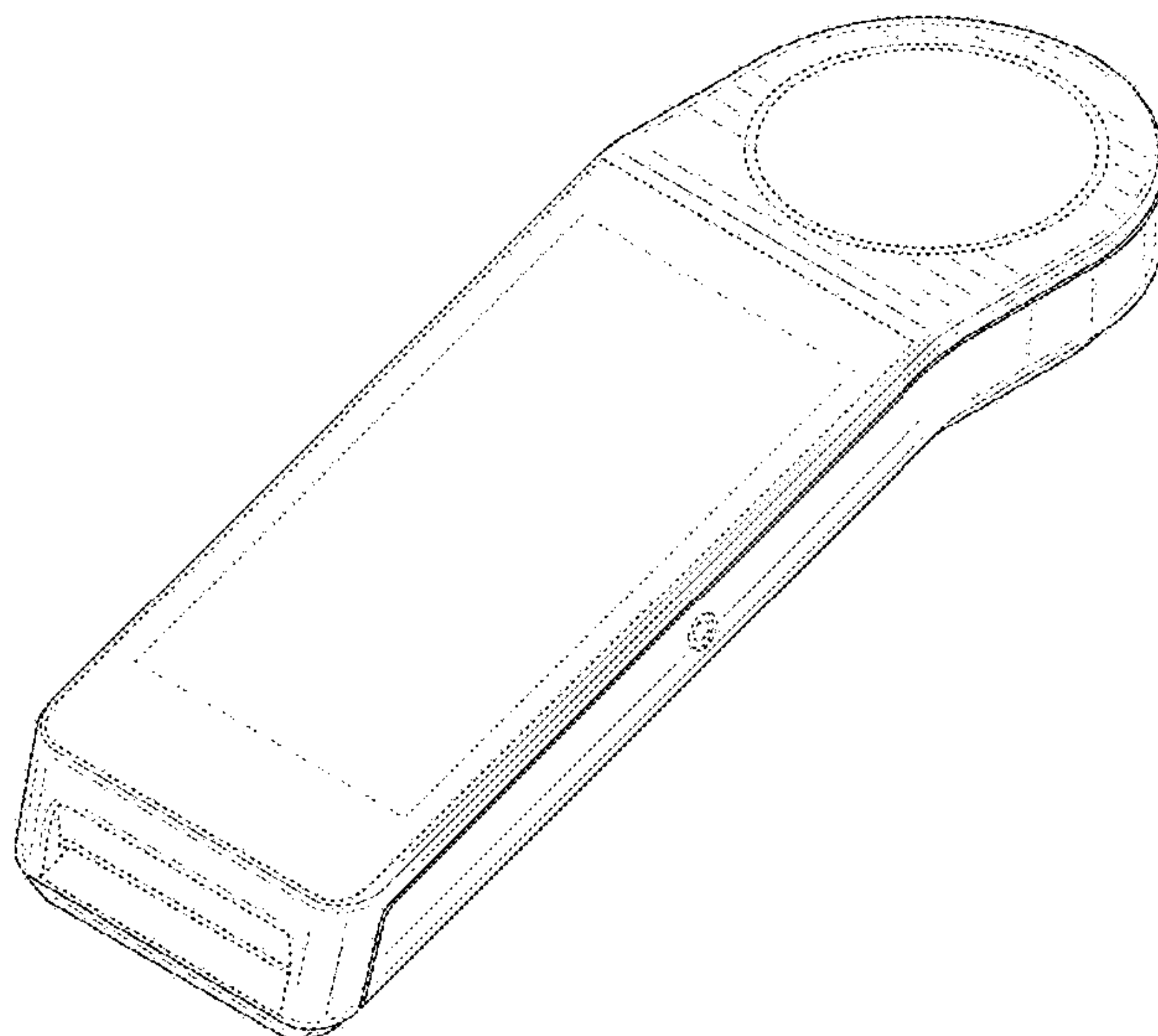
The ornamental design for a user recognition device, as shown and described.

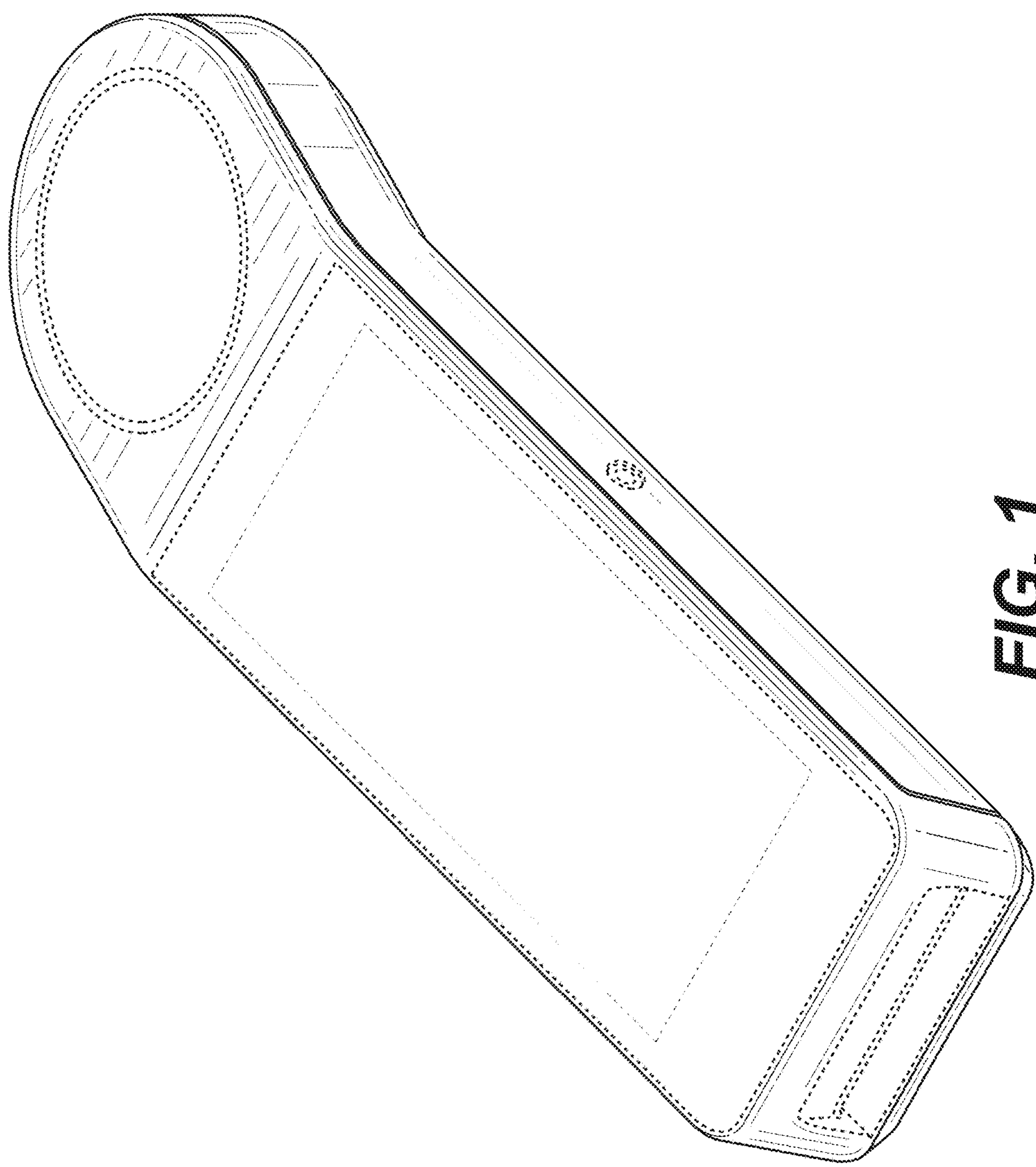

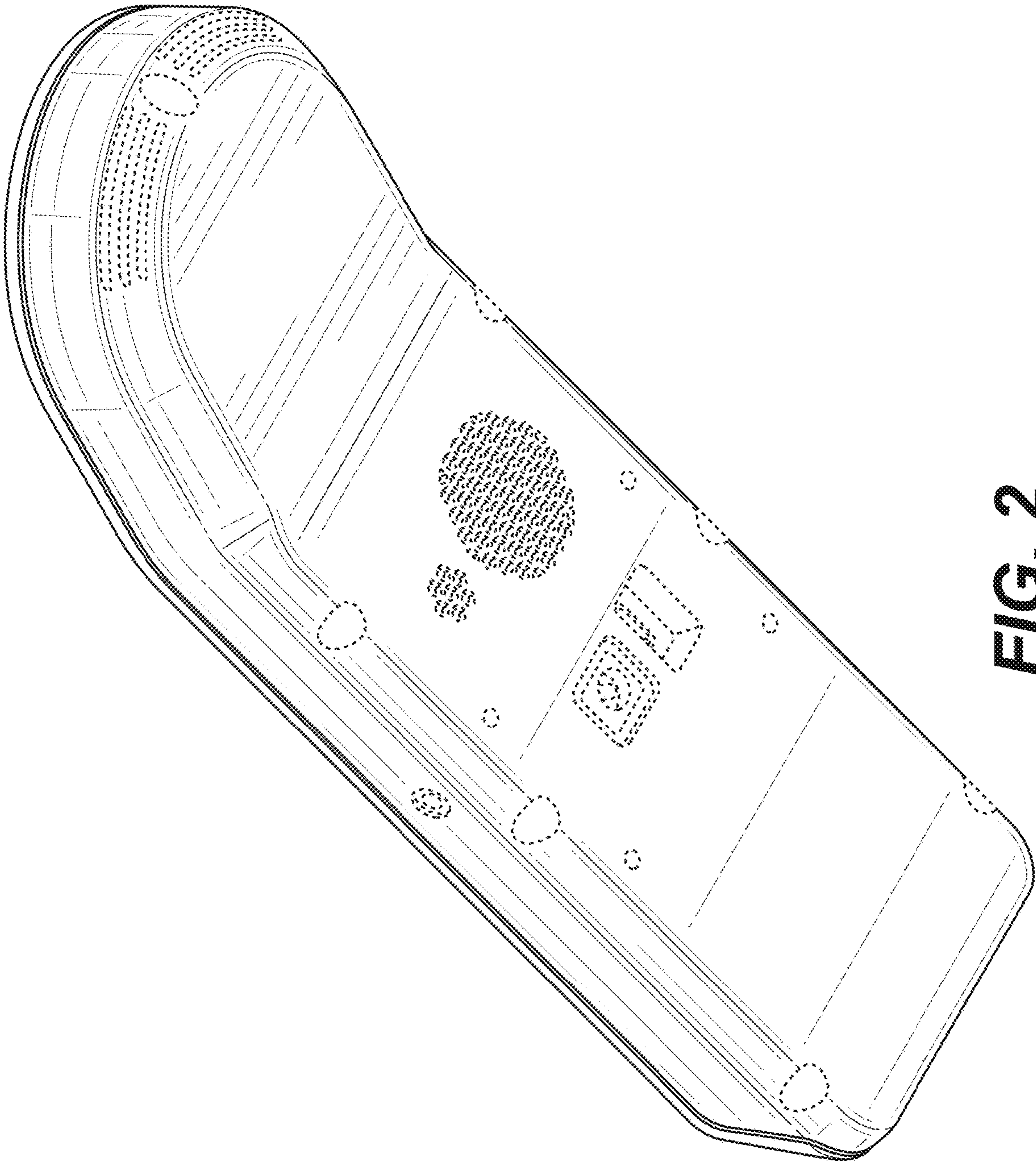

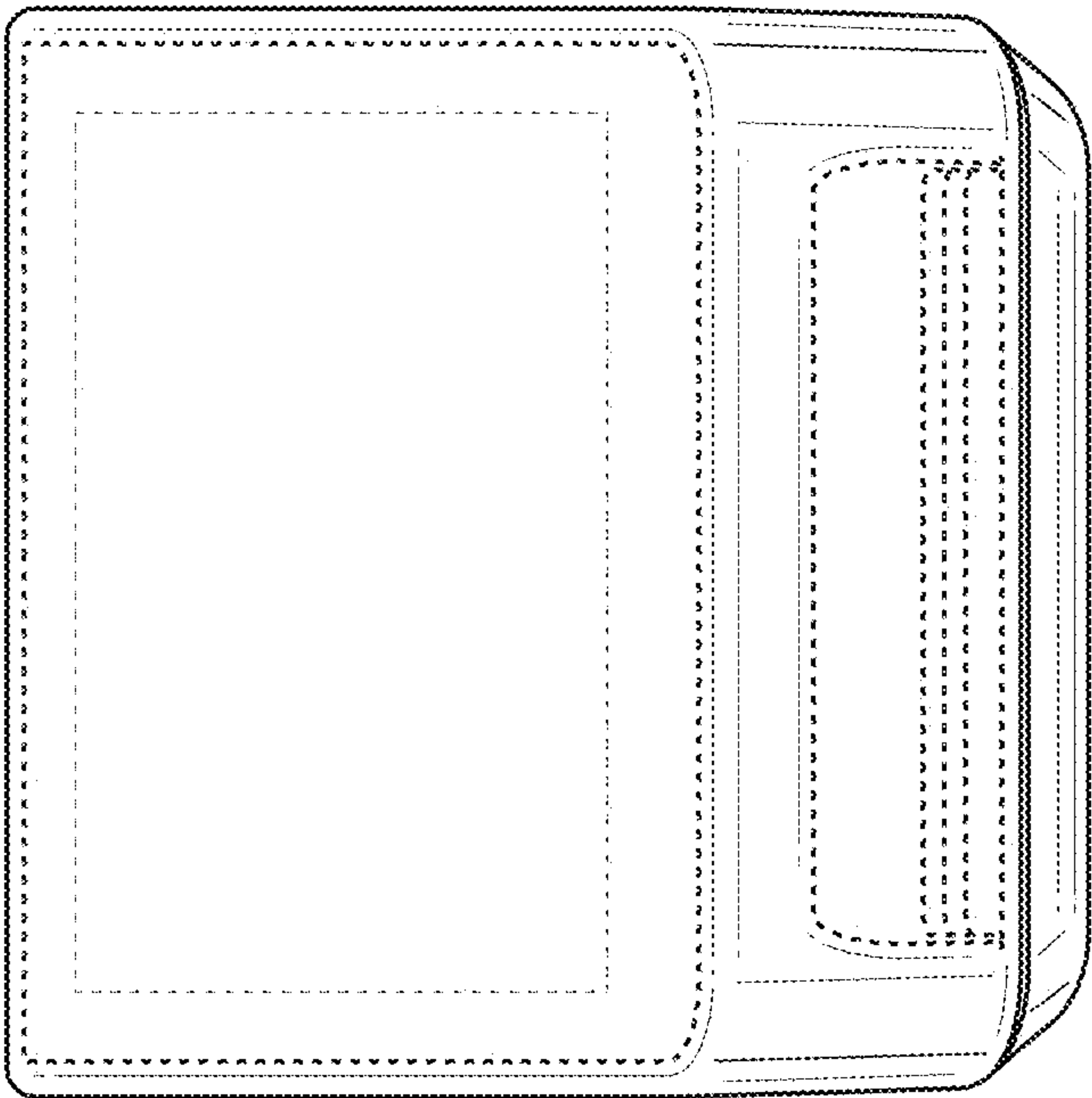

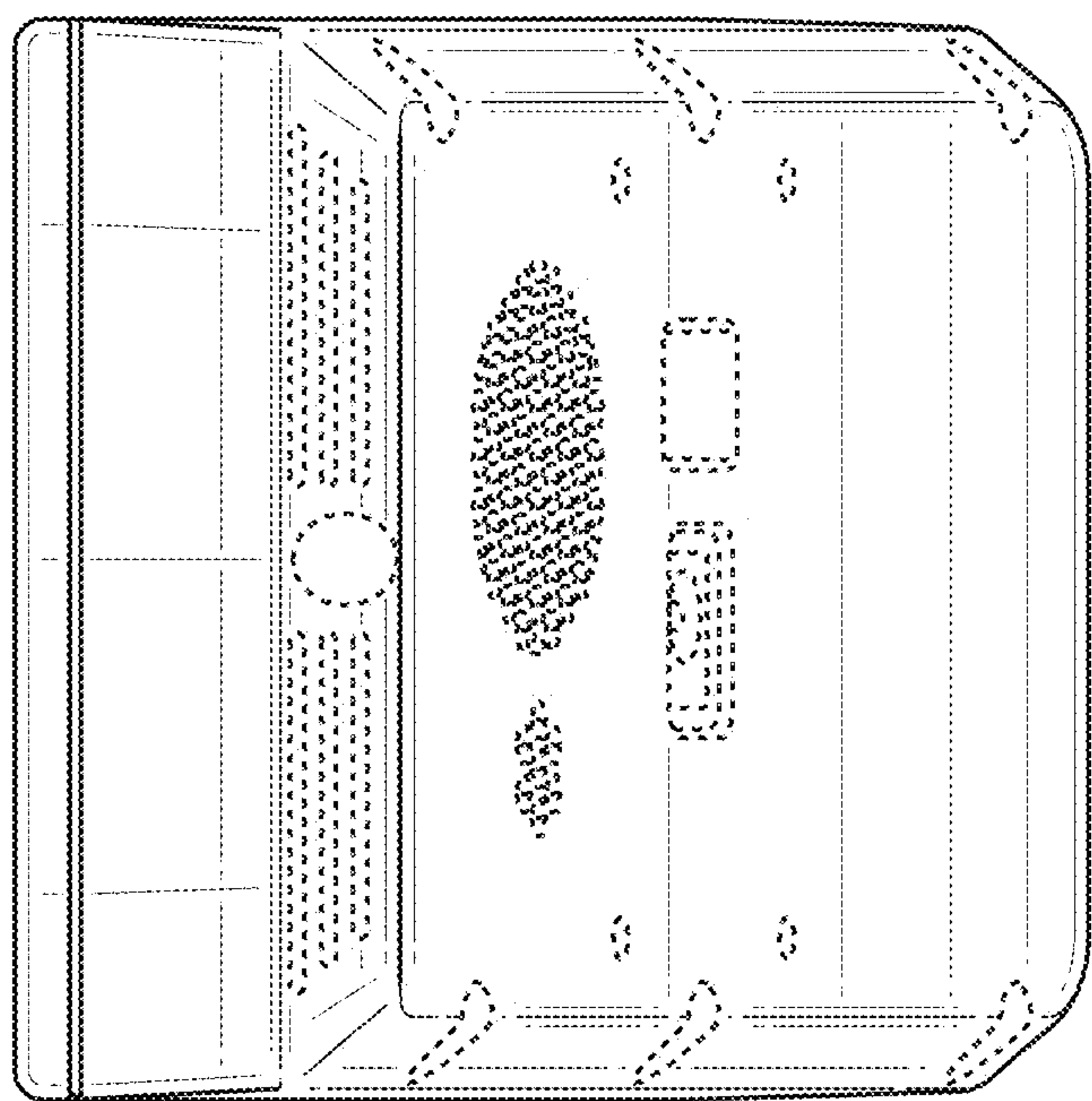

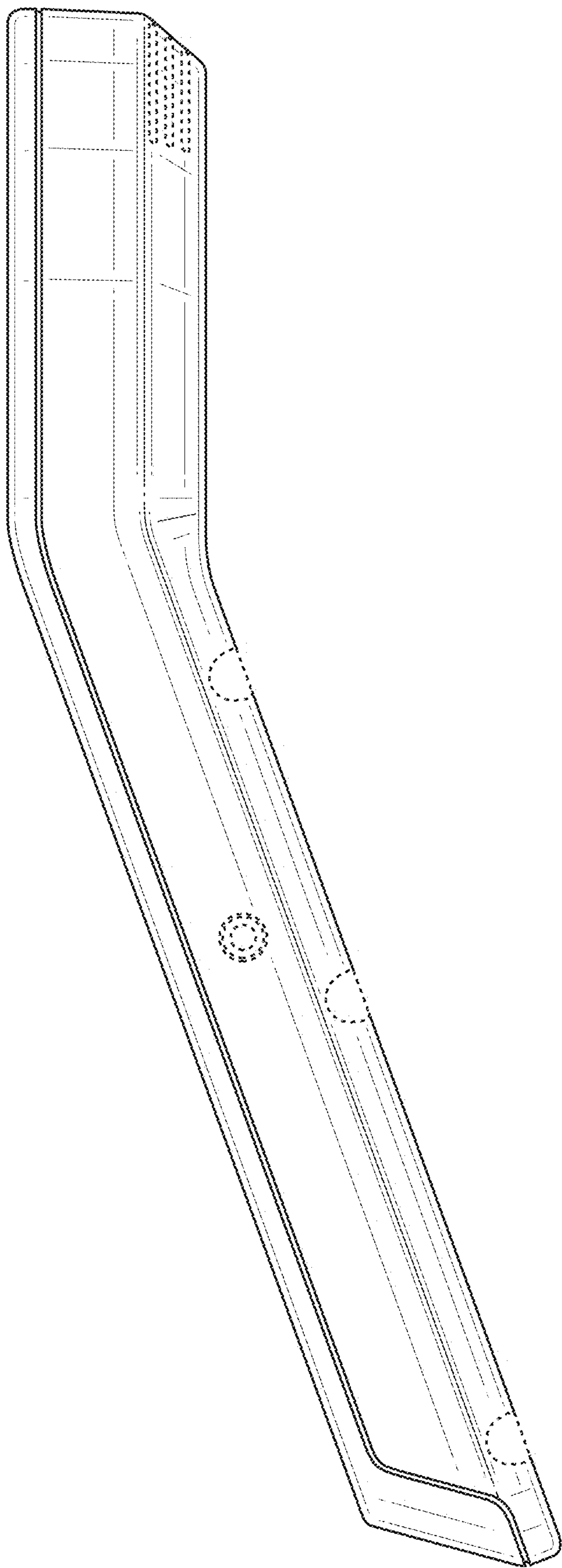

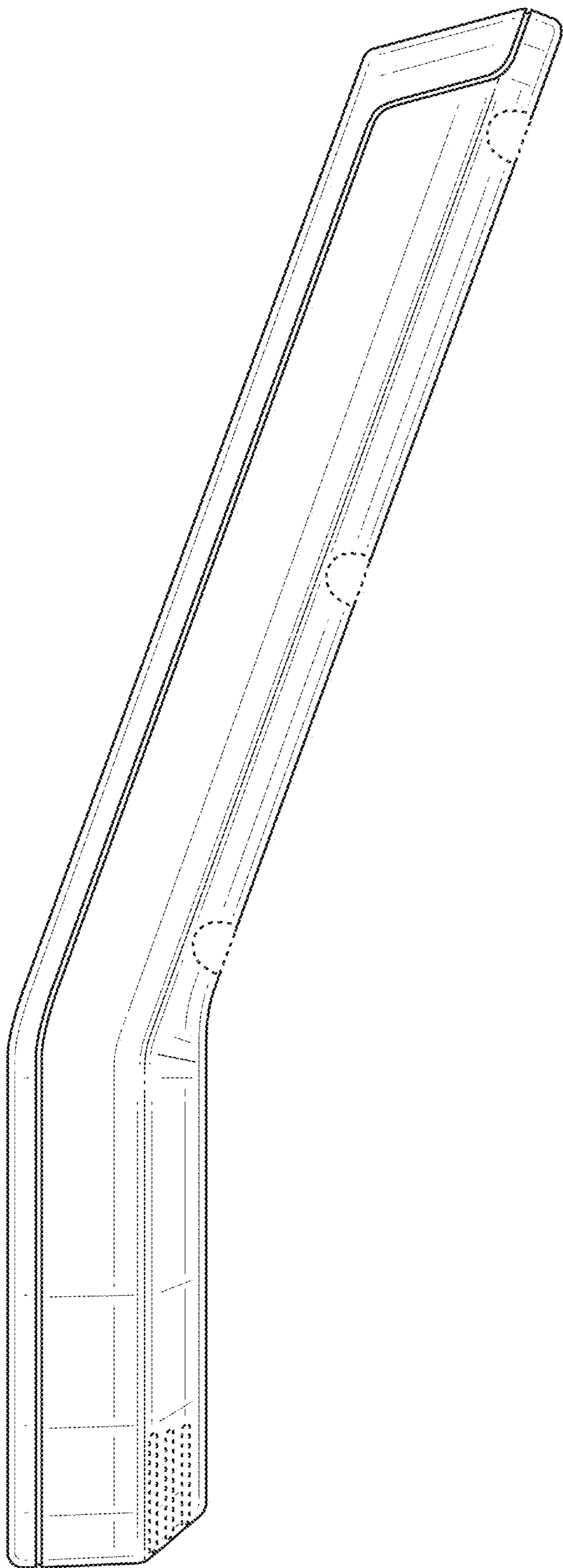

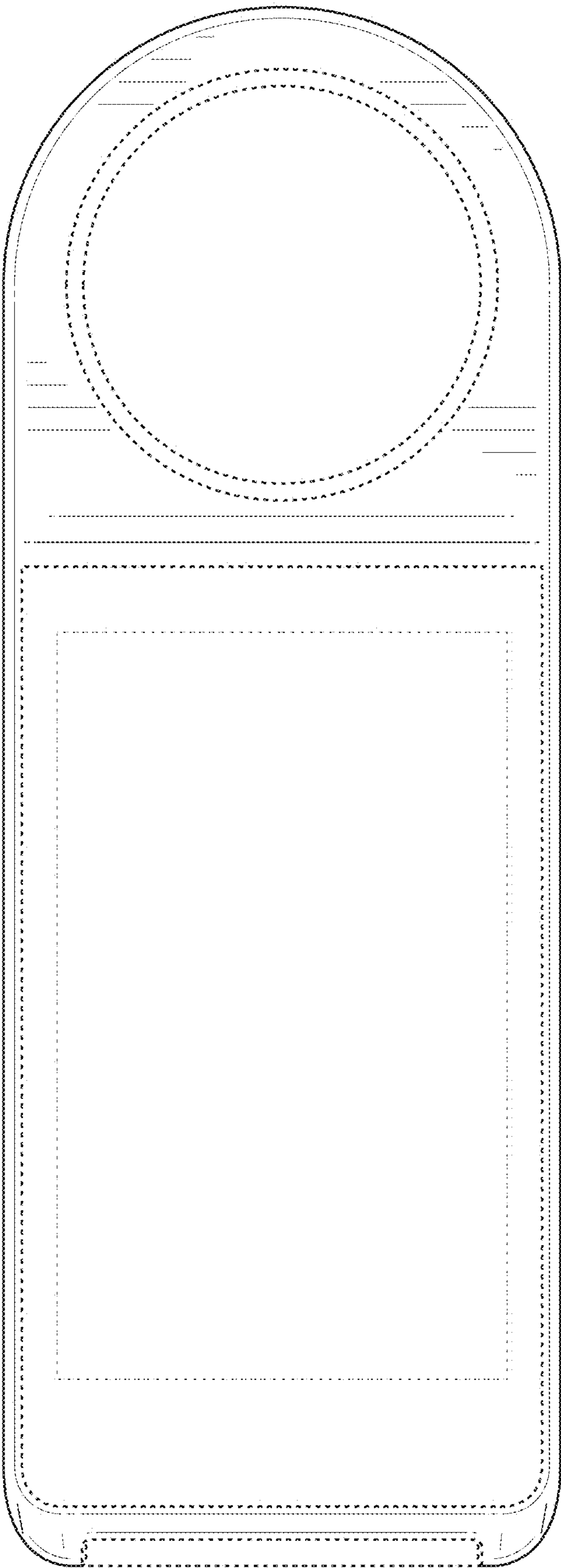

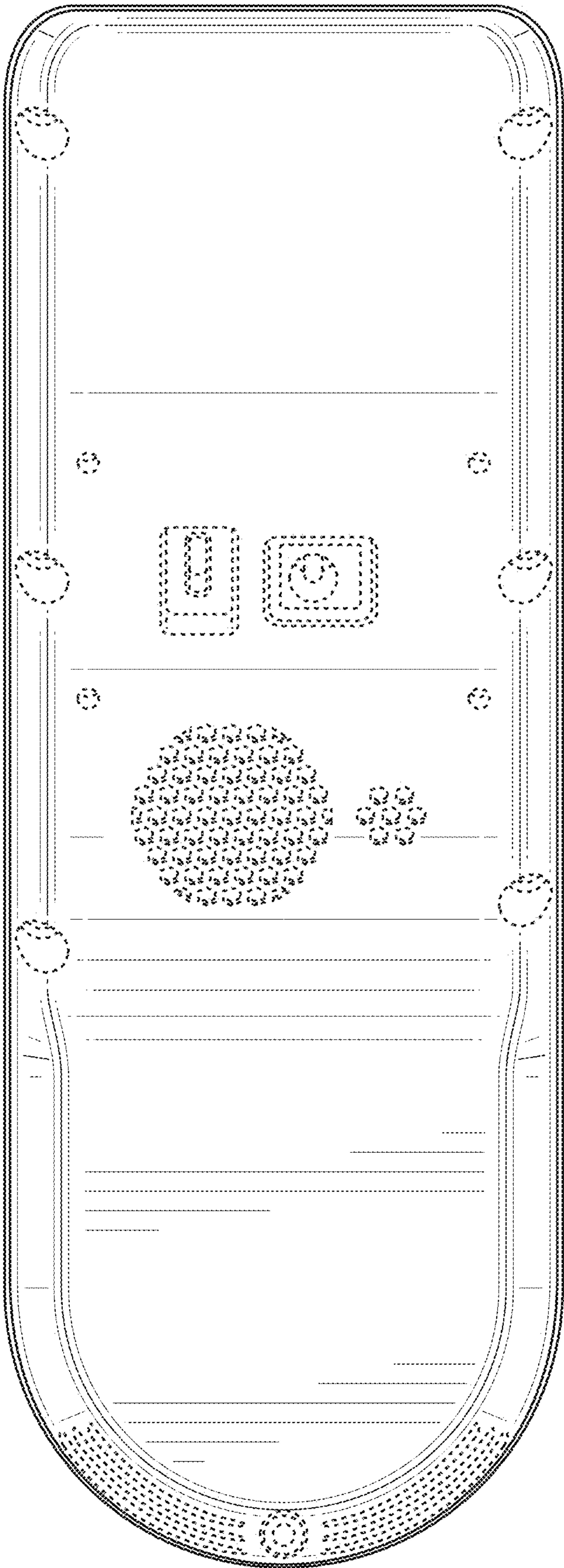
