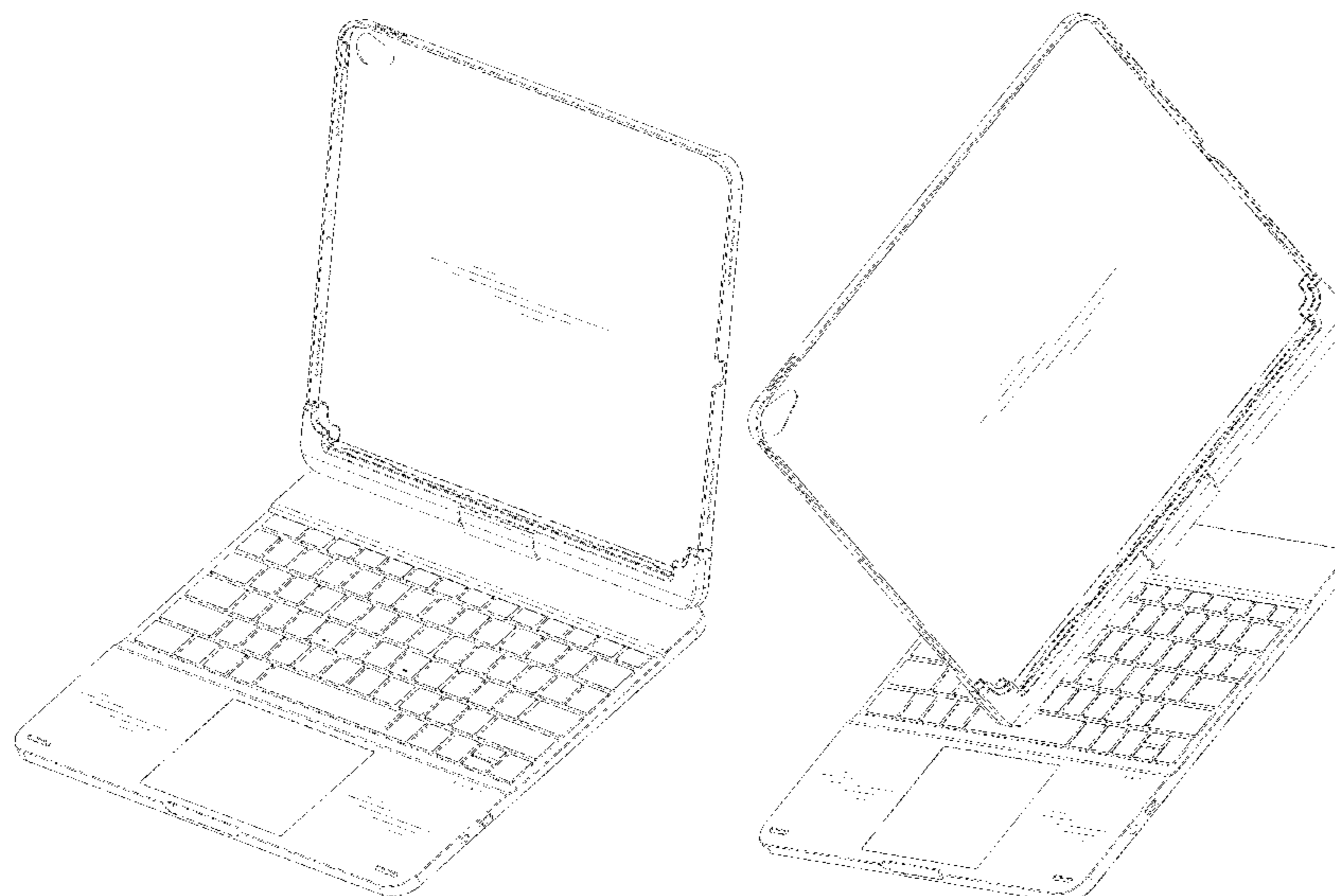
(57) **CLAIM**

The ornamental design for a keyboard with rotatable mount, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a keyboard with rotatable mount showing my new design; FIG. 2 is a rear perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is a bottom plan view thereof; FIG. 9 is an exploded front perspective view thereof, exposing the tablet mount of the keyboard with rotatable mount for clarity of illustration and showing the keyboard with rotatable mount in an alternate position with the kickstand extended. FIG. 10 is an exploded rear perspective view thereof; and, FIG. 11 is a front perspective view thereof, showing the tablet mount in a rotated position. The dashed broken lines in the figures depict portions of the keyboard with rotatable mount that form no part of the claimed design.

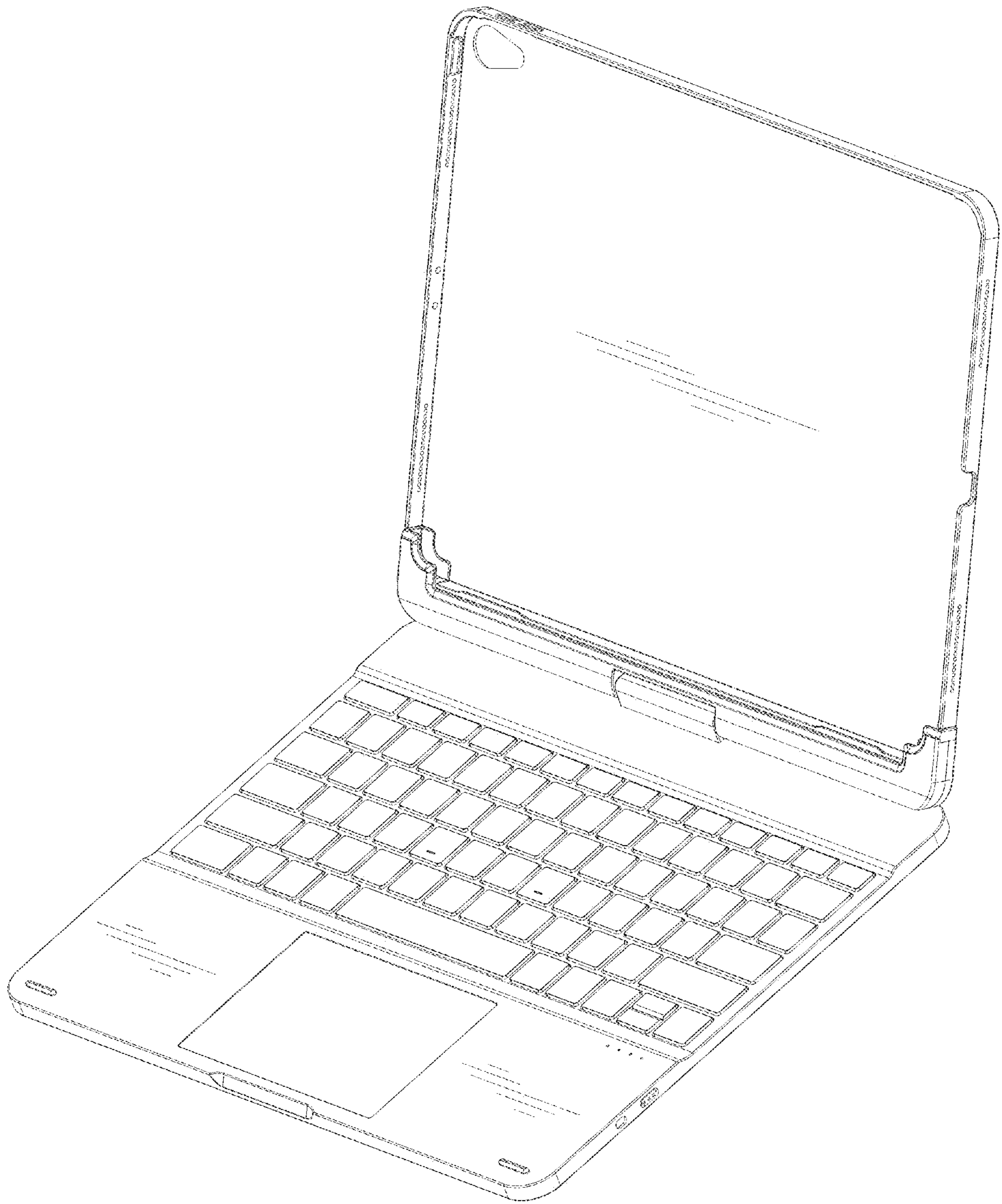

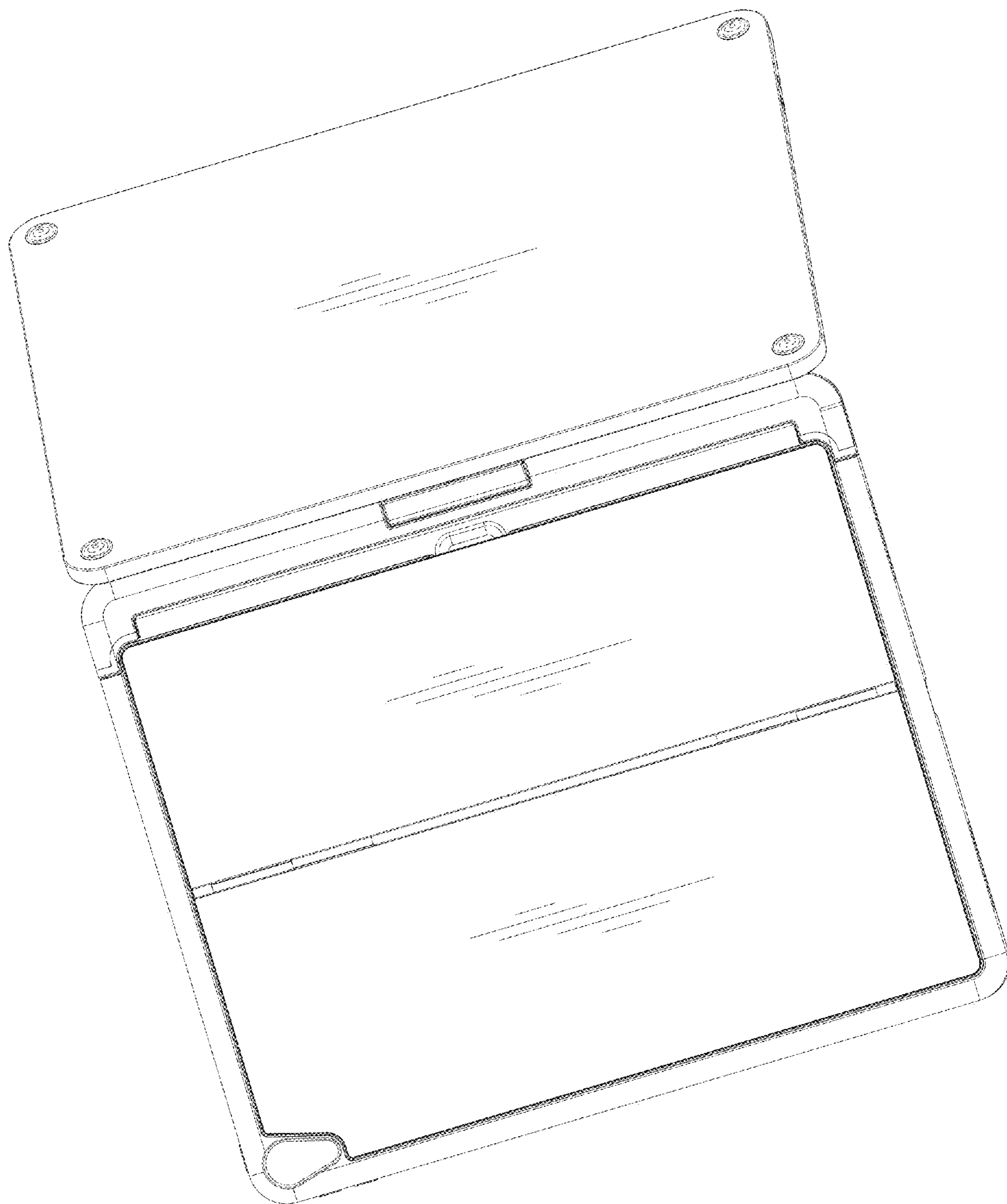

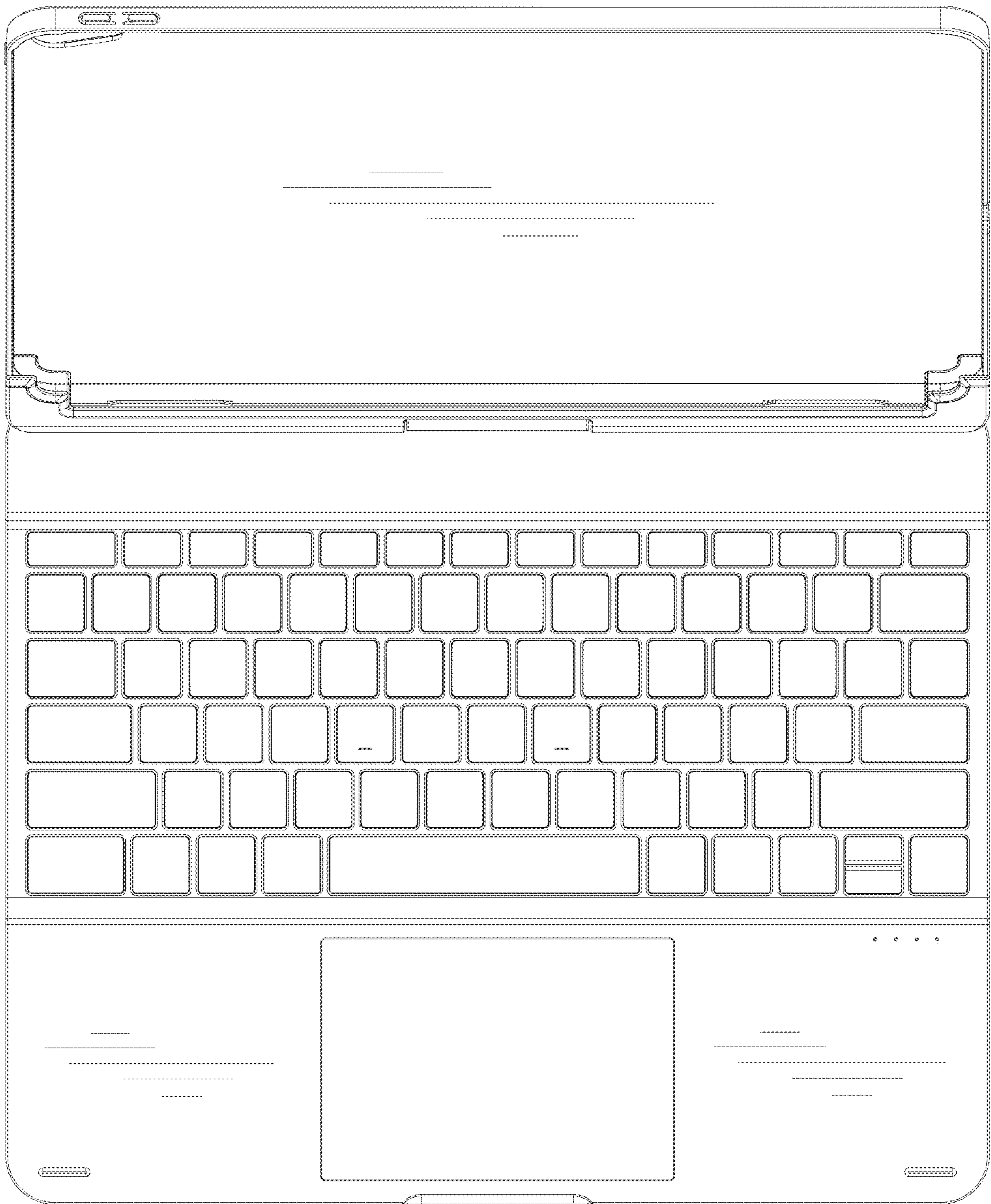

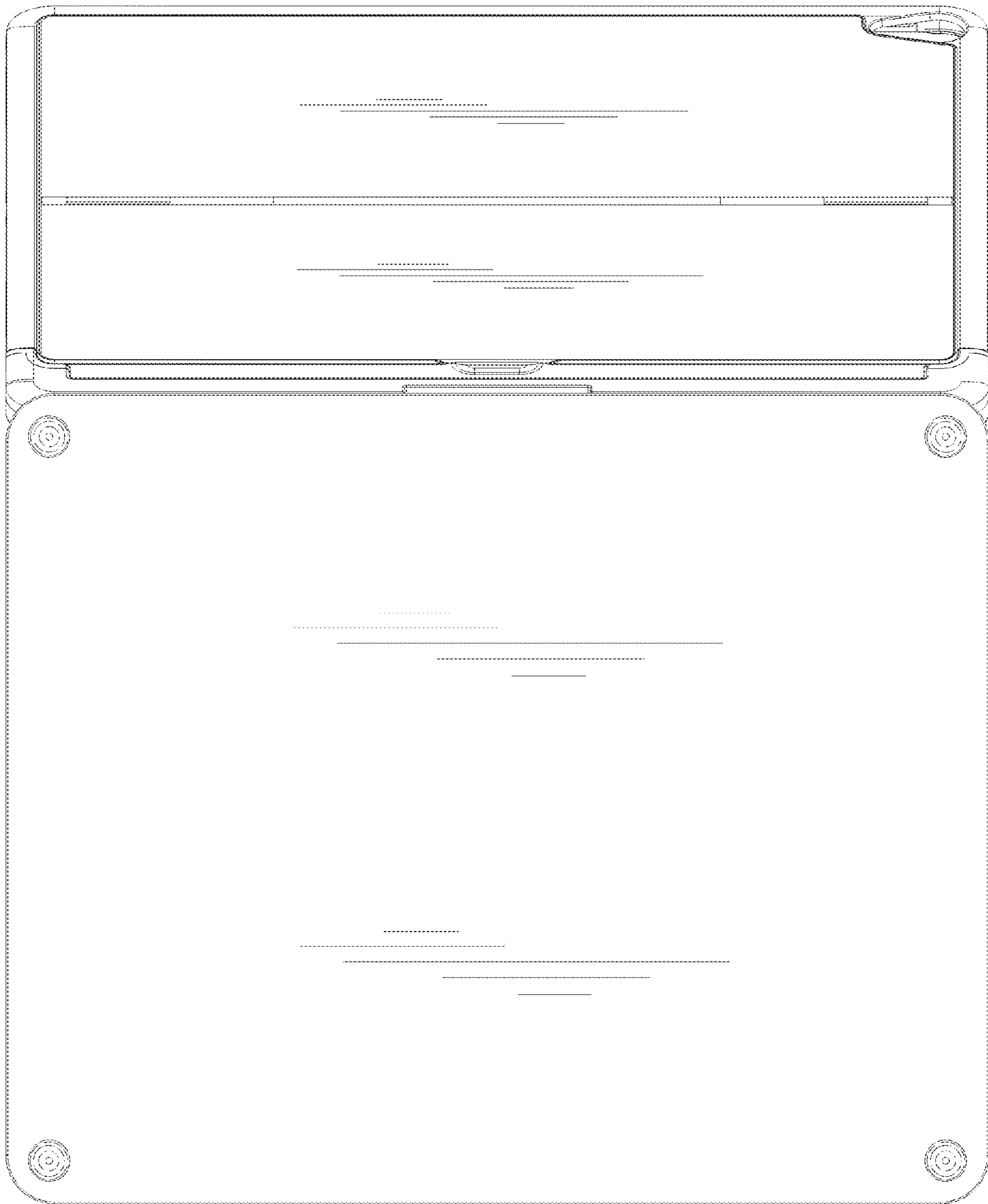

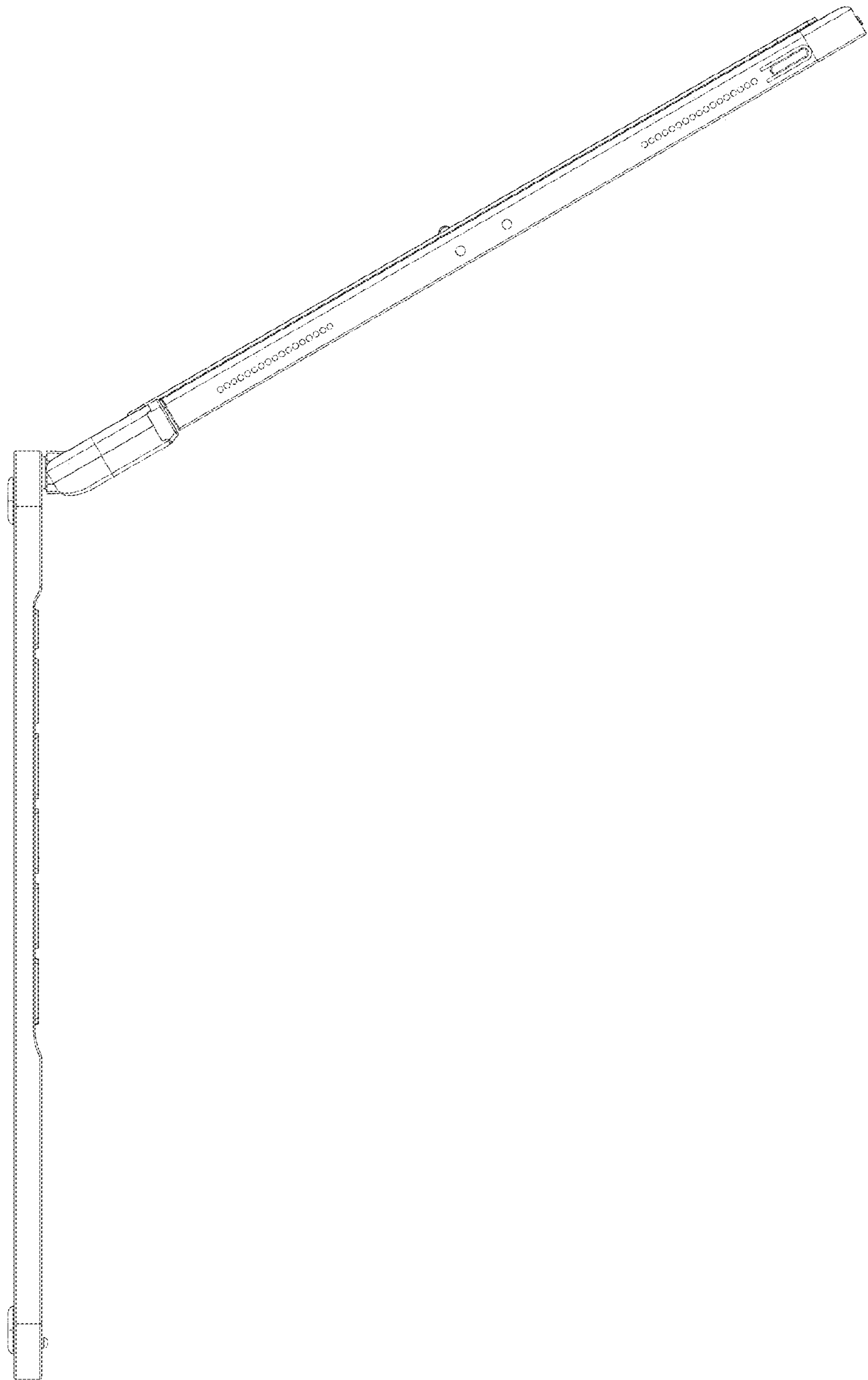

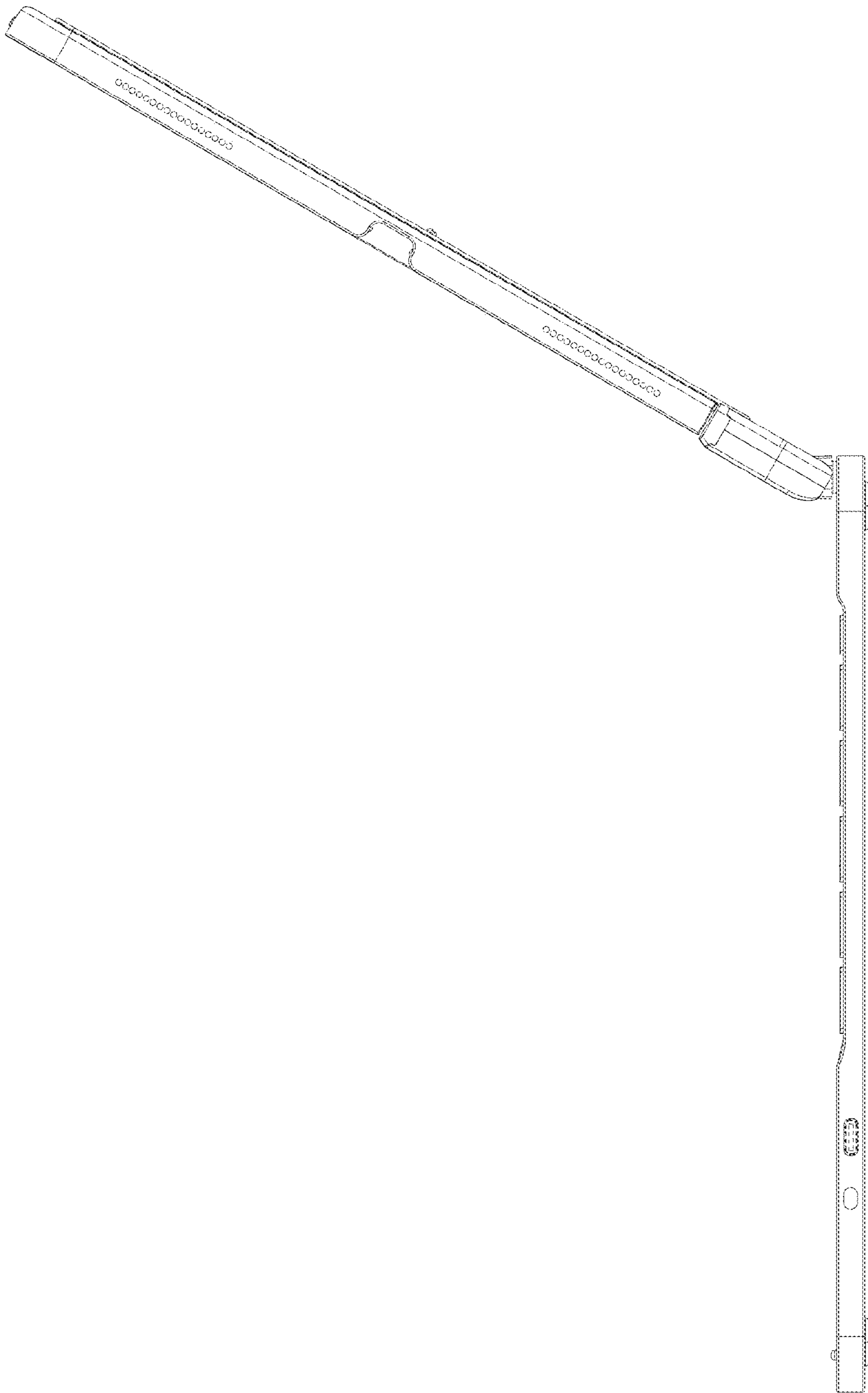

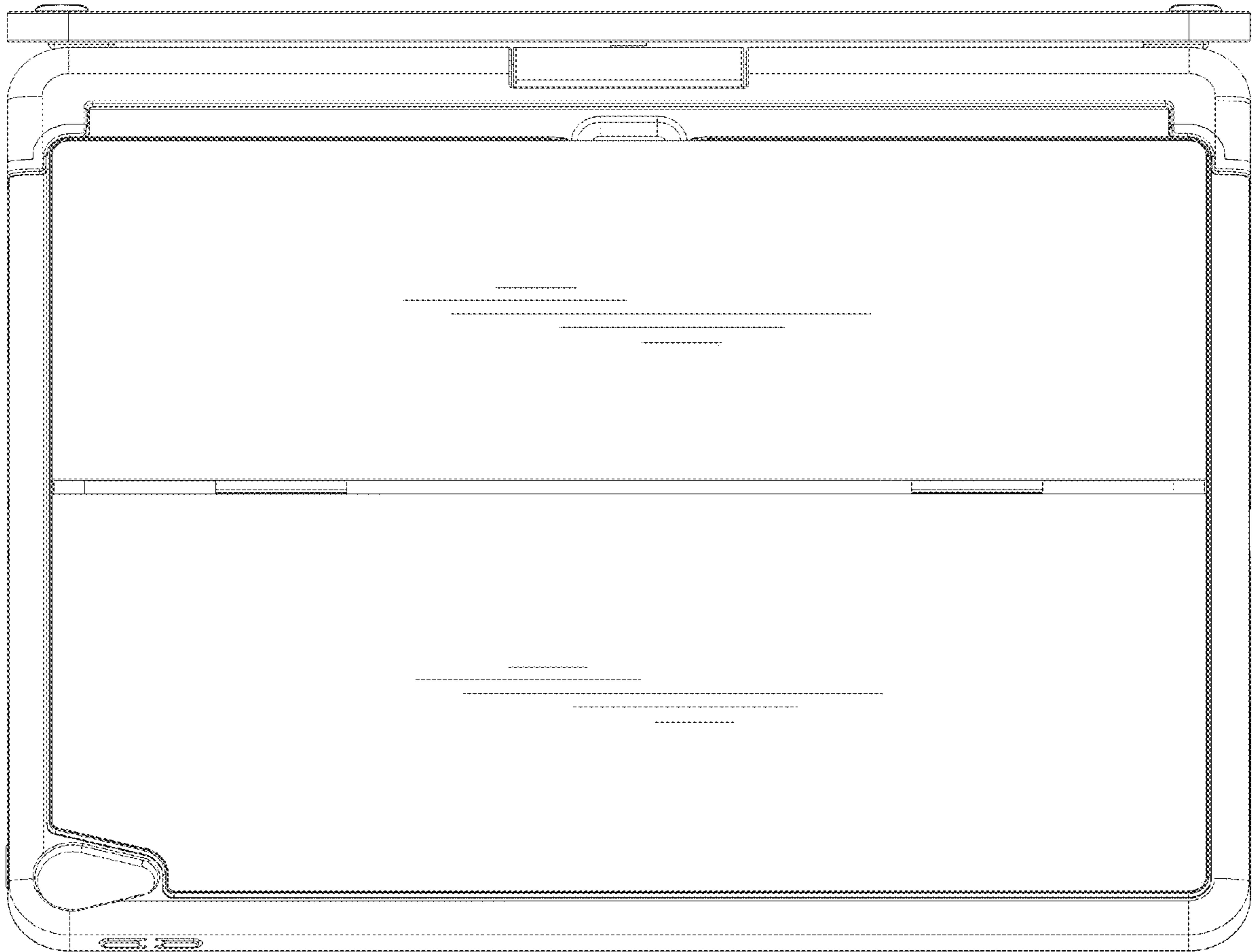

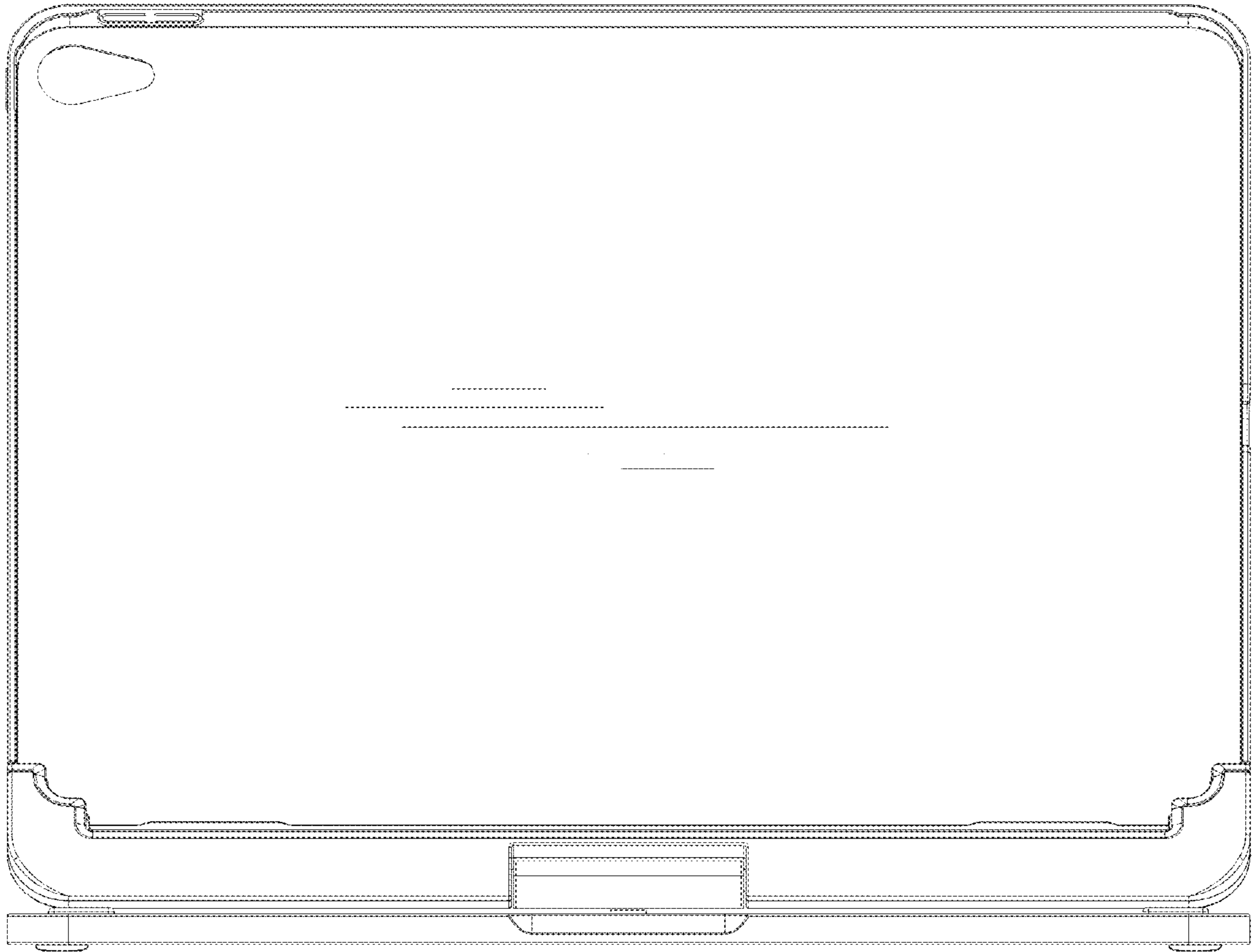

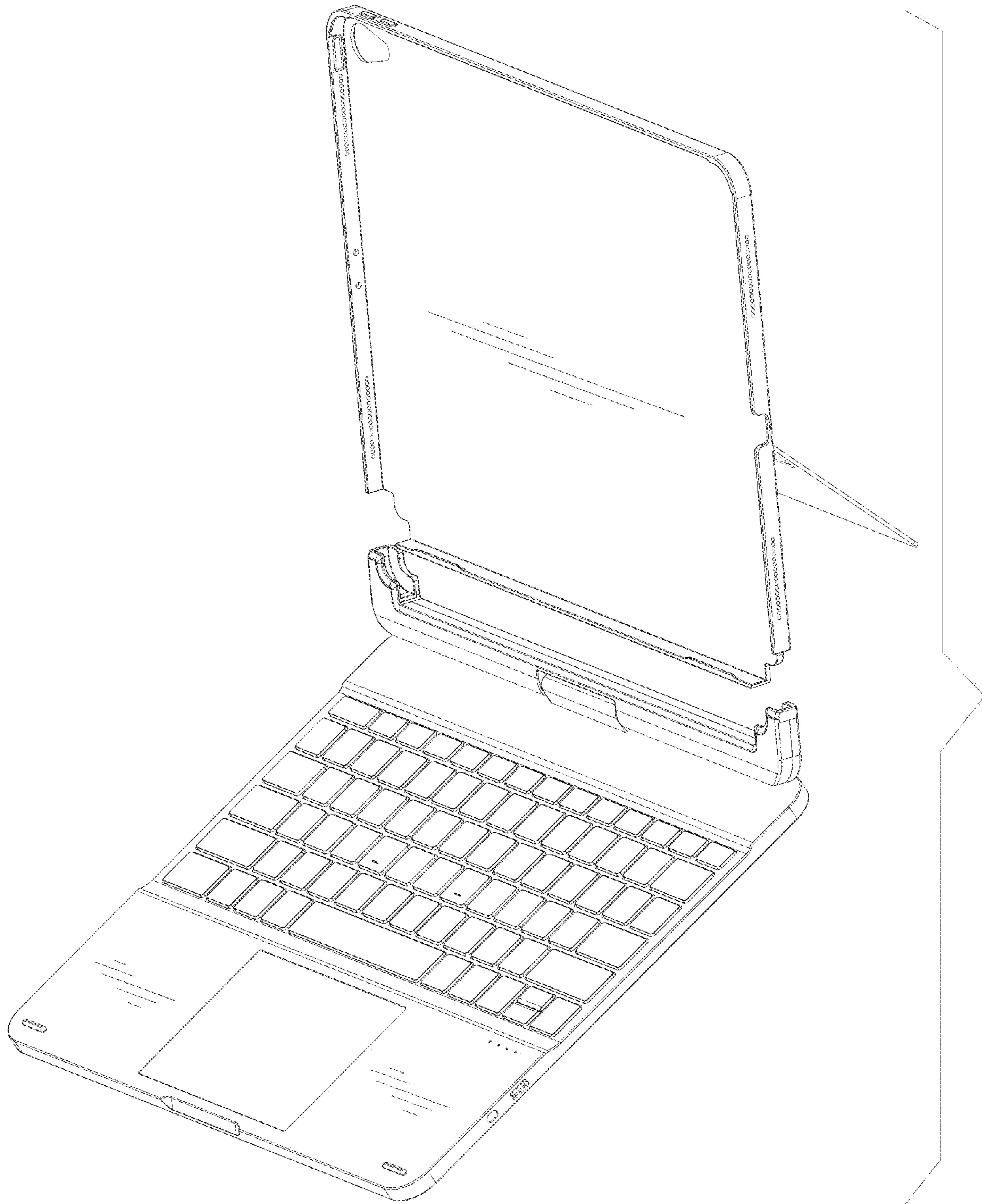

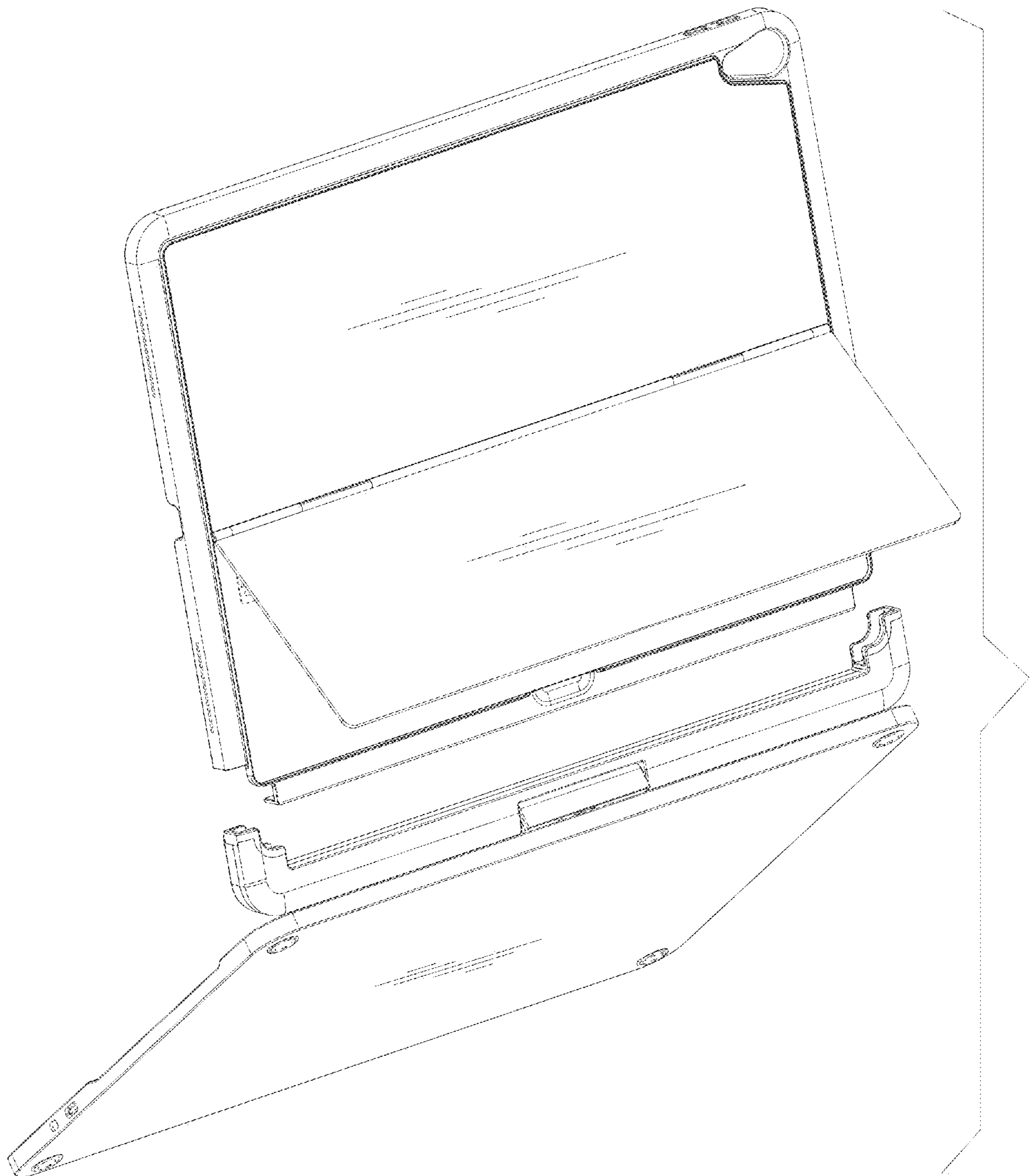

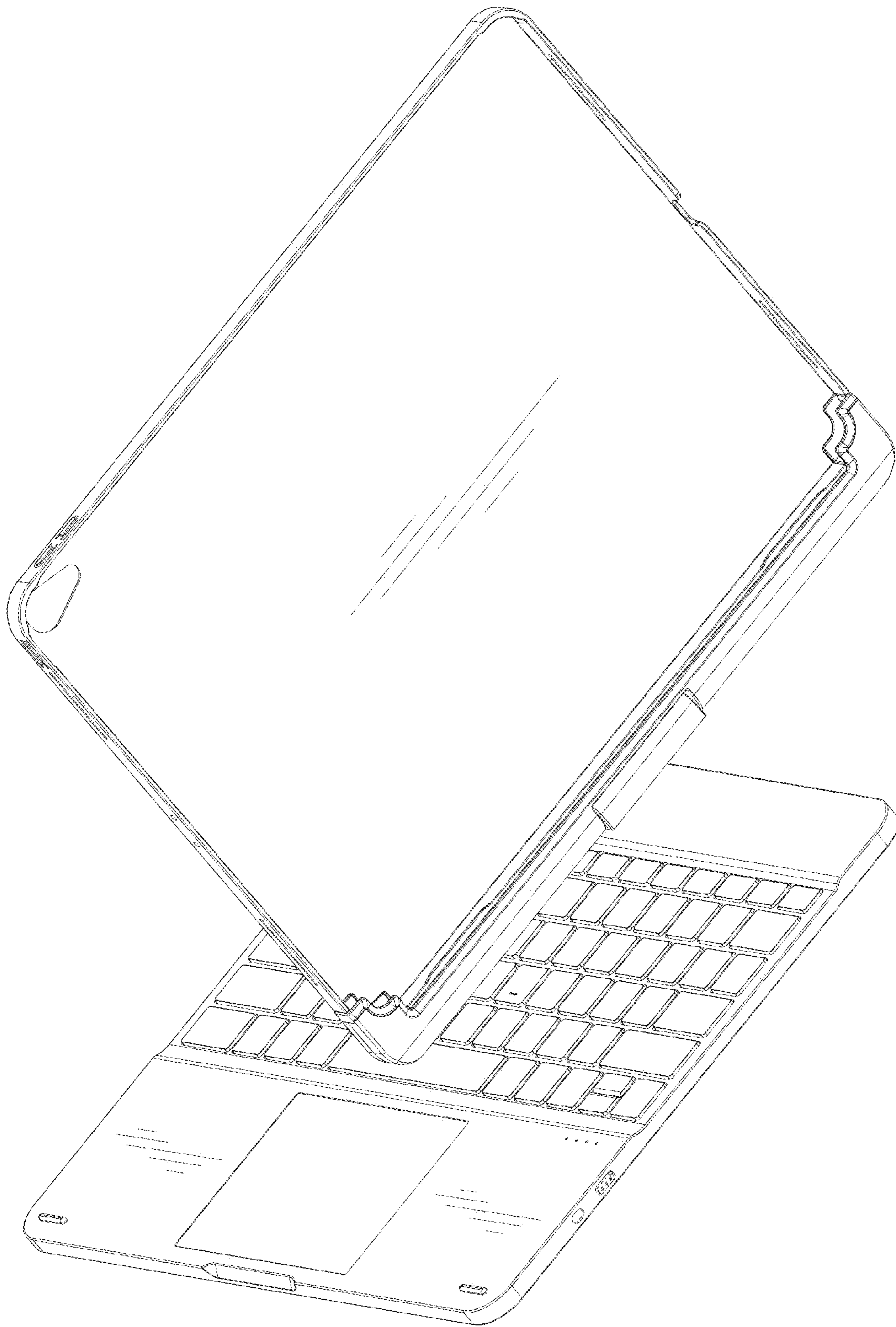
