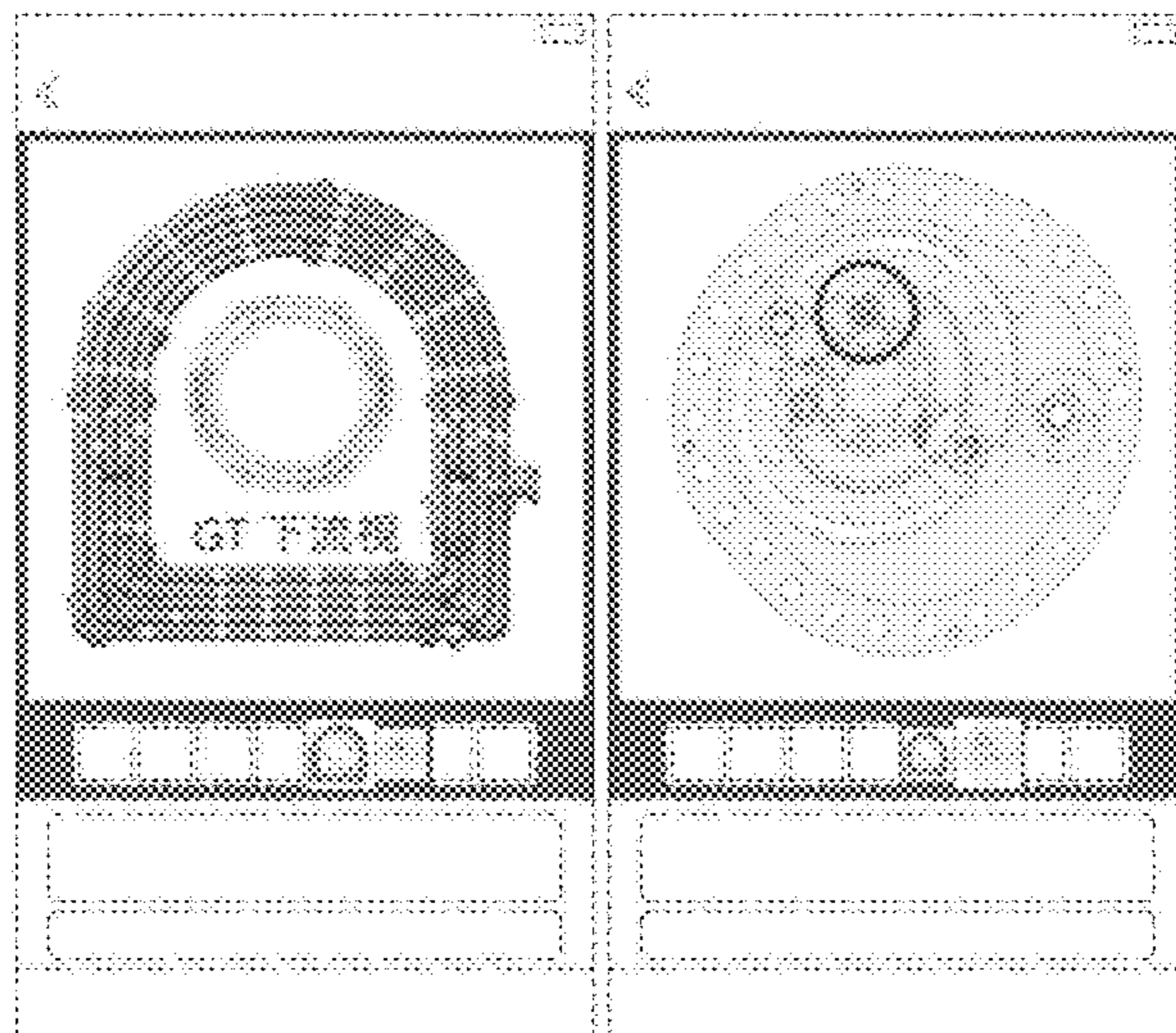
FIG. 1 is a front view of the first image in a sequence of a display screen with graphical user interface showing our new design; and,

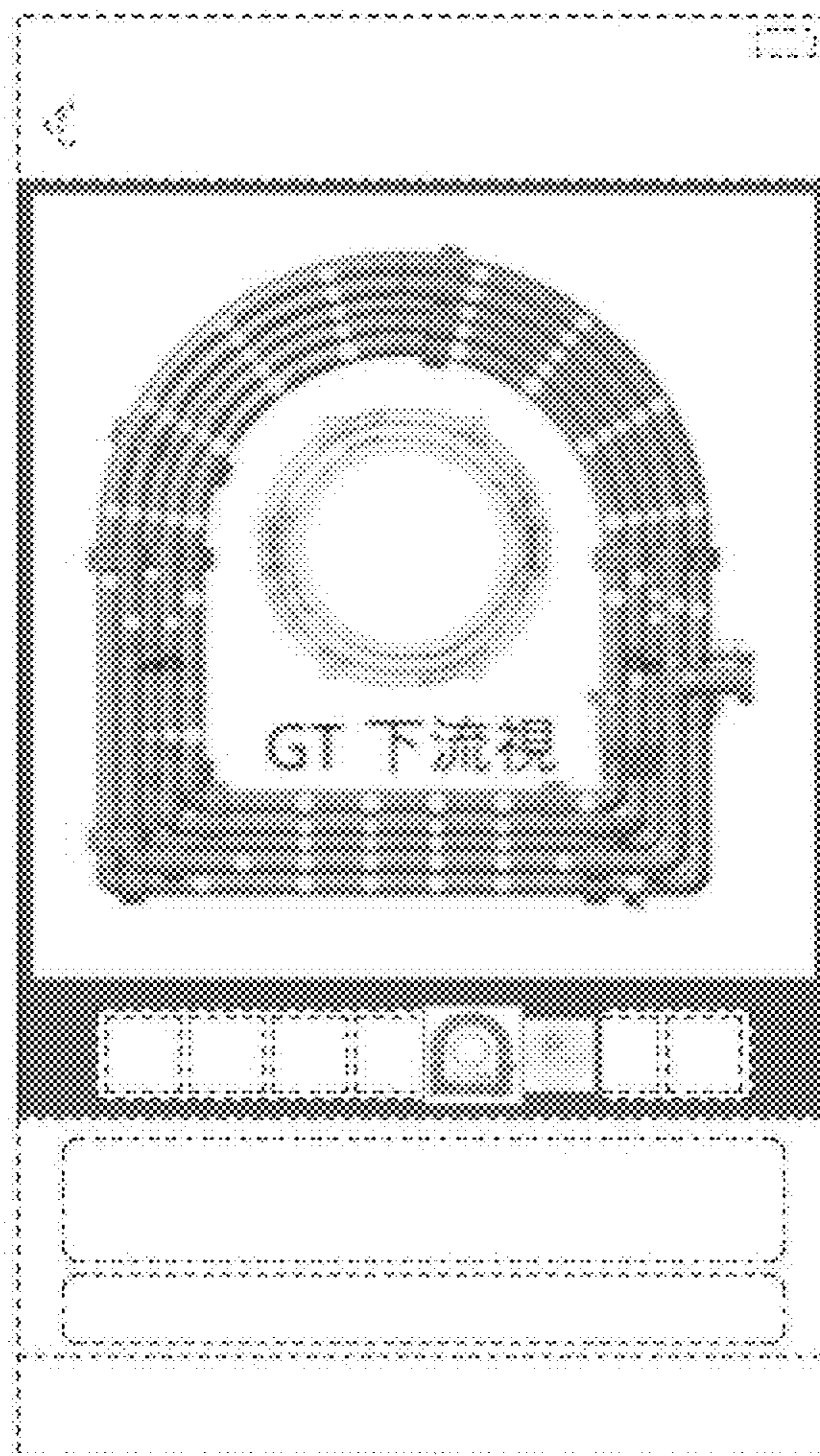
