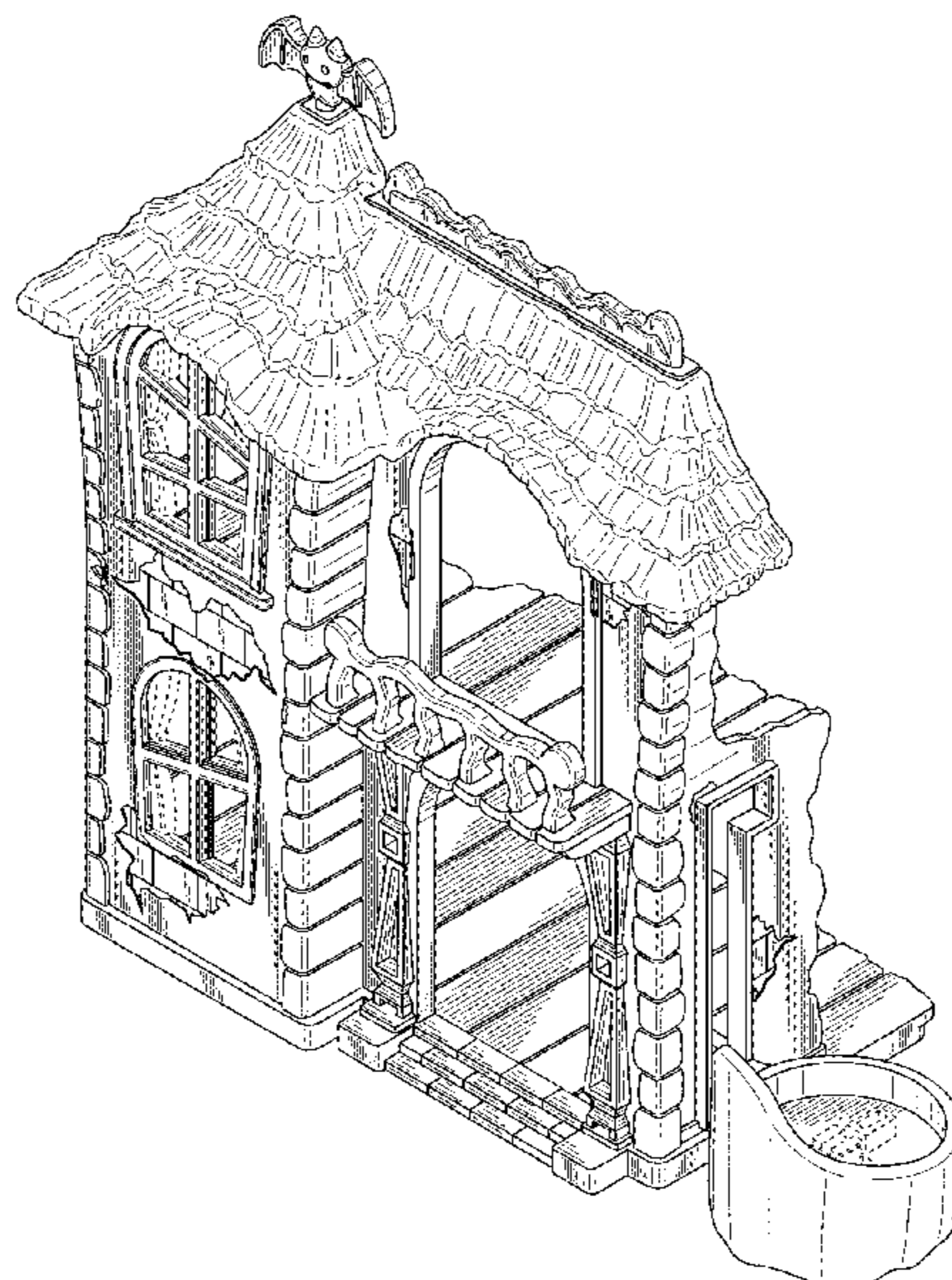
(57) **CLAIM**  
The ornamental design for a toy house, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of portions of the front, top, and right sides of a toy house showing my new design; FIG. 2 is a perspective view of portions of the rear, top, and left sides thereof; FIG. 3 is a front view thereof; FIG. 4 is a rear view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a right side view thereof; and, FIG. 7 is a left side view thereof. The broken lines depict portions of the toy house that form no part of the claimed design.

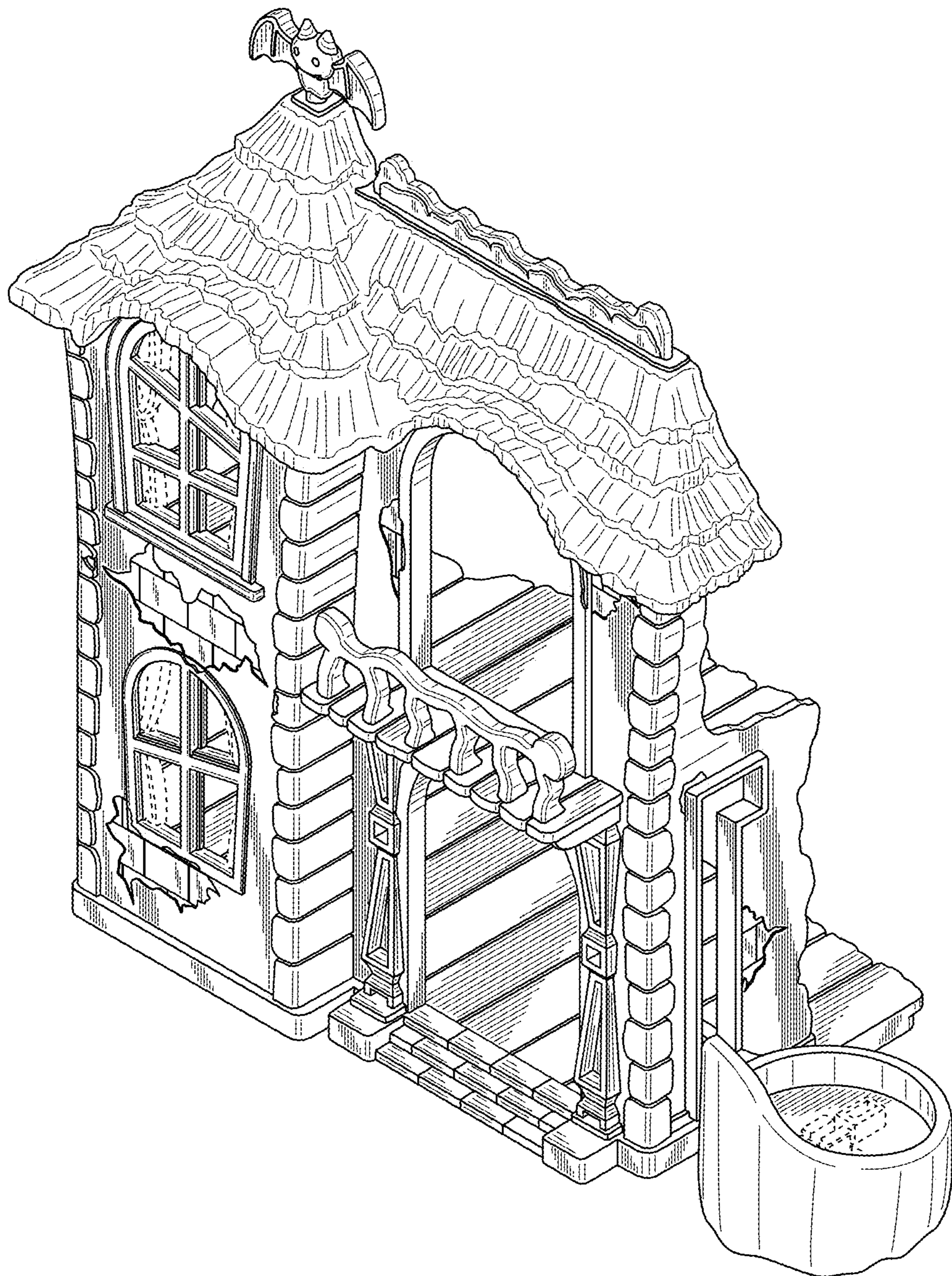

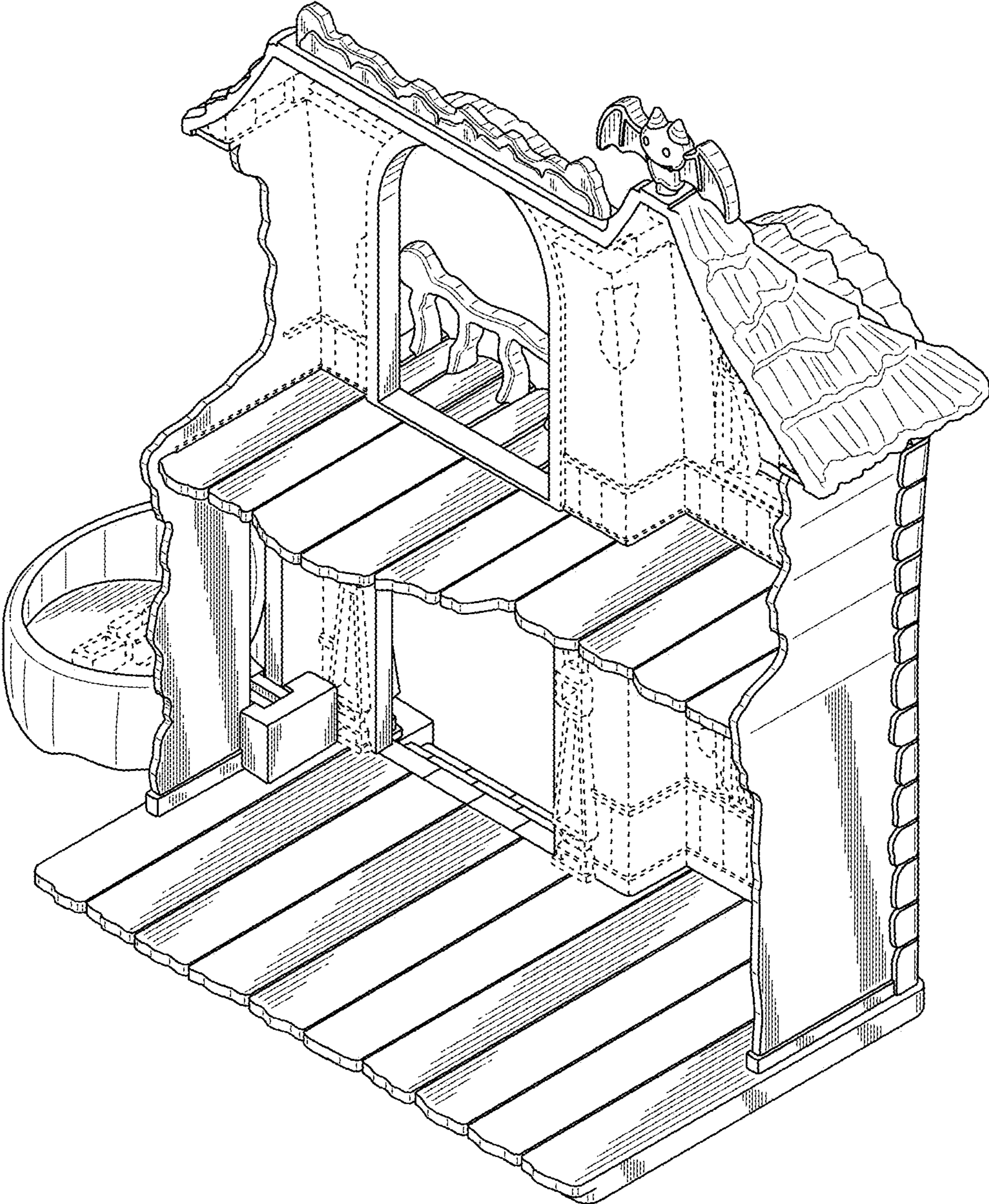

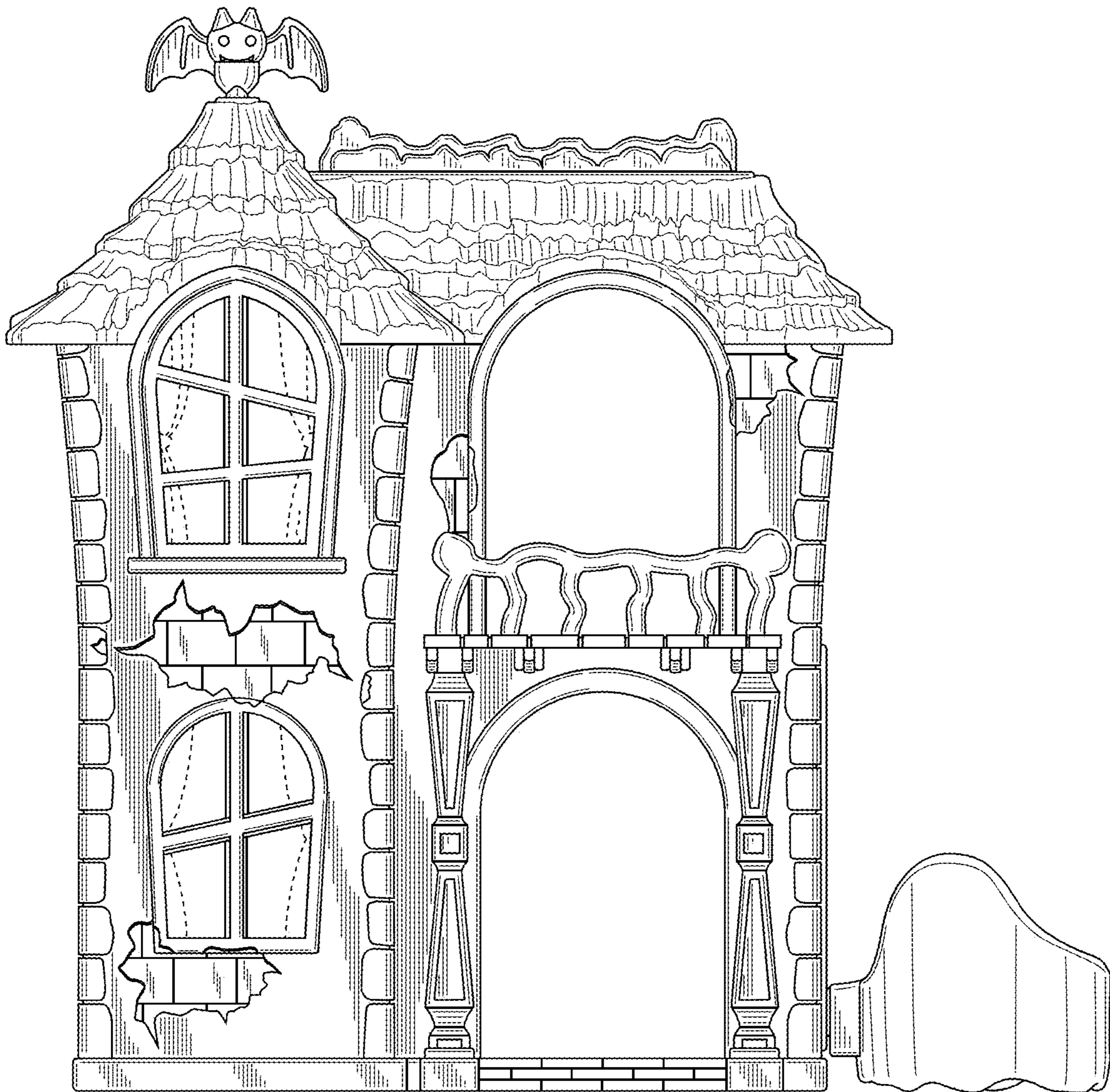

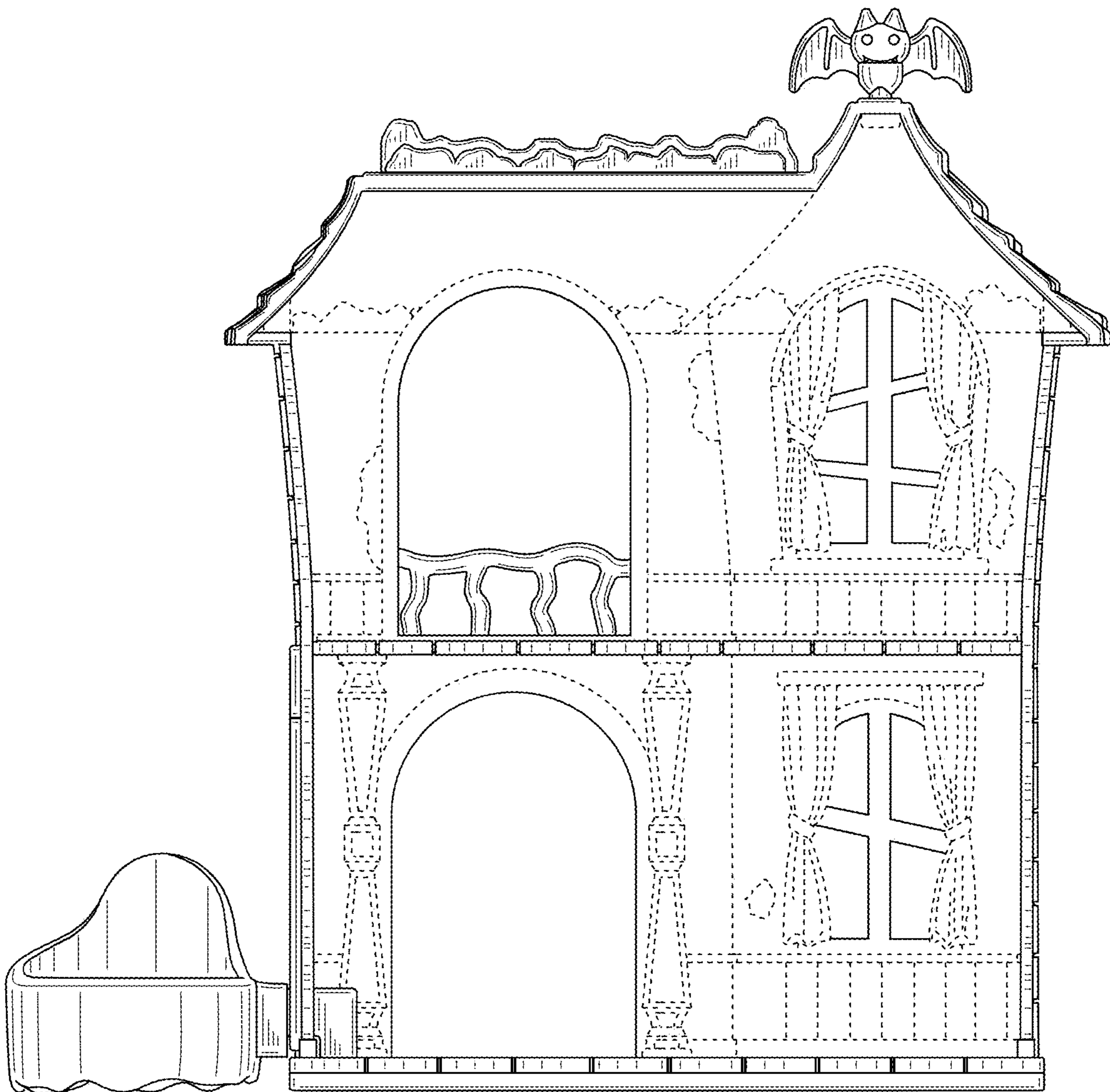

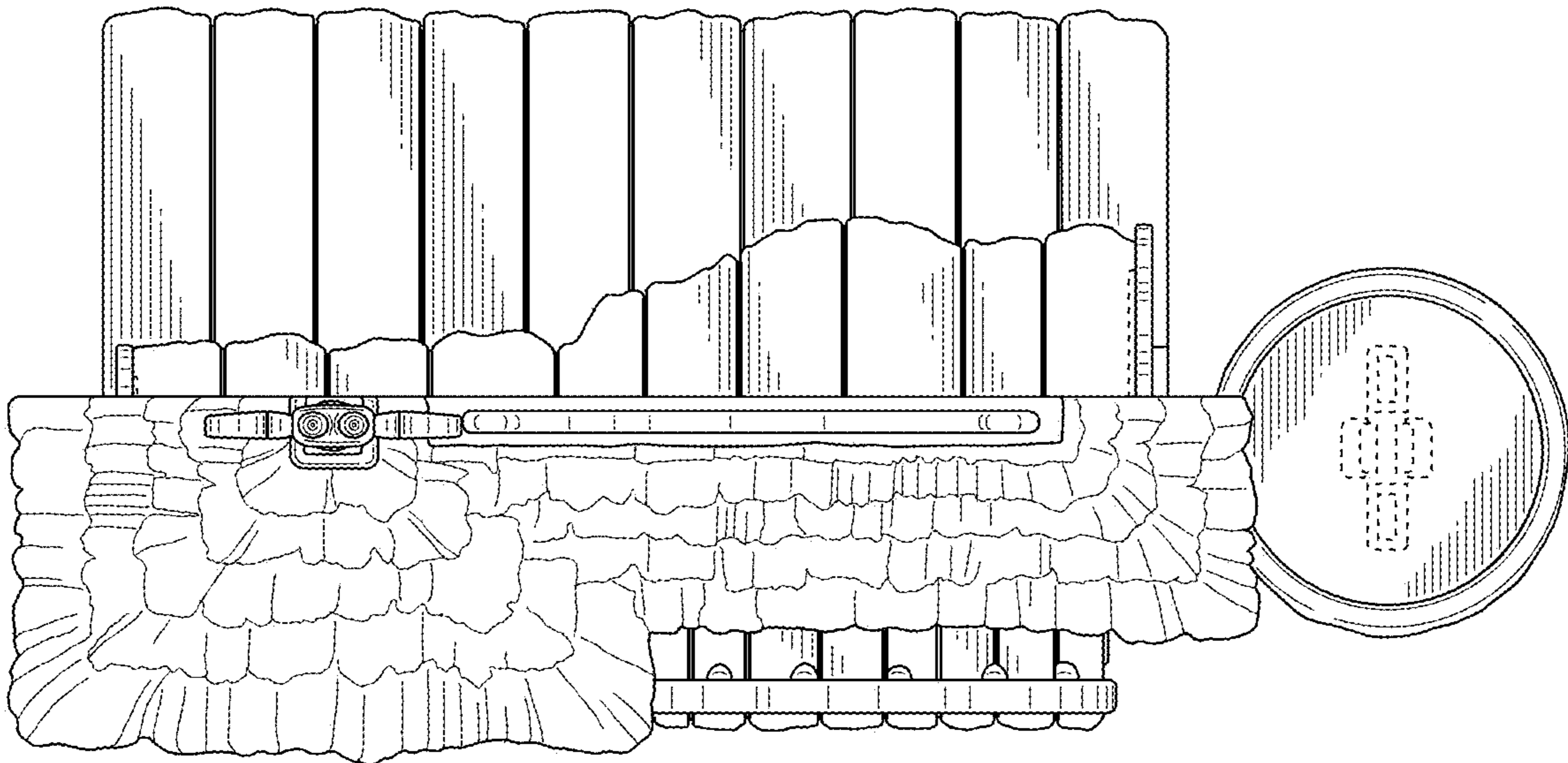

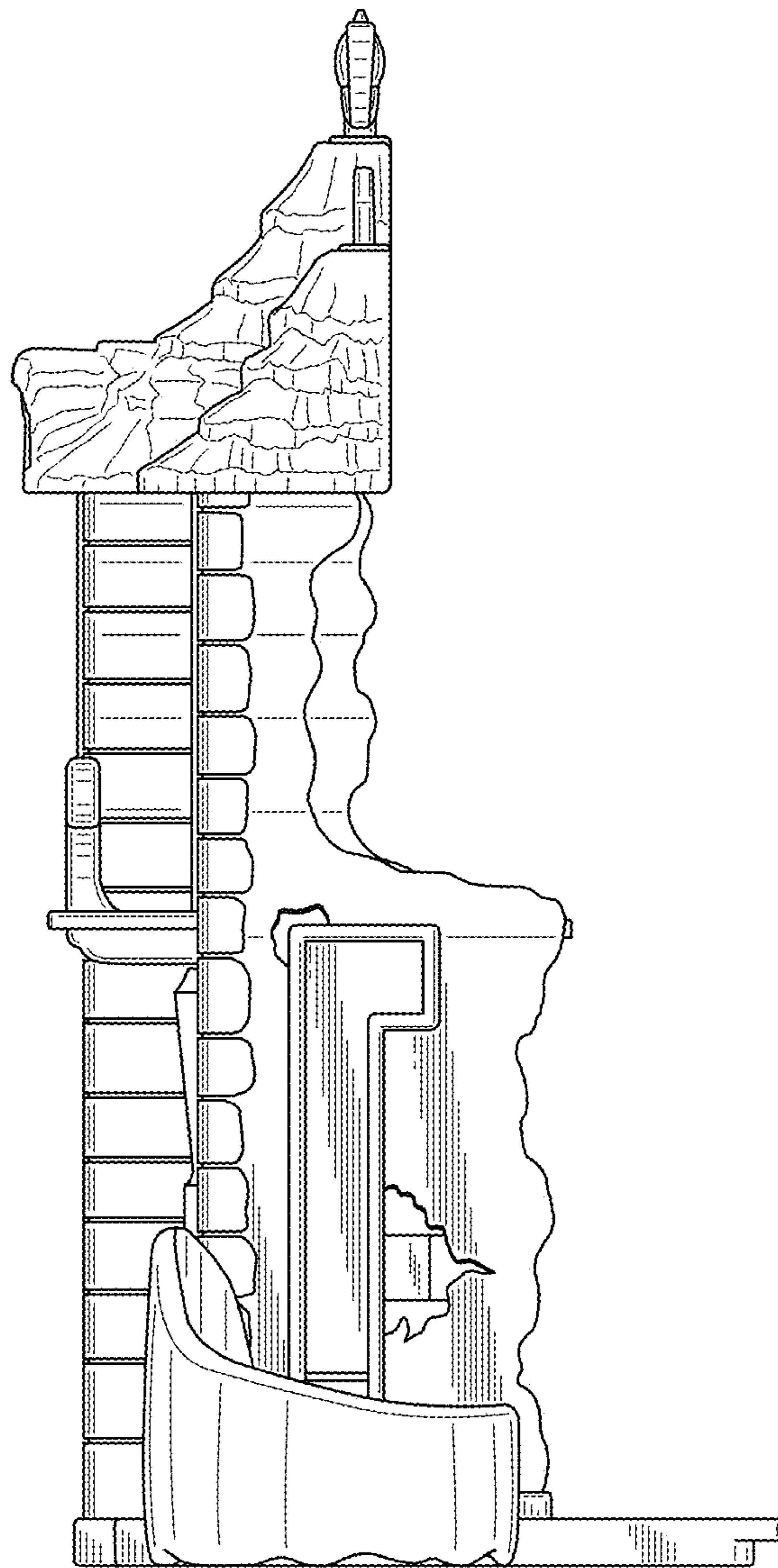
