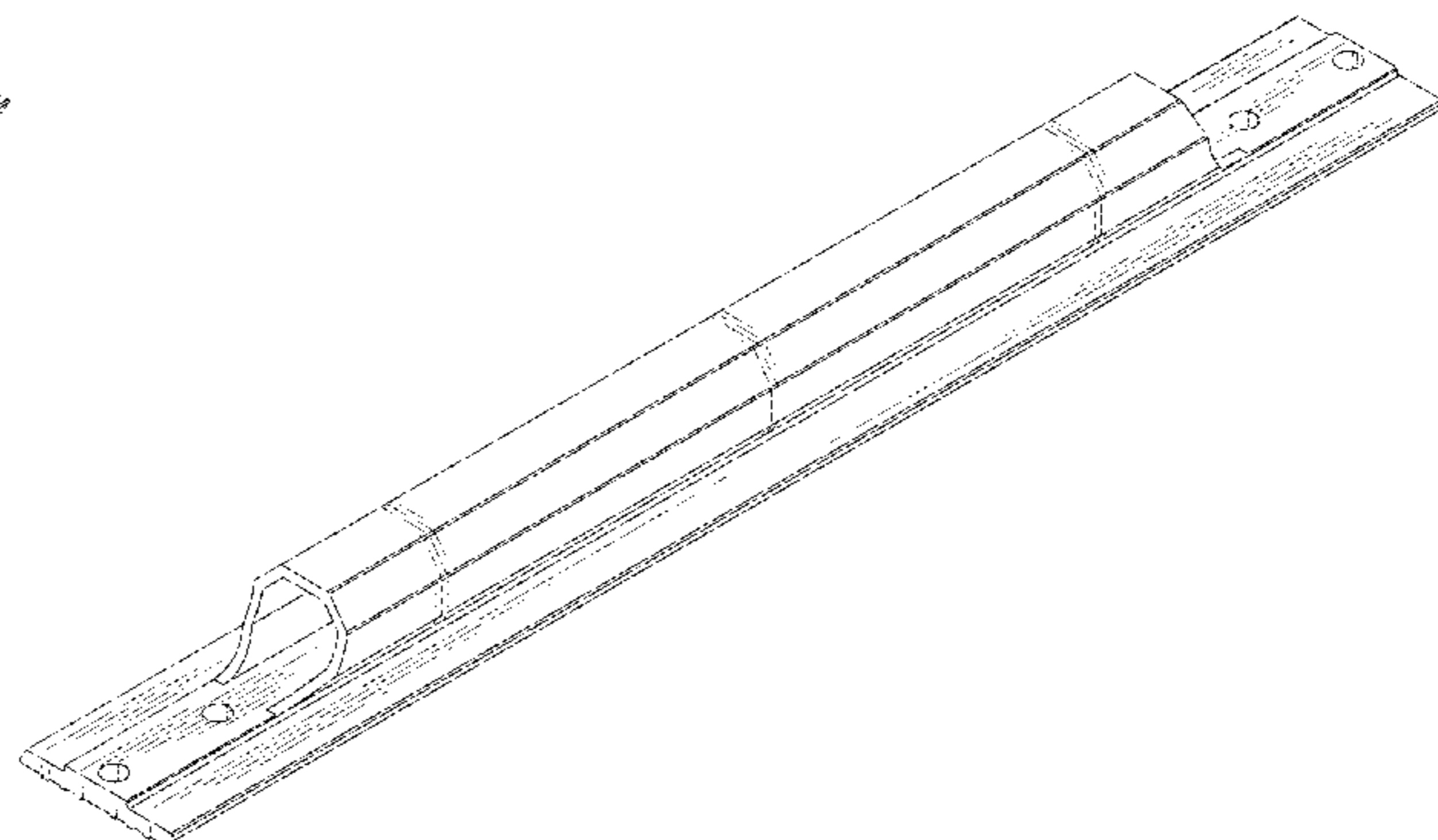
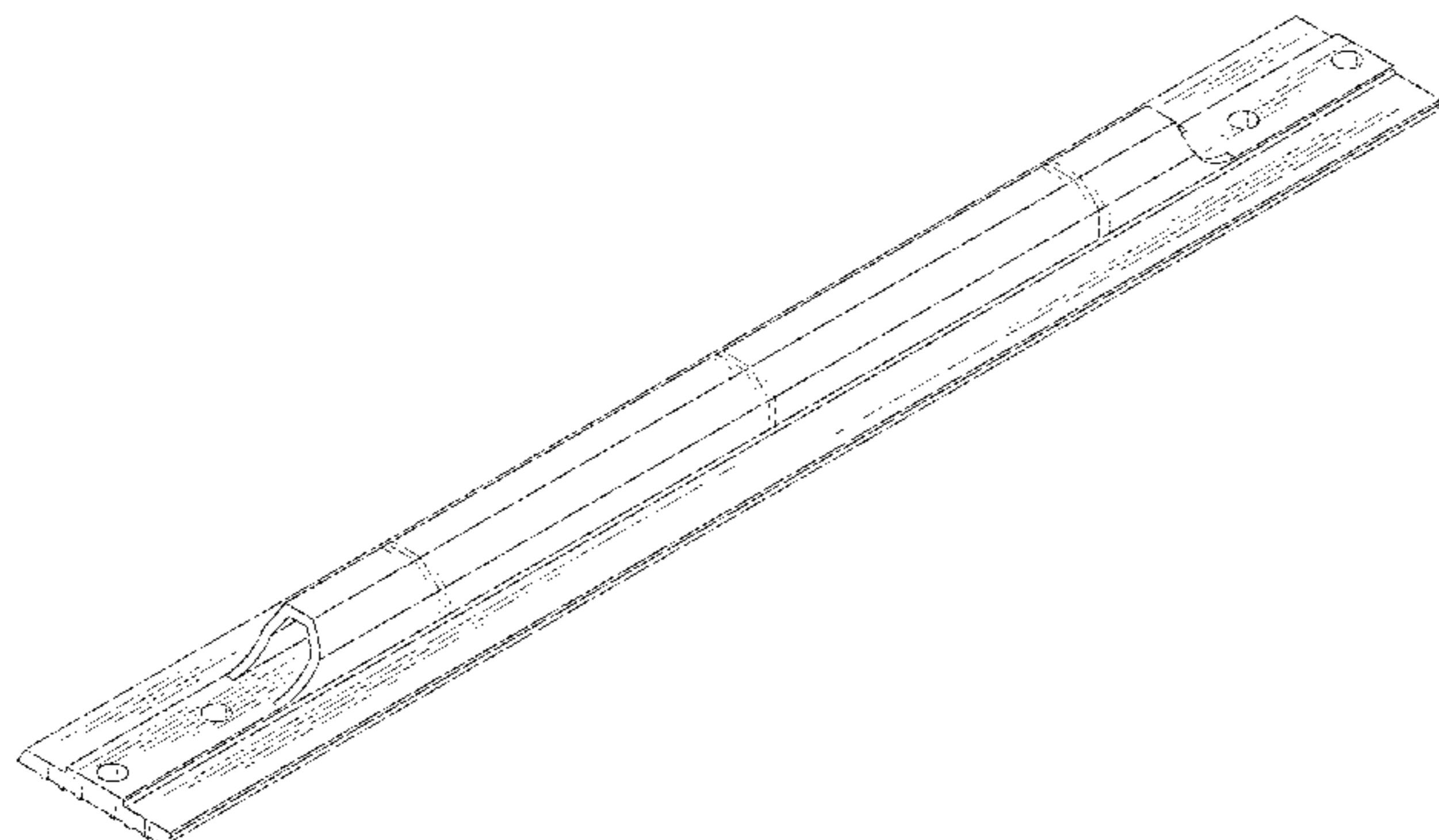


FIG. 27 is a top view of the fourth treadmill slat according to the present design;

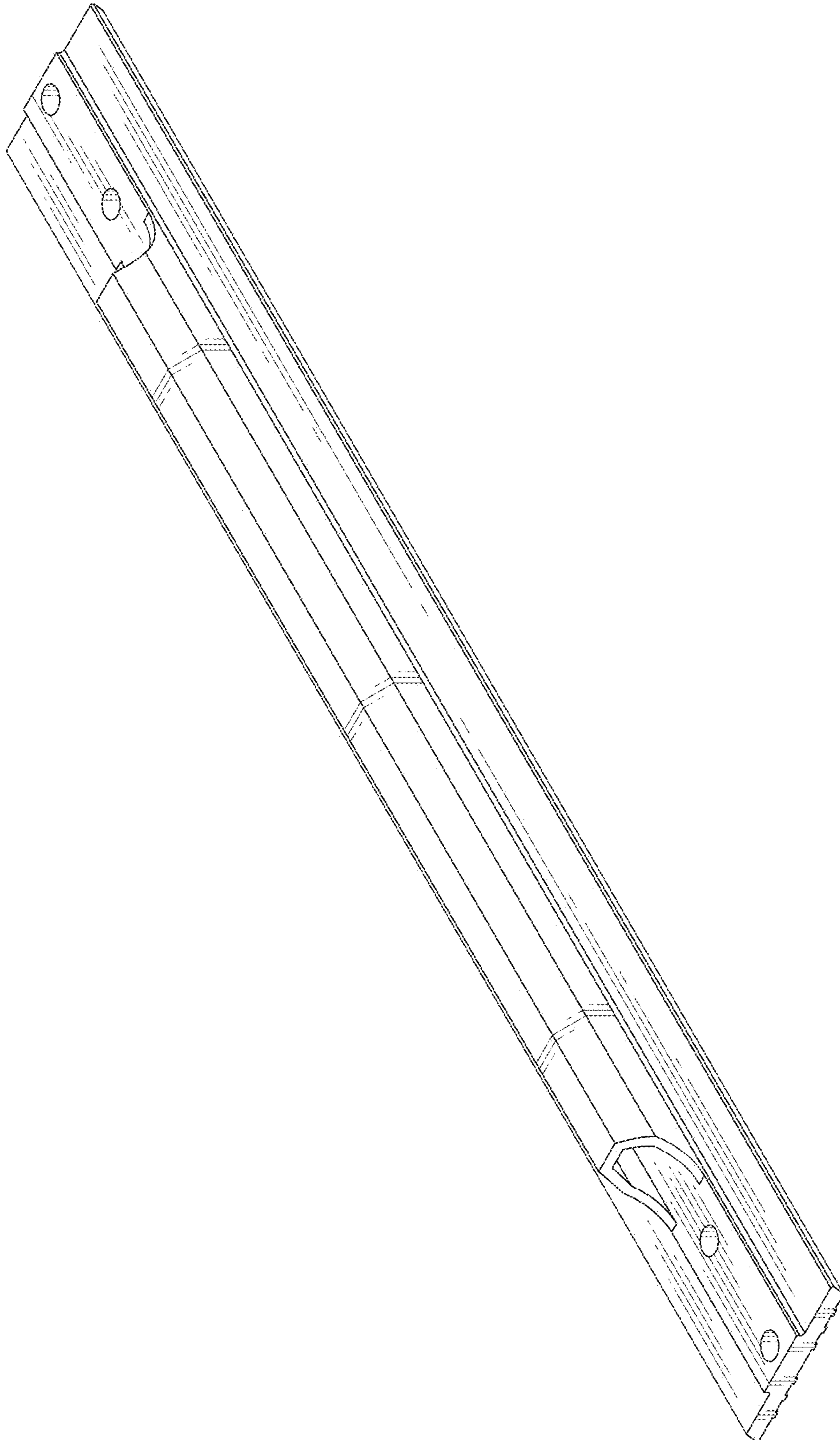

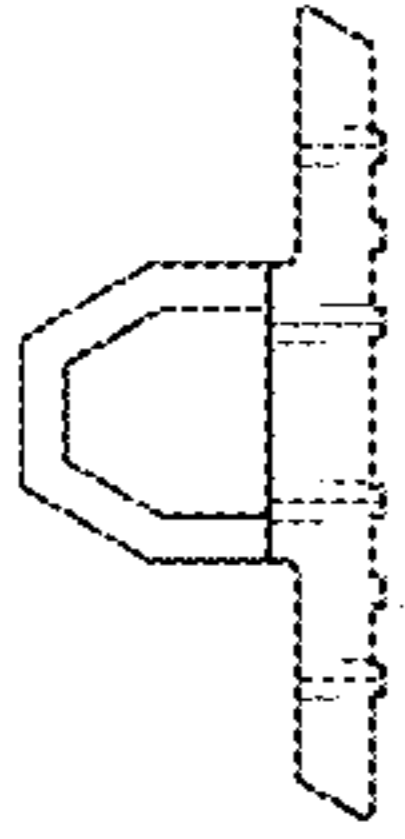

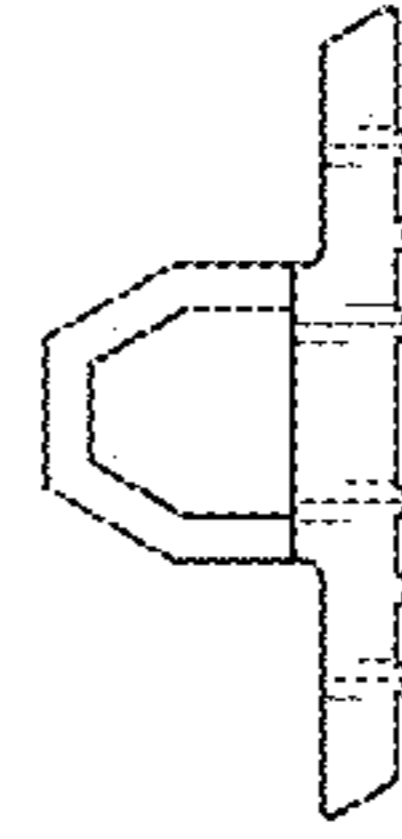

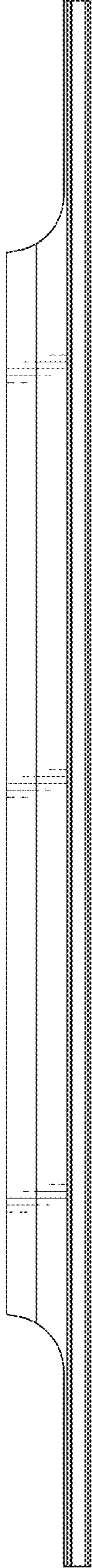

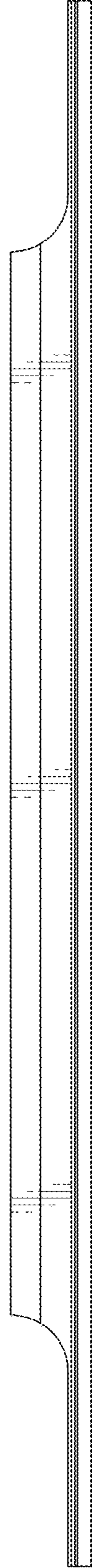

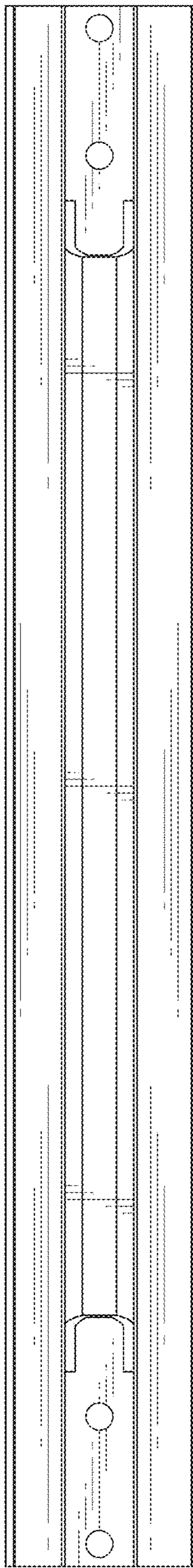

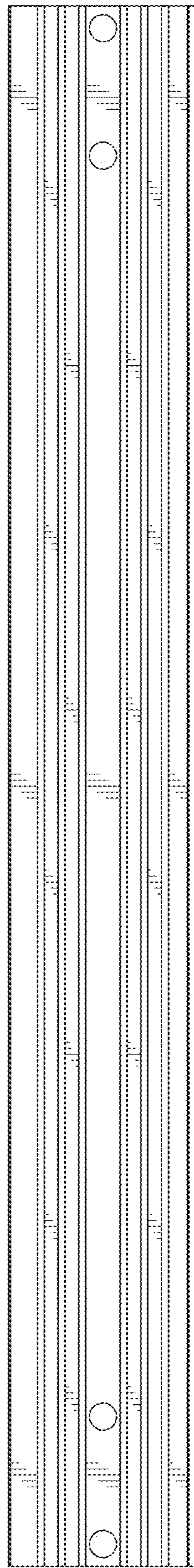

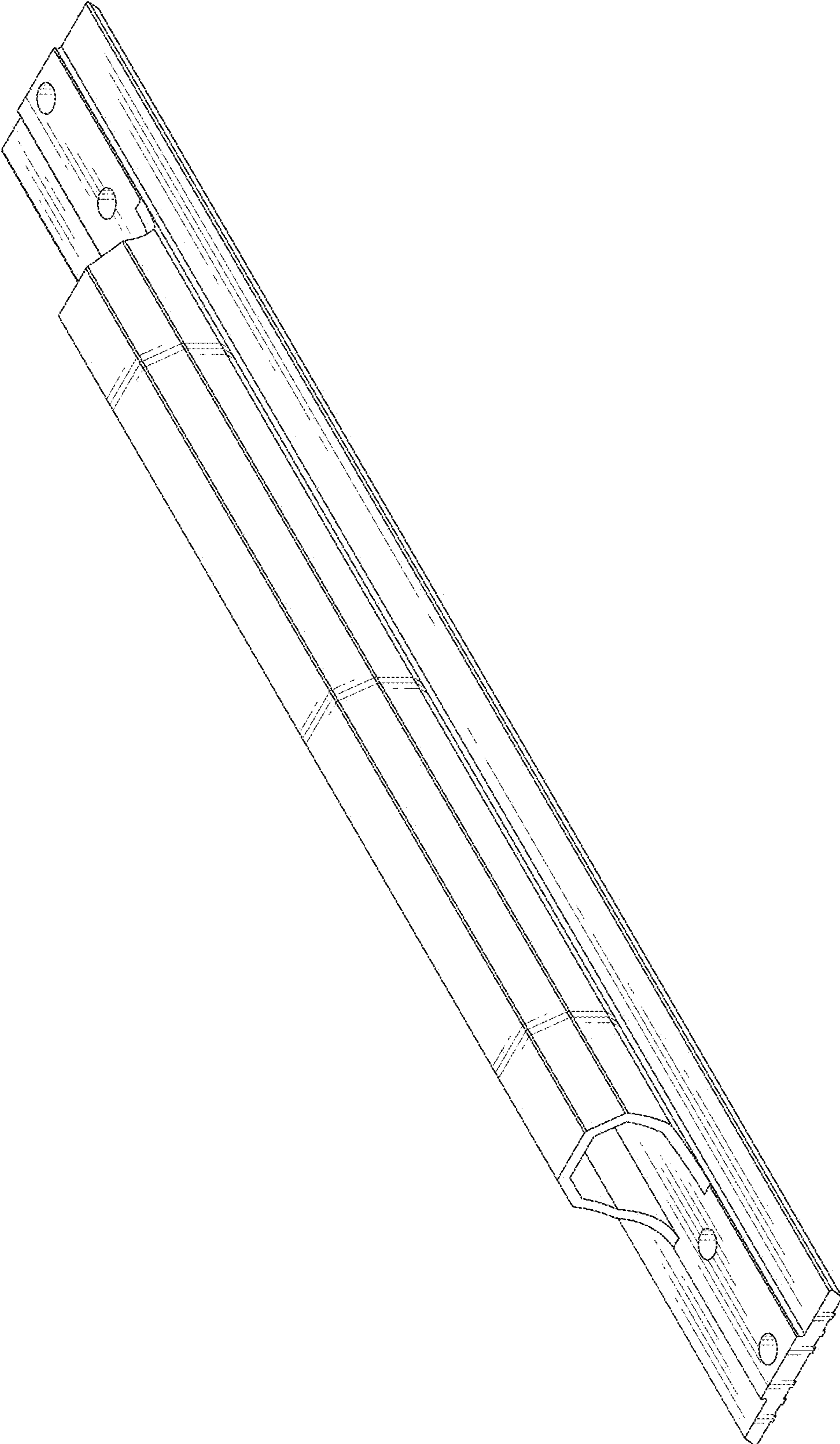

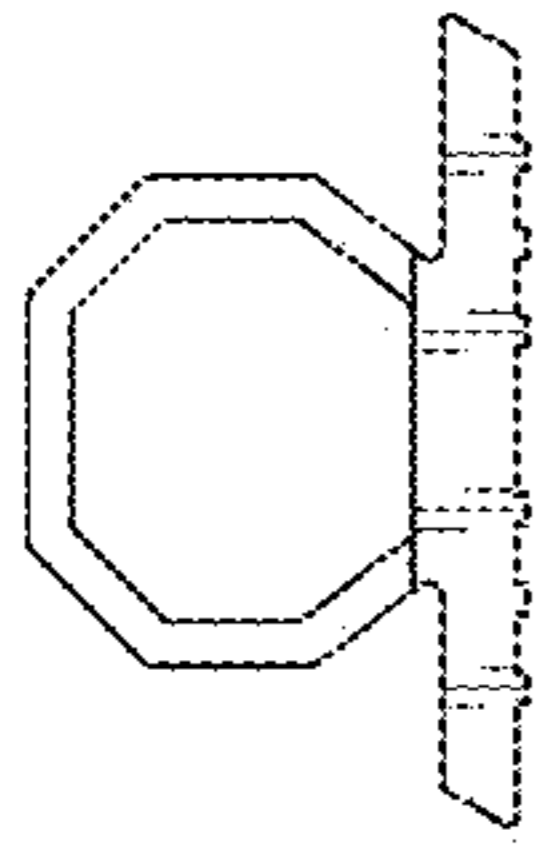

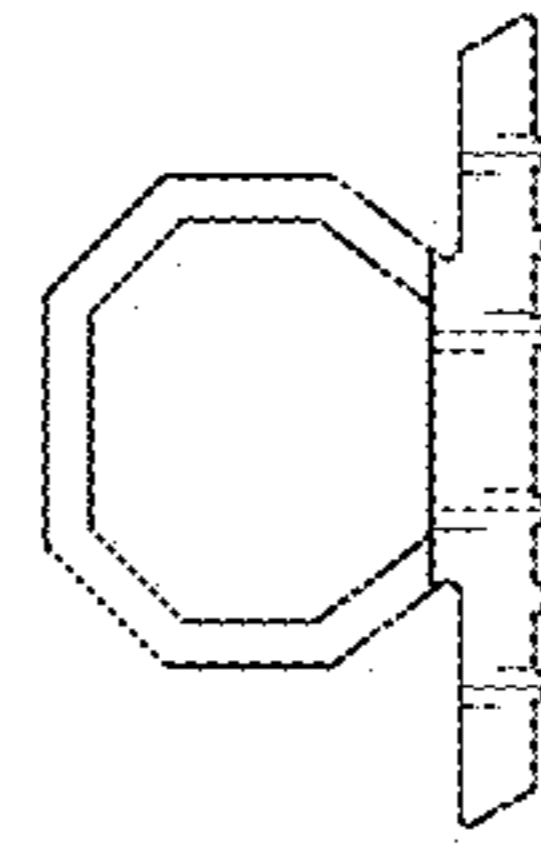

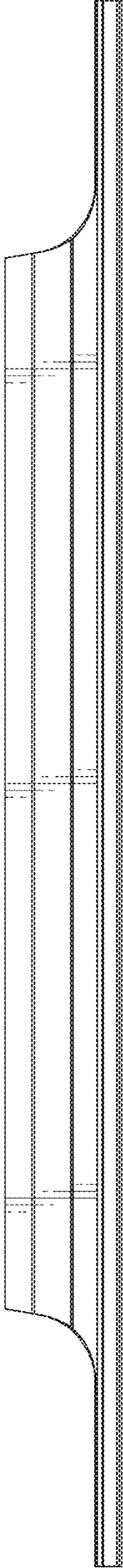

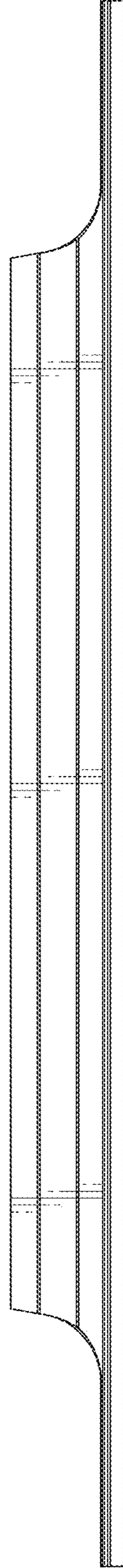

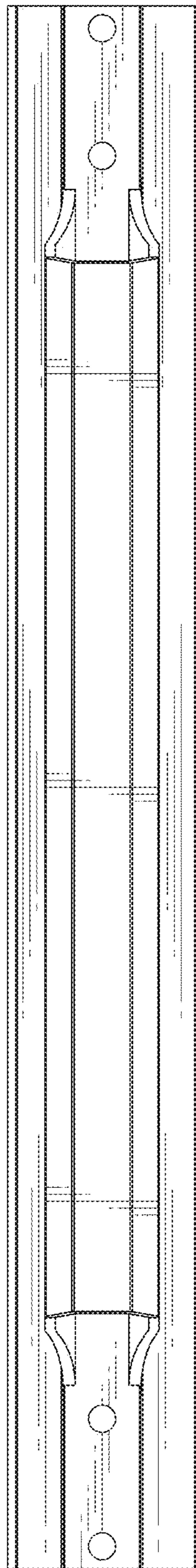

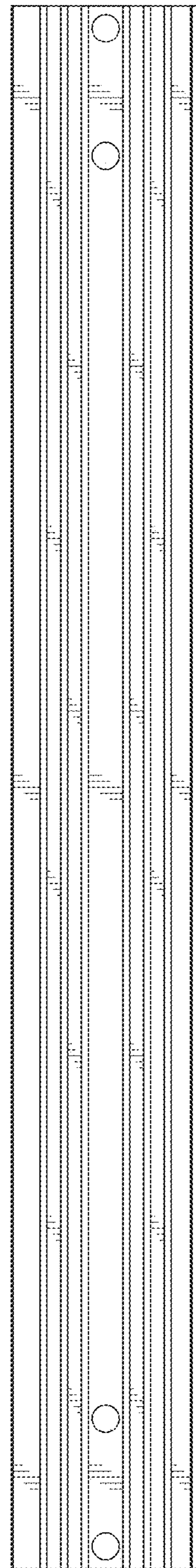

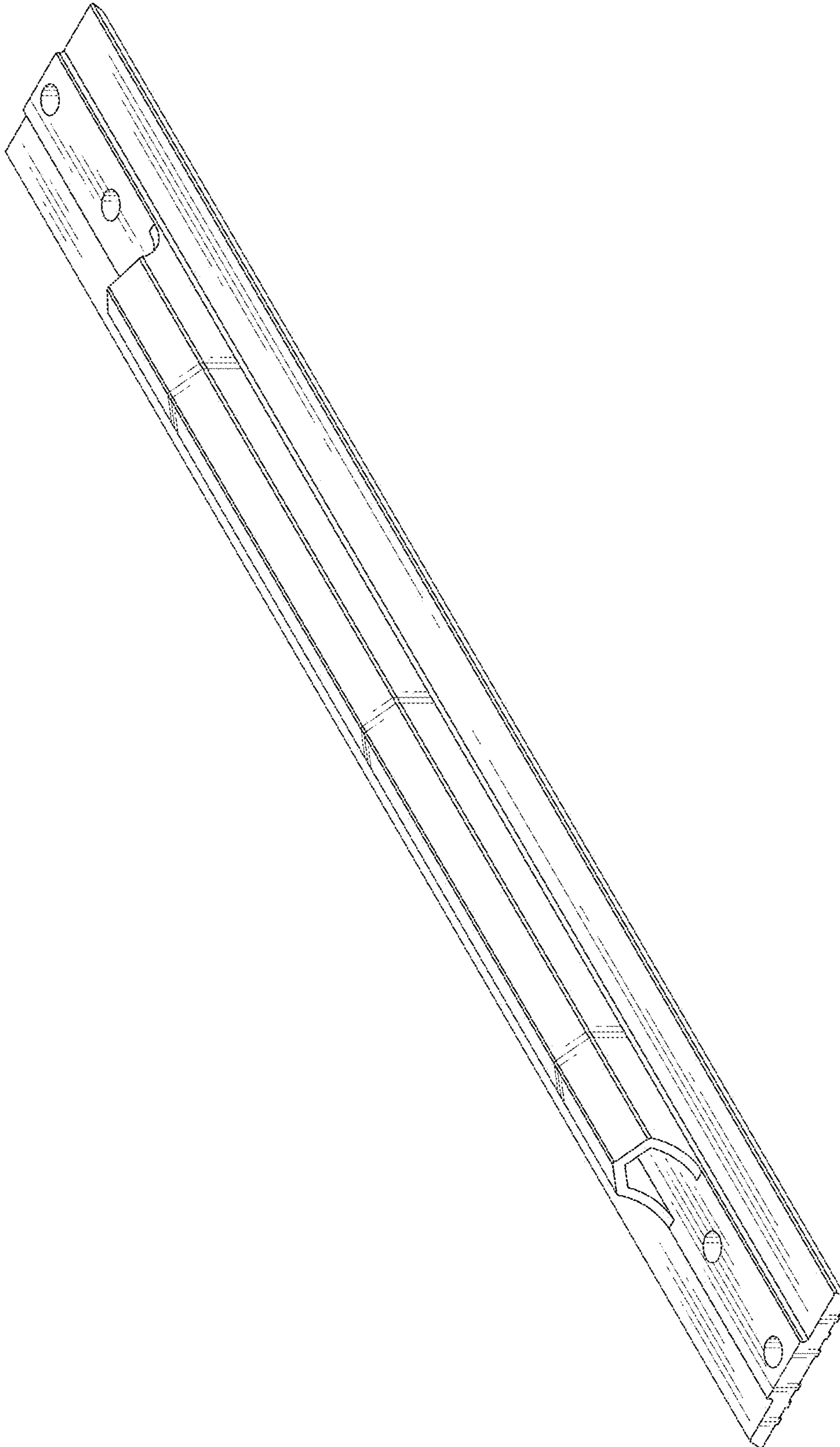

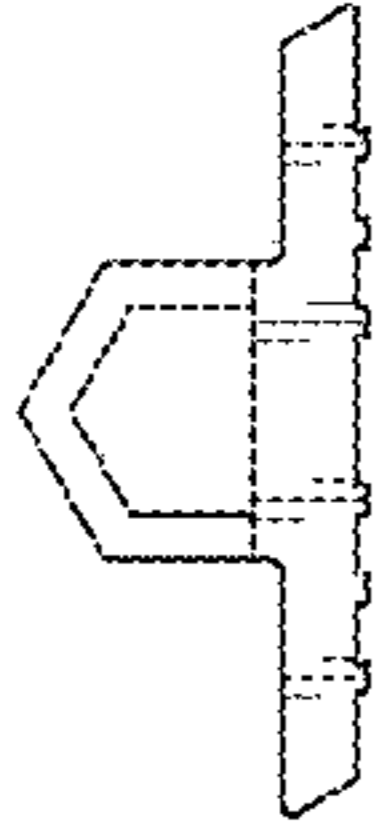

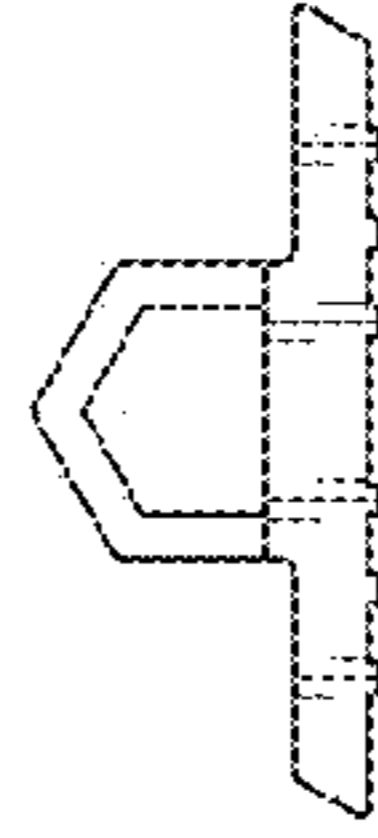

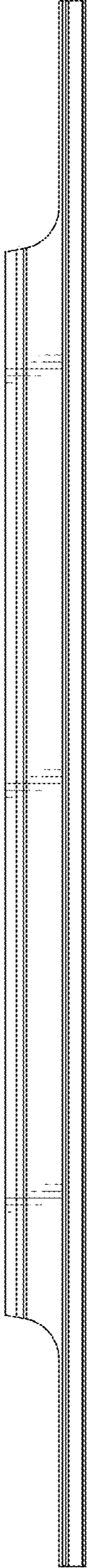

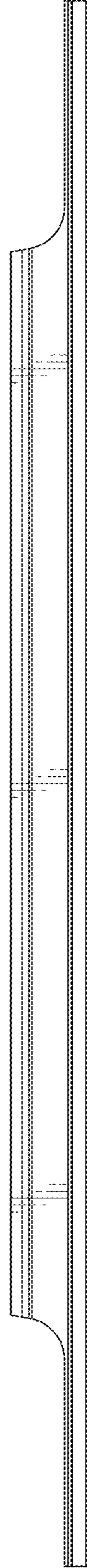

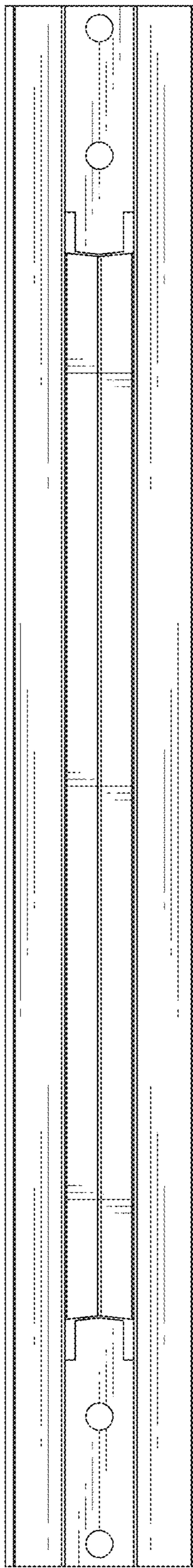

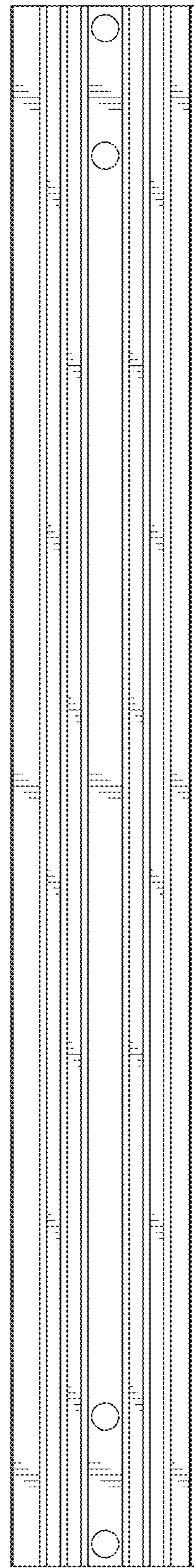

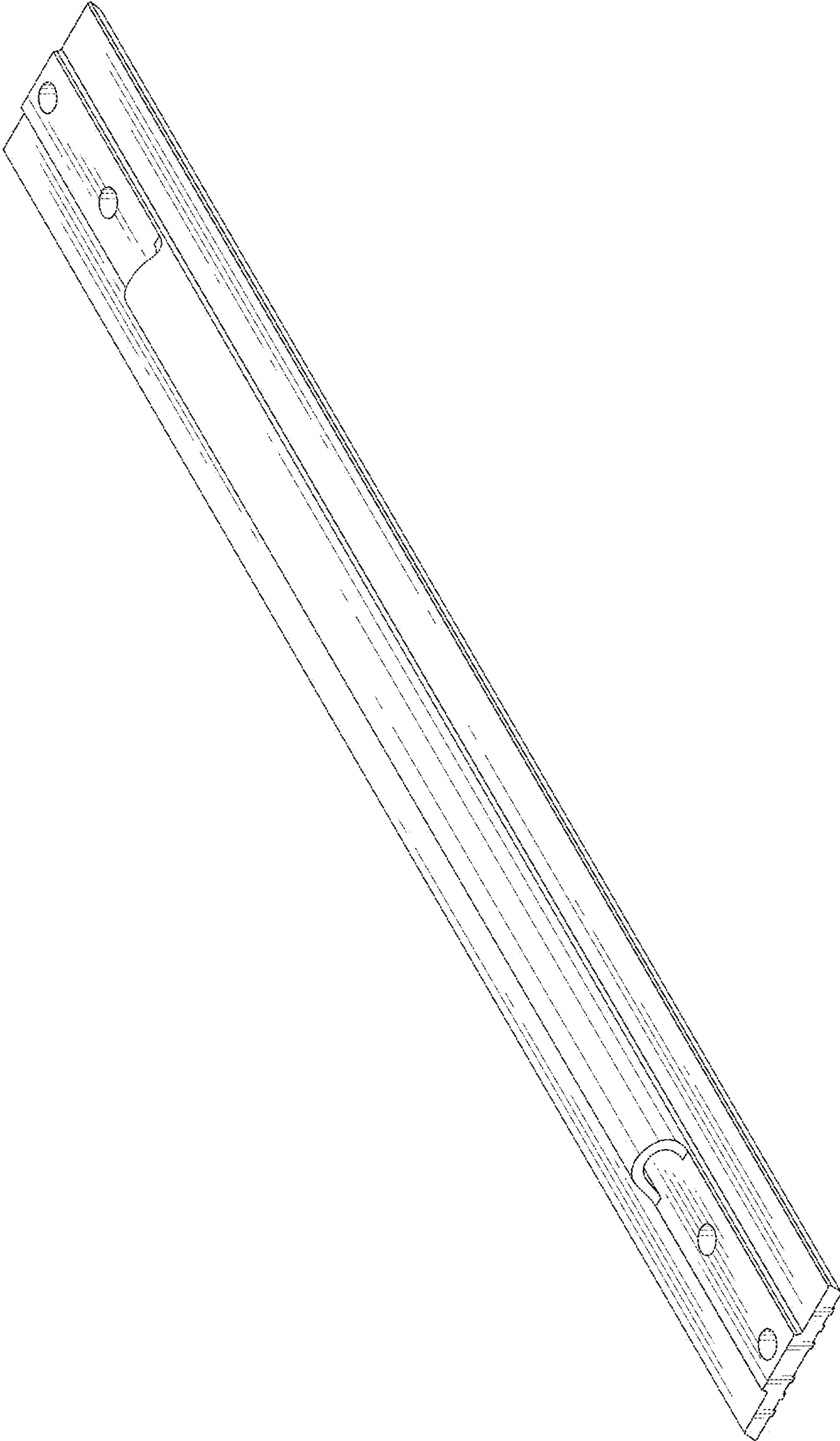

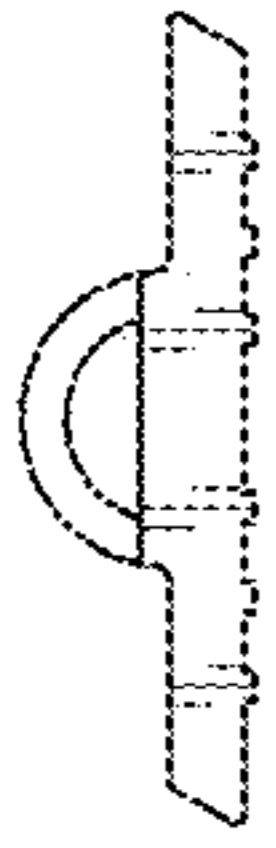

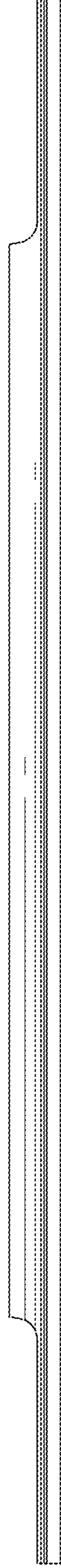

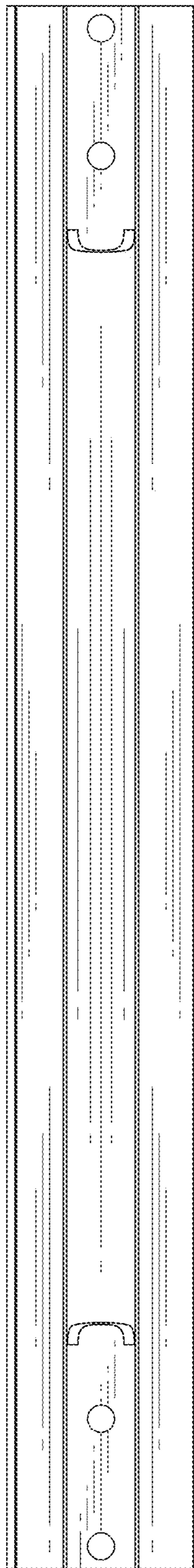

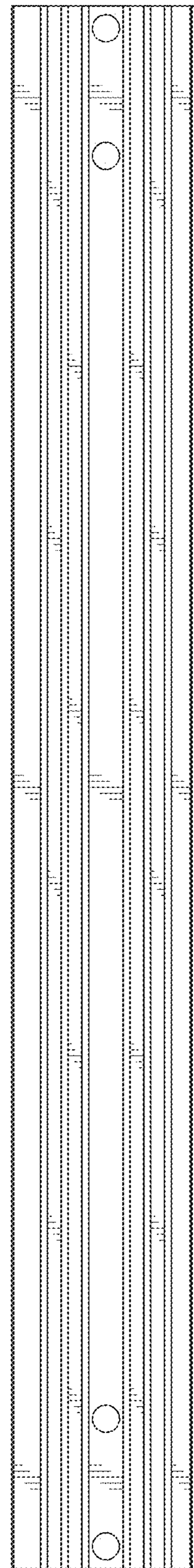

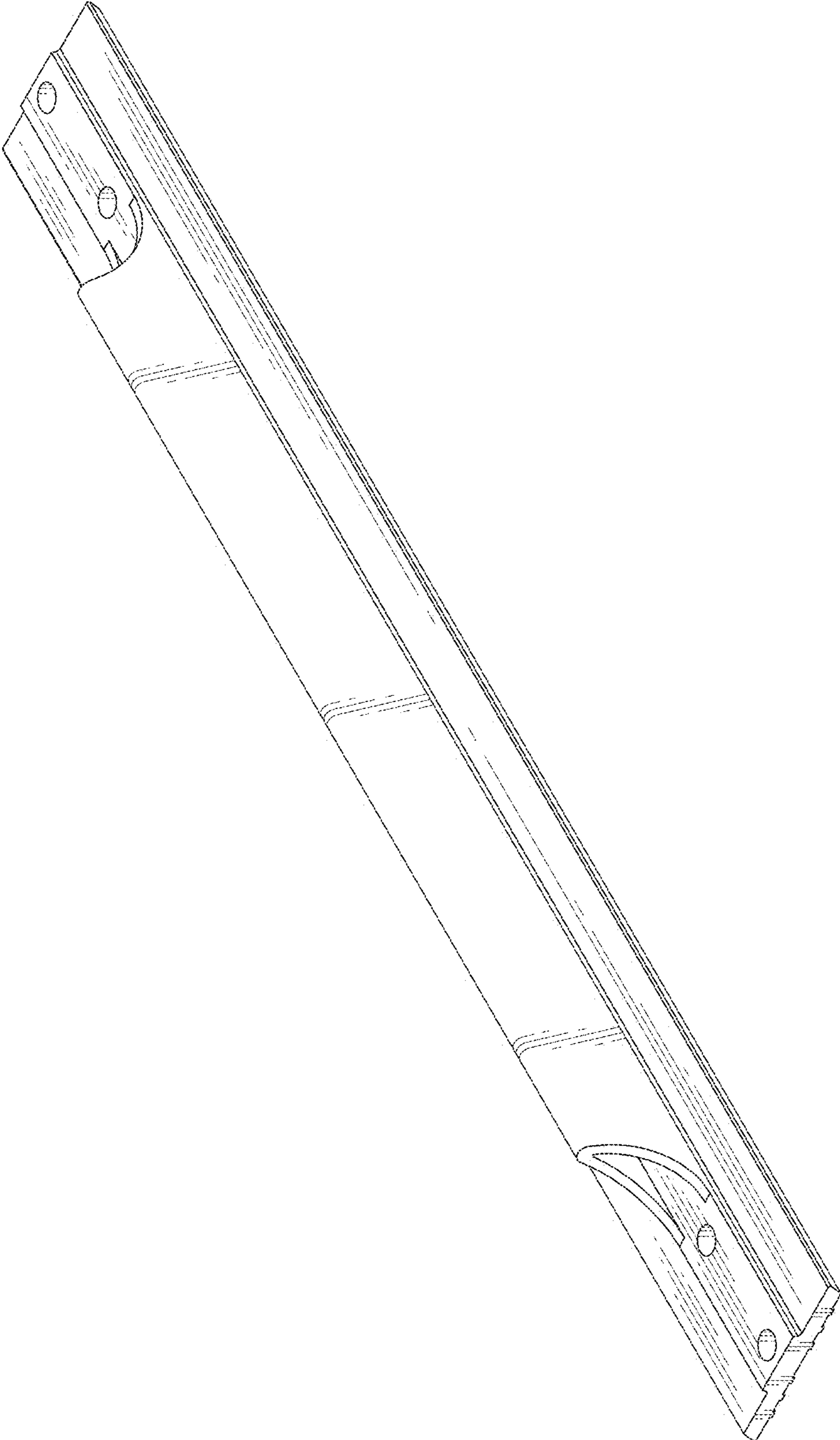

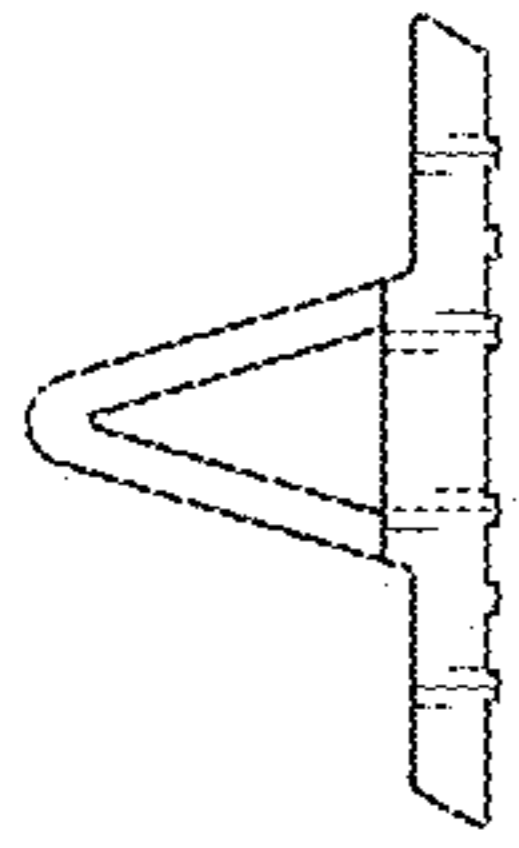

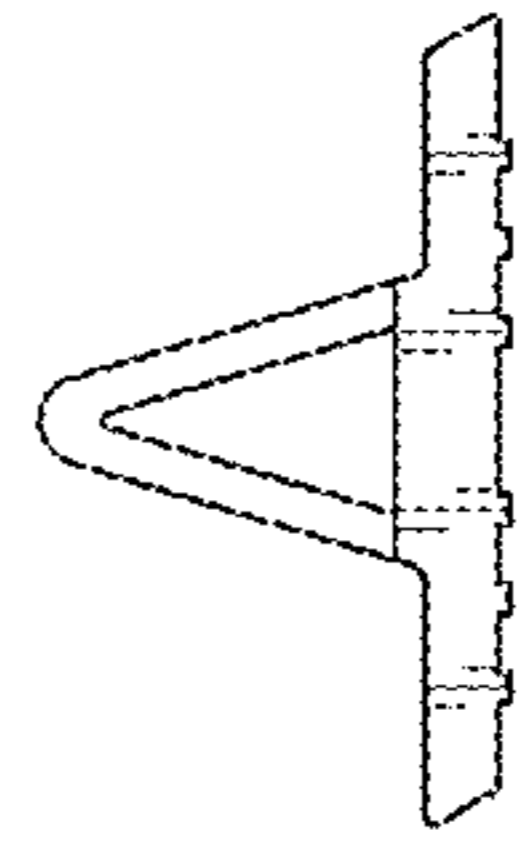

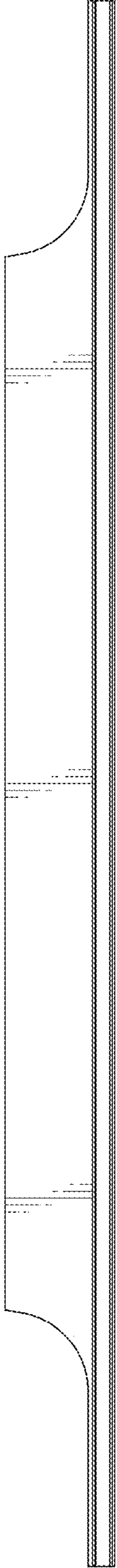

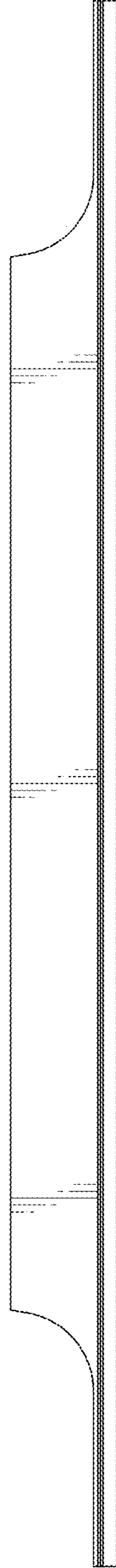

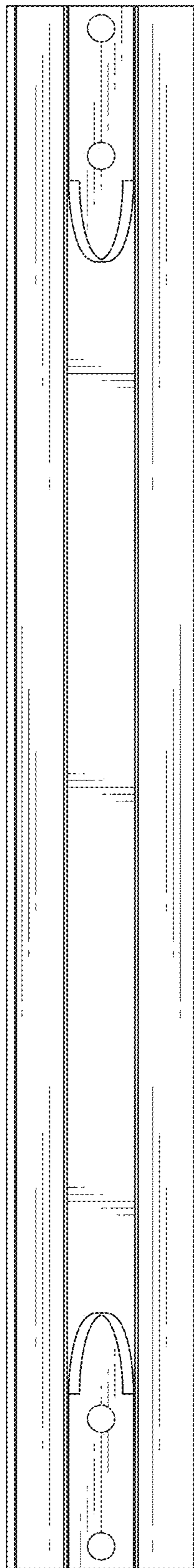

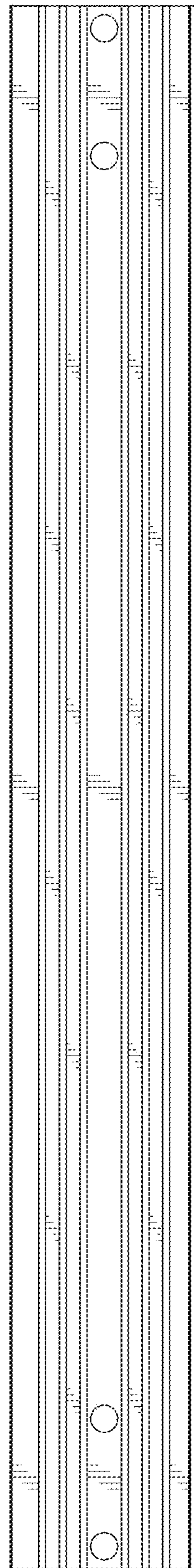
