(57) **CLAIM**

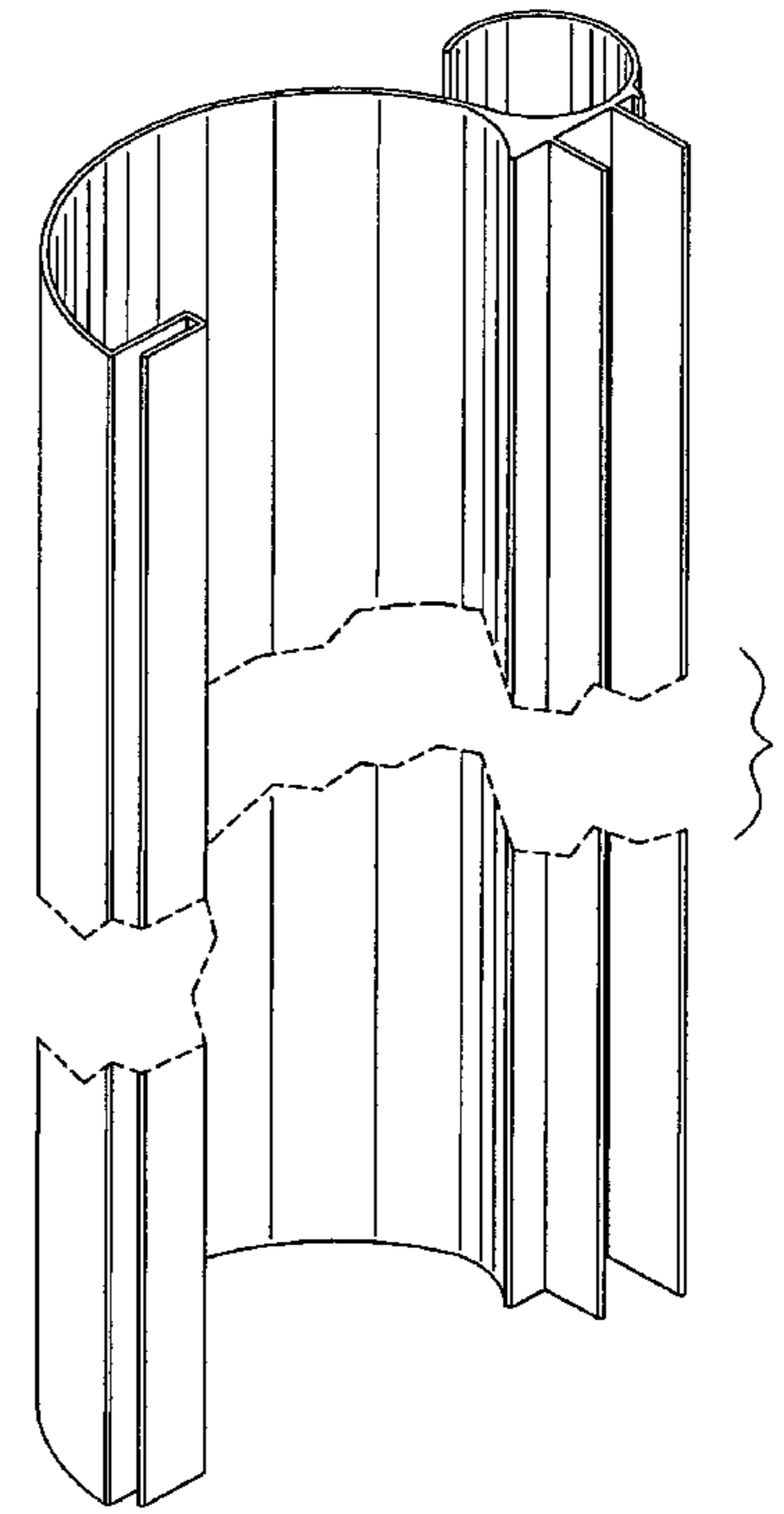
The ornamental design for an eavestrough, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of an eavestrough showing my new design;
FIG. 2 is a side elevation view thereof; and,

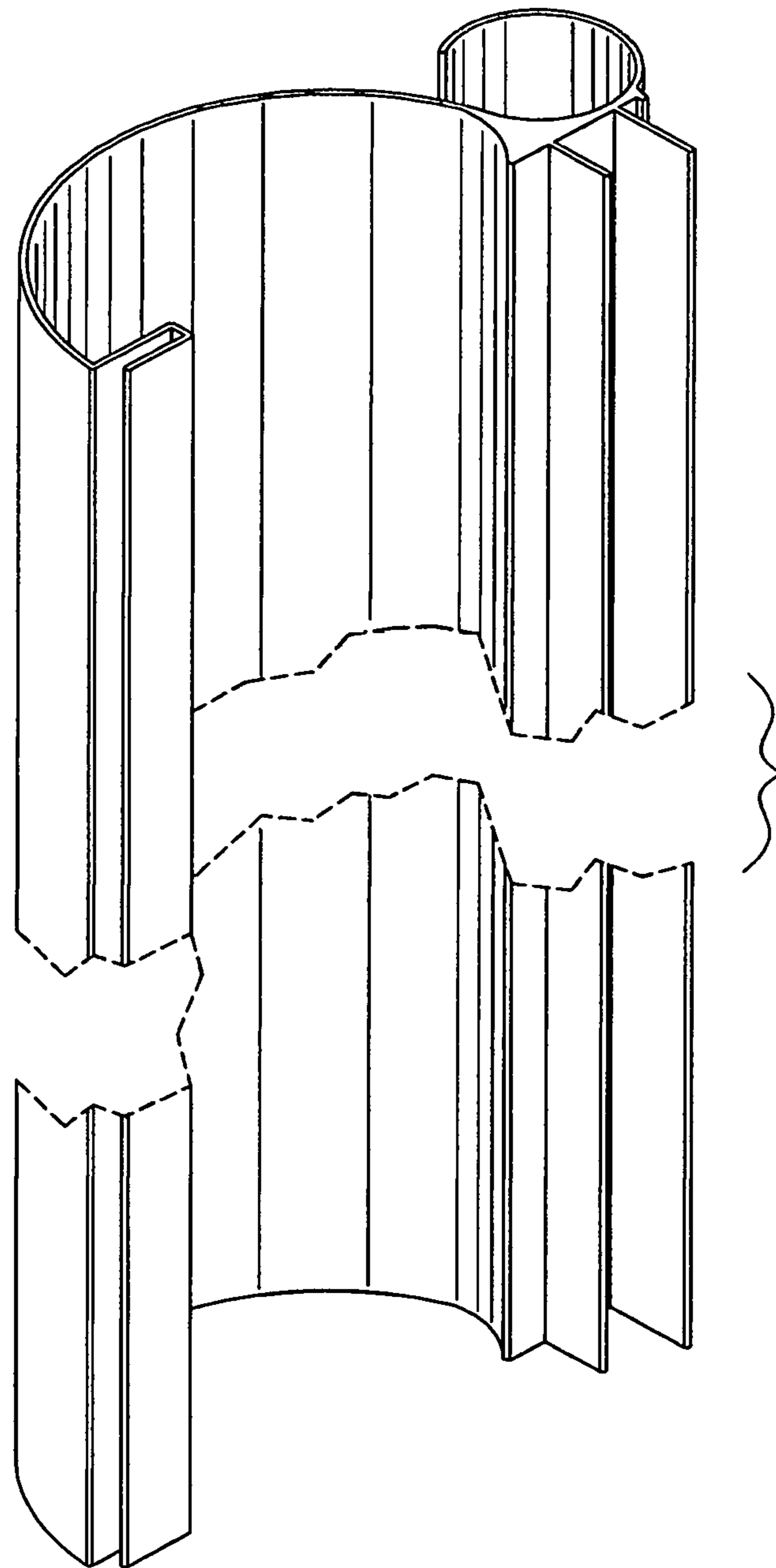

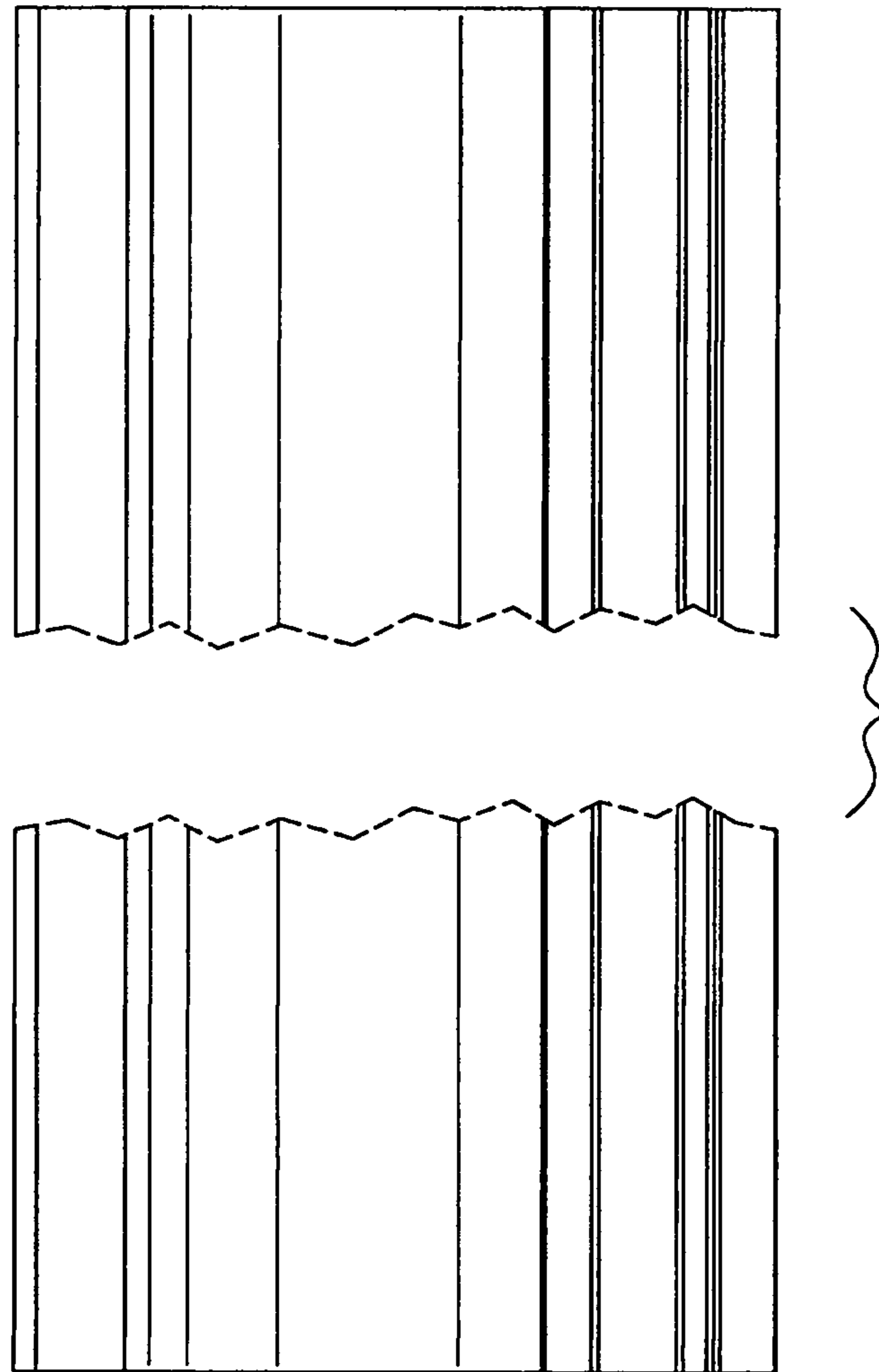

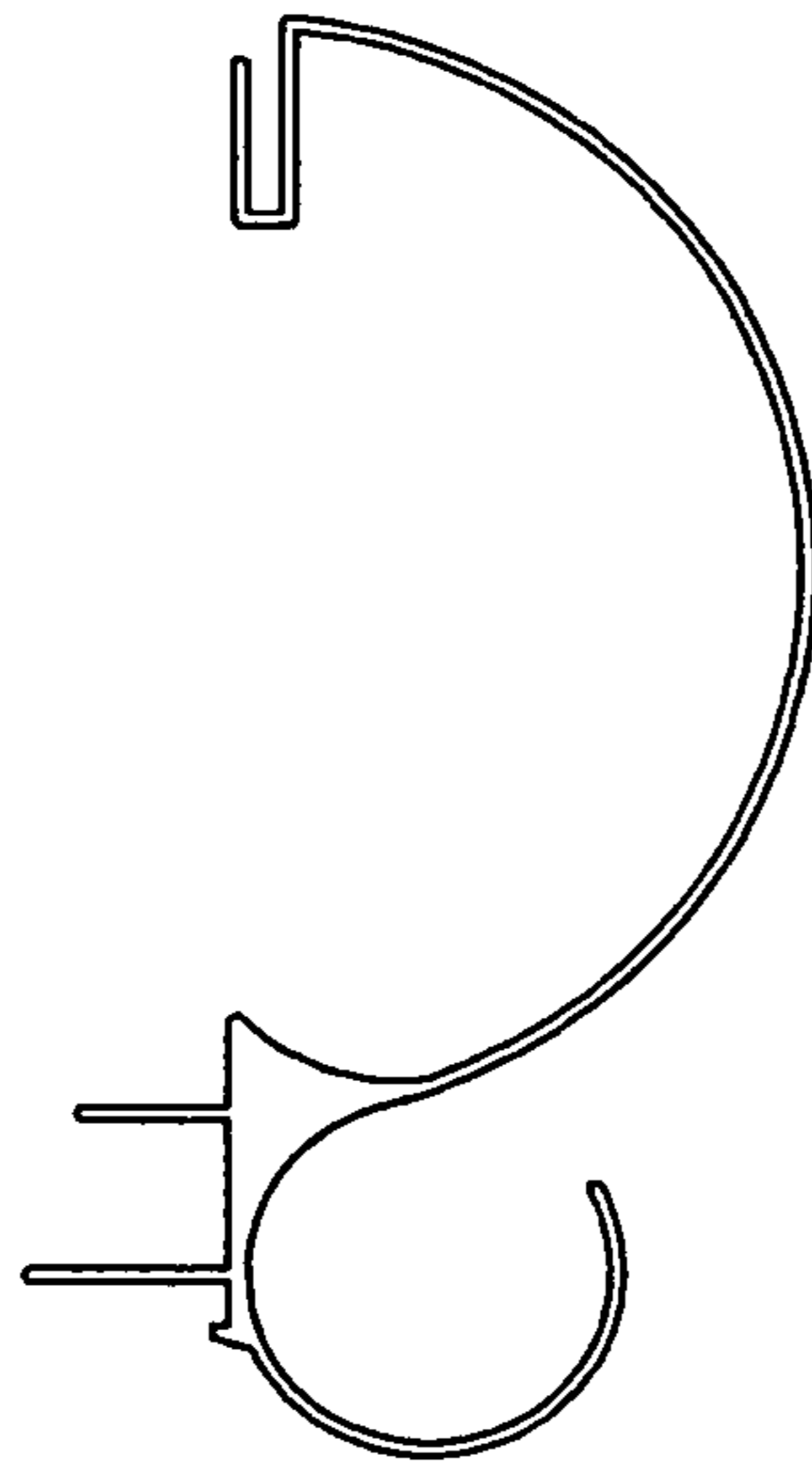
