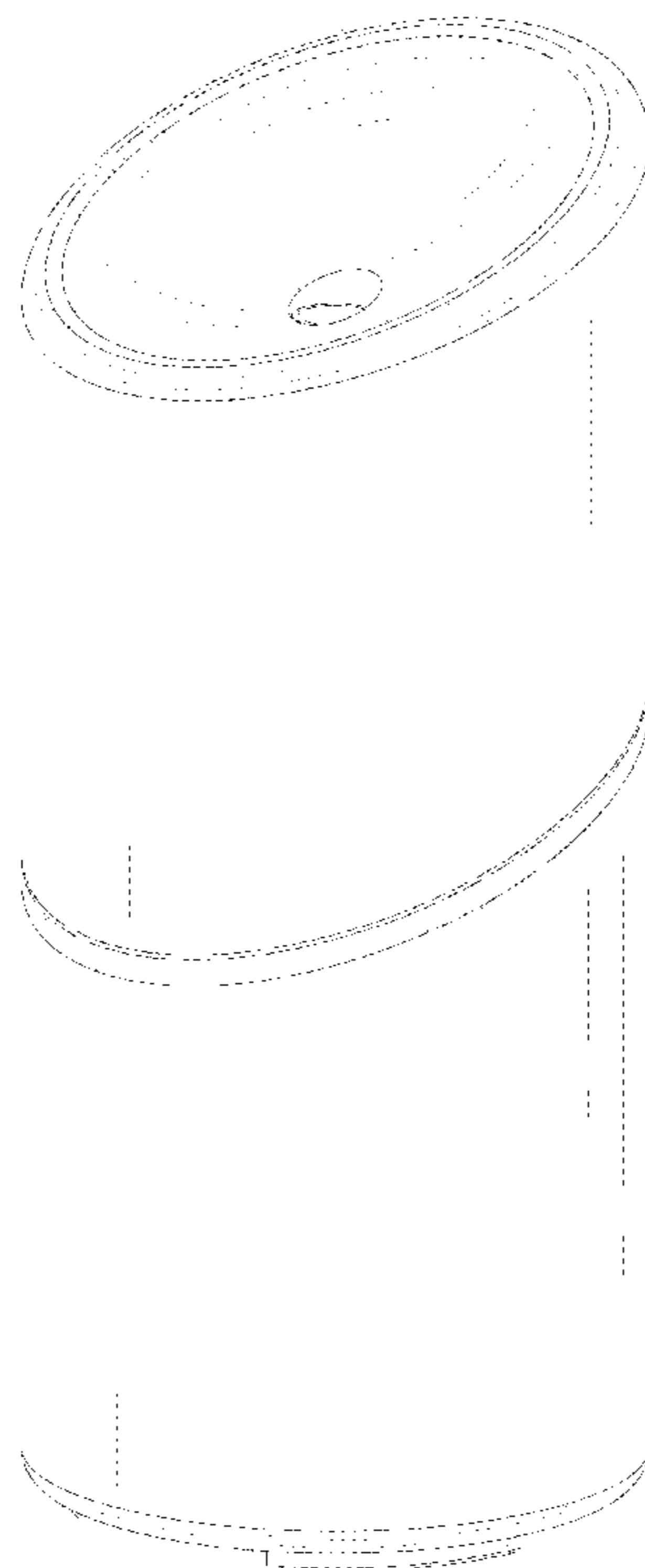

DESCRIPTION
FIG. 1 is a perspective view of an aroma diffuser showing my new design;

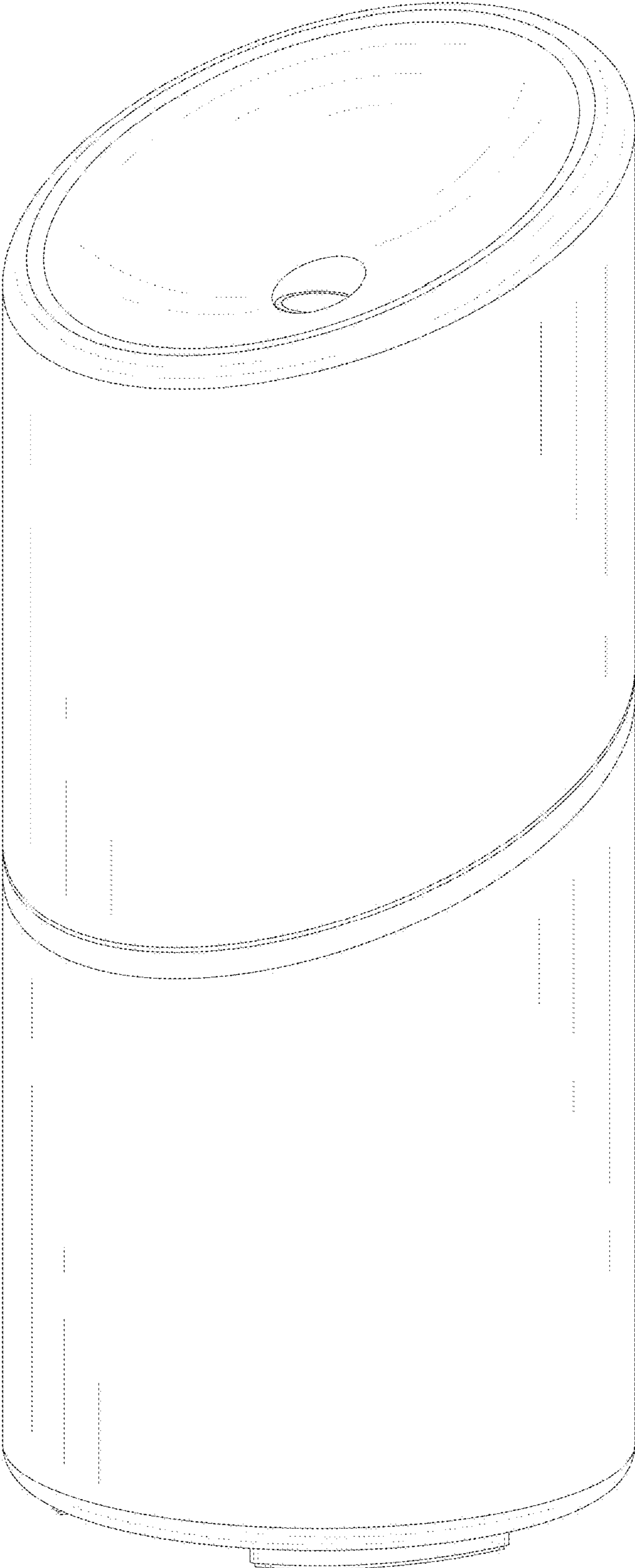

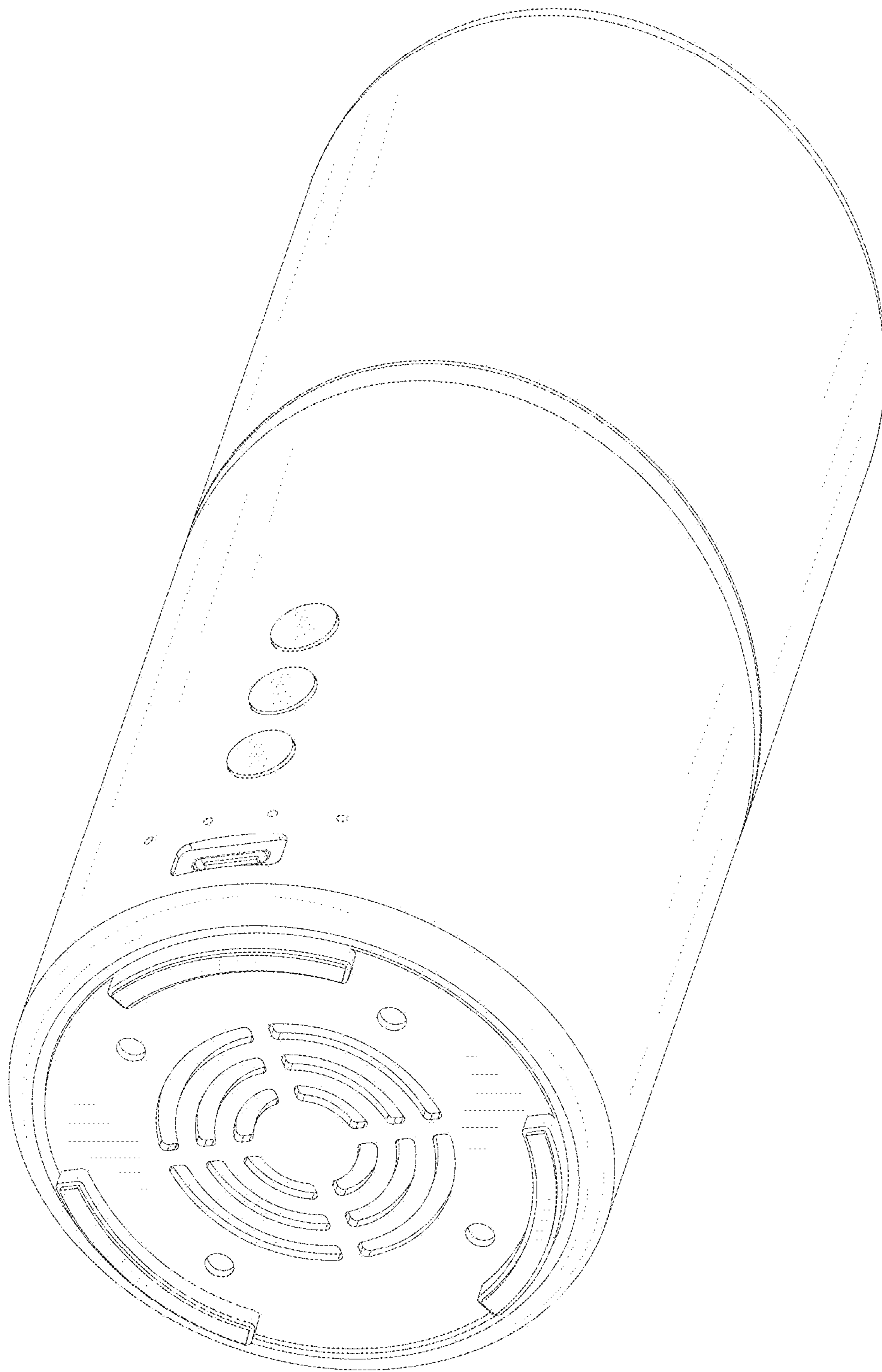

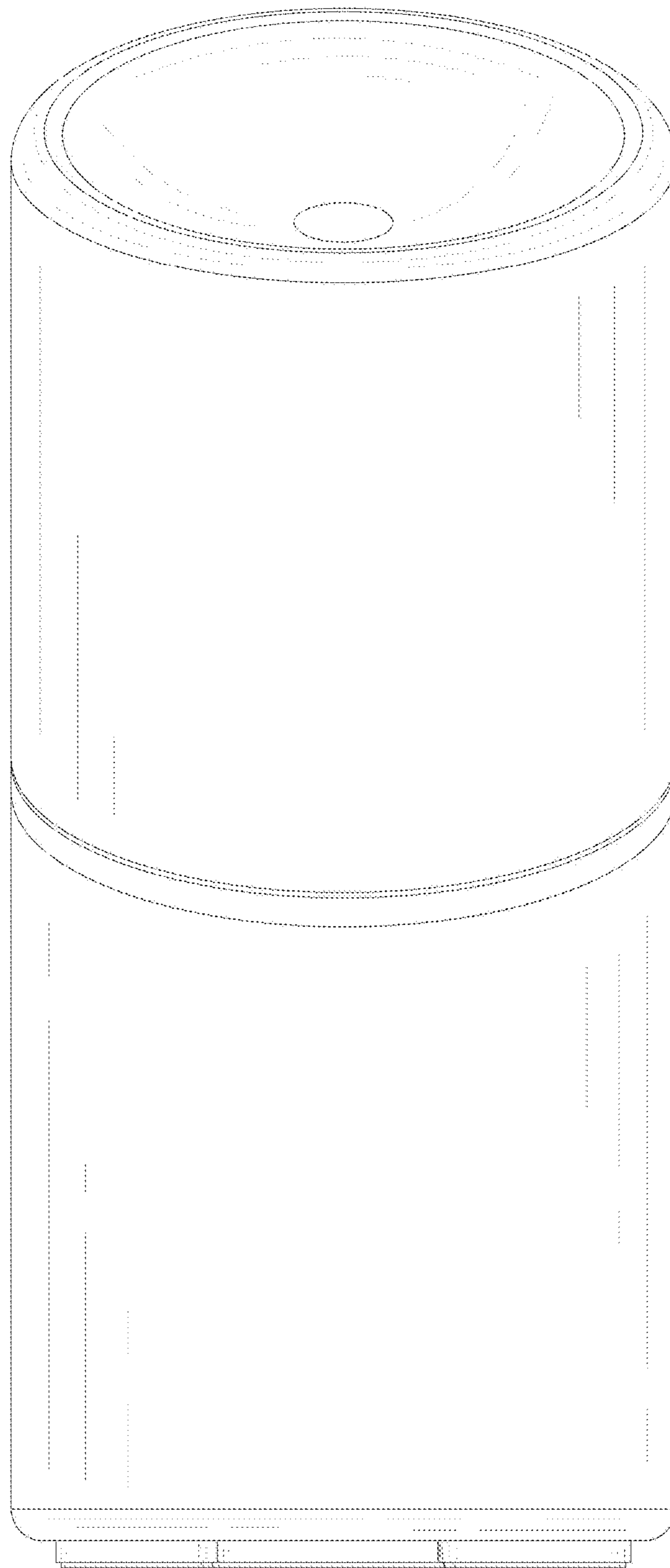

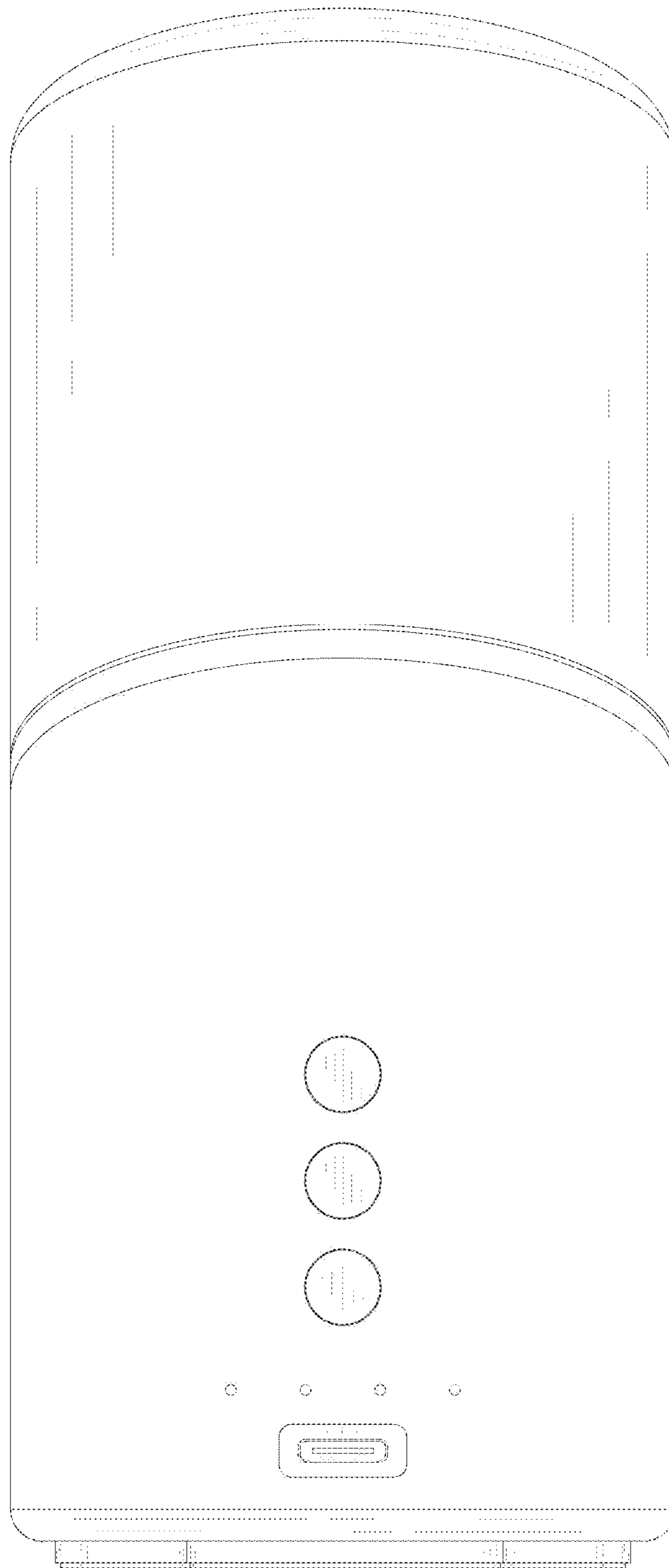

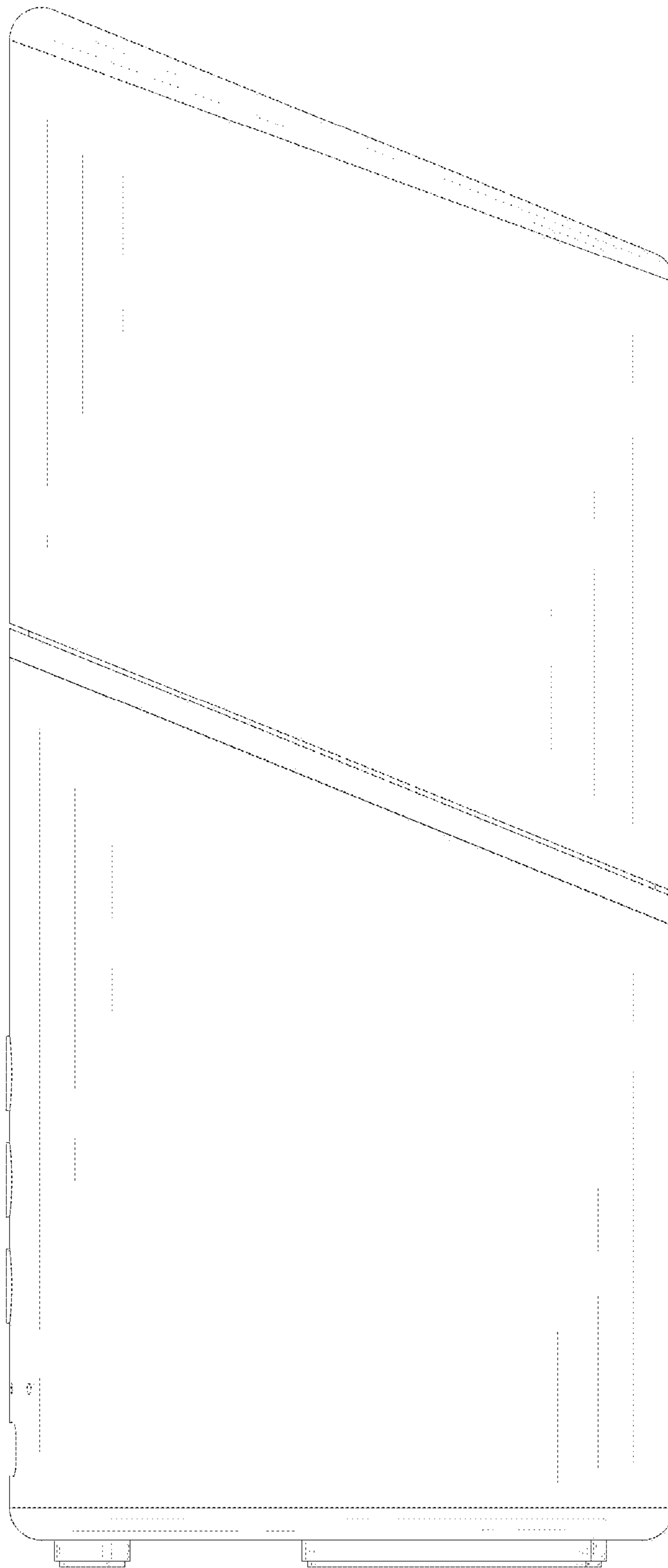

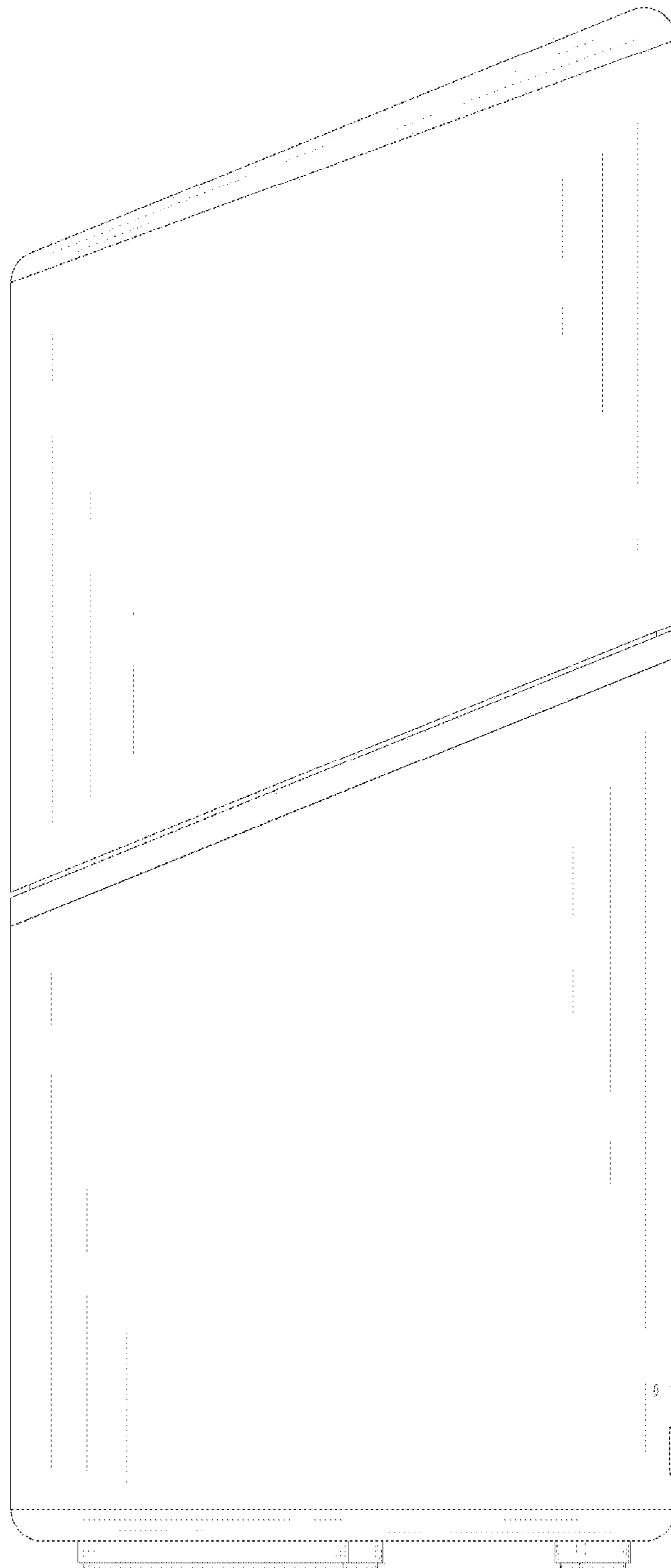

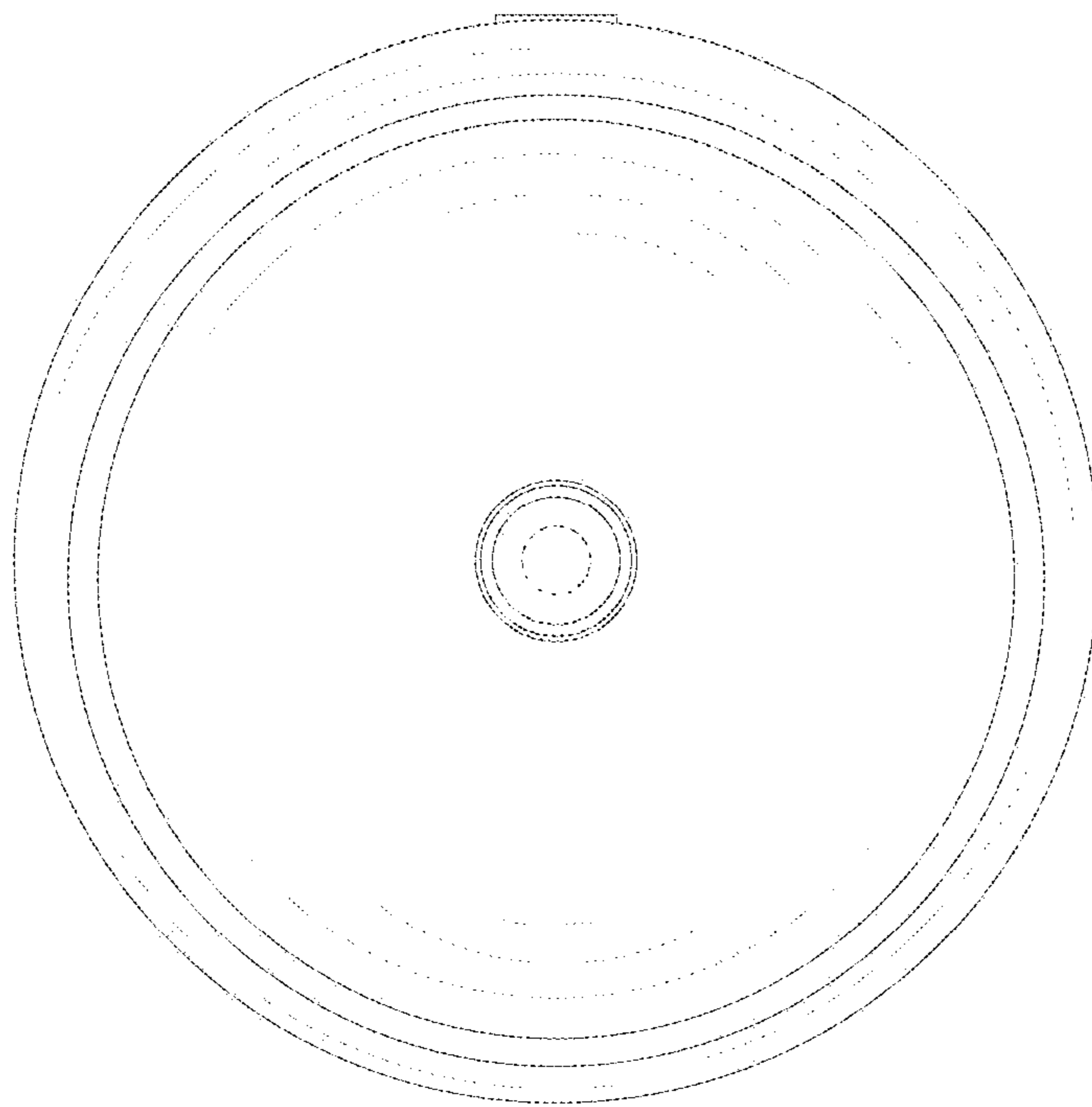

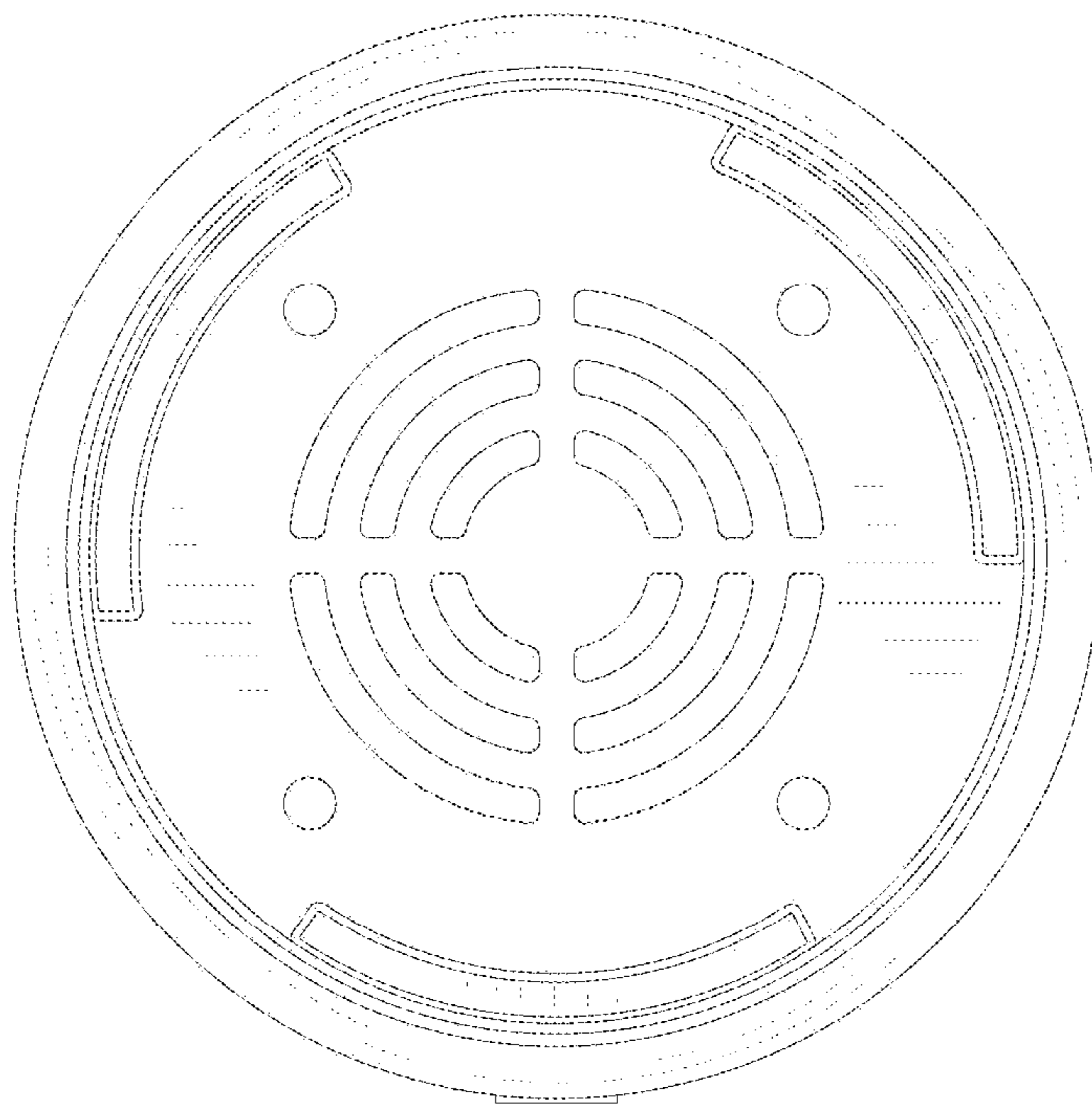
