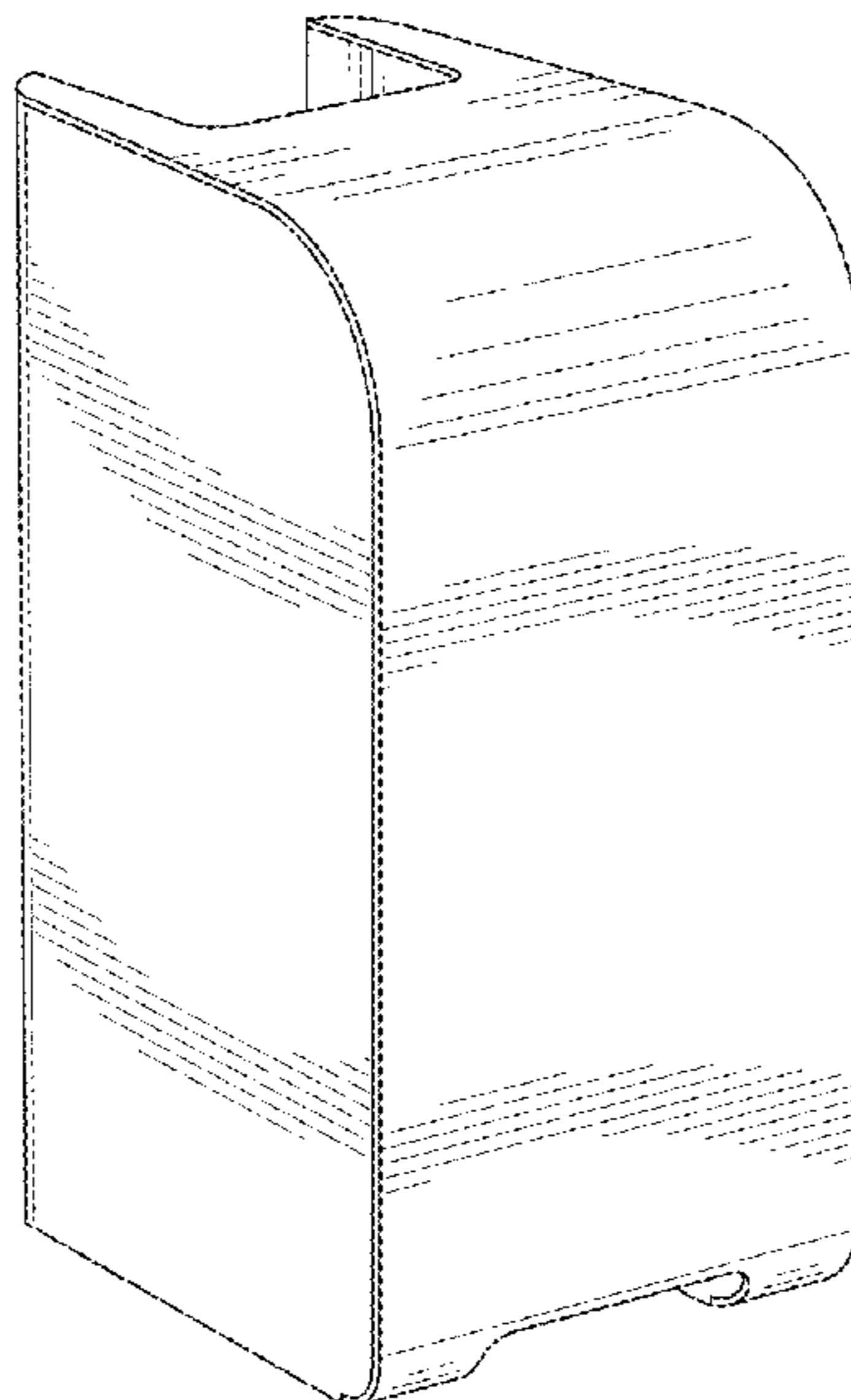
(57) **CLAIM**

We claim the ornamental design for a cartridge for an eyewash station, as shown and described.

DESCRIPTION

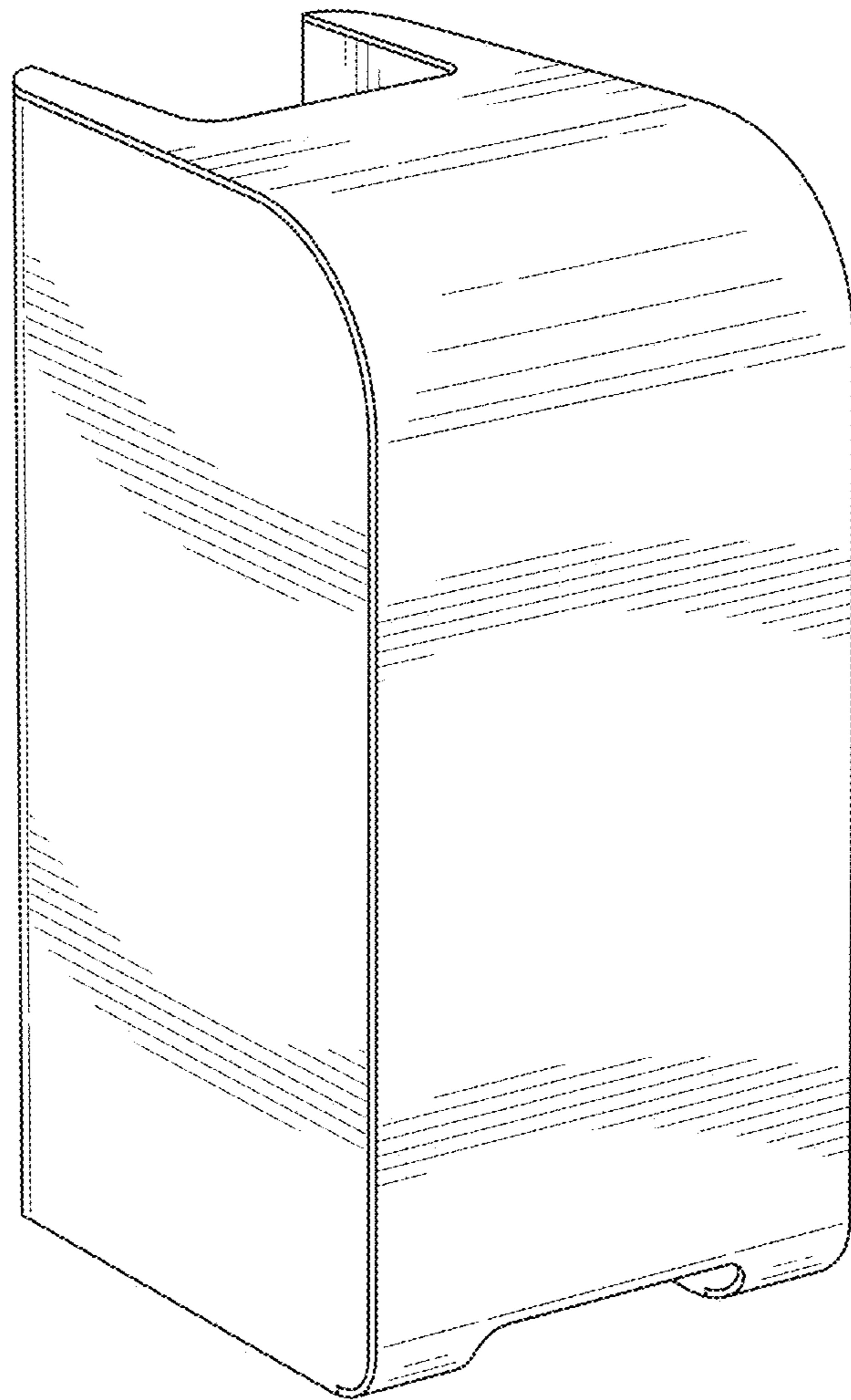

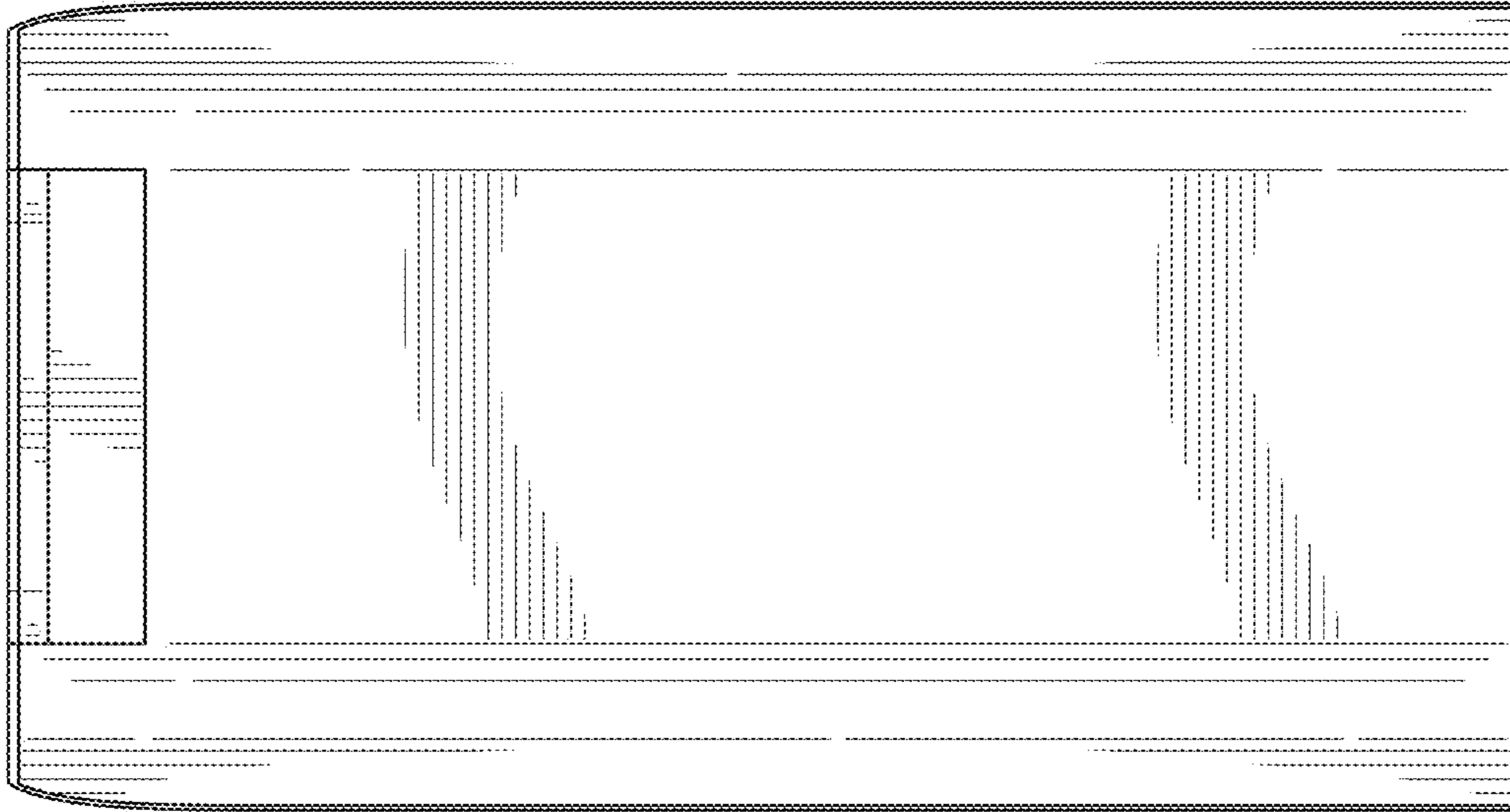

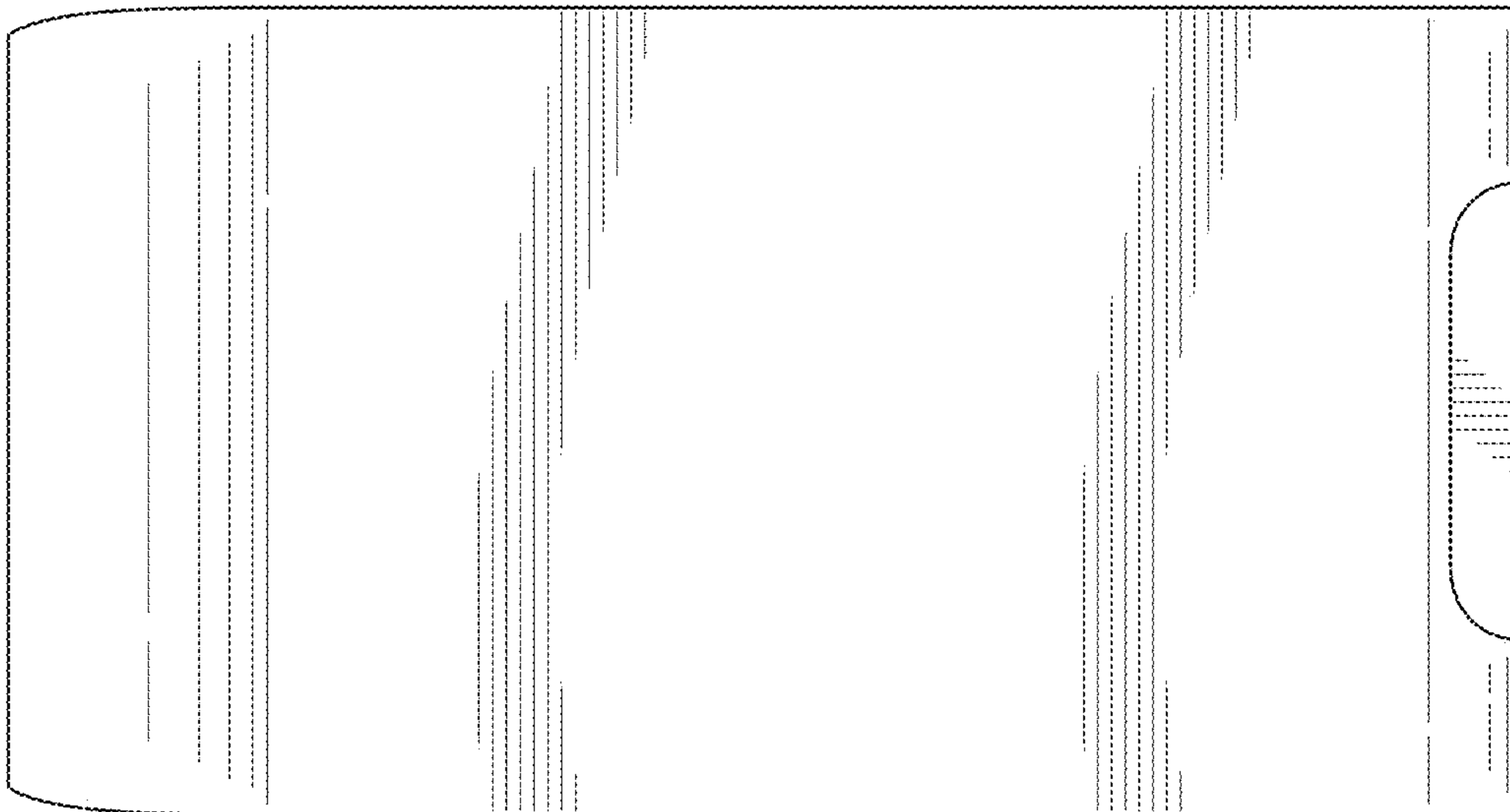

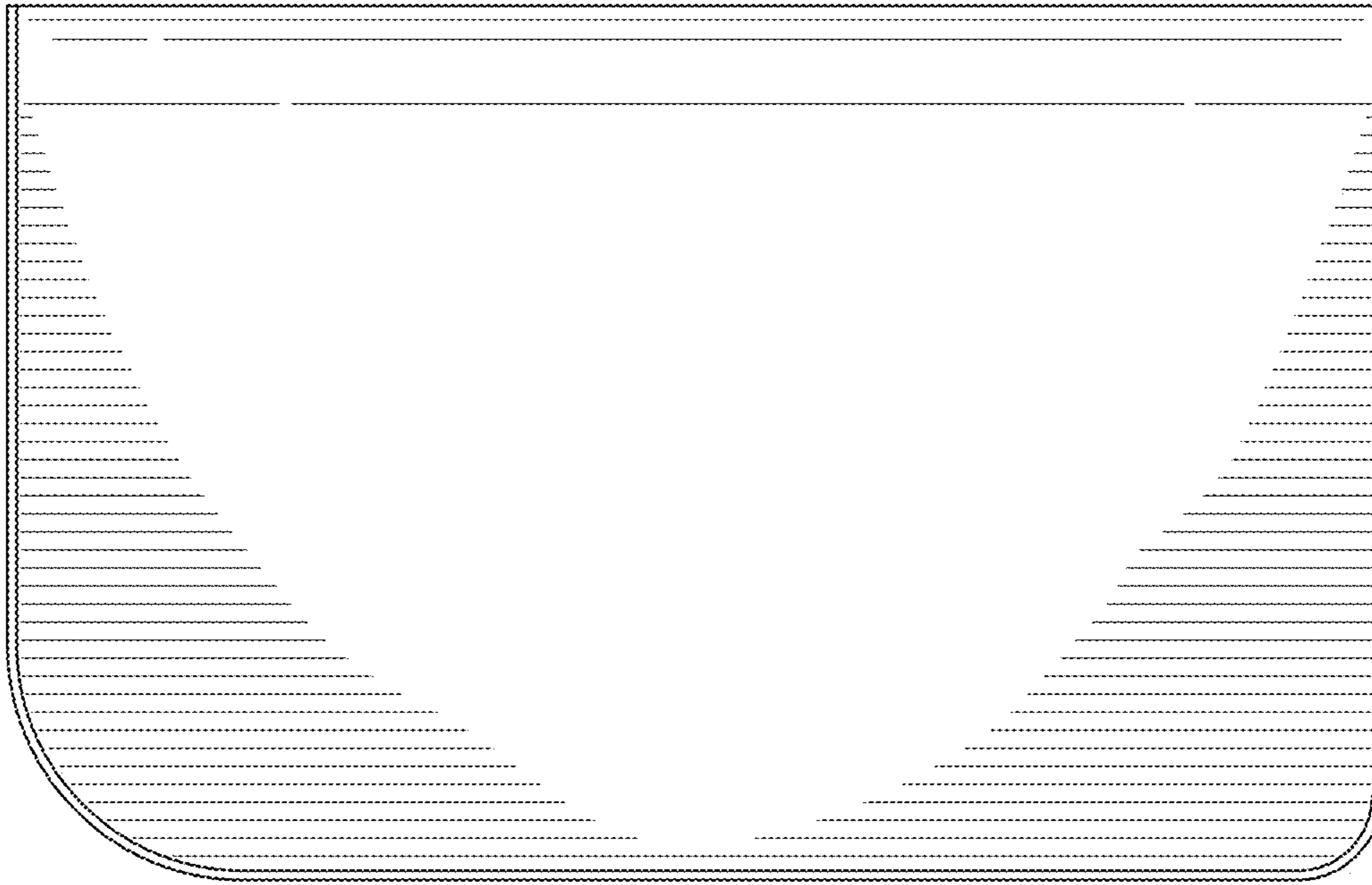

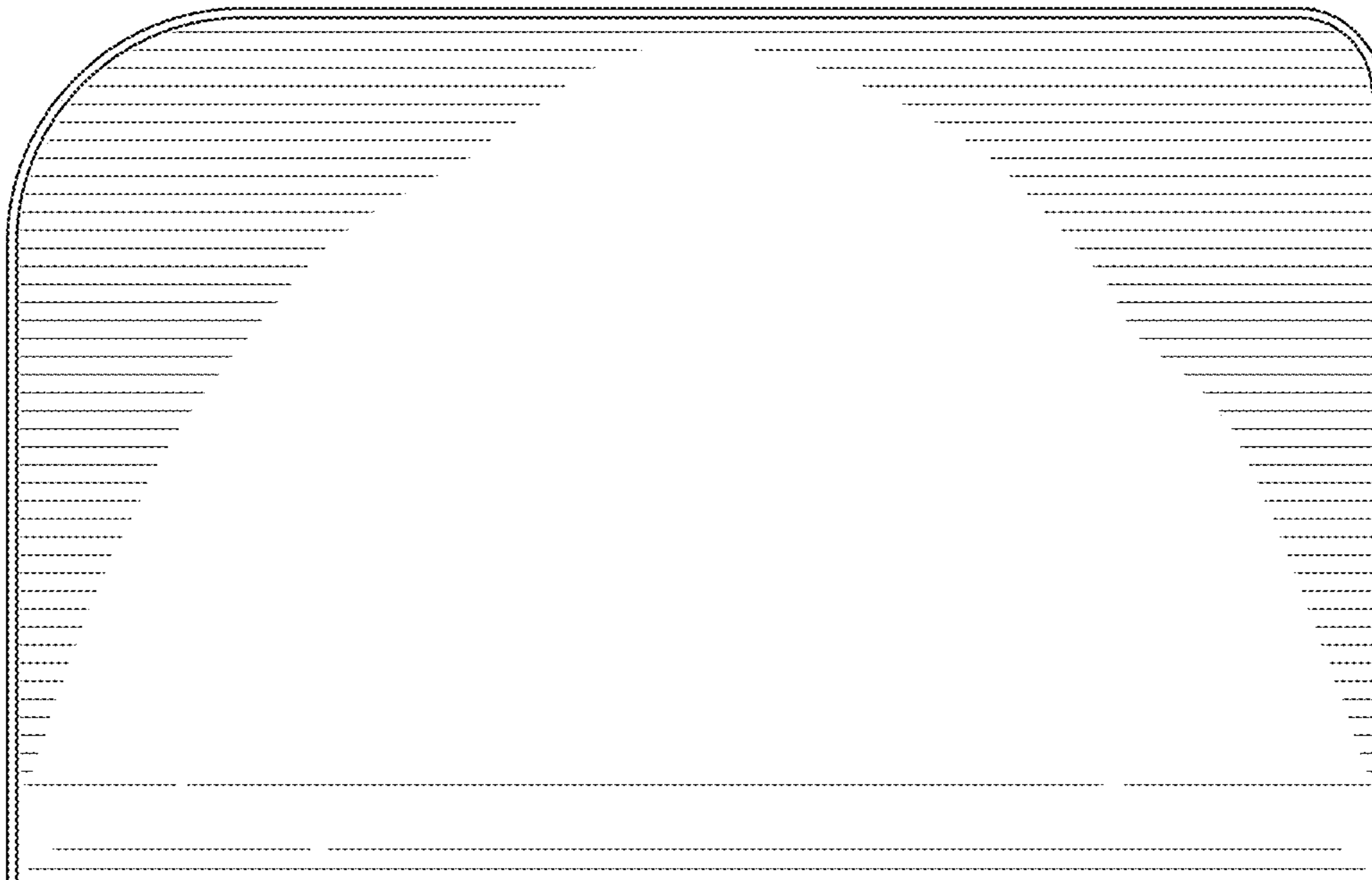

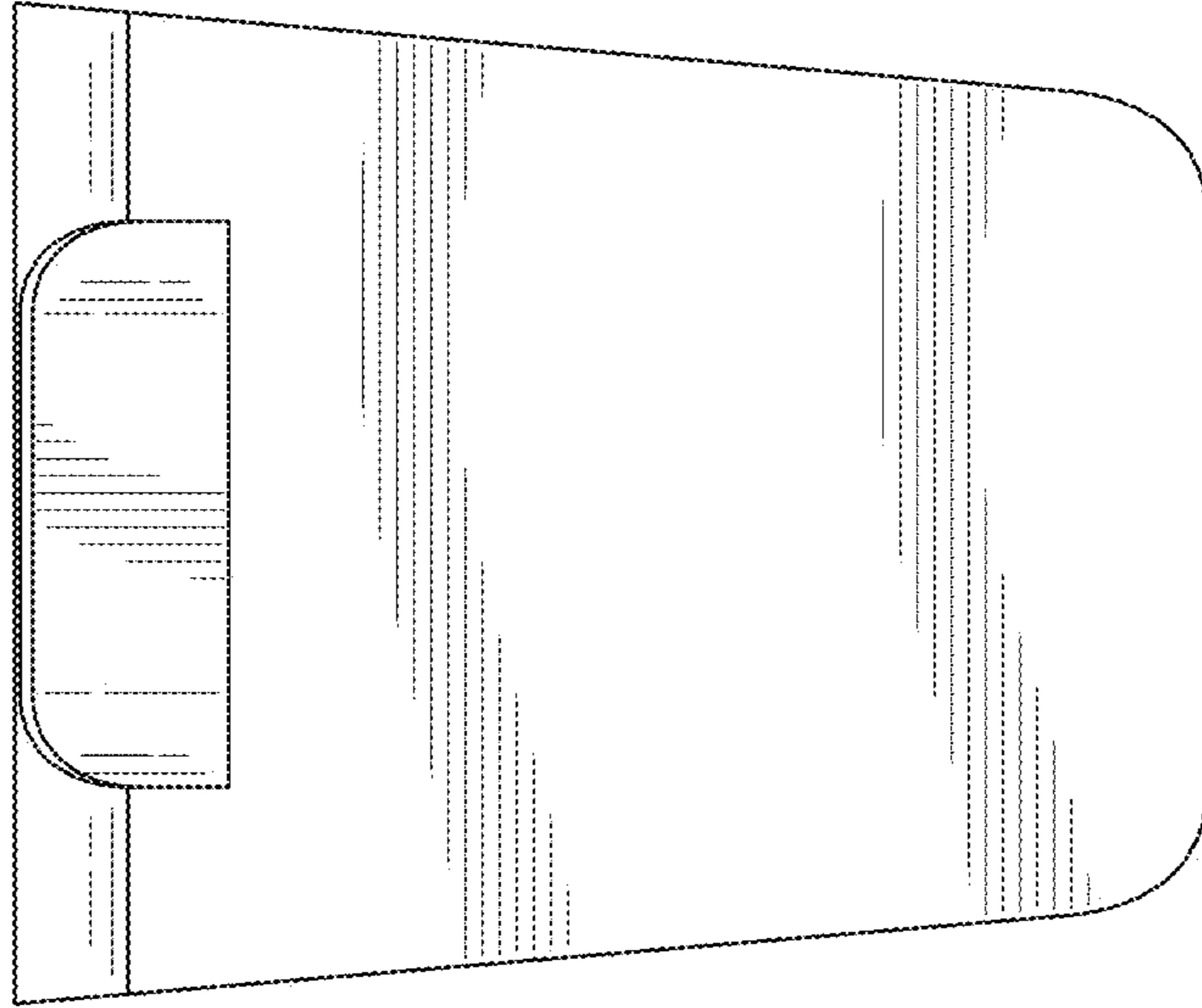

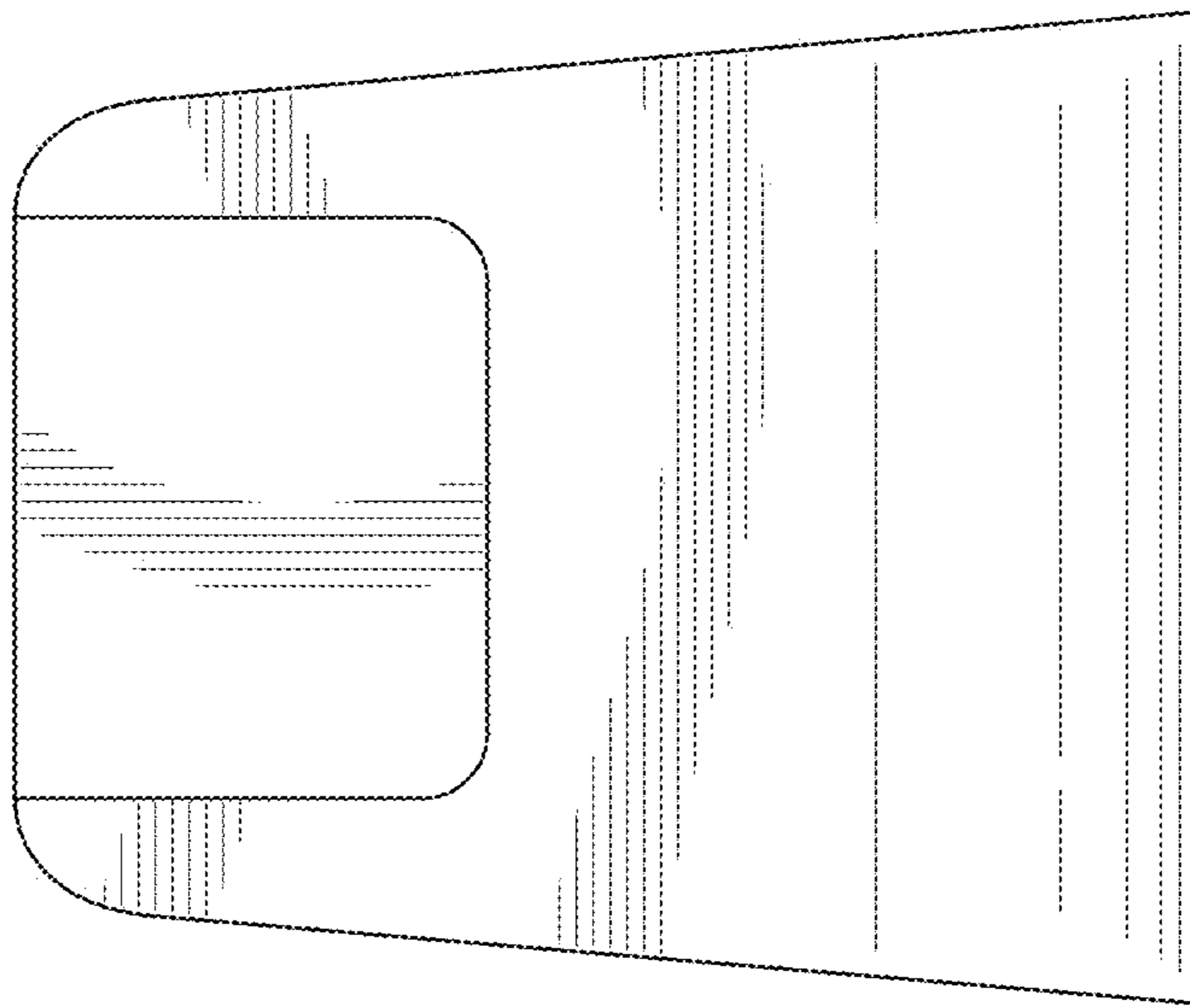
