1. Massage instrument

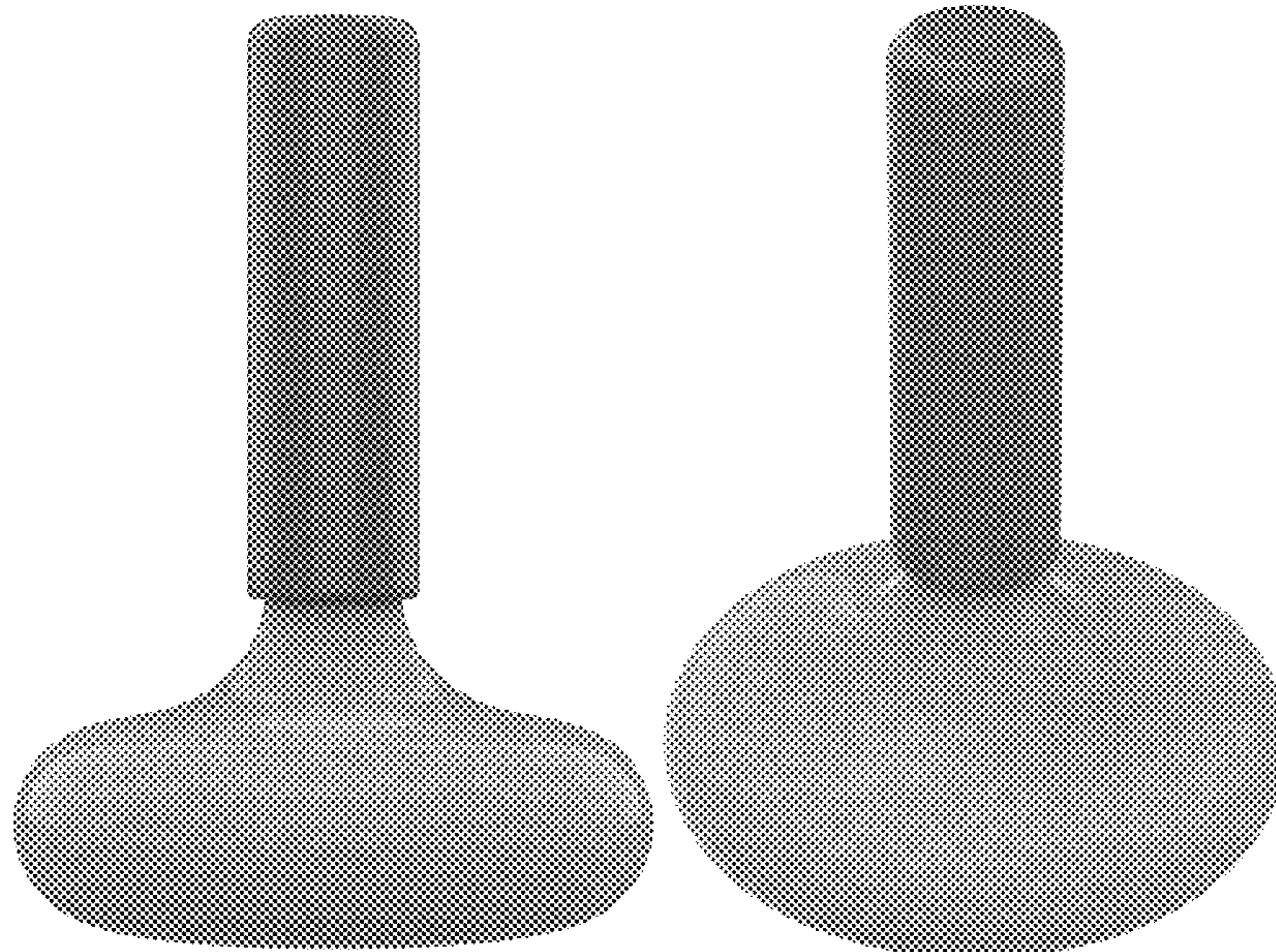

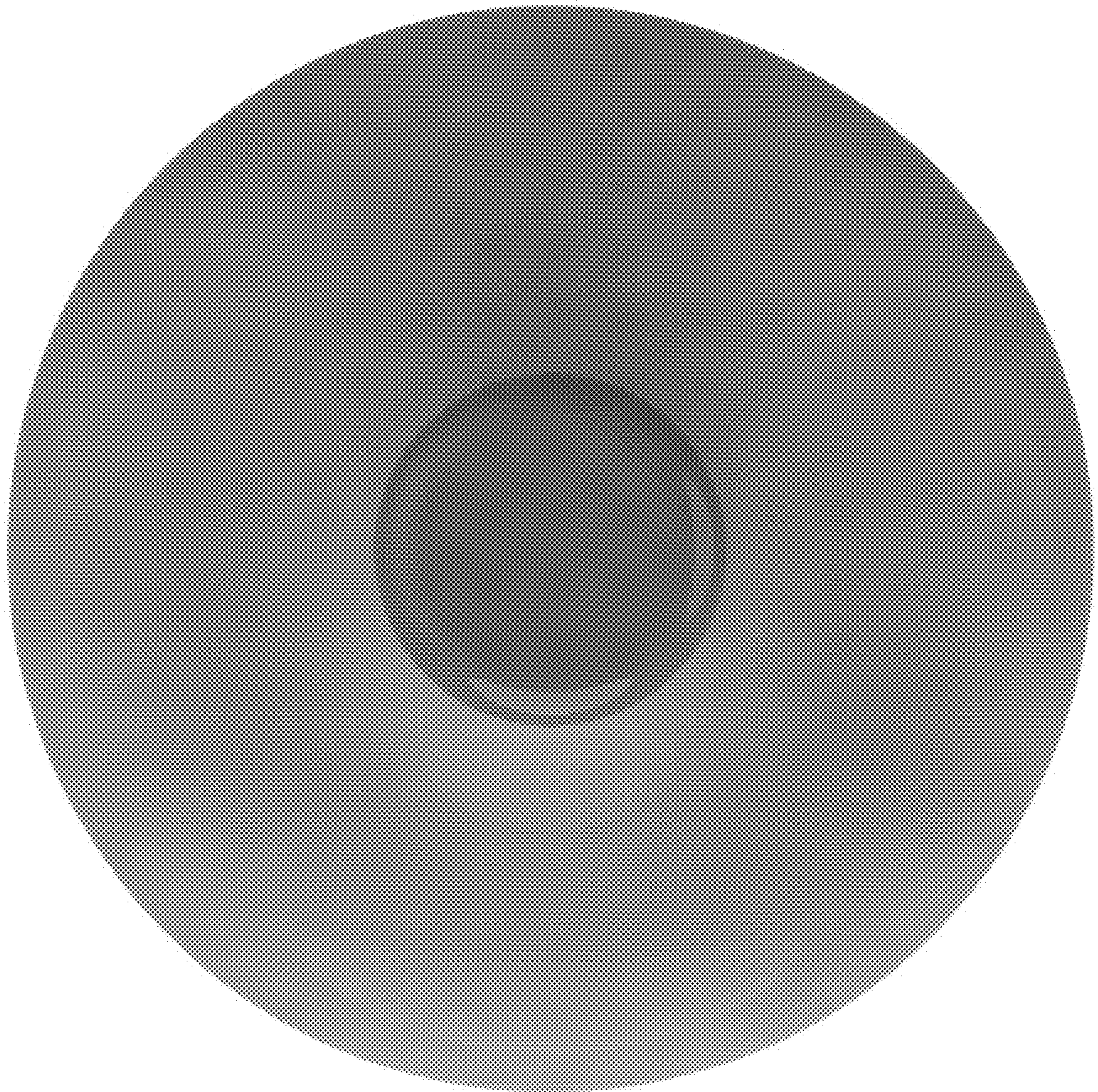
Massage instrument consisting of a handle fixed in the center of a circular base with rounded edges, narrowing on its upper and lower parts.
