(57) **CLAIM**

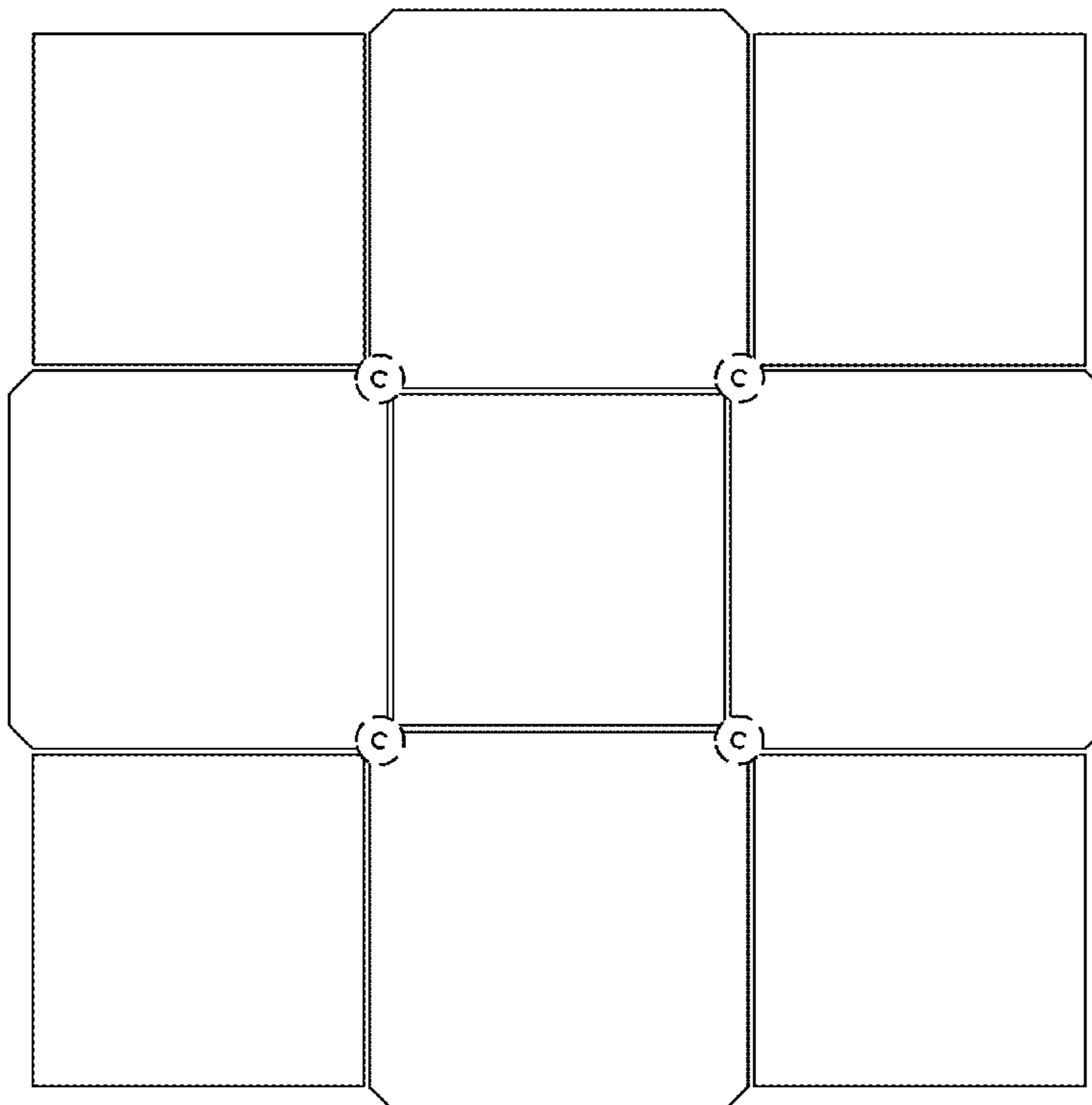
The ornamental design for an interlocking burn tile pattern for a burn room, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an interlocking burn tile pattern for a burn room showing the new design; and, FIG. 2 is a close-up view of the interlocking burn tile pattern for a burn room of FIG. 1.

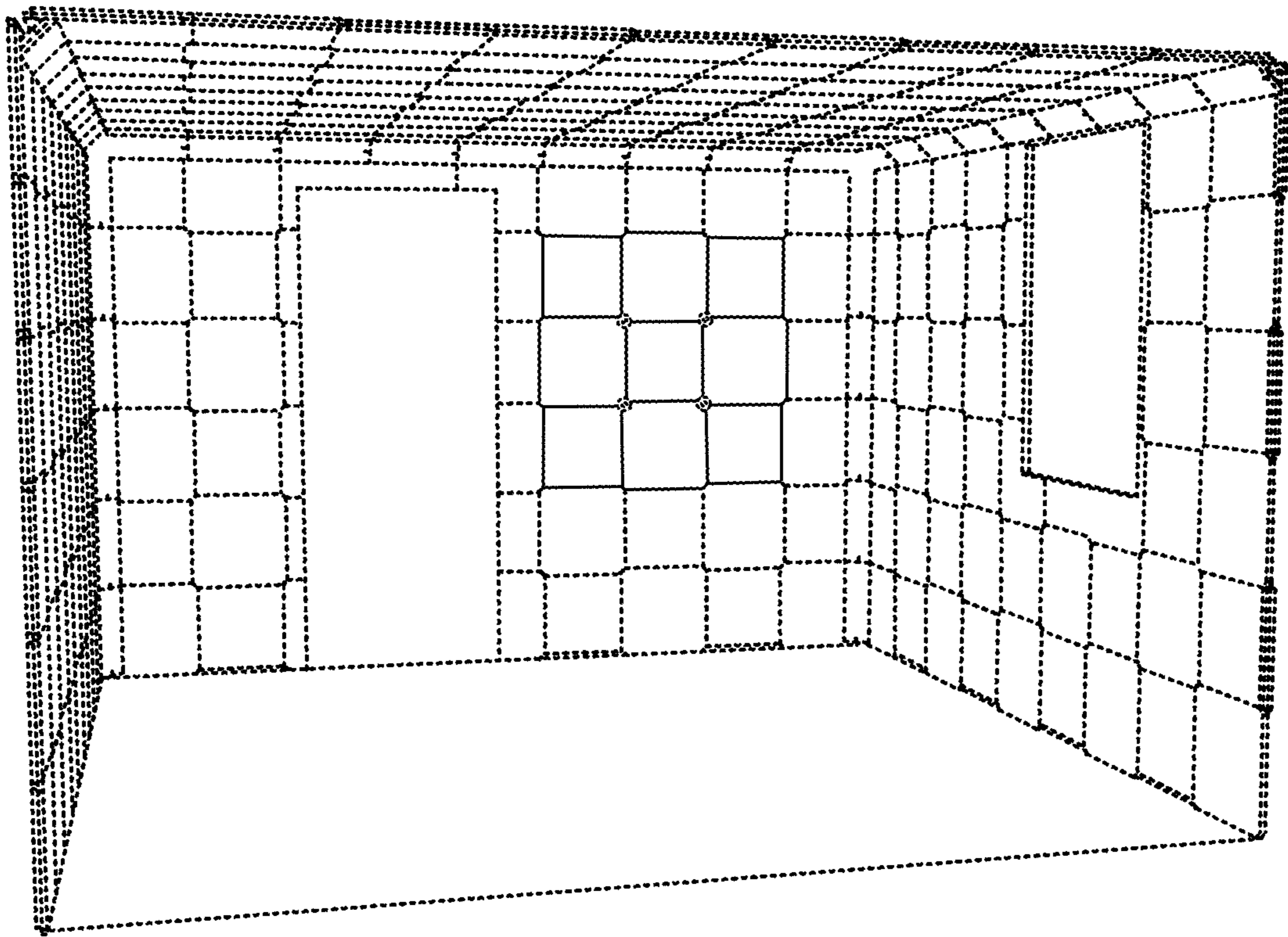

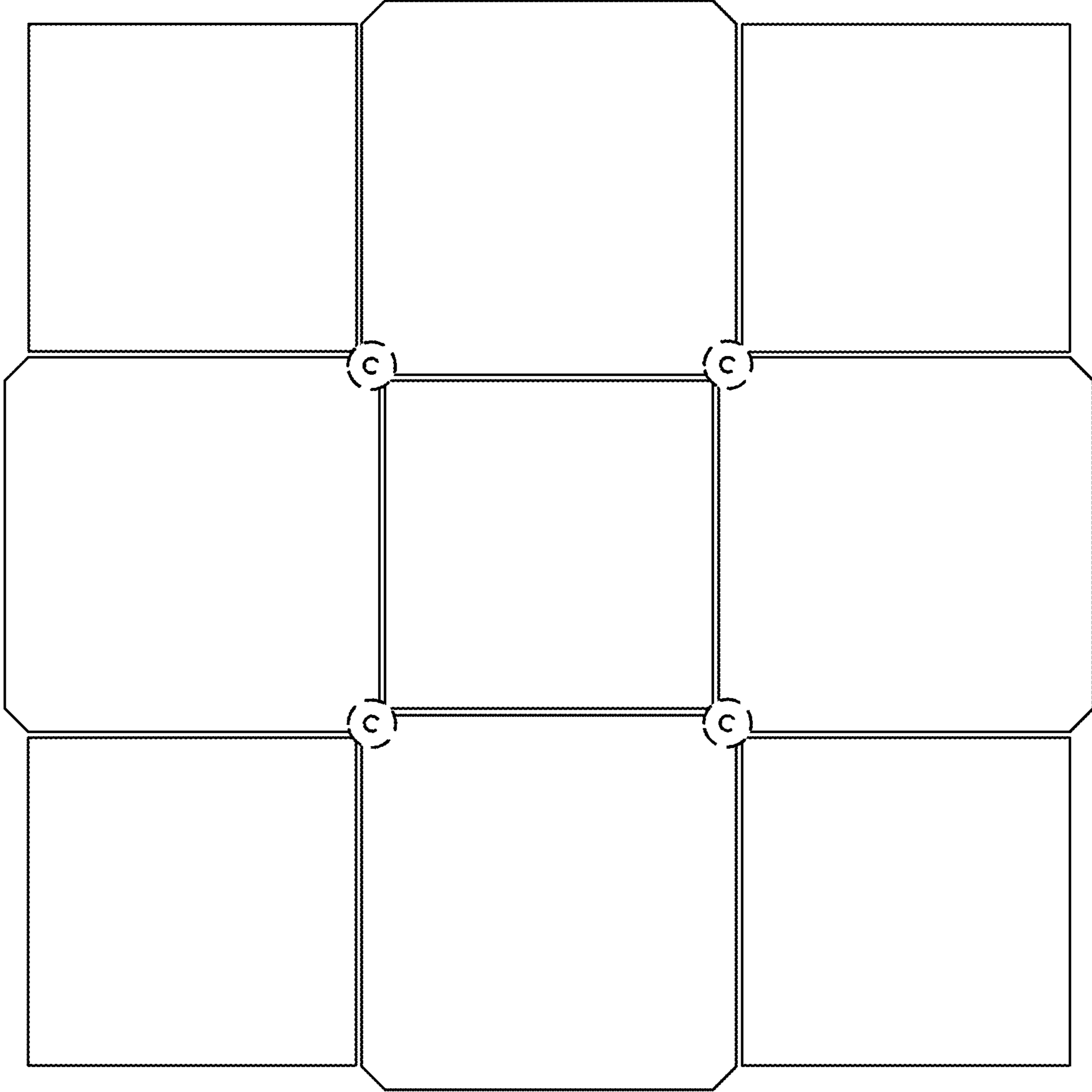
