FIG. 8 is a top perspective view of the tobacco product holding device shown in an environment of use.

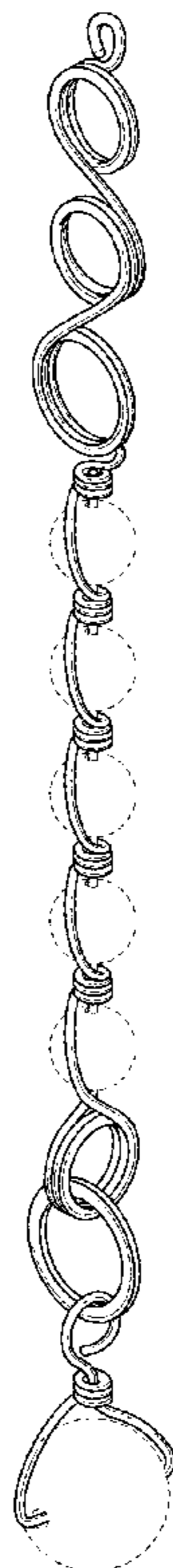

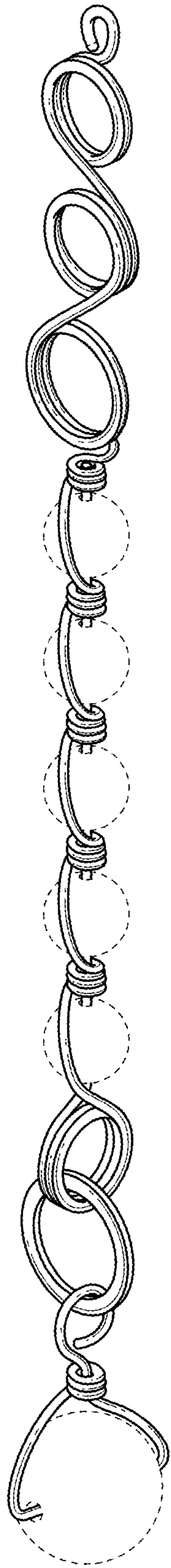

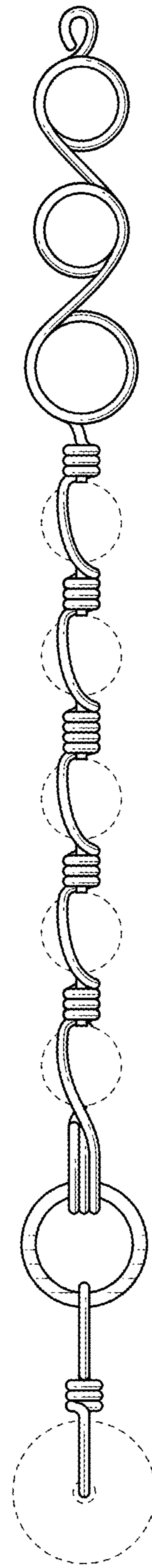

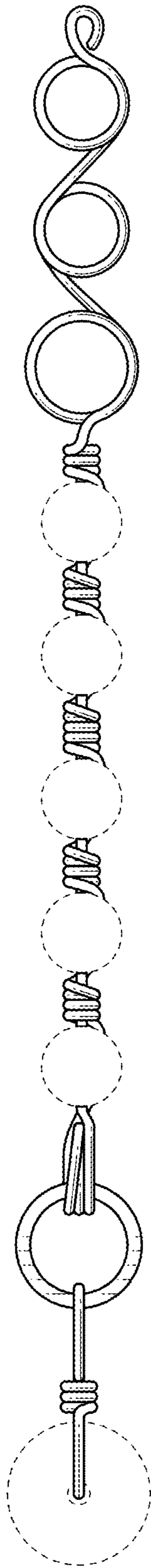

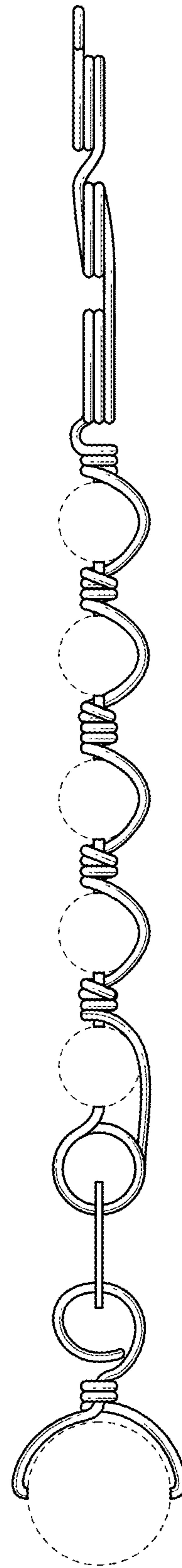

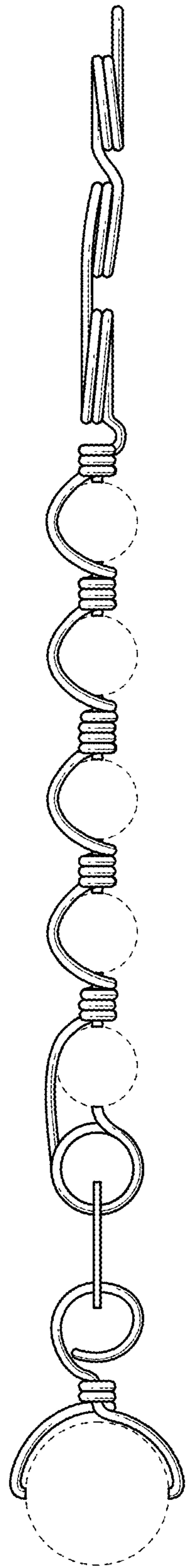

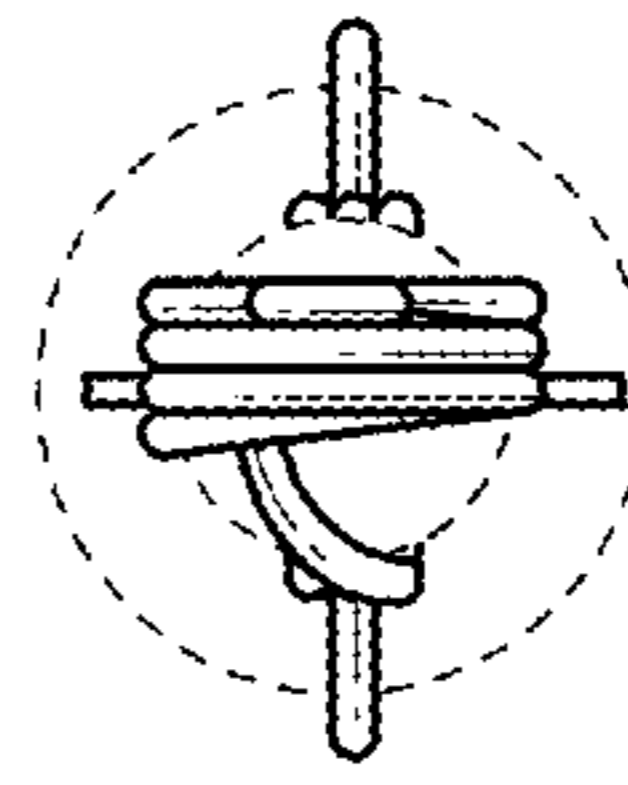

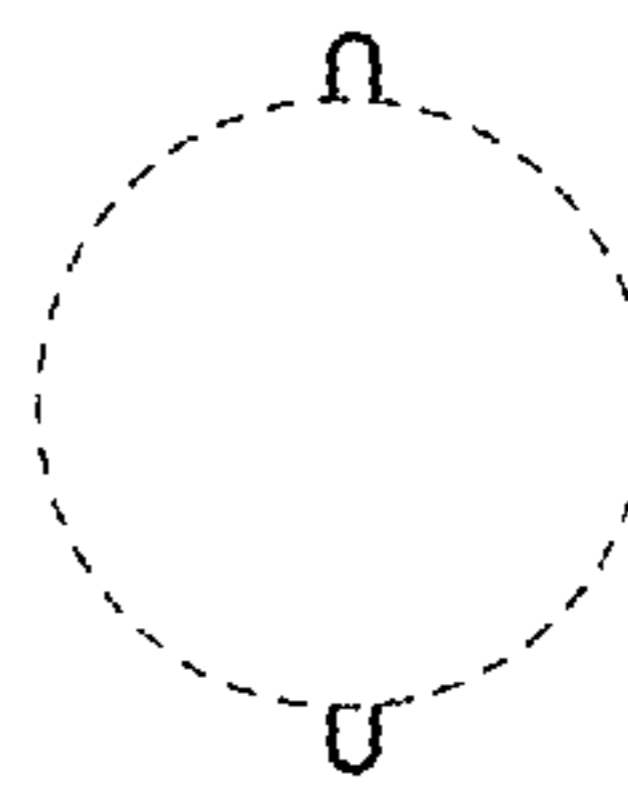

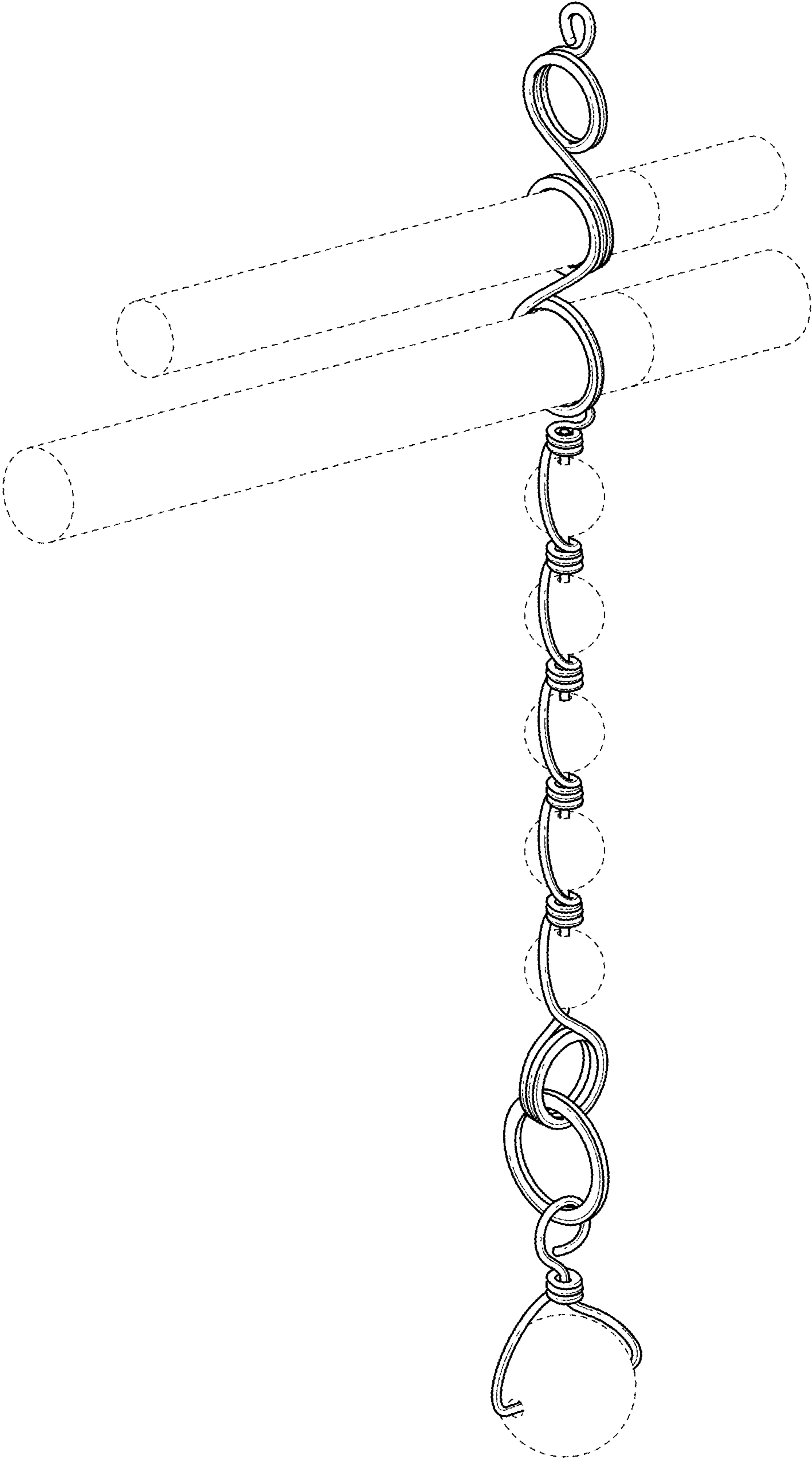
