The ornamental design for a braces friendly mouth guard, as shown.

**DESCRIPTION**

FIG. 1 is an isometric top rear view of a braces friendly mouth guard.

FIG. 2 is an isometric top front view of the braces friendly mouth guard of FIG. 1.

FIG. 3 is an isometric bottom rear view of the braces friendly mouth guard of FIG. 1.

FIG. 4 is an isometric bottom front view of the braces friendly mouth guard of FIG. 1.

FIG. 5 is a top view of the braces friendly mouth guard of FIG. 1.

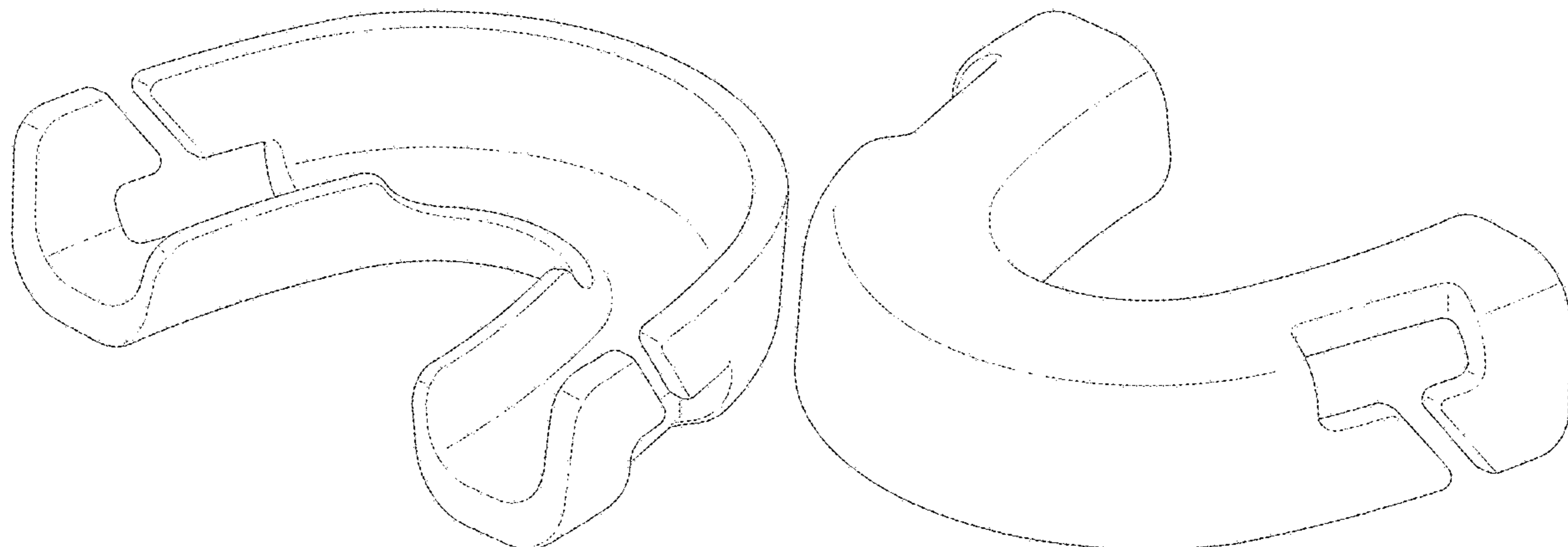
FIG. 6 is a bottom view of the braces friendly mouth guard of FIG. 1.

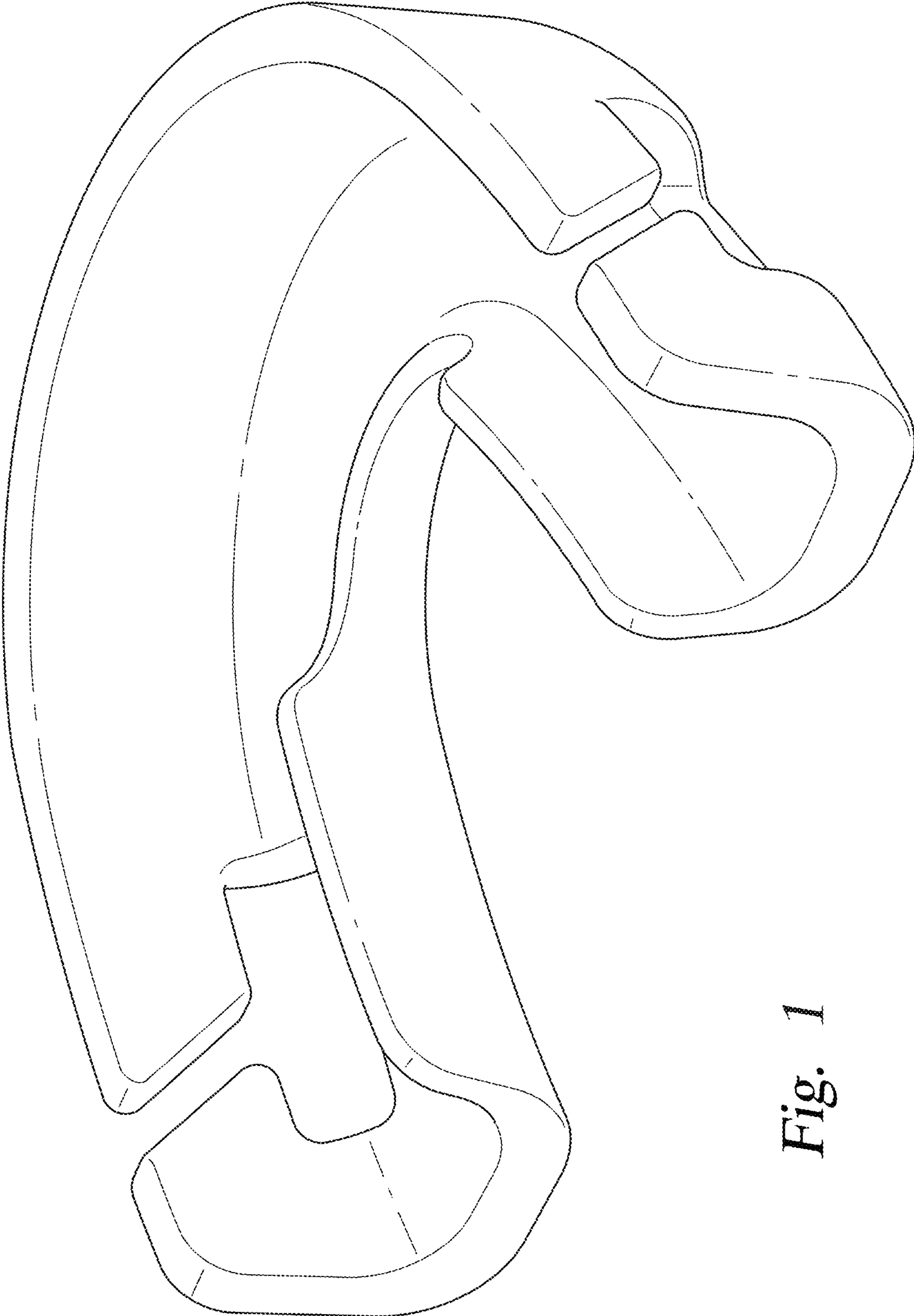
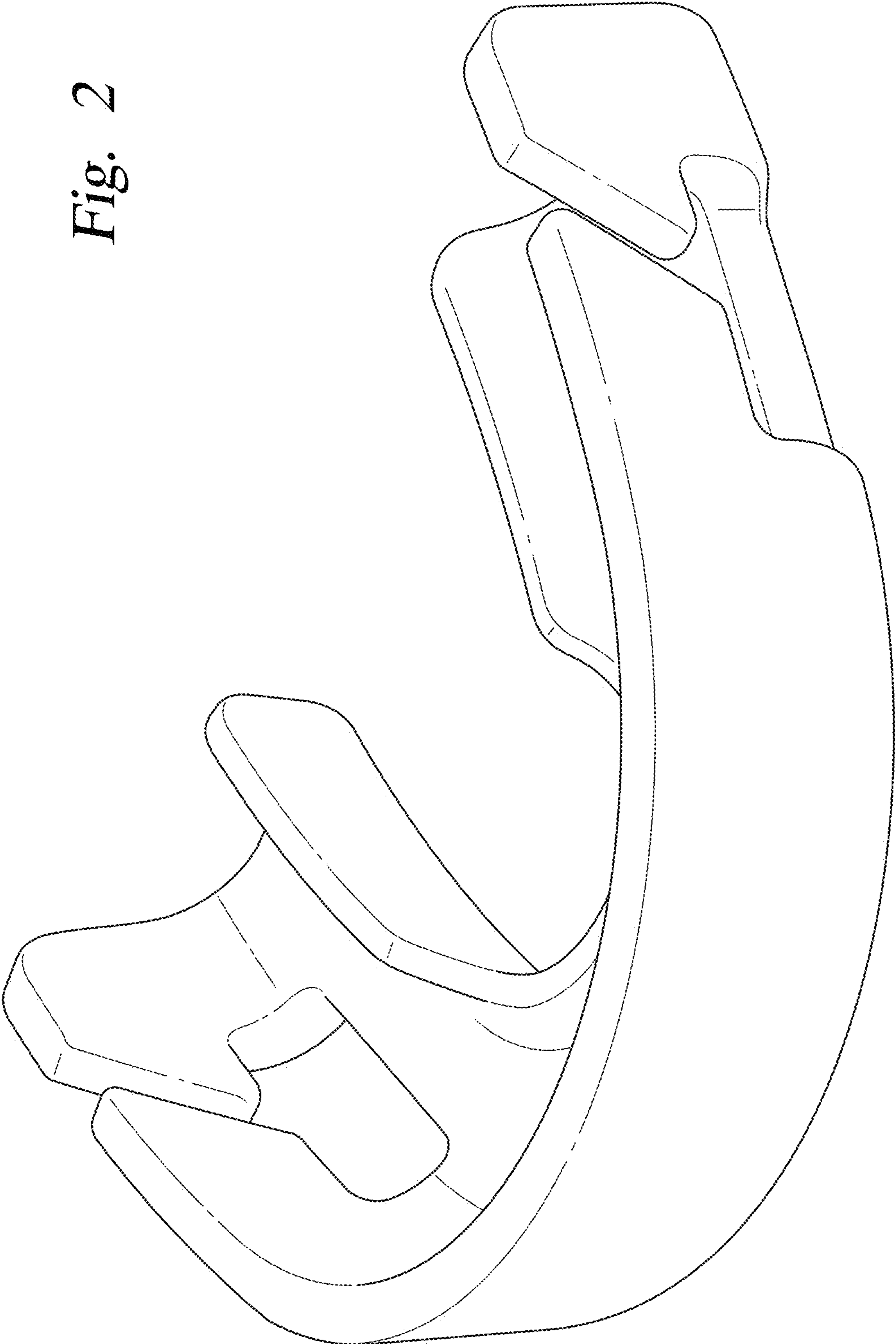

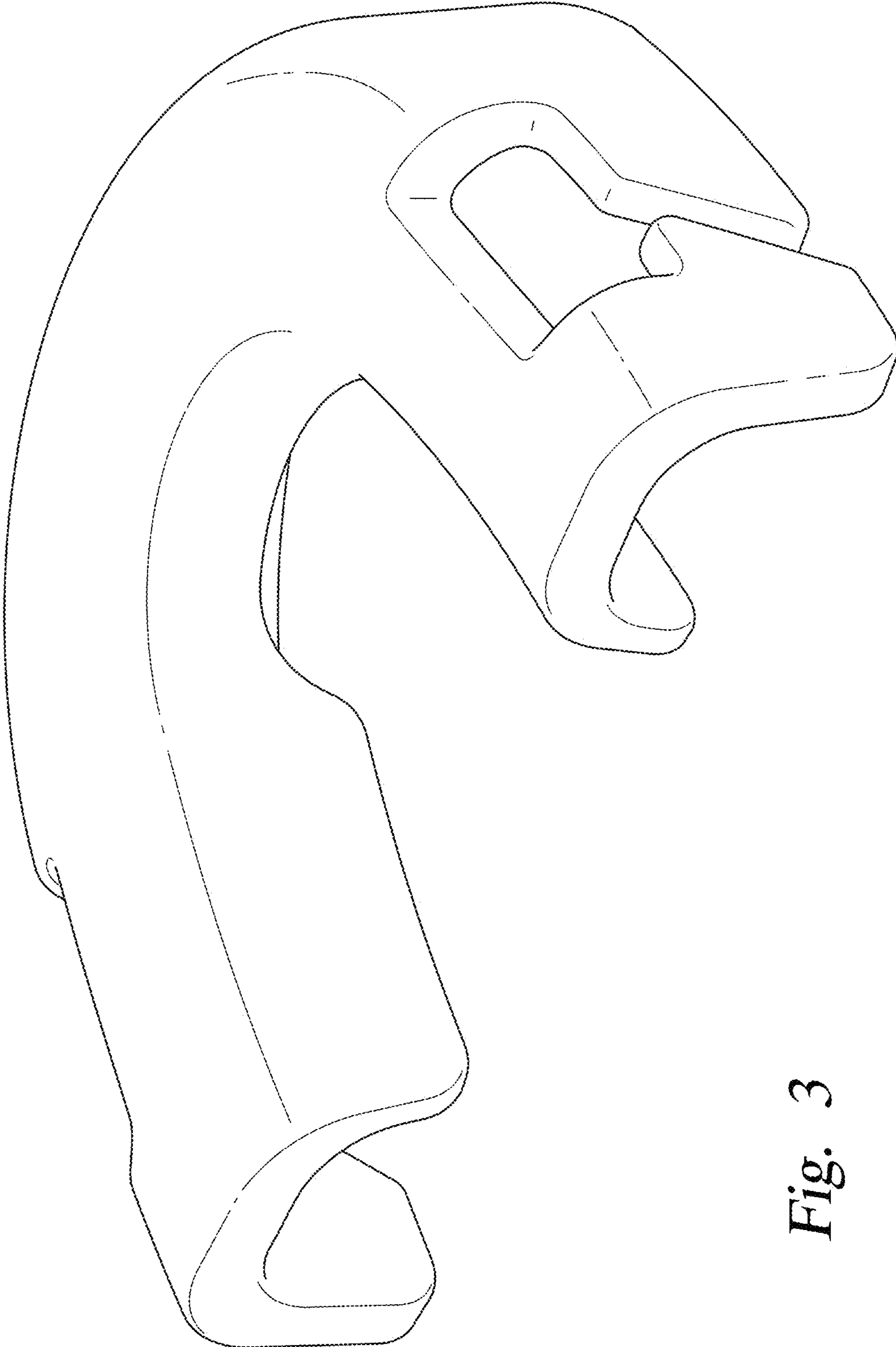
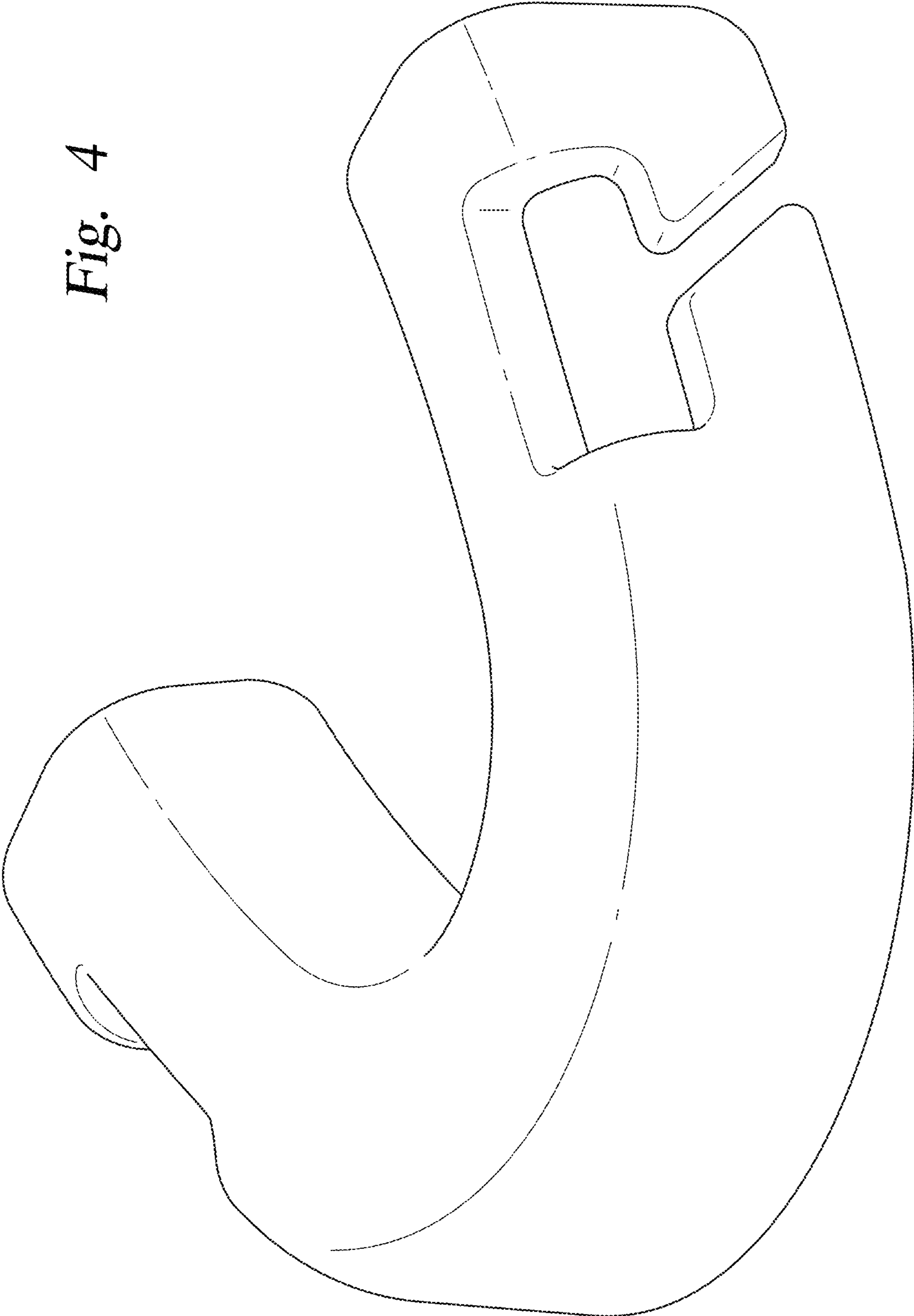

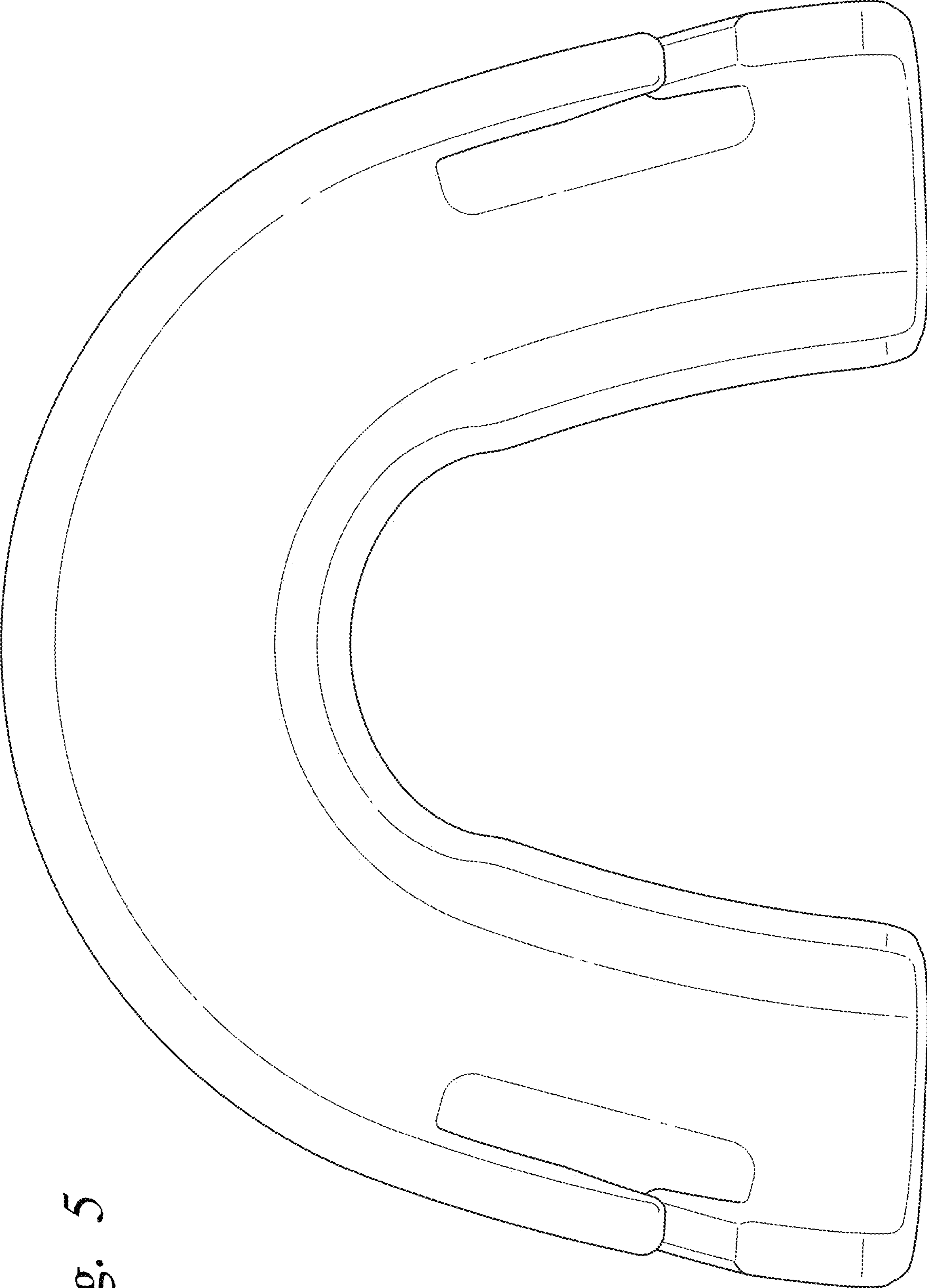

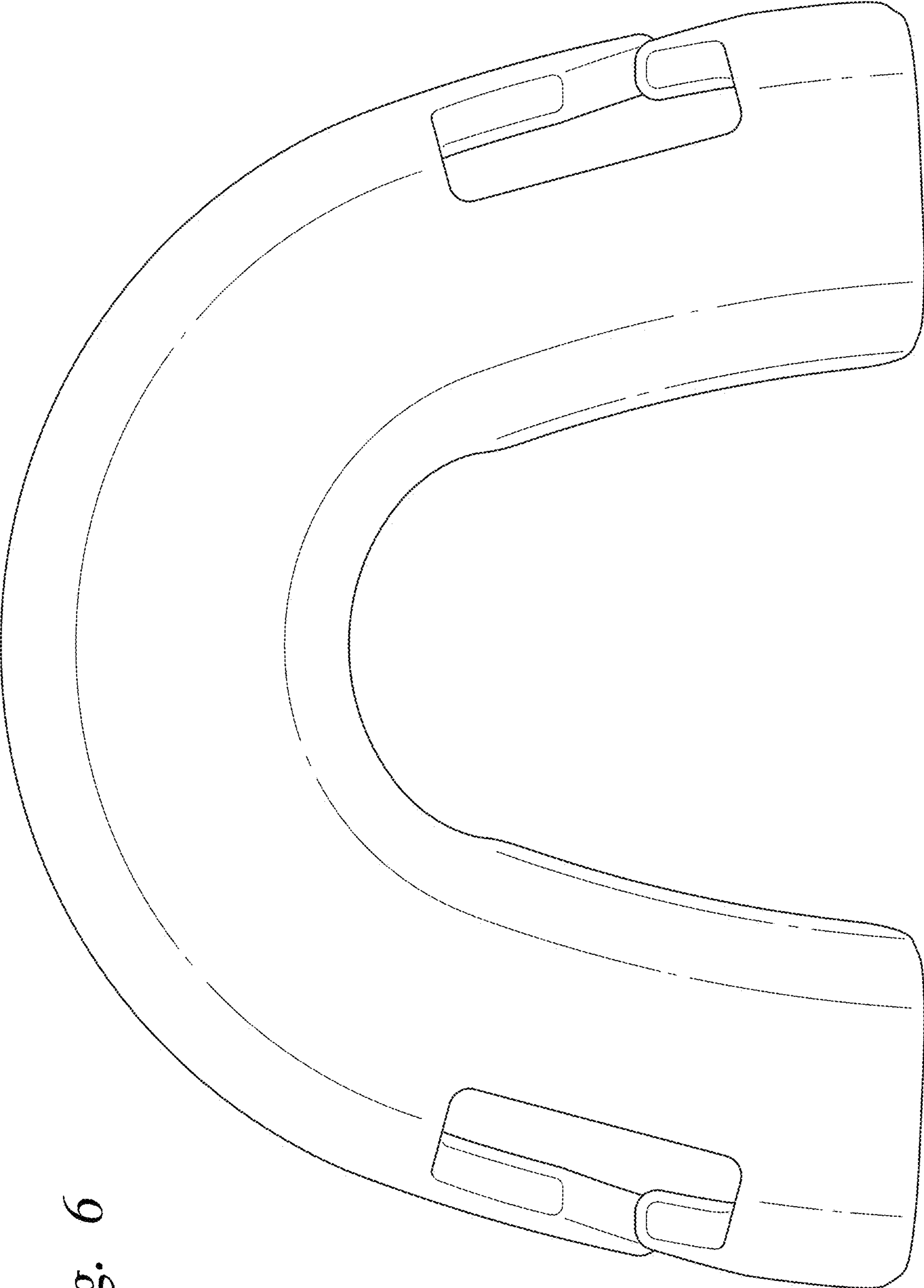

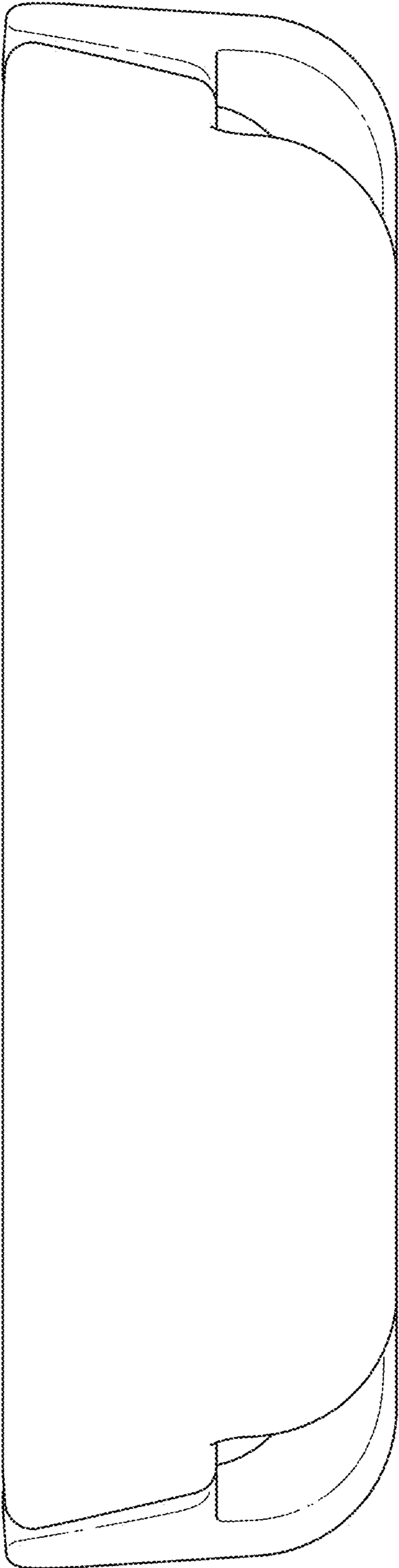

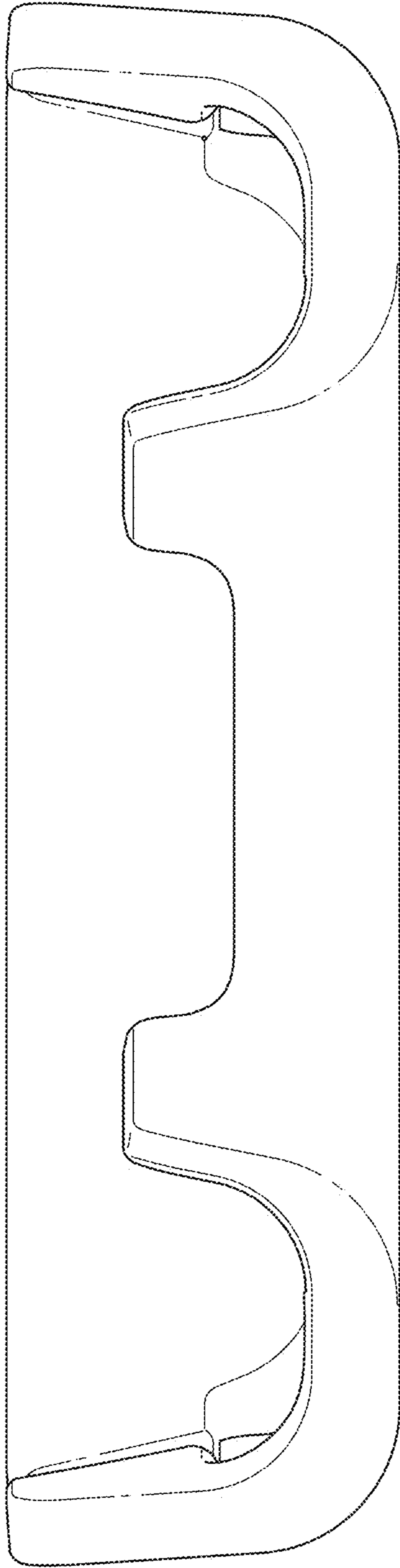
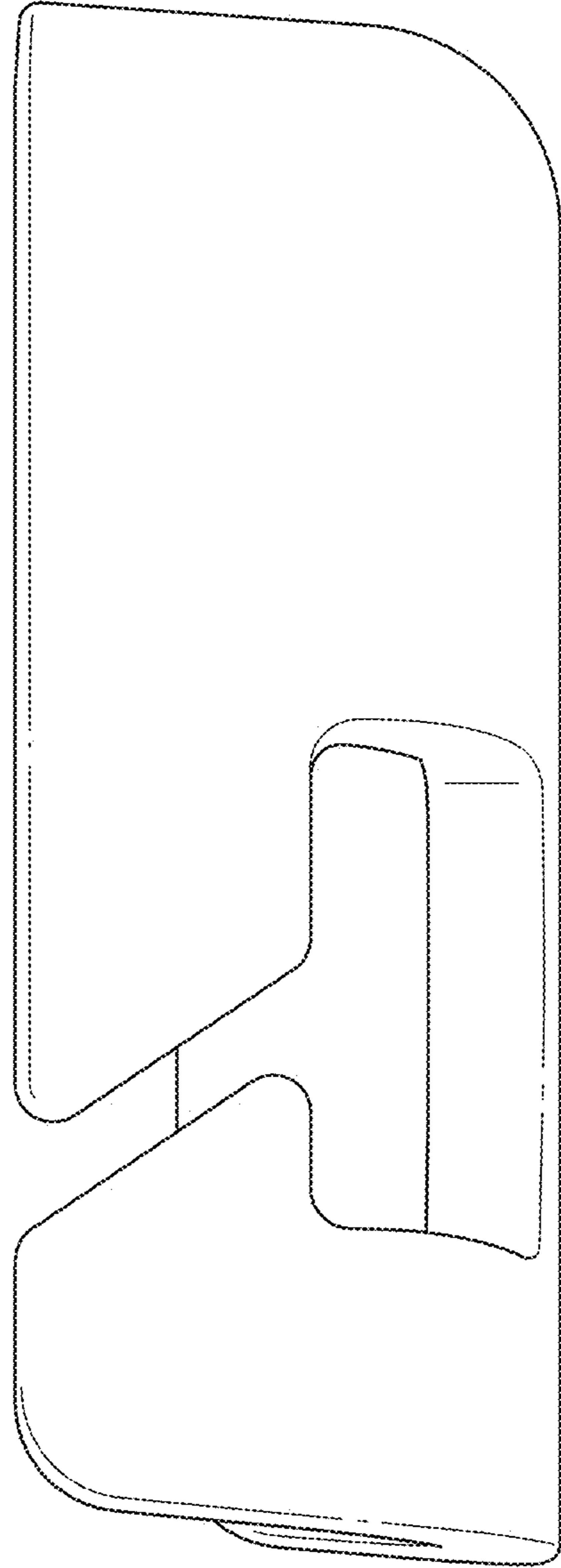
