FIG. 12 is a partial enlarged view of an area labeled 12 in FIG. 6.

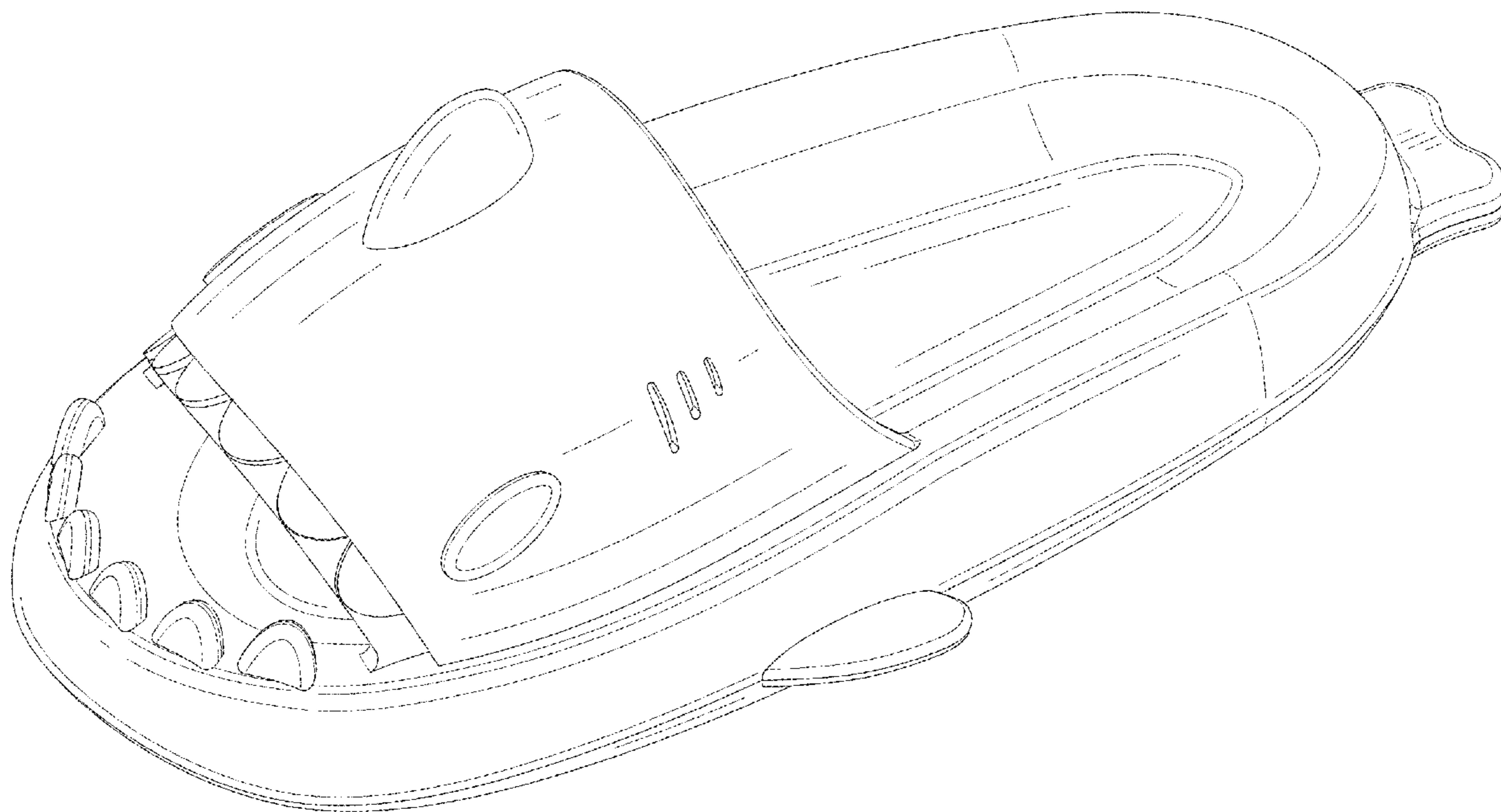

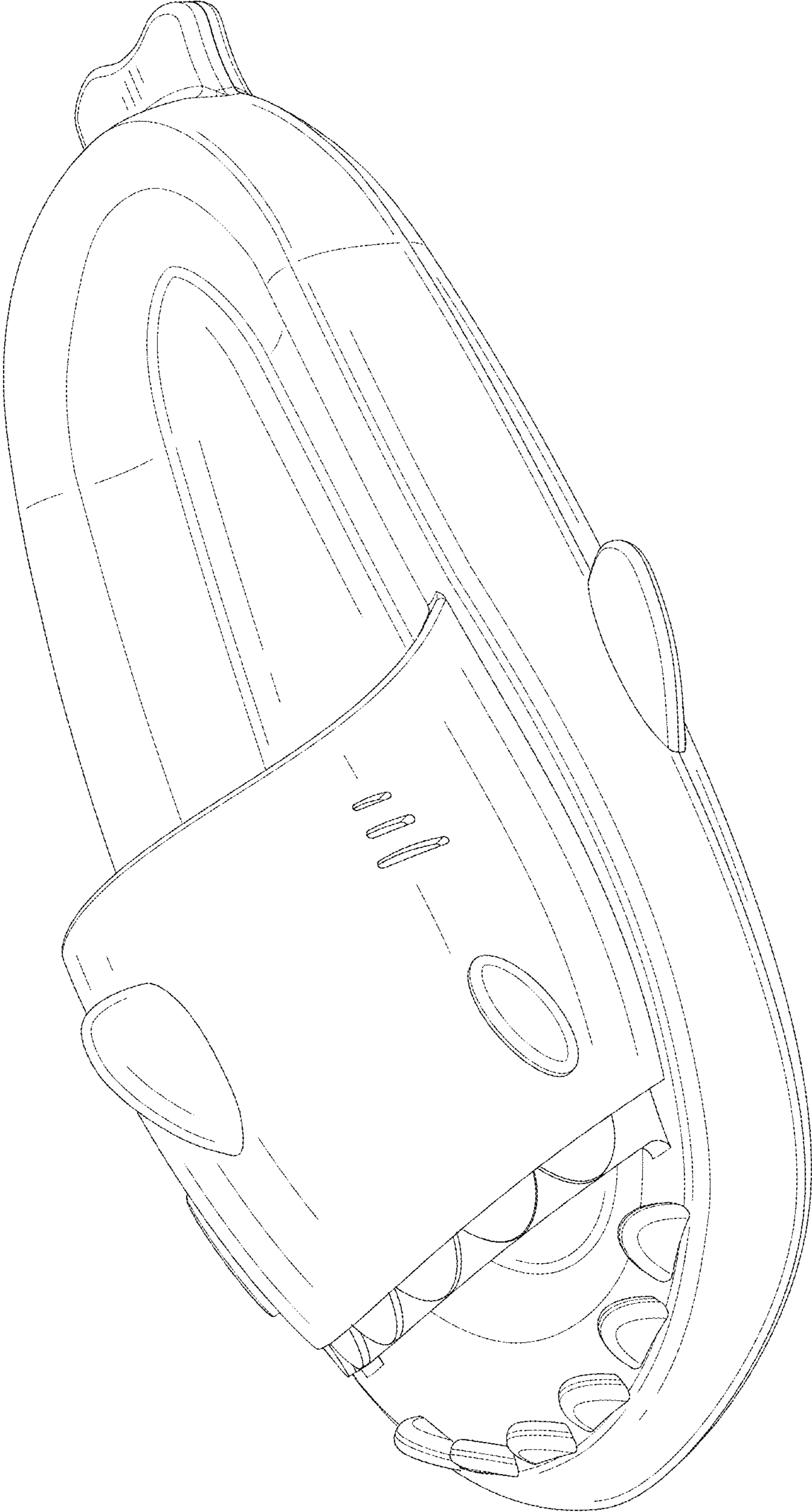

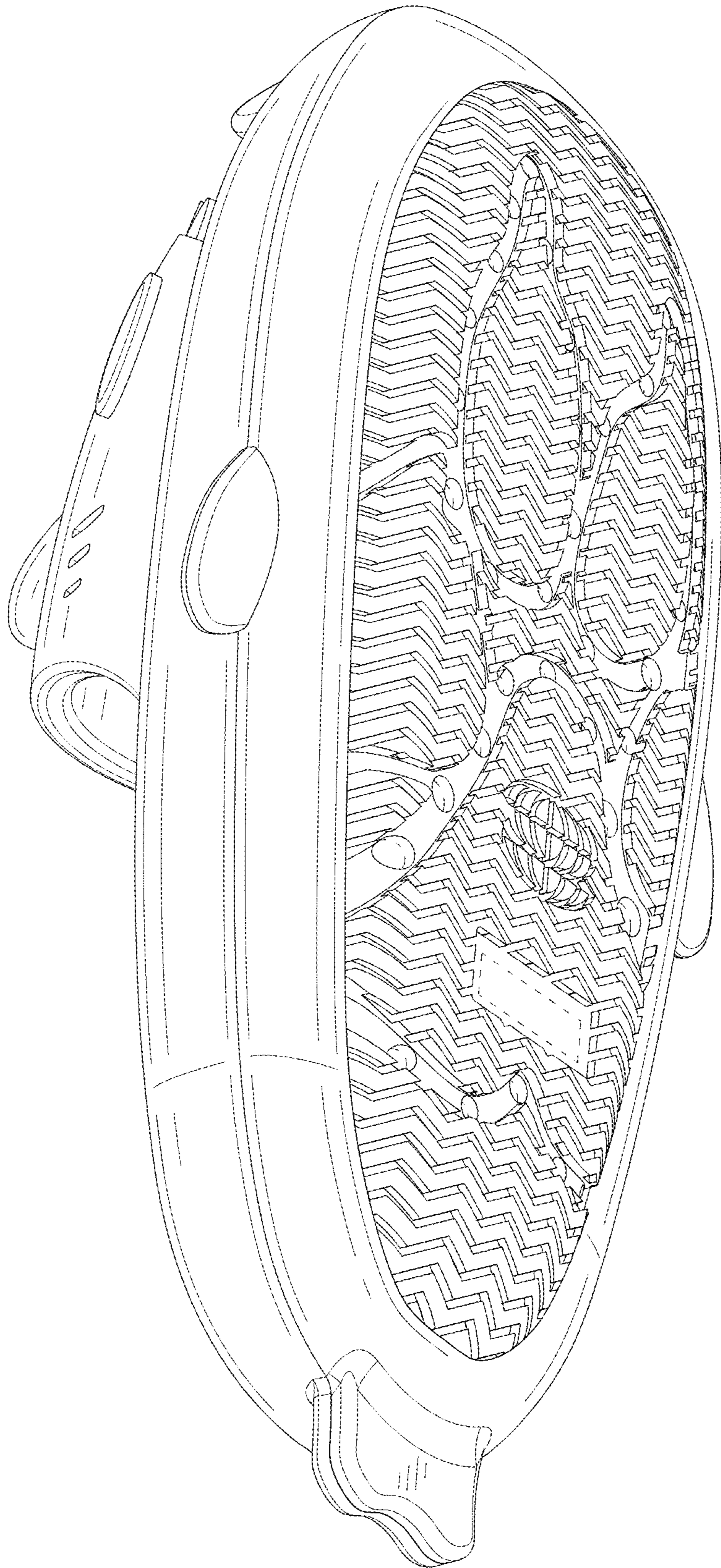

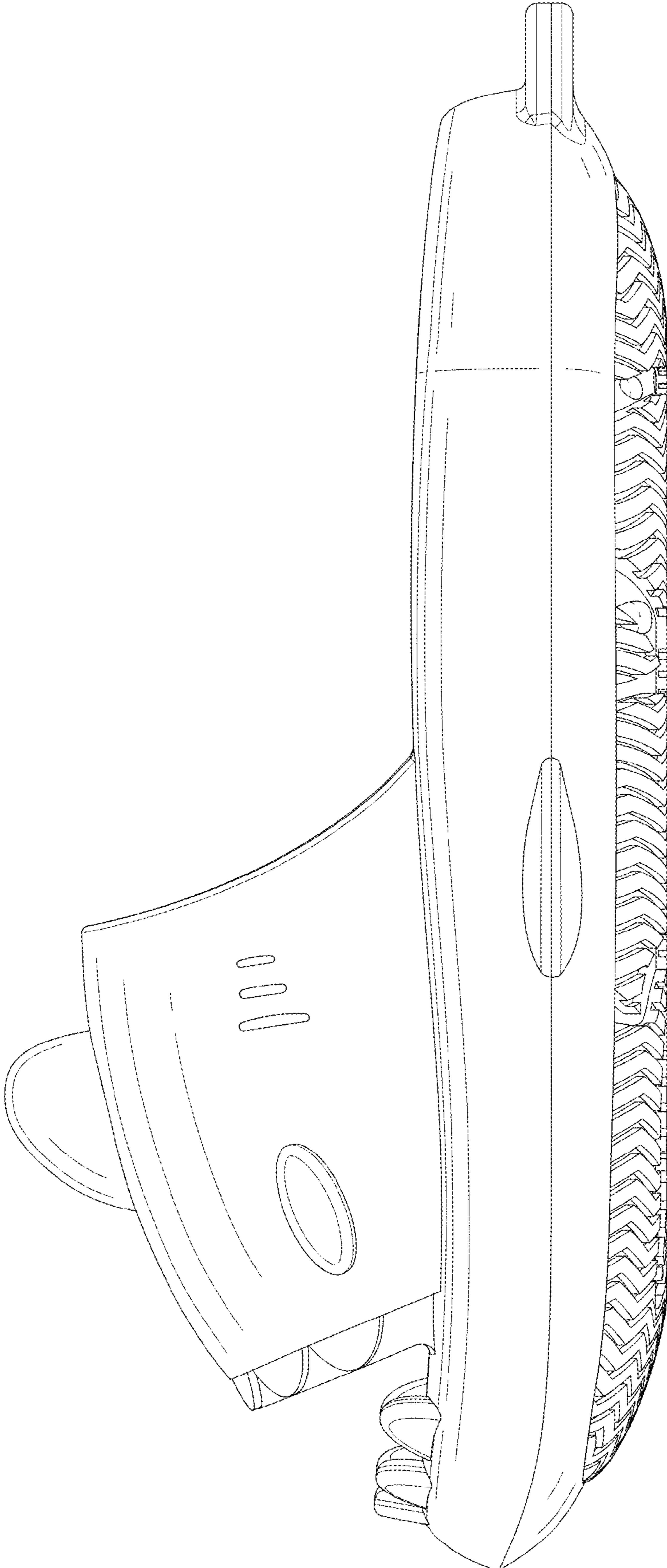

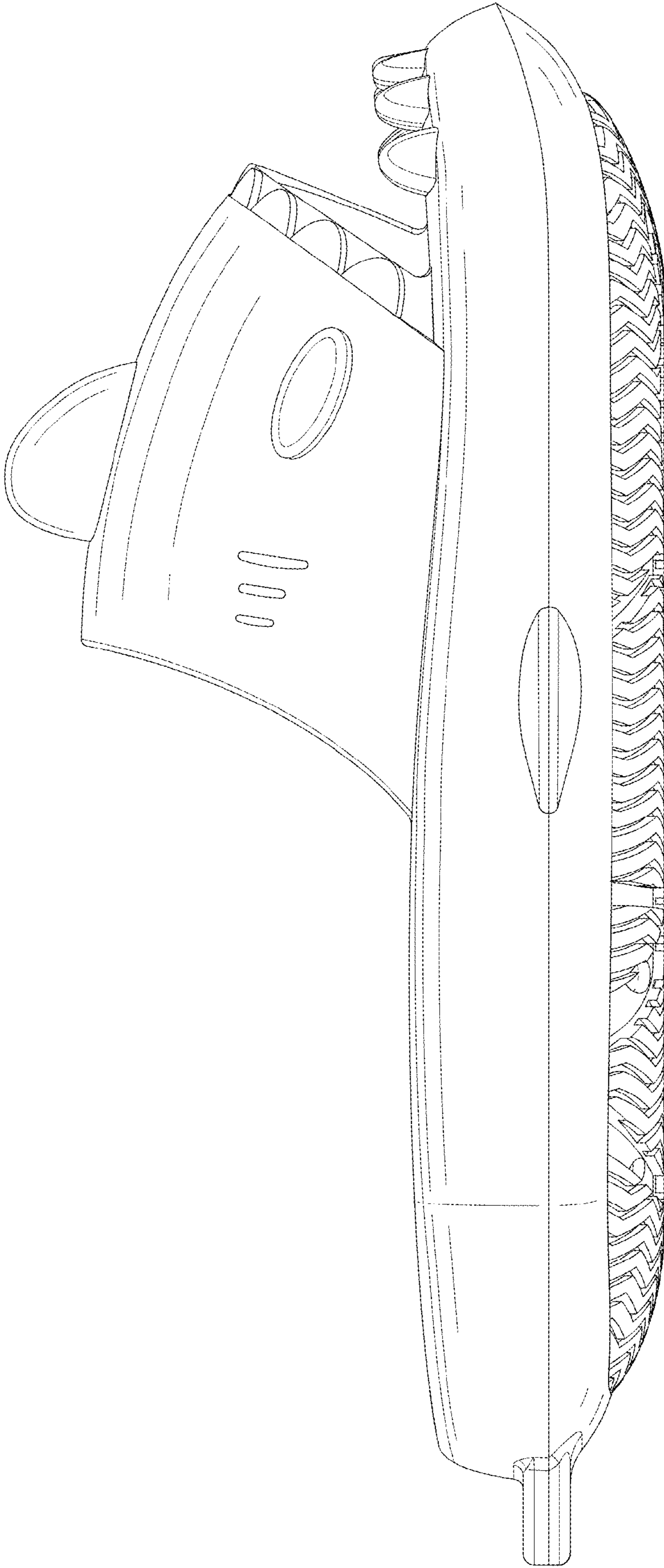

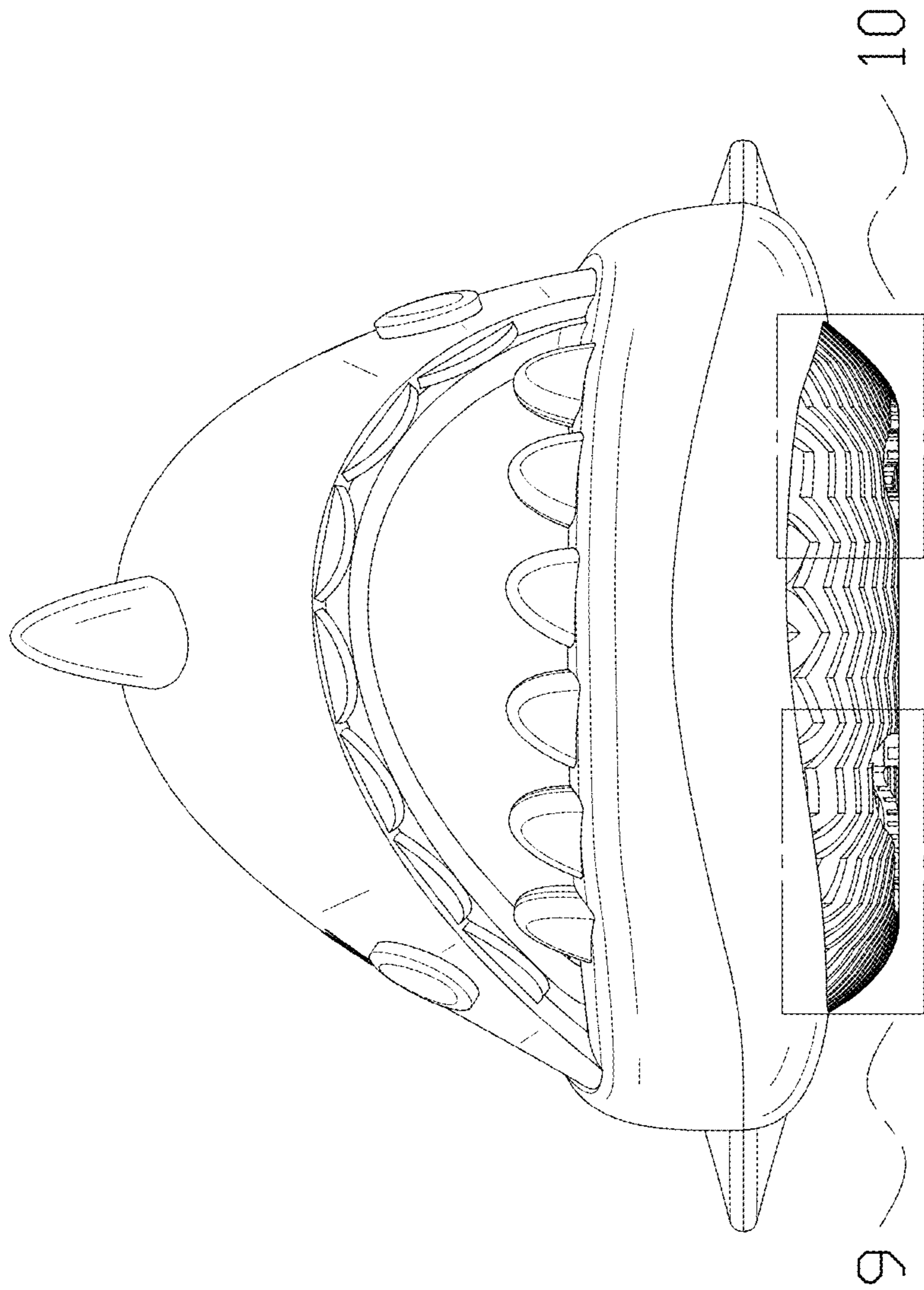

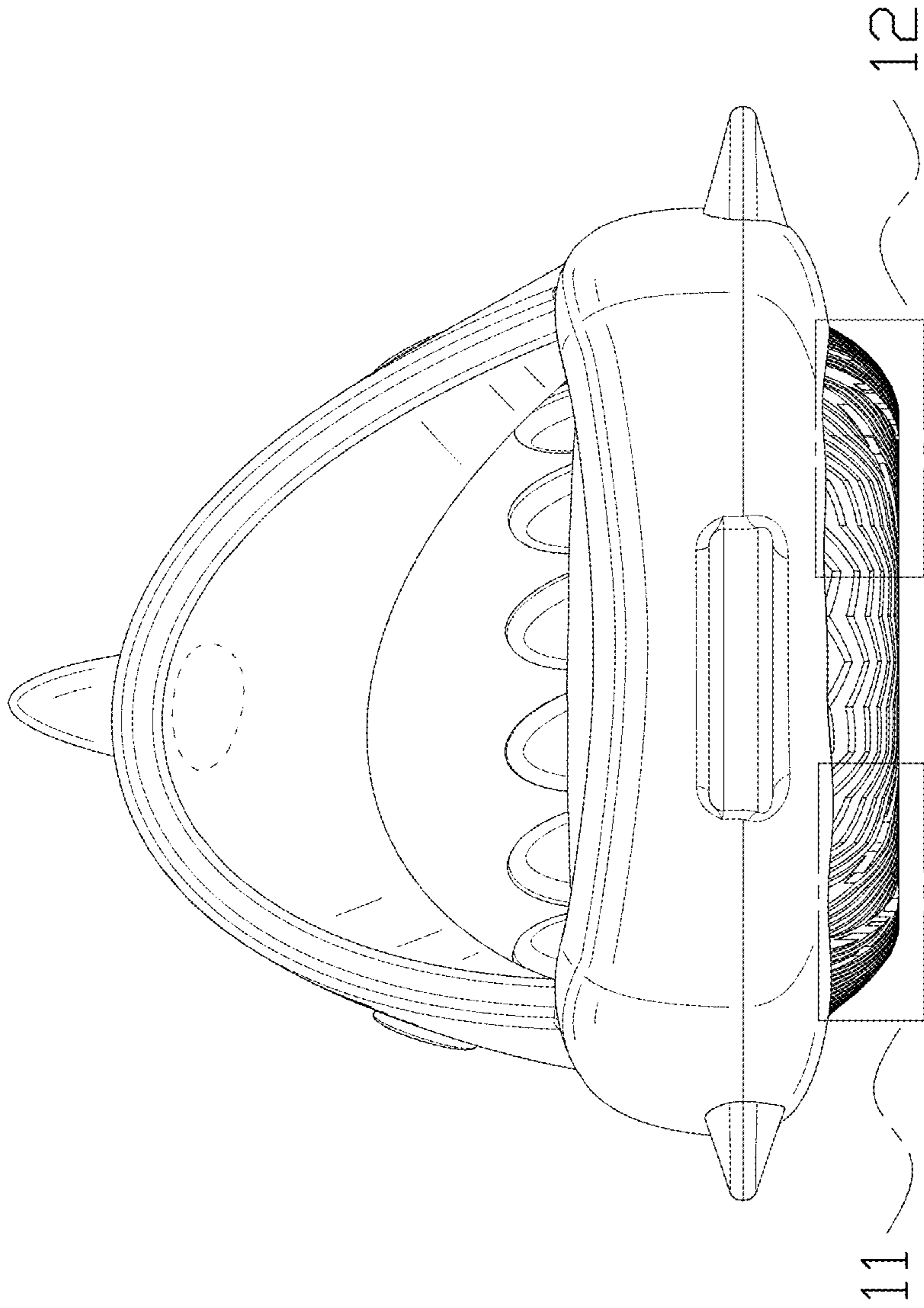

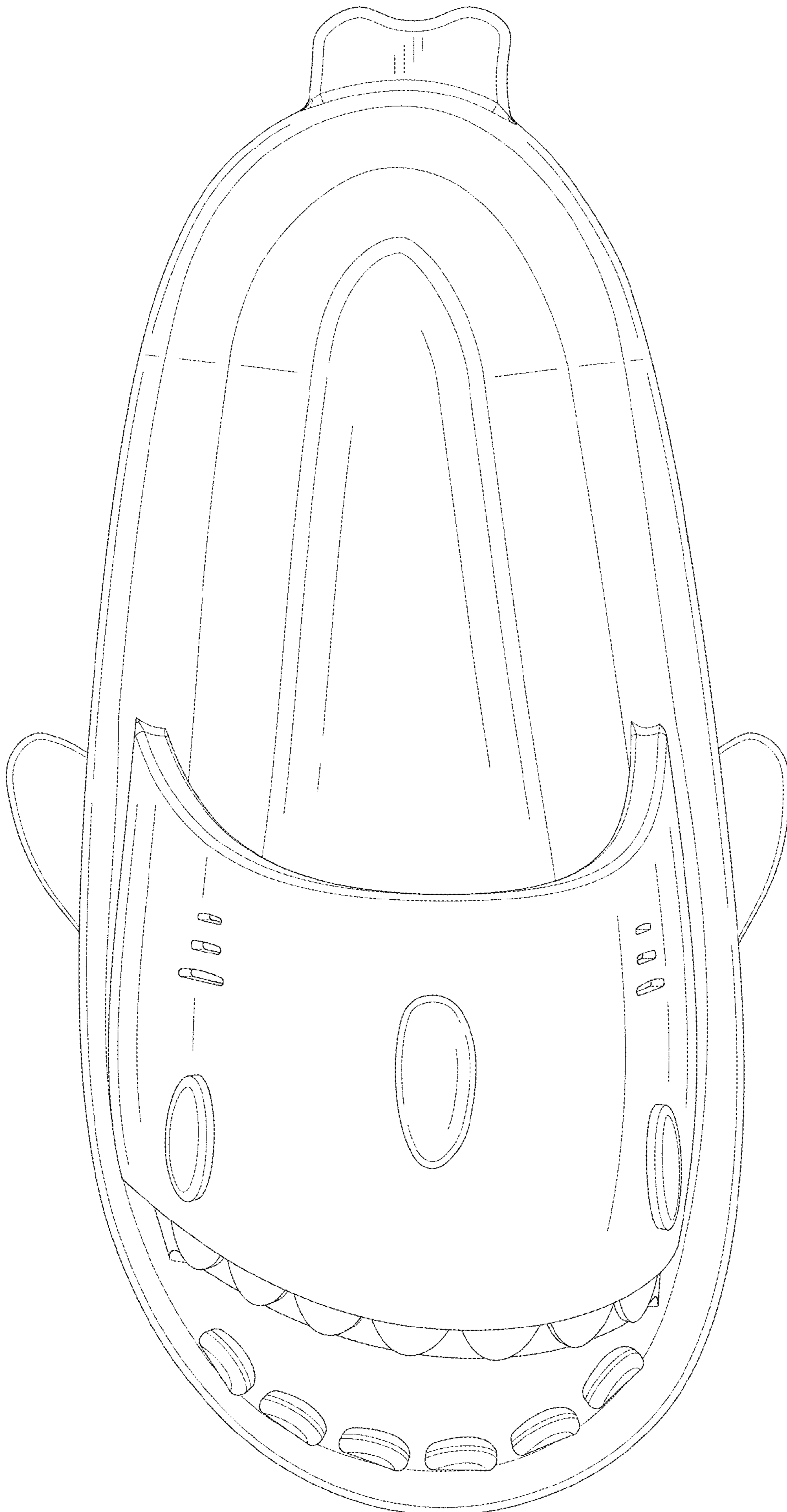

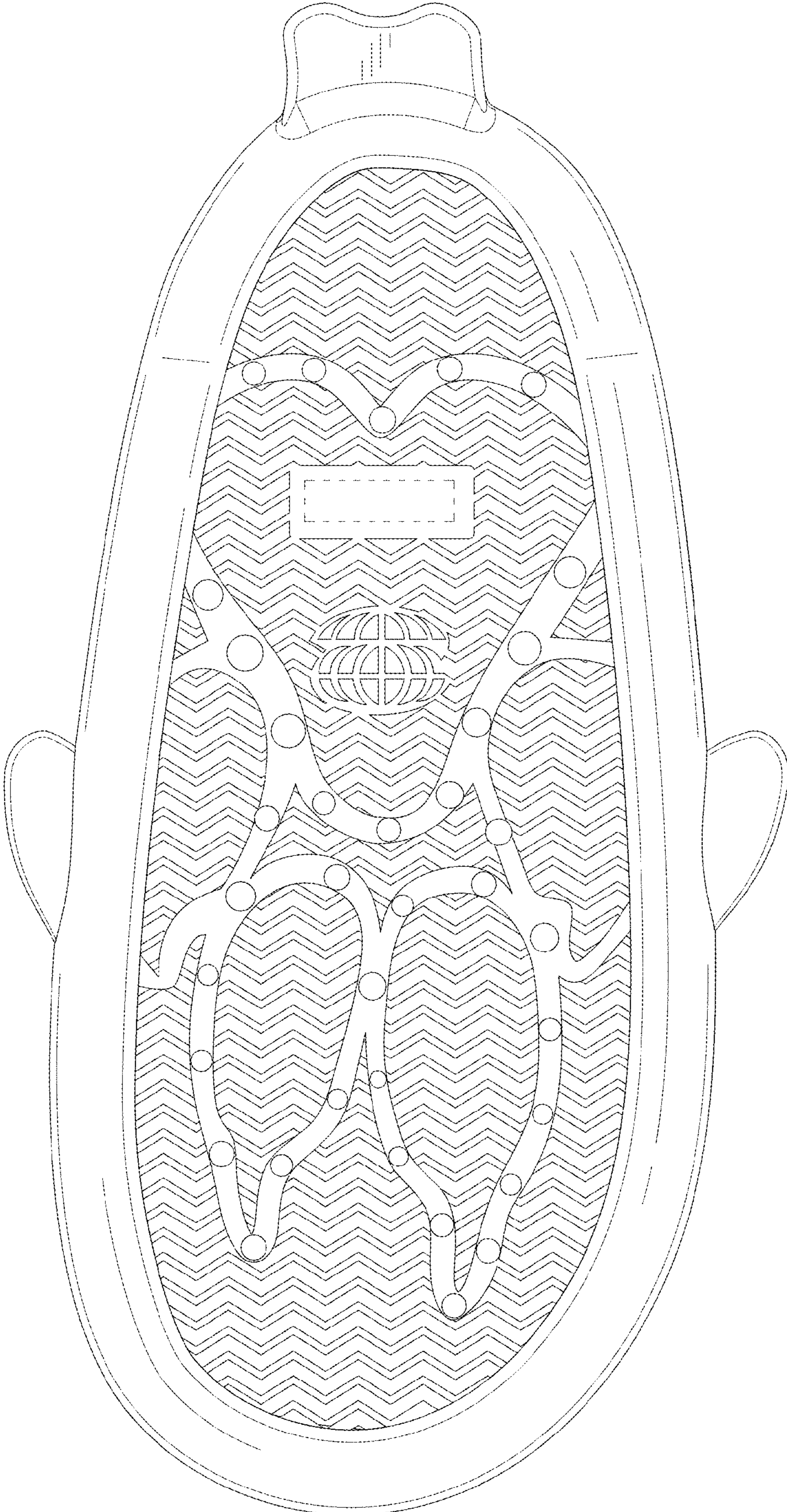

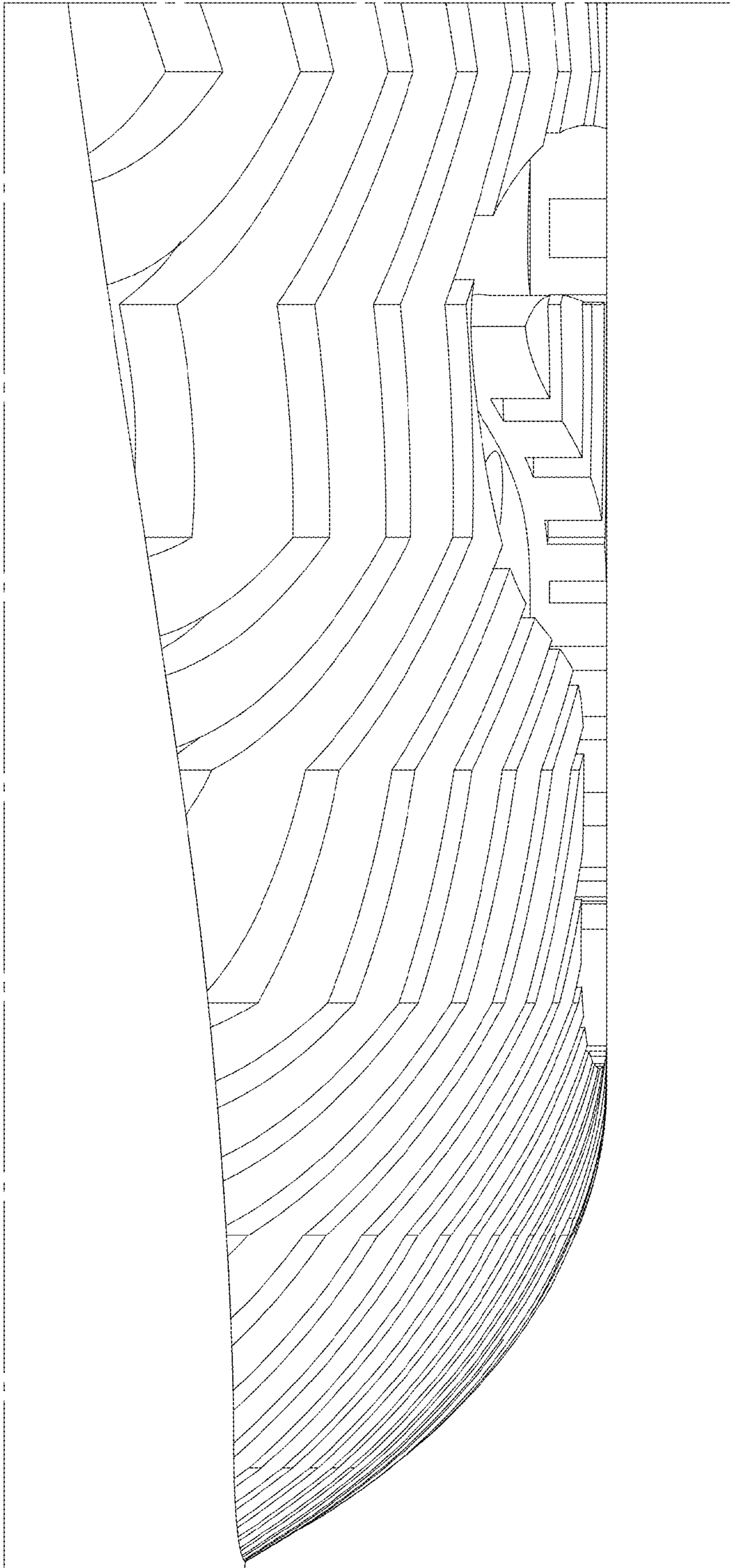

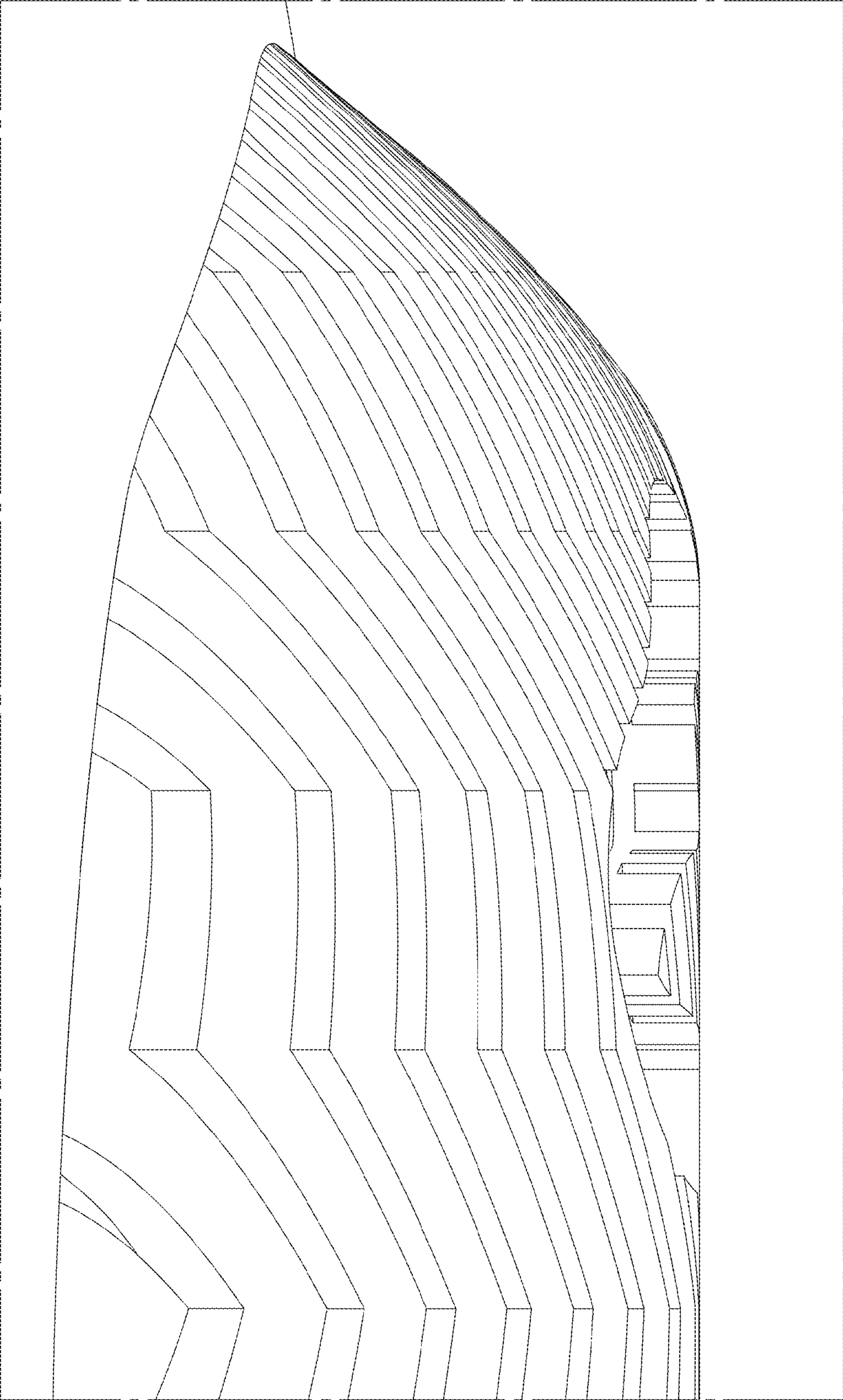

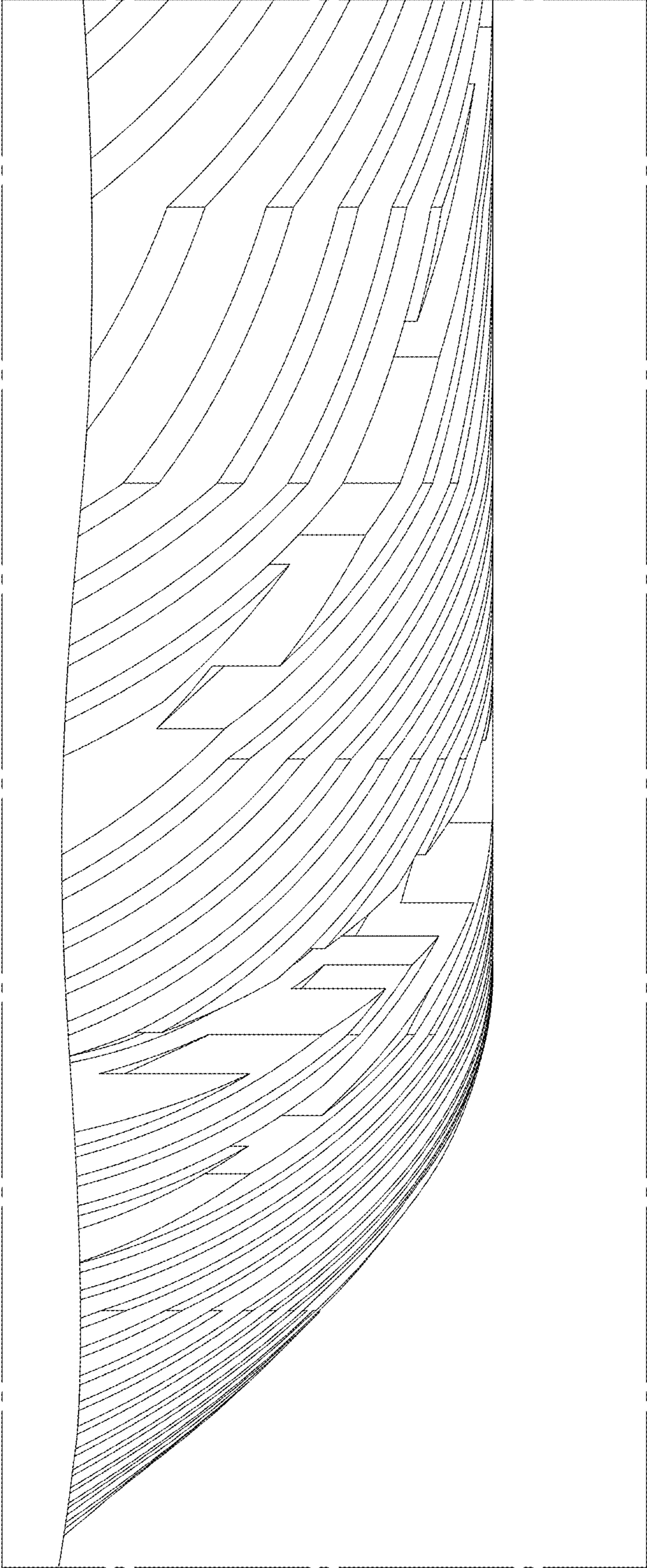

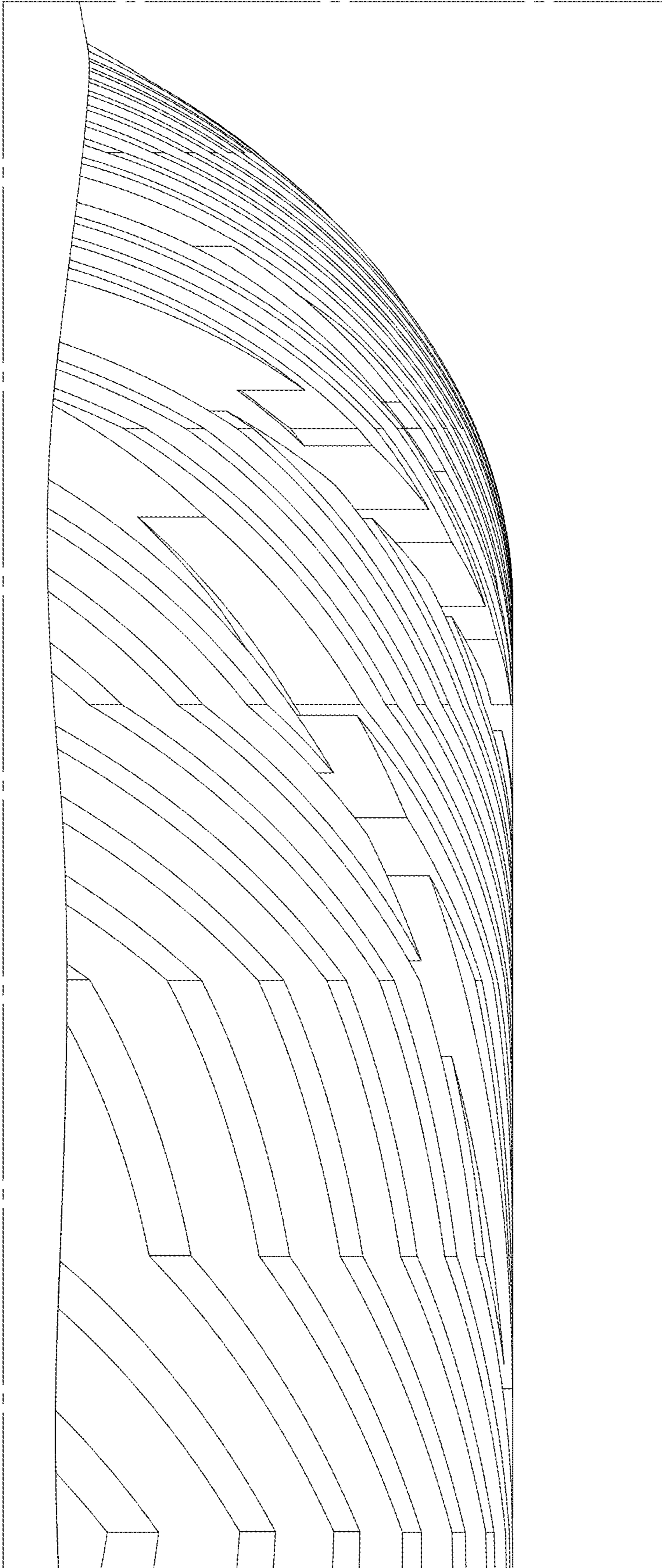
