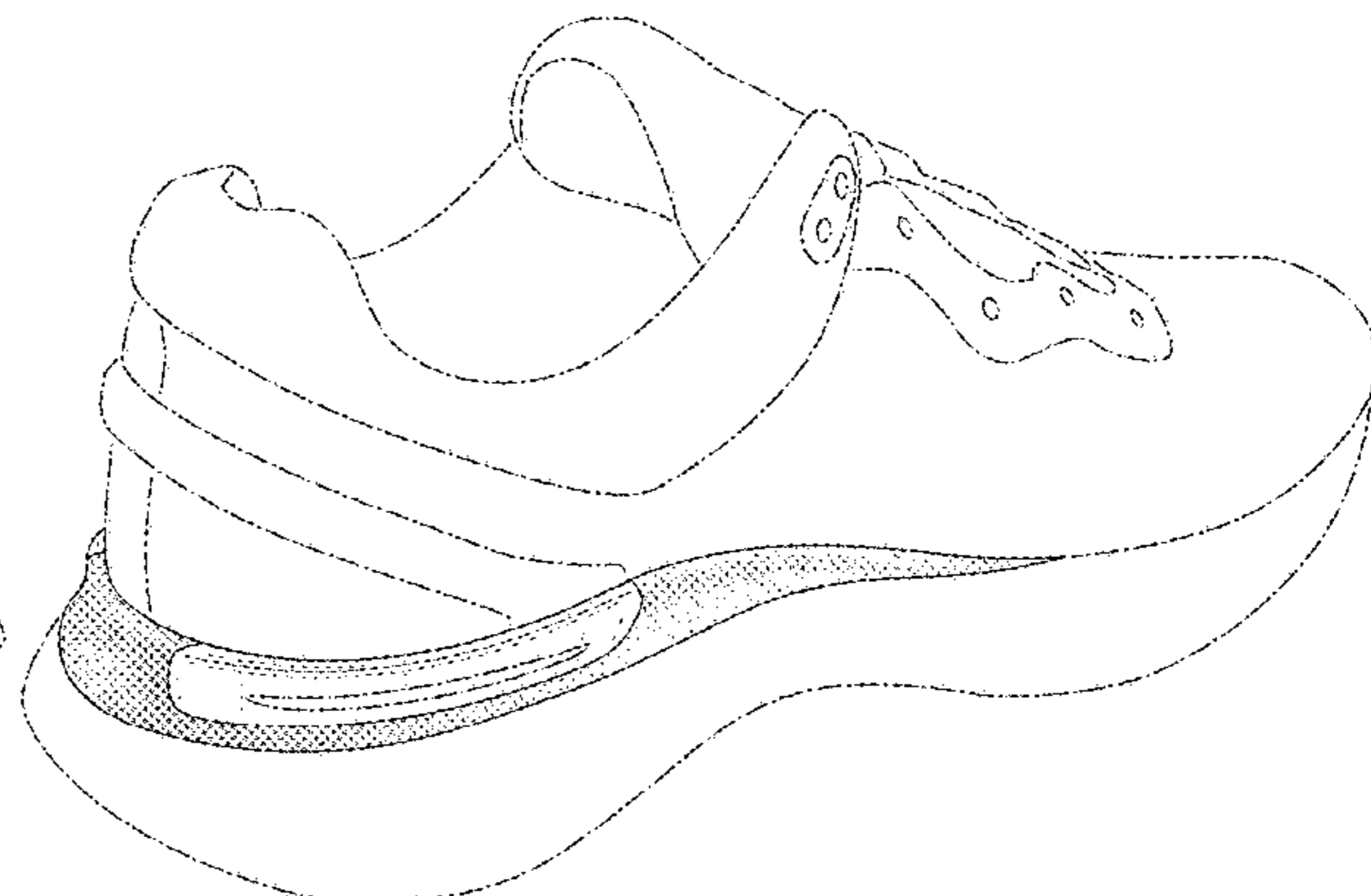
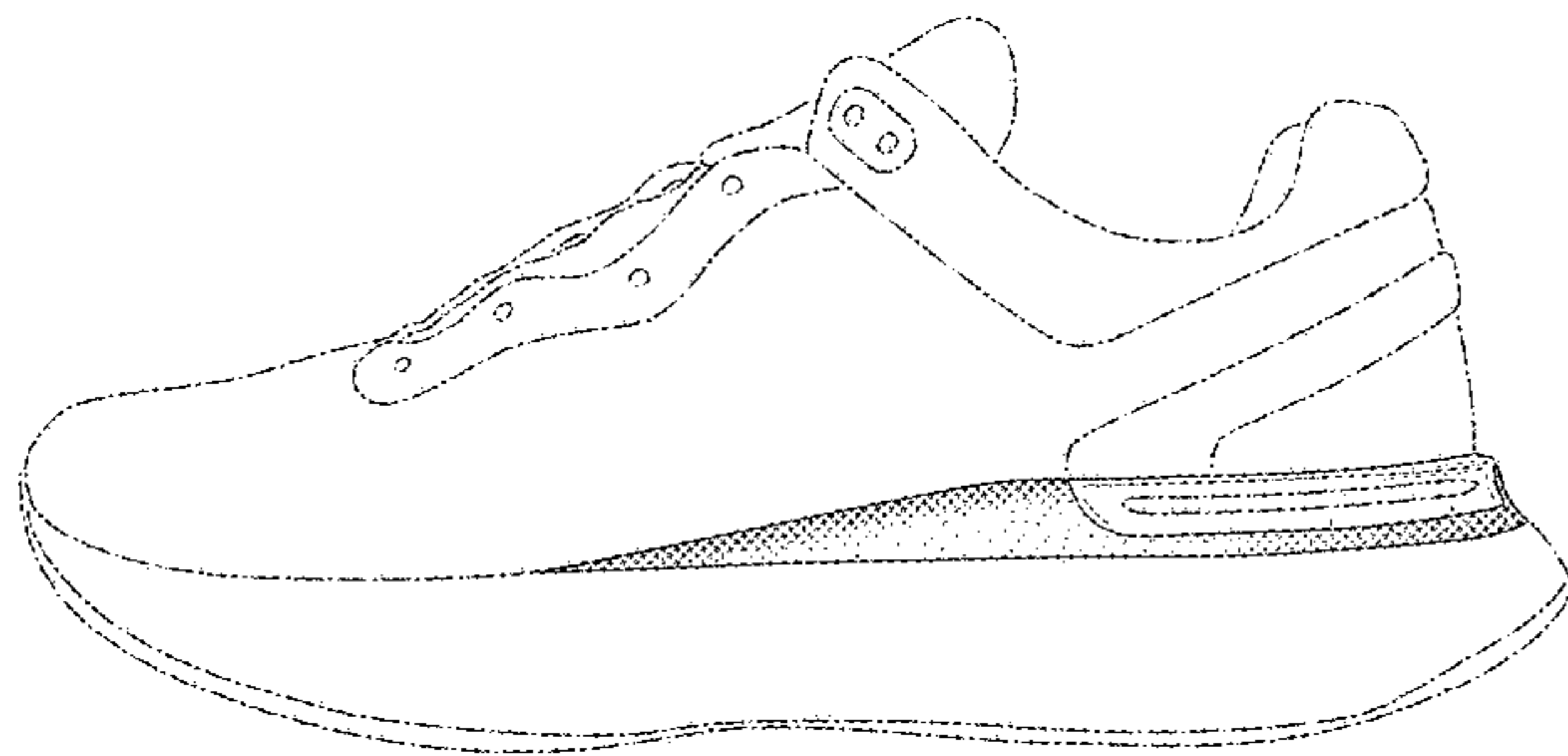
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a side view of a shoe showing my new design; FIG. 2 is a rear perspective view thereof; FIG. 3 is a rear view thereof; FIG. 4 is an opposite side rear perspective view thereof; and, FIG. 5 is an opposite side view thereof. The broken lines showing the two racetrack shaped elements form no part of the claimed design. The broken lines depicting the remainder of the shoe form no part of the claimed design.

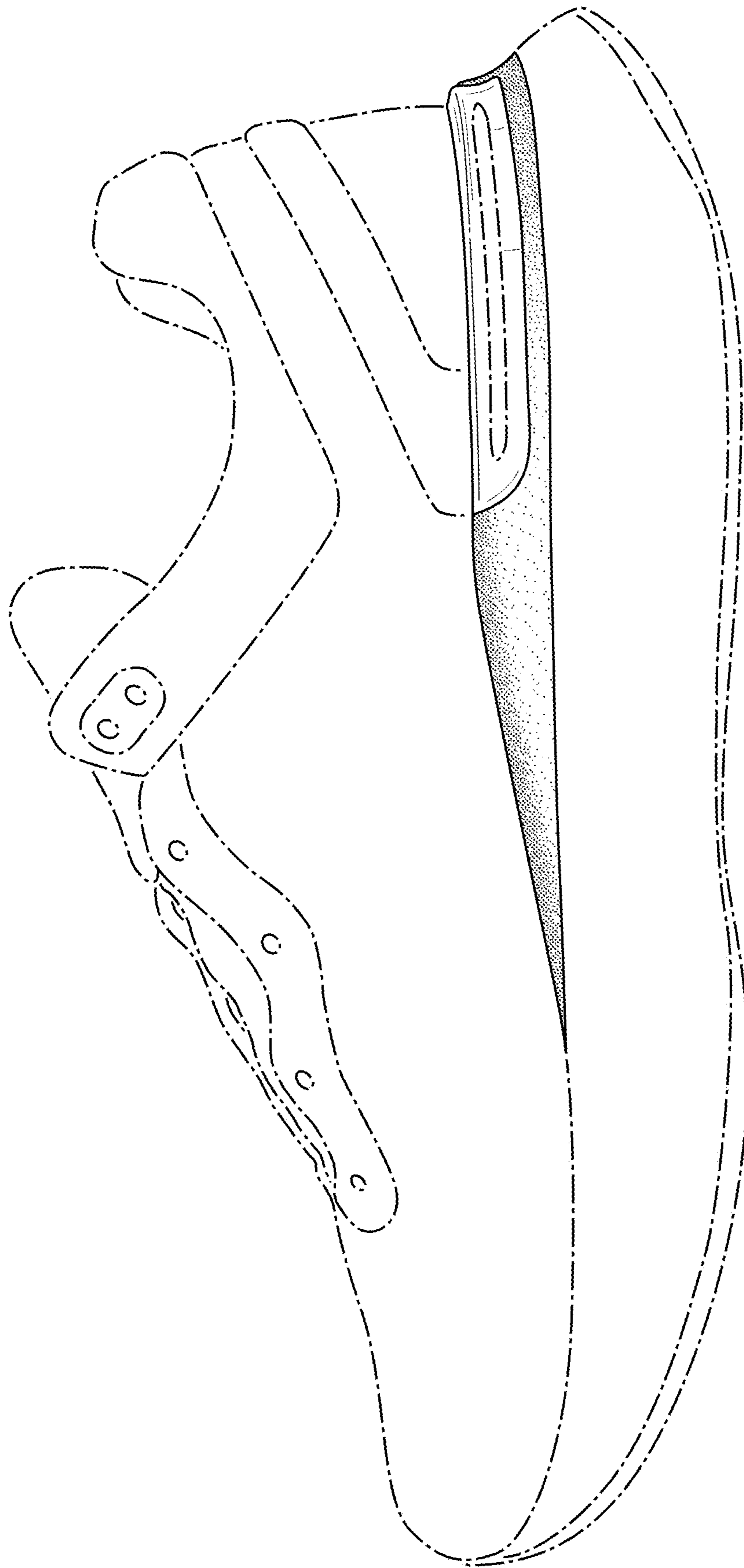

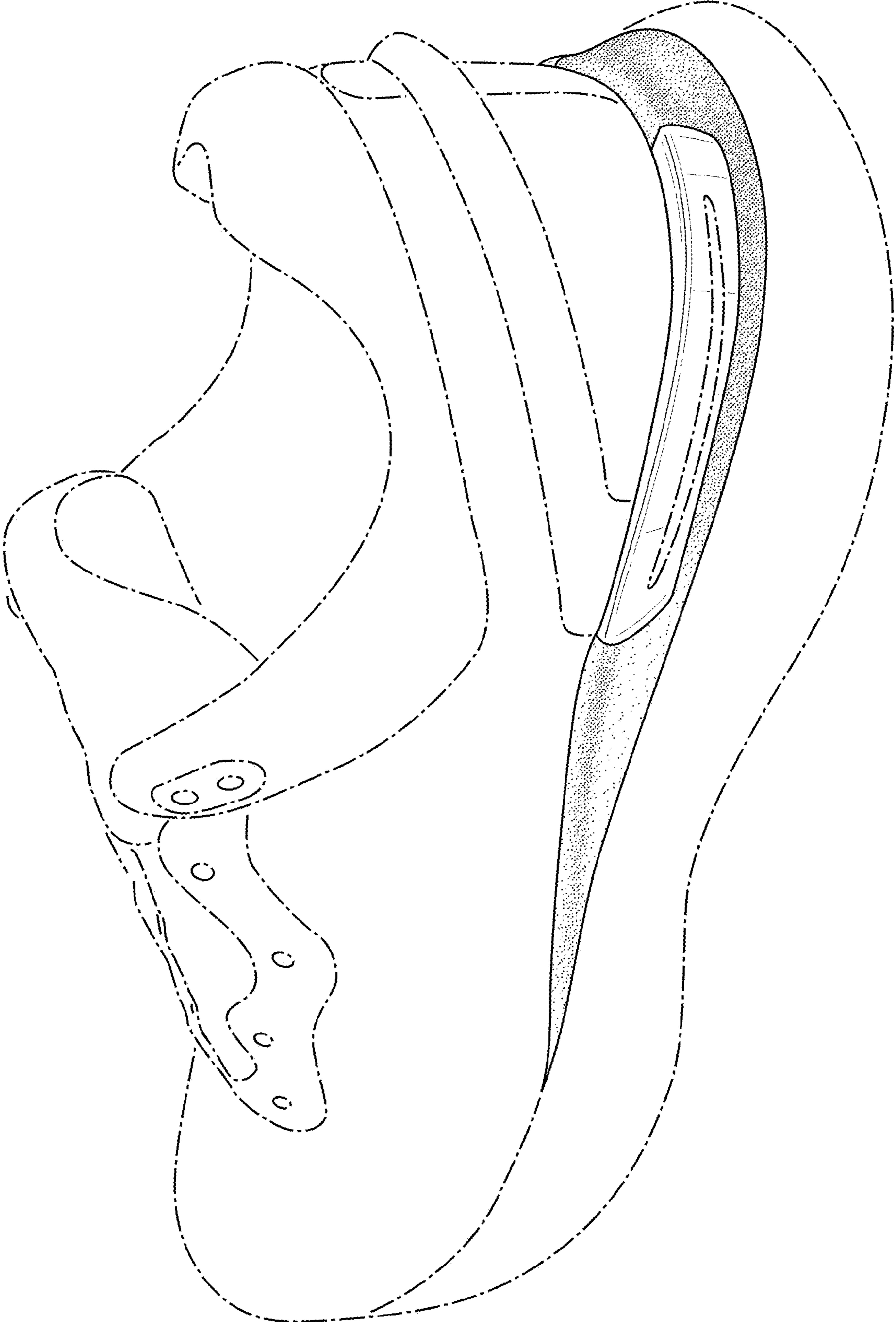

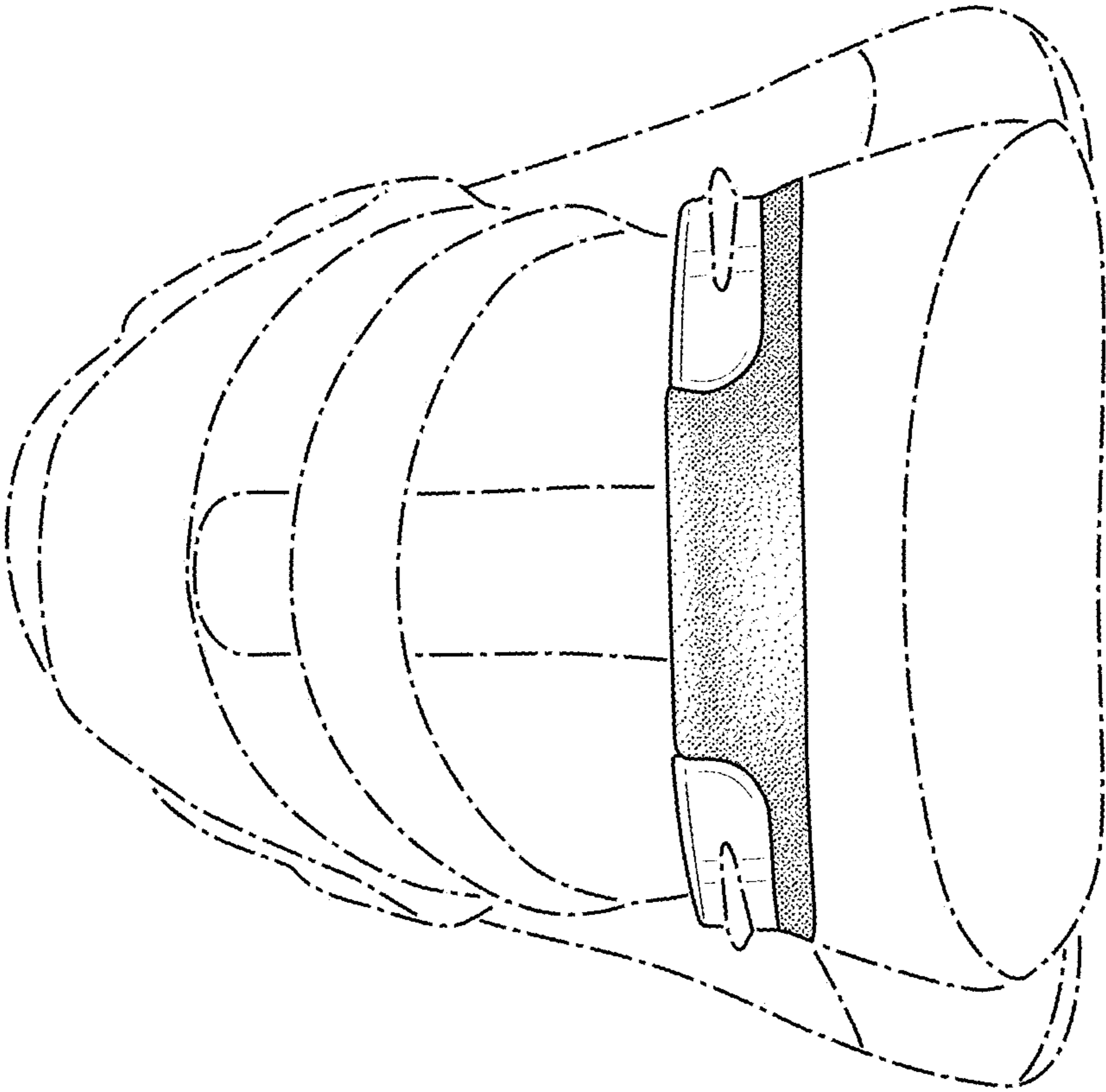

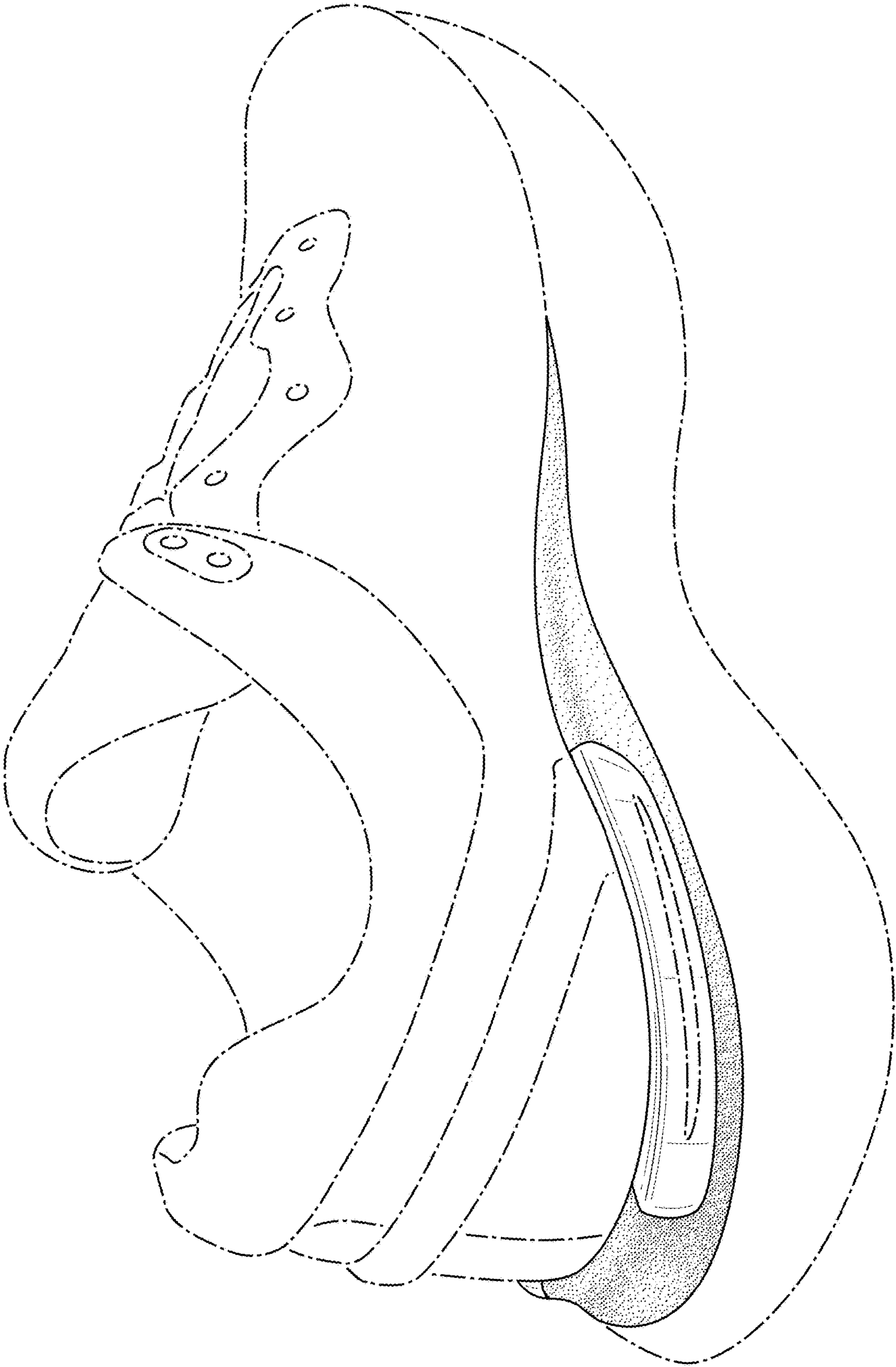

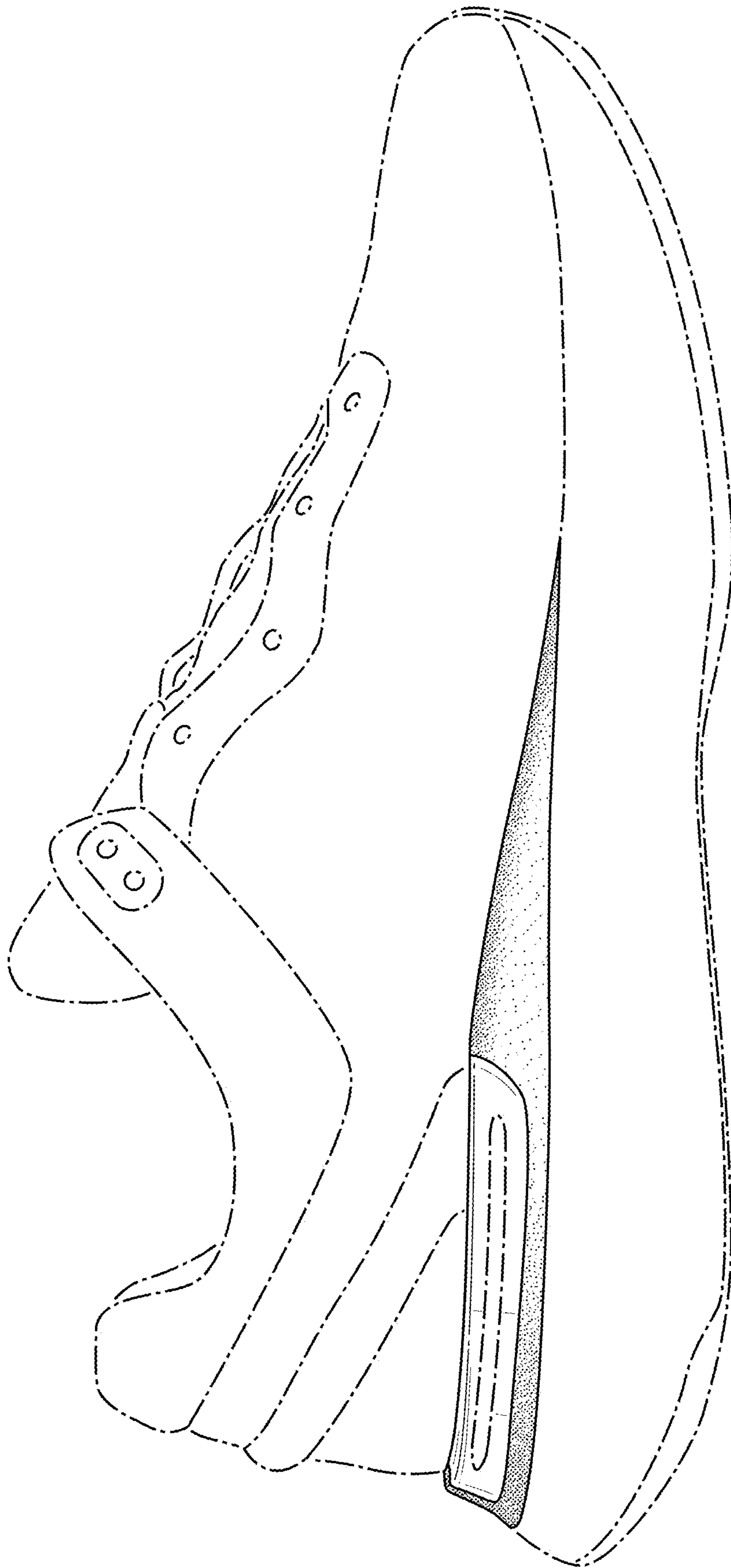
