FIG. 4 is an enlarged view of the claim as shown in FIG. 2 with environment removed for clarity purposes.

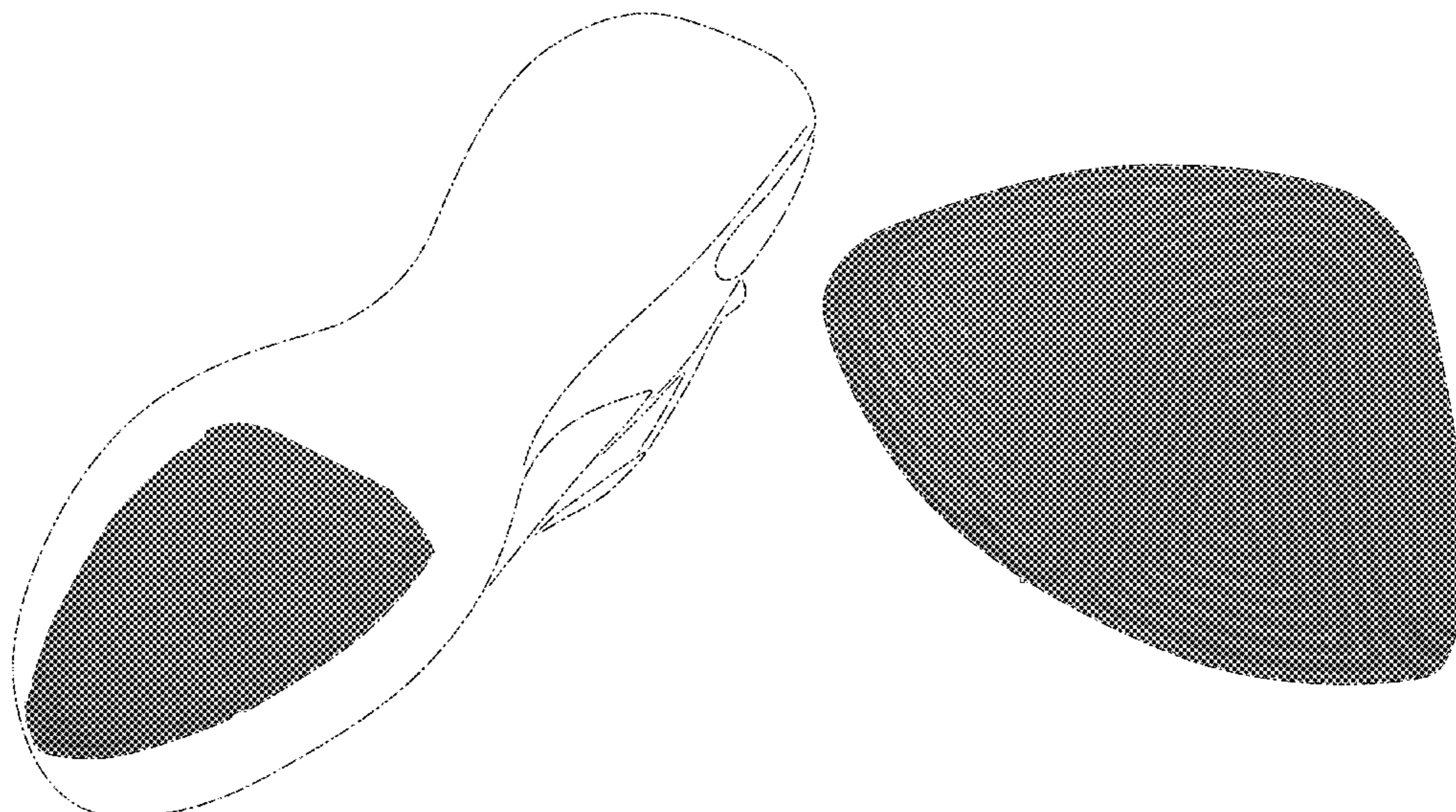

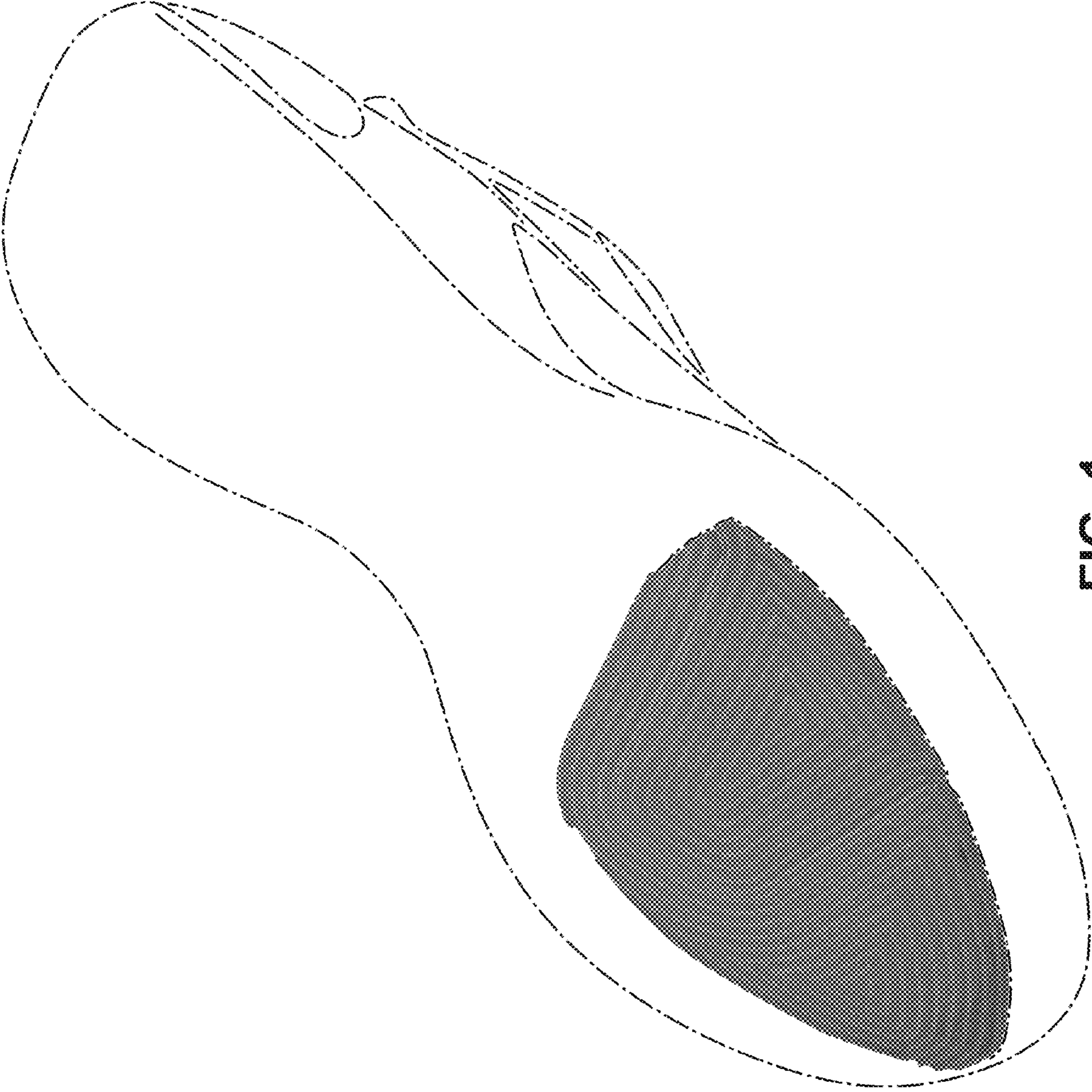

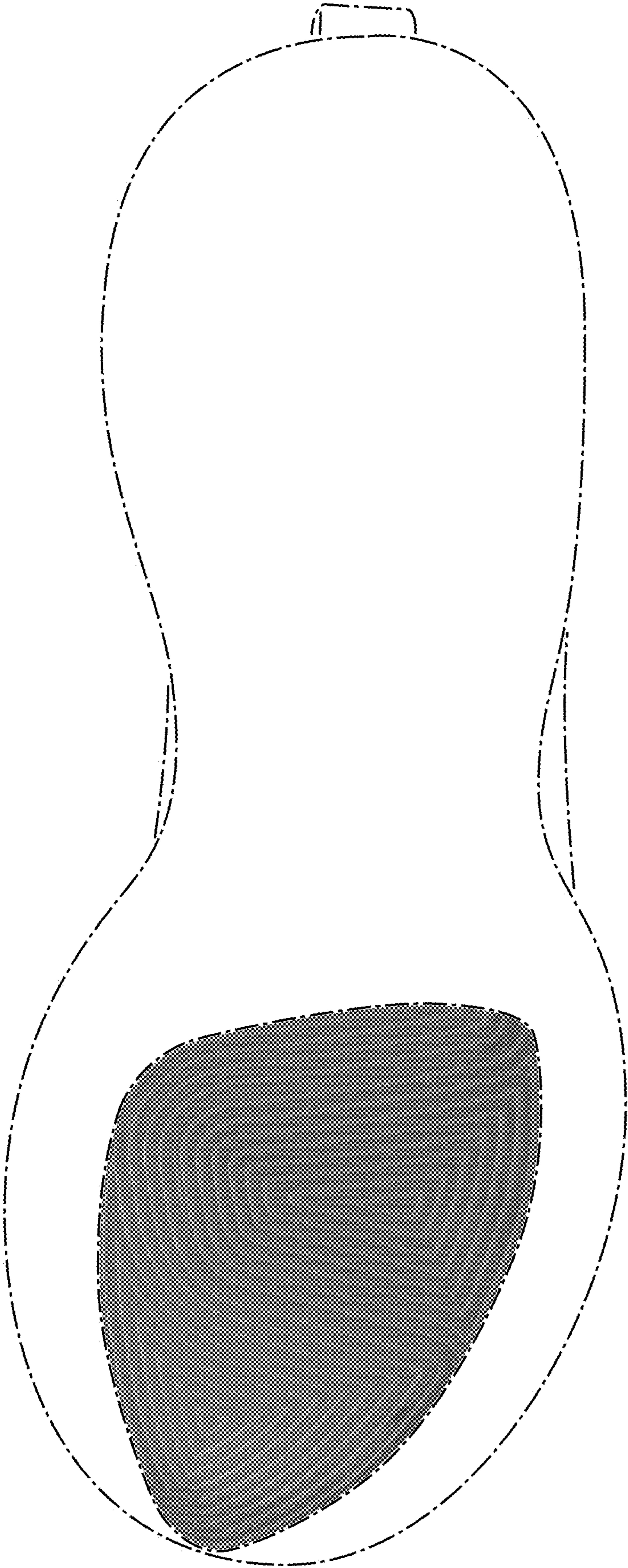

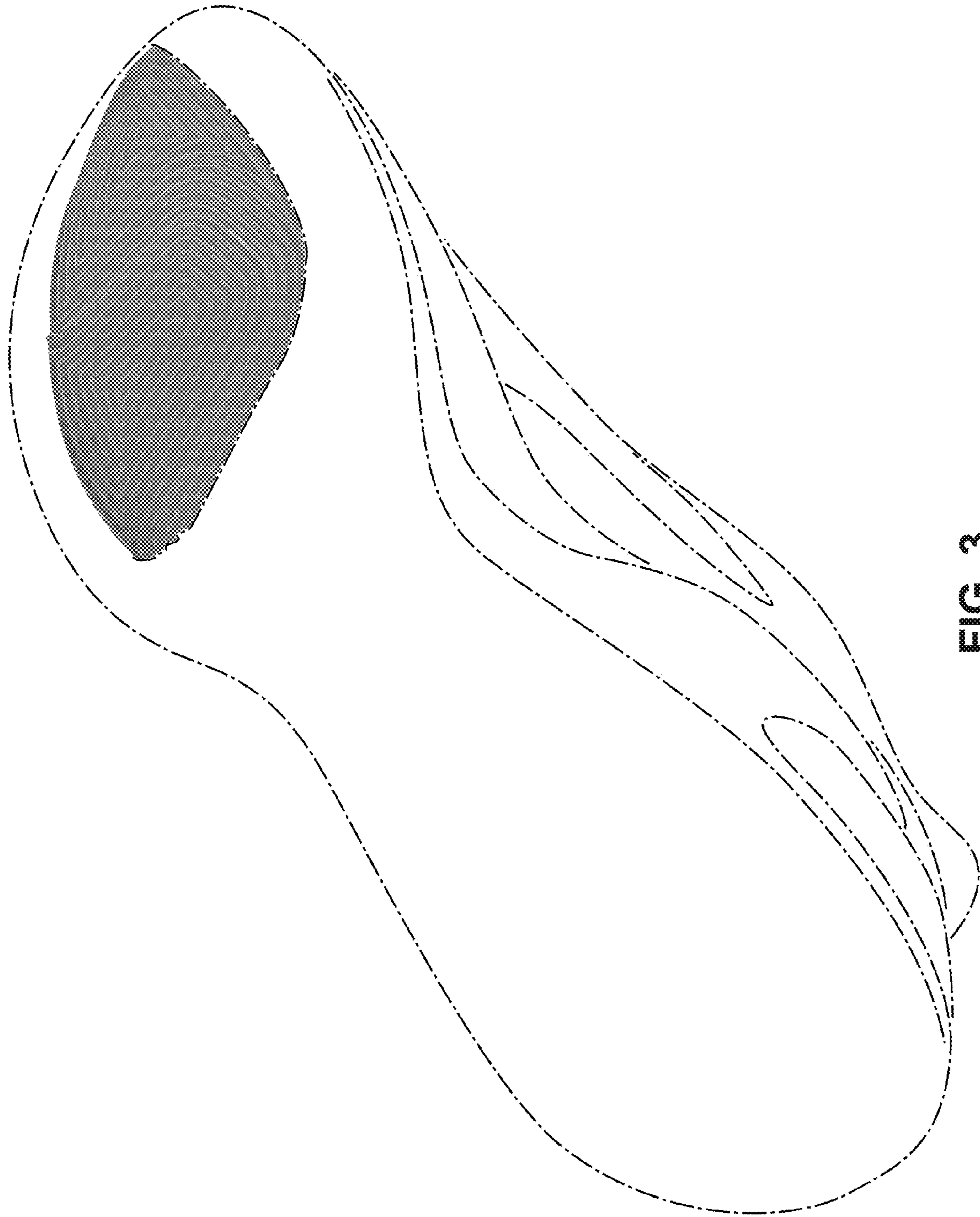

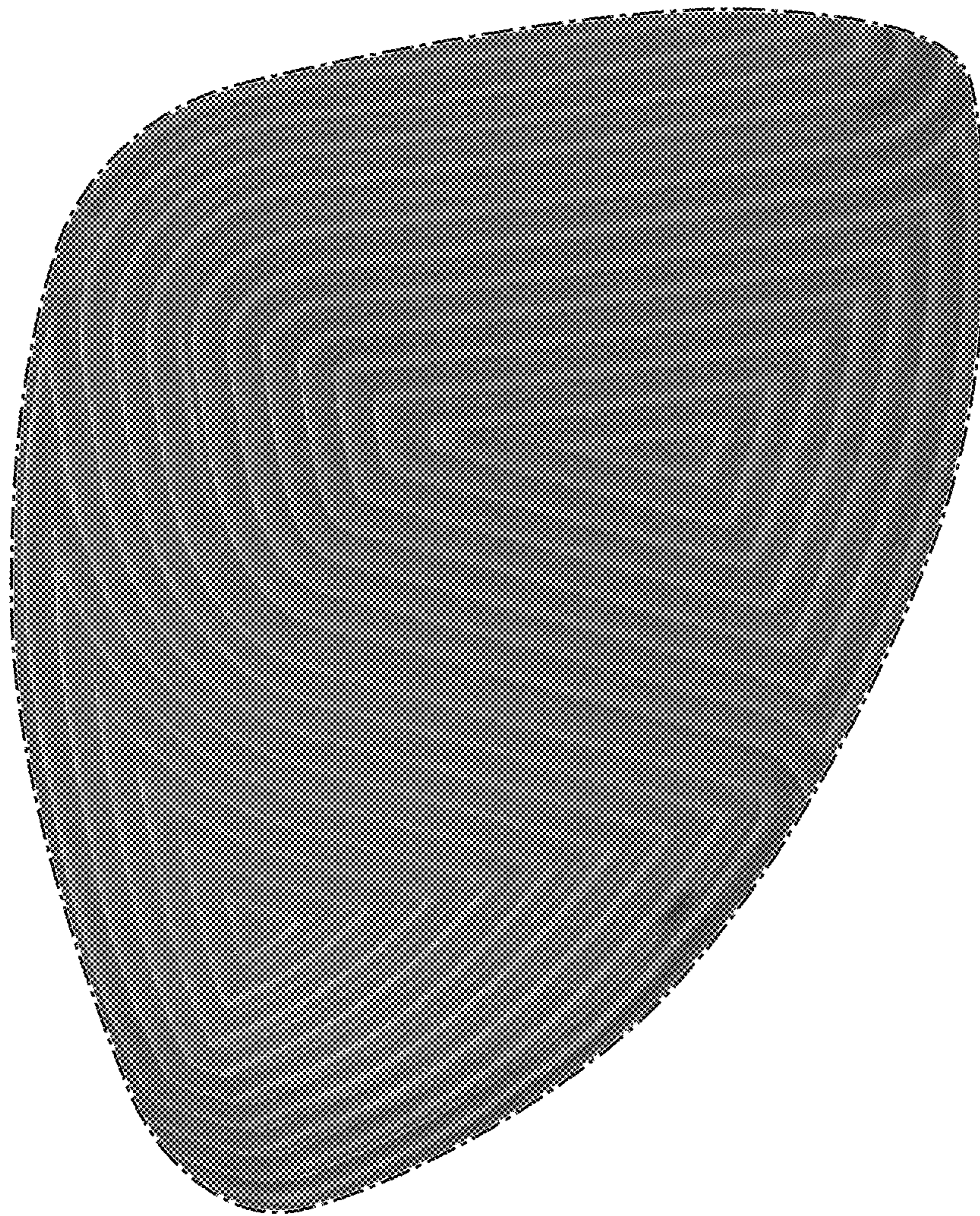
