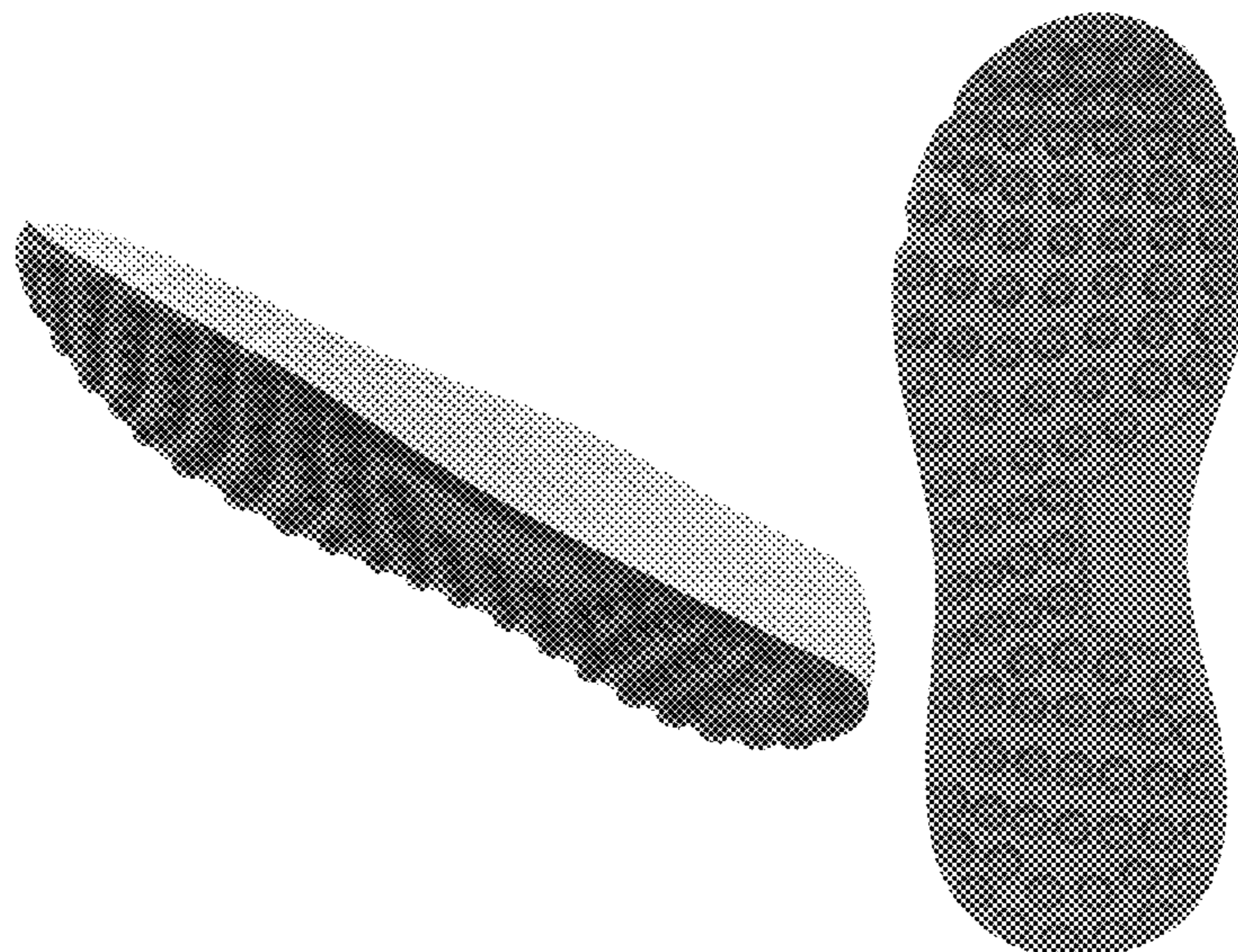
The ornamental design for a shoe sole, as shown and described.

DESCRIPTION

- 1. Shoe sole
- 1.1 : Perspective
- 1.2 : Front
- 1.3 : Back
- 1.4 : Right
- 1.5 : Left
- 1.6 : Top
- 1.7 : Bottom

The various views of the design show only the right shoe sole; the left shoe sole is not shown as it is symmetrical to the right one; the shoe sole of the present design is shown in greyscale, as protection of the present design is not to be limited to a specific colour and/or combination of colours of the shoe sole and of its parts.

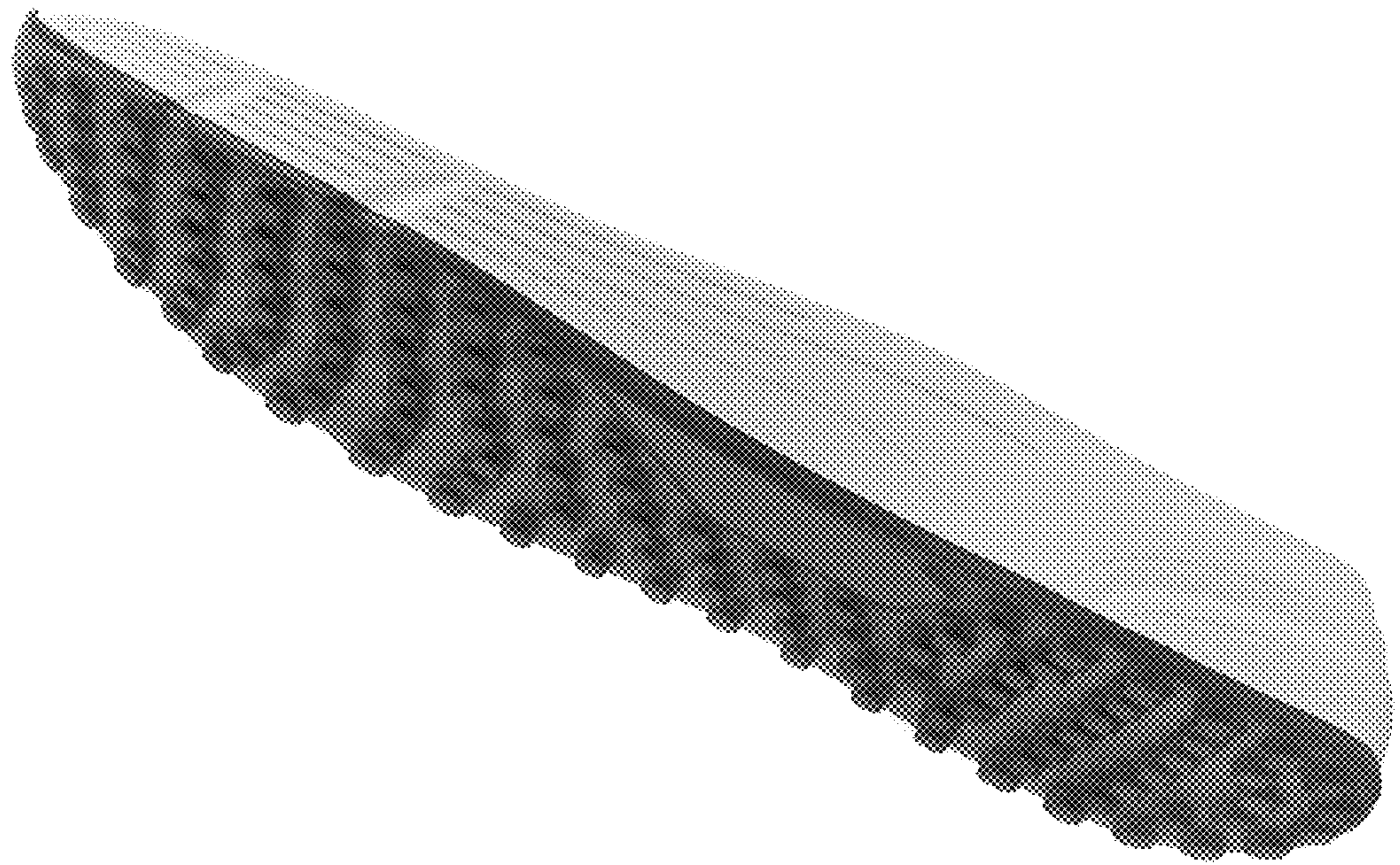

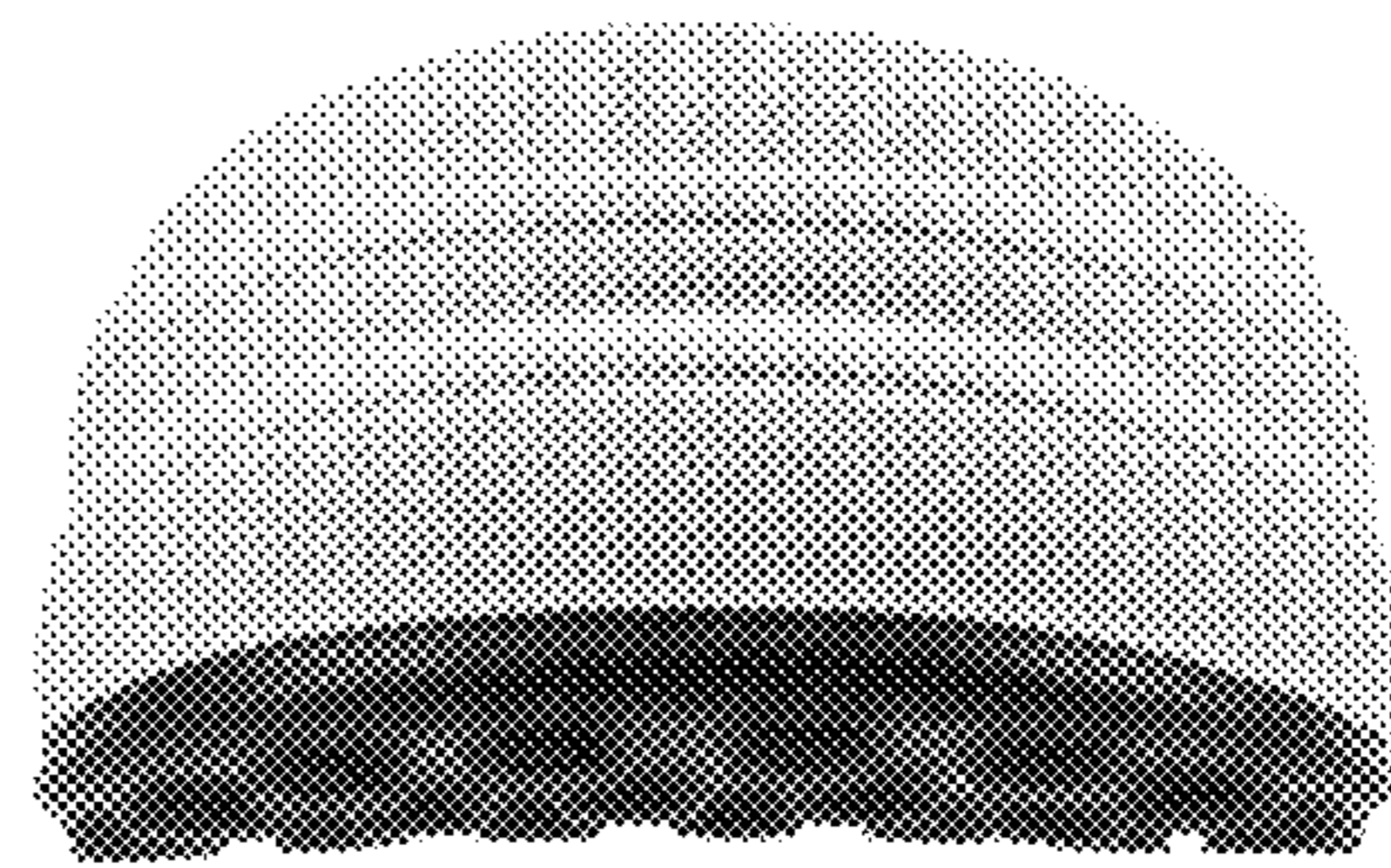

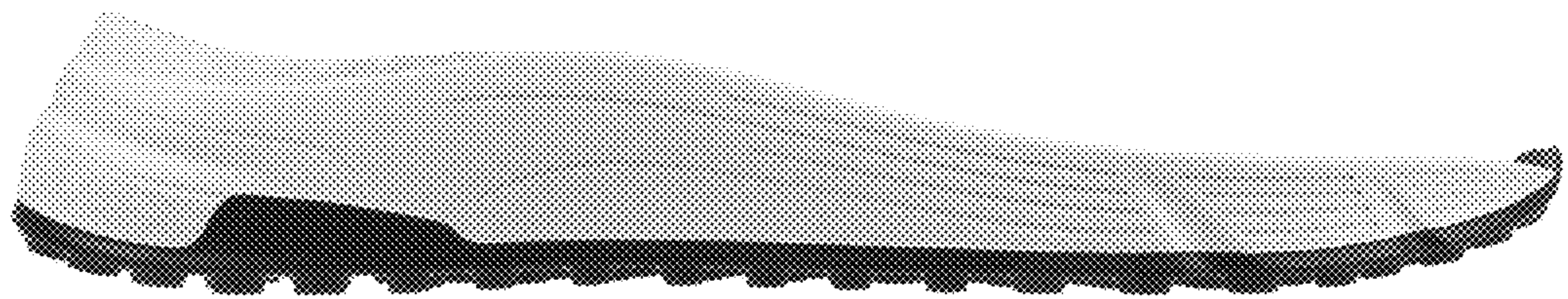
