DESCRIPTION

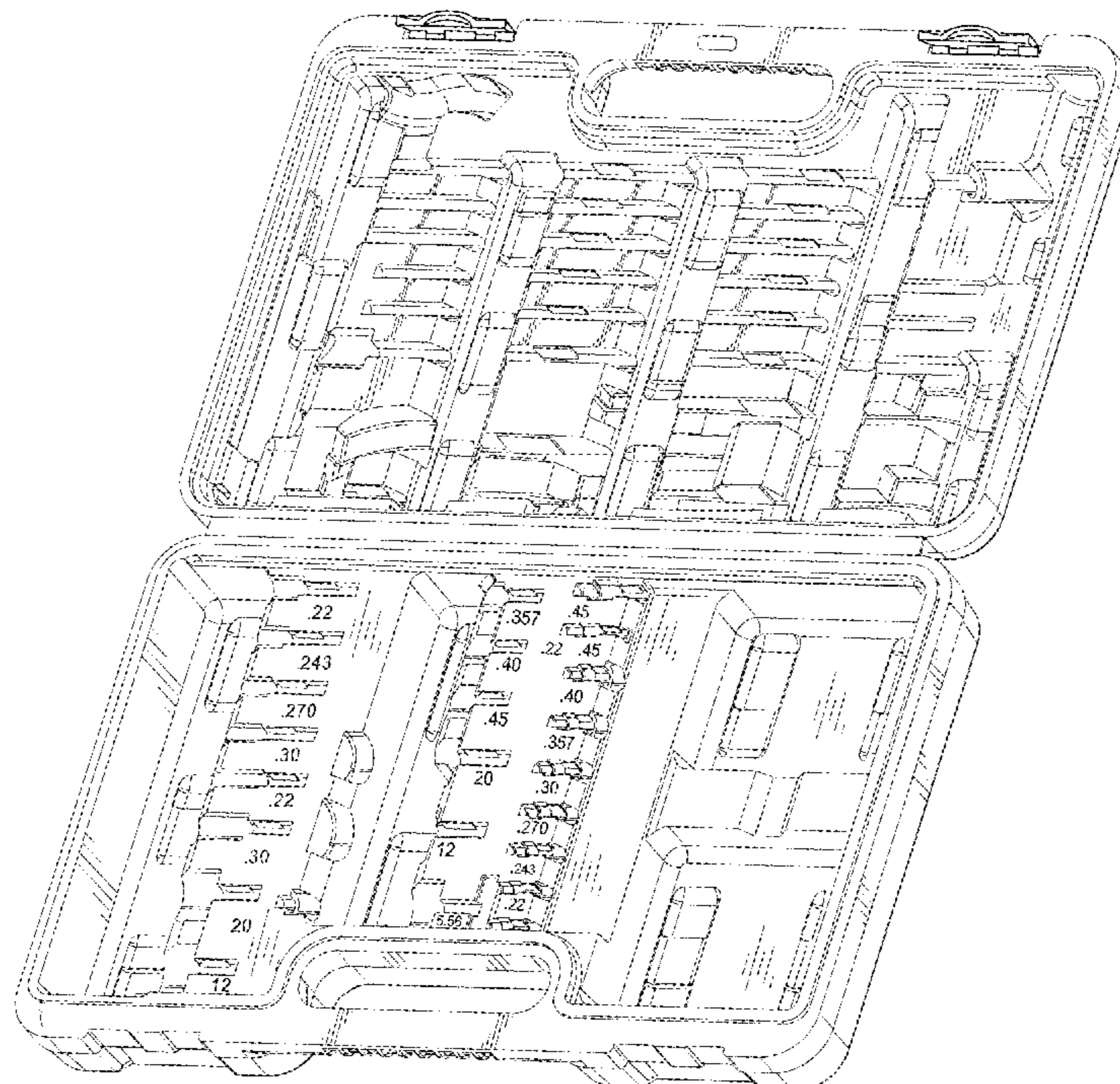
FIG. 1 is a perspective view of a gun cleaning kit case showing my new design;

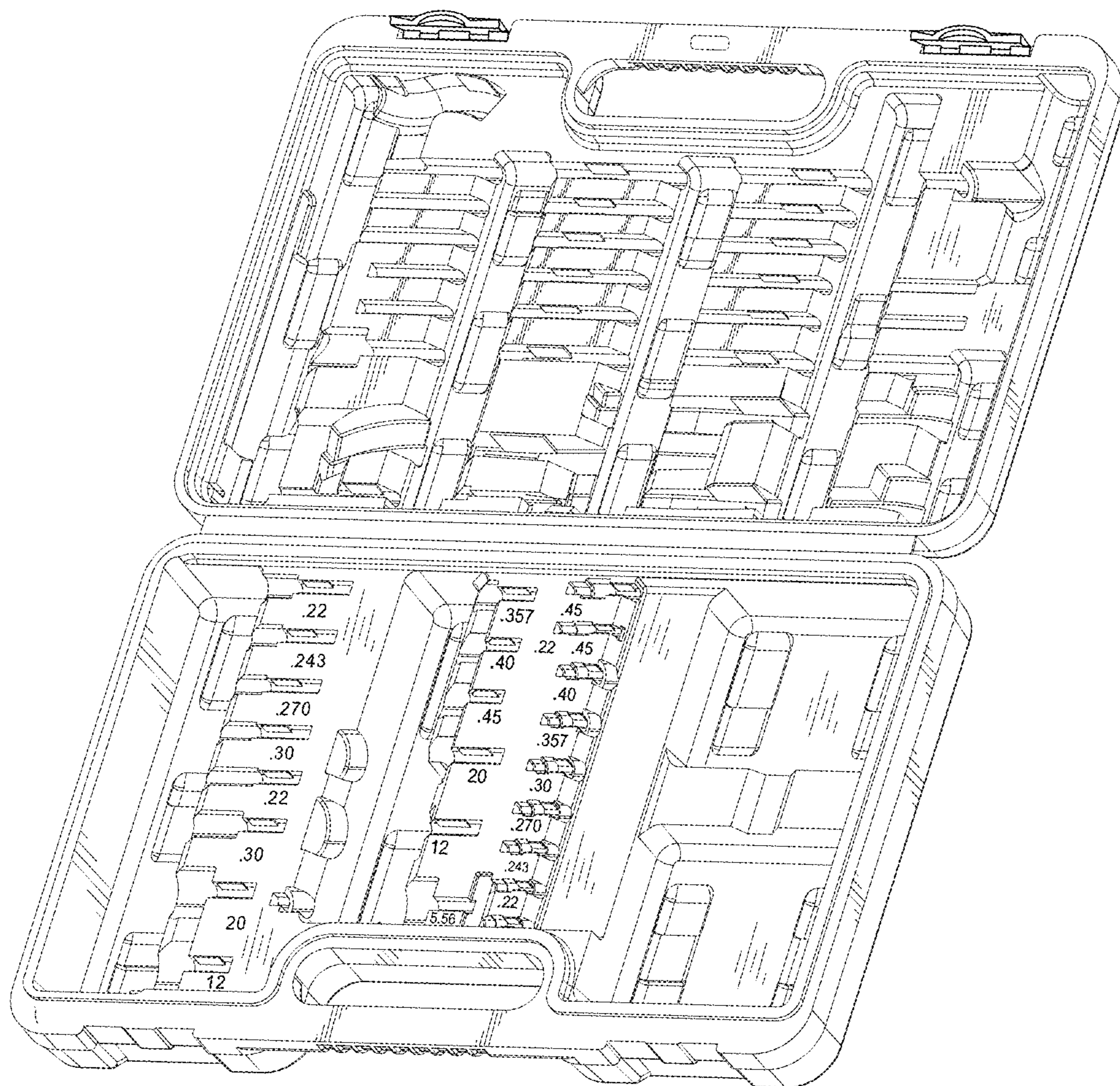

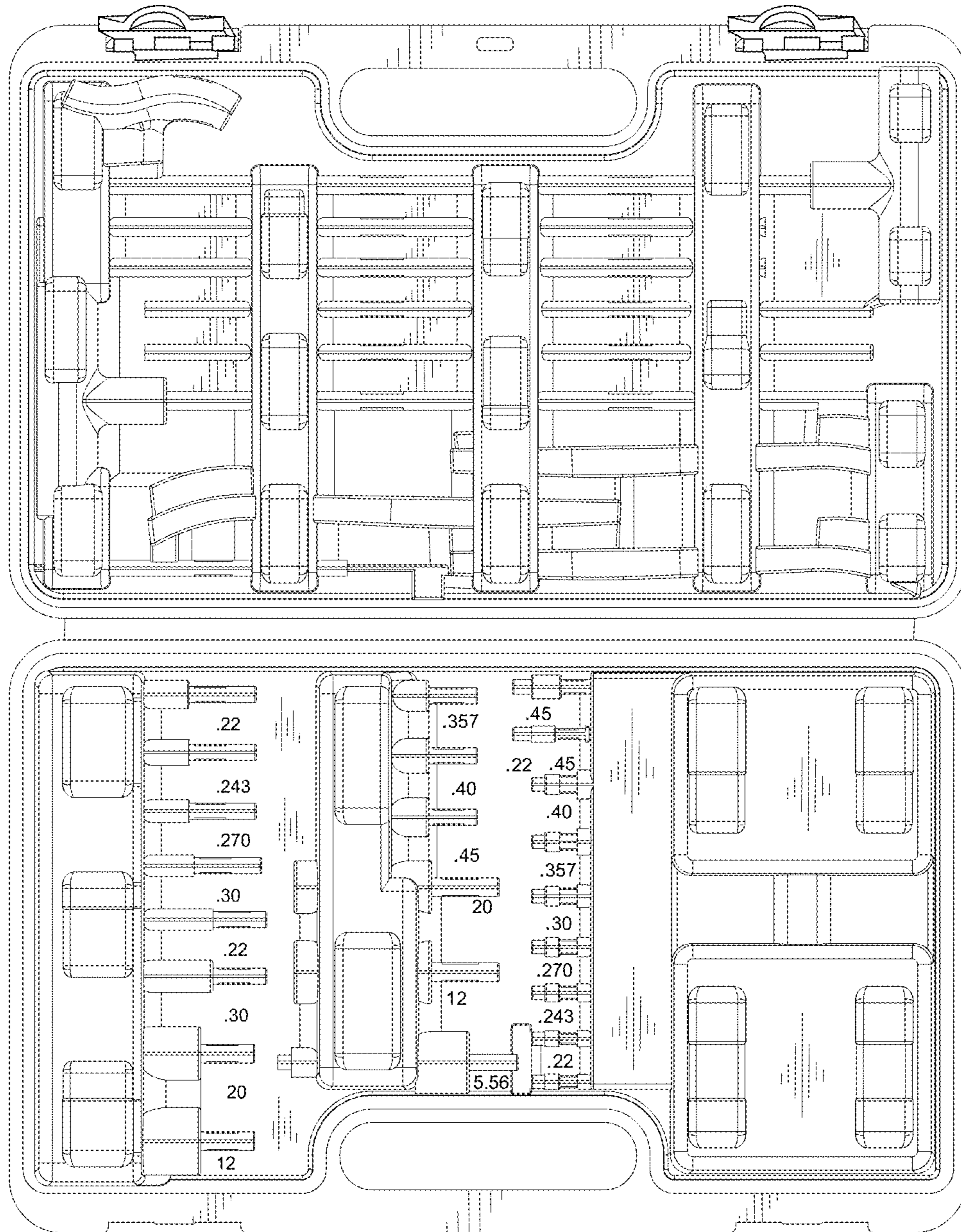

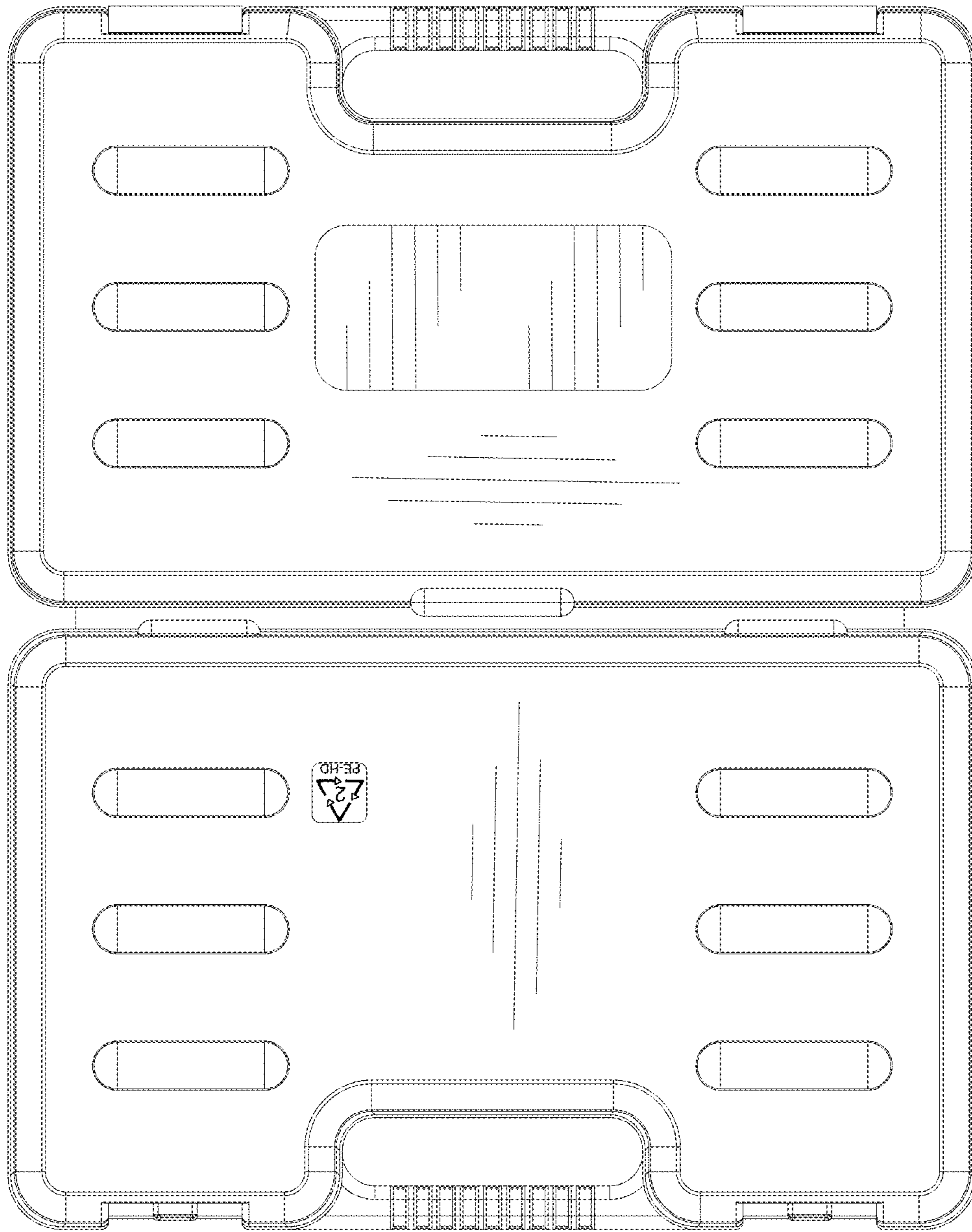

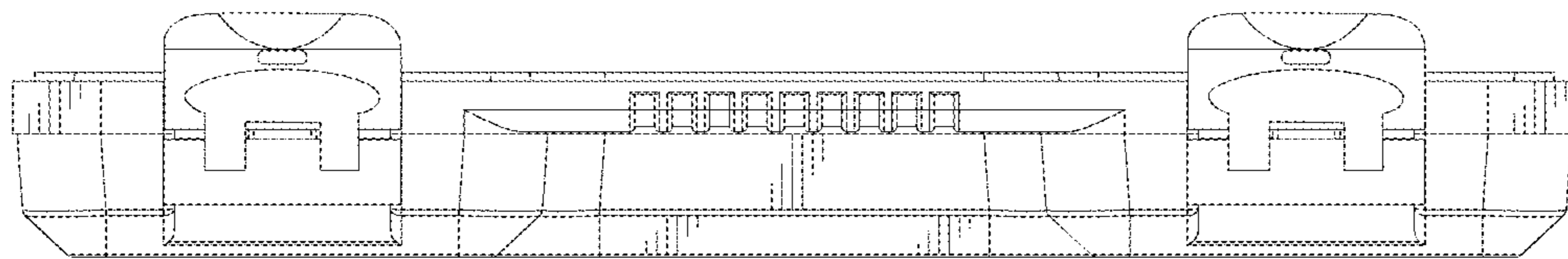

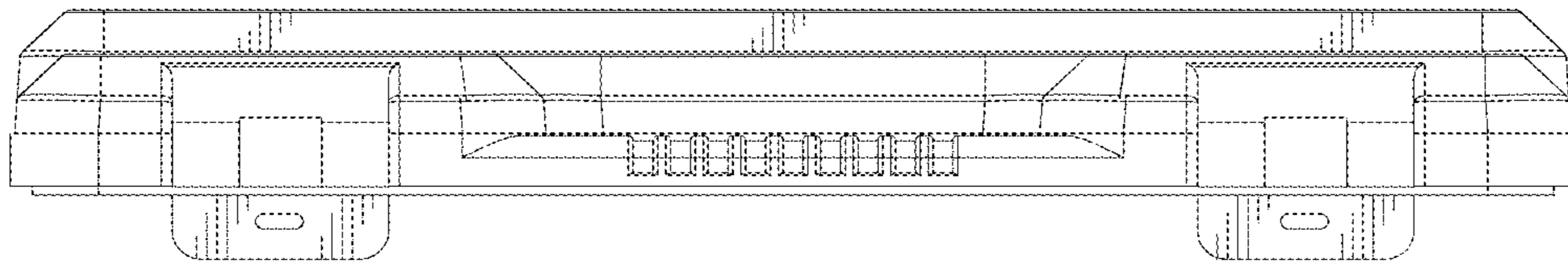

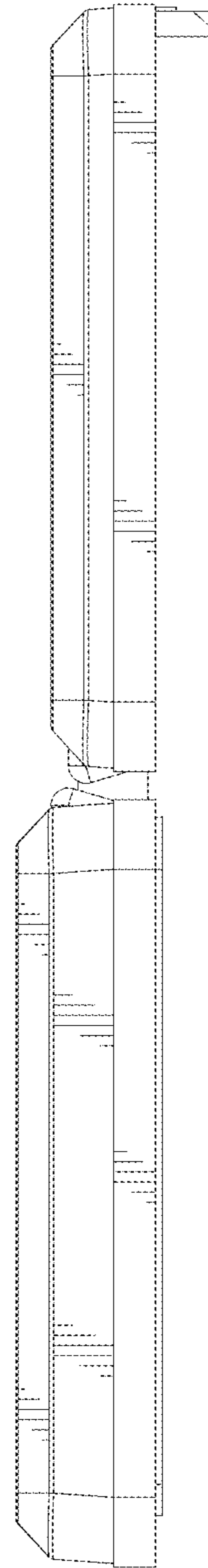

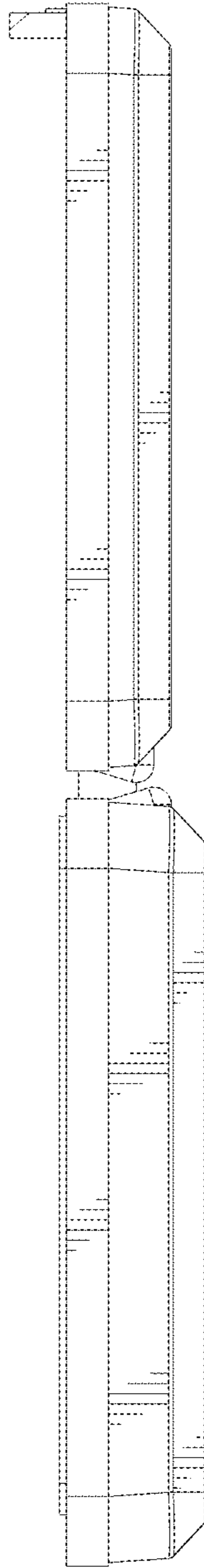

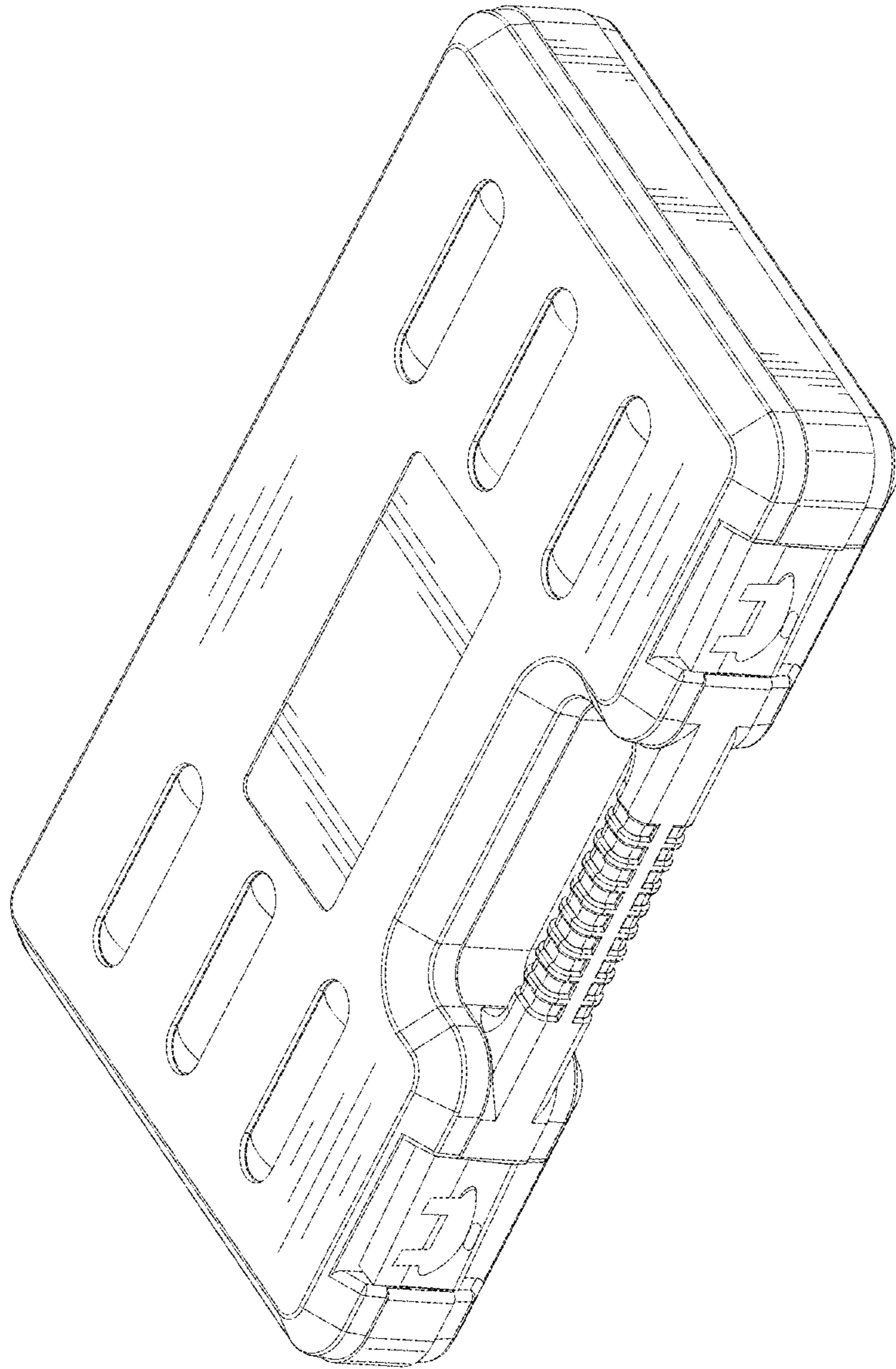

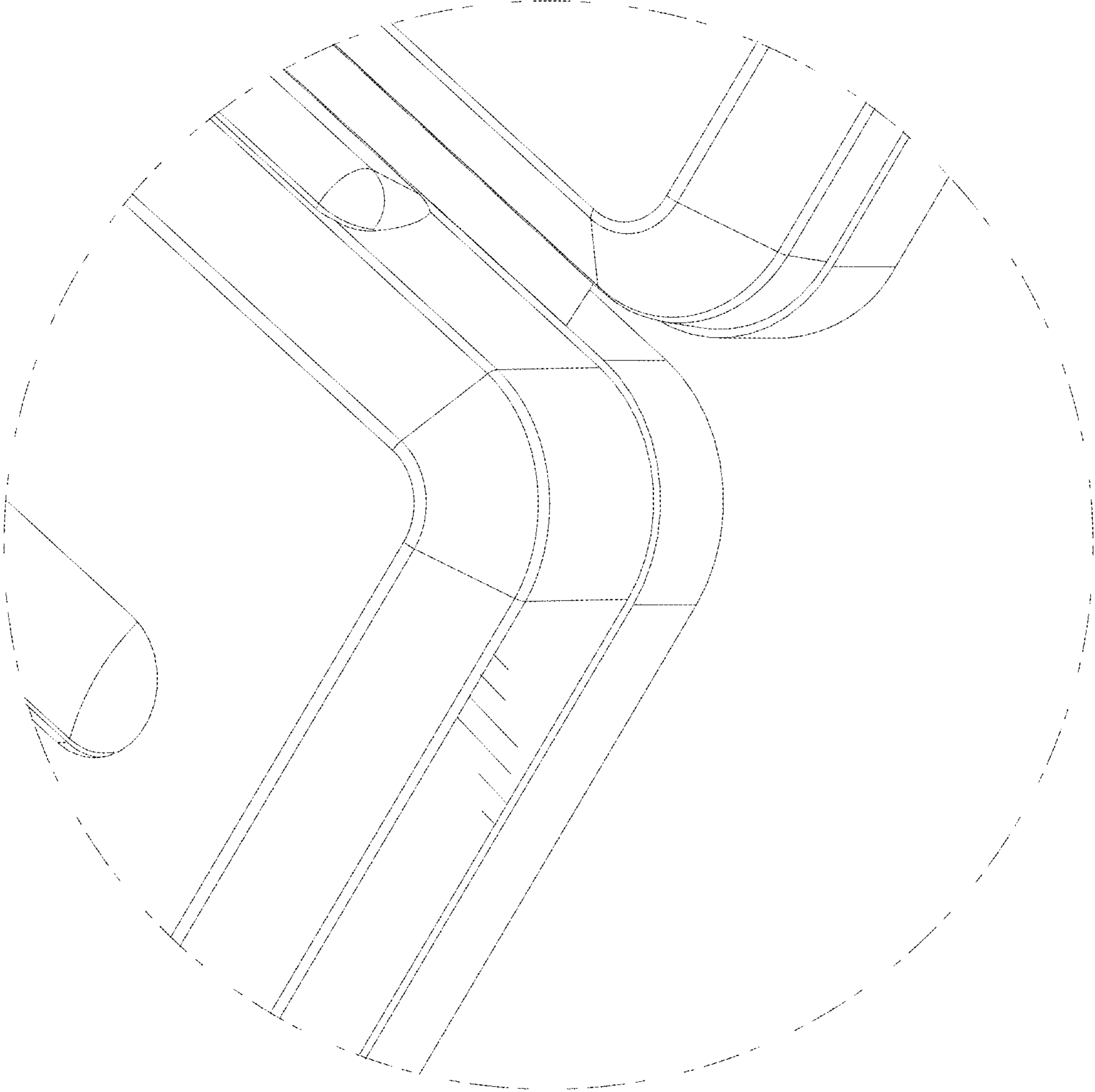
