The ornamental design for a bathroom tissue cabinet, as shown and described.

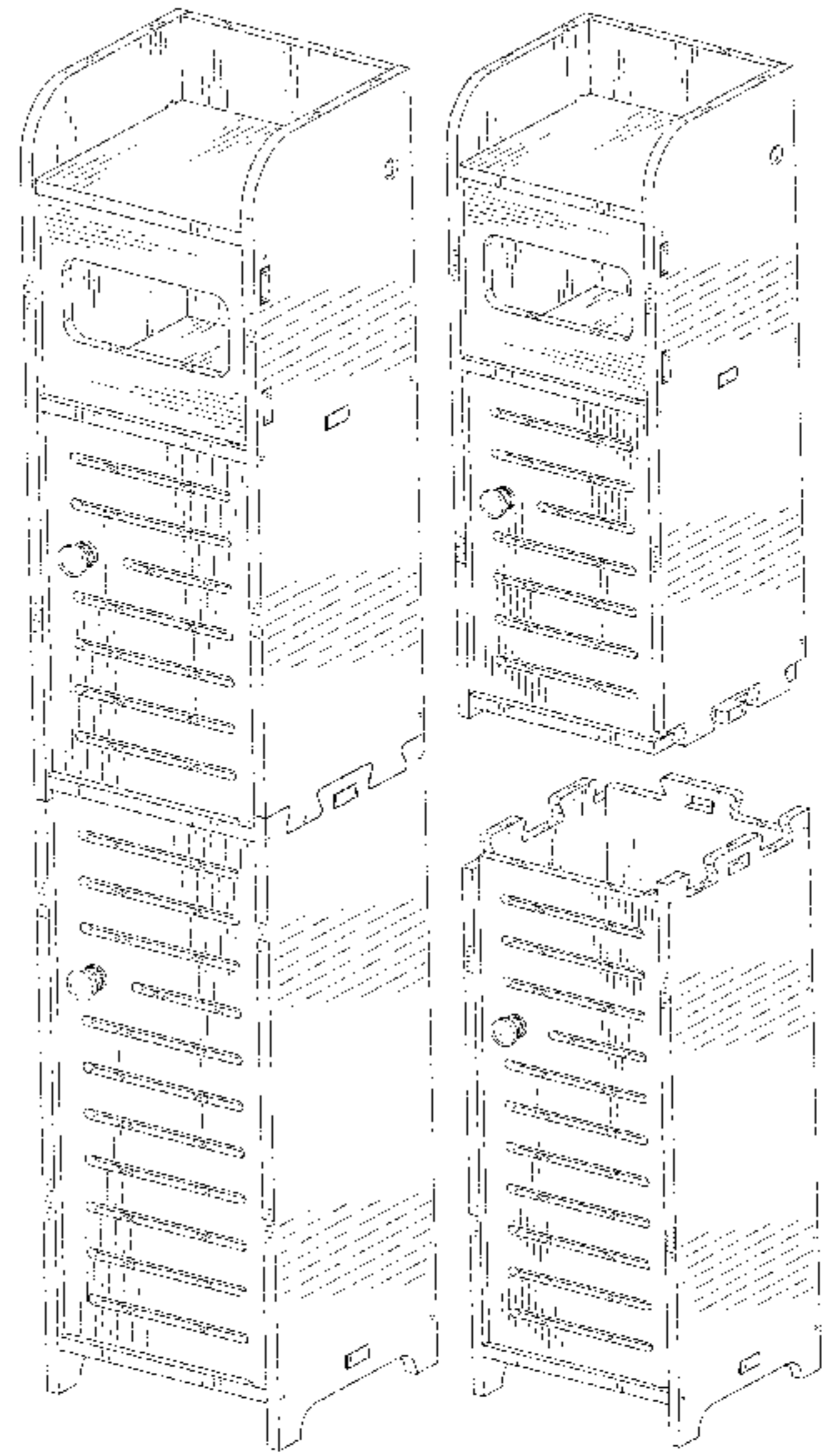
**DESCRIPTION**

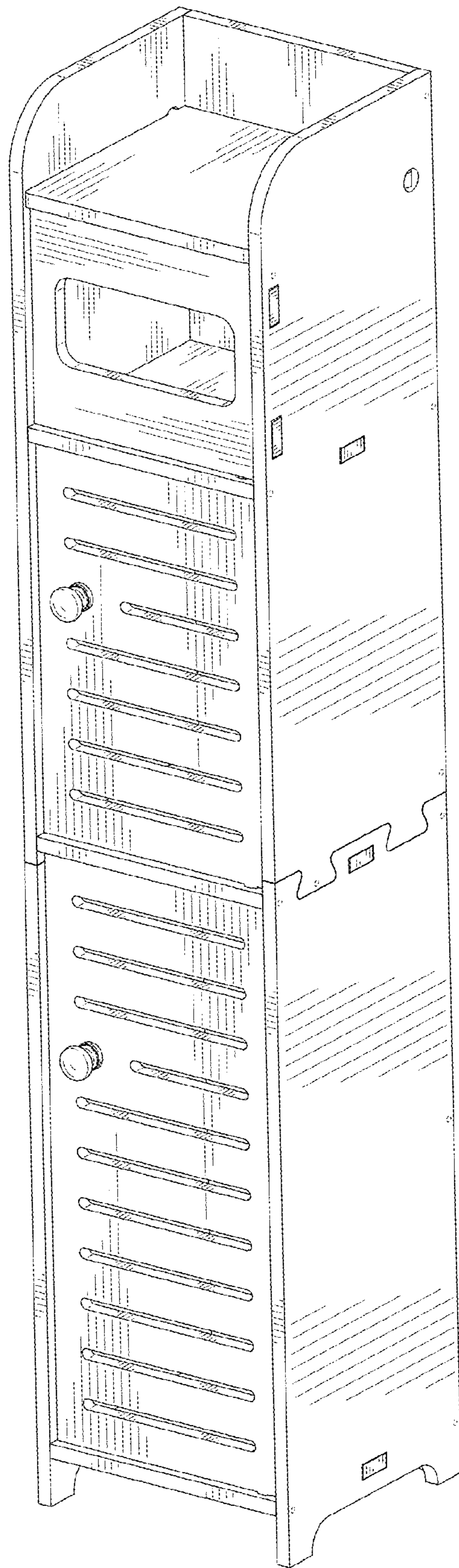

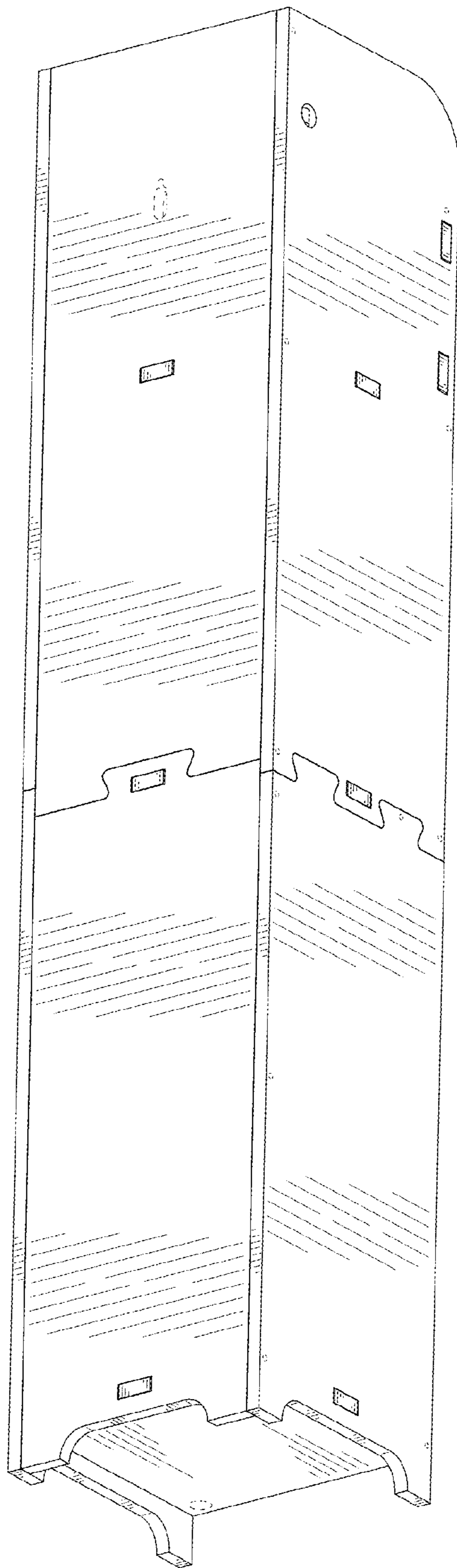

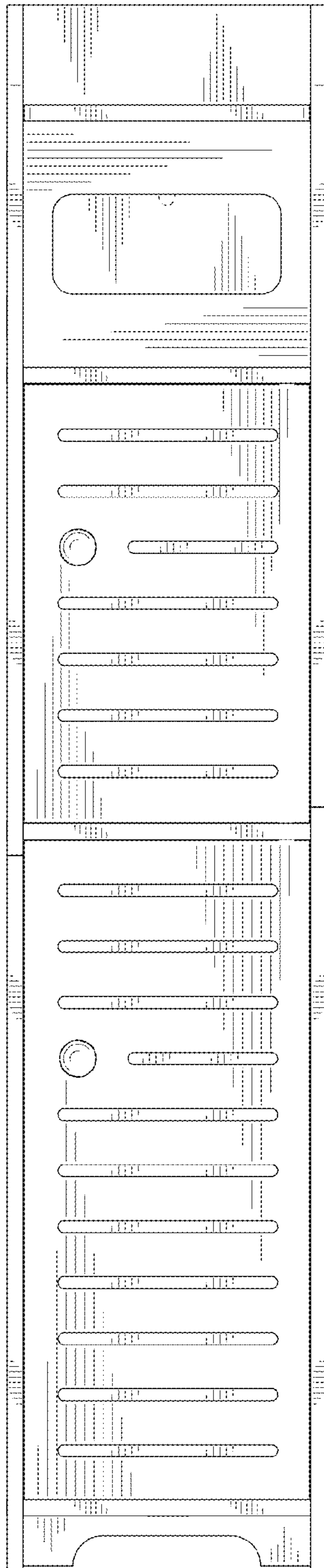

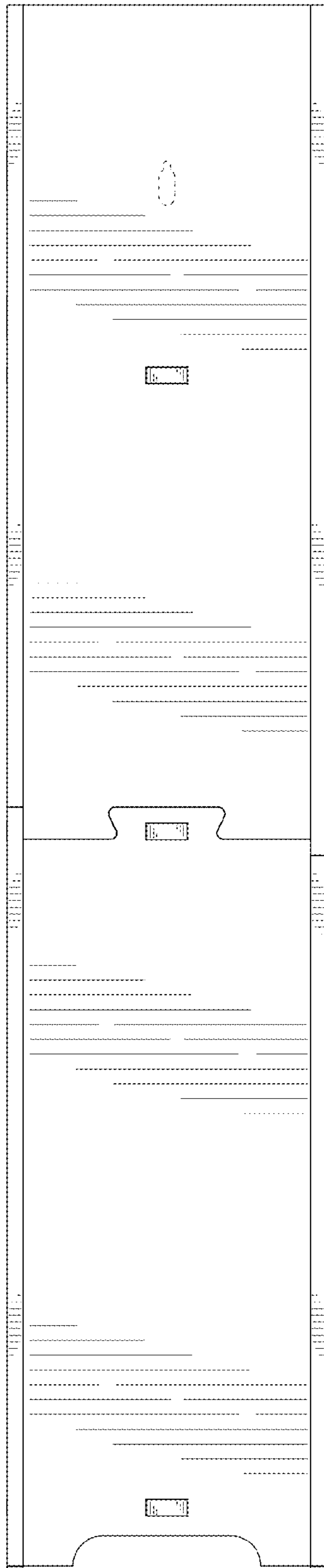

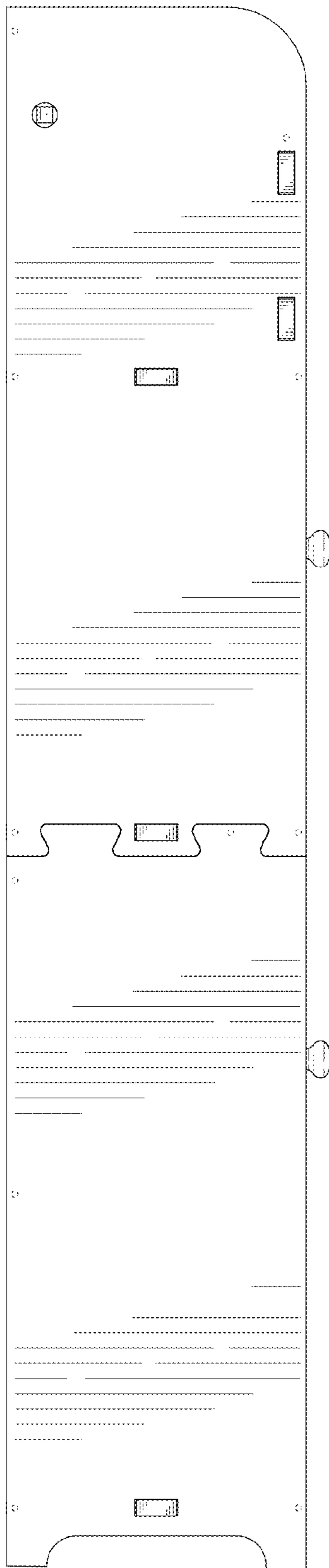

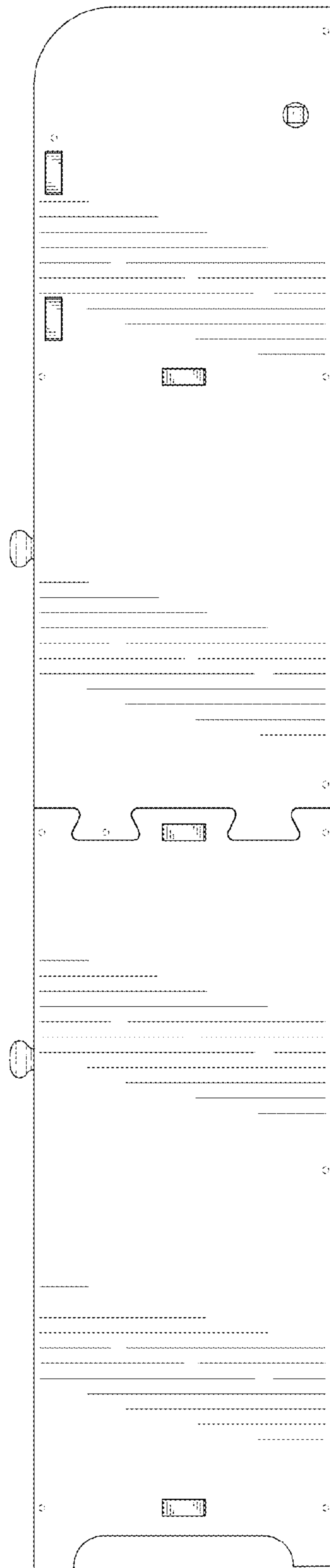

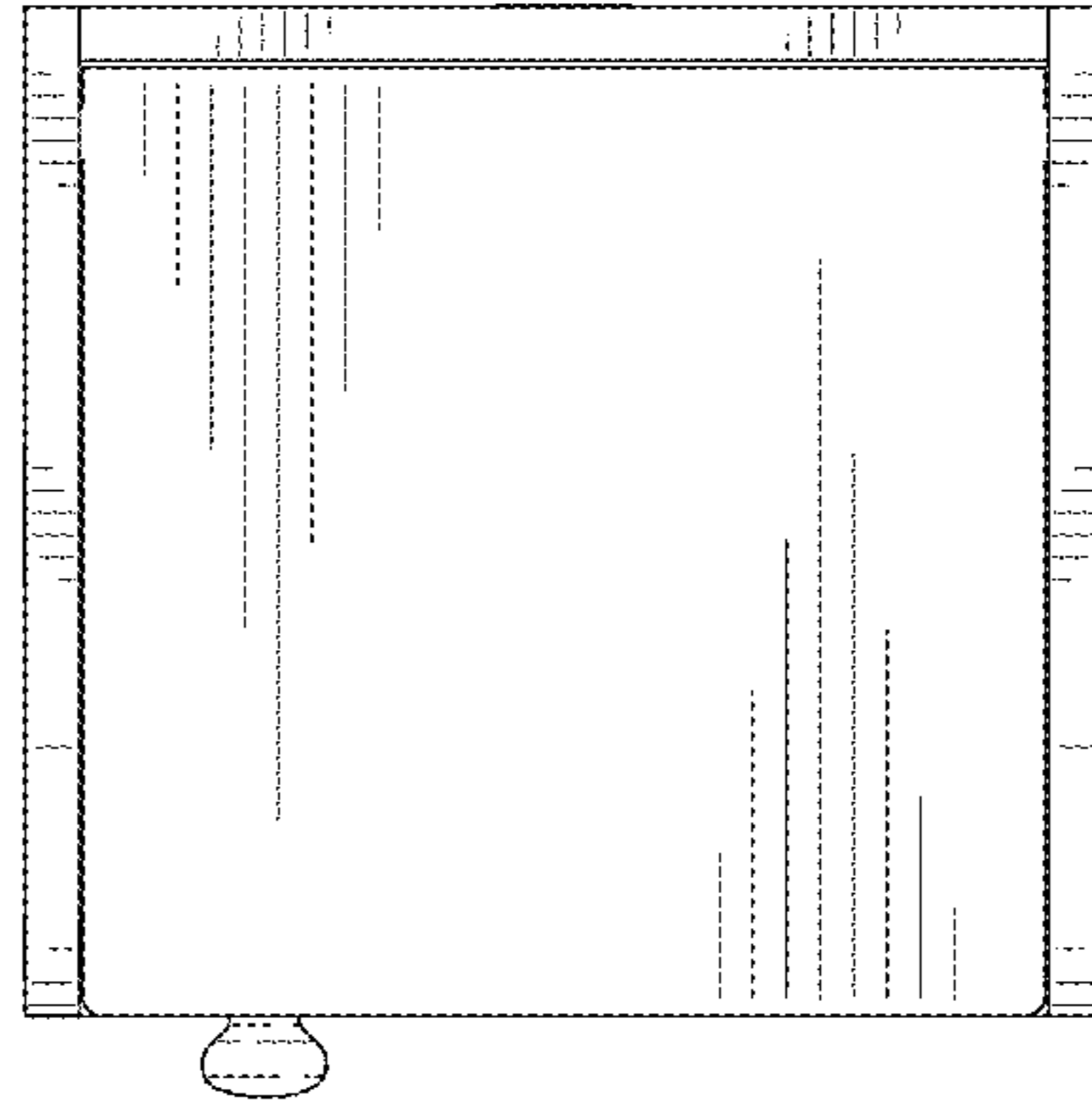

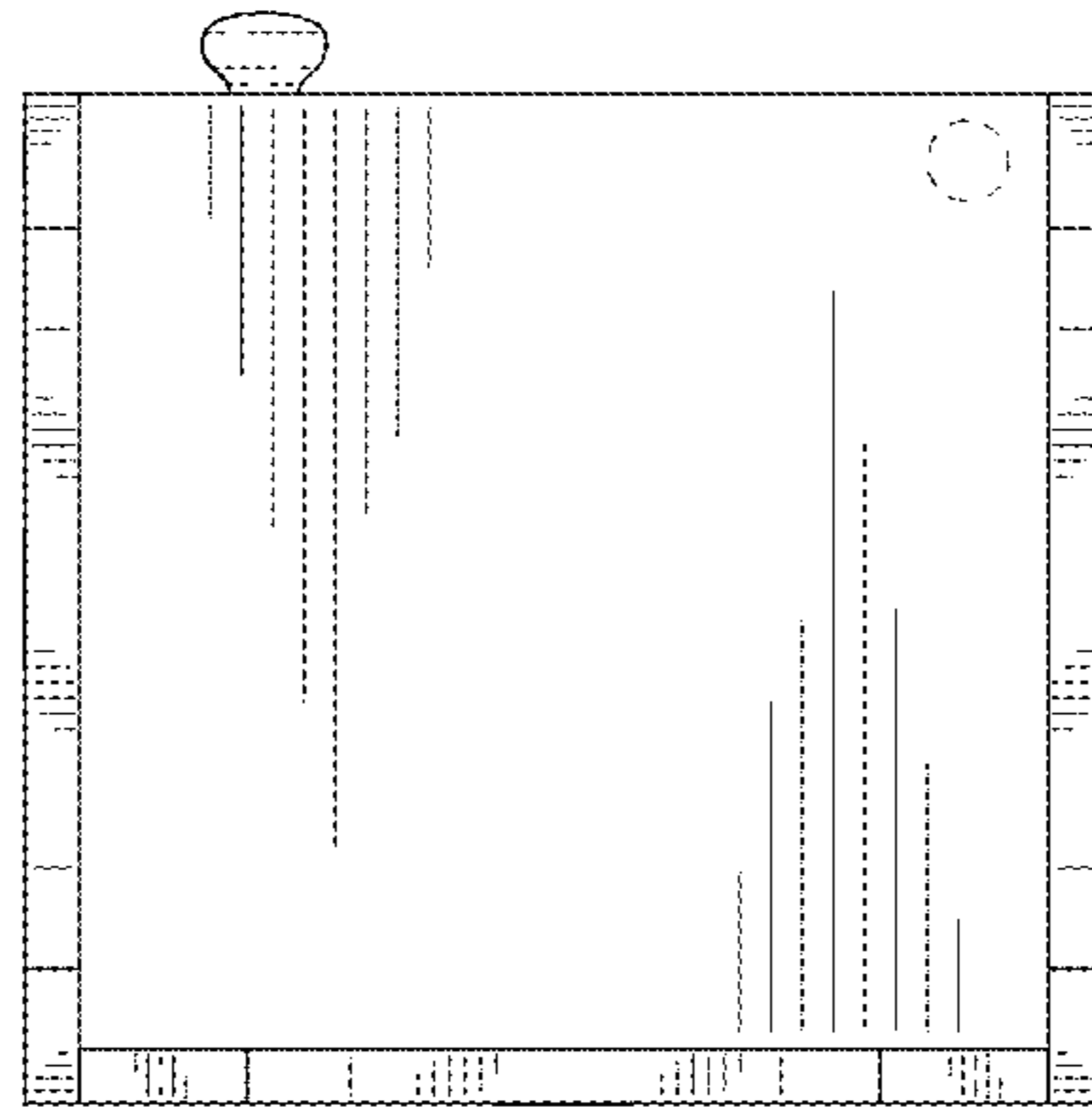

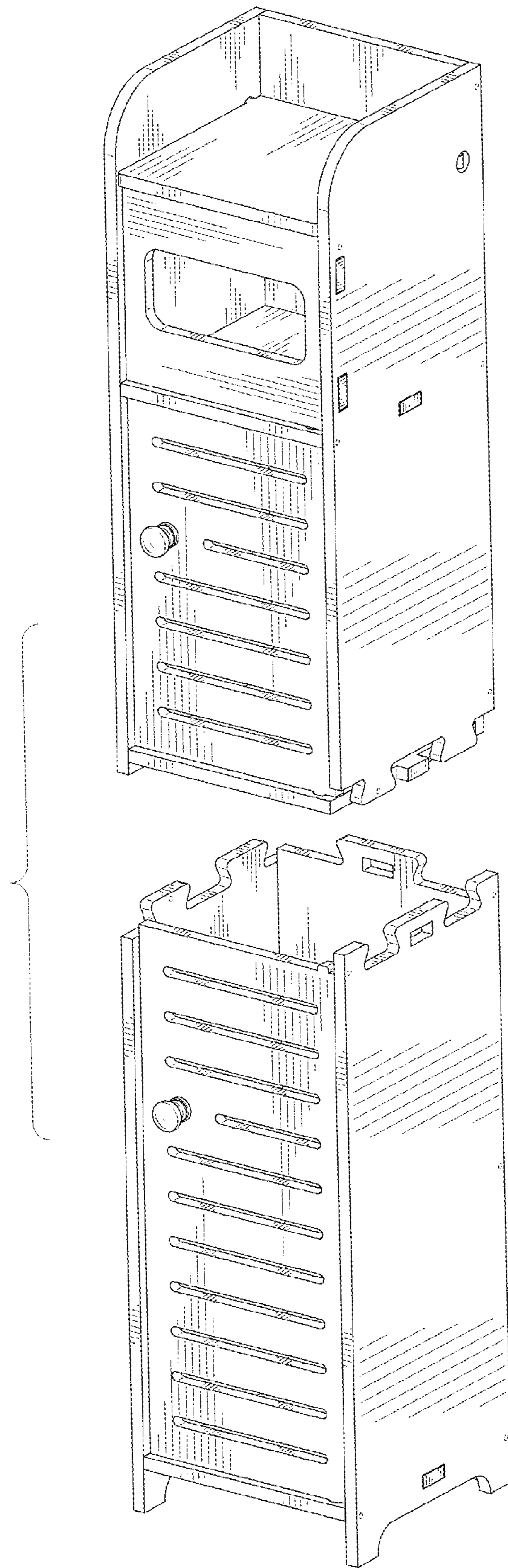
