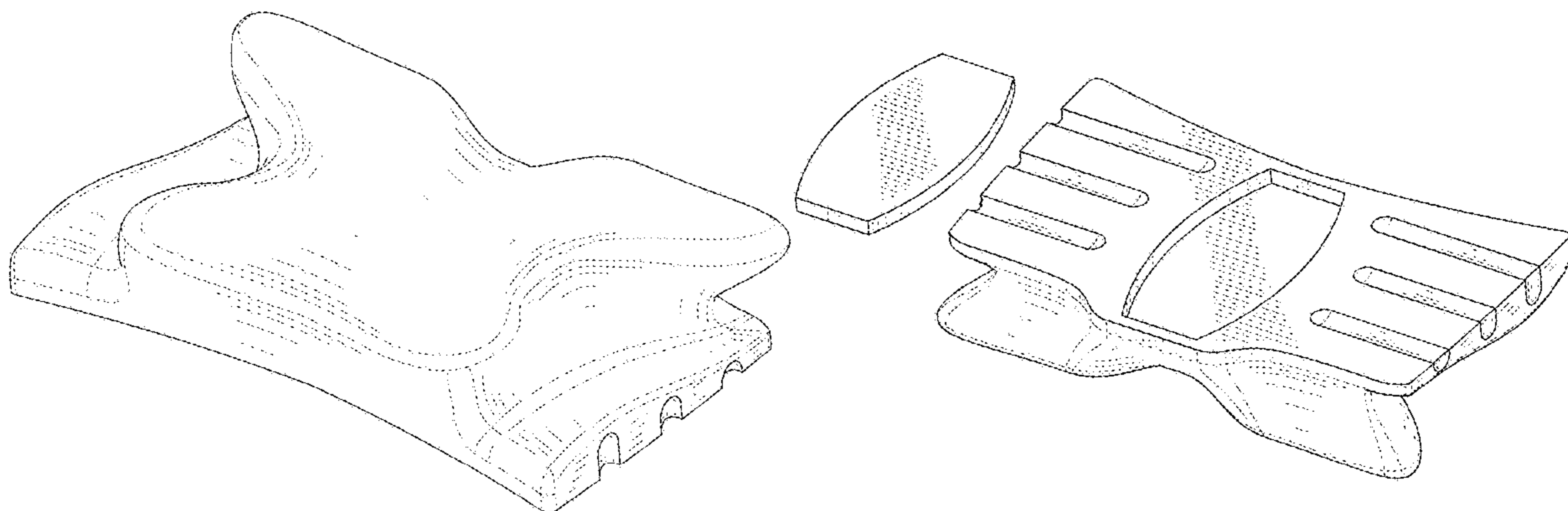
(57) **CLAIM**

The ornamental design for a pillow, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, right side, bottom perspective view of a pillow showing my new design; FIG. 2 is a rear, right side, top perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is a bottom plan view thereof; and, FIG. 9 is a rear, right side, top perspective view thereof with a central portion of the rear section of the pillow removed from the pillow. The broken lines depict portions of the pillow that form no part of the claimed design.

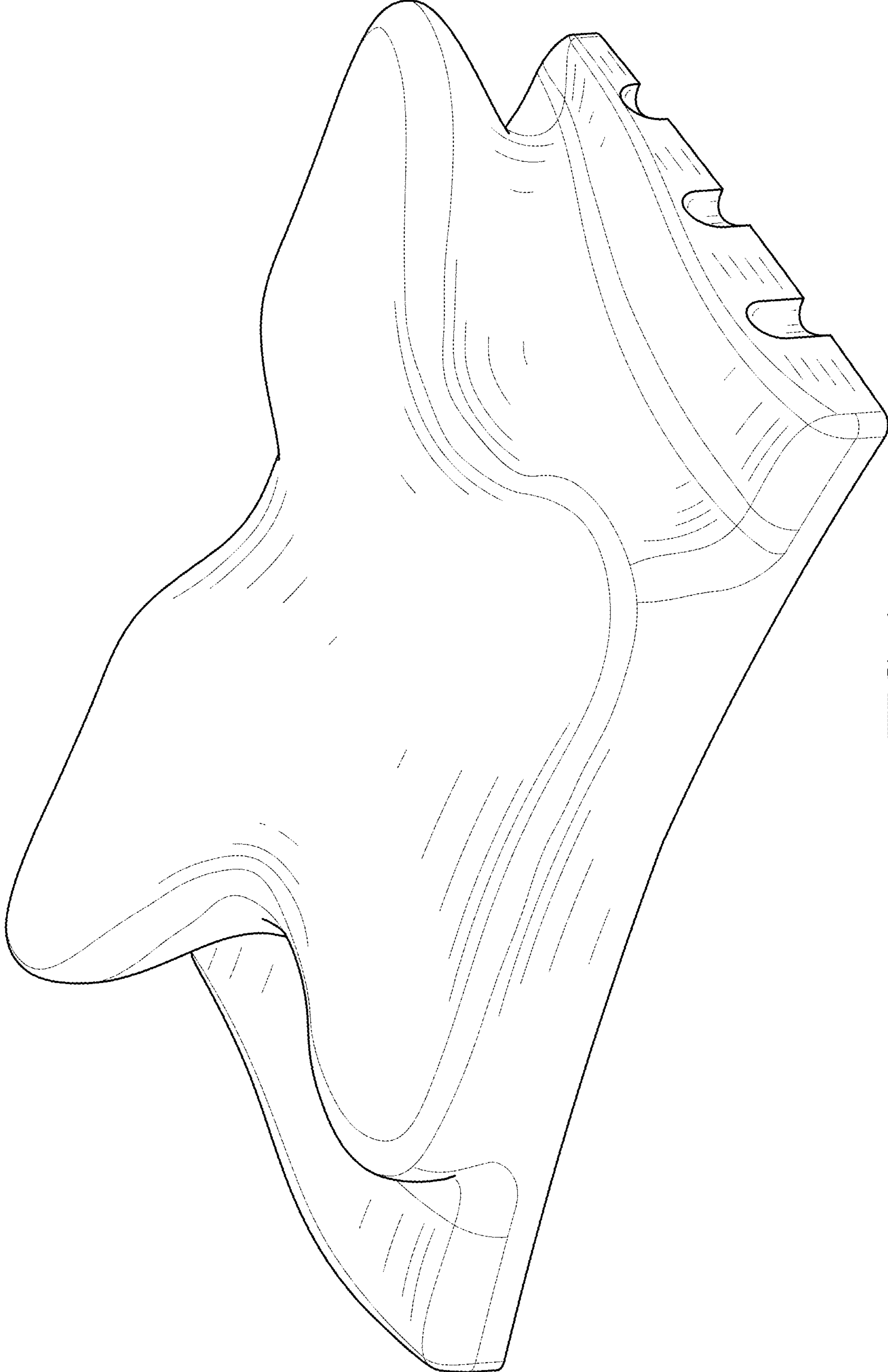

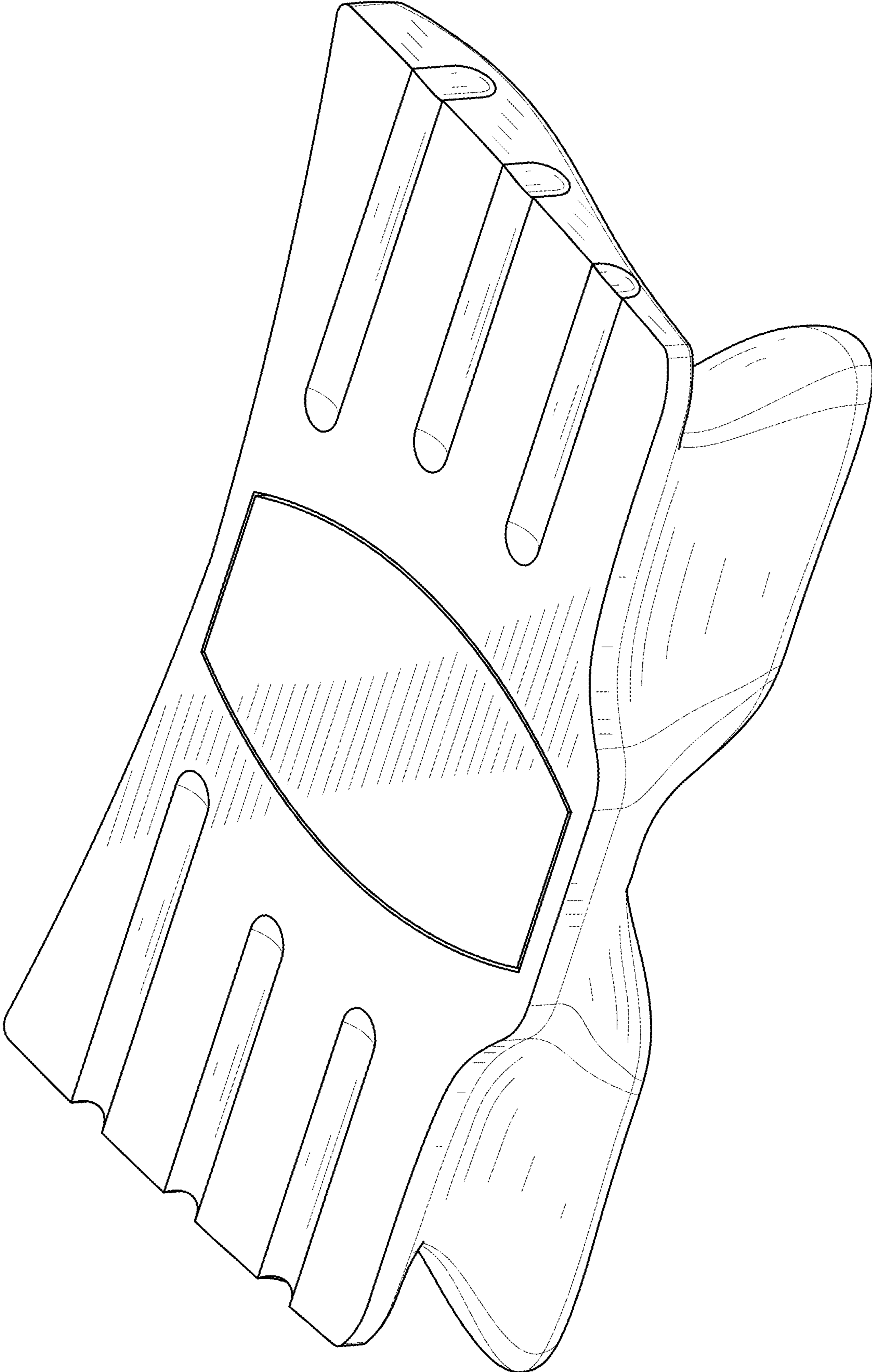

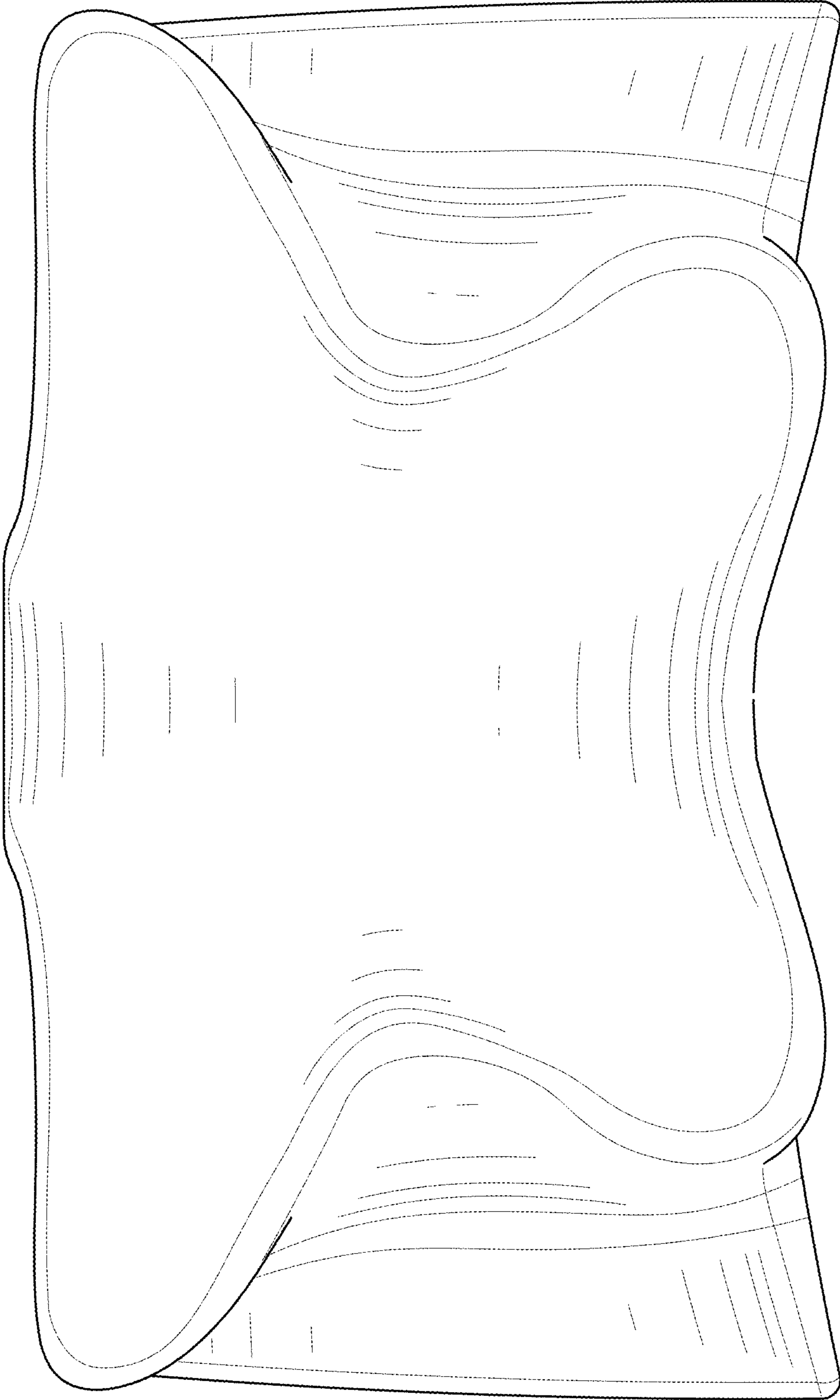

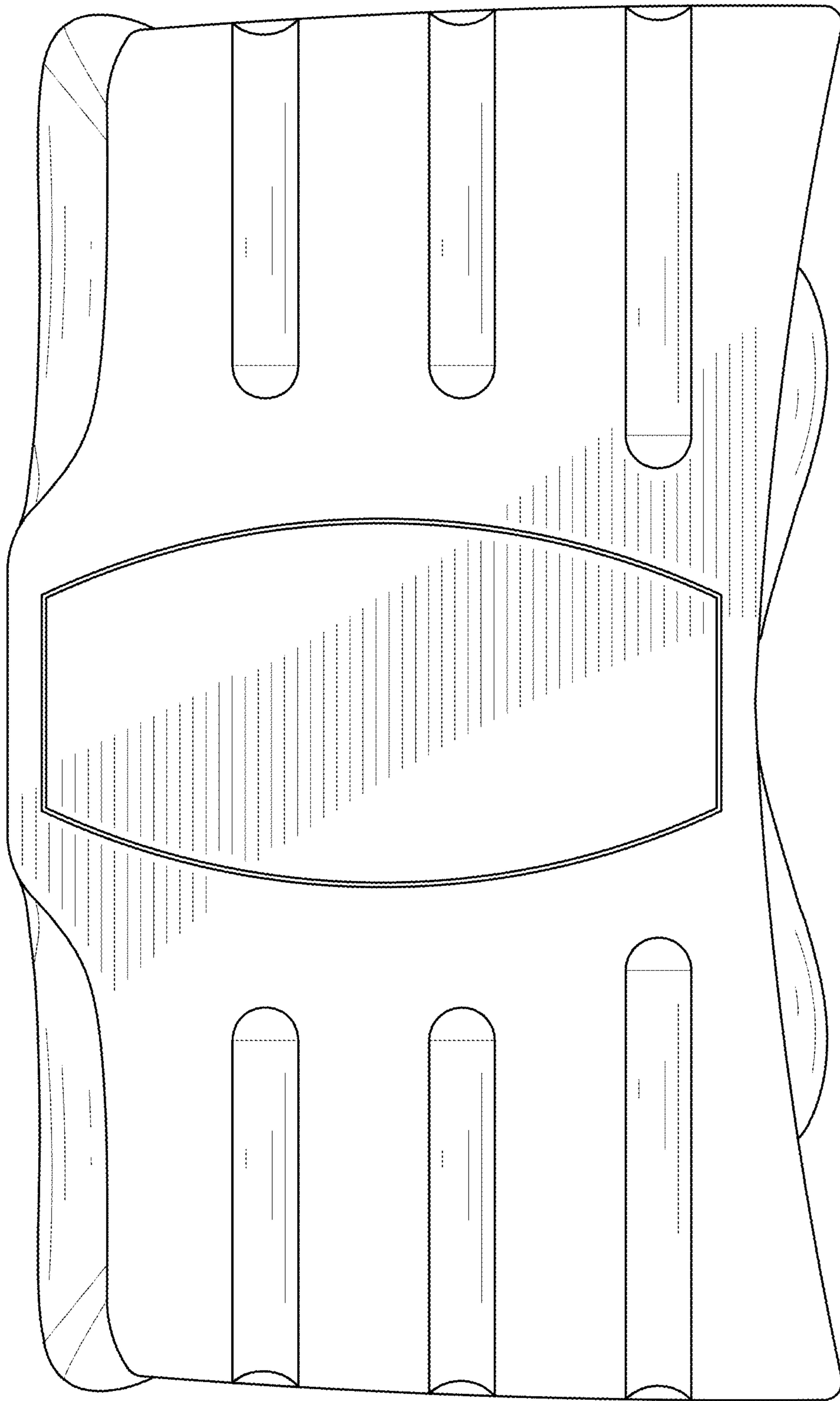

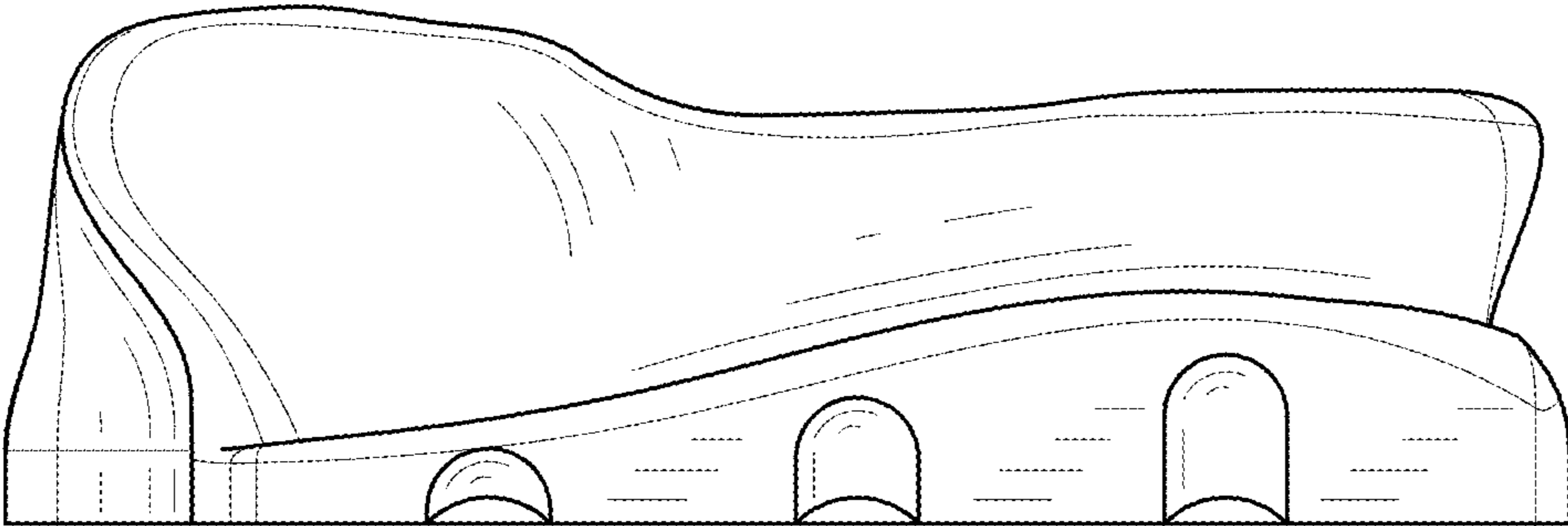

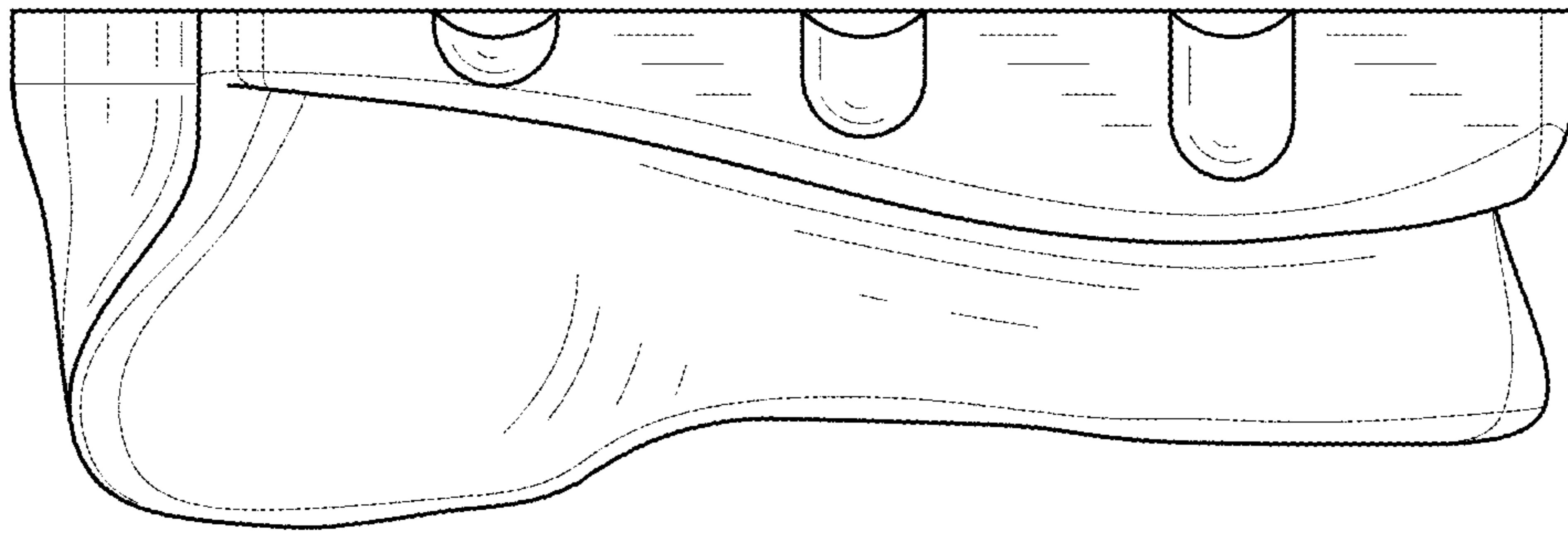

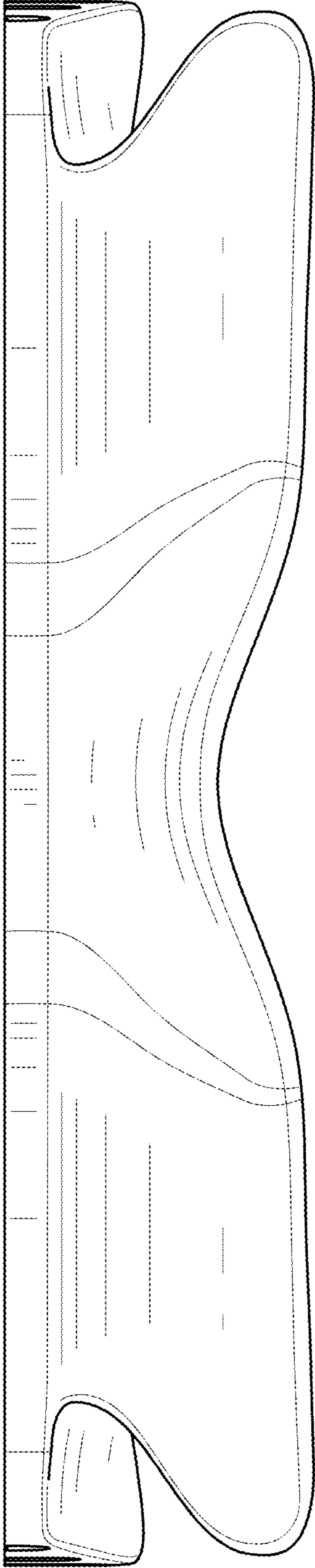

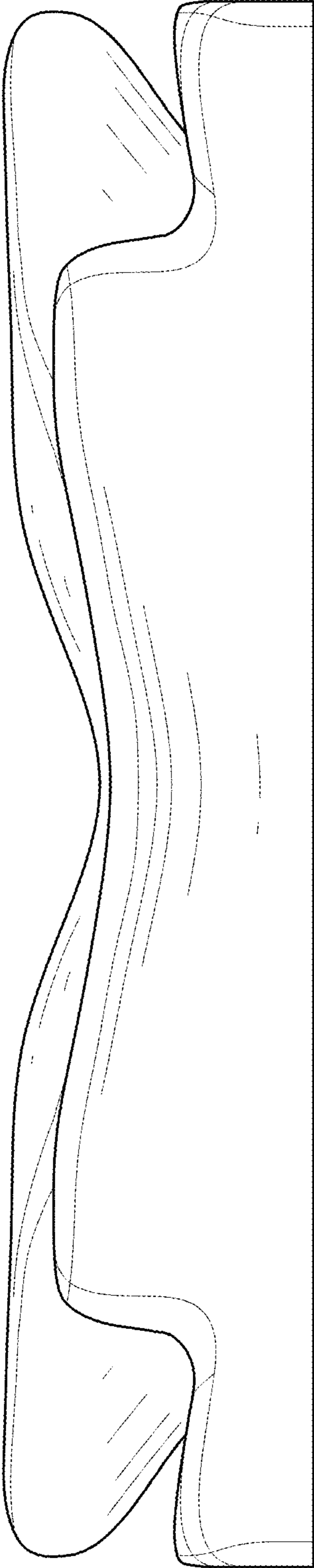

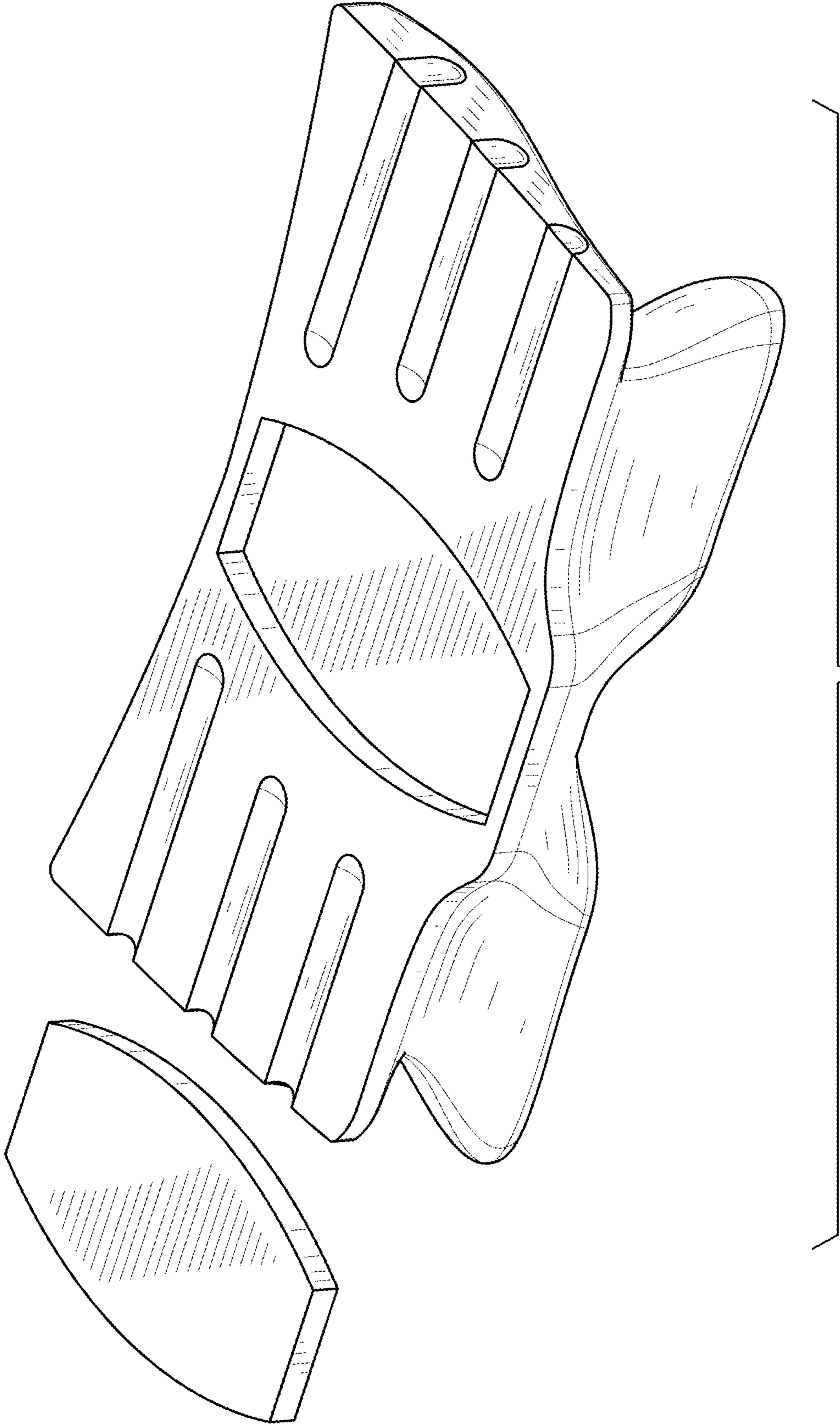
