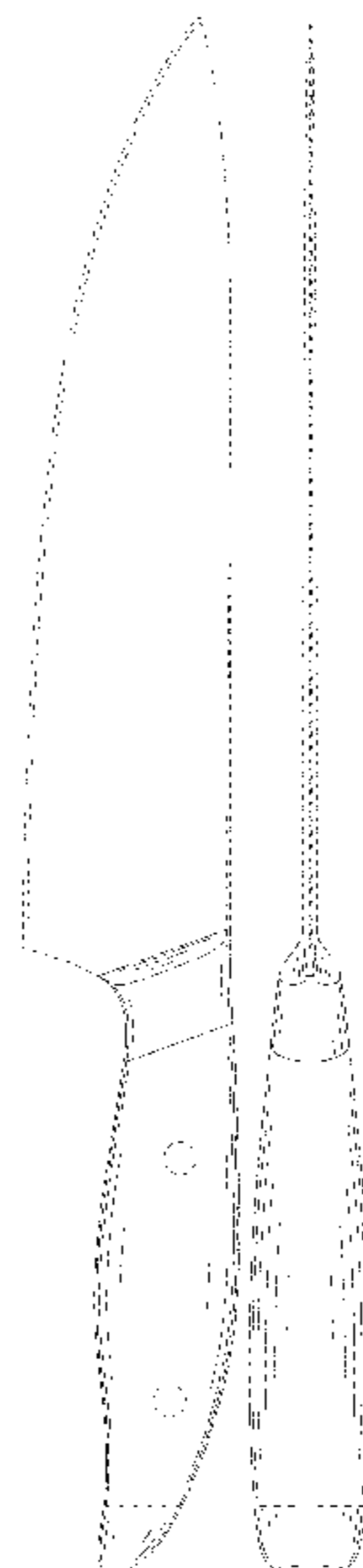
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, left and top perspective view of a knife showing my design.
FIG. 2 is a rear, right and bottom perspective view of a knife showing my design.
FIG. 3 is a front elevation view thereof.
FIG. 4 is a rear elevation view thereof.
FIG. 5 is a left-side elevation view thereof.
FIG. 6 is a right-side elevation view thereof.
FIG. 7 is a top plan view thereof; and,
FIG. 8 is a bottom plan view thereof.

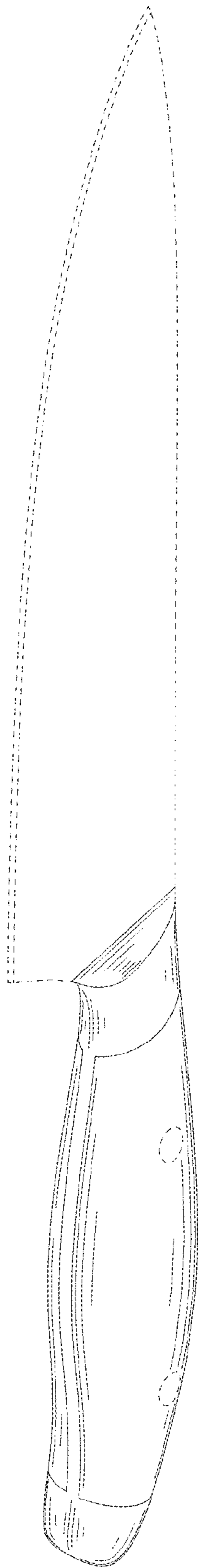

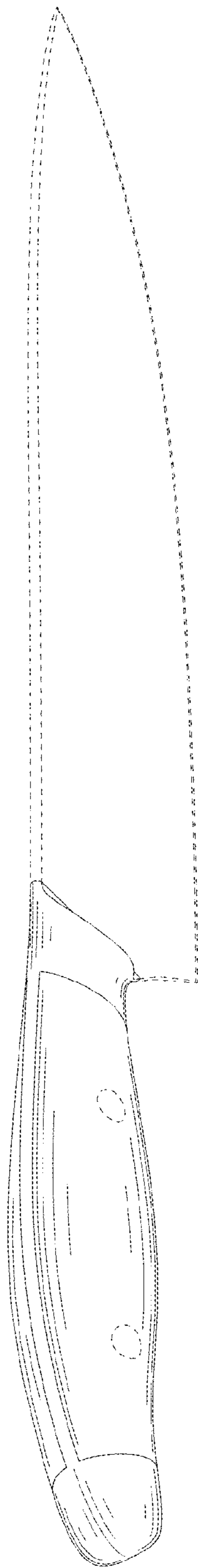

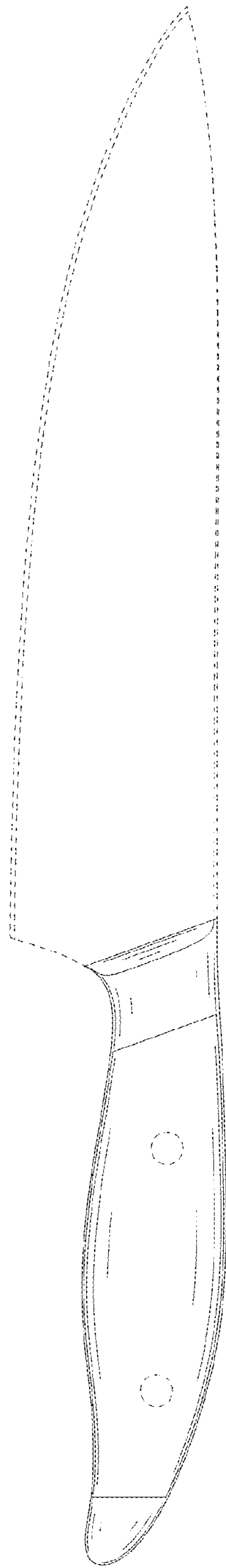

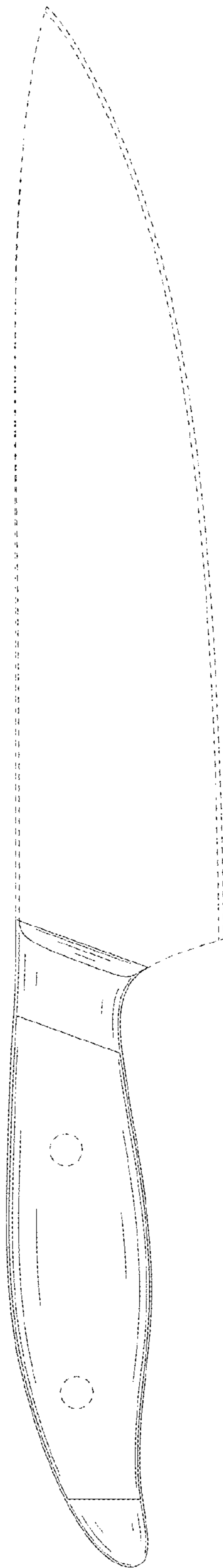

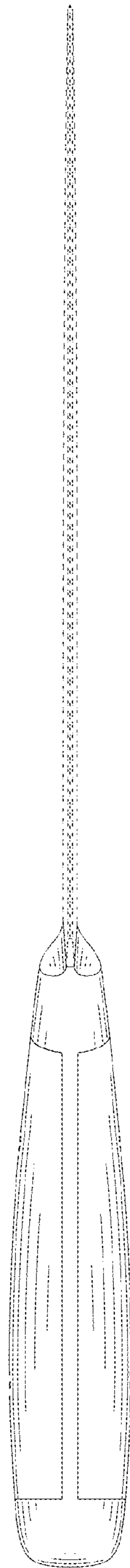

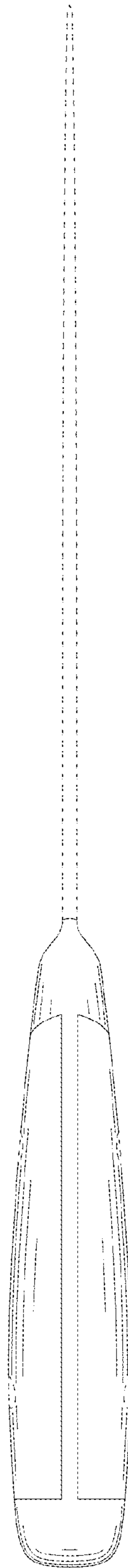

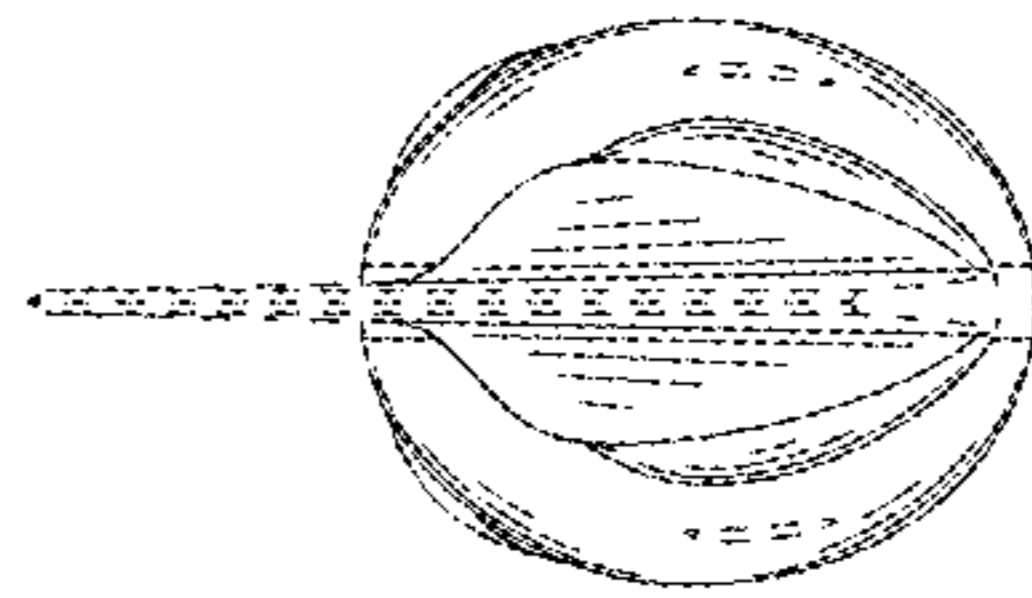

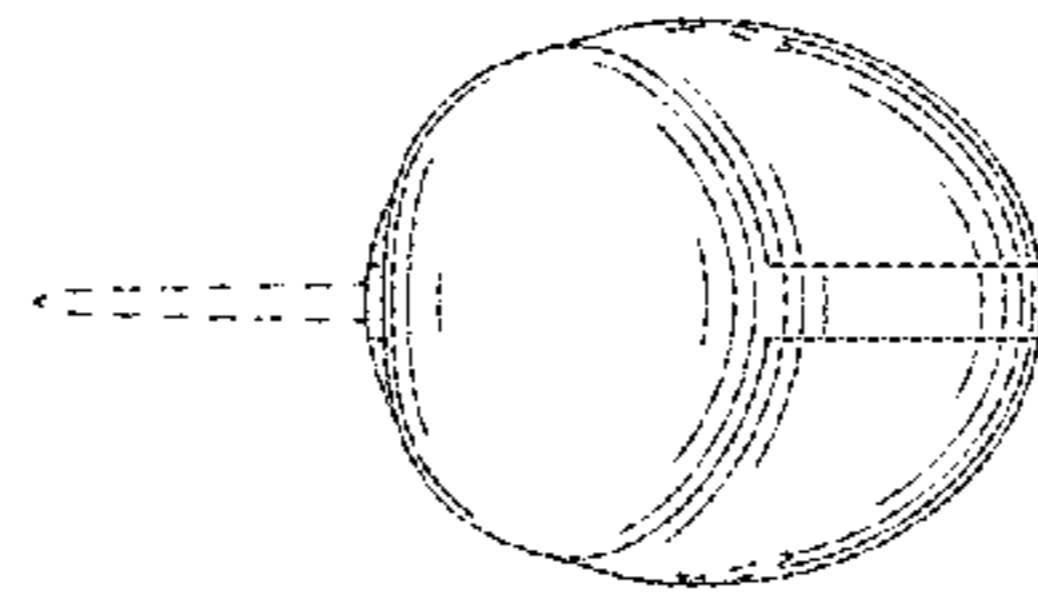
