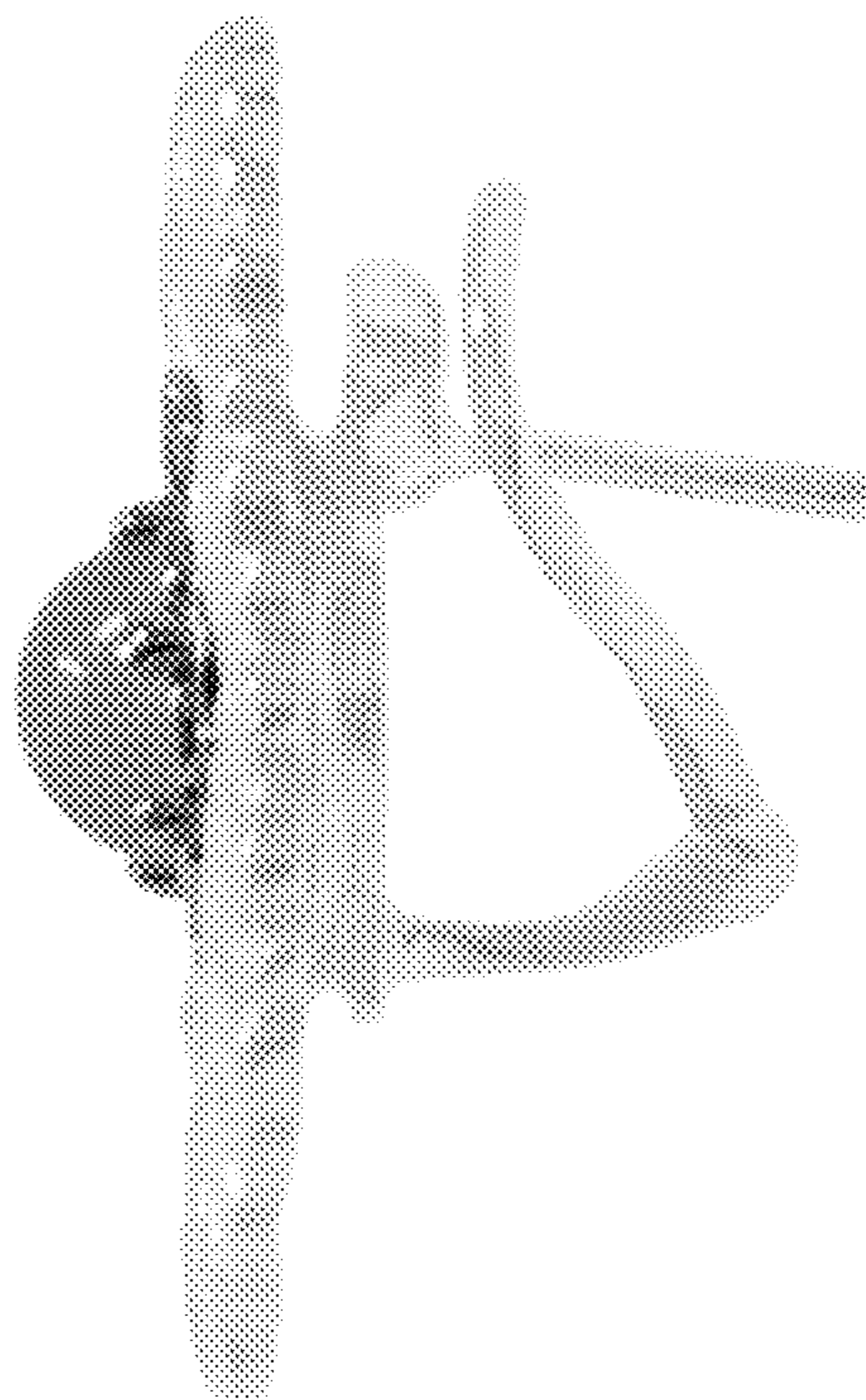
The ornamental design for an earring, as shown and described.

In the representations of the design blurred lighter portions indicate disclaimed features for which protection is not being sought, whereas darker portions represent features for which protection is sought.

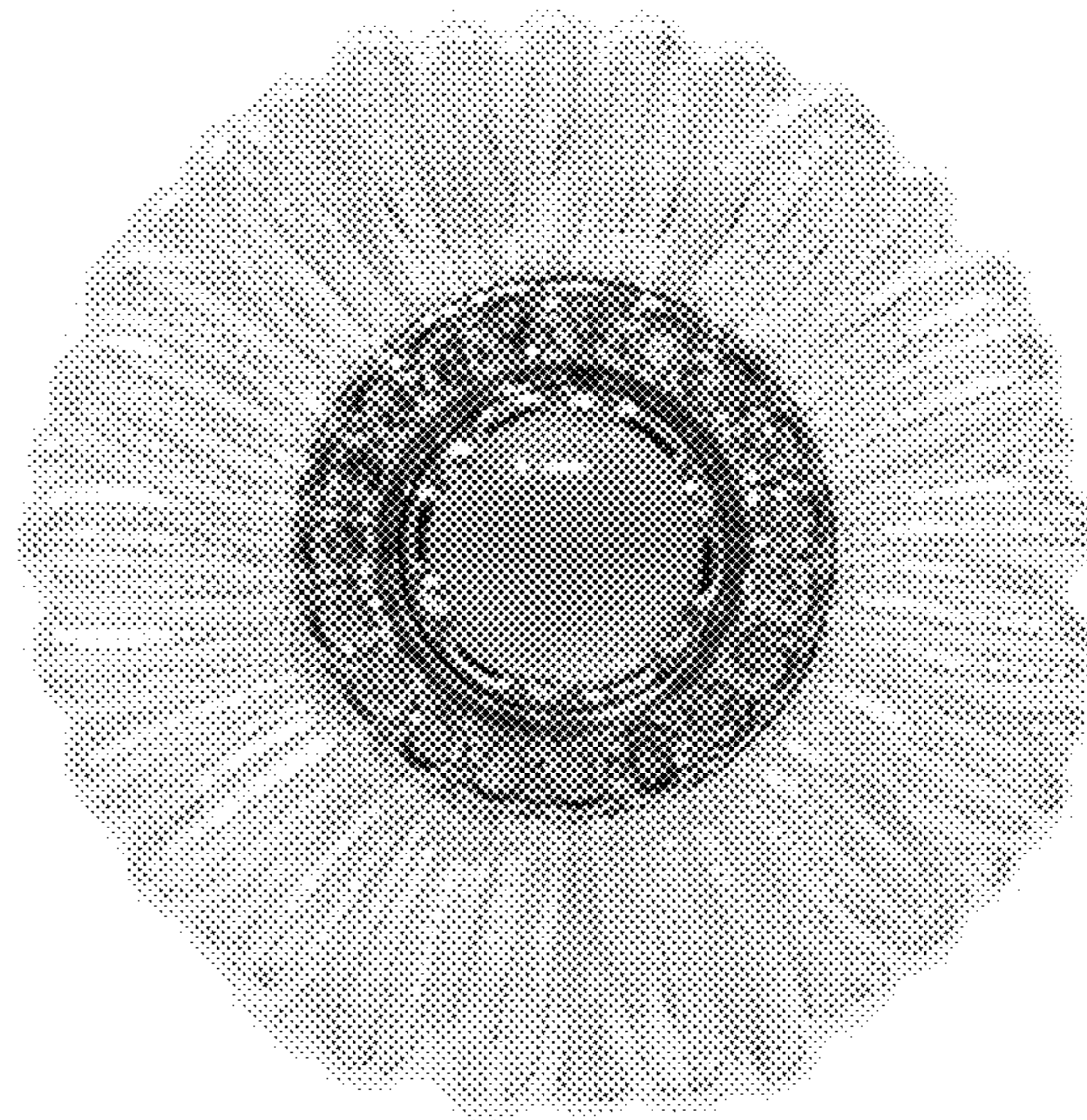

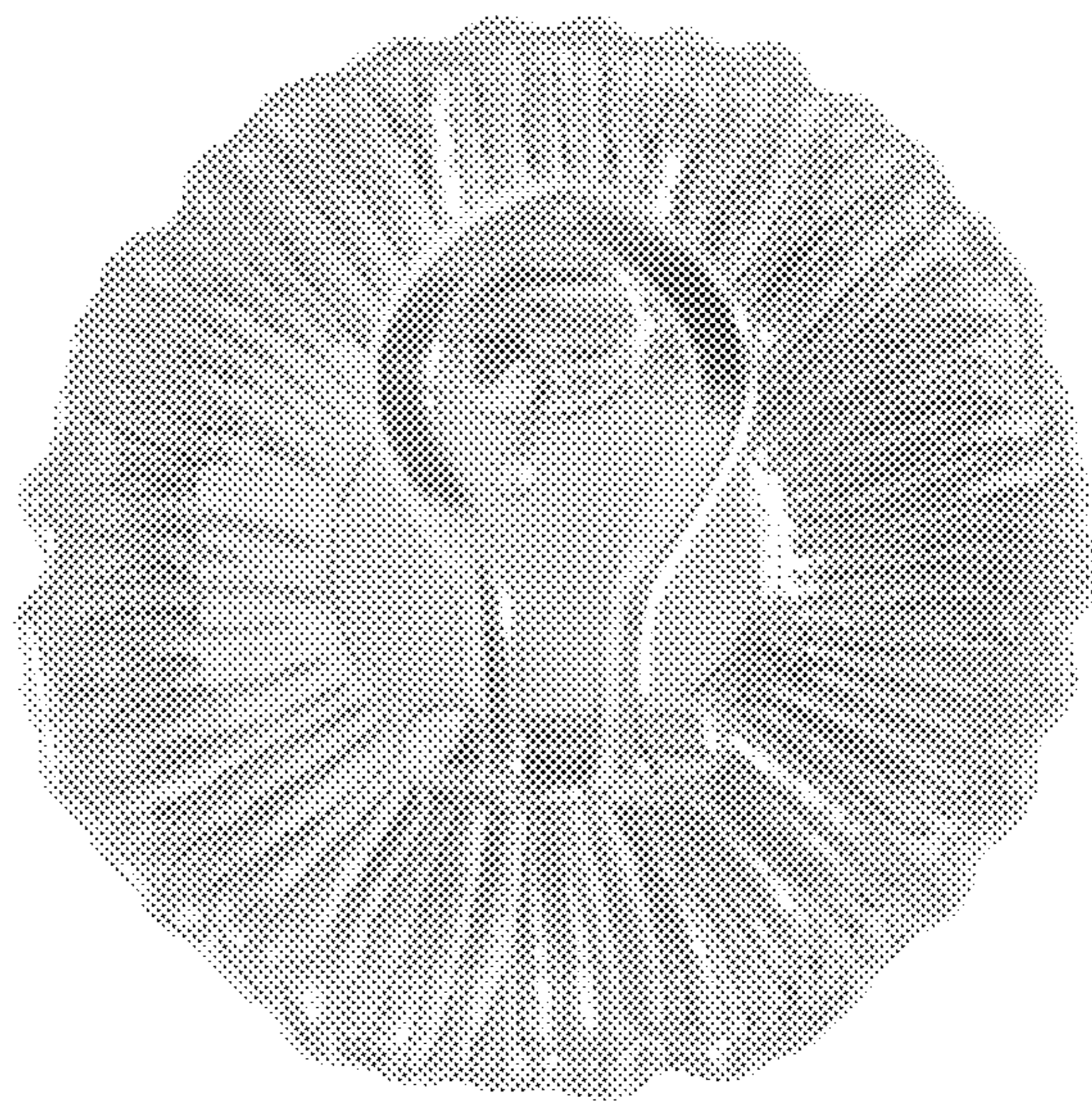

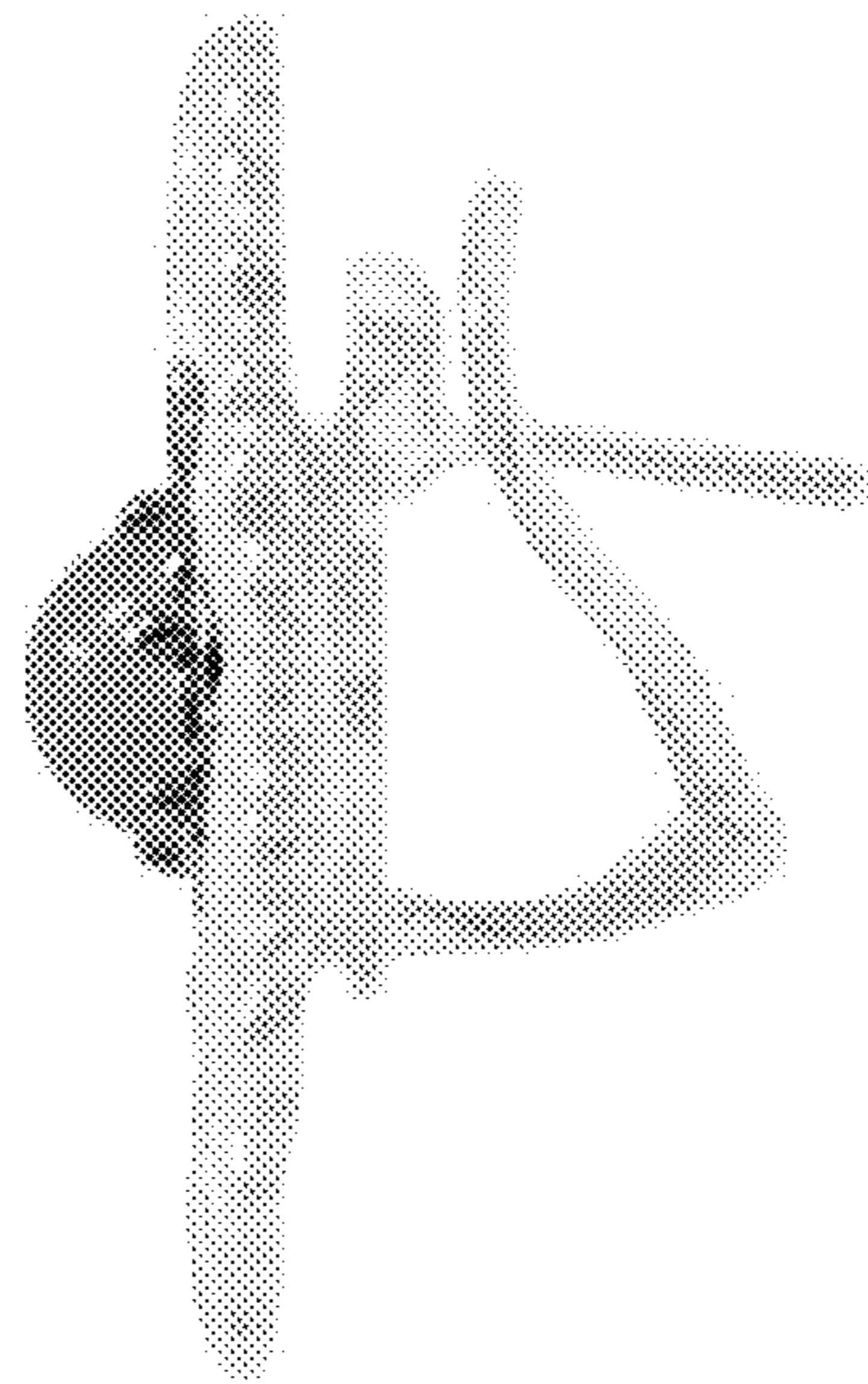

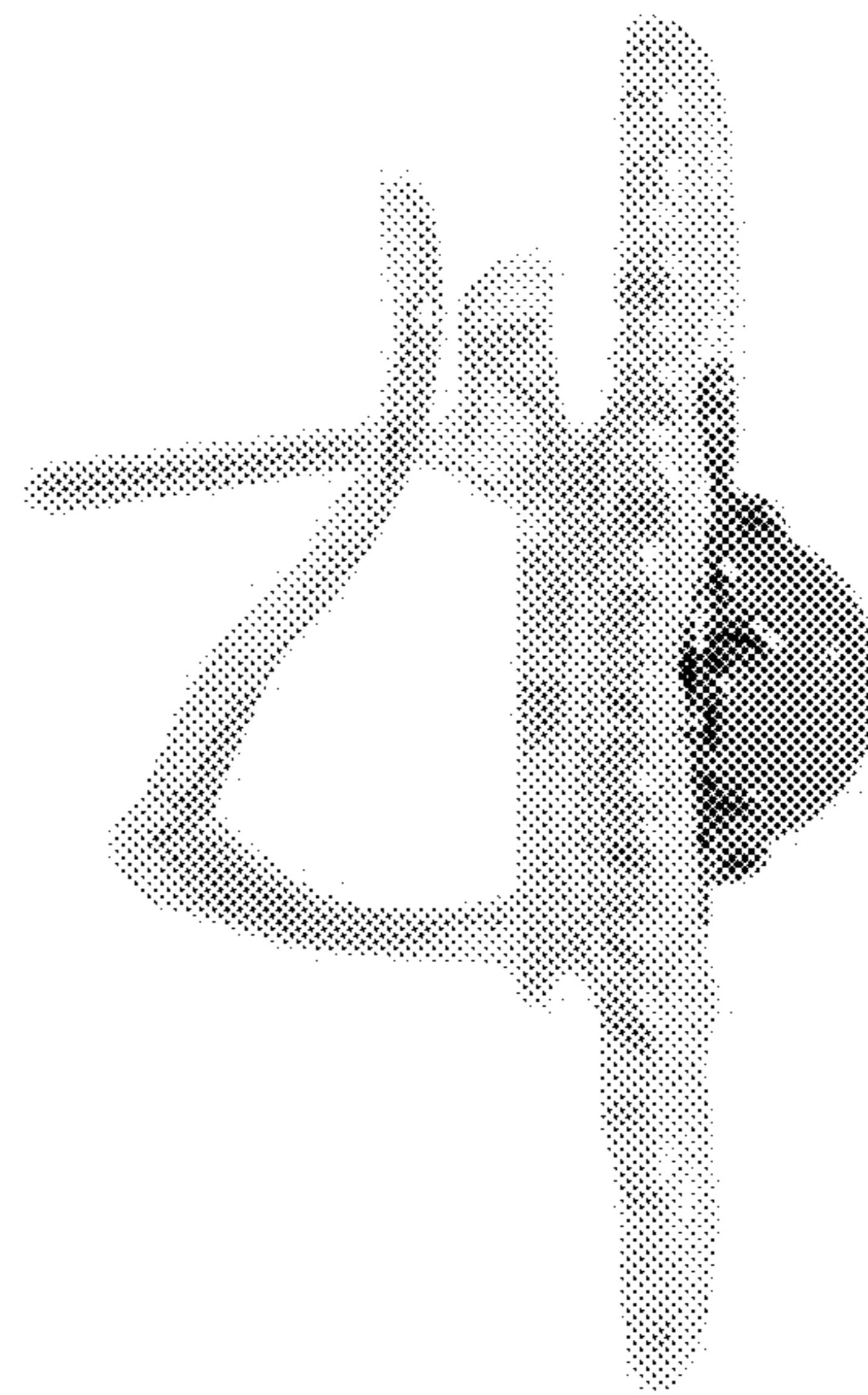

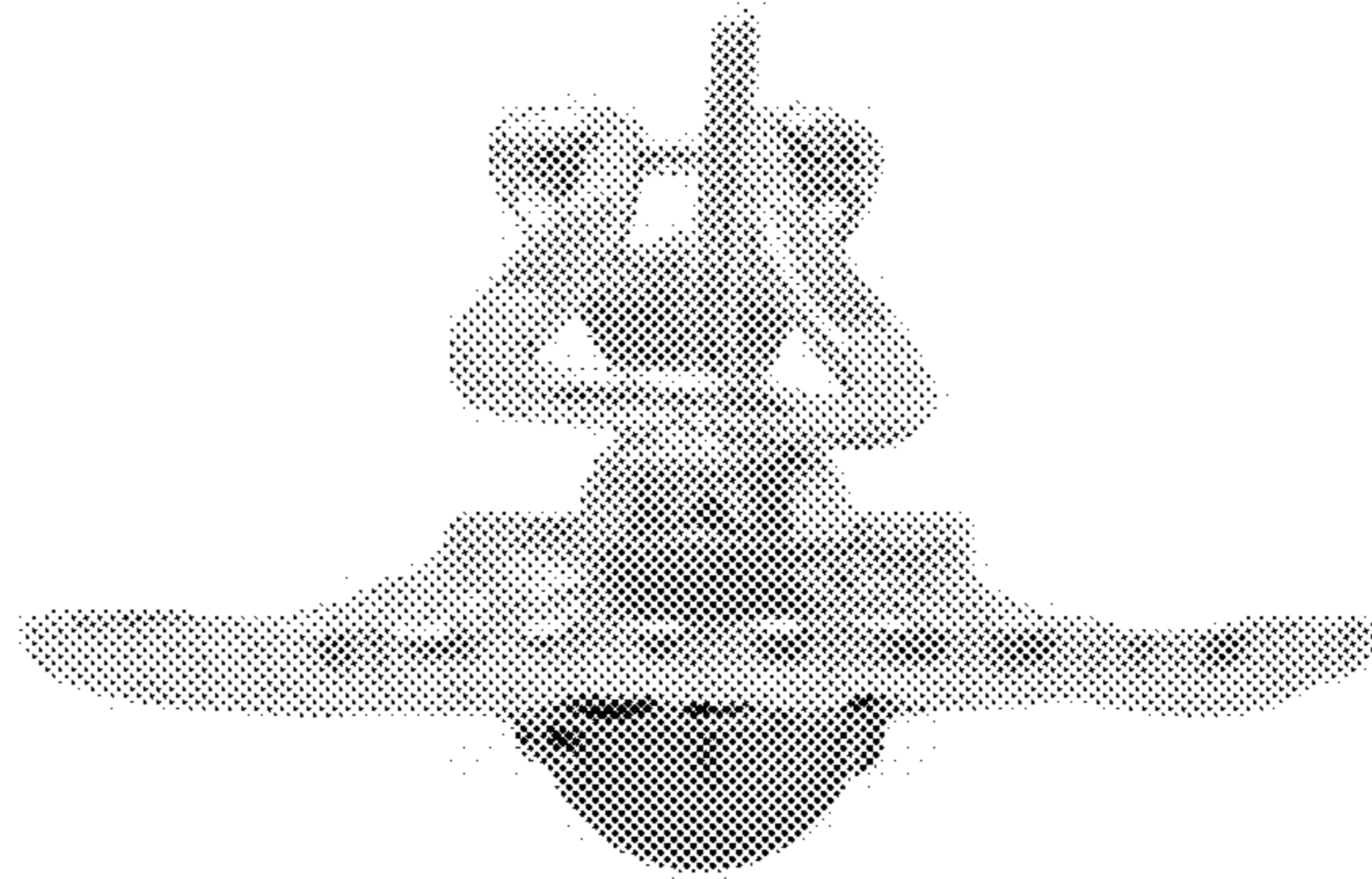
