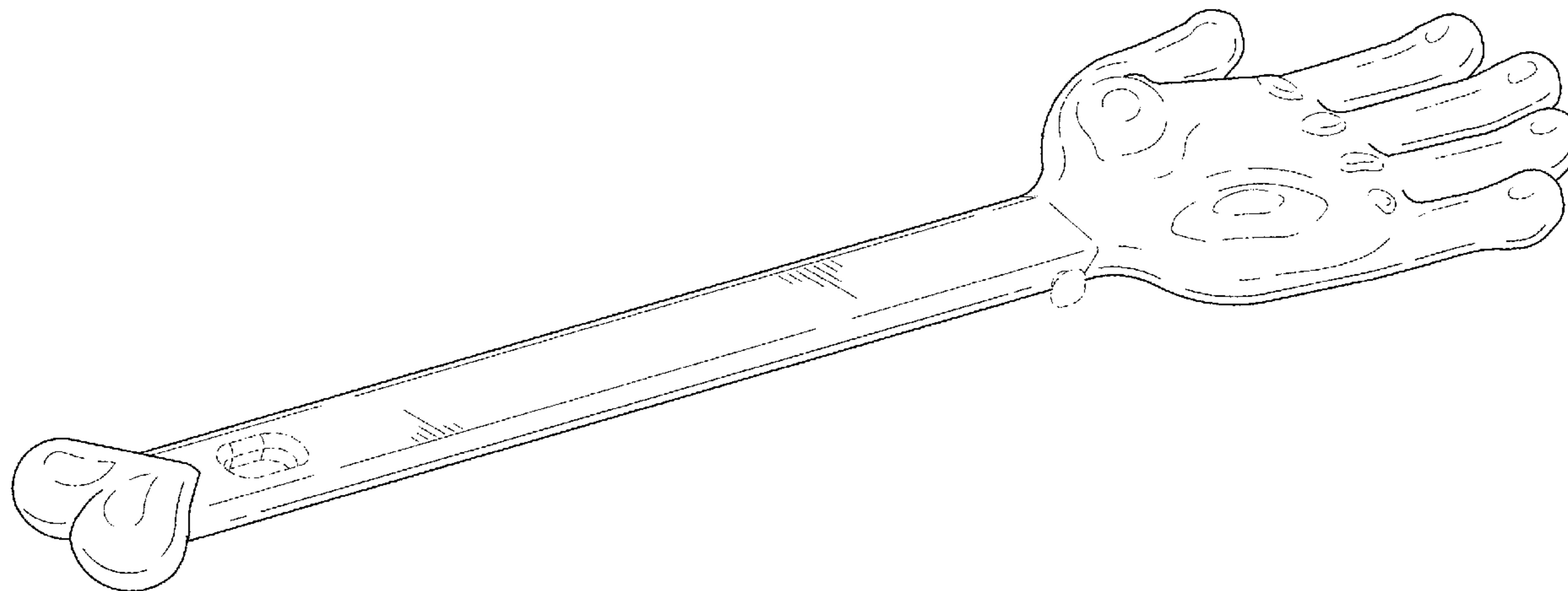
(57) **CLAIM**

The ornamental design for a hand shaped body scrubber massager, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a hand shaped body scrubber massager, showing the new design;

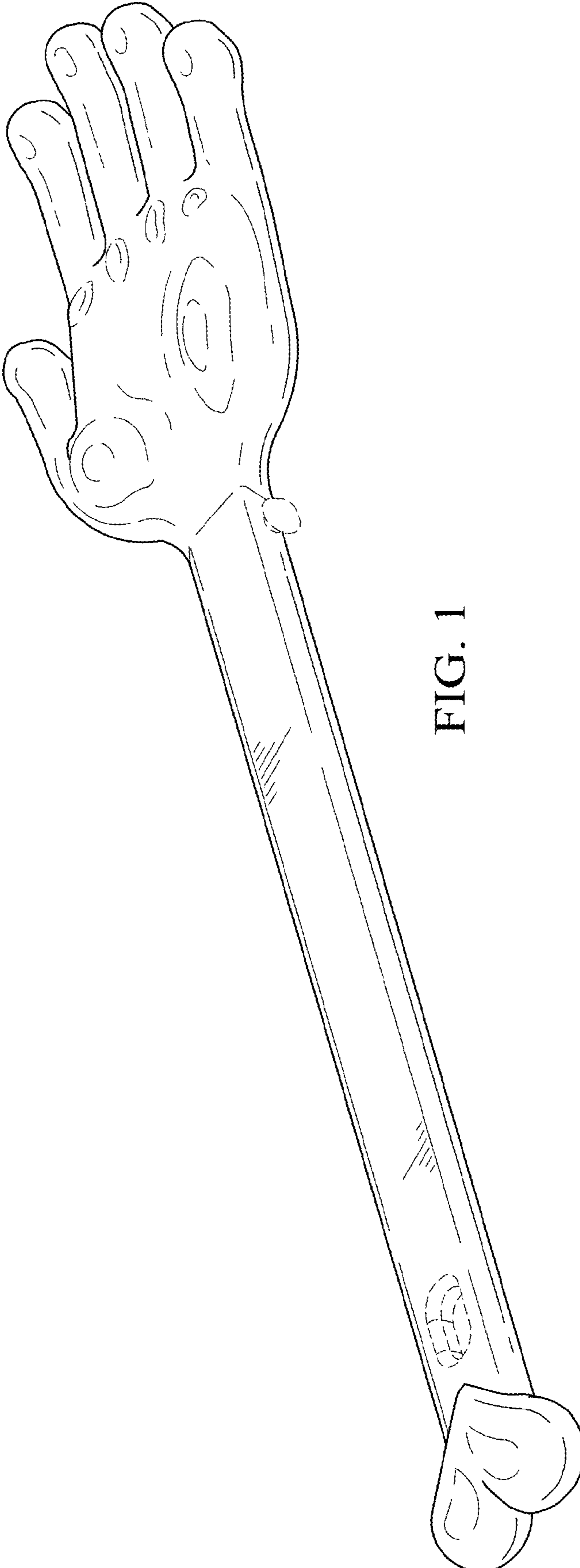

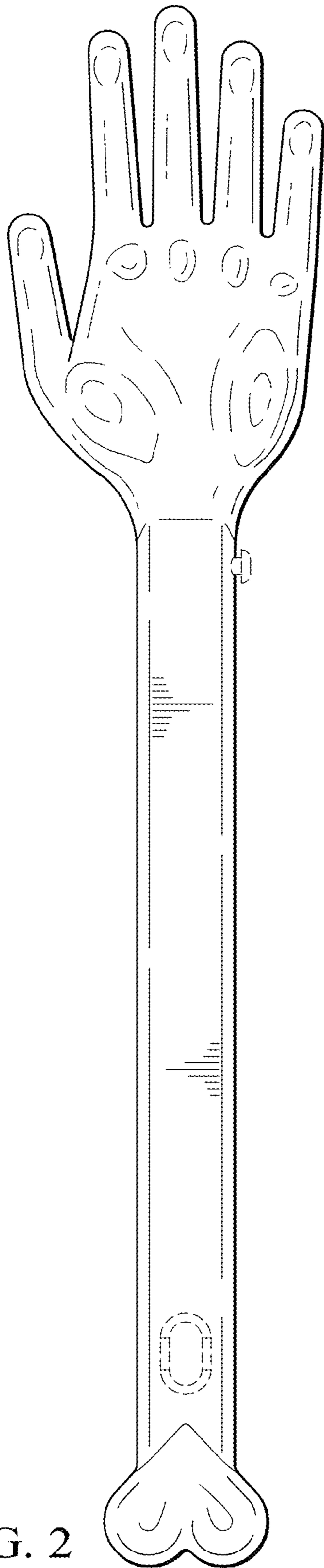

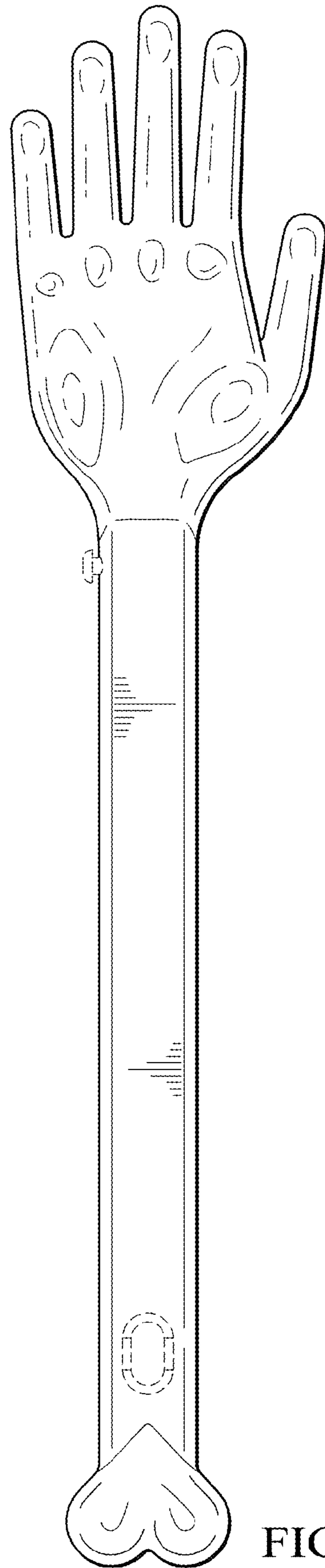

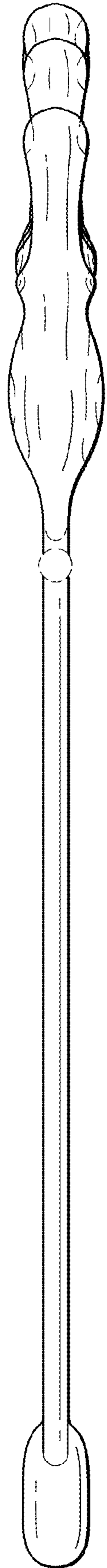

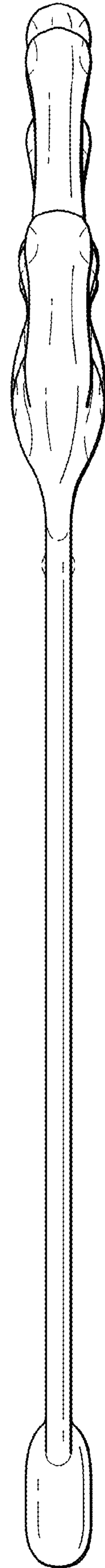

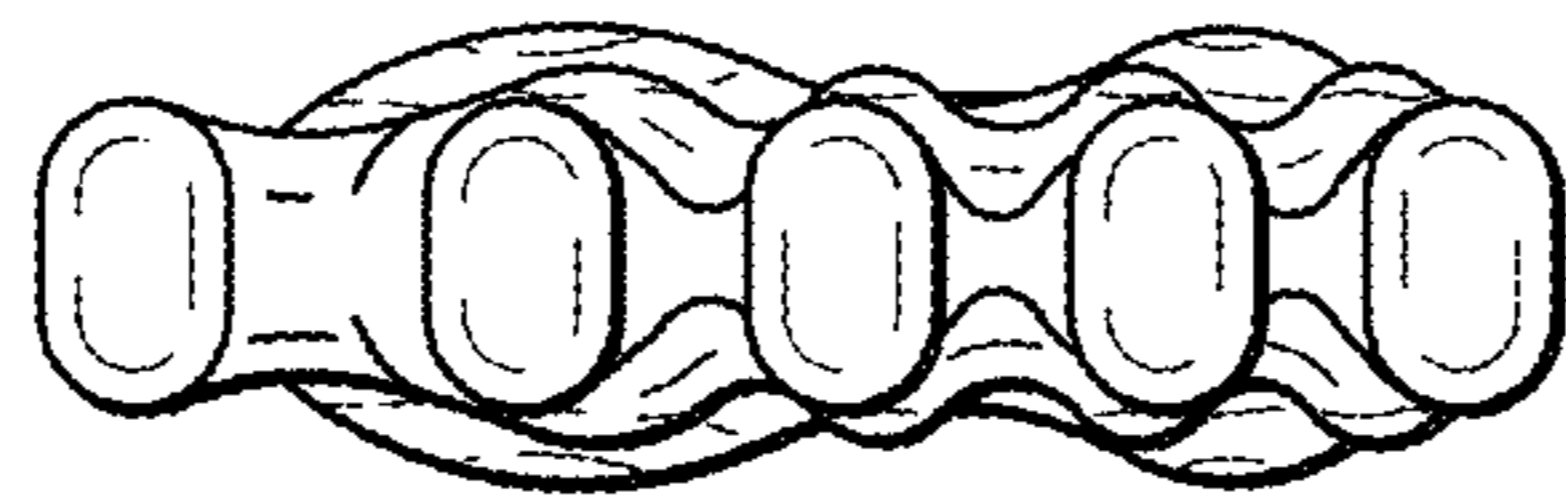

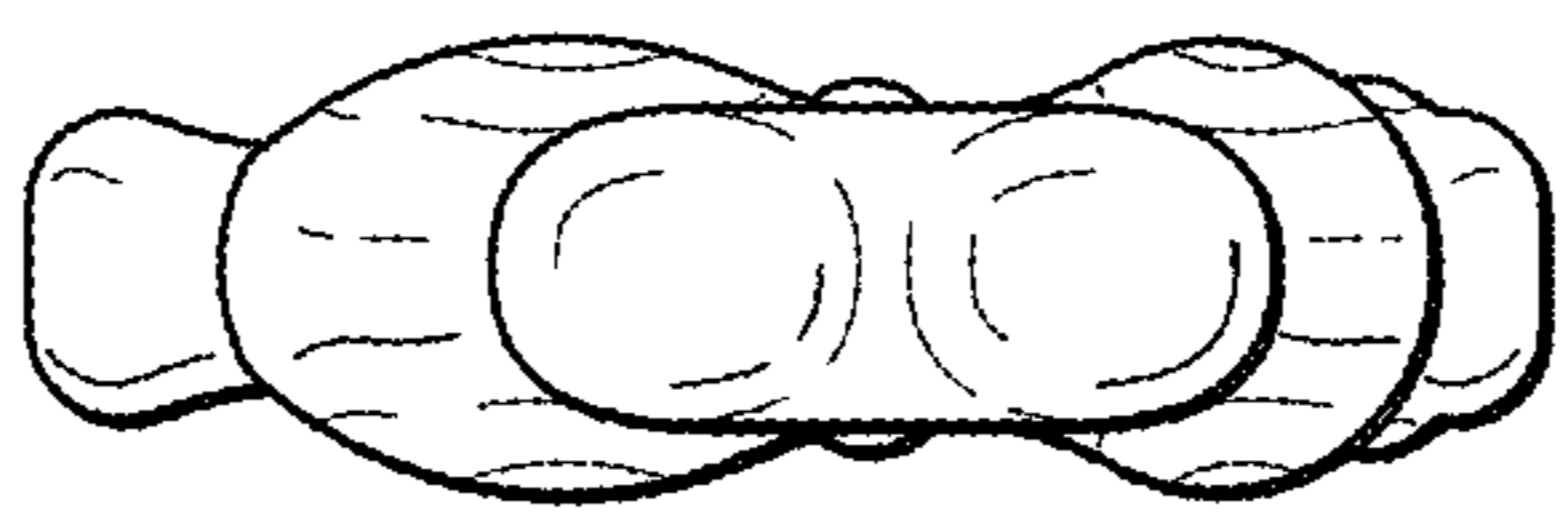
