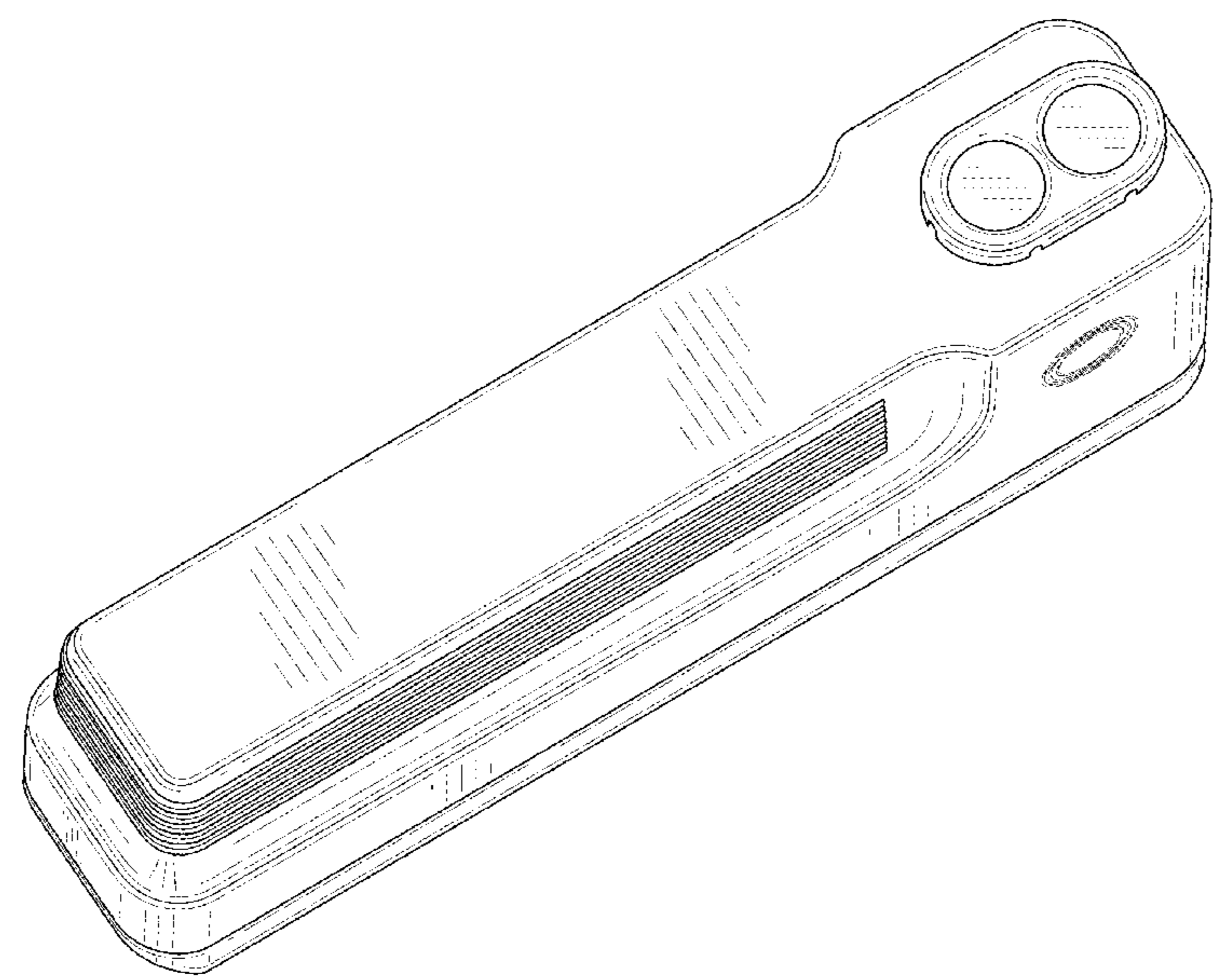
The ornamental design for a wash bottle, as shown and described.

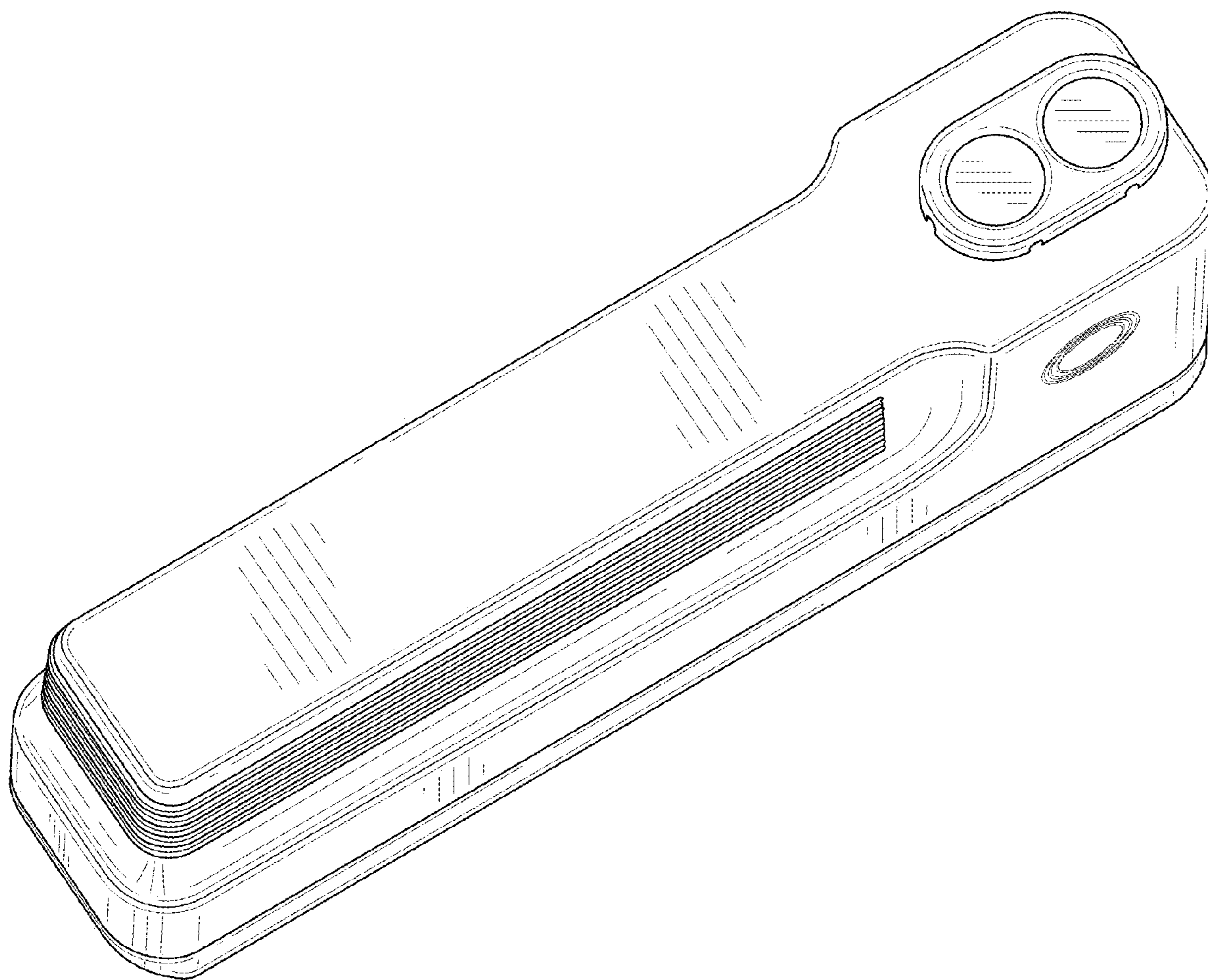

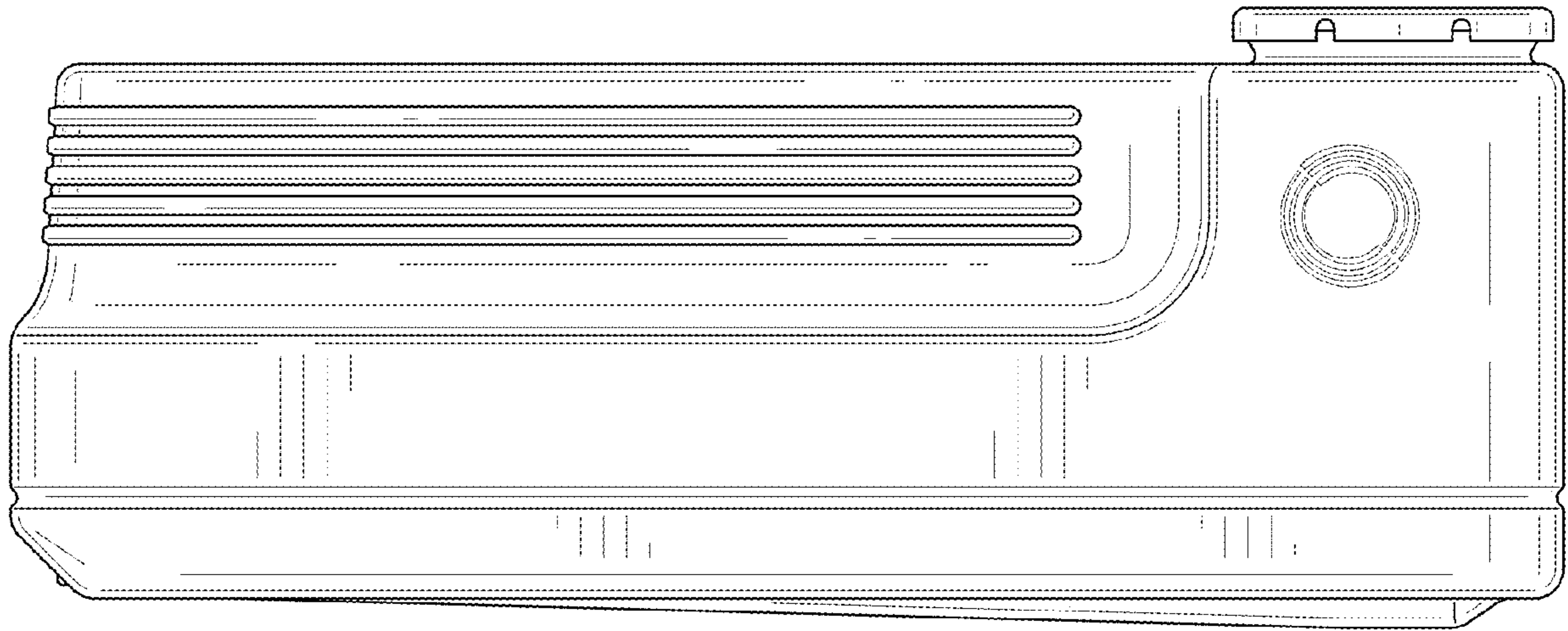

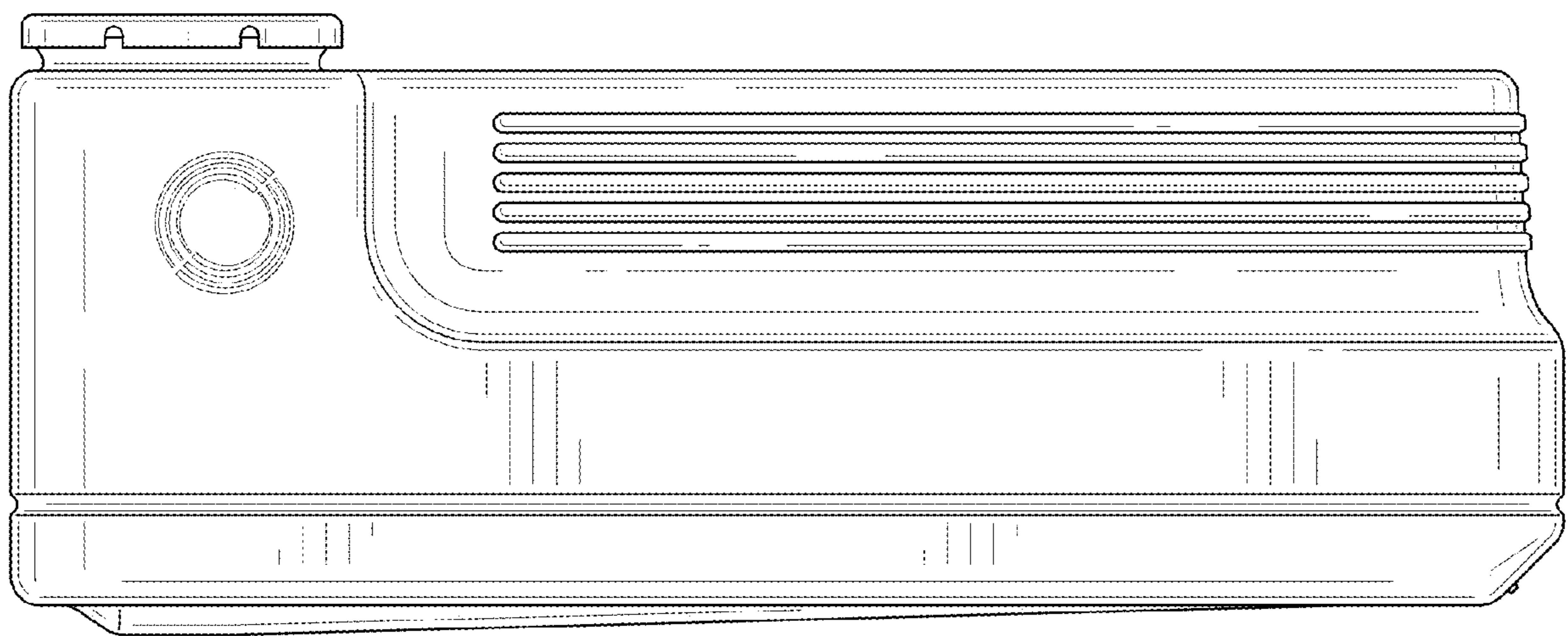

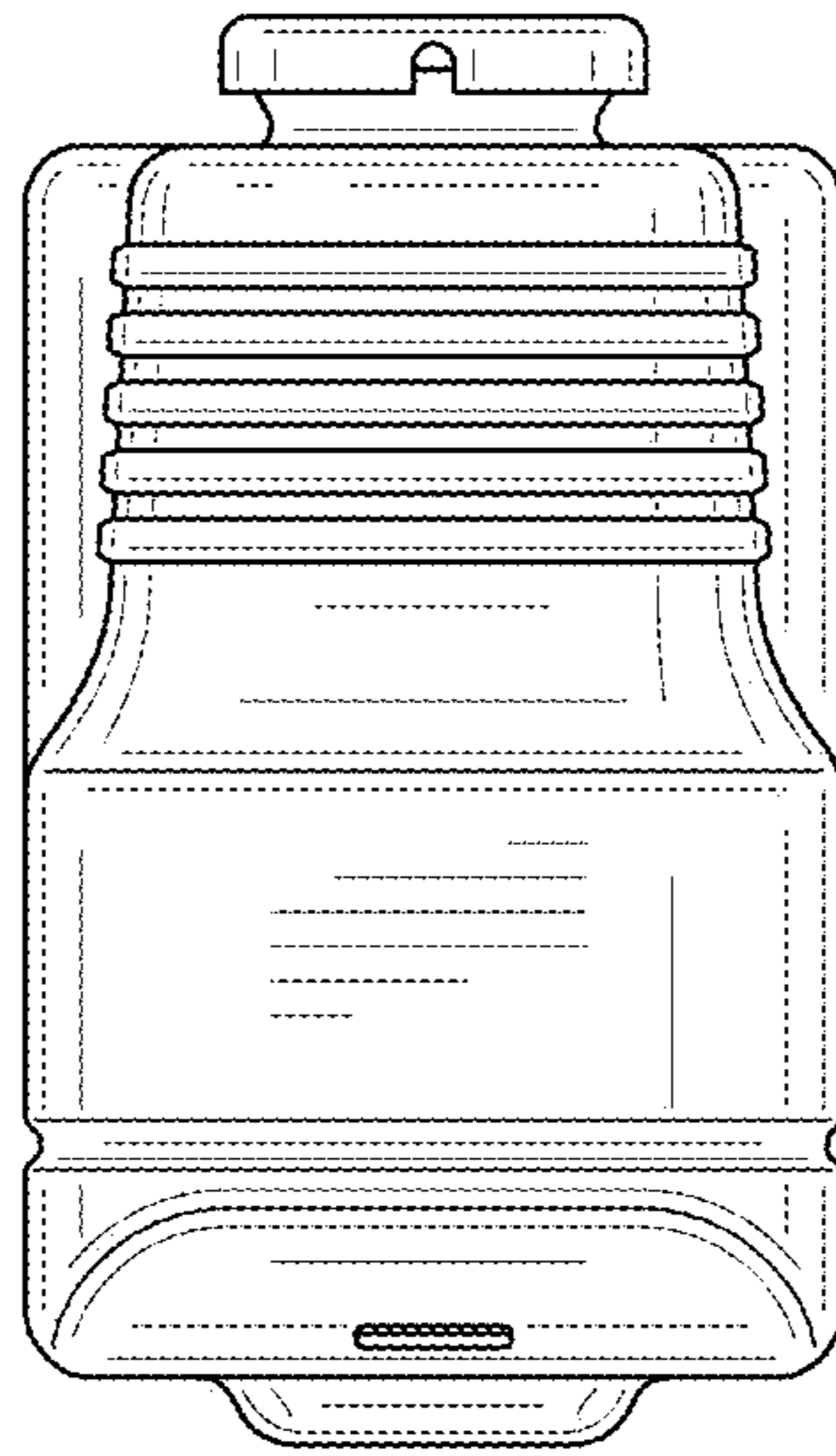

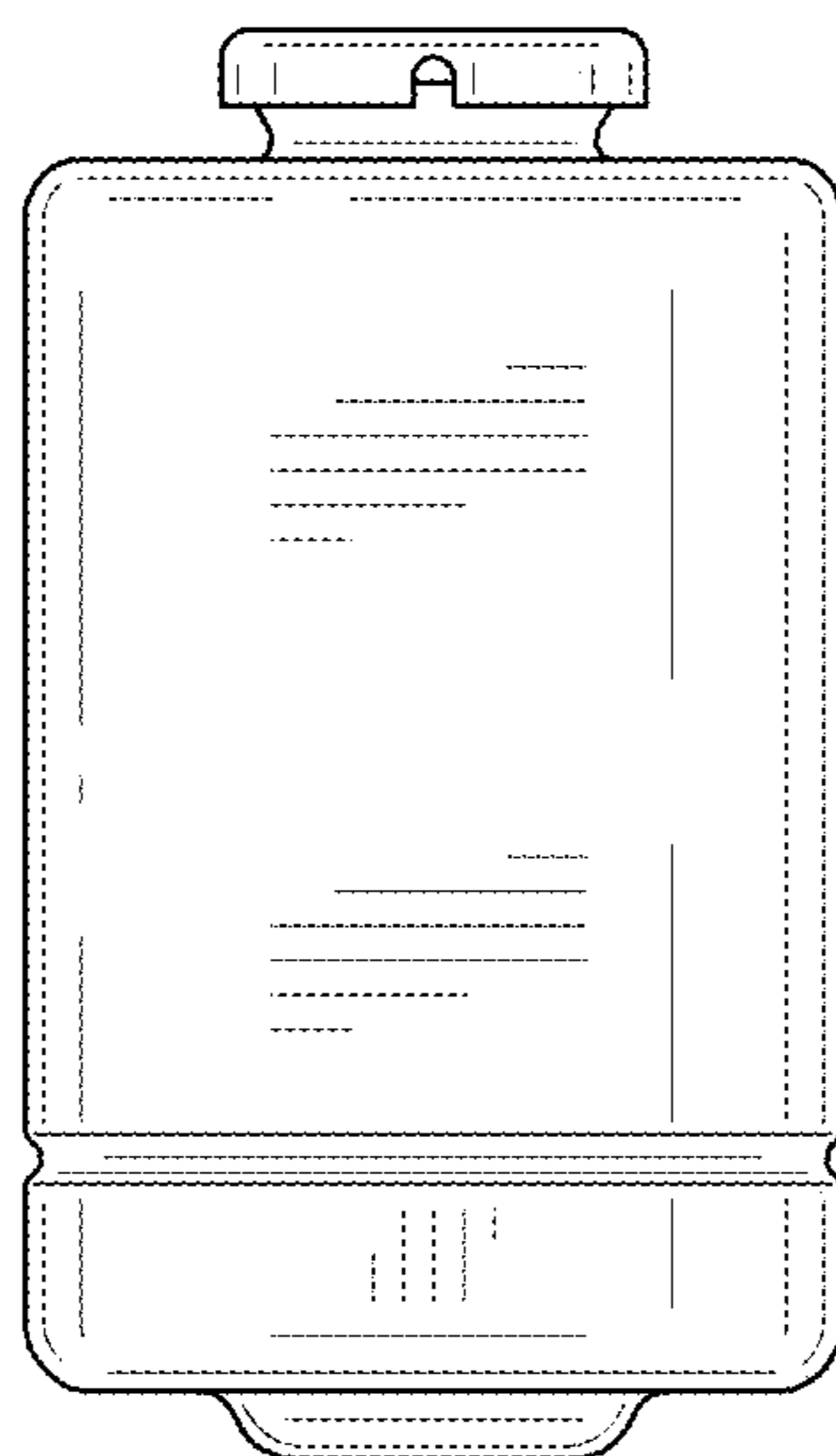

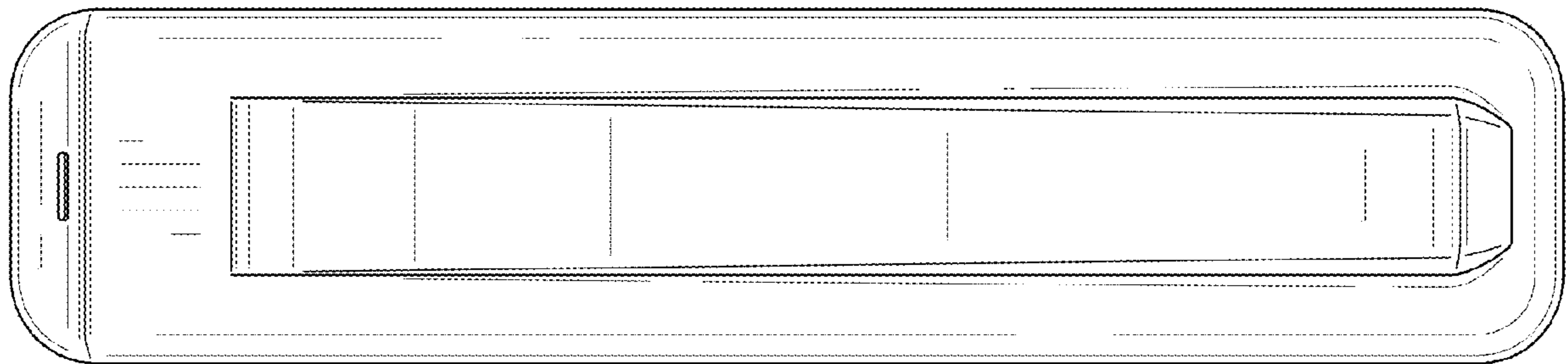
