The broken lines depict portions of the smoking booth that form no part of the claim.

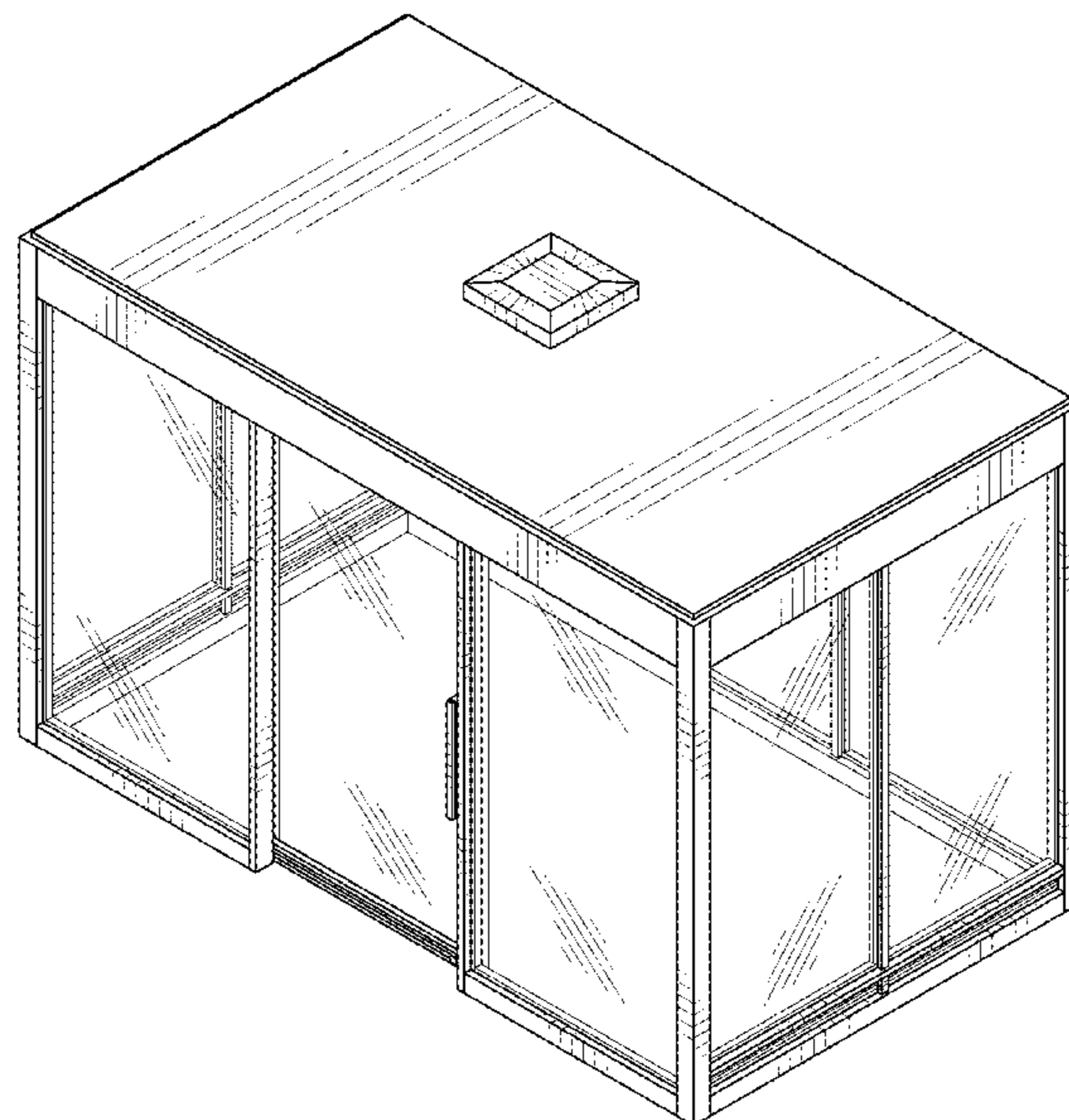

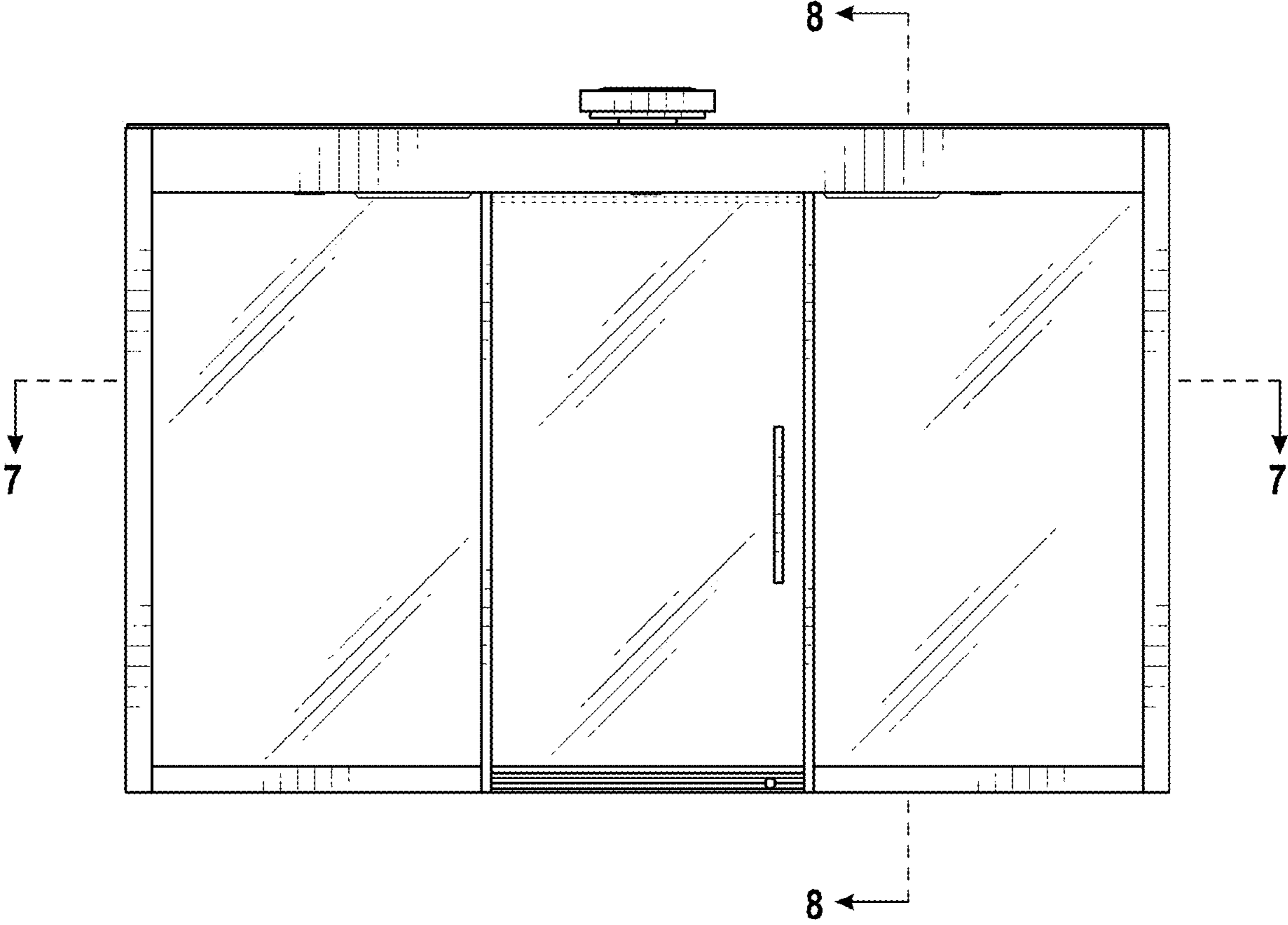

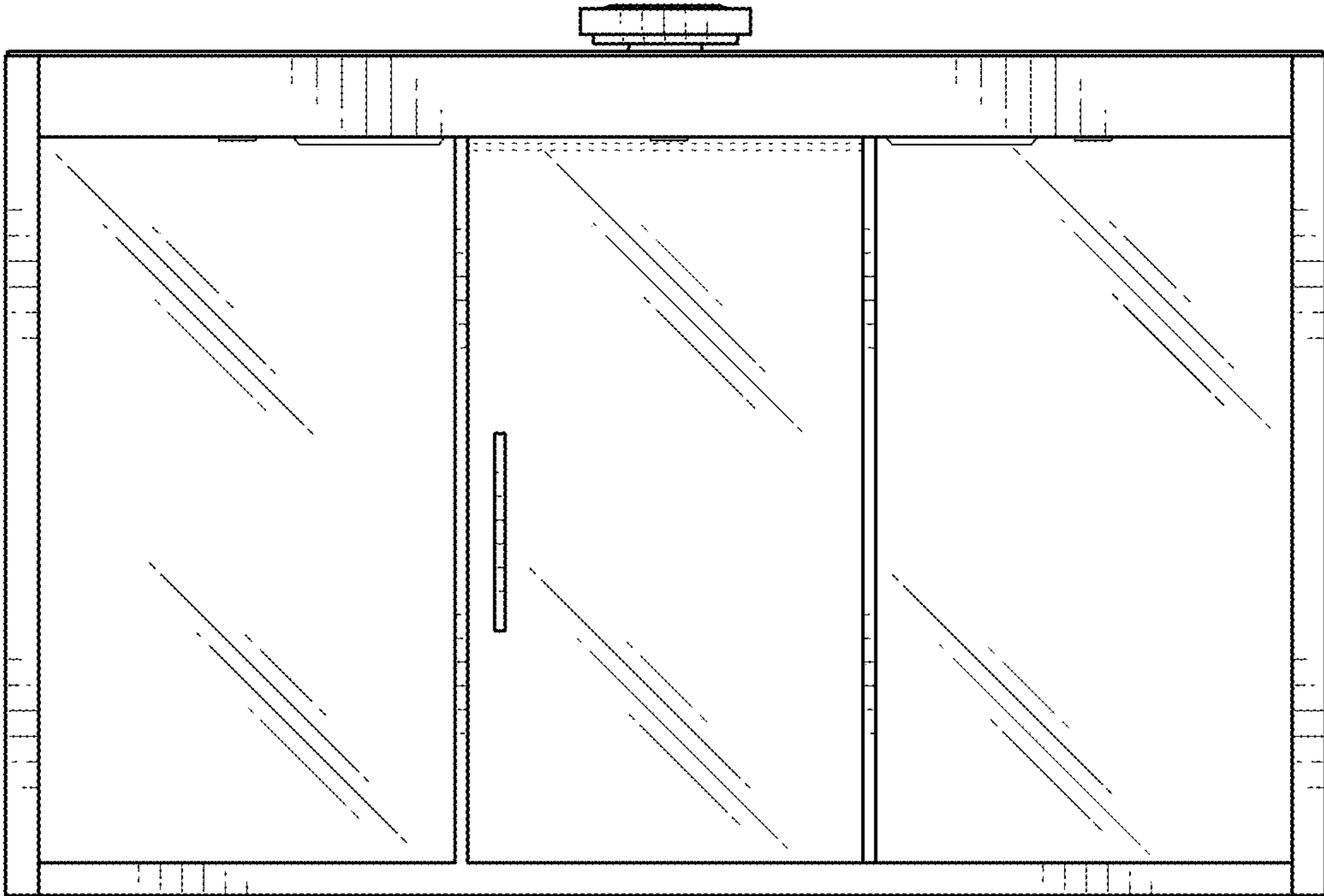

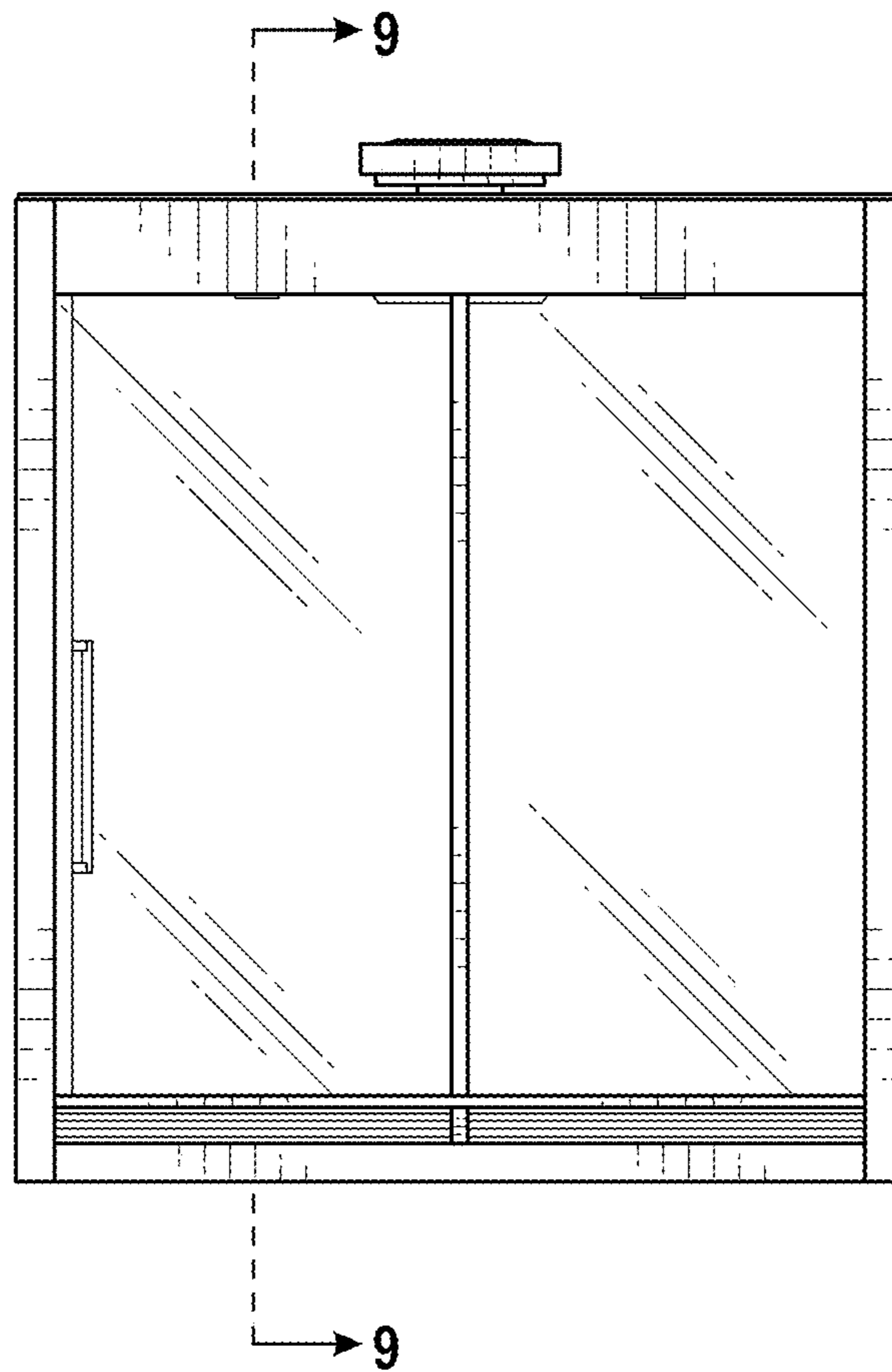

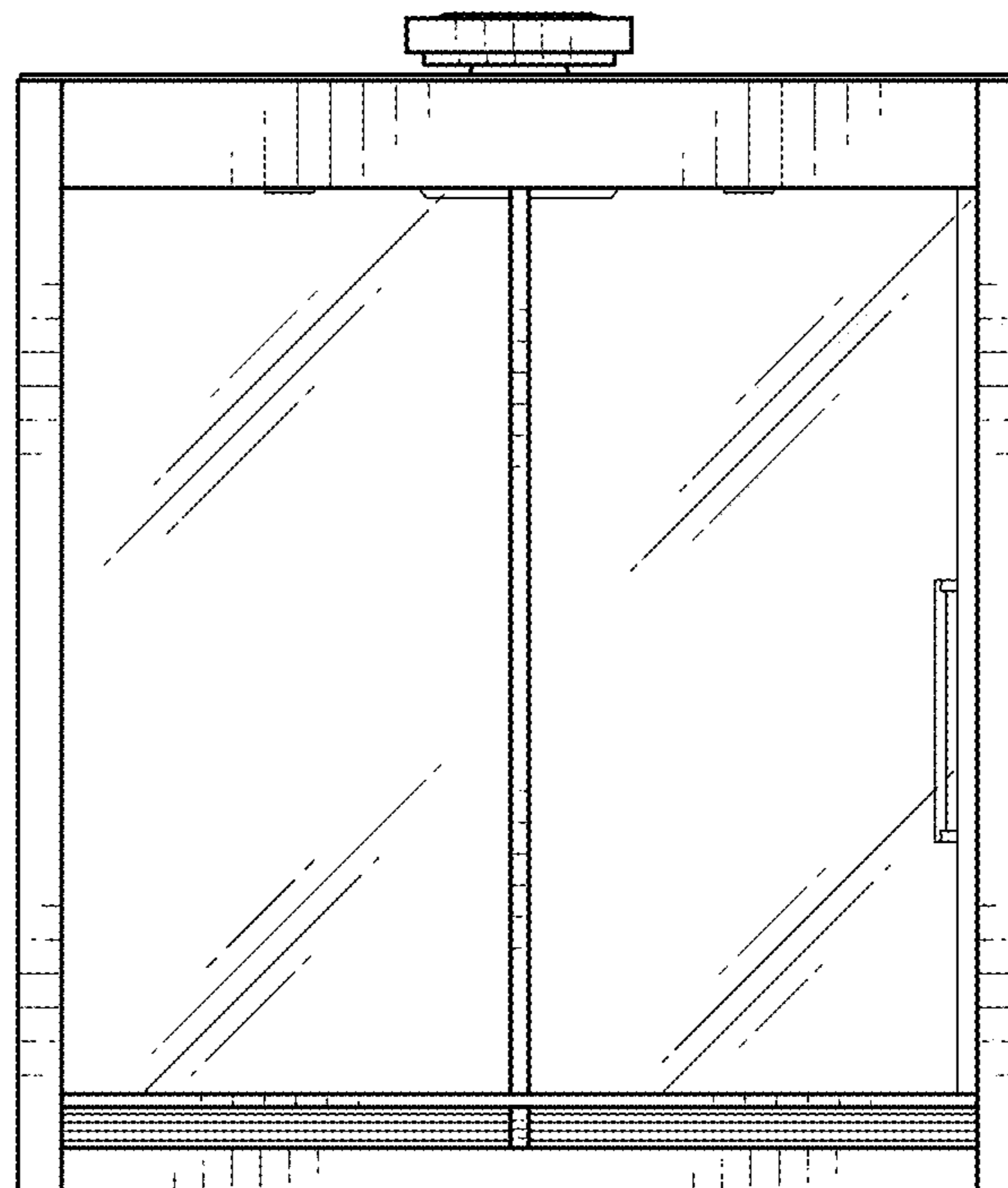

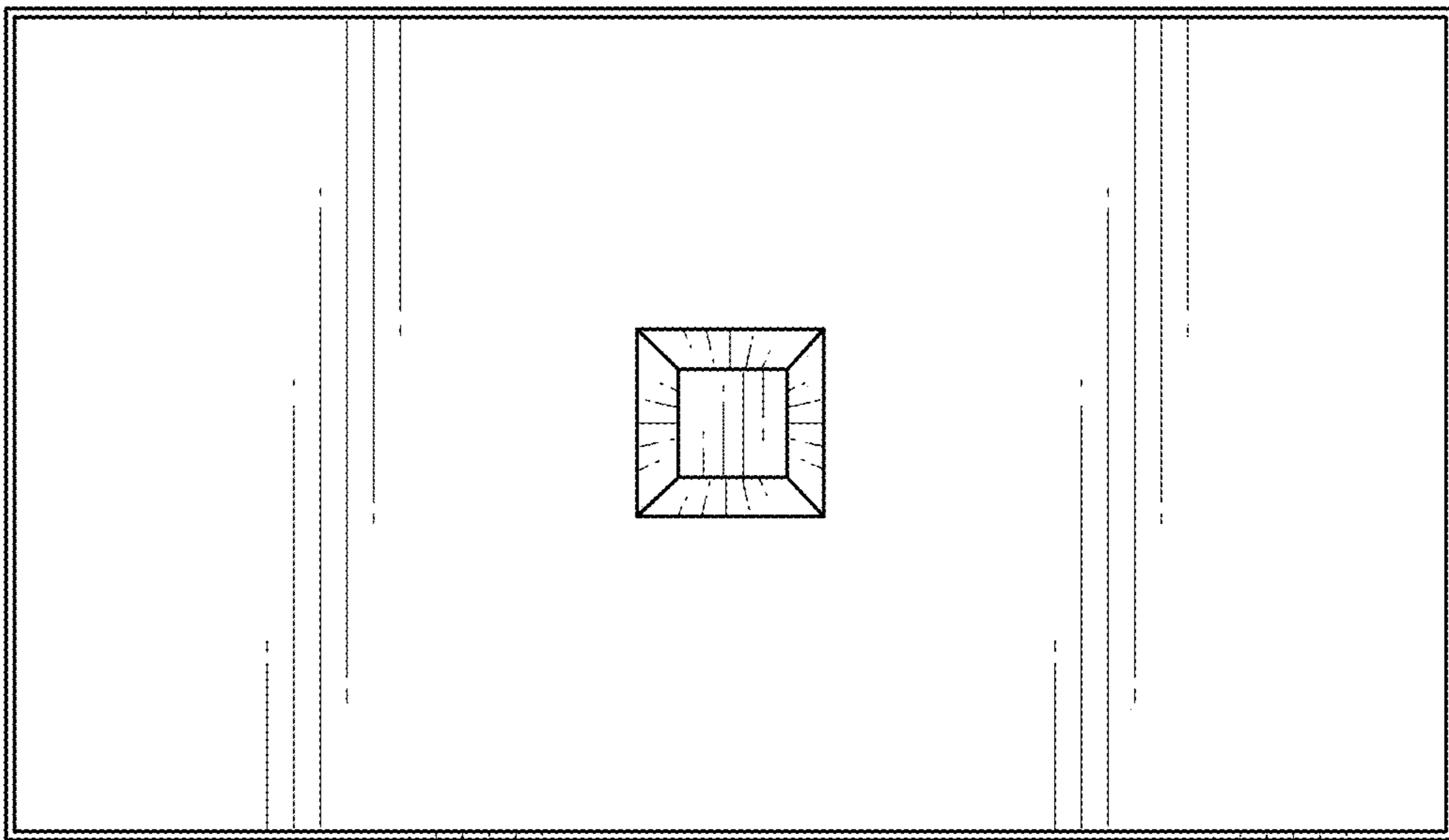

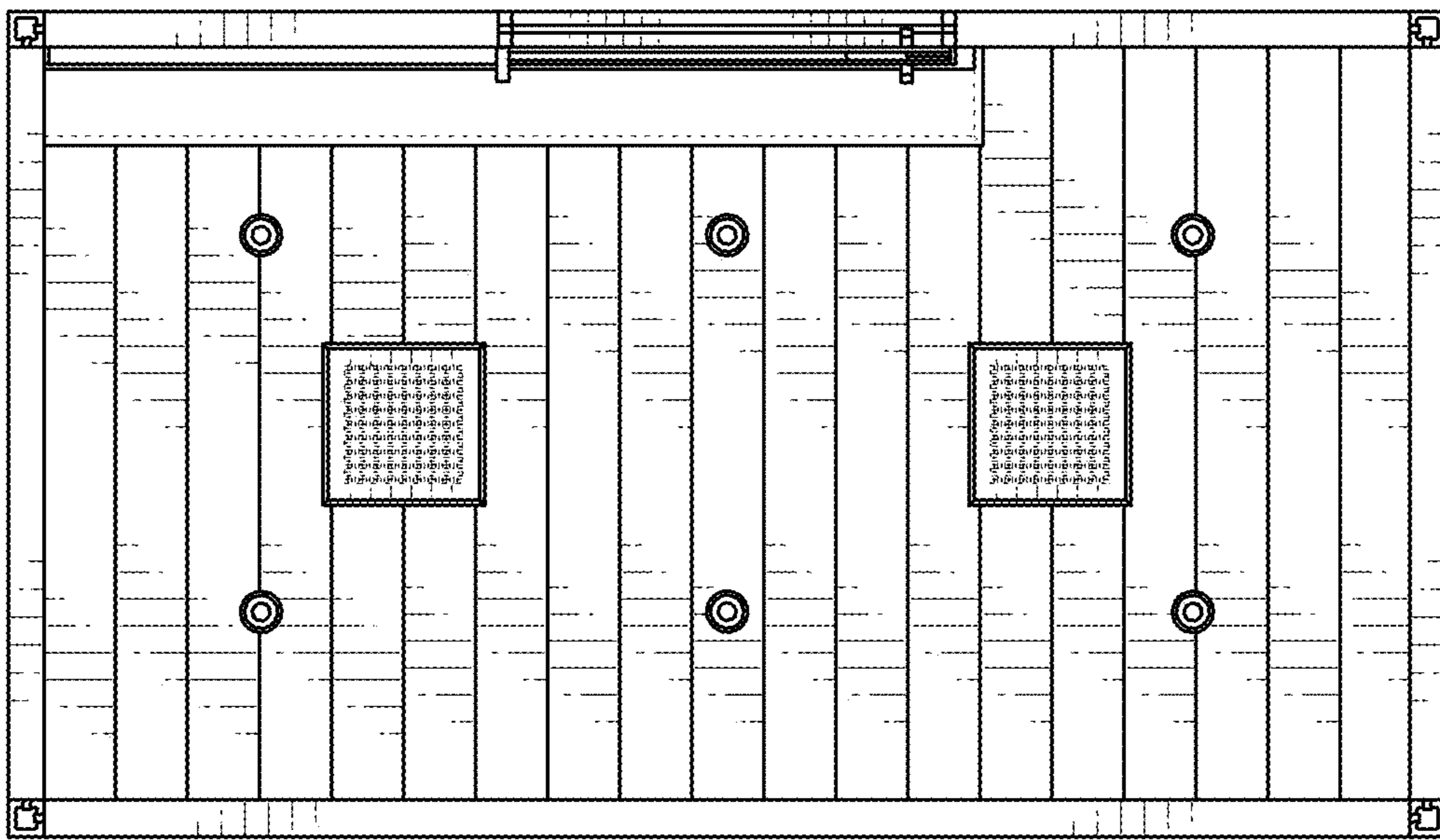

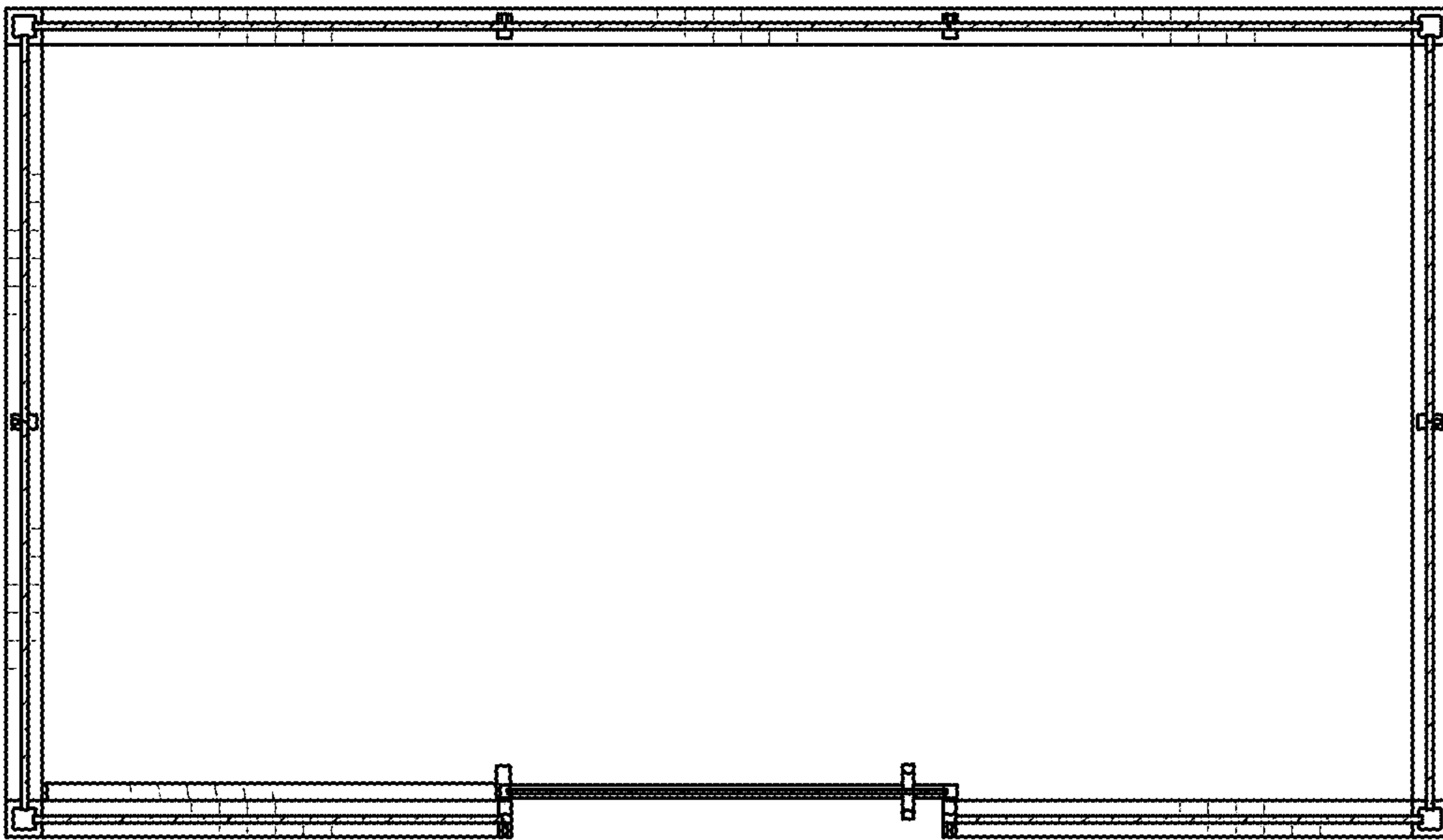

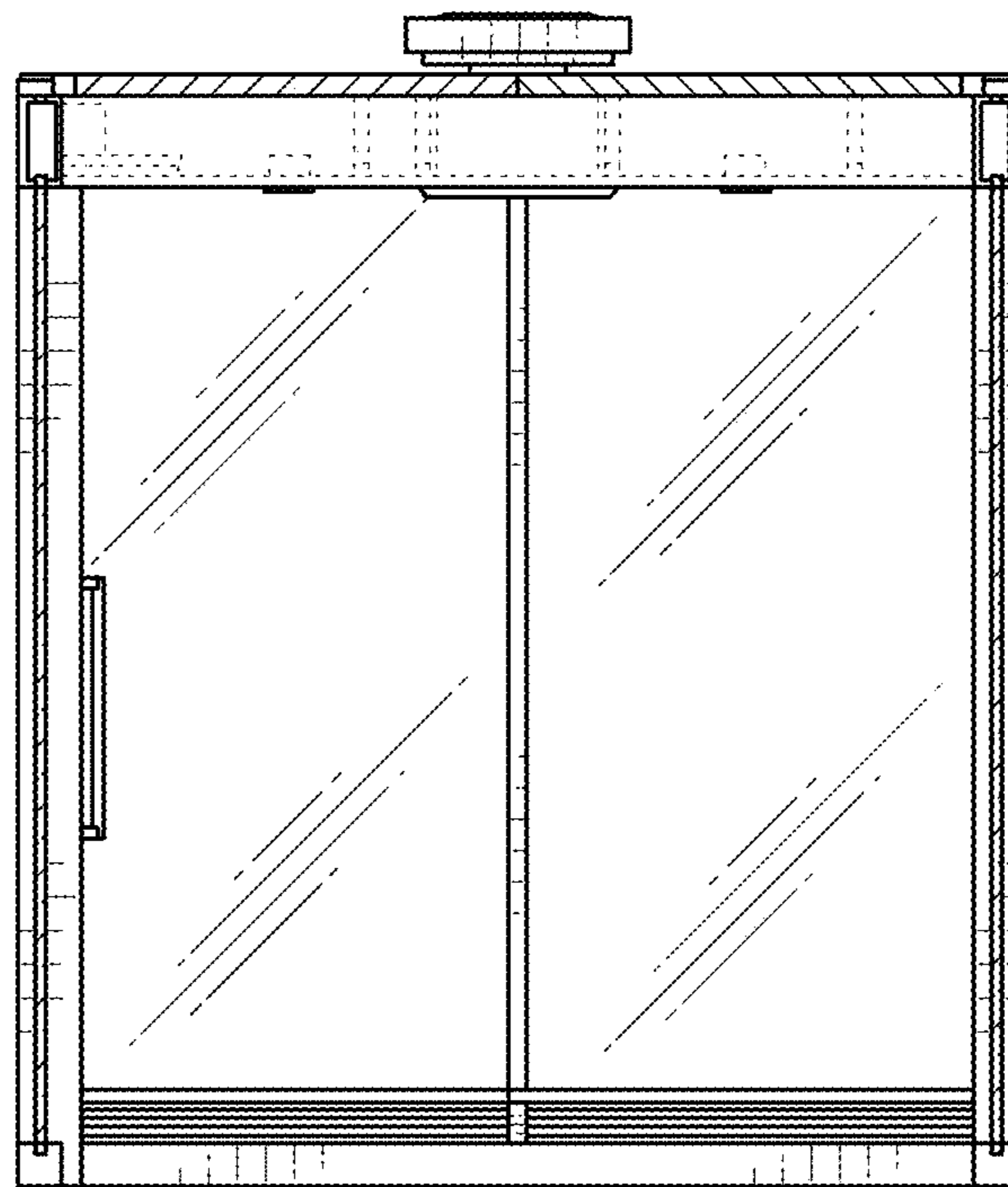

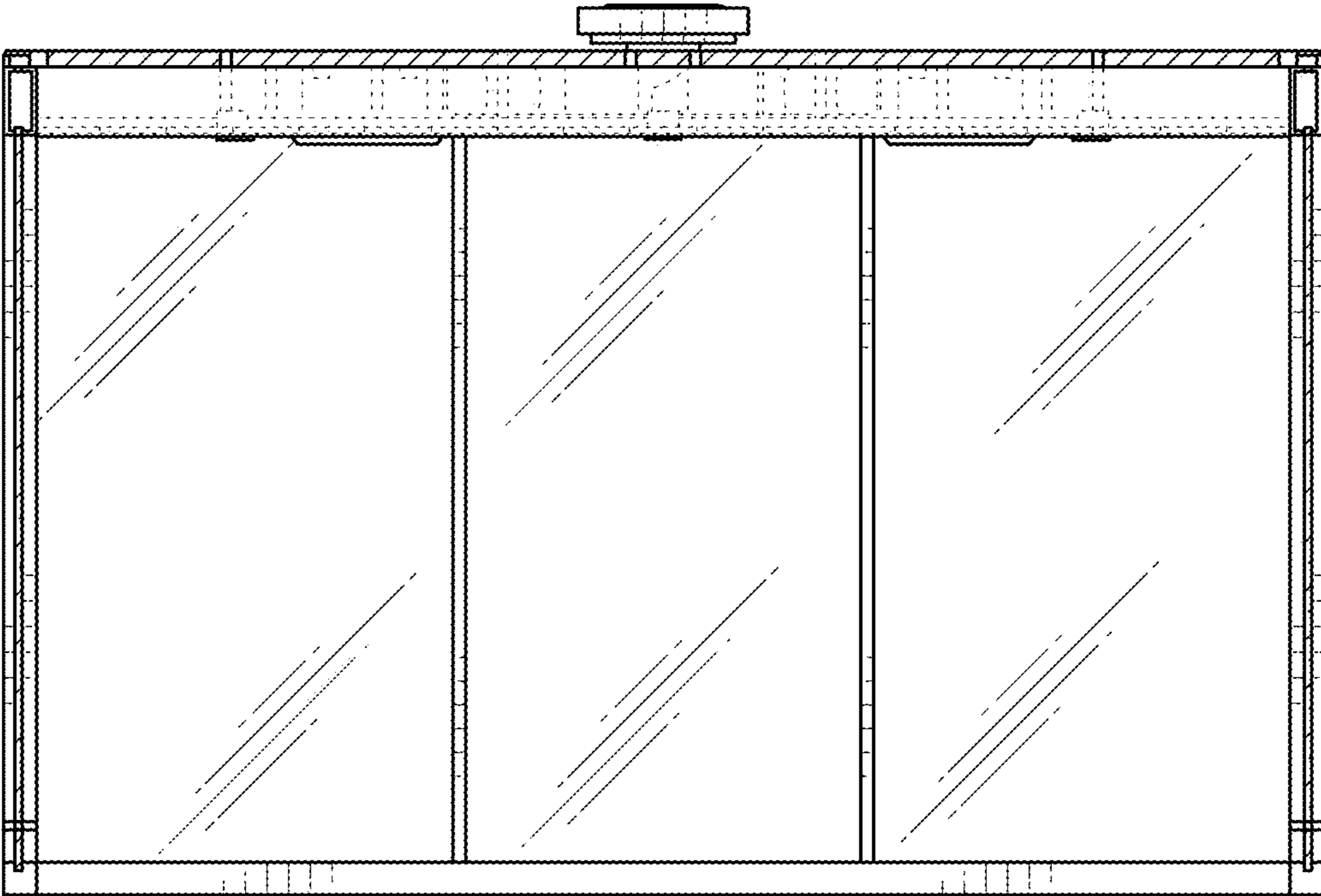

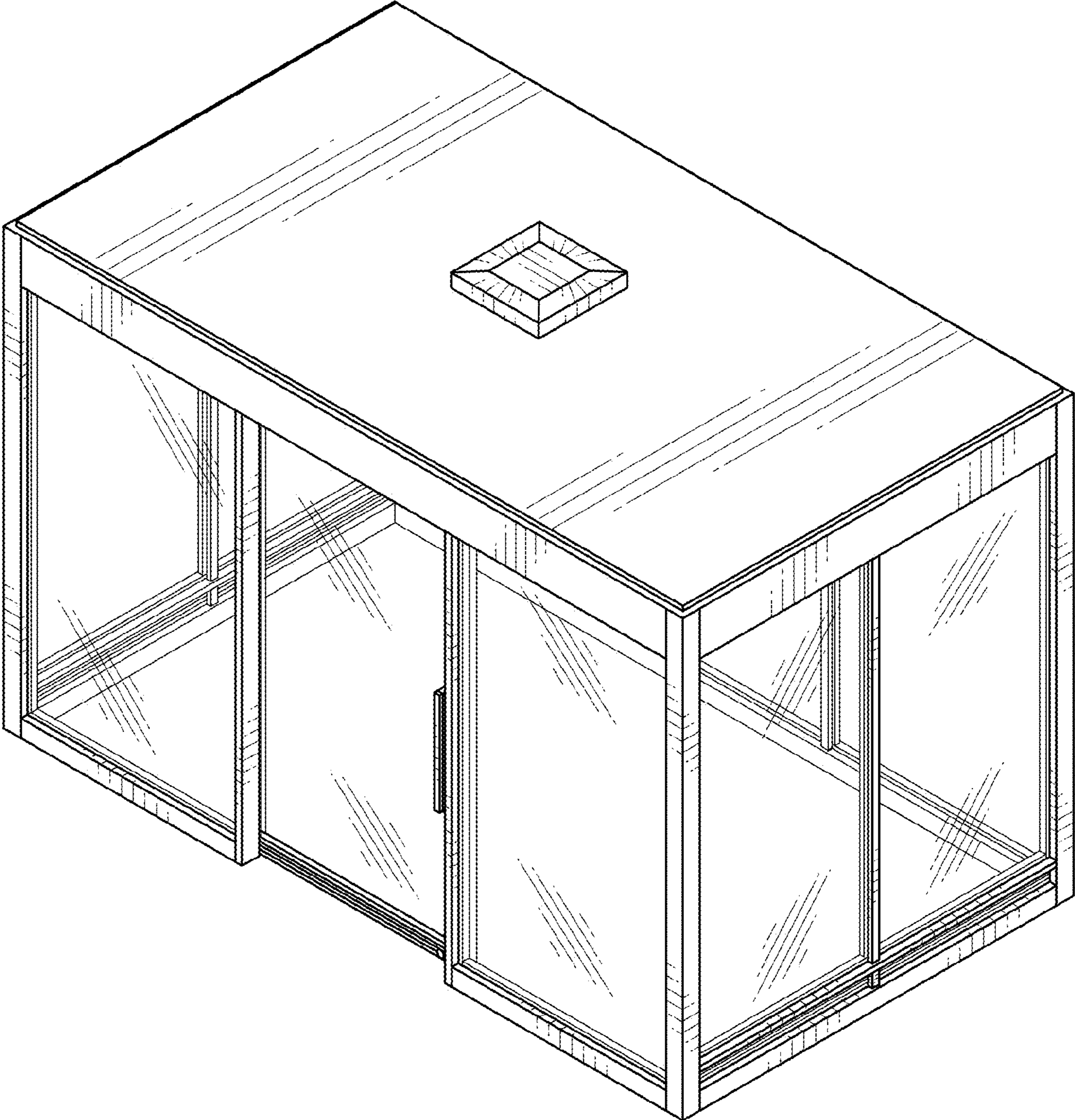

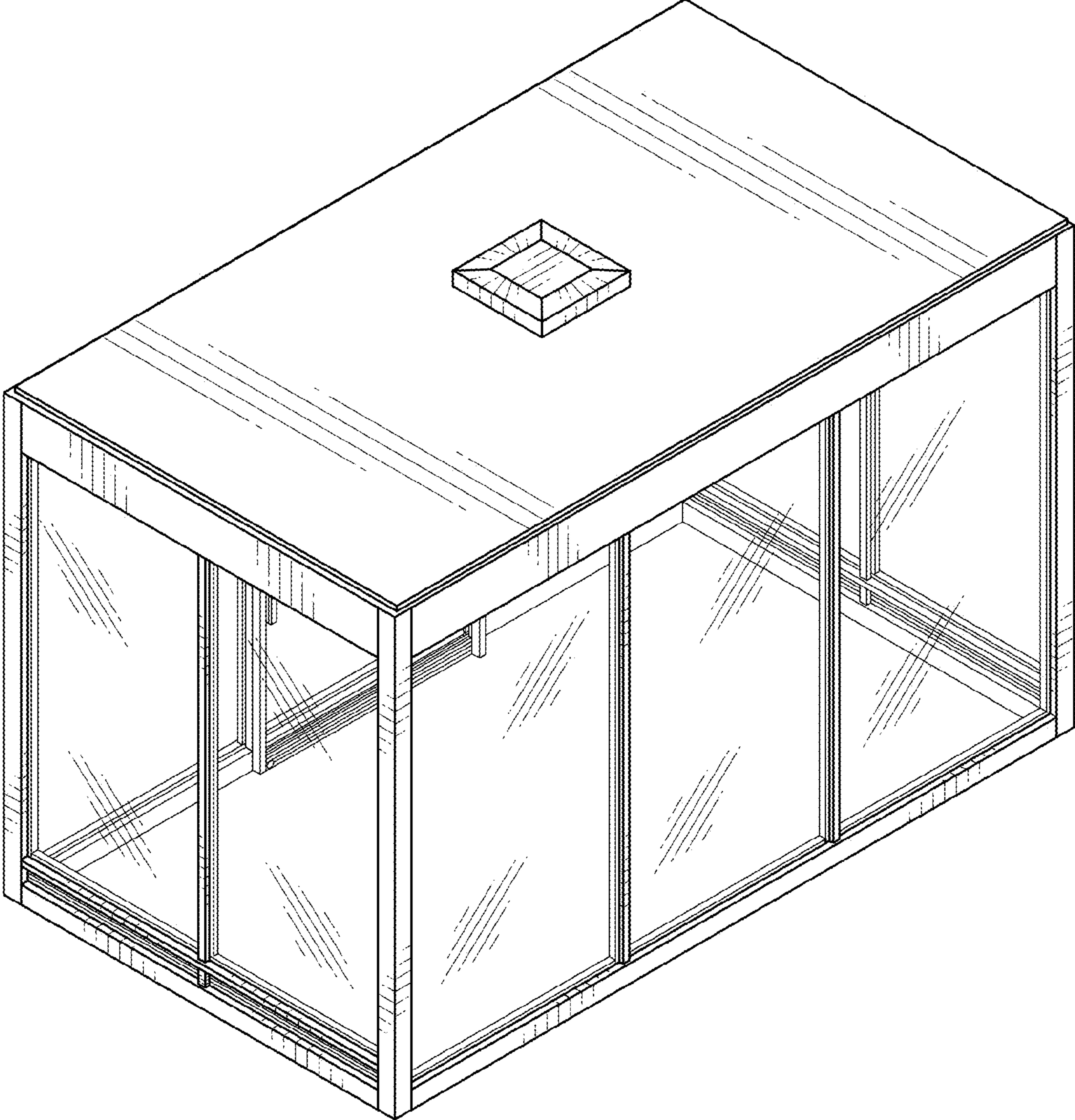
