(57) **CLAIM**

The ornamental design for a decorative lamp, as shown and described.

DESCRIPTION

FIG. 1 is a front, right, and top perspective view of a decorative lamp, showing my design.

FIG. 2 is a rear, left, and bottom perspective view thereof.

FIG. 3 is a front elevation view thereof.

FIG. 4 is a rear elevation view thereof.

FIG. 5 is a left side elevation view thereof.

FIG. 6 is a right side elevation view thereof.

FIG. 7 is a top plan view thereof.

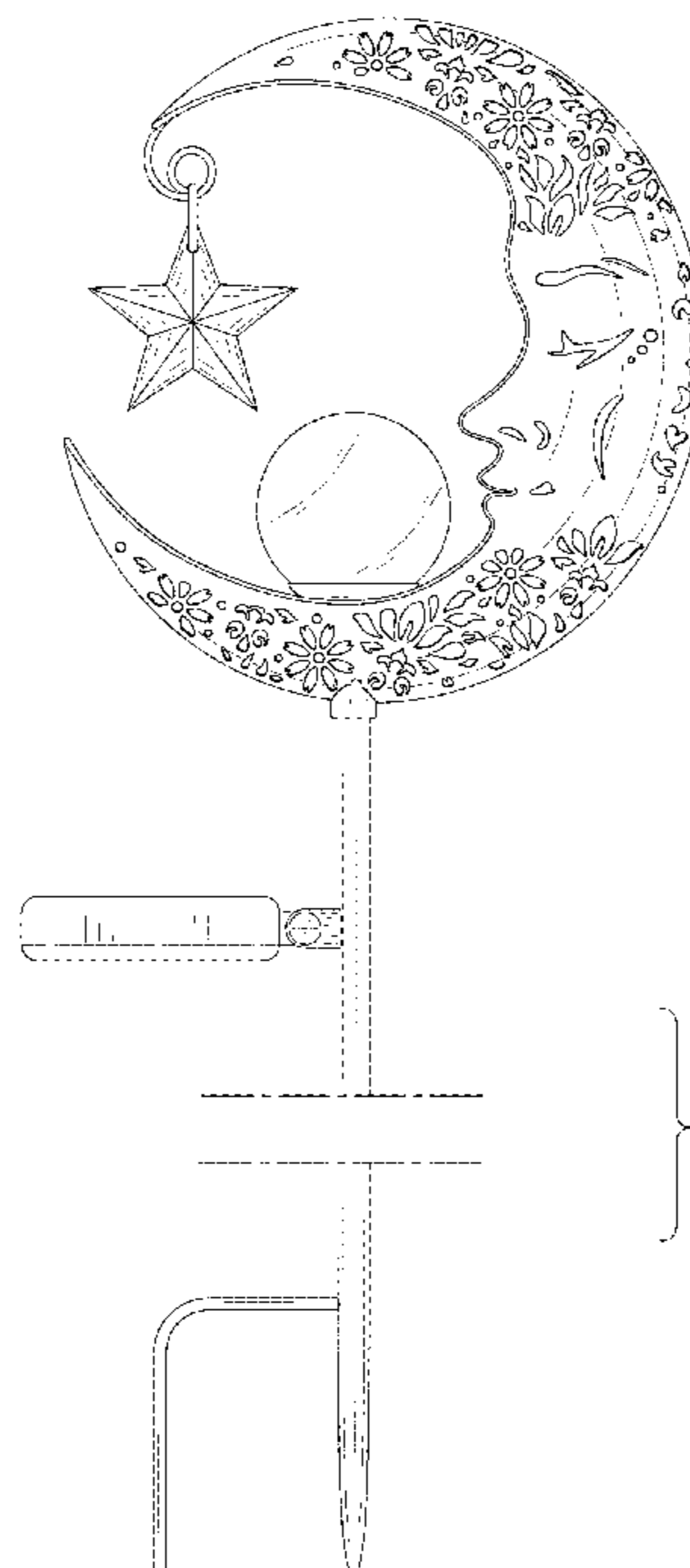
FIG. 8 is a bottom plan view thereof.

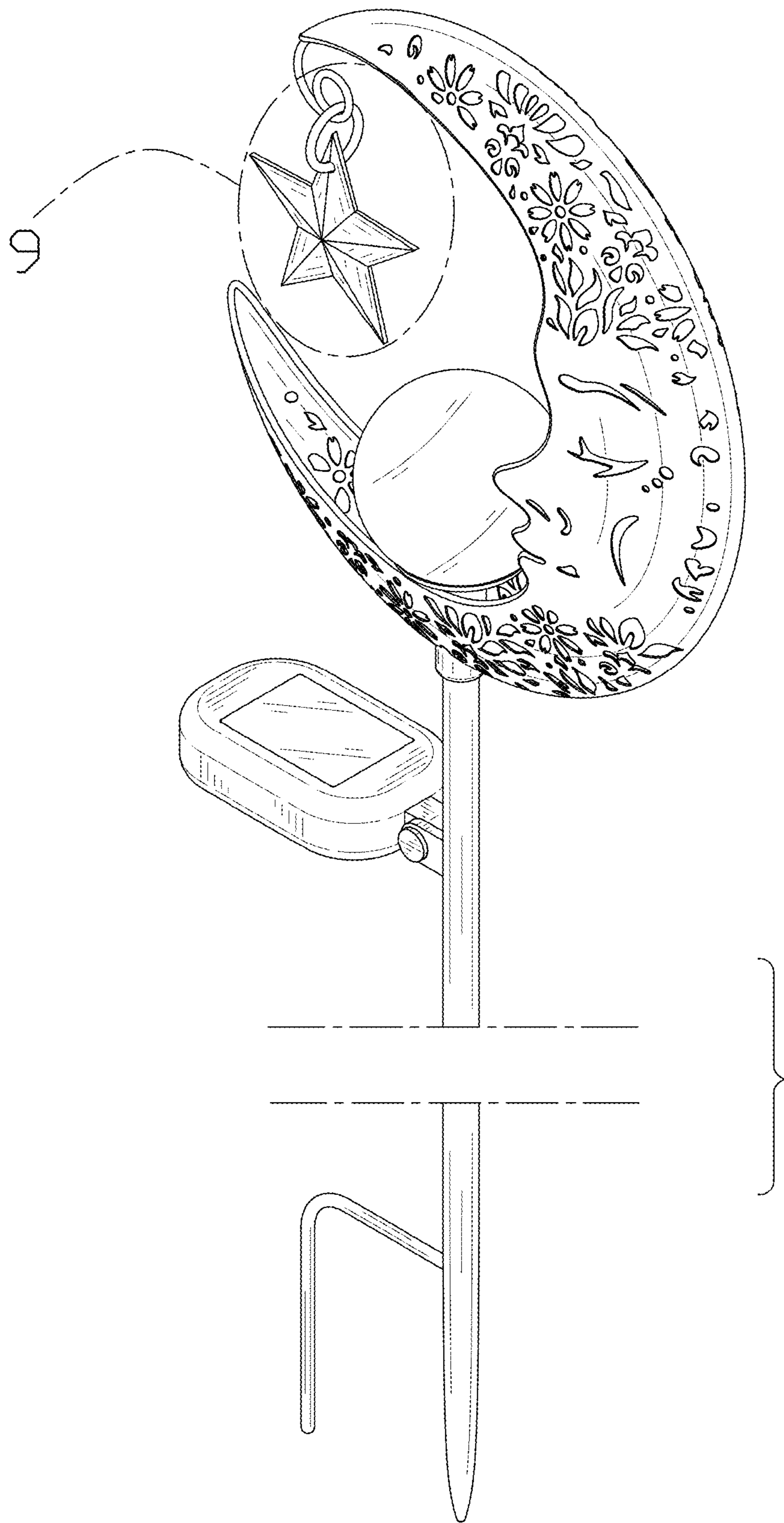

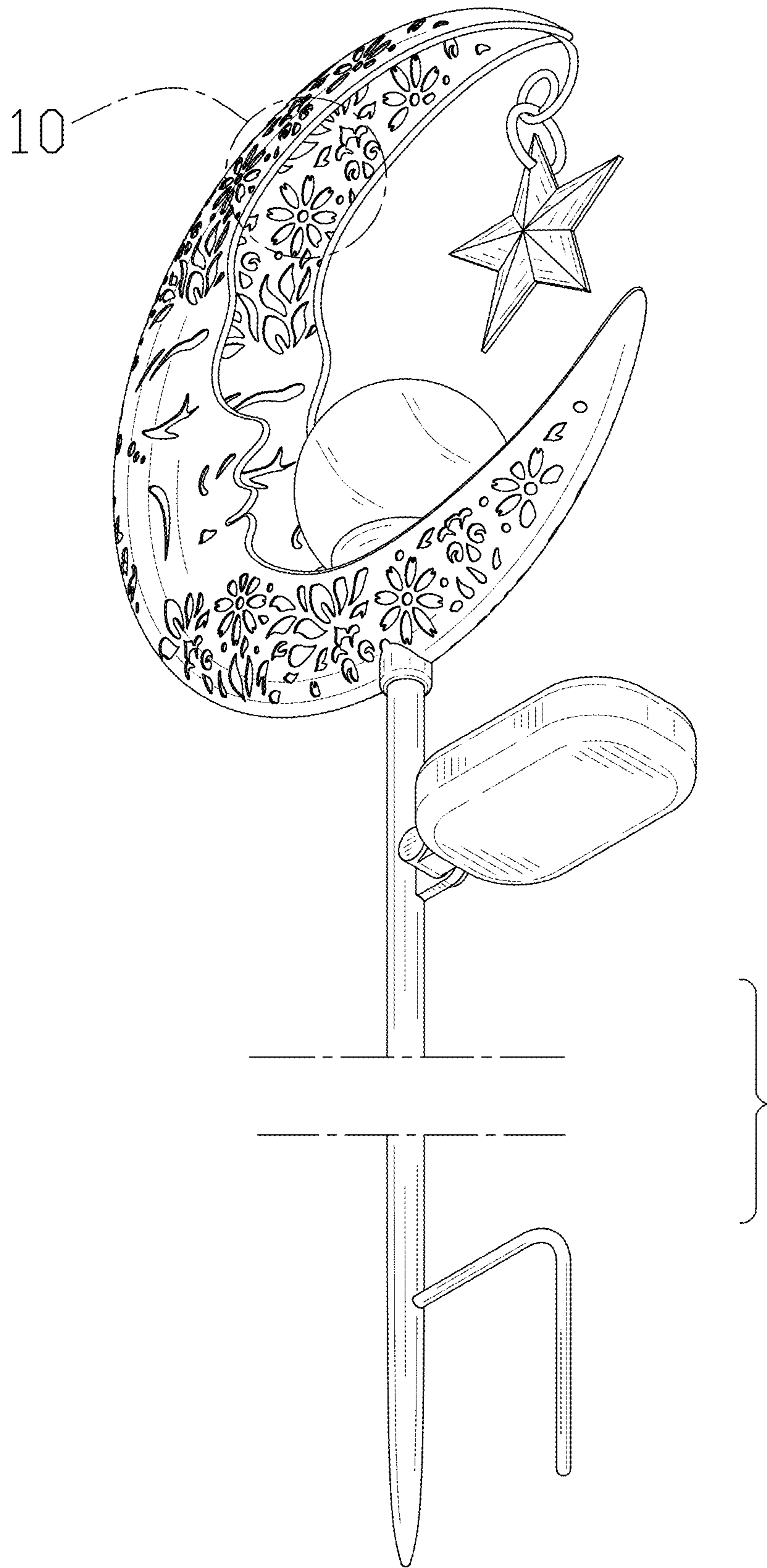

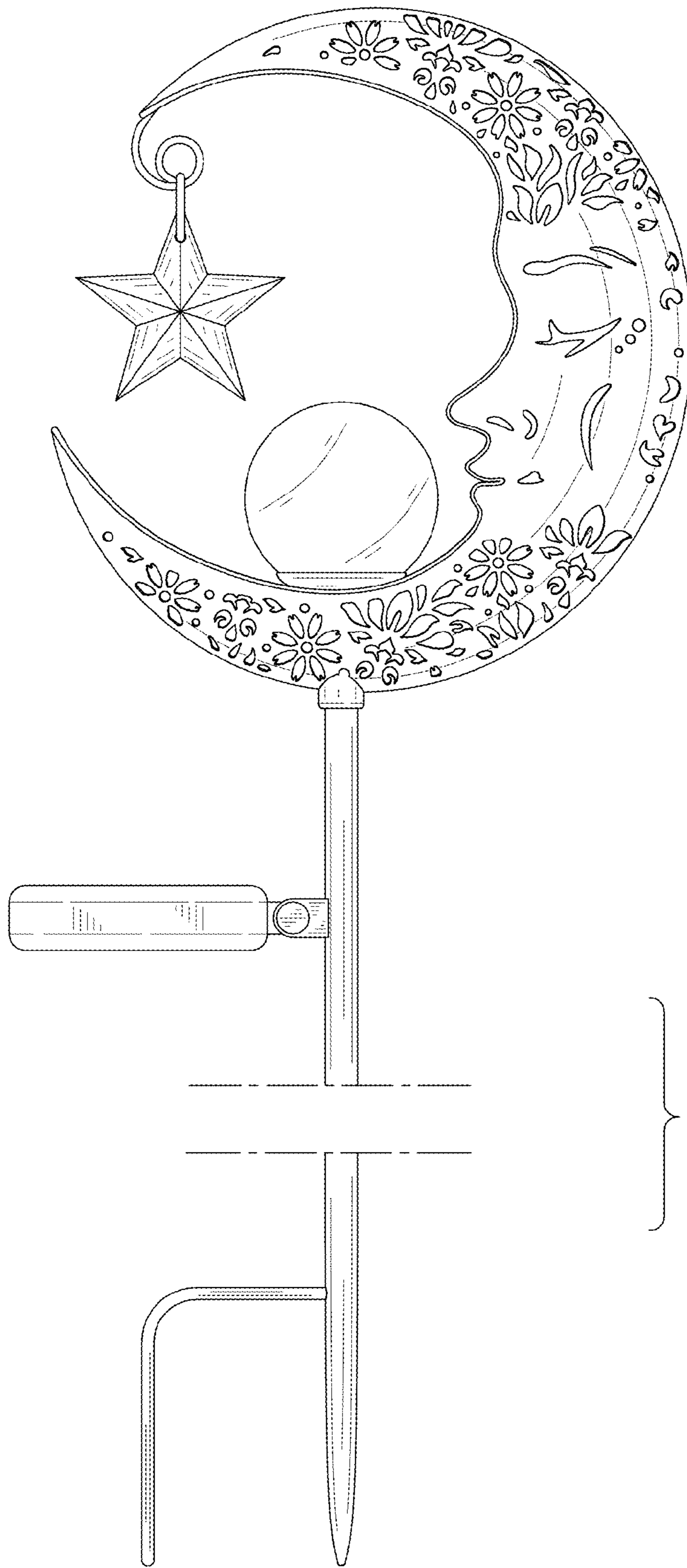

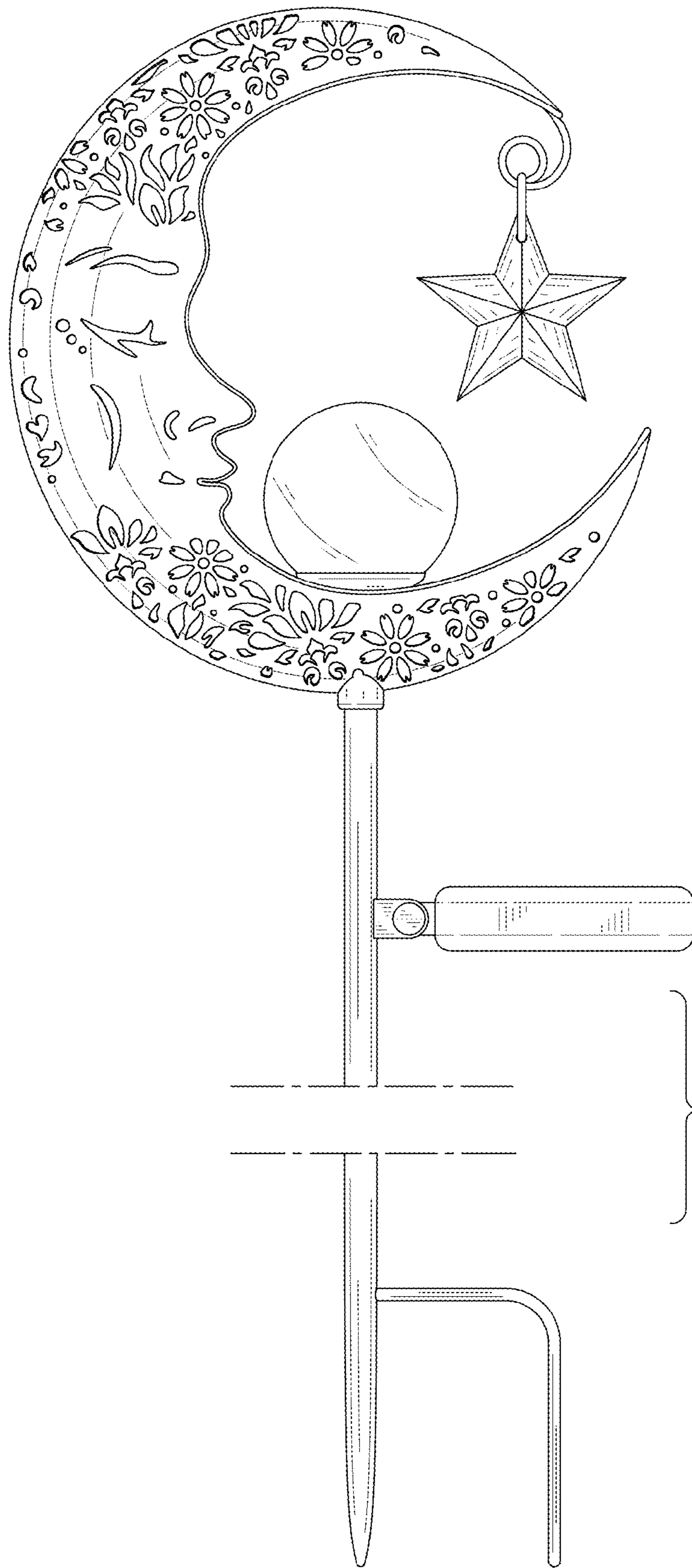

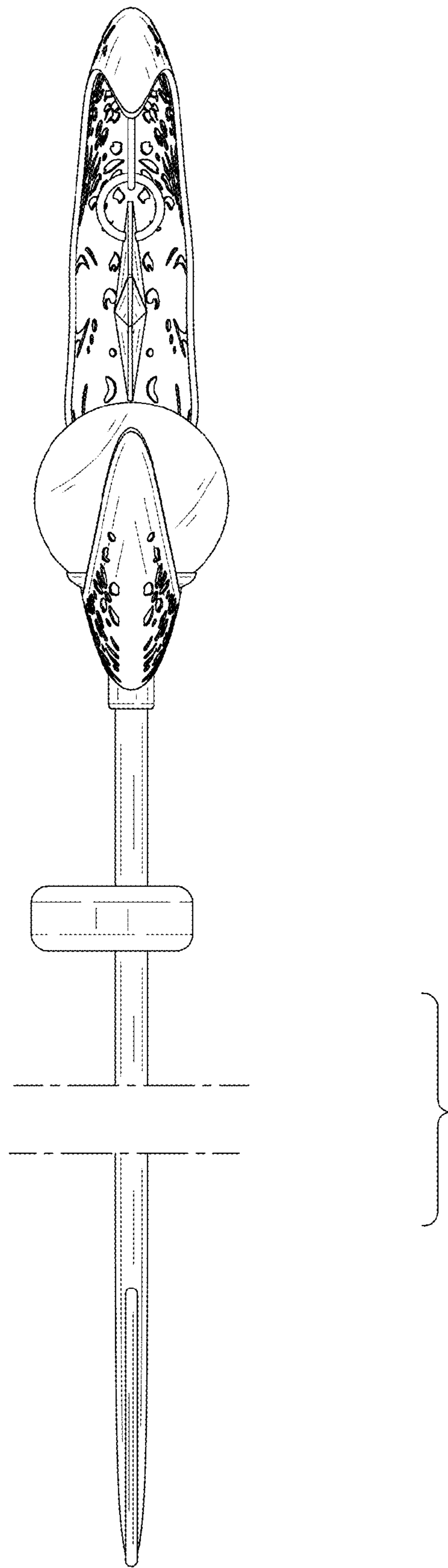

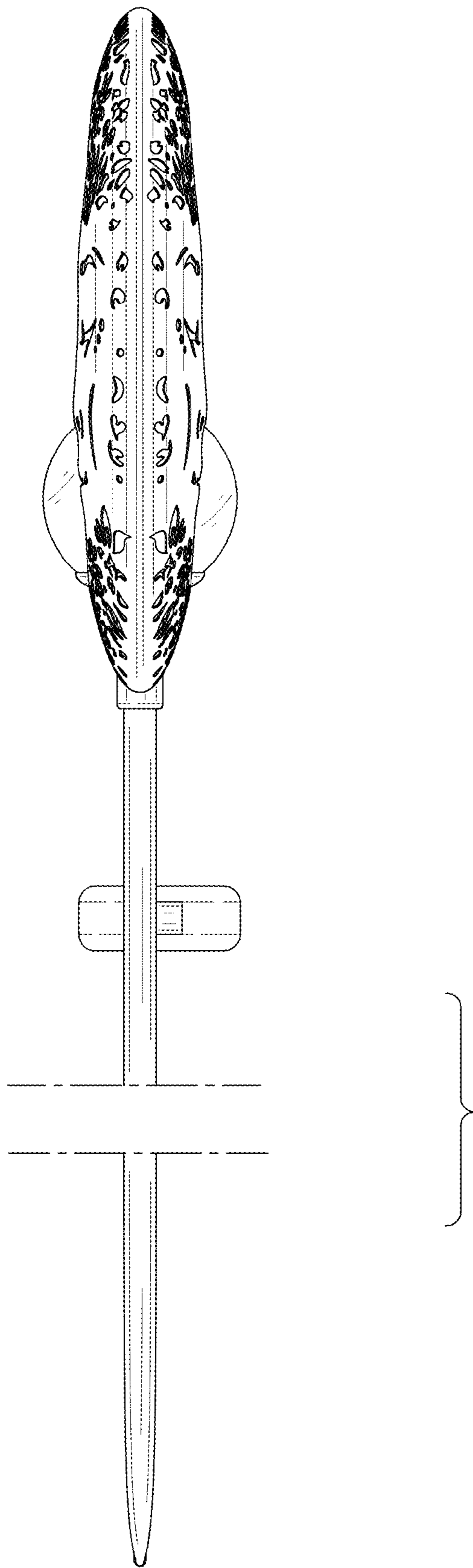

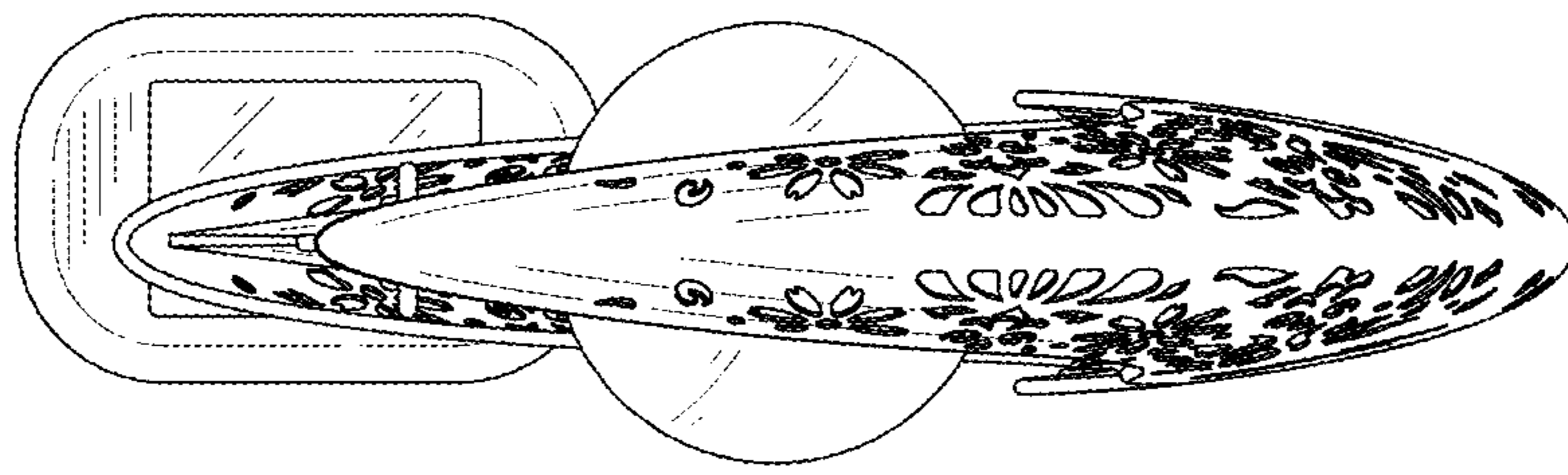

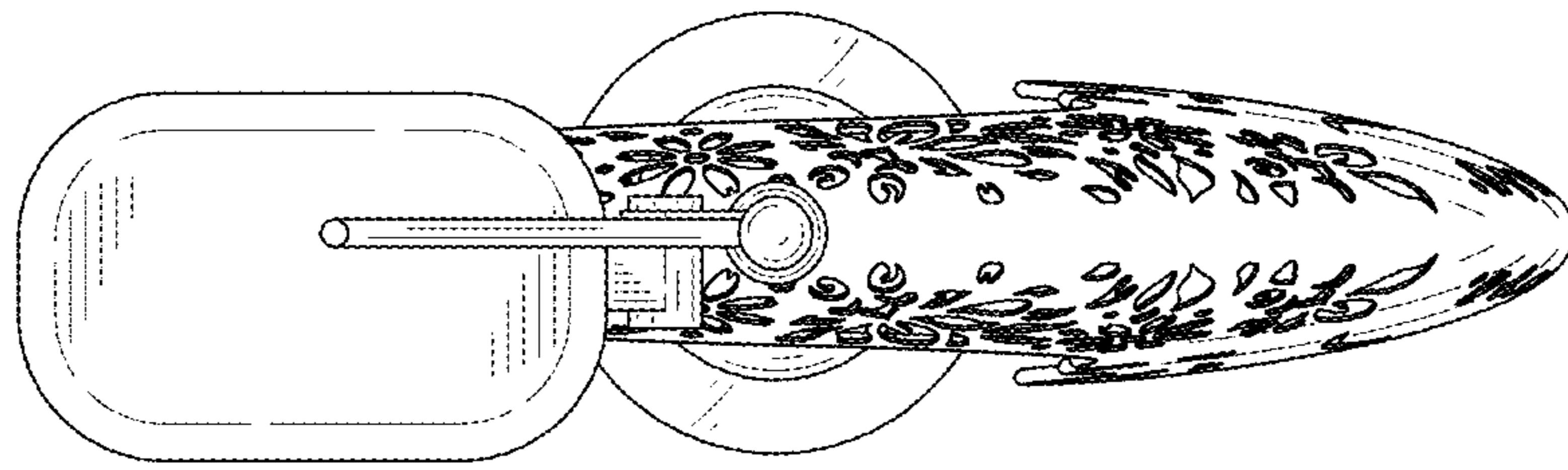

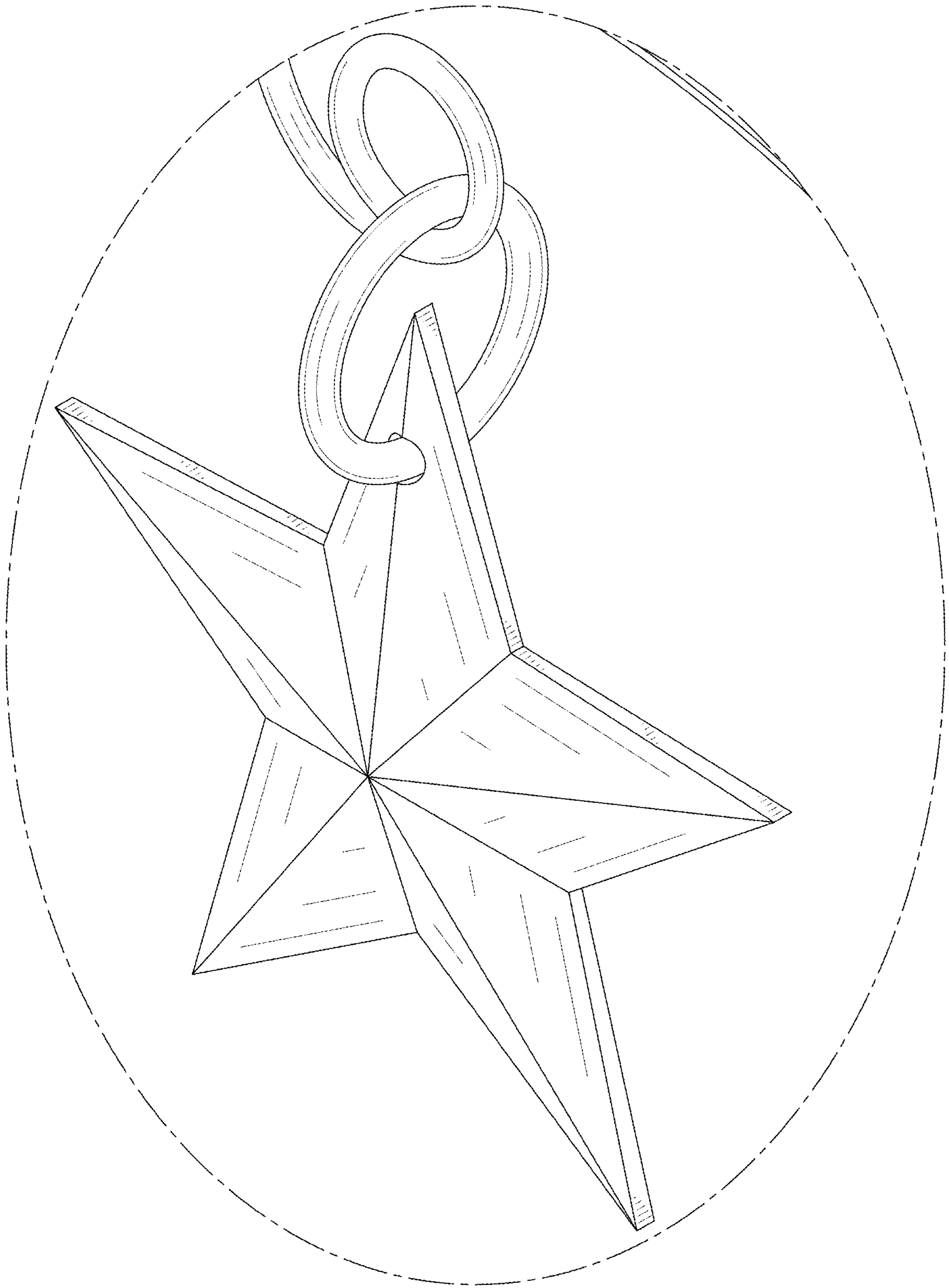
