The ornamental design for a cup, as shown and described.

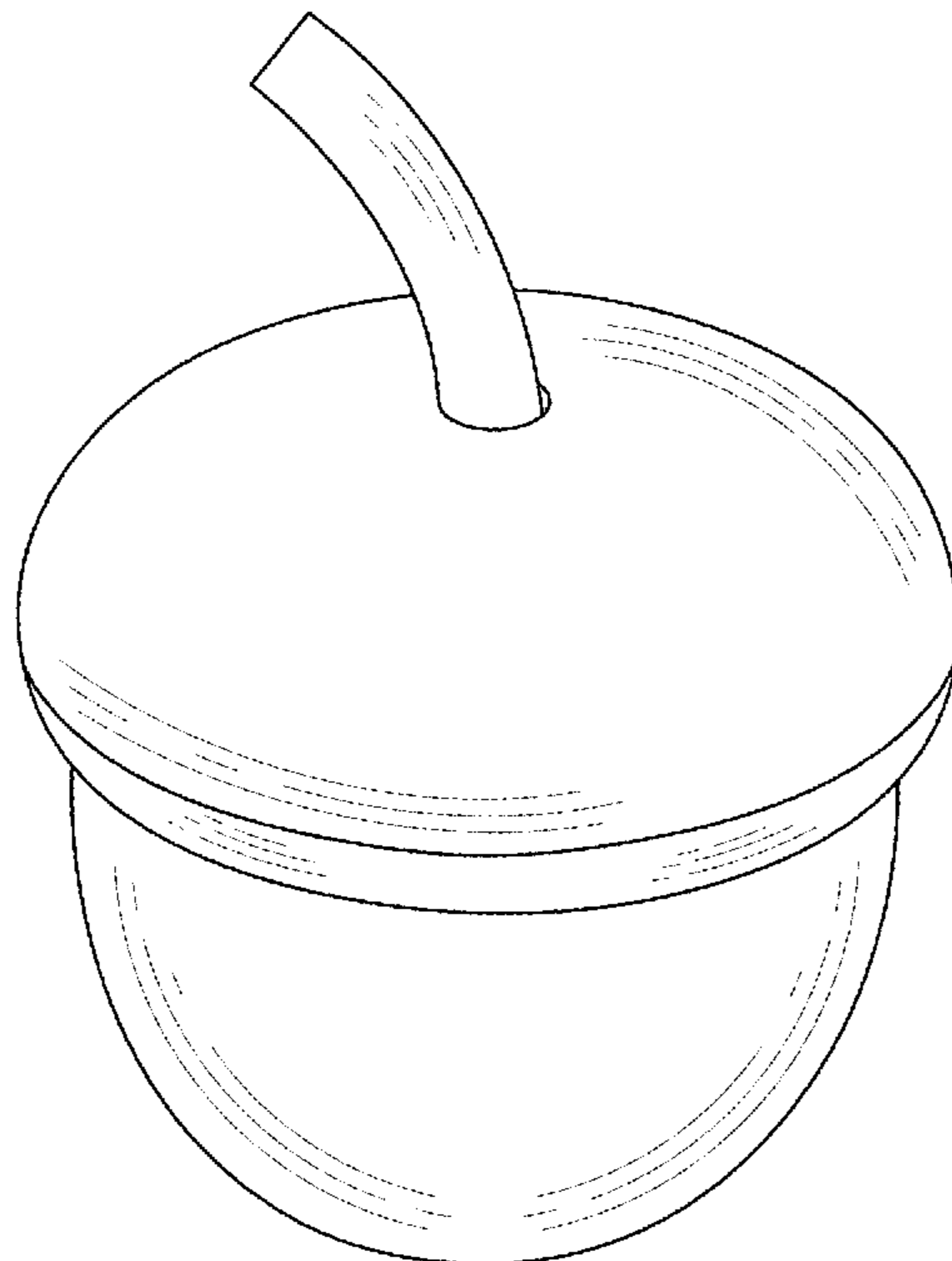
DESCRIPTION

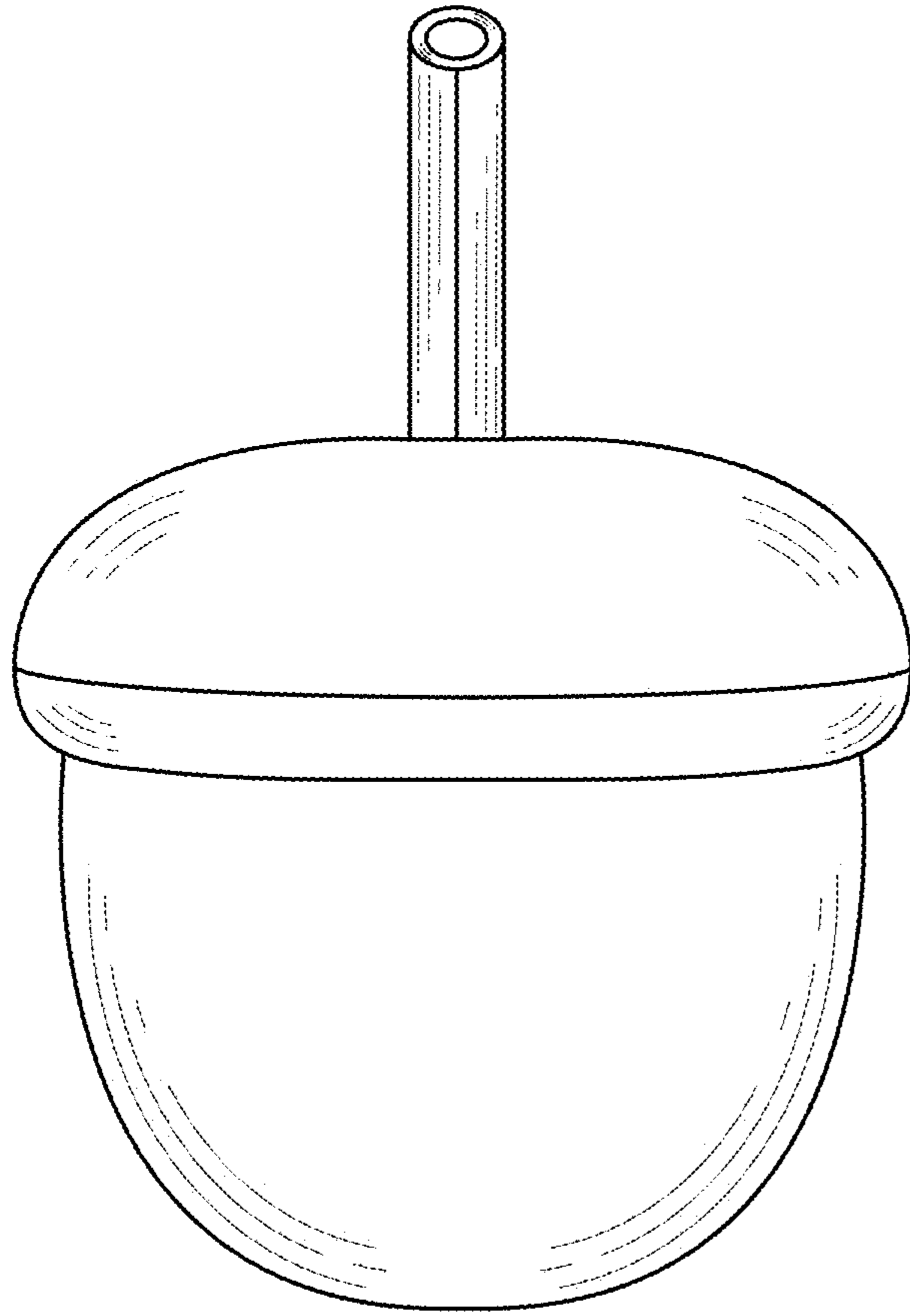

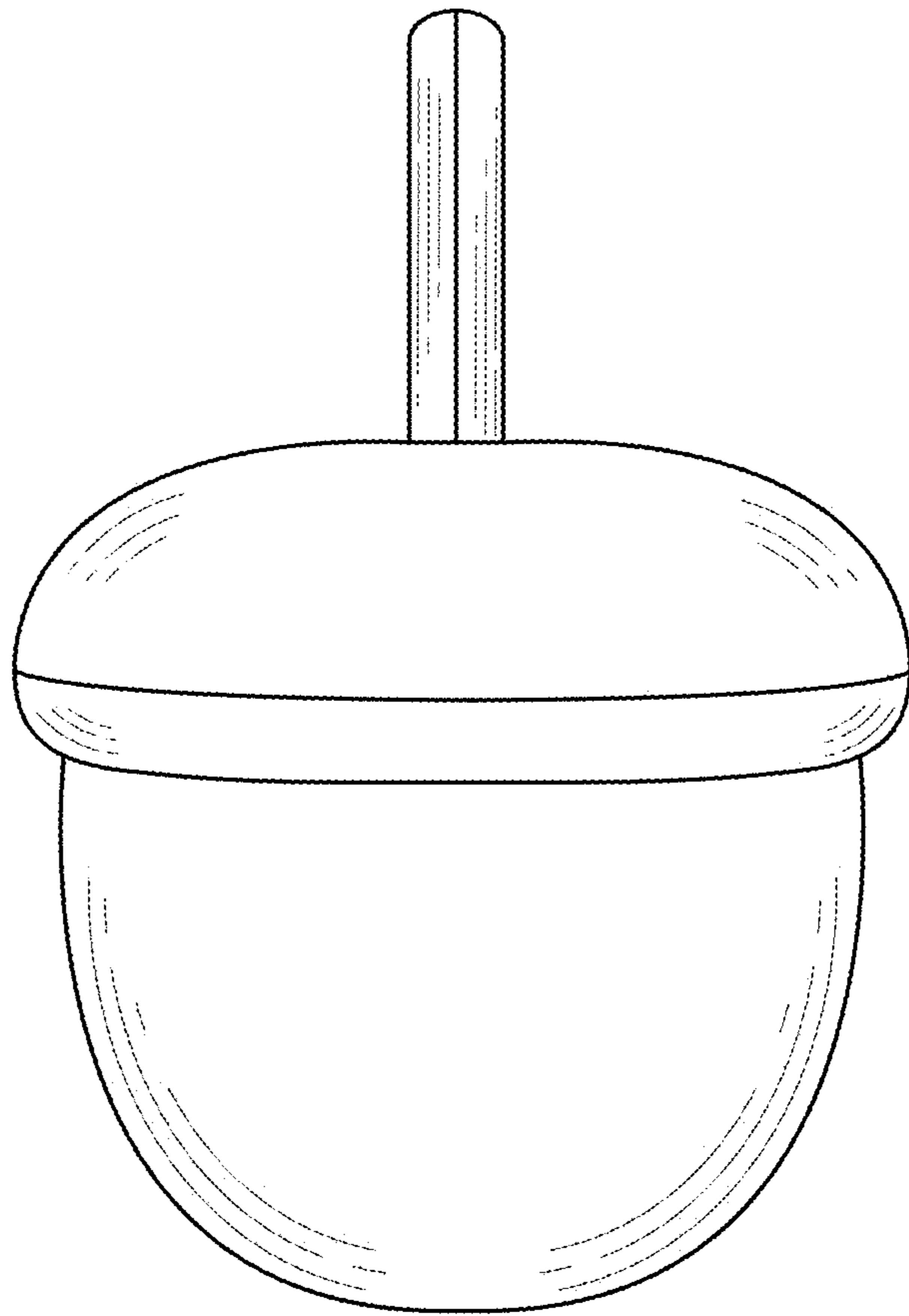

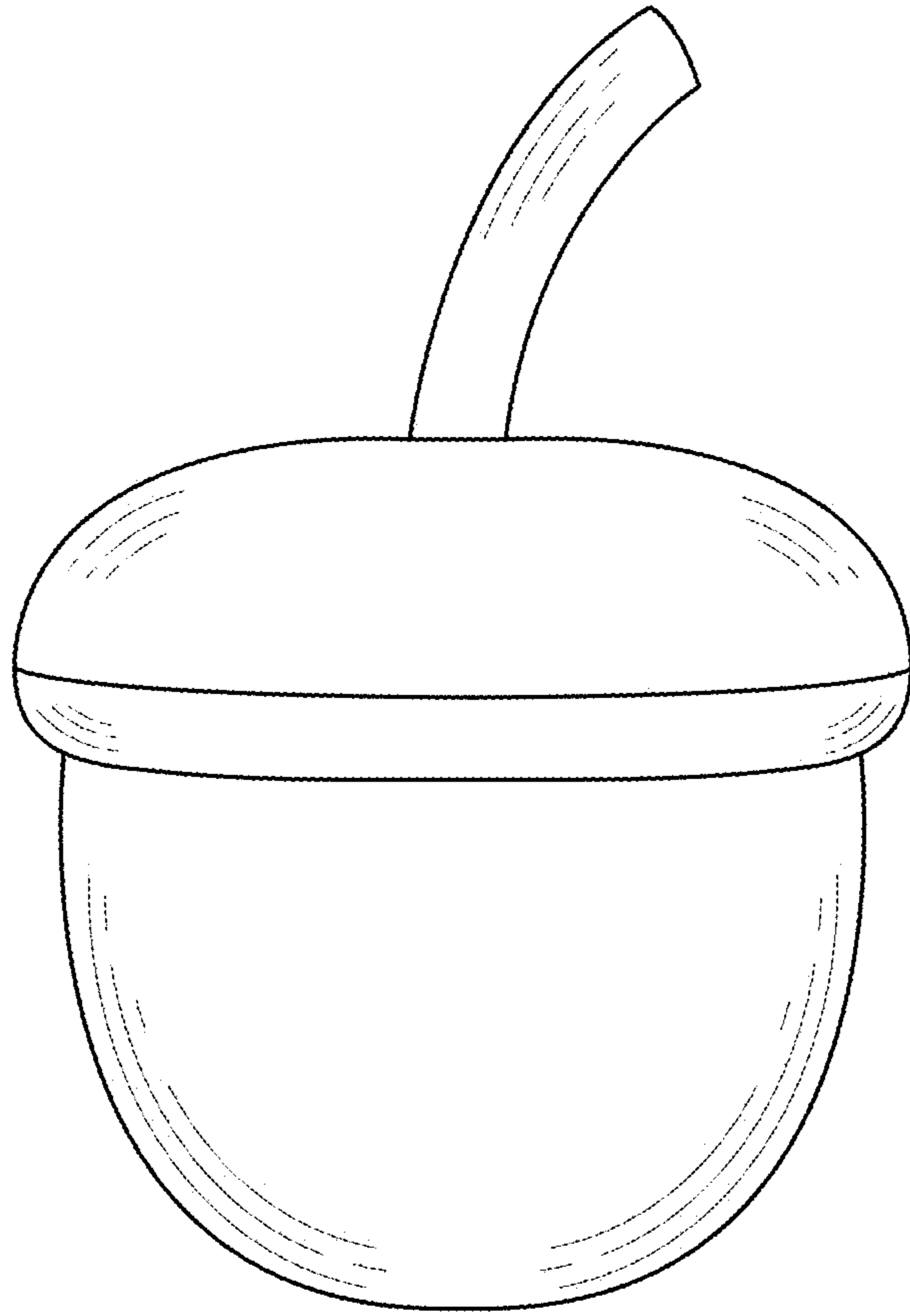

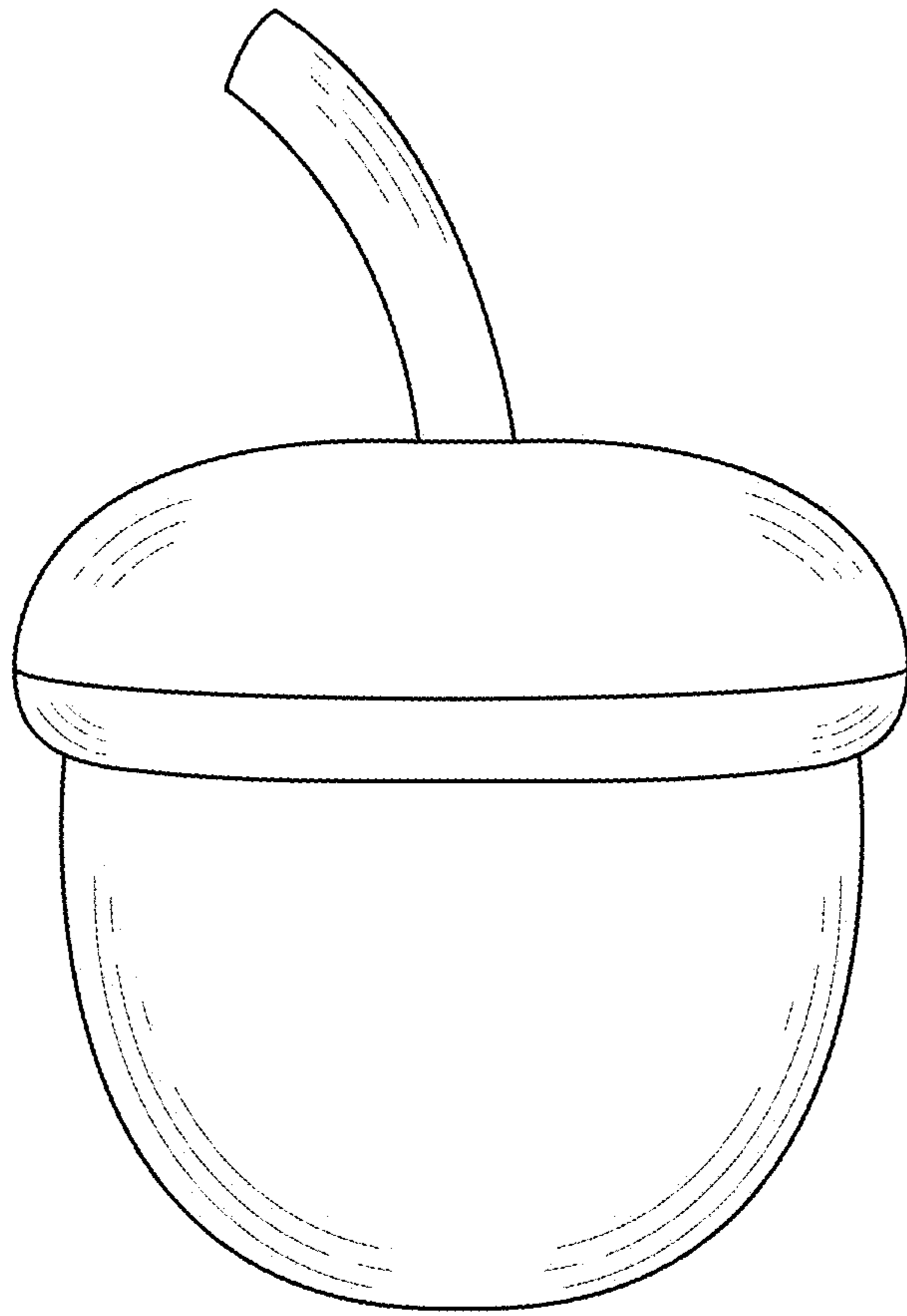

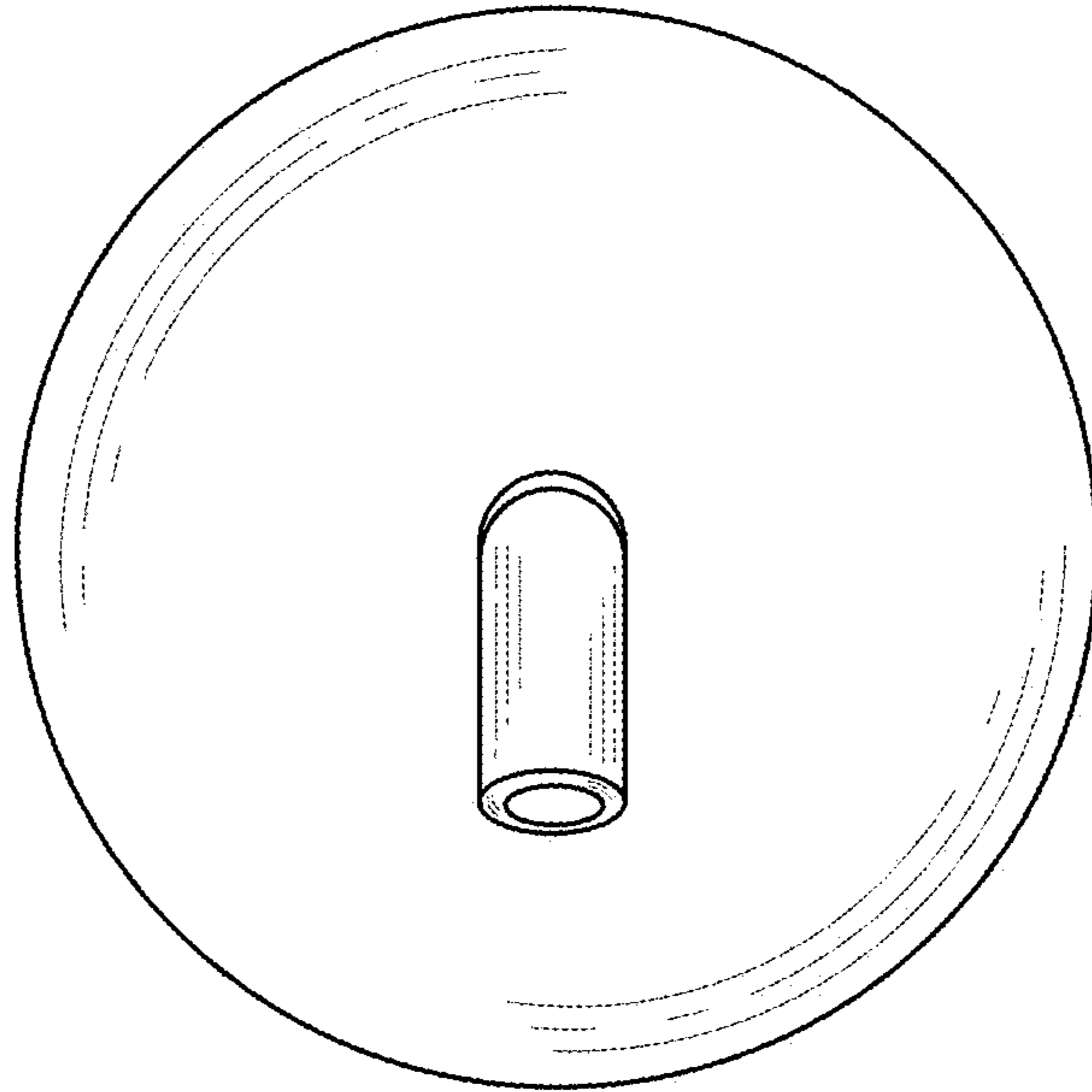

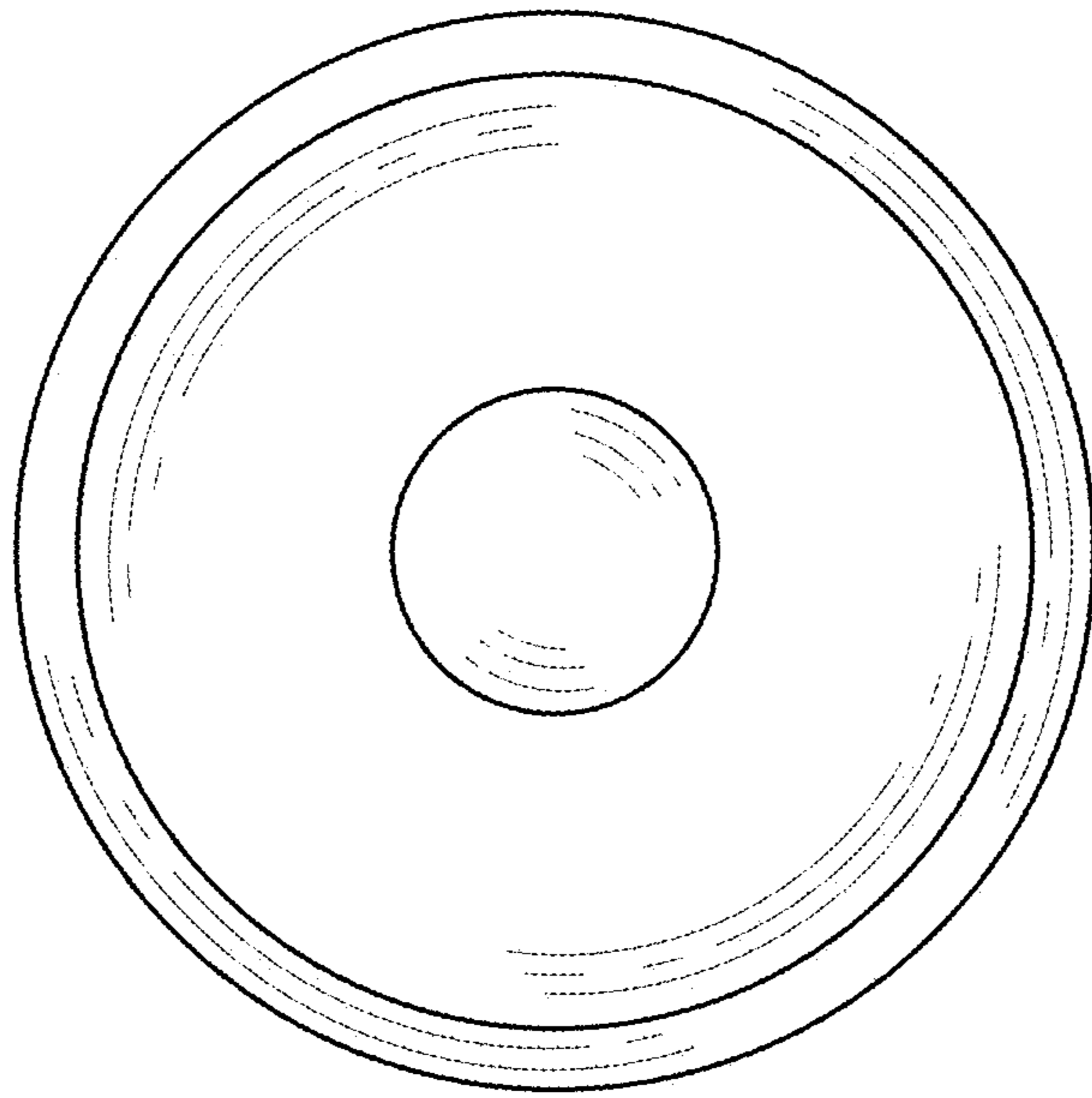

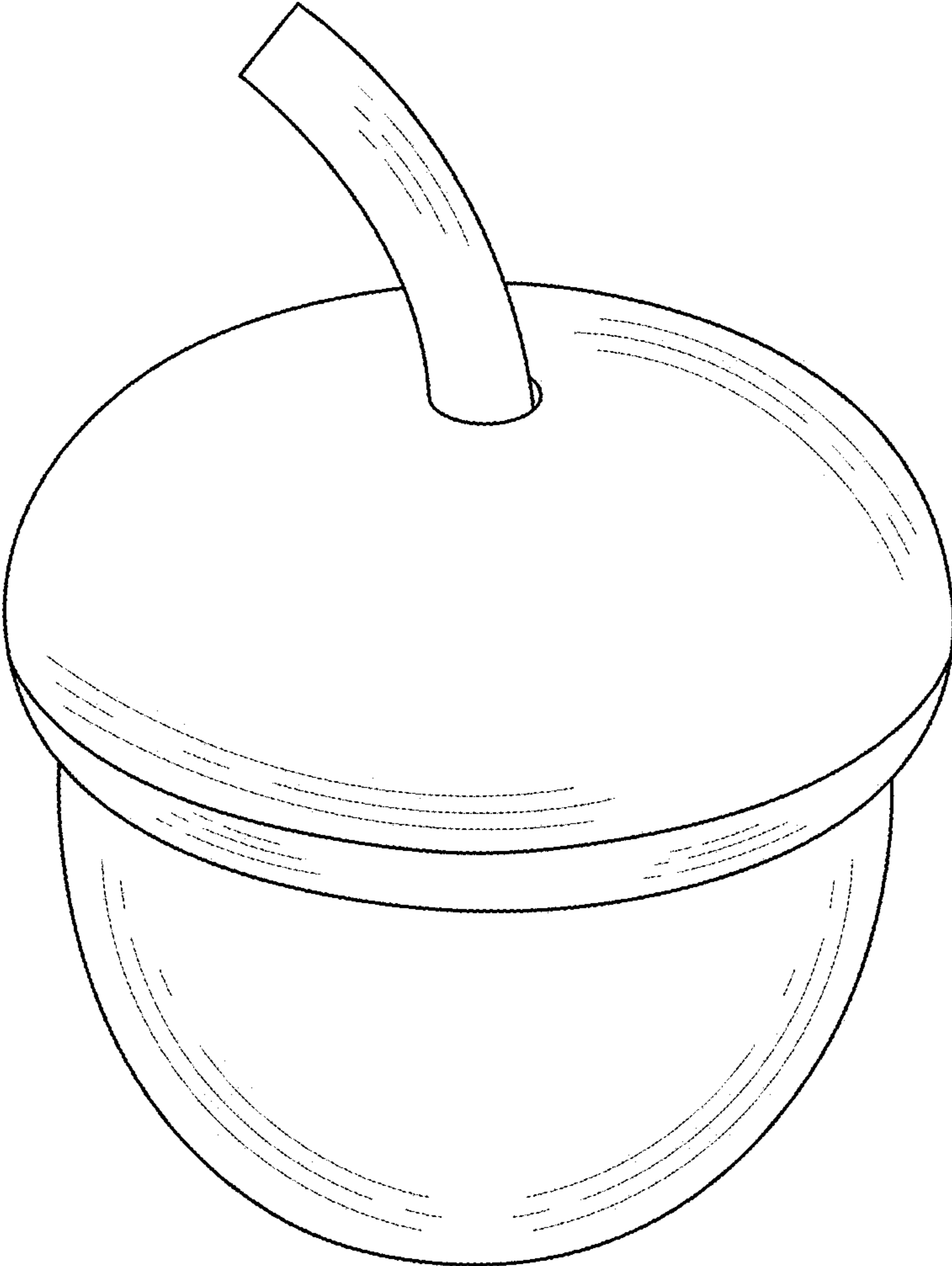
