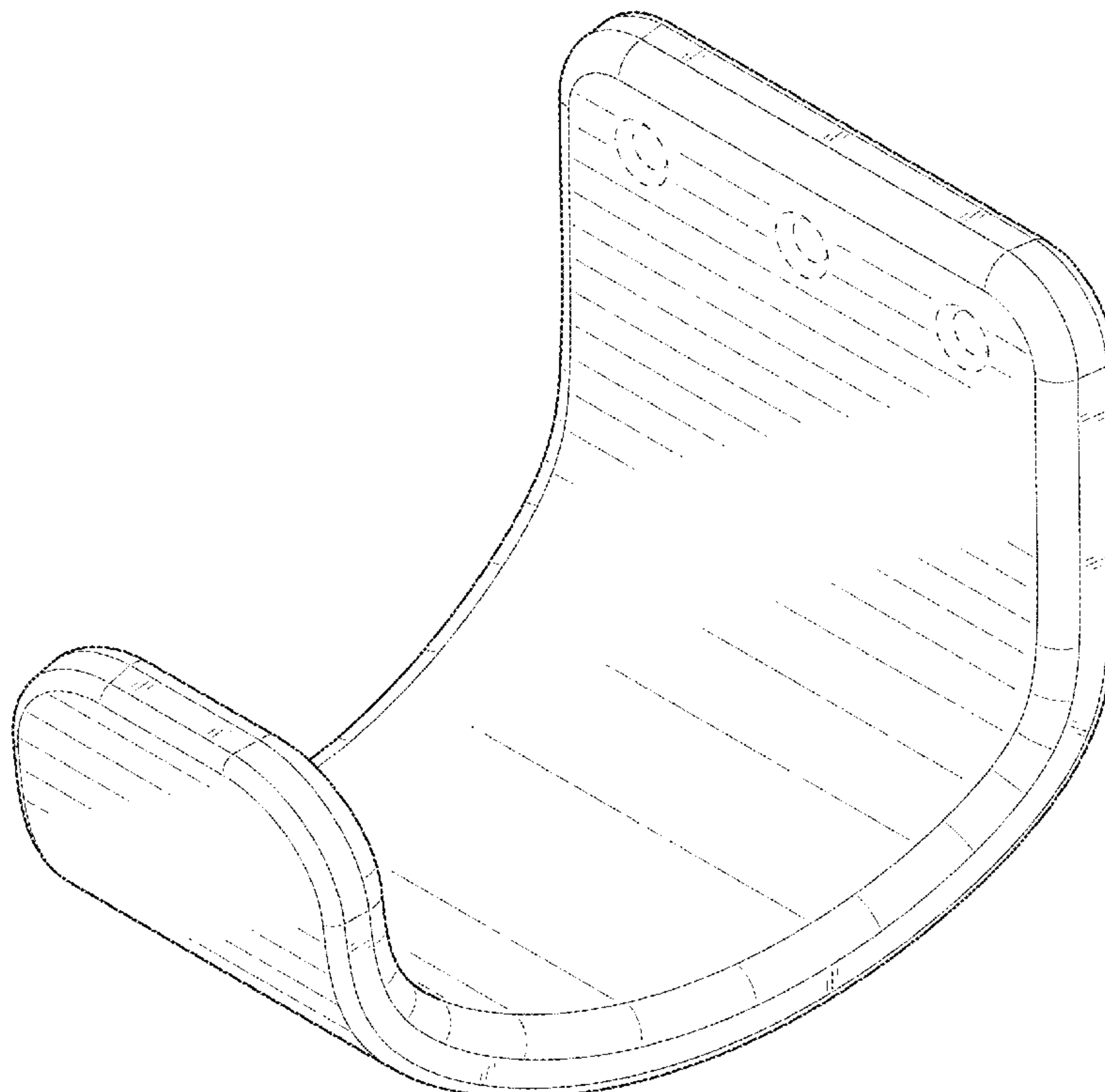
(57) **CLAIM**

The ornamental design of a door pull, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of a door pull in accordance with the present application;  
FIG. 2 is a front elevational view of the door pull of FIG. 1;  
FIG. 3 is a rear elevational view of the door pull of FIG. 1;  
FIG. 4 is a side elevational view of a first side of the door pull of FIG. 1;  
FIG. 5 is a side elevational view of a second side of the door pull of FIG. 1;  
FIG. 6 is a top plan view of the door pull of FIG. 1; and  
FIG. 7 is a bottom plan view of the door pull of FIG. 1.  
The broken lines shown represent portions of the door pull that form no part of the claimed design.

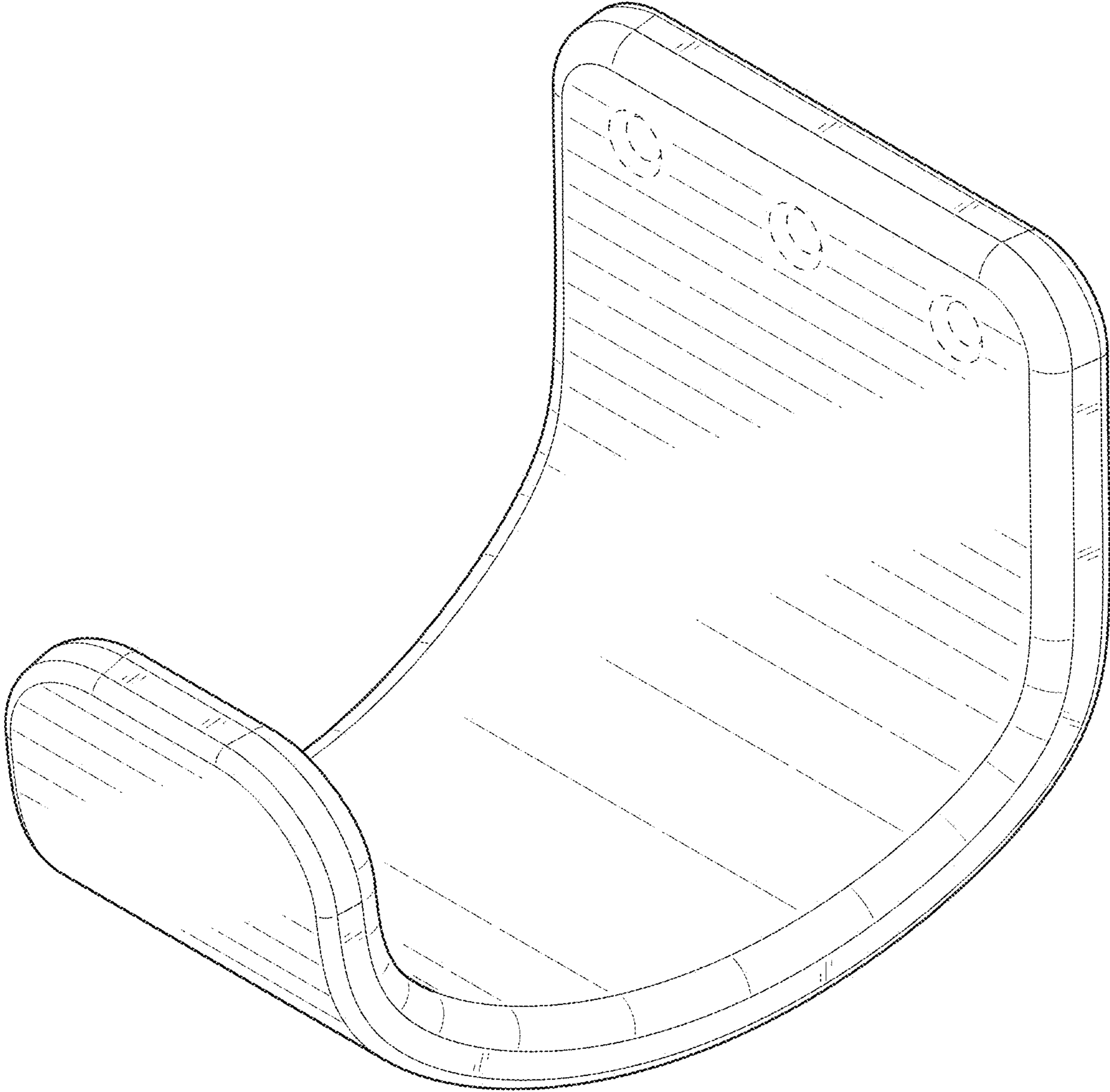

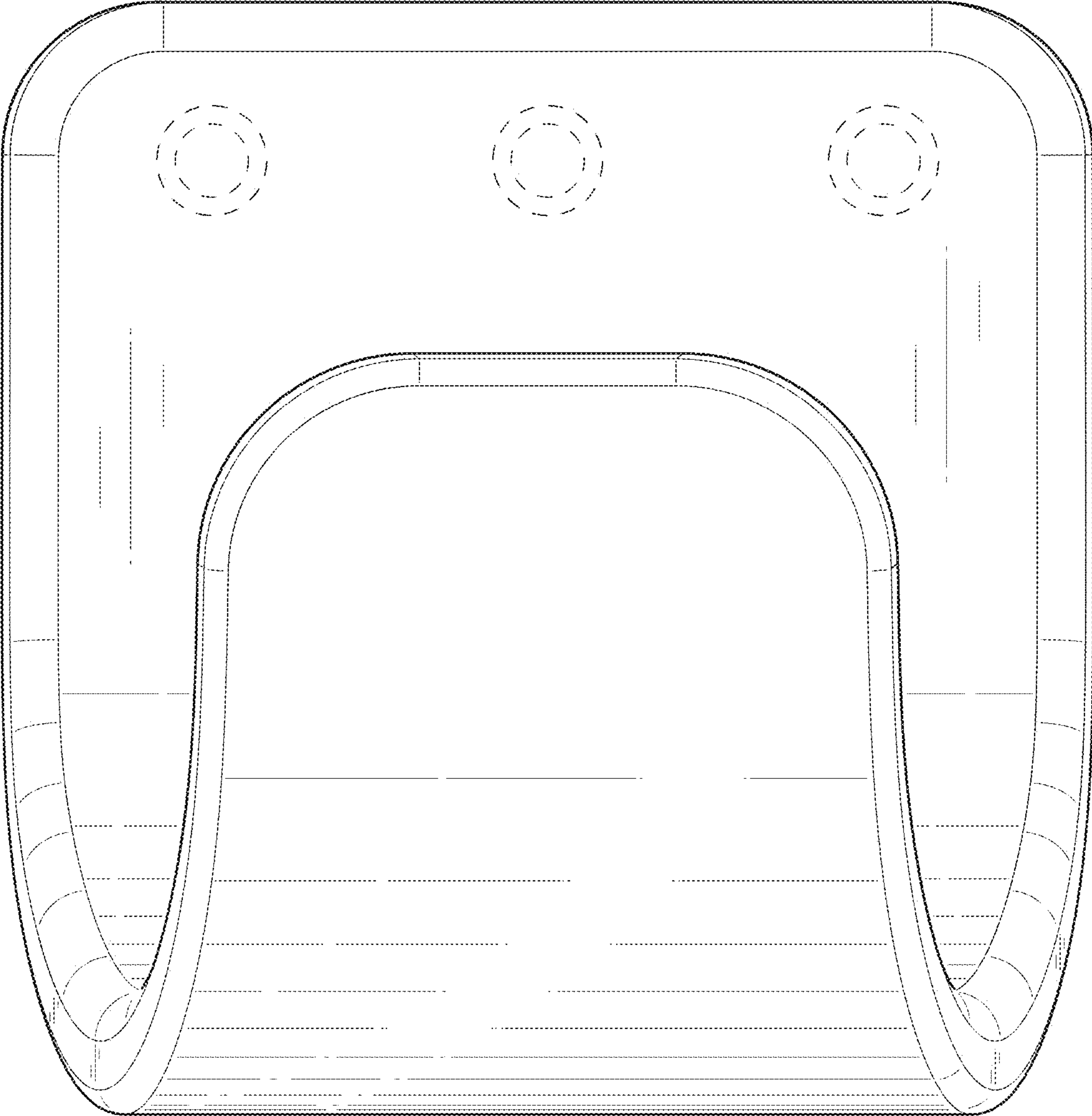

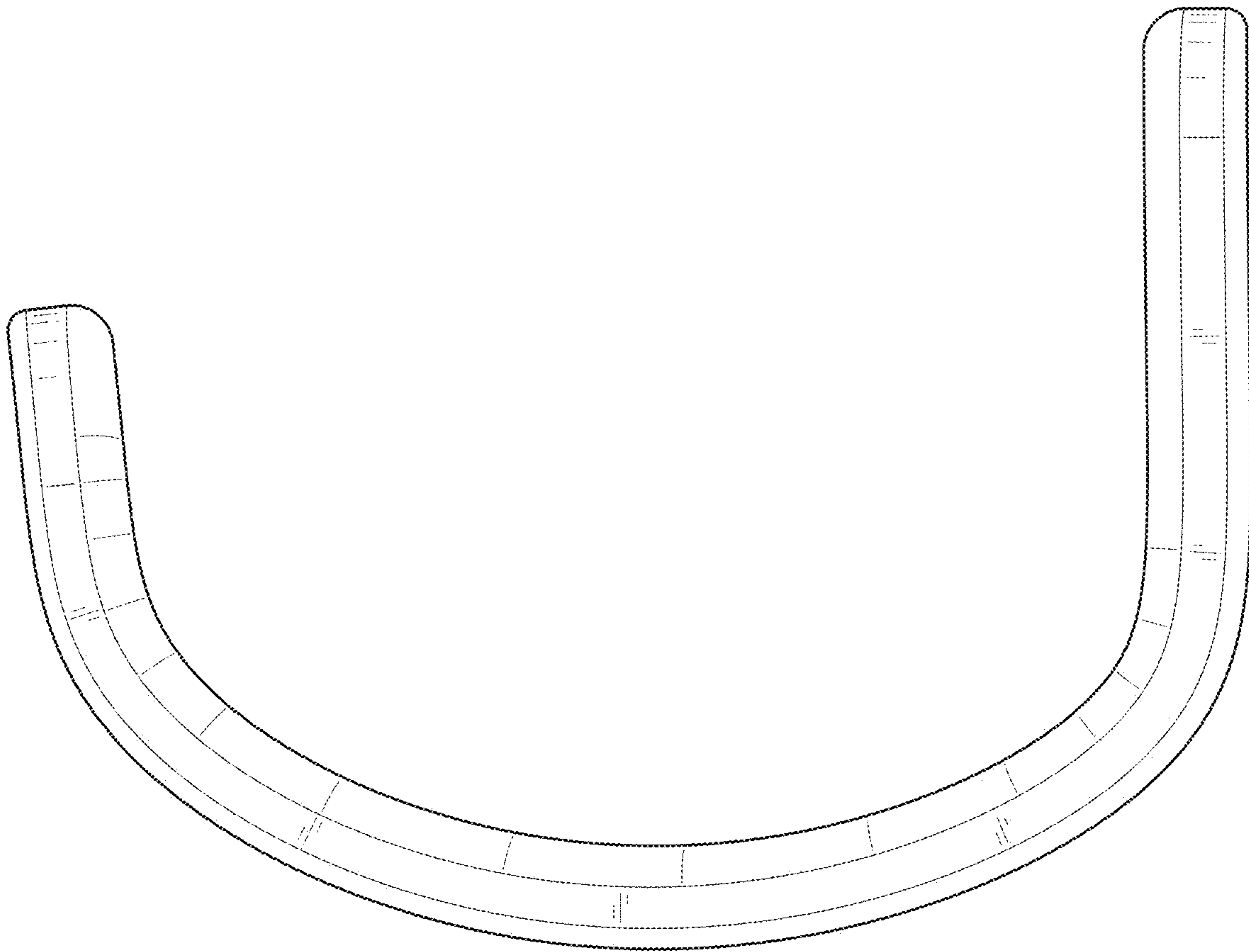

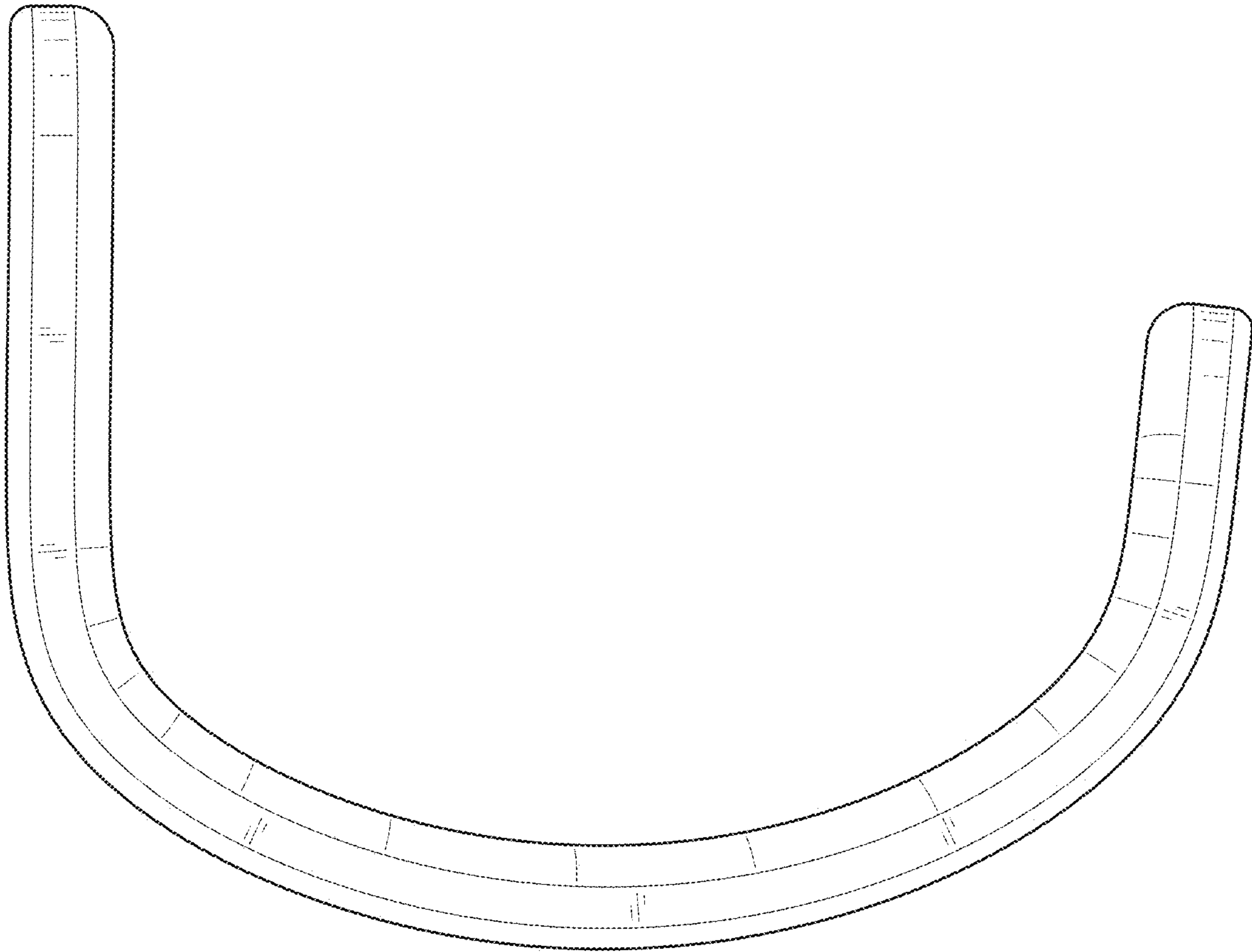

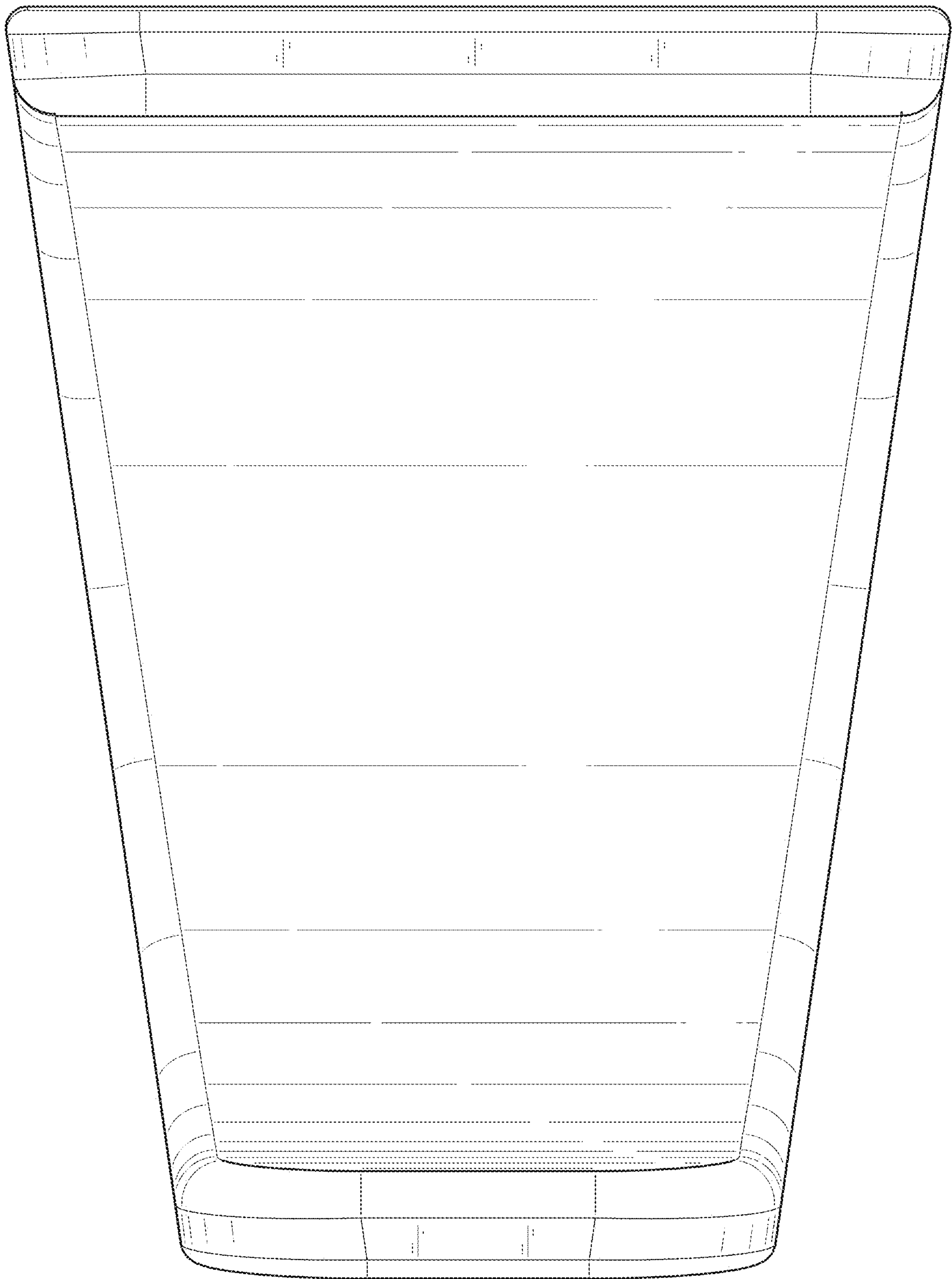

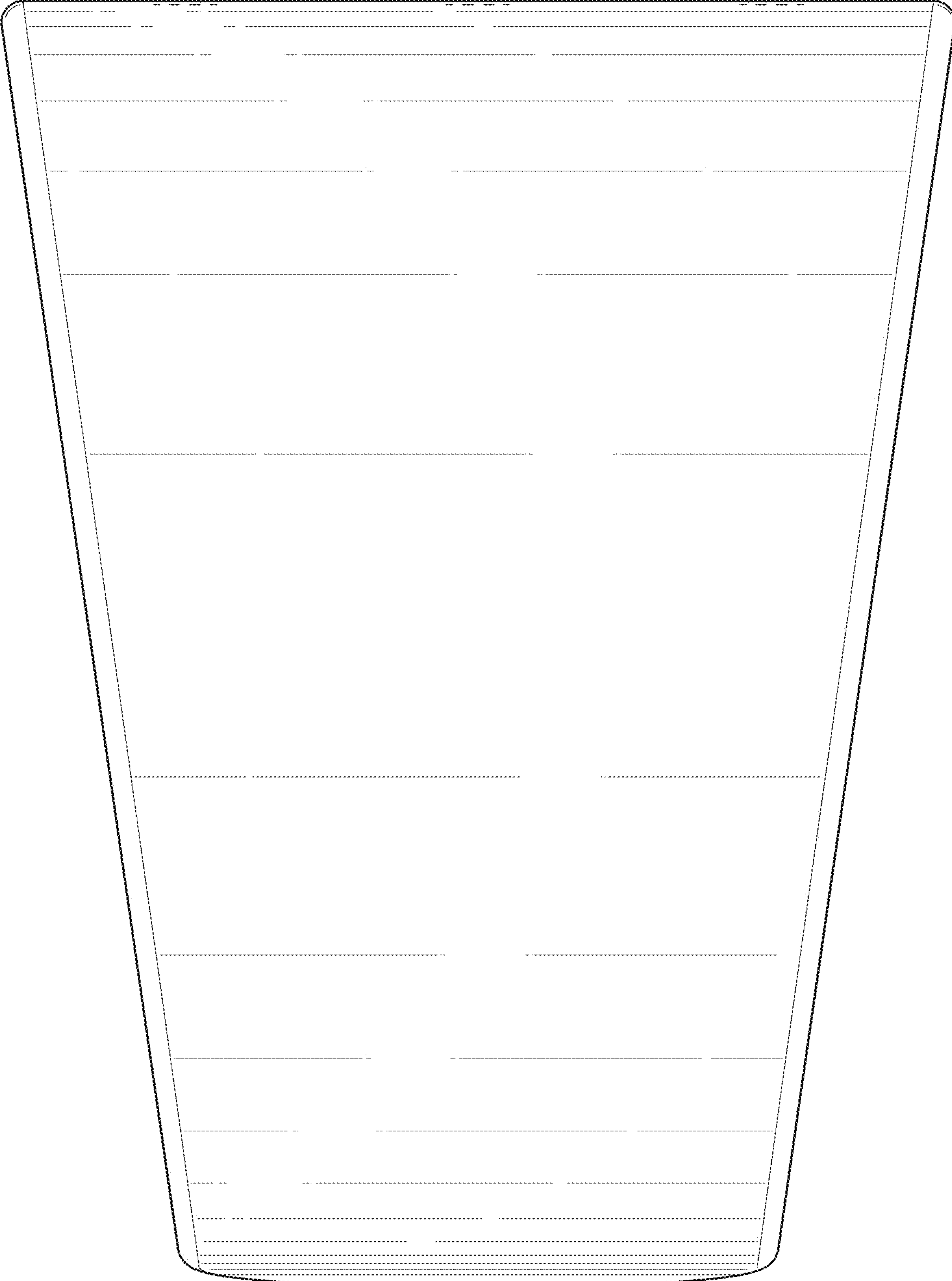
