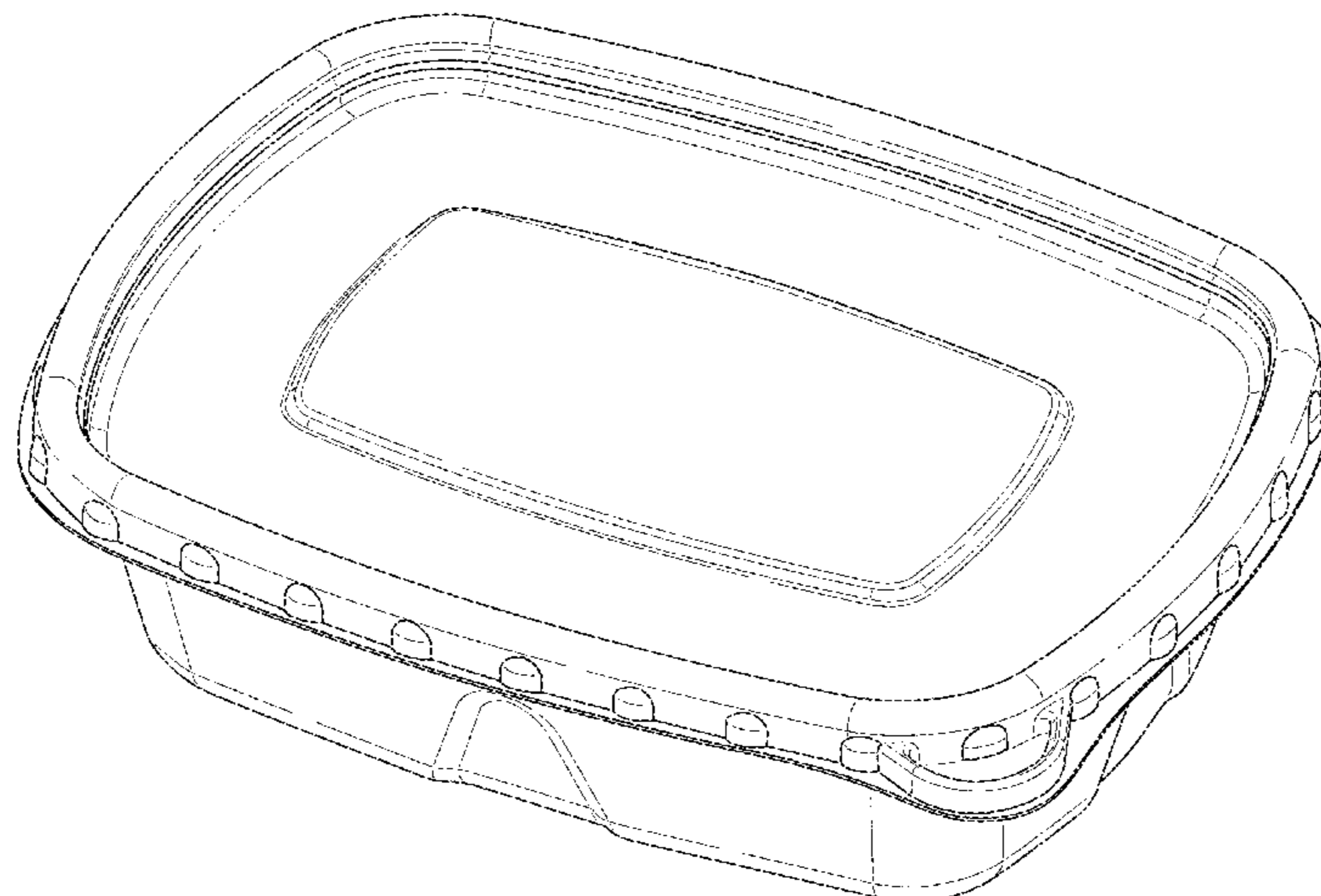

DESCRIPTION

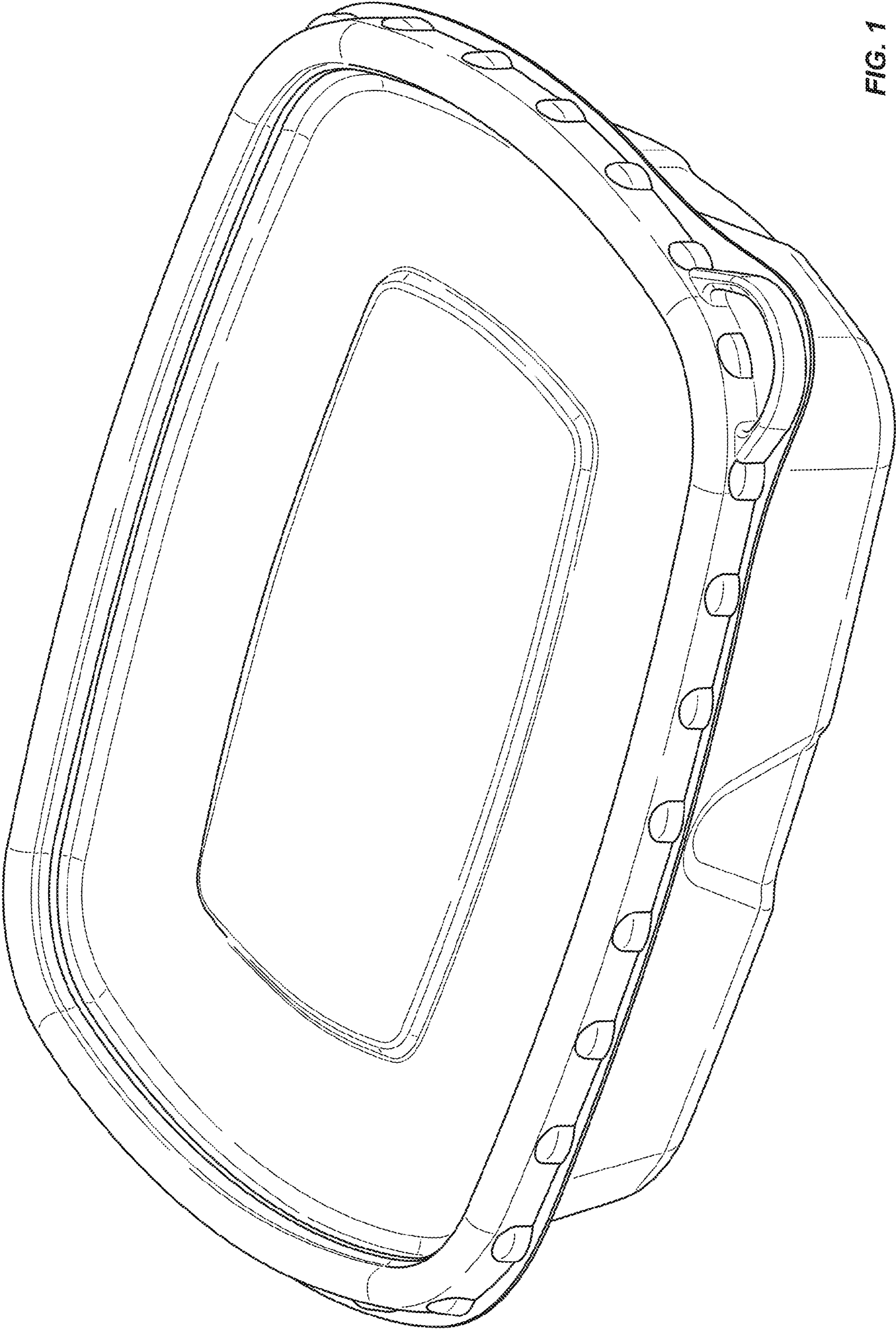

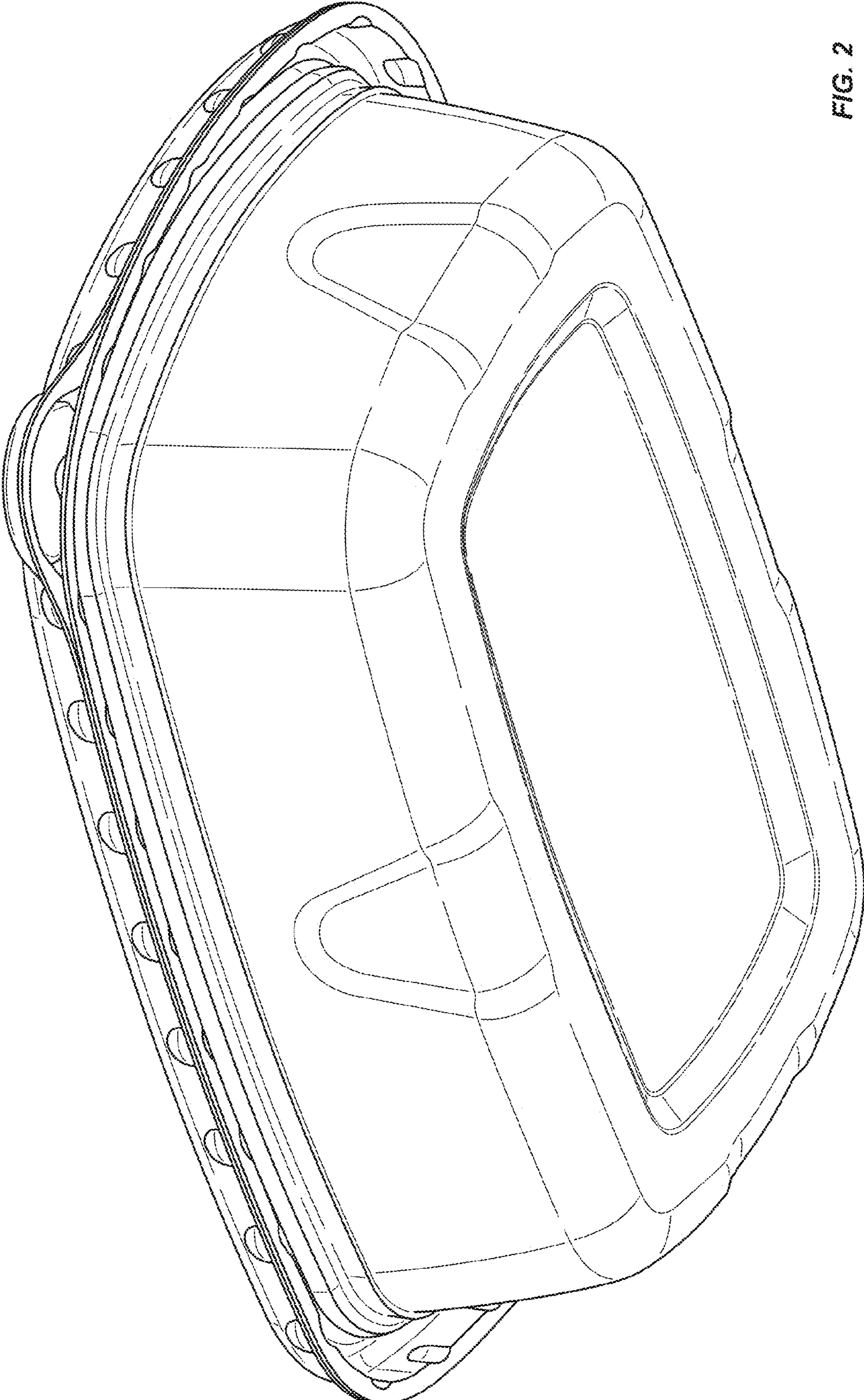

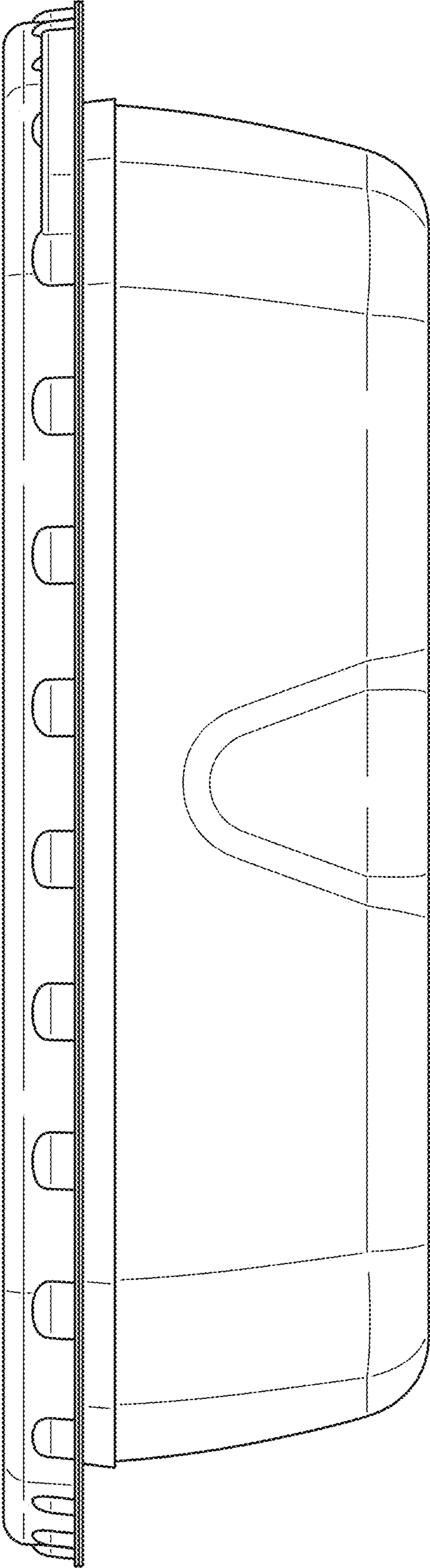

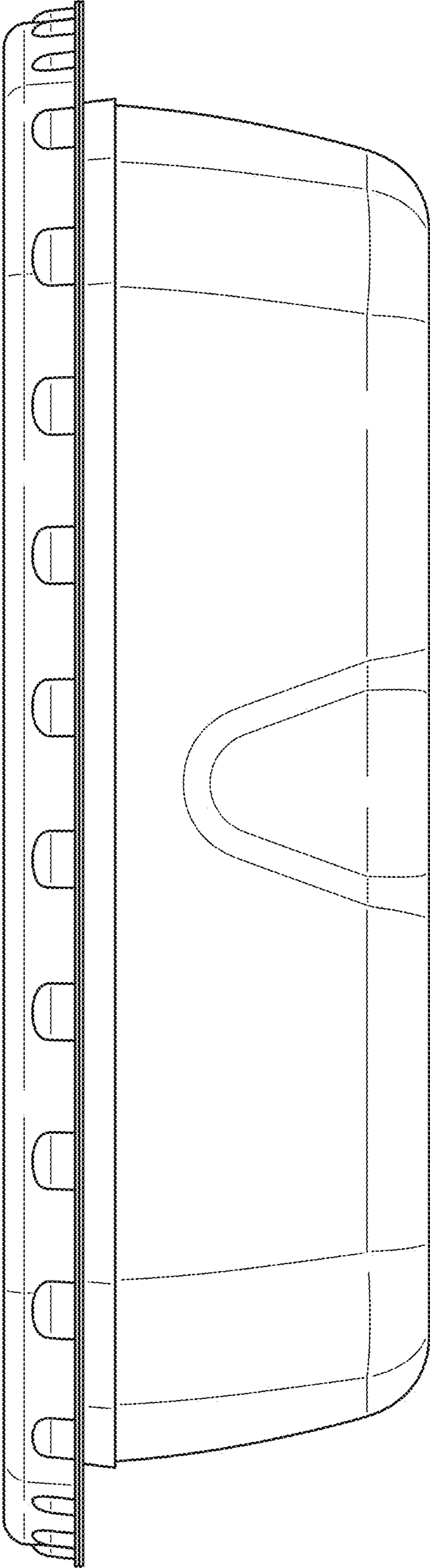

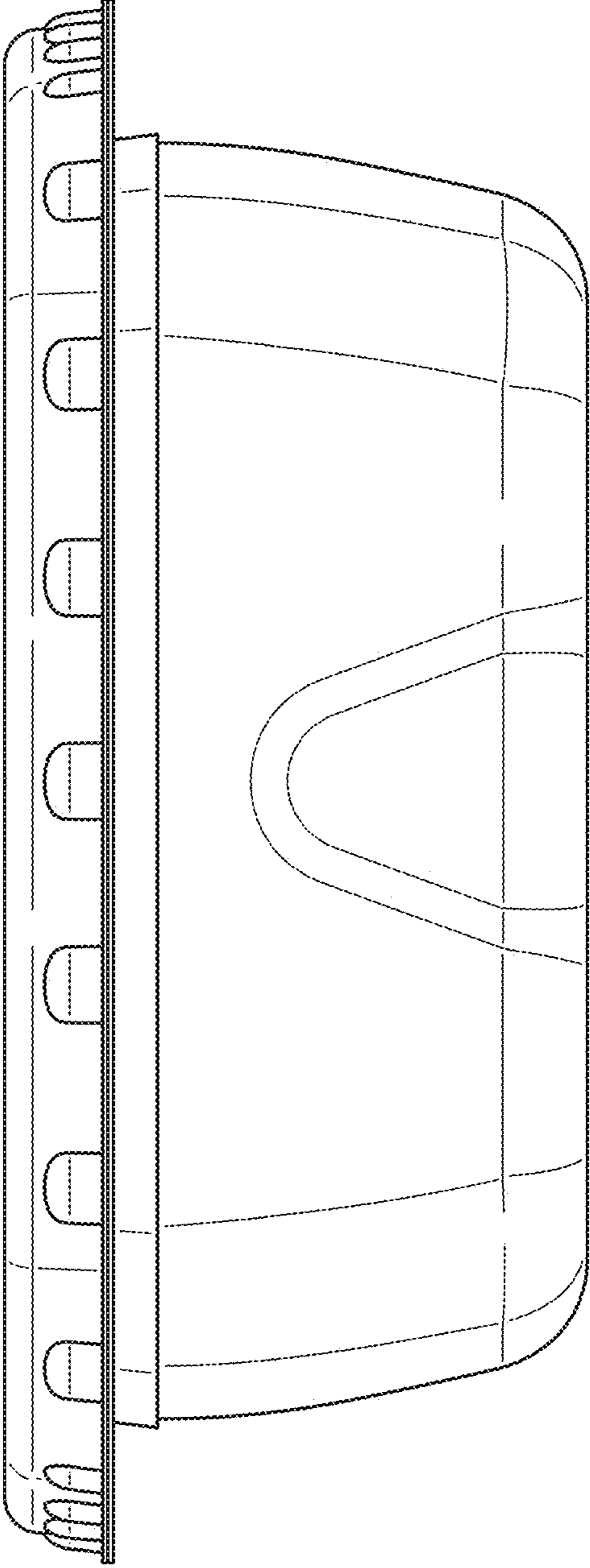

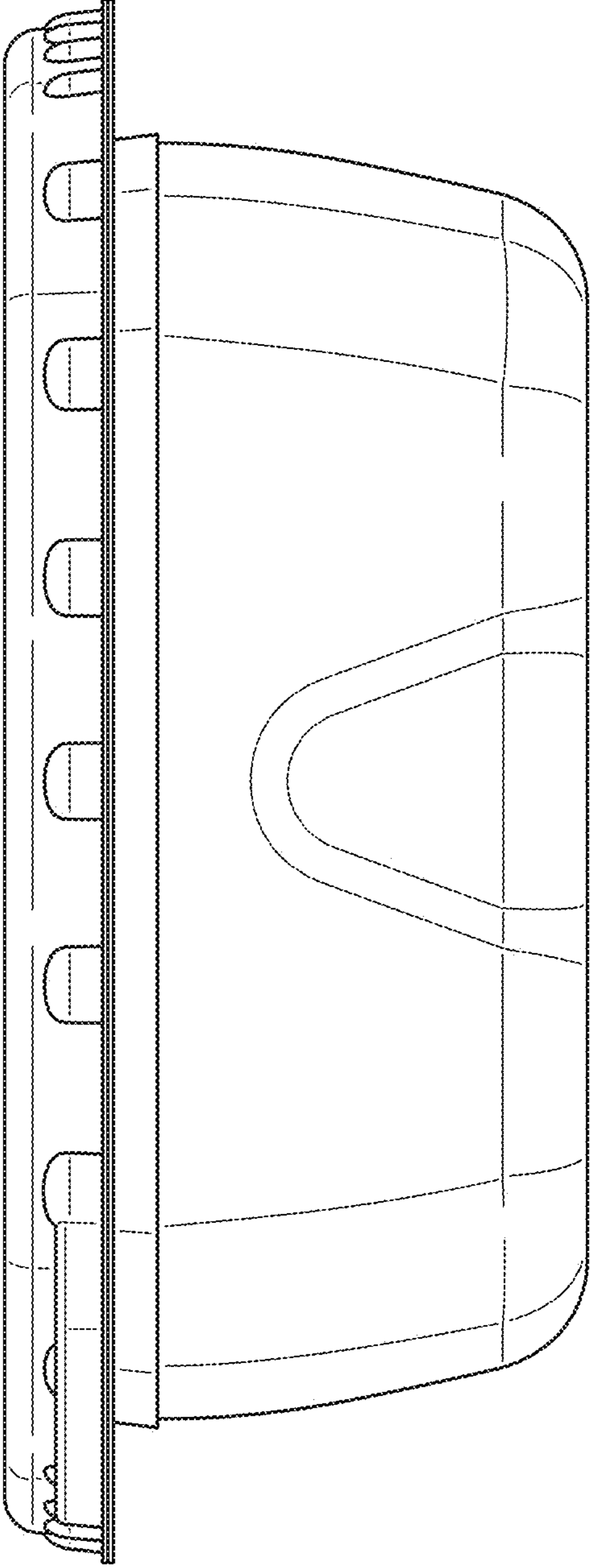

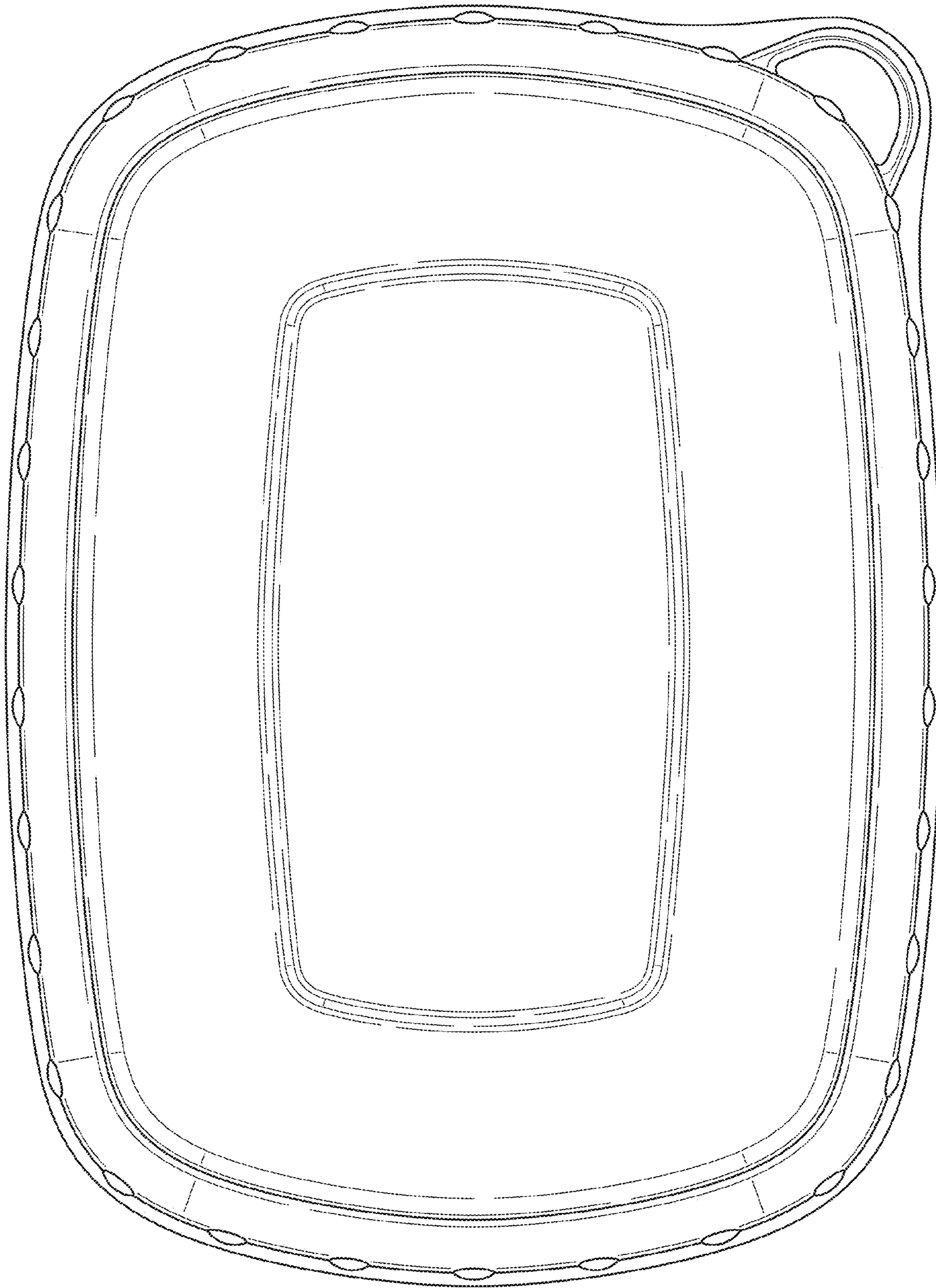

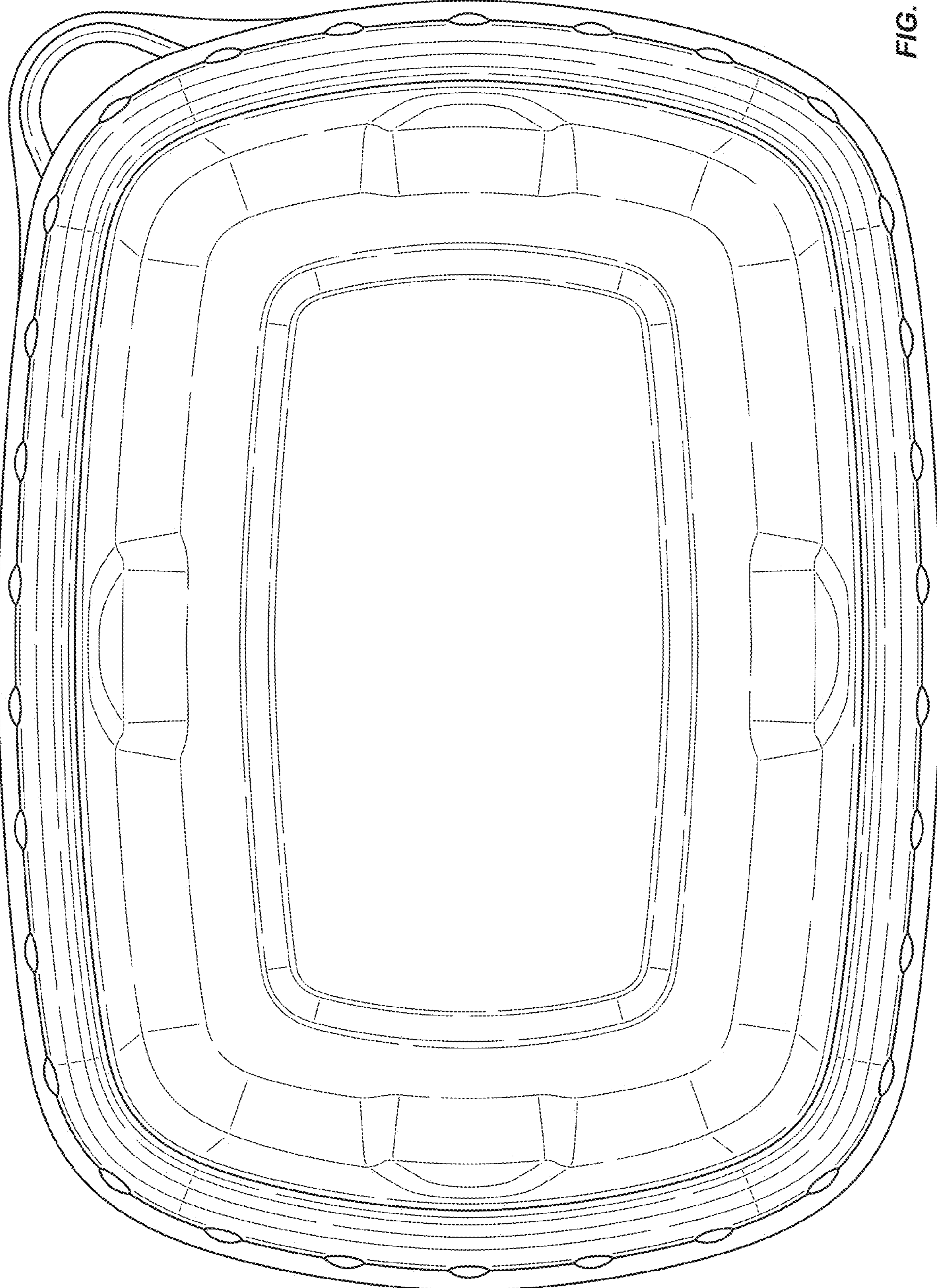
