(57) **CLAIM**

The ornamental design for a game box, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a game box showing my new design;

FIG. 2 is a front elevation view of the game box of FIG. 1, the rear elevation view being identical to the front elevation view;

FIG. 3 is a top plan view of the game box of FIG. 1;

FIG. 4 is a bottom plan view of the game box of FIG. 1;

FIG. 5 is a perspective exploded view of the game box of FIG. 1, showing the top half of the game box removed from the bottom half of the game box;

FIG. 6 is a front elevation exploded view of the game box of FIG. 1, showing the top half of the game box removed from the bottom half of the game box;

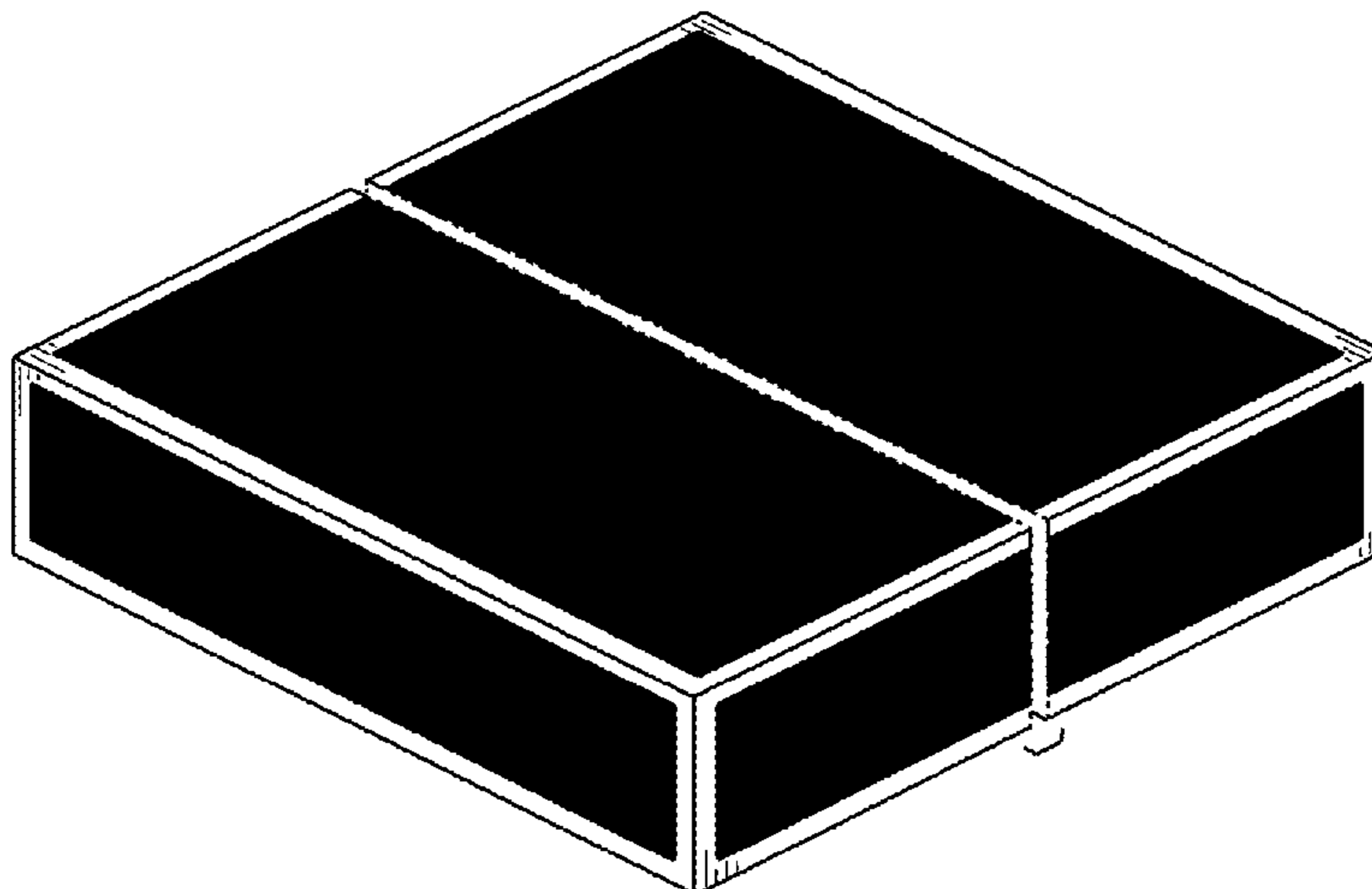
FIG. 7 is a top plan view of the top half of the game box of FIG. 1 in a flattened configuration;

FIG. 8 is a bottom plan view of the bottom half of the game box of FIG. 1 in a flattened configuration; and,

FIG. 9 is a right side elevation view of the game box, the left side elevation view being identical to the right elevation view.

The dashed lines, the areas within them, and the areas bounded by dashed lines and solid lines depict portions of the game box that form no part of the claimed design. The dot-dash lines in the drawings depict the fold lines and form part of the claimed design. The dot-dot-dash lines in the drawings illustrate symbolic breaks. The appearance of any portion of the article between the break lines forms no part of the claimed design.

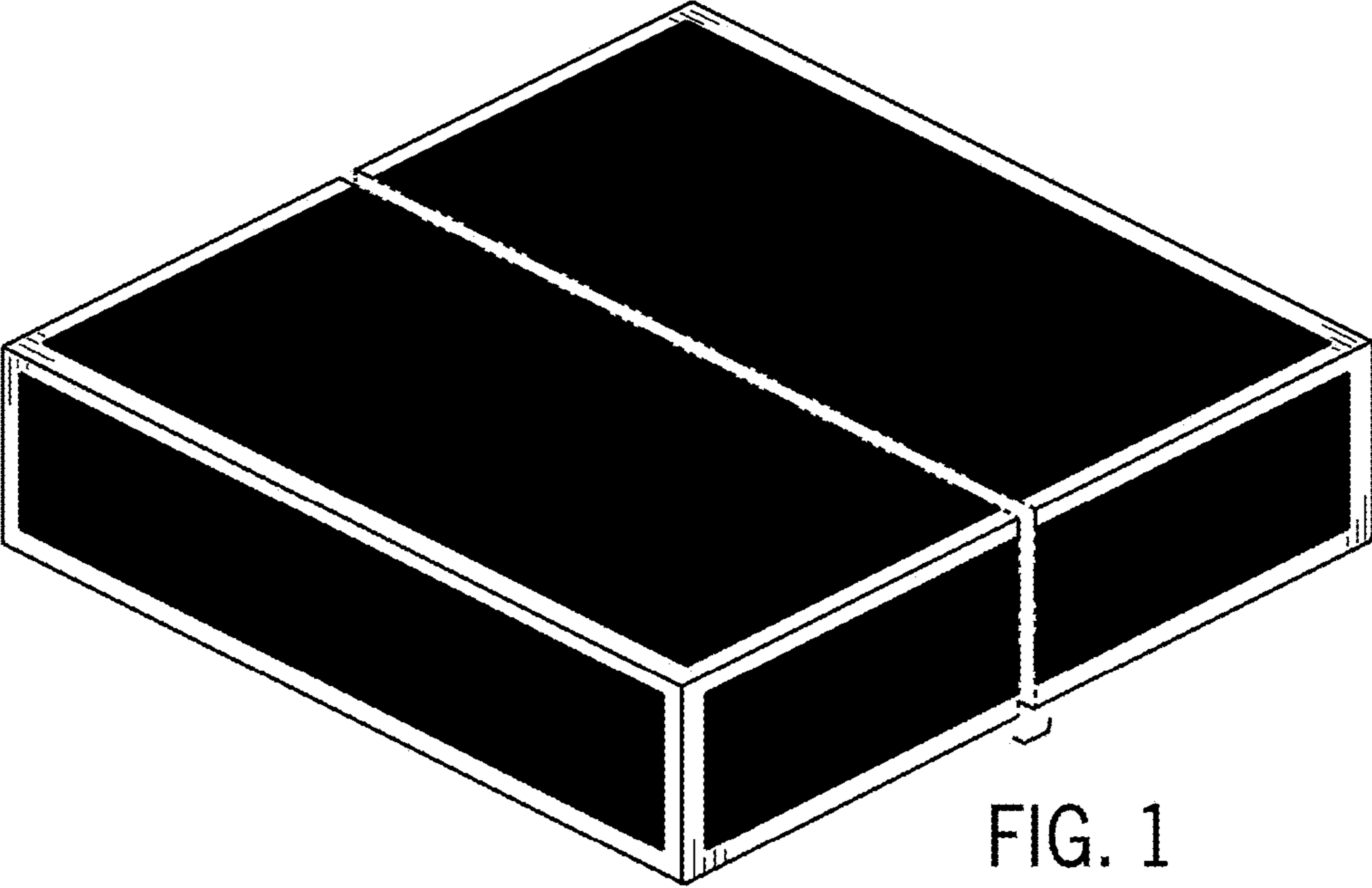

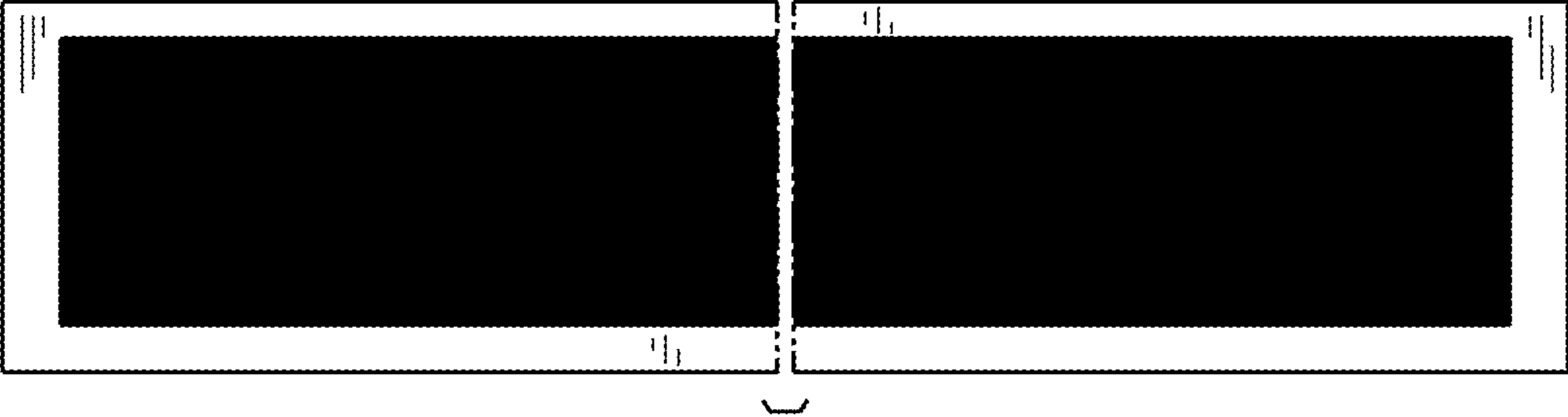

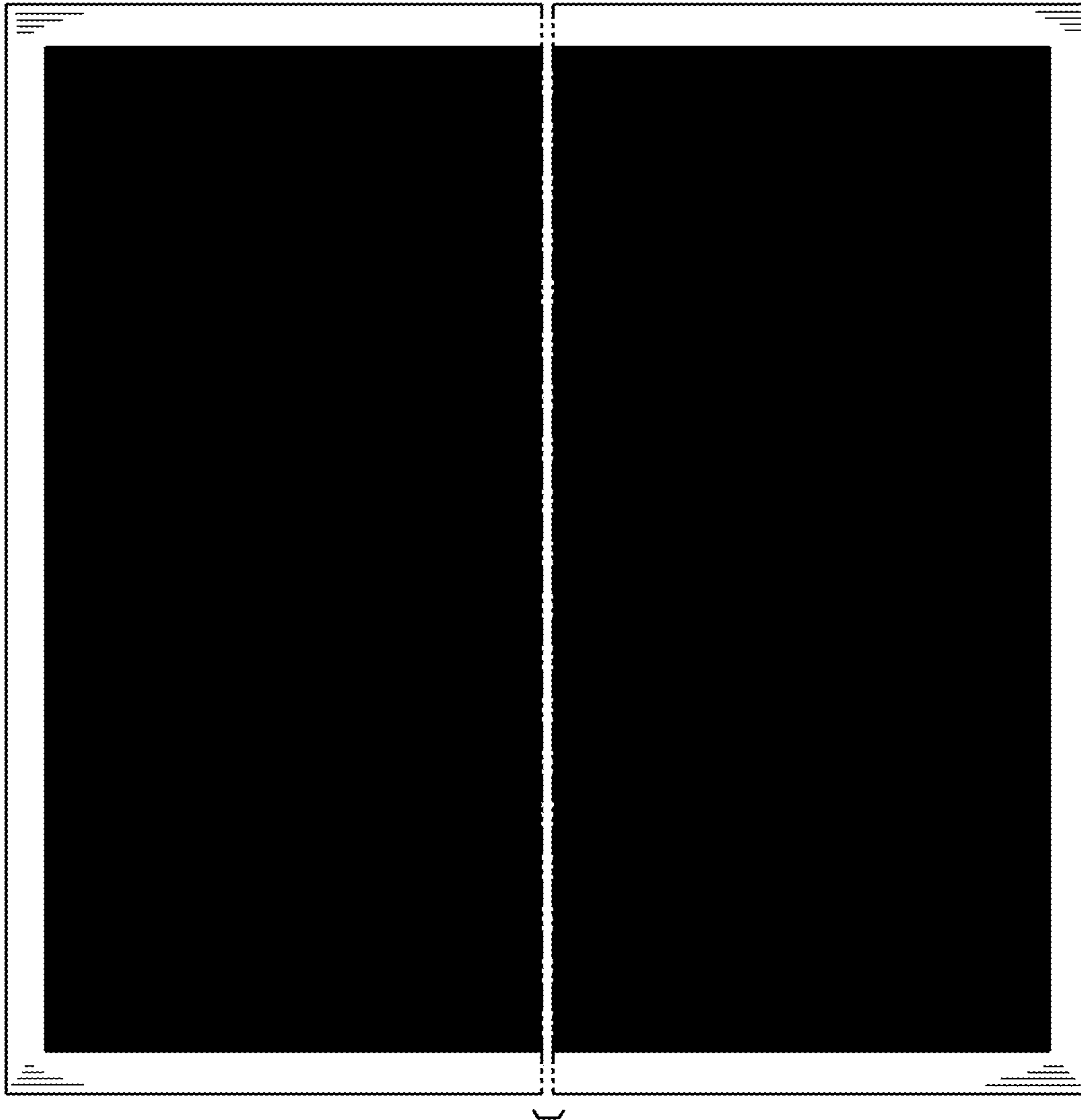

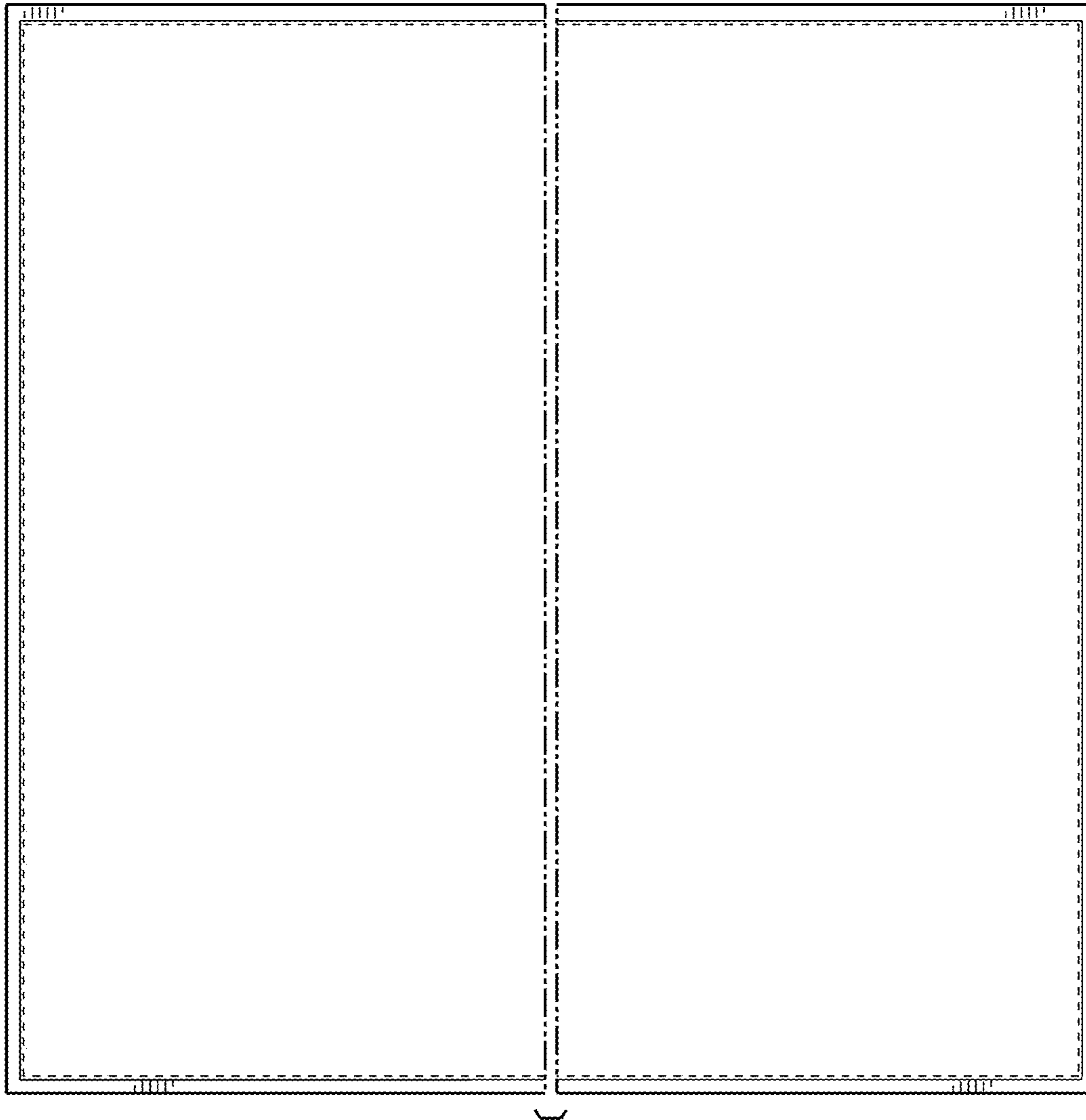

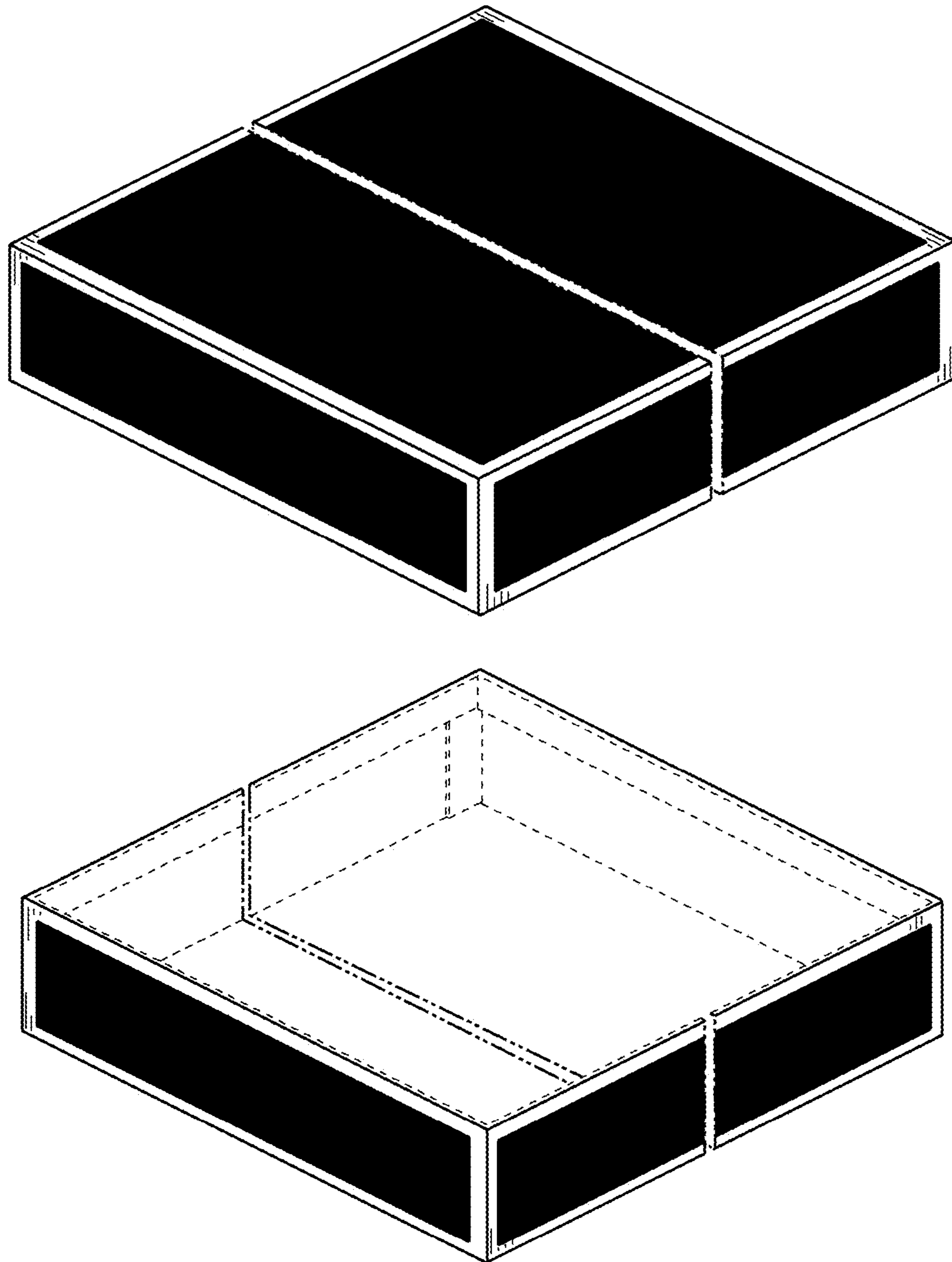

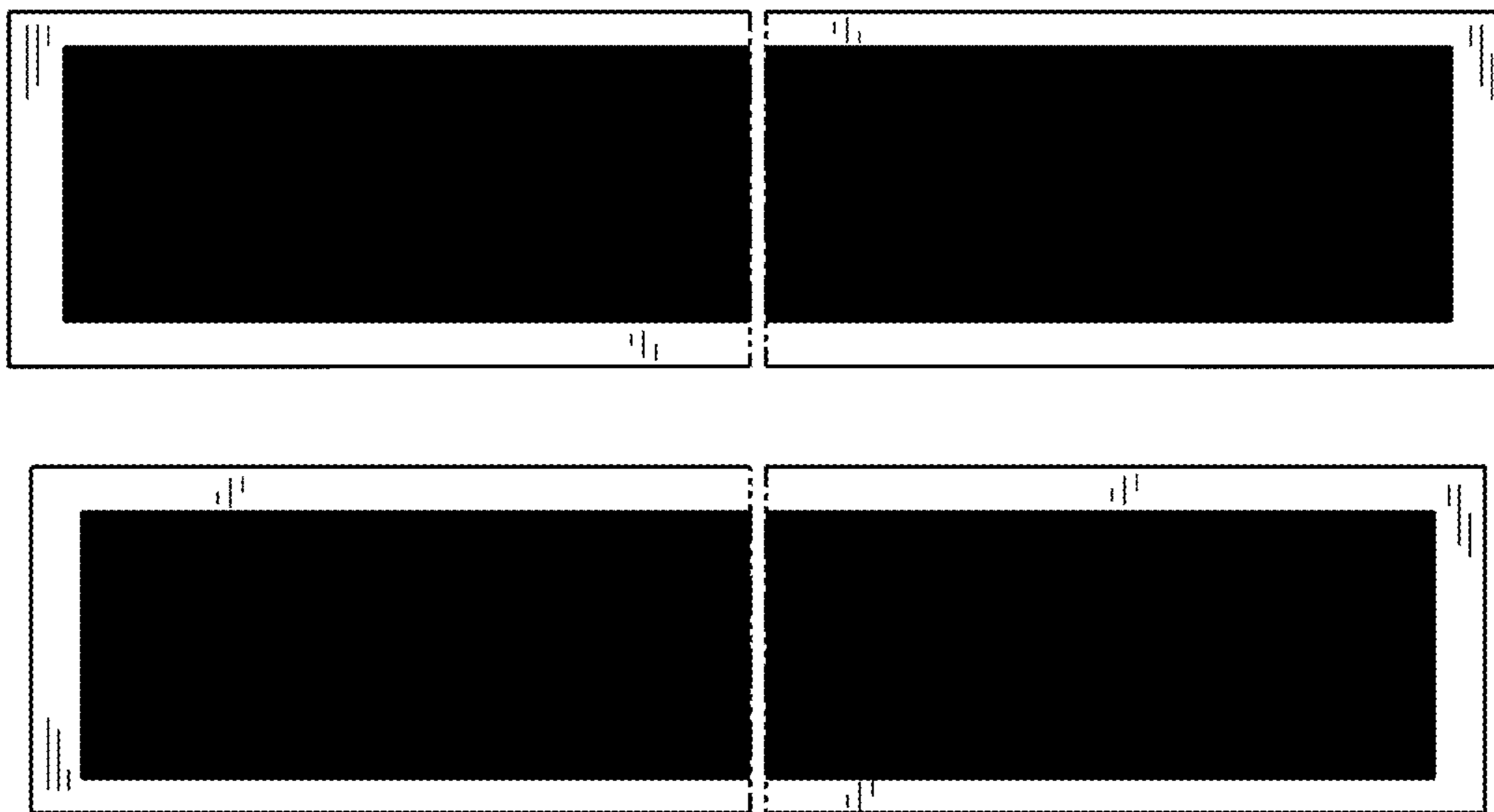

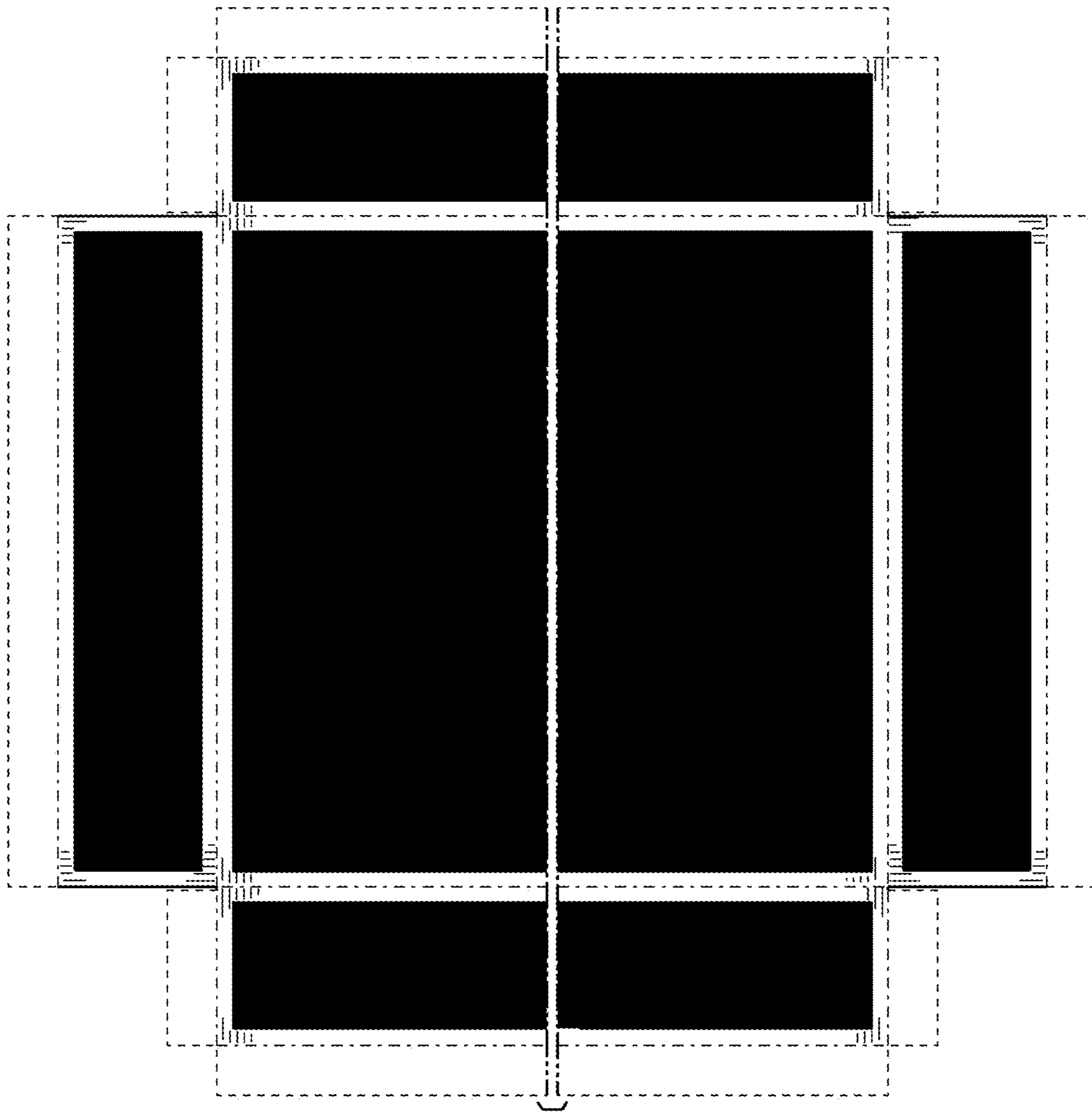

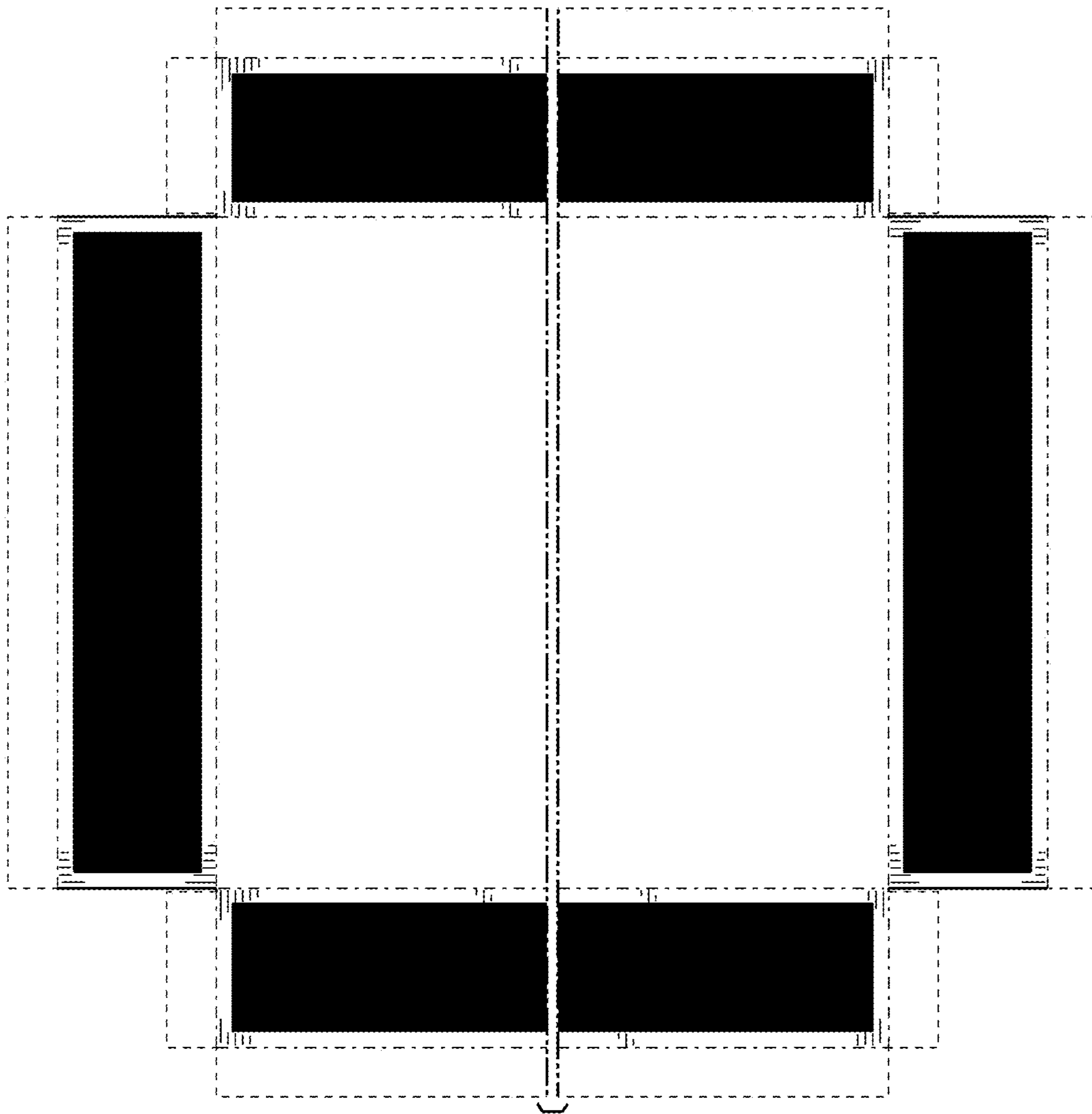

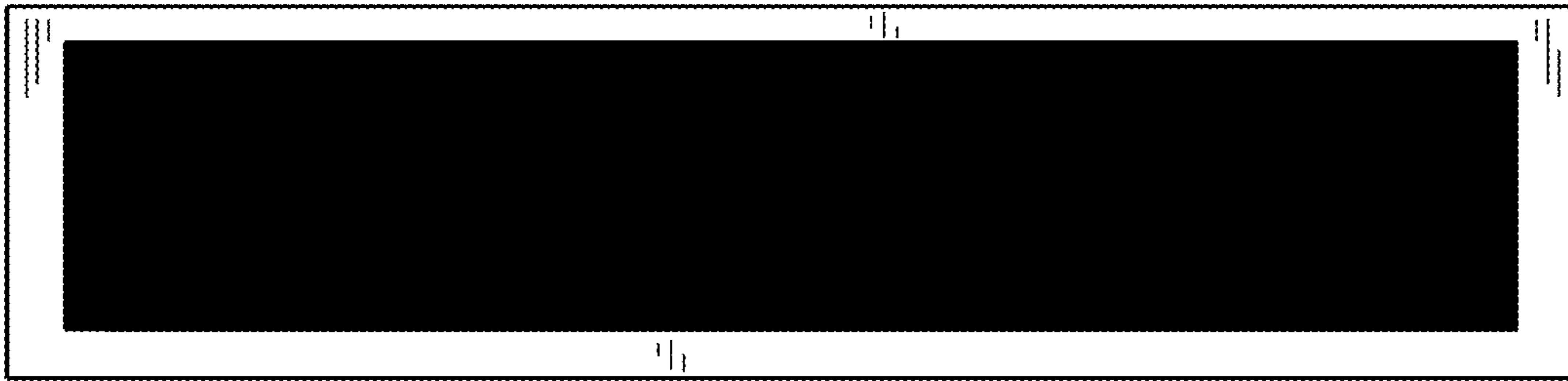
