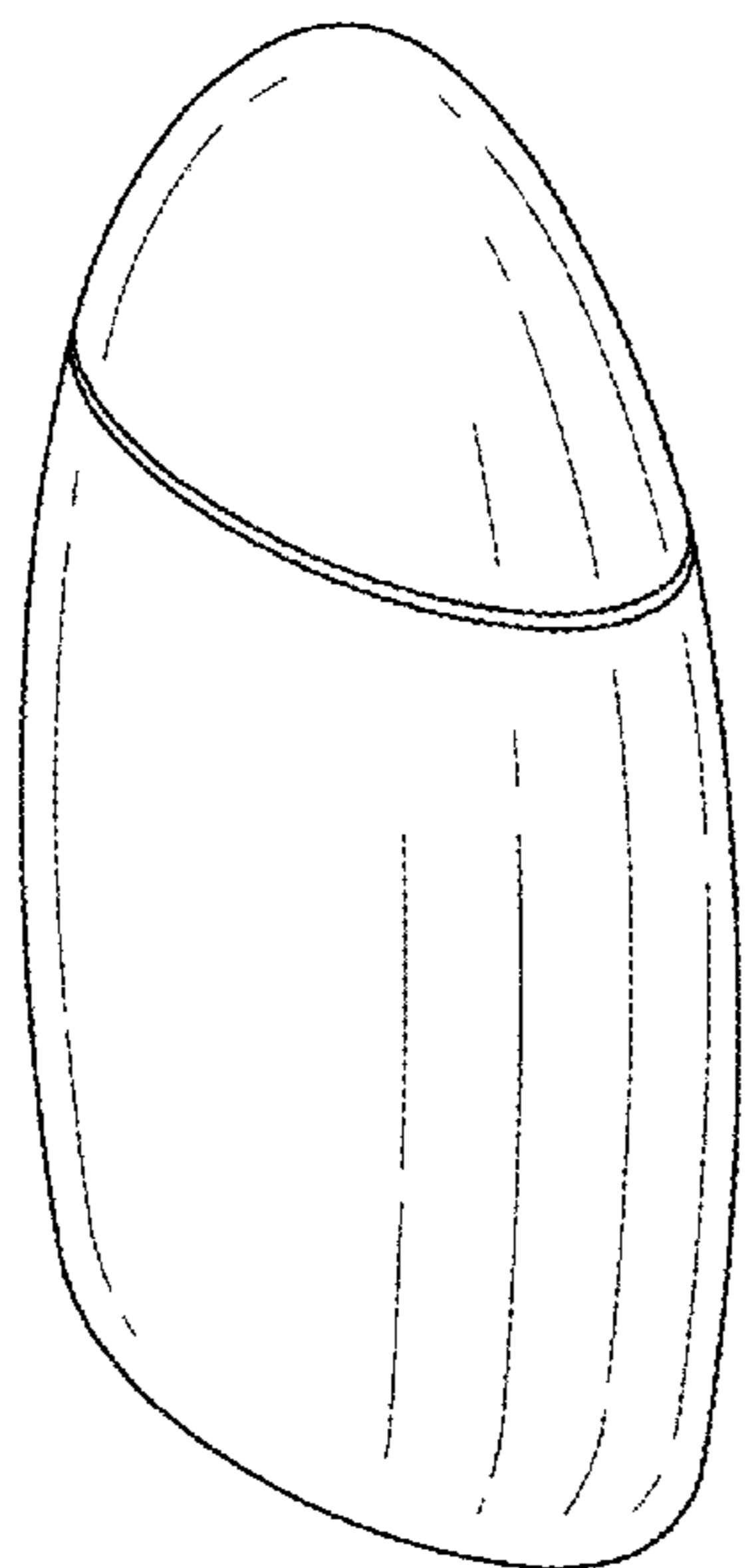

(57) **CLAIM**
The ornamental design for a container for cosmetics, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a container for cosmetics; FIG. 2 is a front side view of the container for cosmetics; FIG. 3 is a back side view of the container for cosmetics; FIG. 4 is a left side view of the container for cosmetics; FIG. 5 is a right side view of the container for cosmetics; FIG. 6 is a top side view of the container for cosmetics; and, FIG. 7 is a bottom side view of the container for cosmetics. The dot-dash boundary line in FIG. 7 defines the bounds of the claimed design and forms no part thereof.

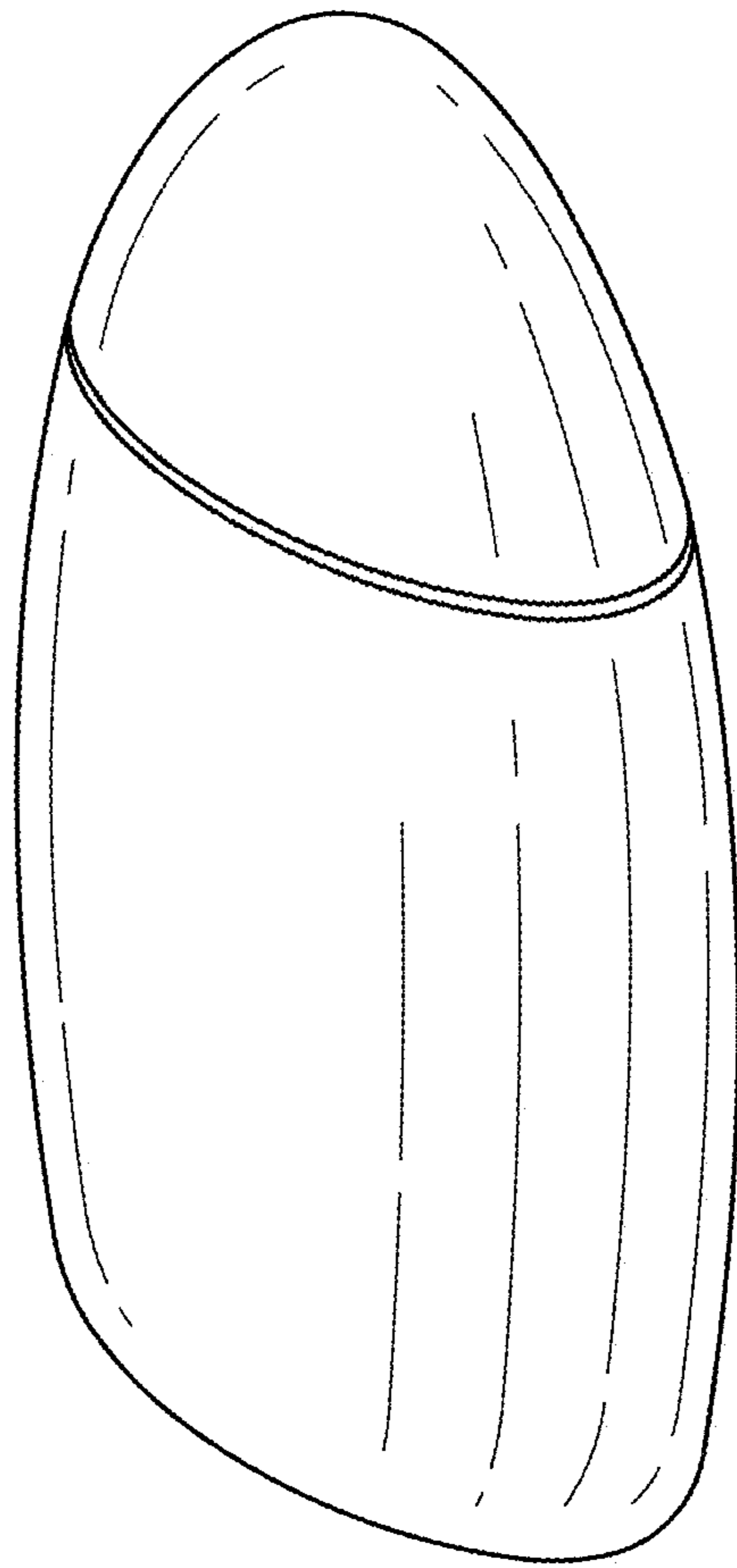

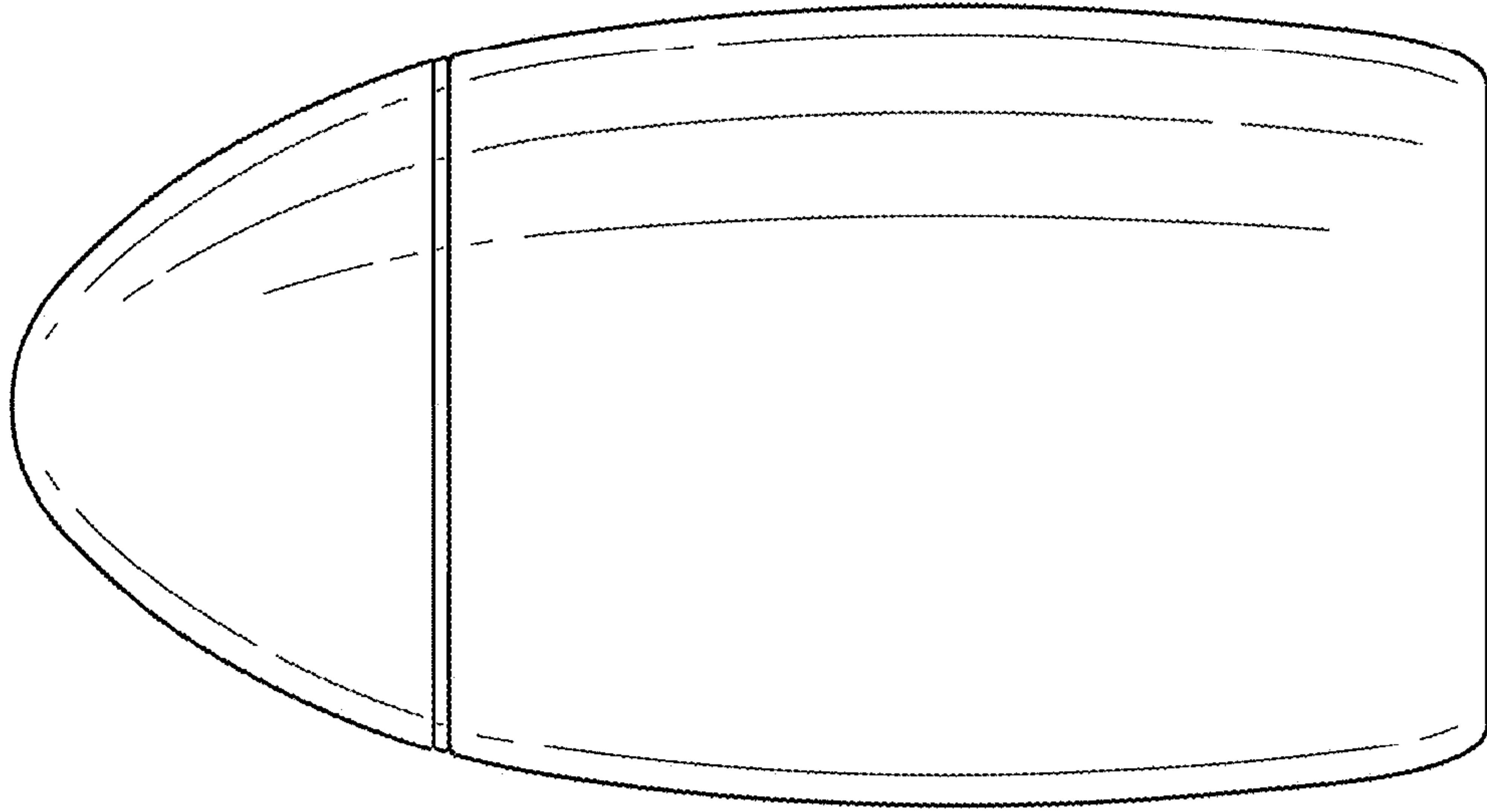

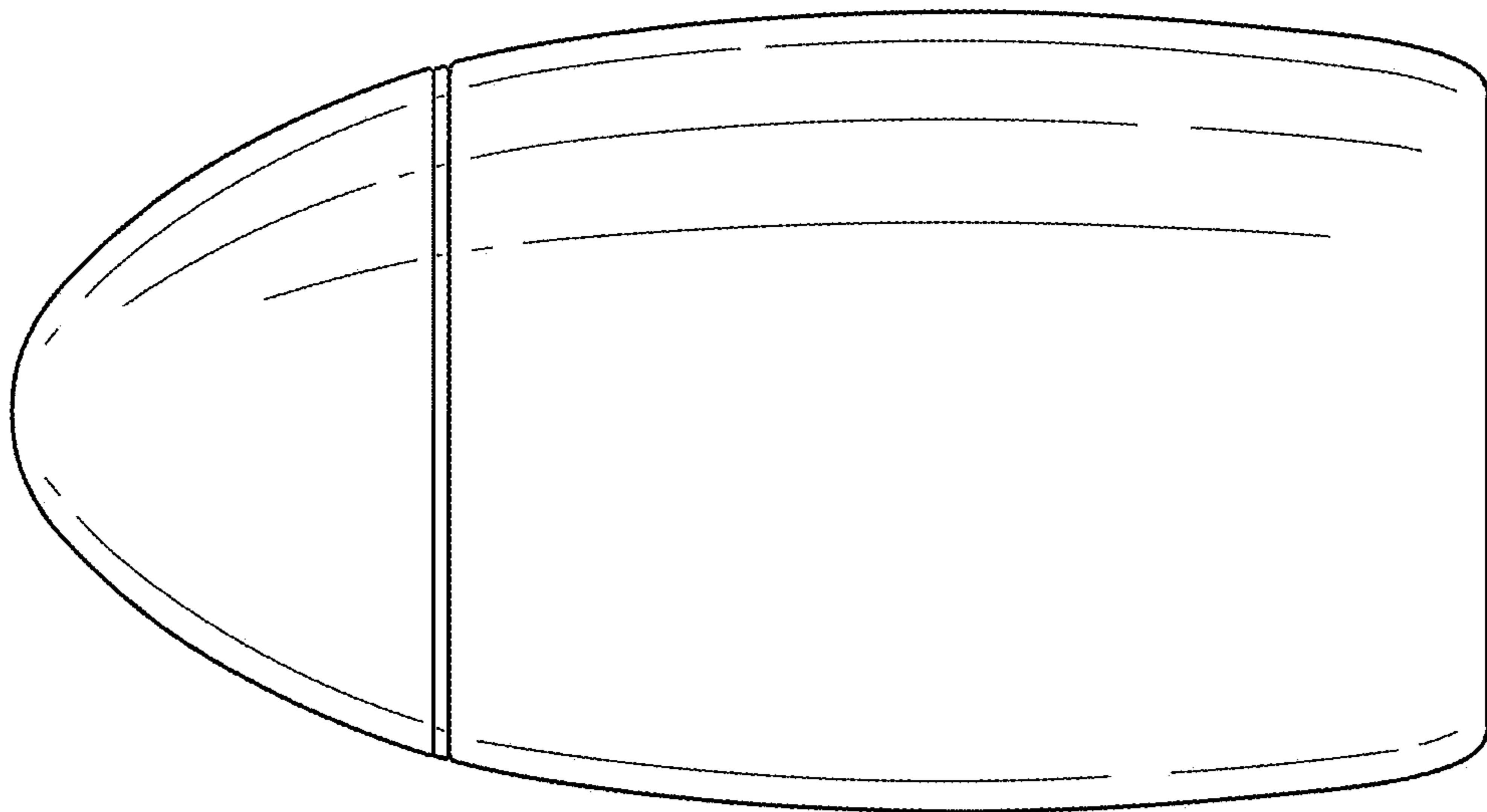

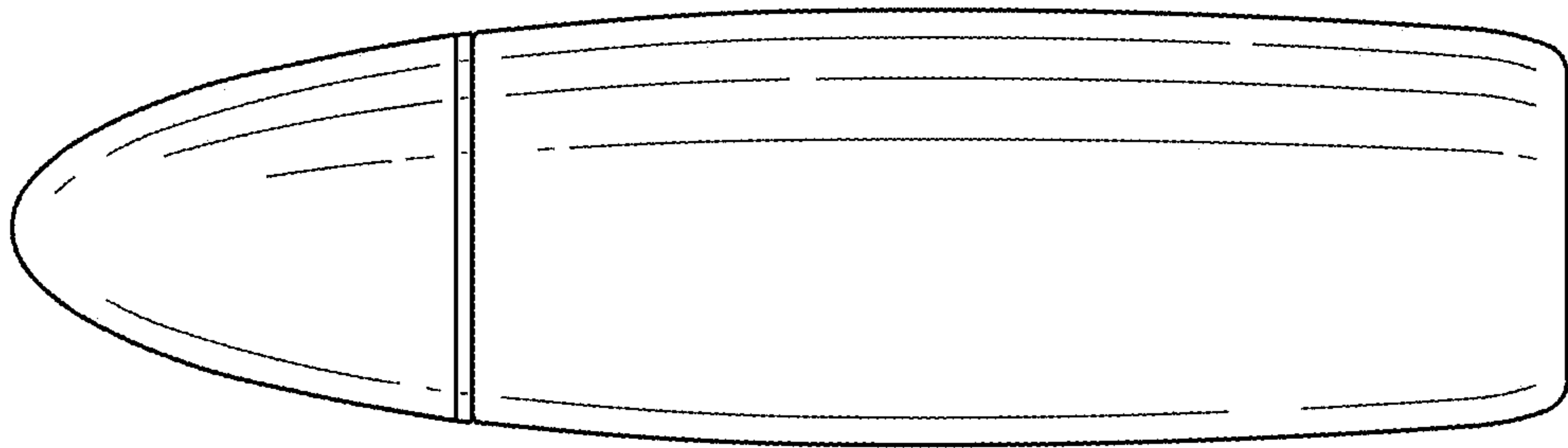

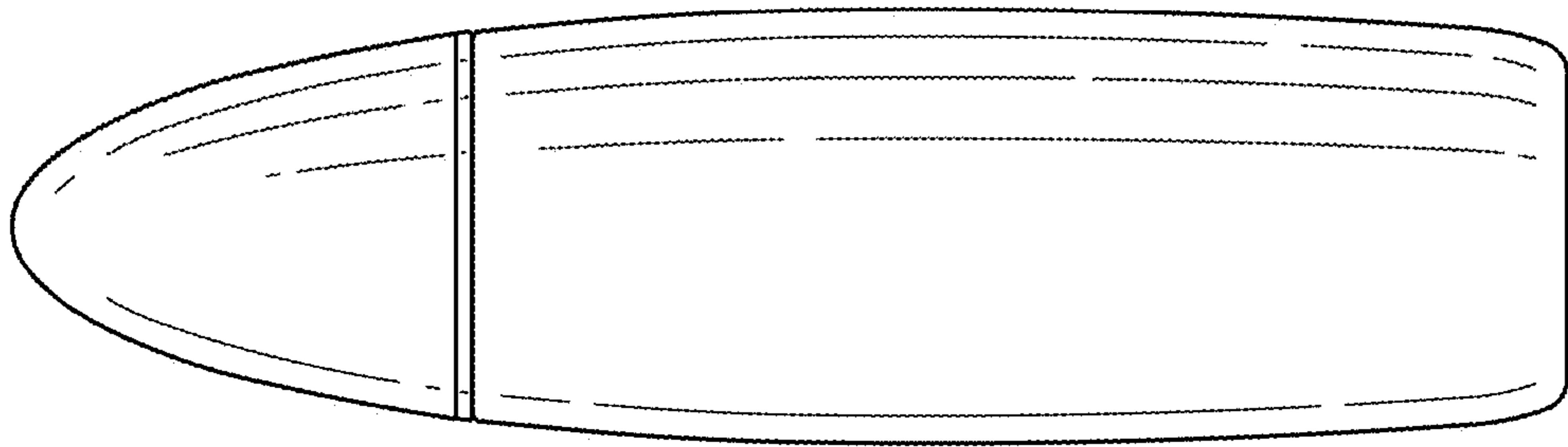

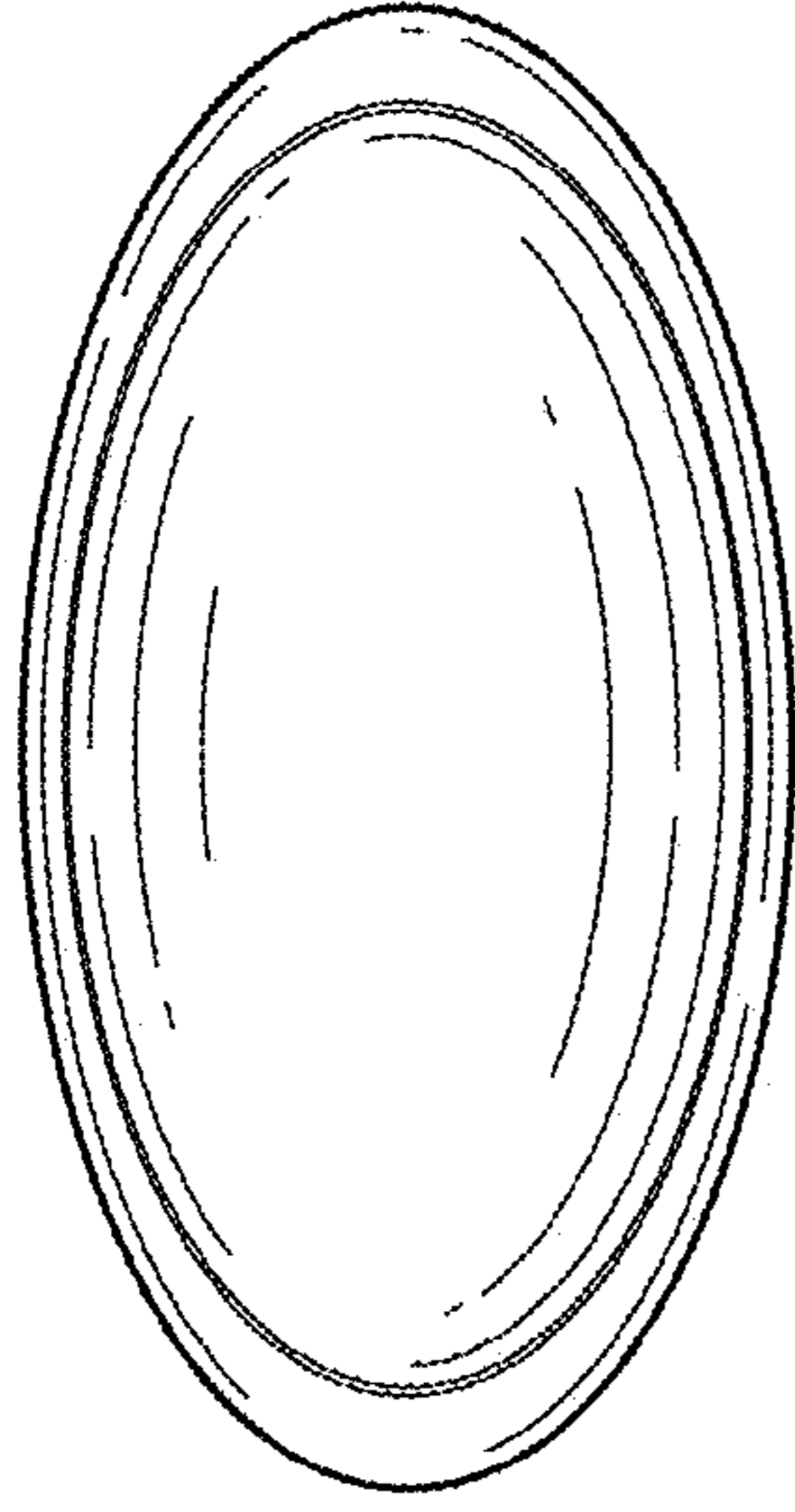

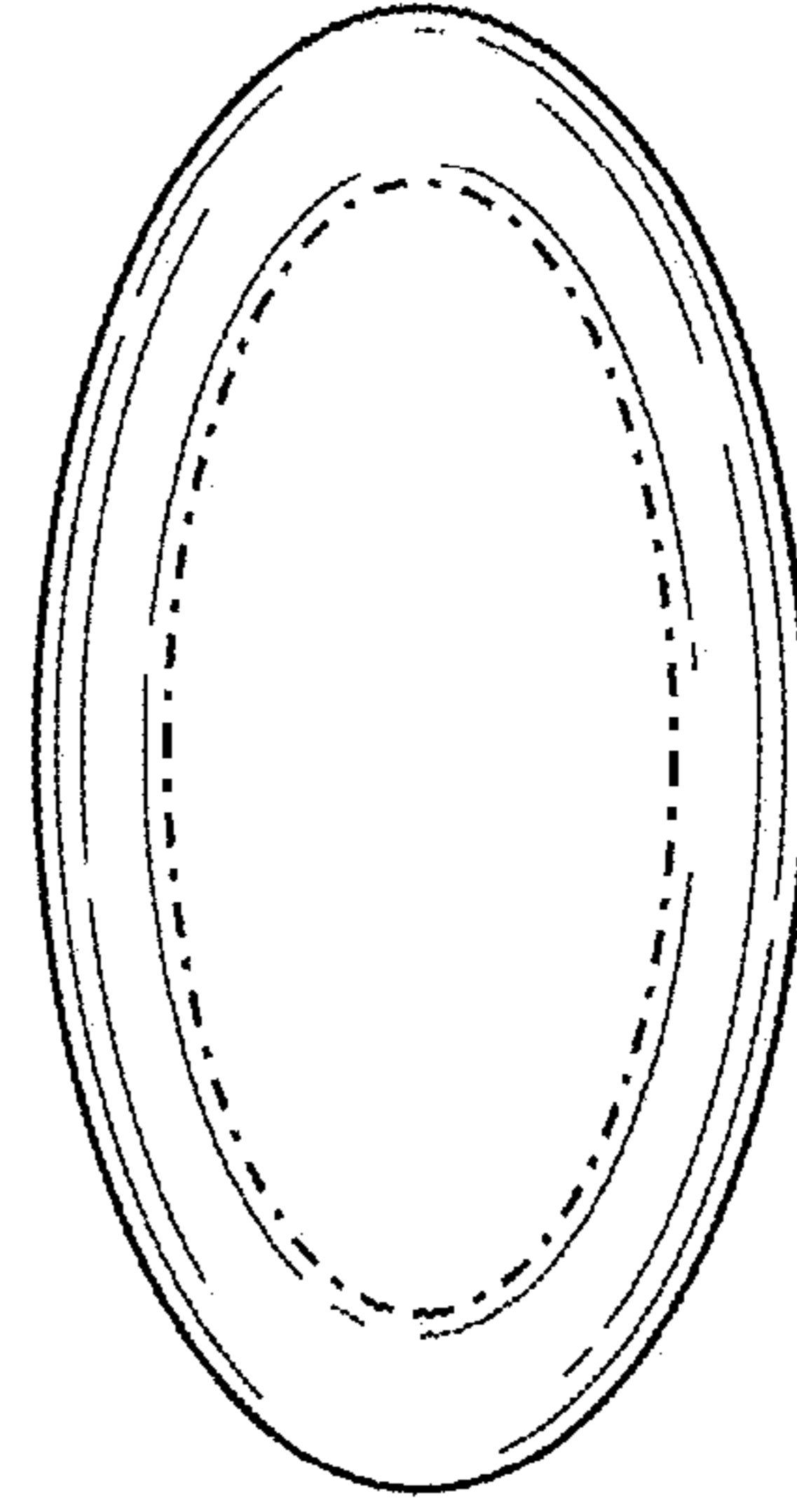
