FIG. 5 is a perspective view thereof;

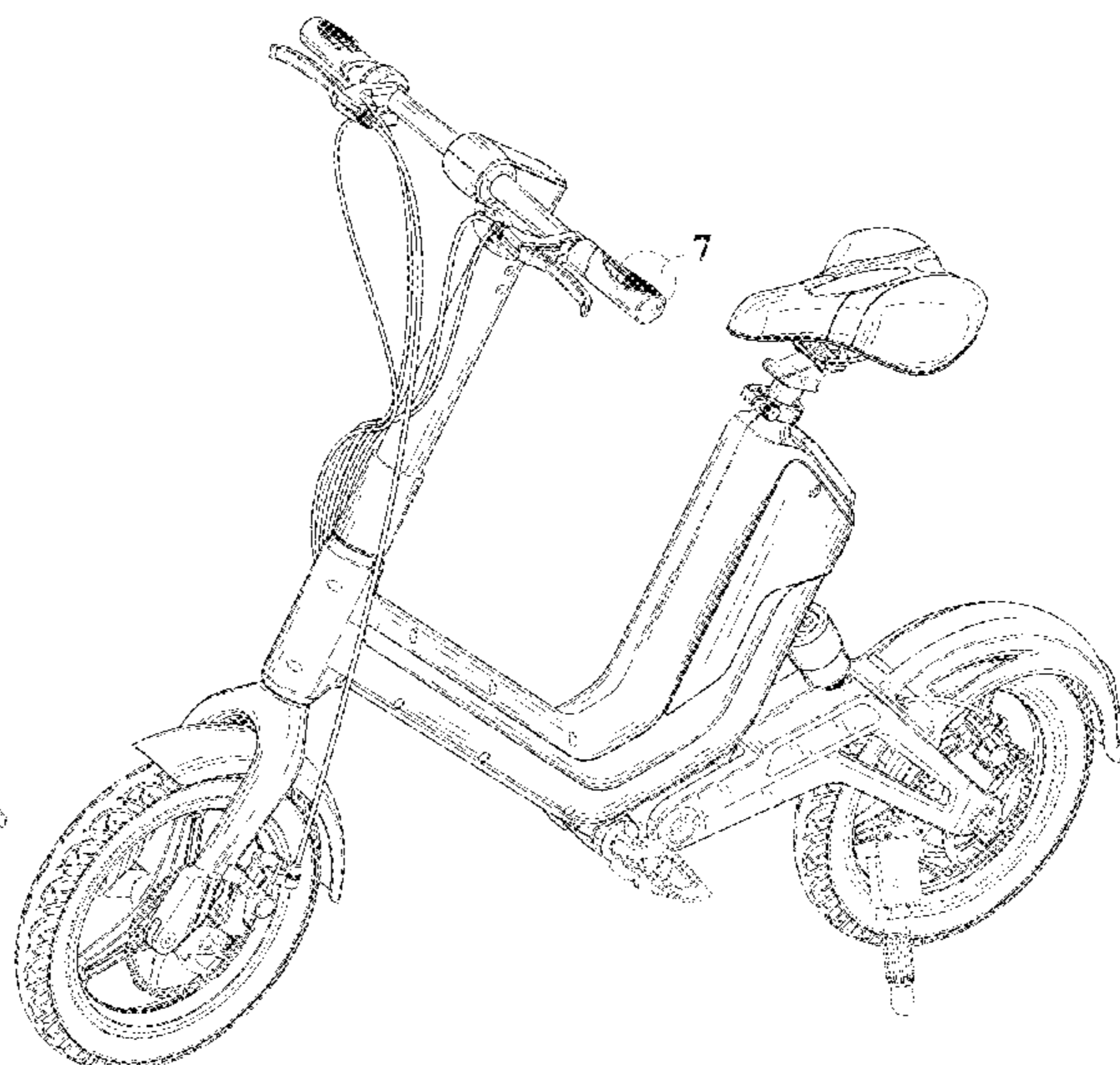
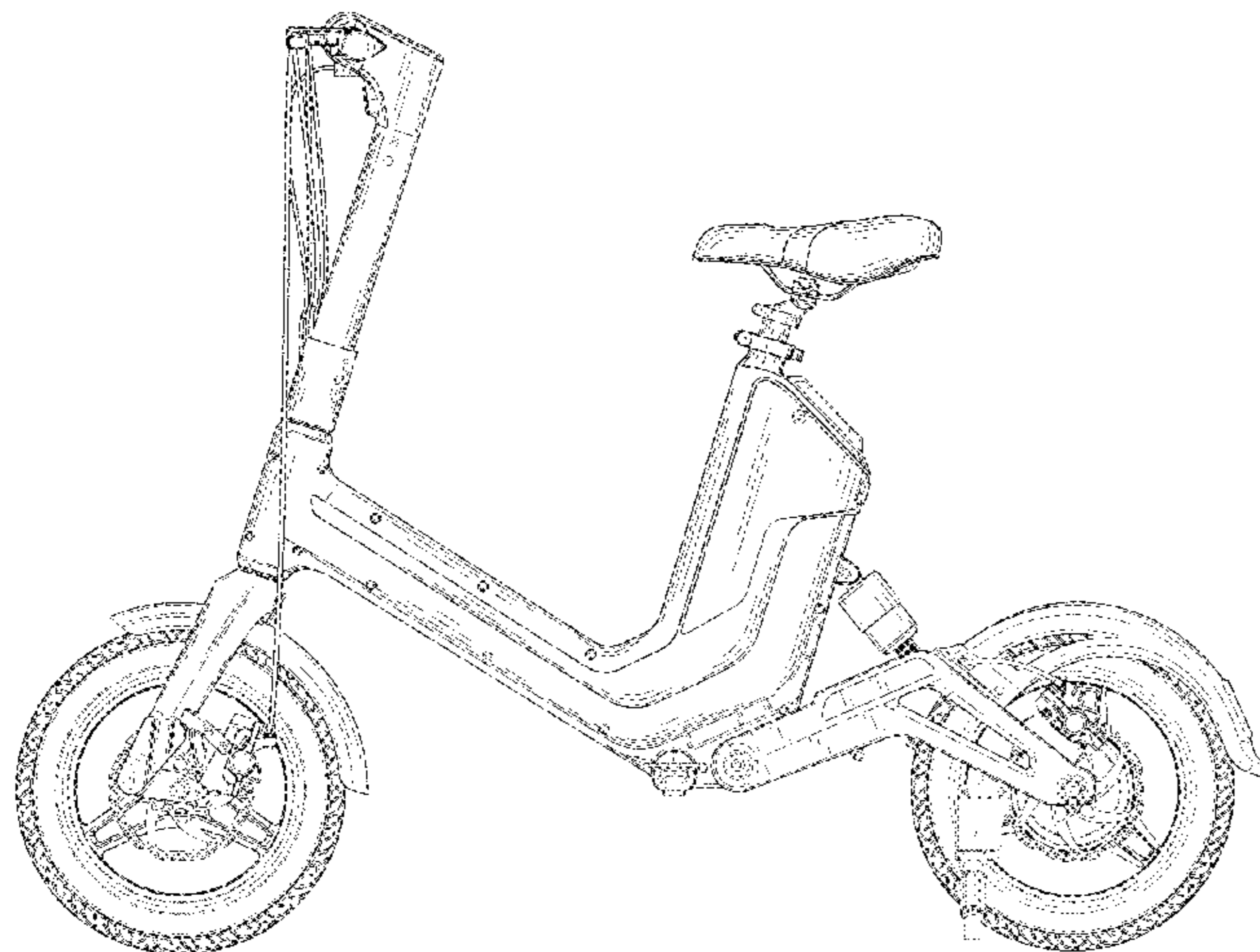
FIG. 6 is a second perspective view thereof; and,

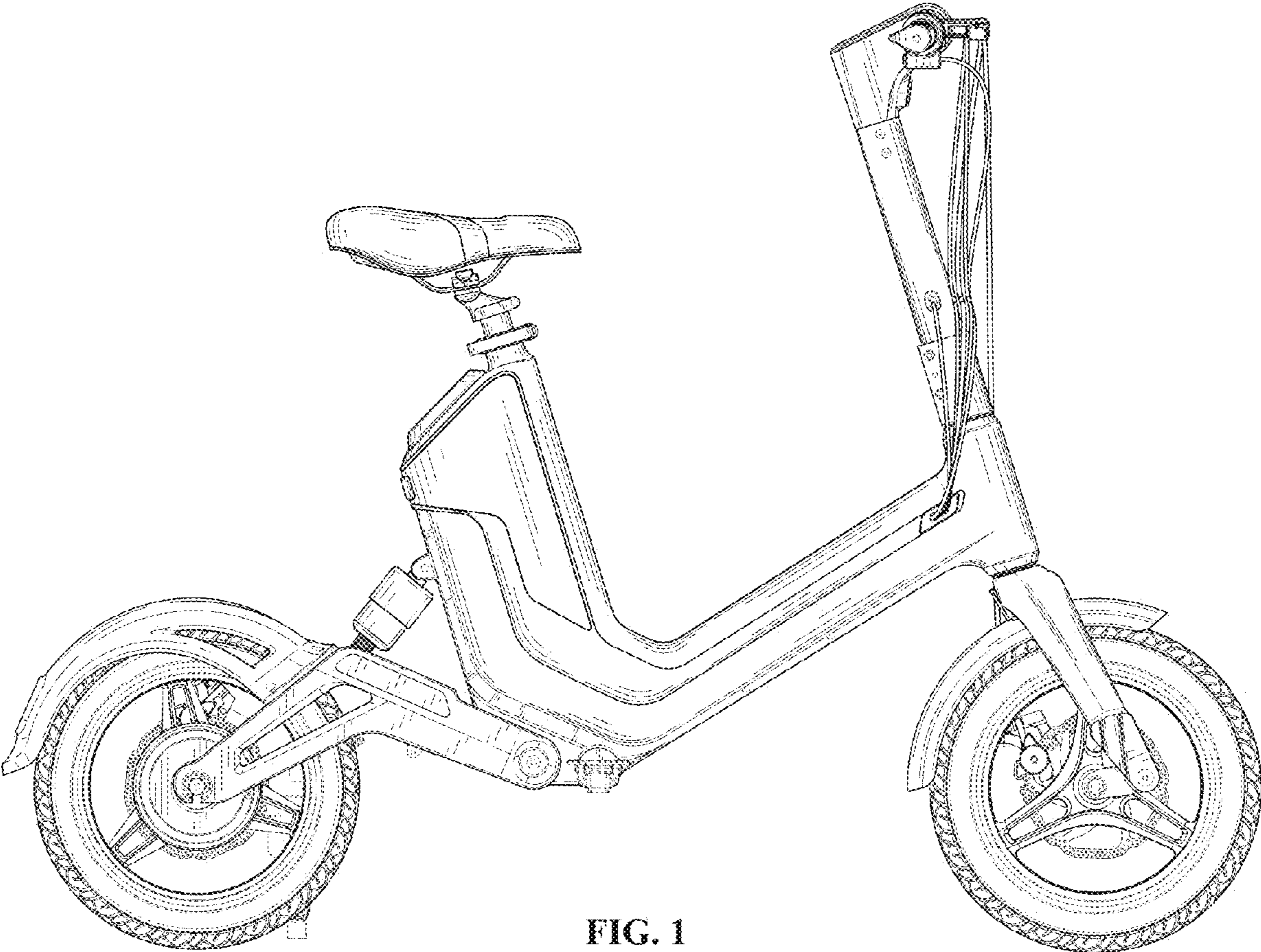

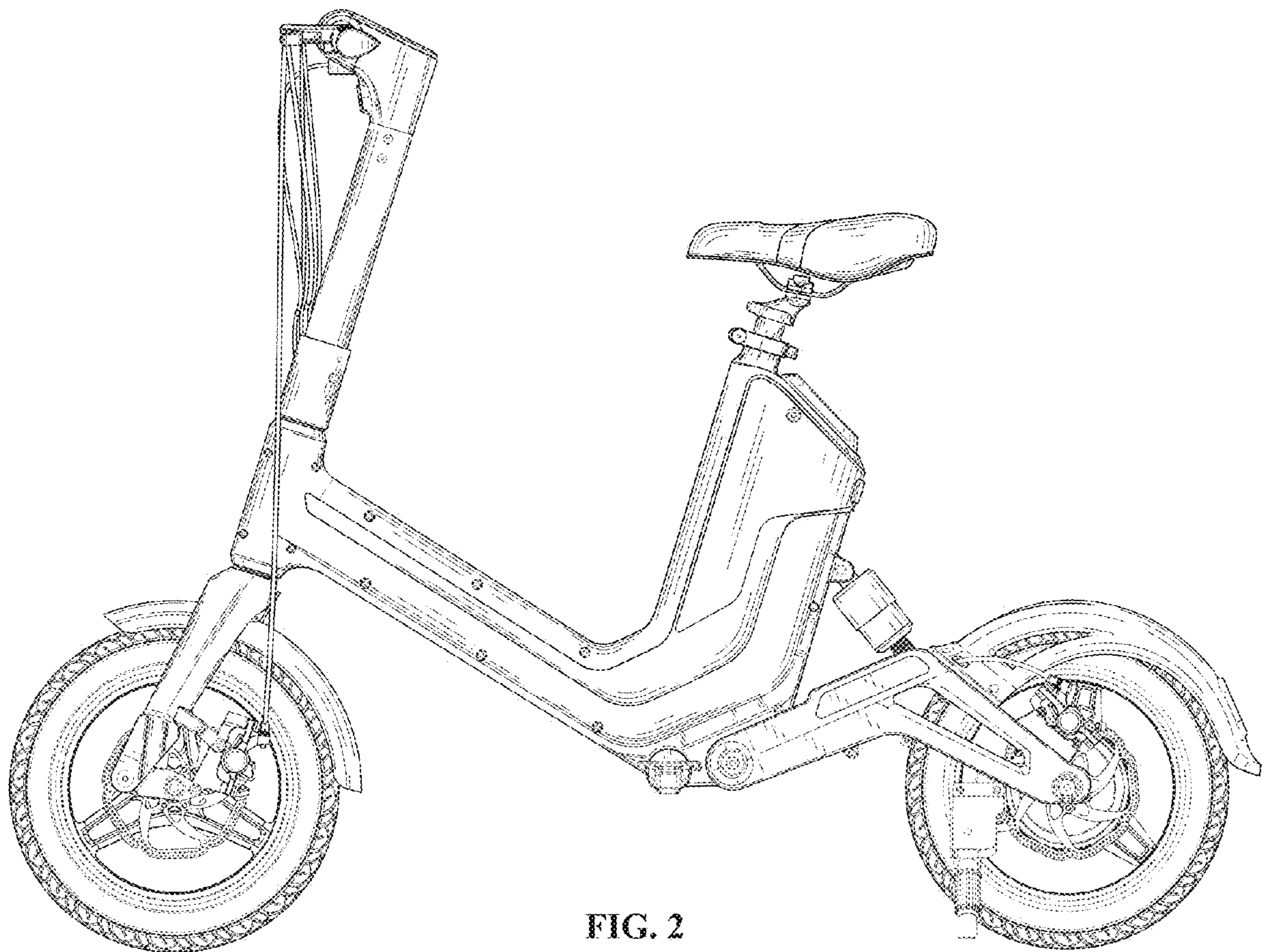

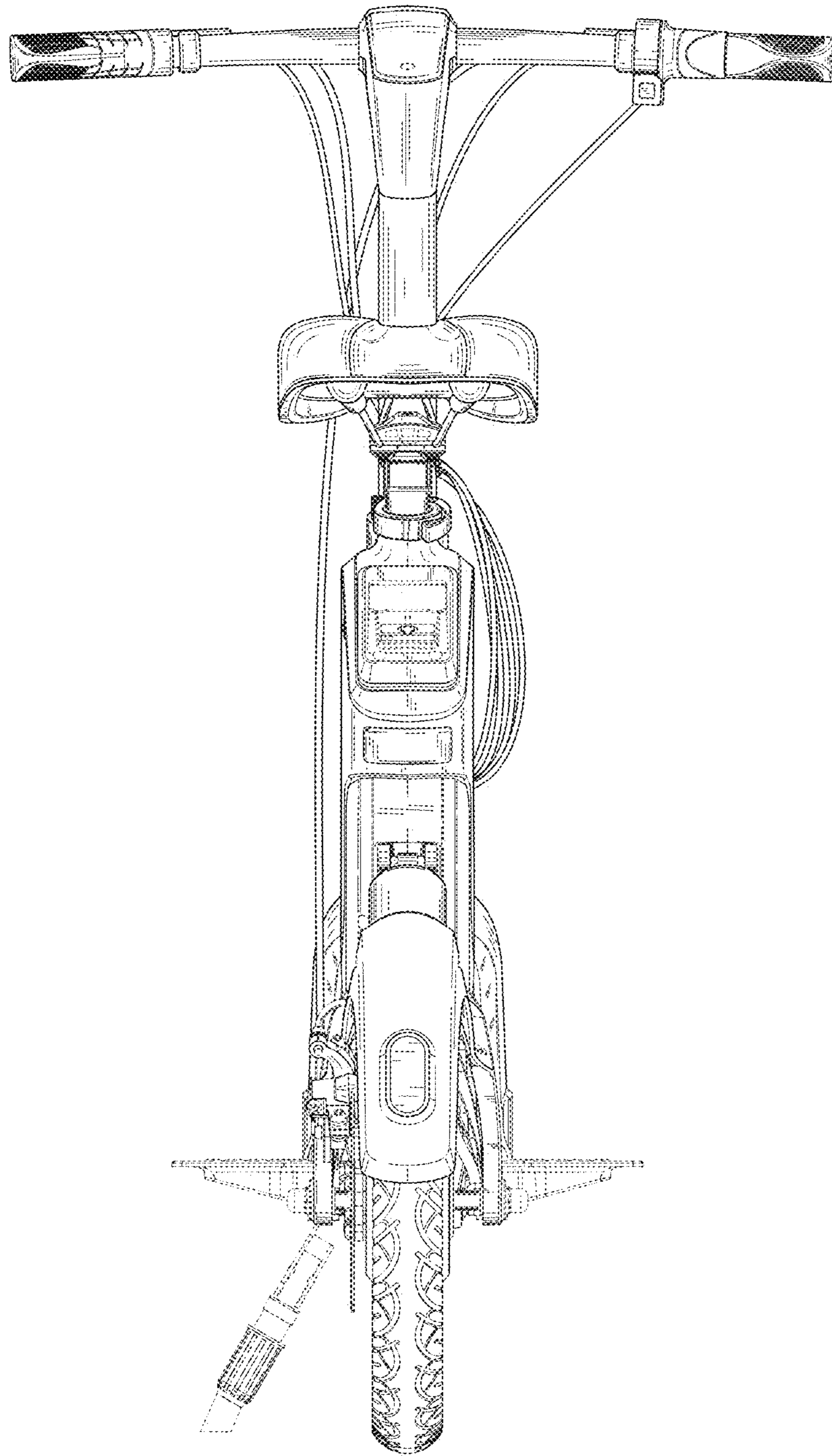

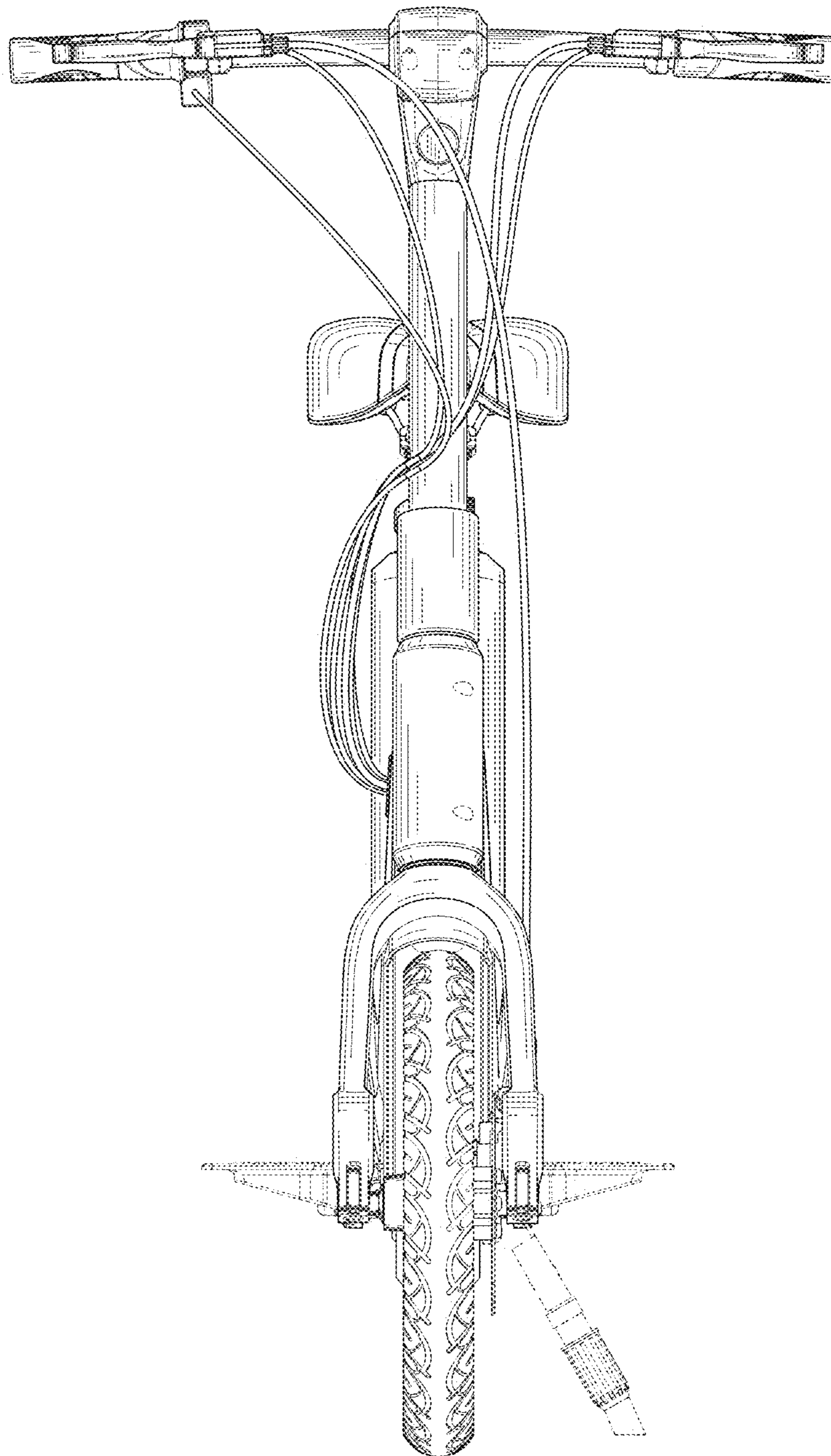

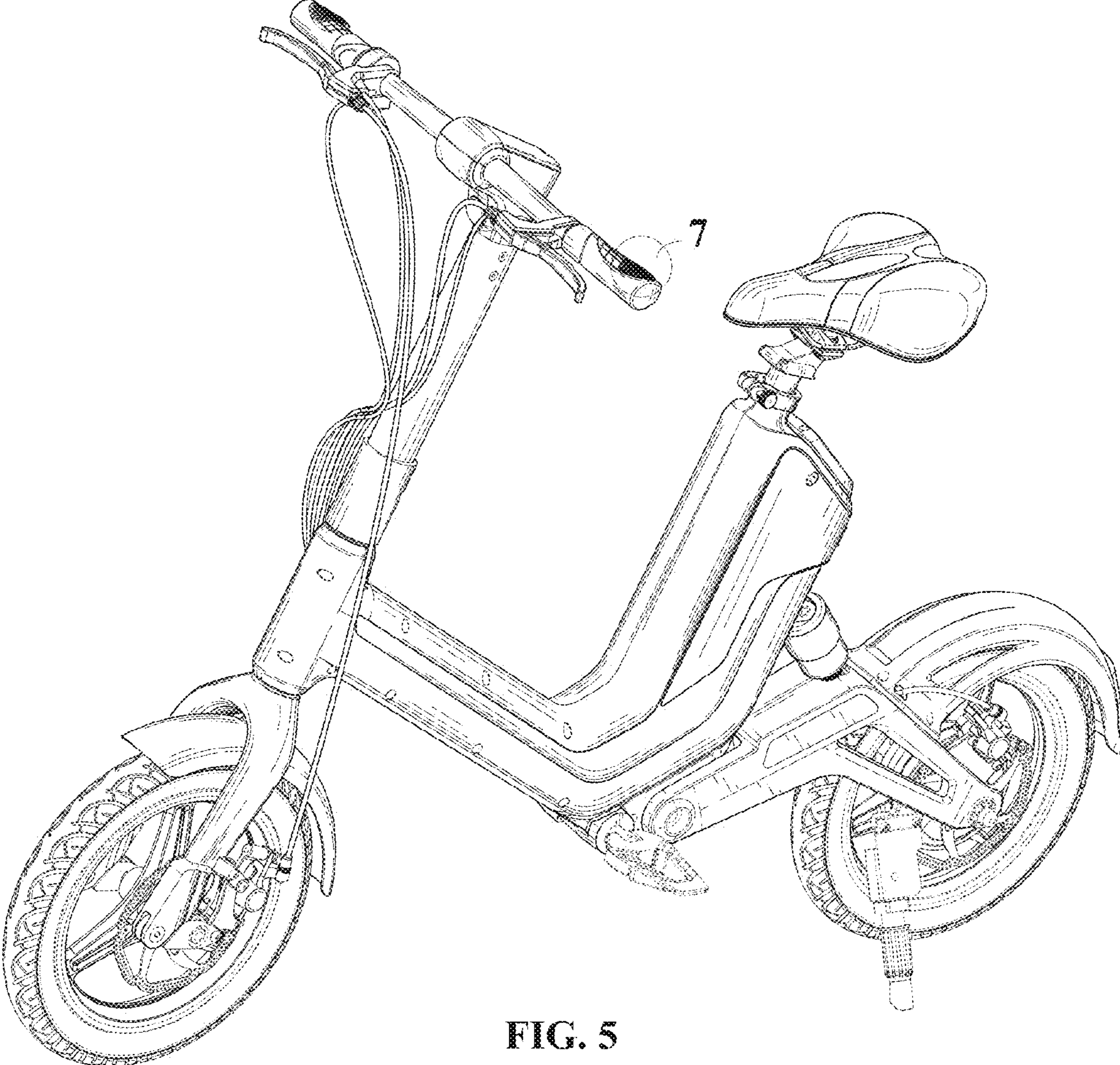

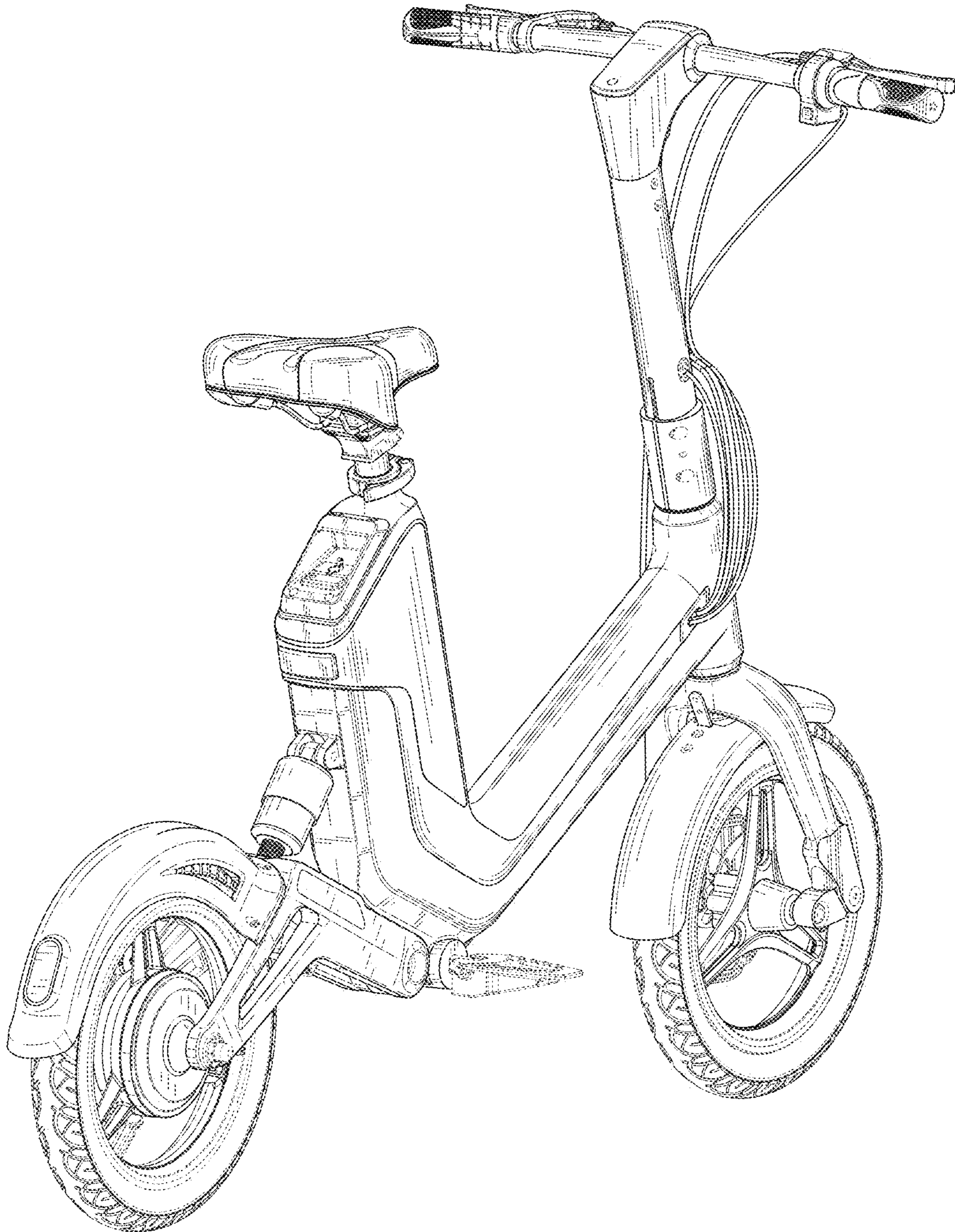

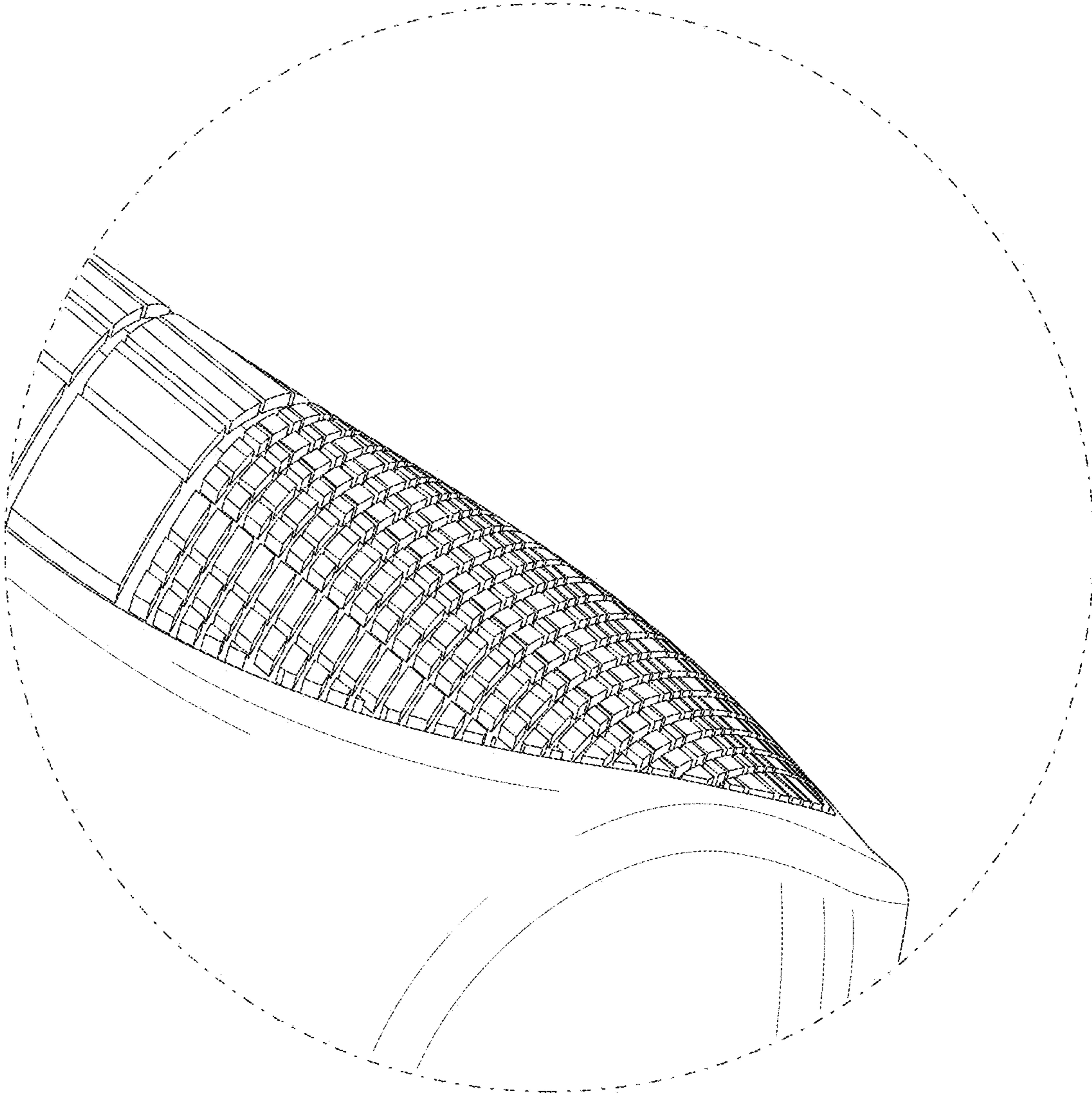
