FIG. 9 is an enlarged cross-sectional view taken along line 9-9 in FIG. 8, wherein the opposite direction is a mirror image thereof.

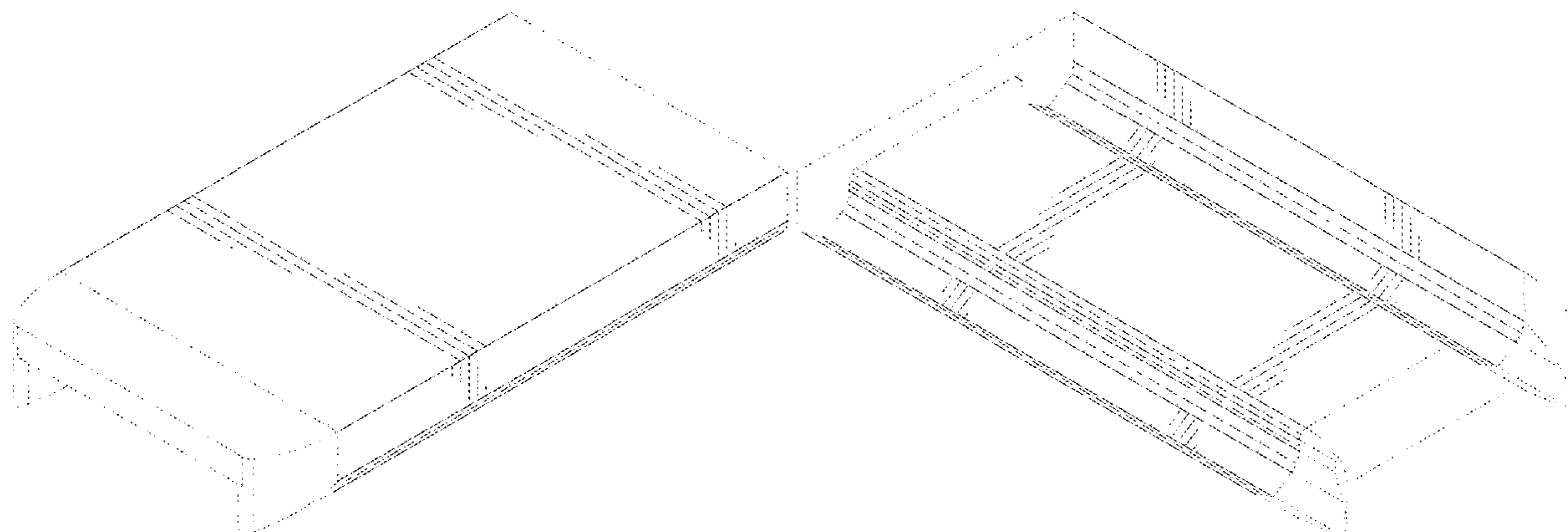

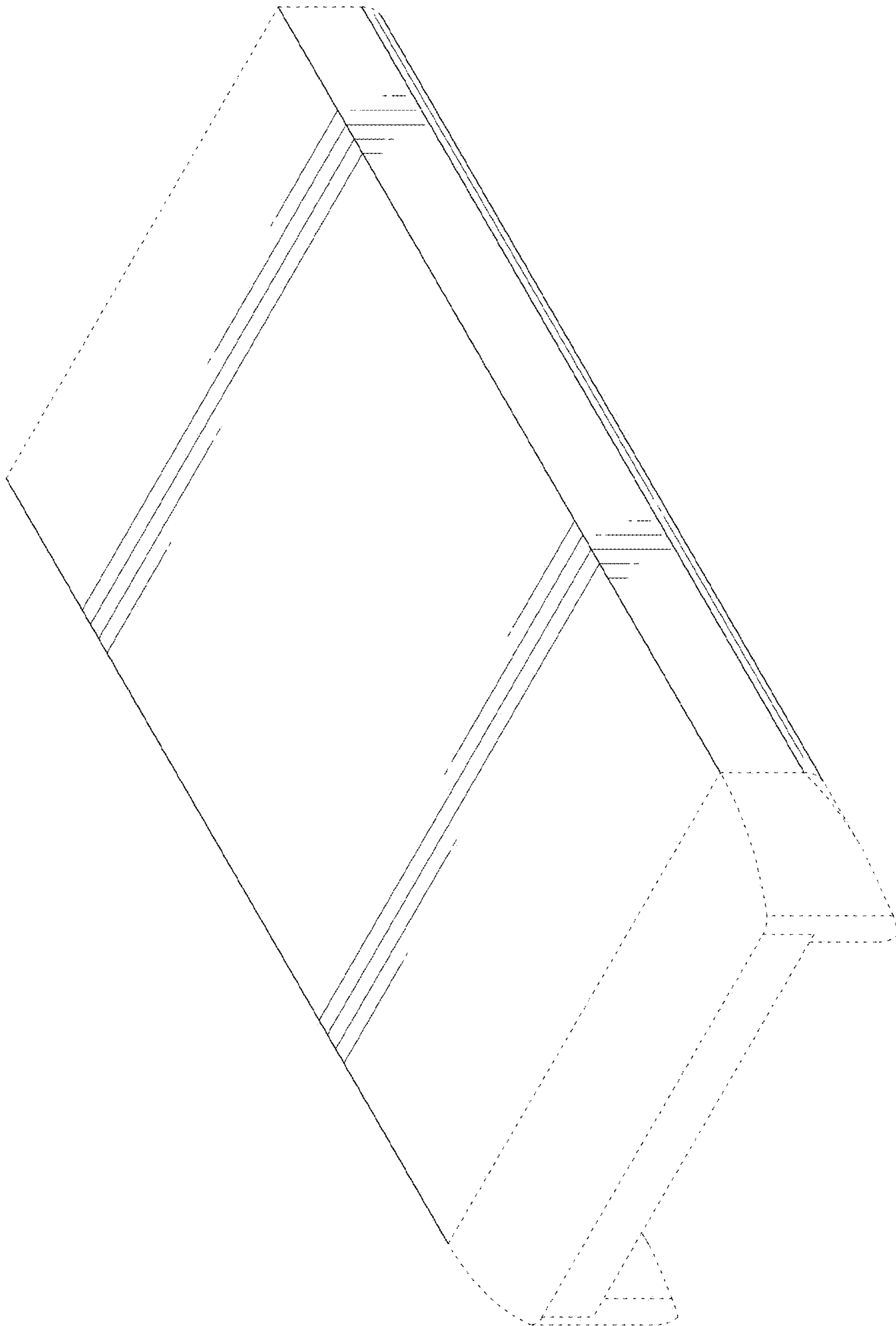

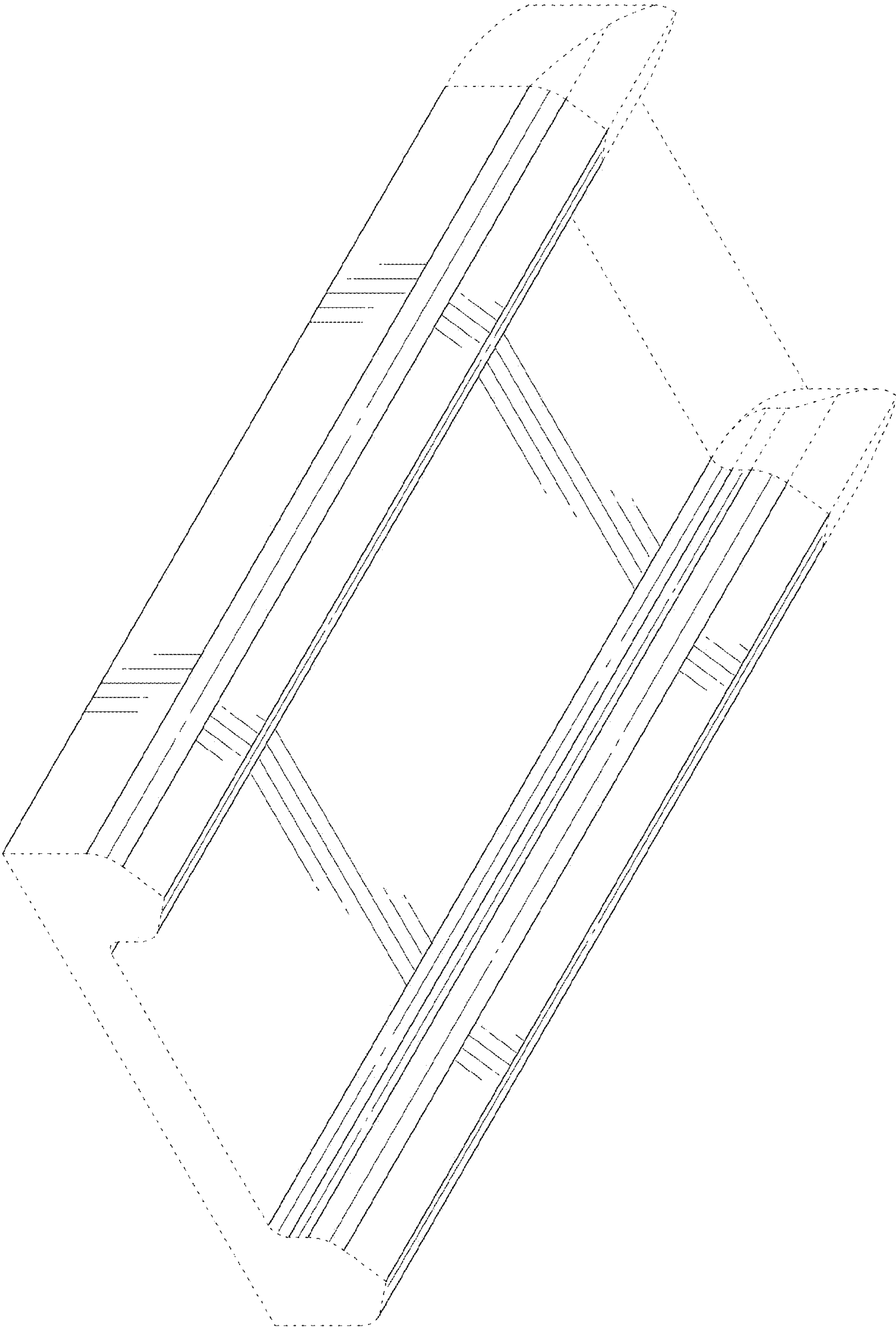

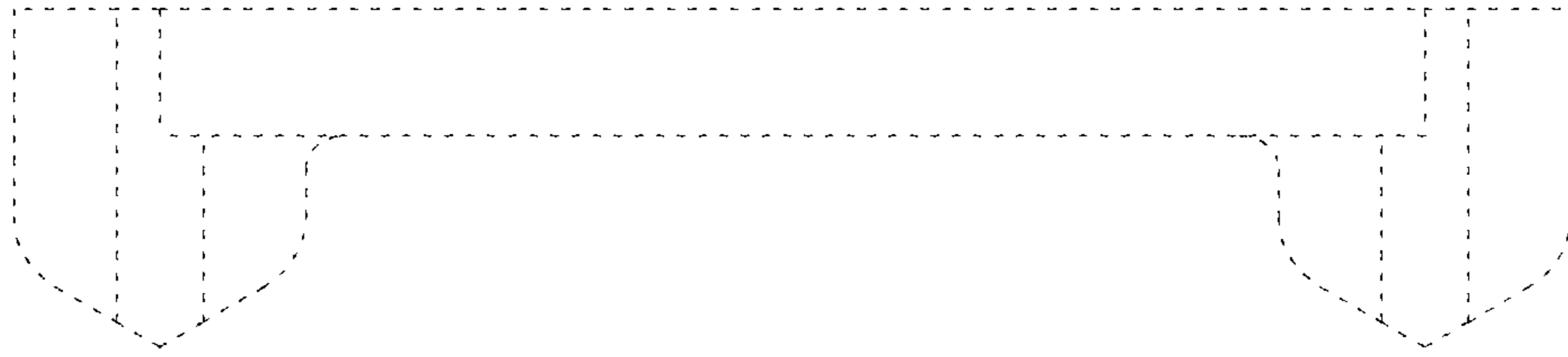

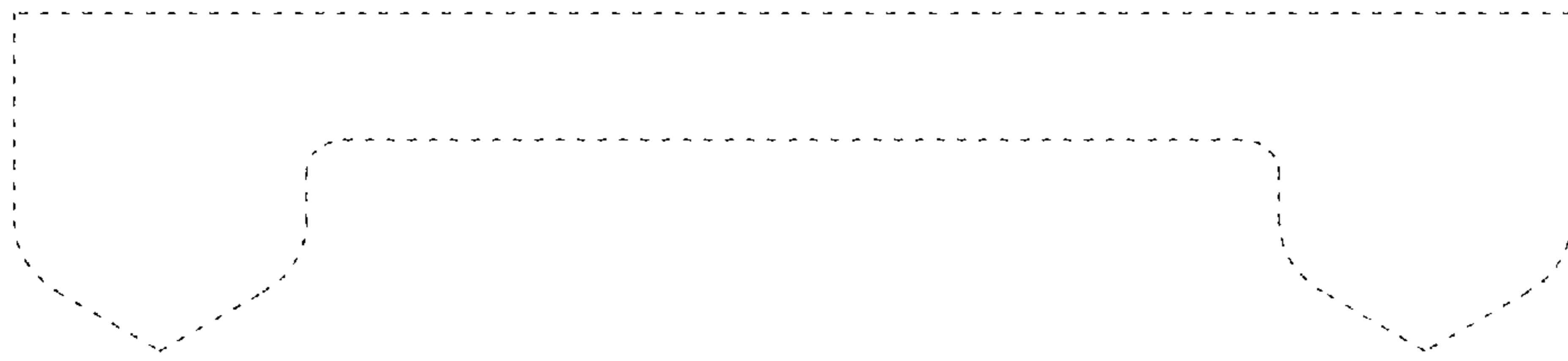

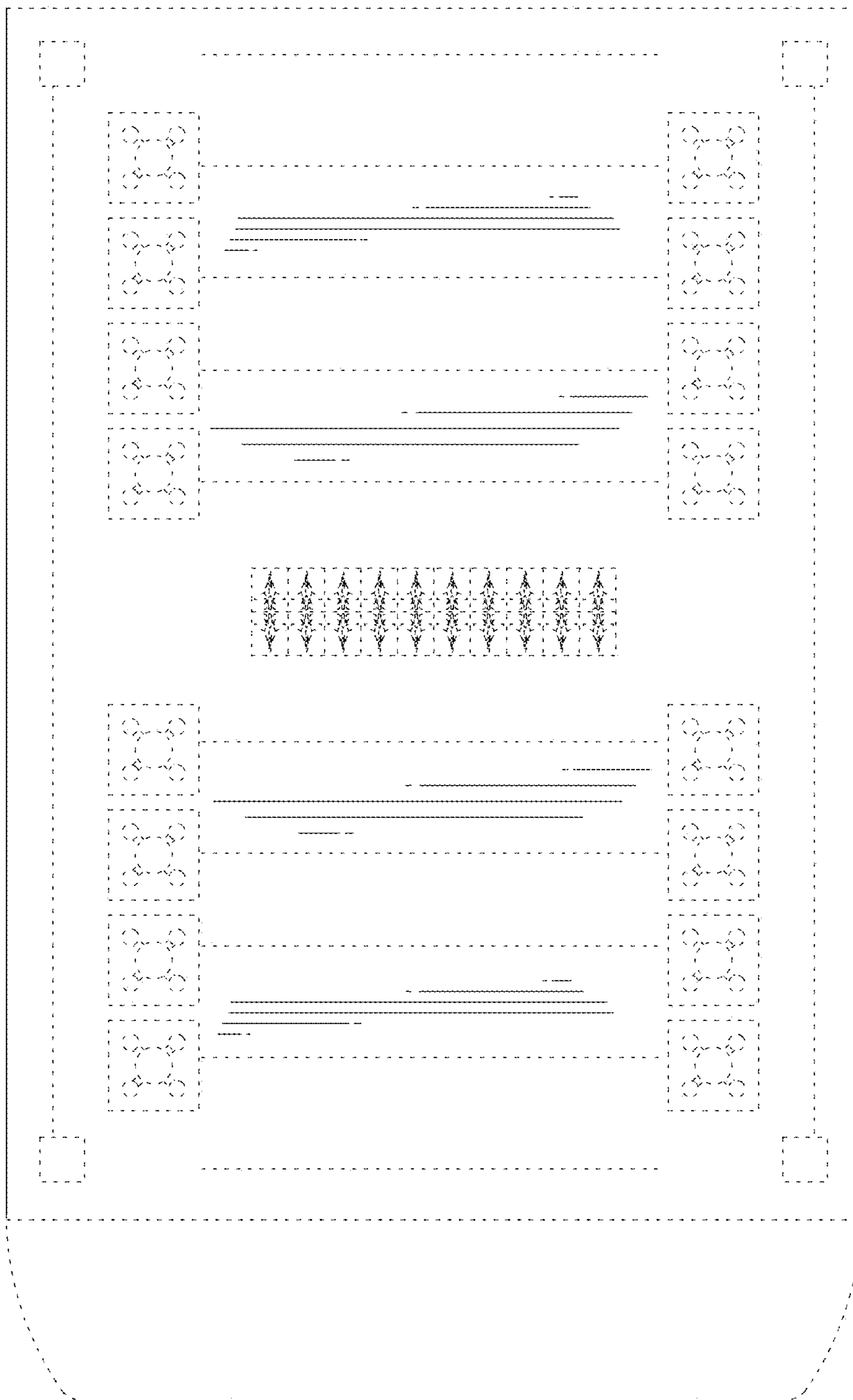

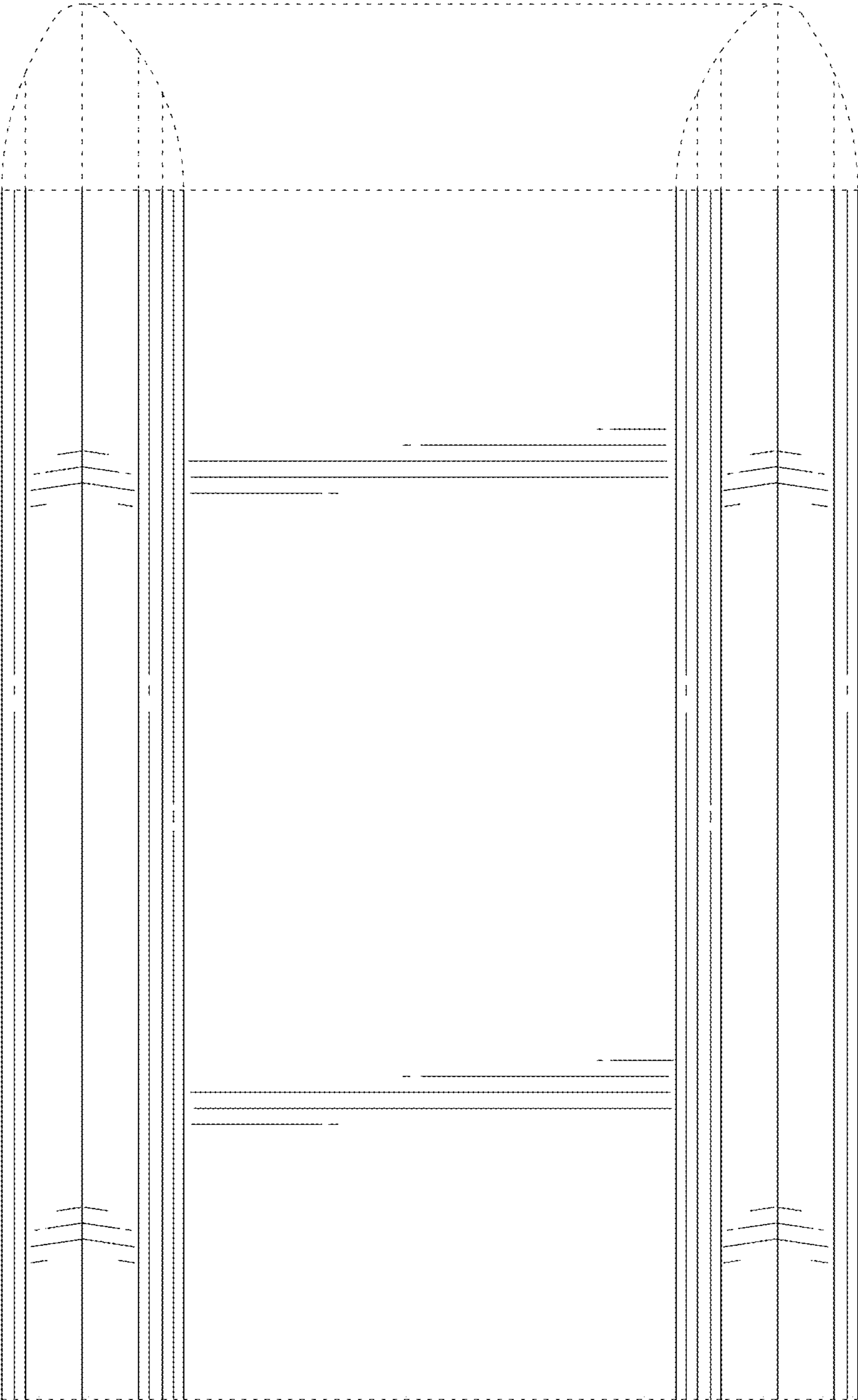

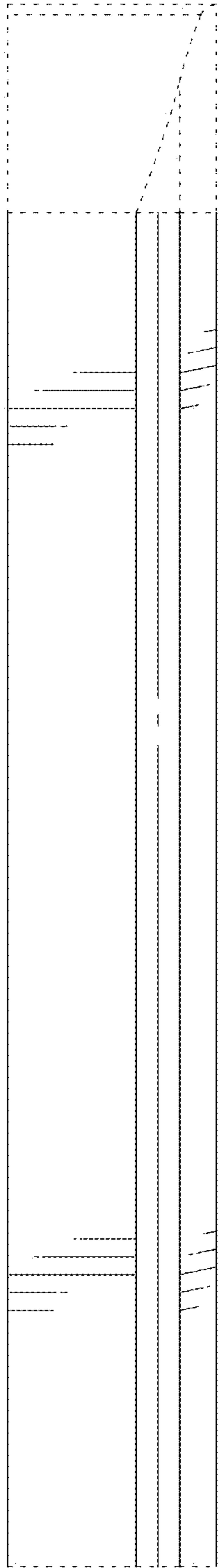

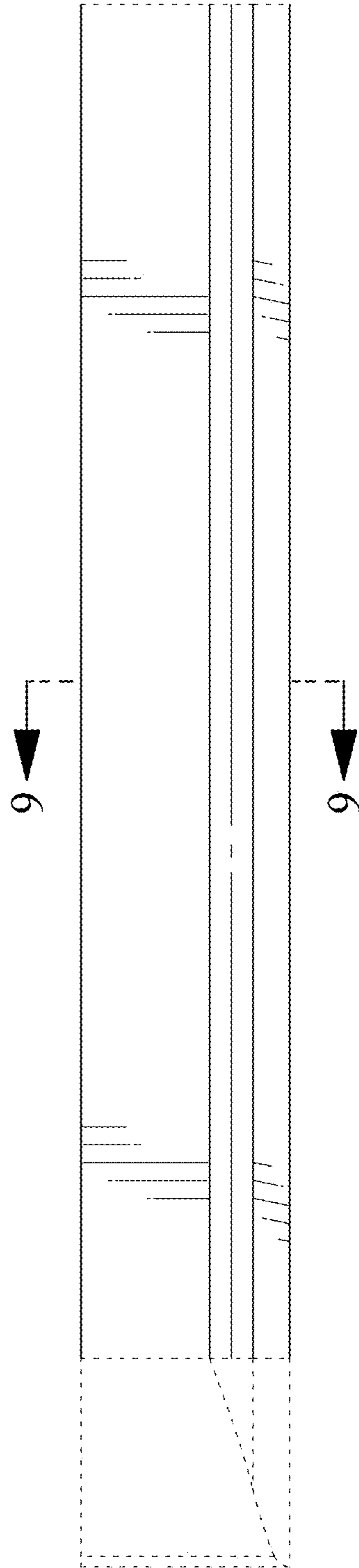

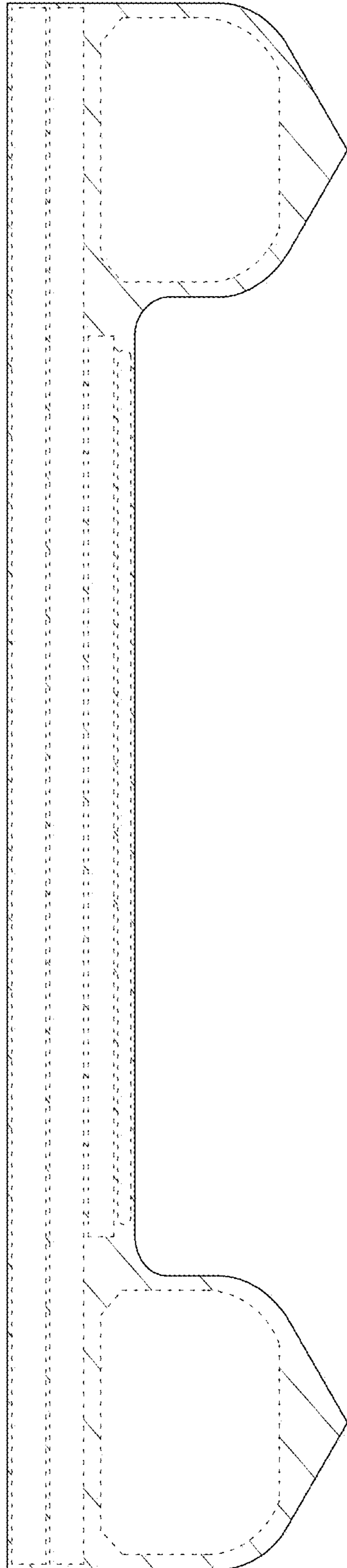
