(57) **CLAIM**

I claim the ornamental design for an earphone, as shown and described.

DESCRIPTION

FIG. 1 is a front, left side perspective view of an earphone, showing my new design;

FIG. 4 is a rear elevation view thereof;

FIG. 5 is a left side elevation view thereof;

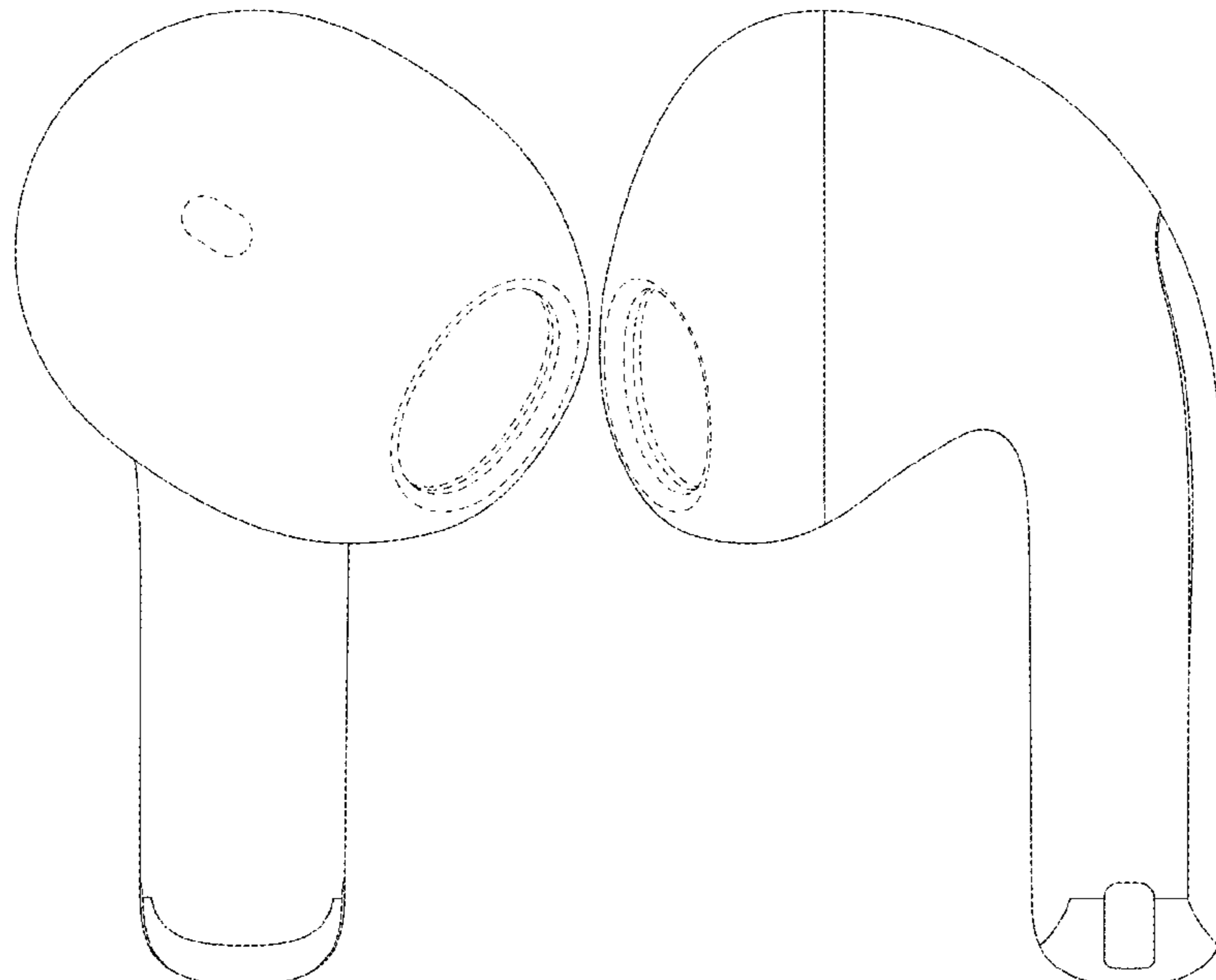
FIG. 6 is a right side elevation view thereof;

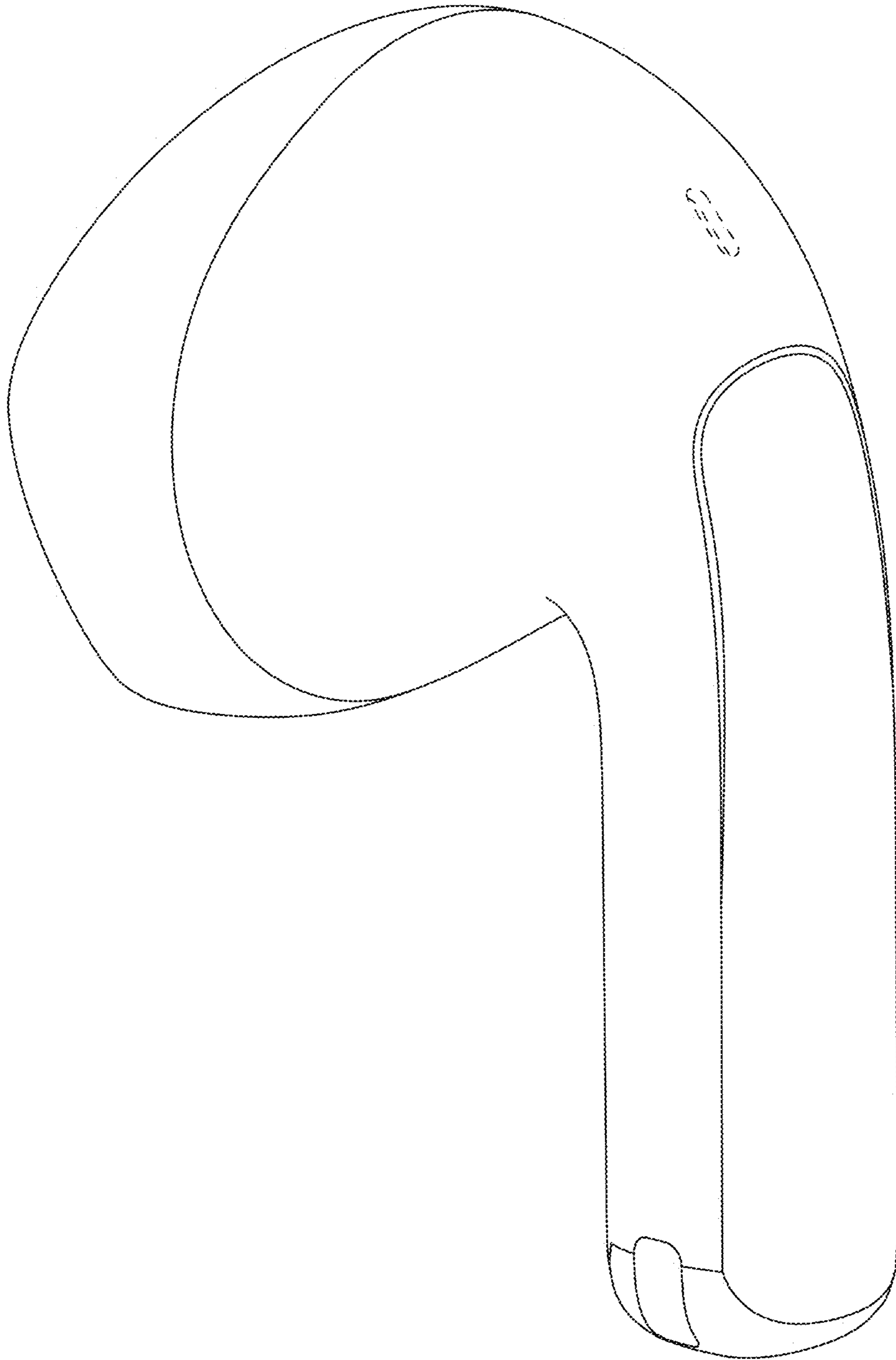

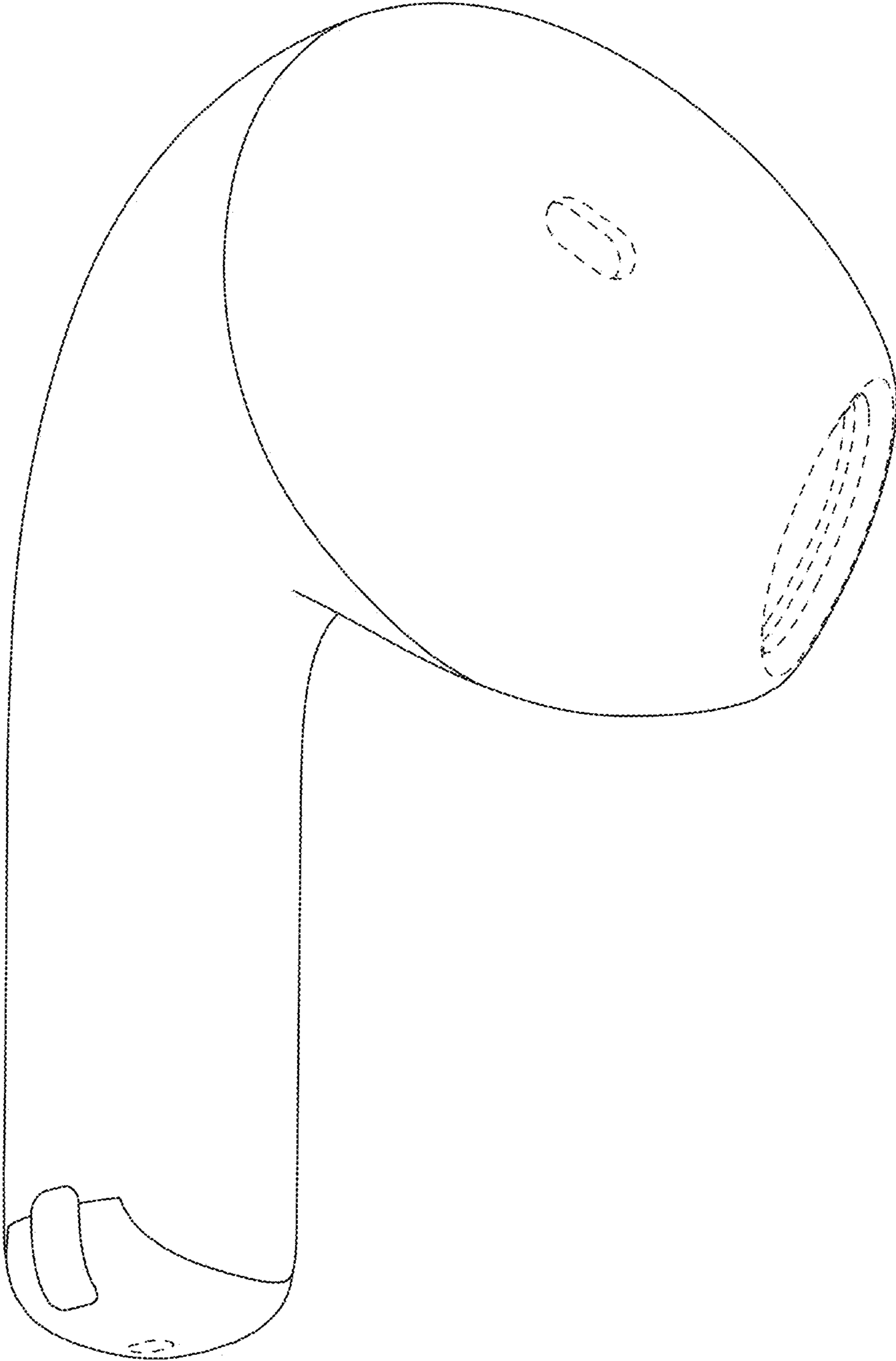

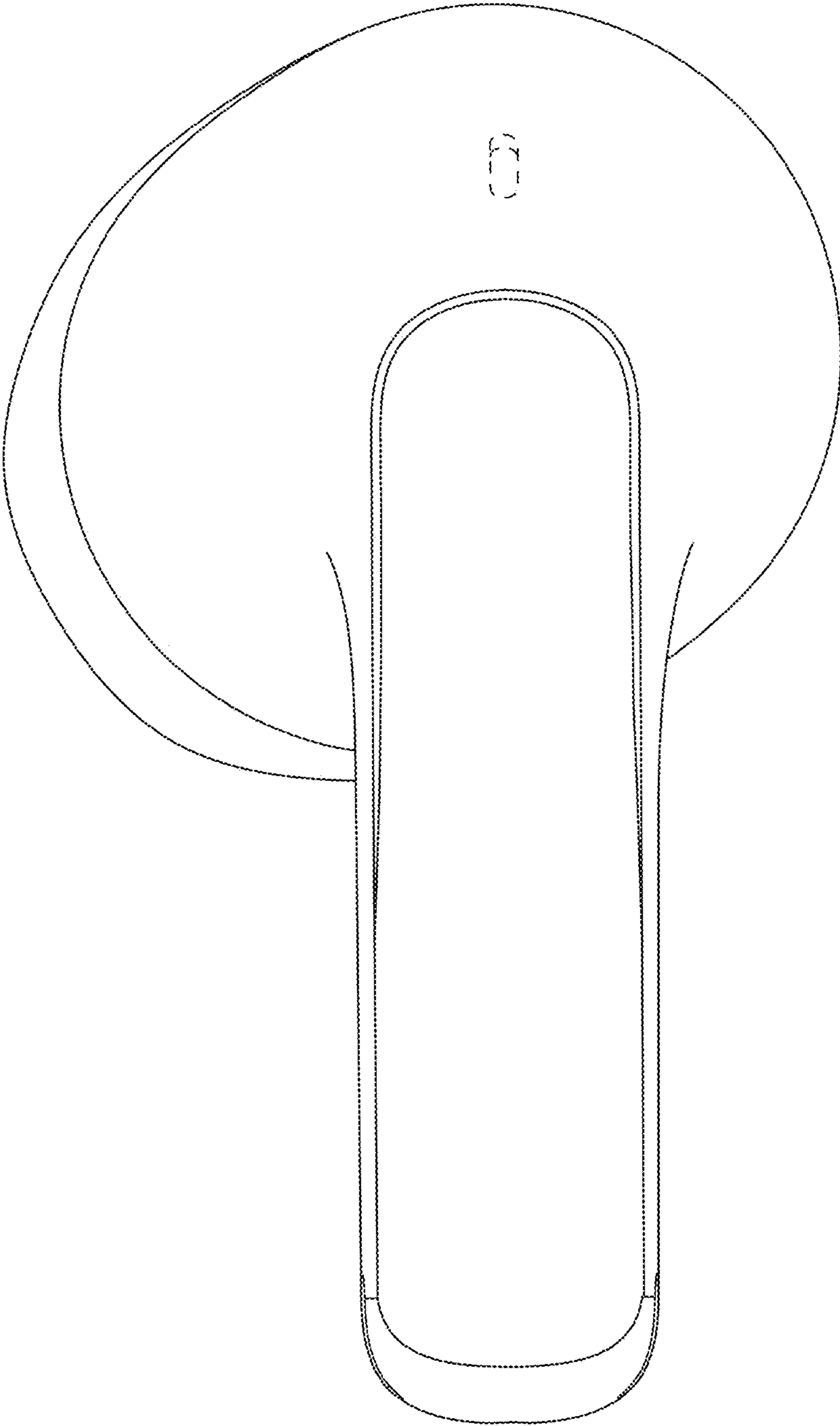

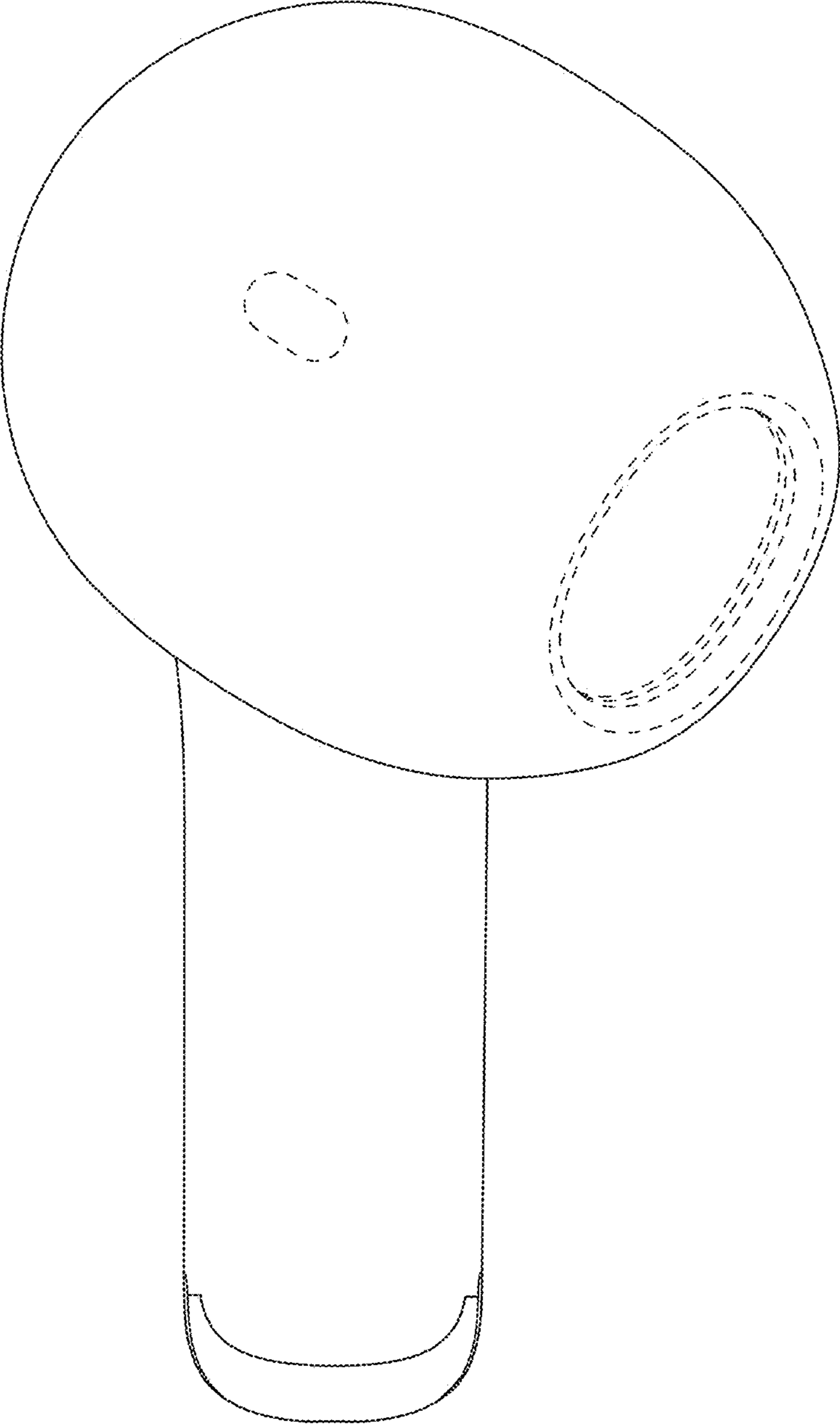

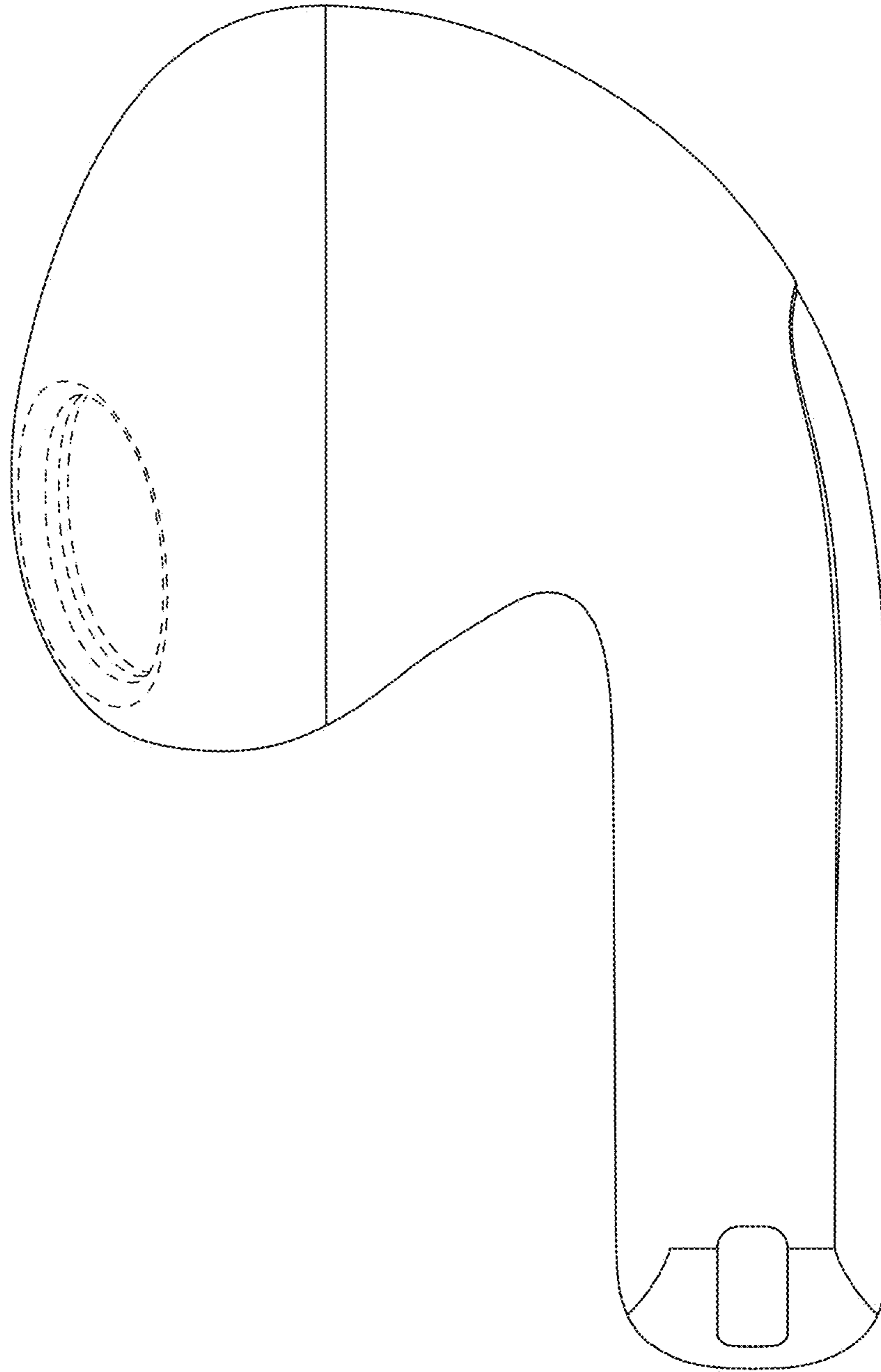

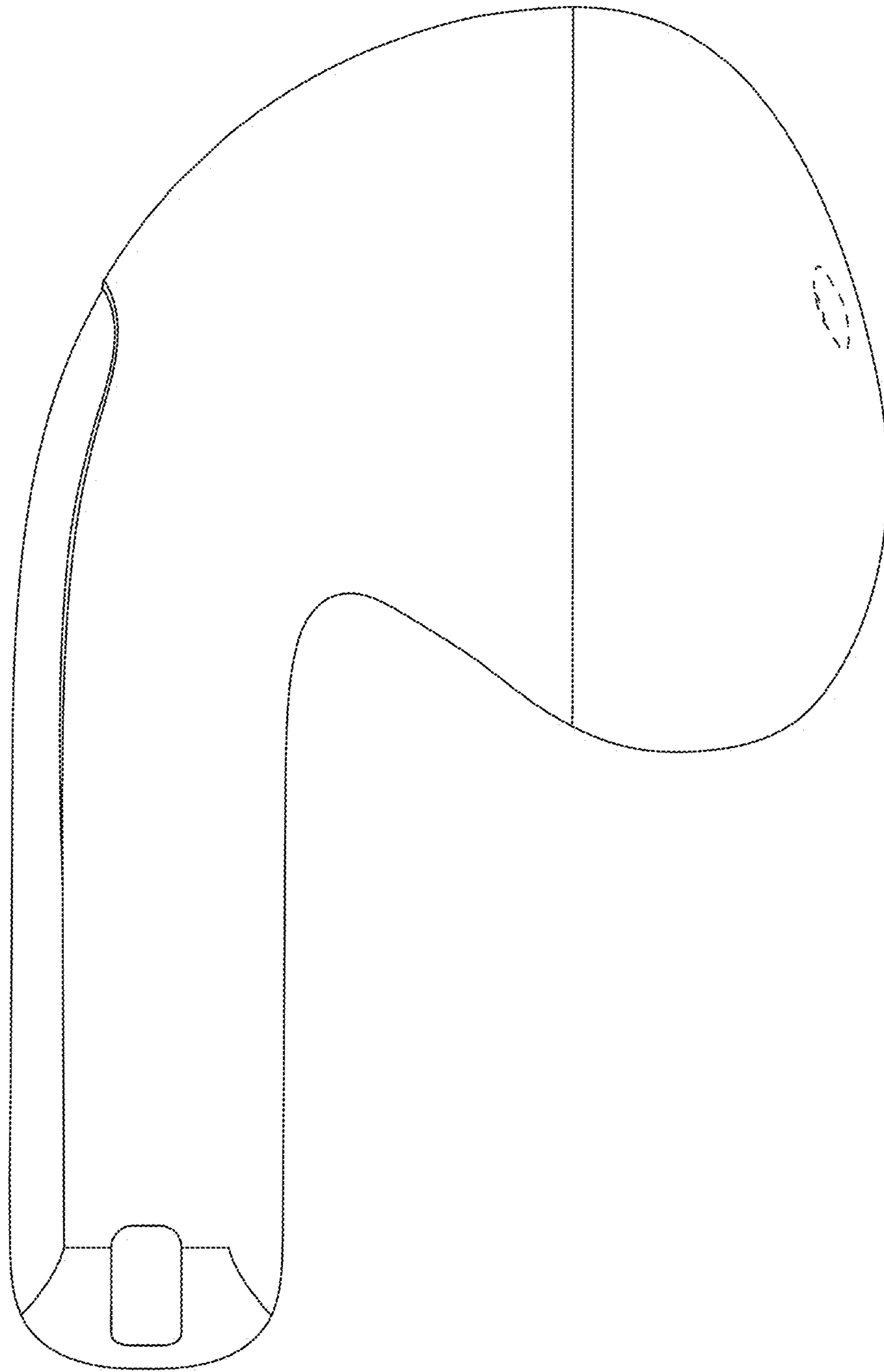

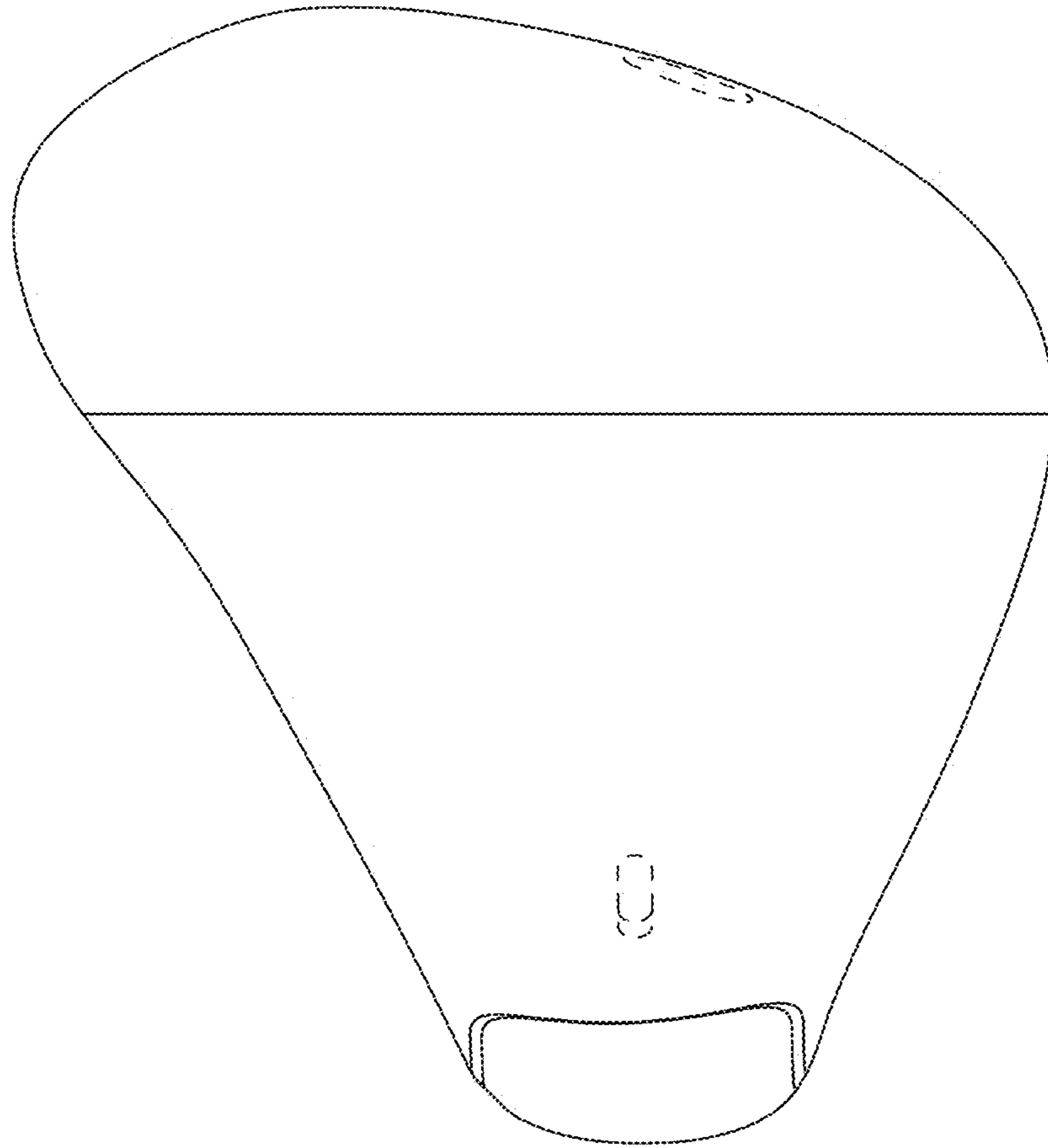

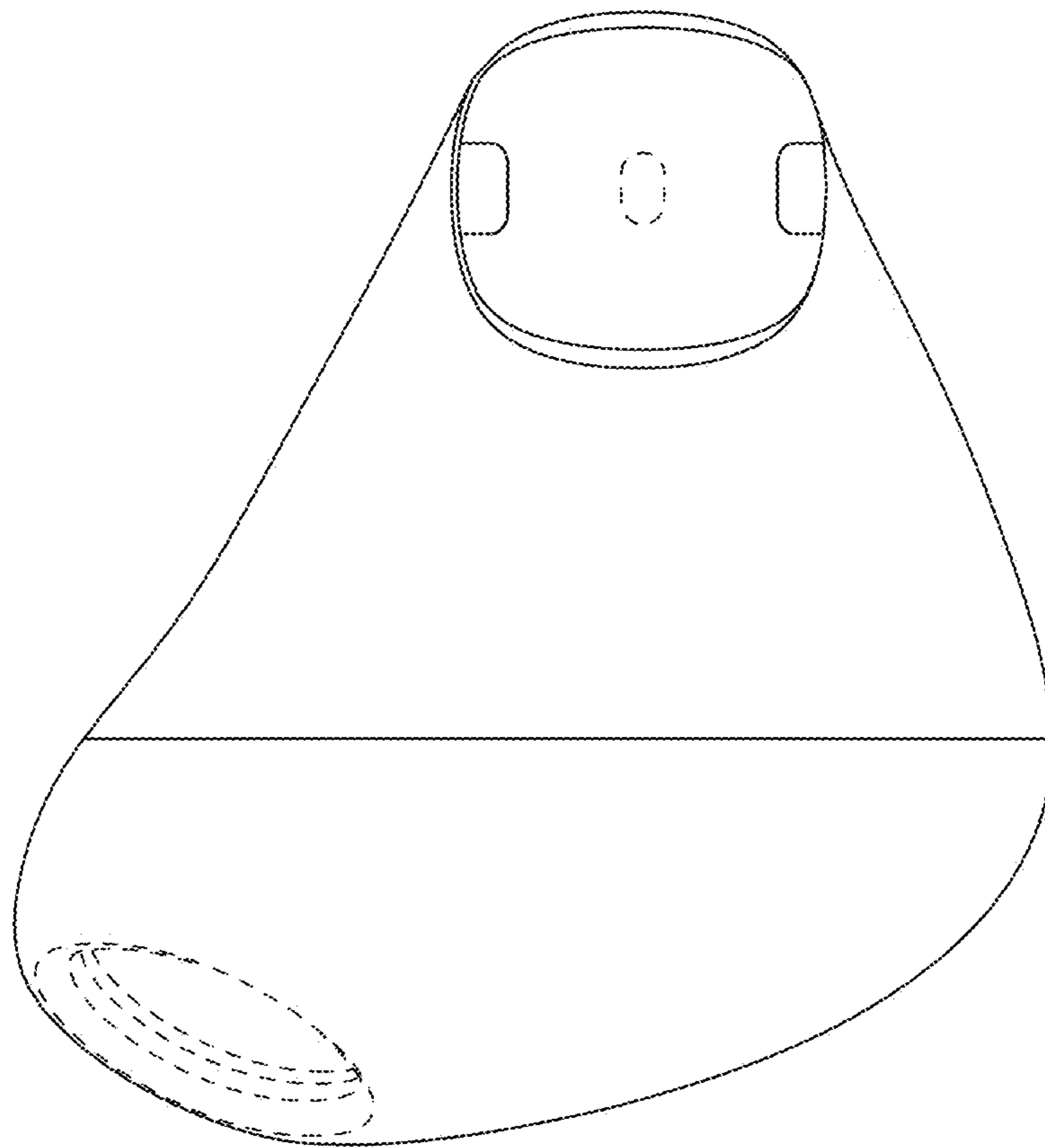
