The ornamental design for a memory card typed wireless communication module, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a memory card typed wireless communication module showing my new design;

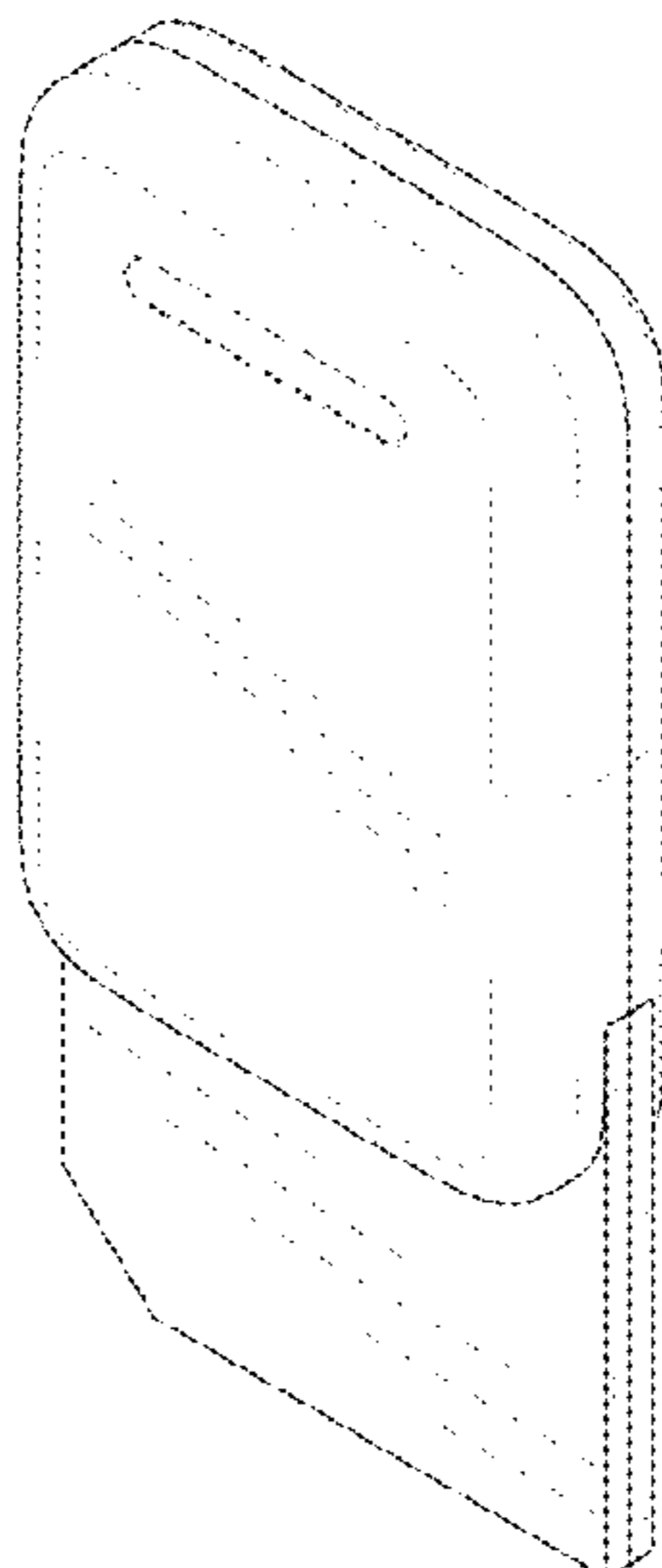

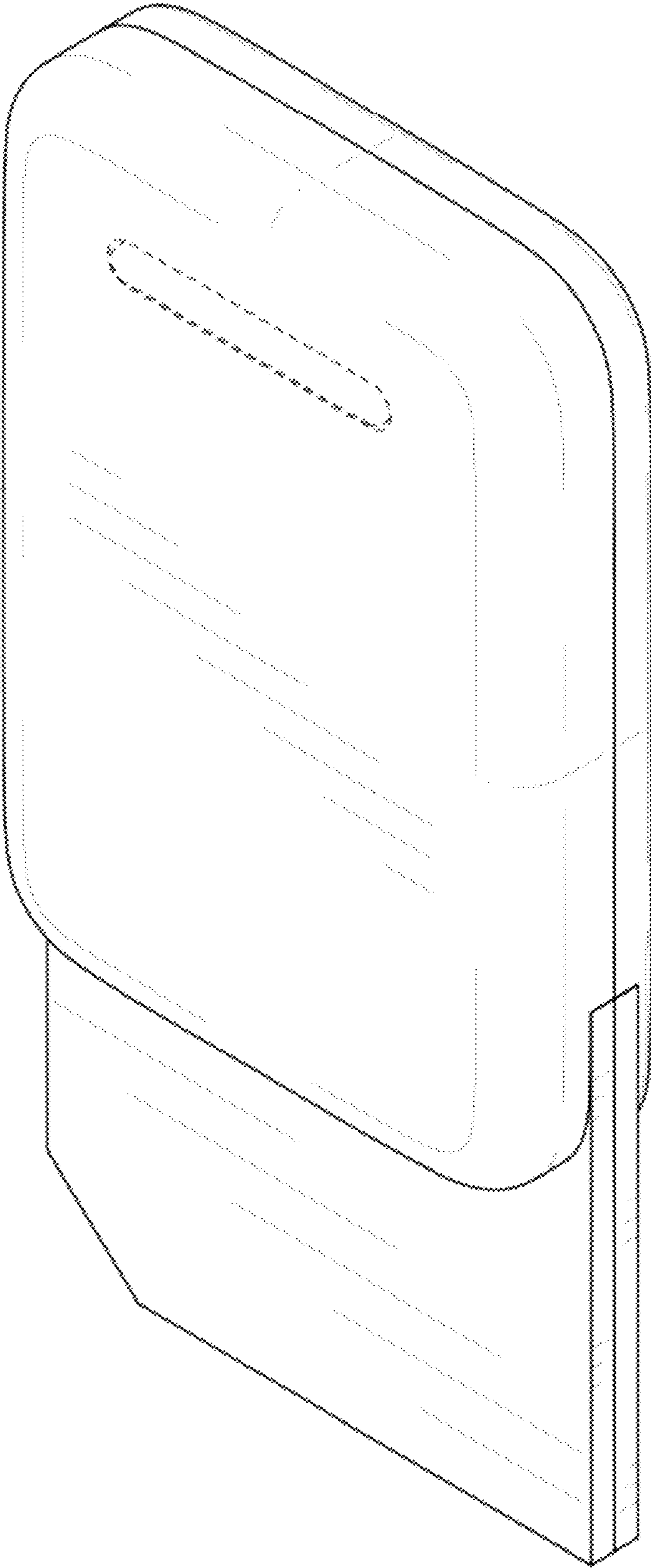

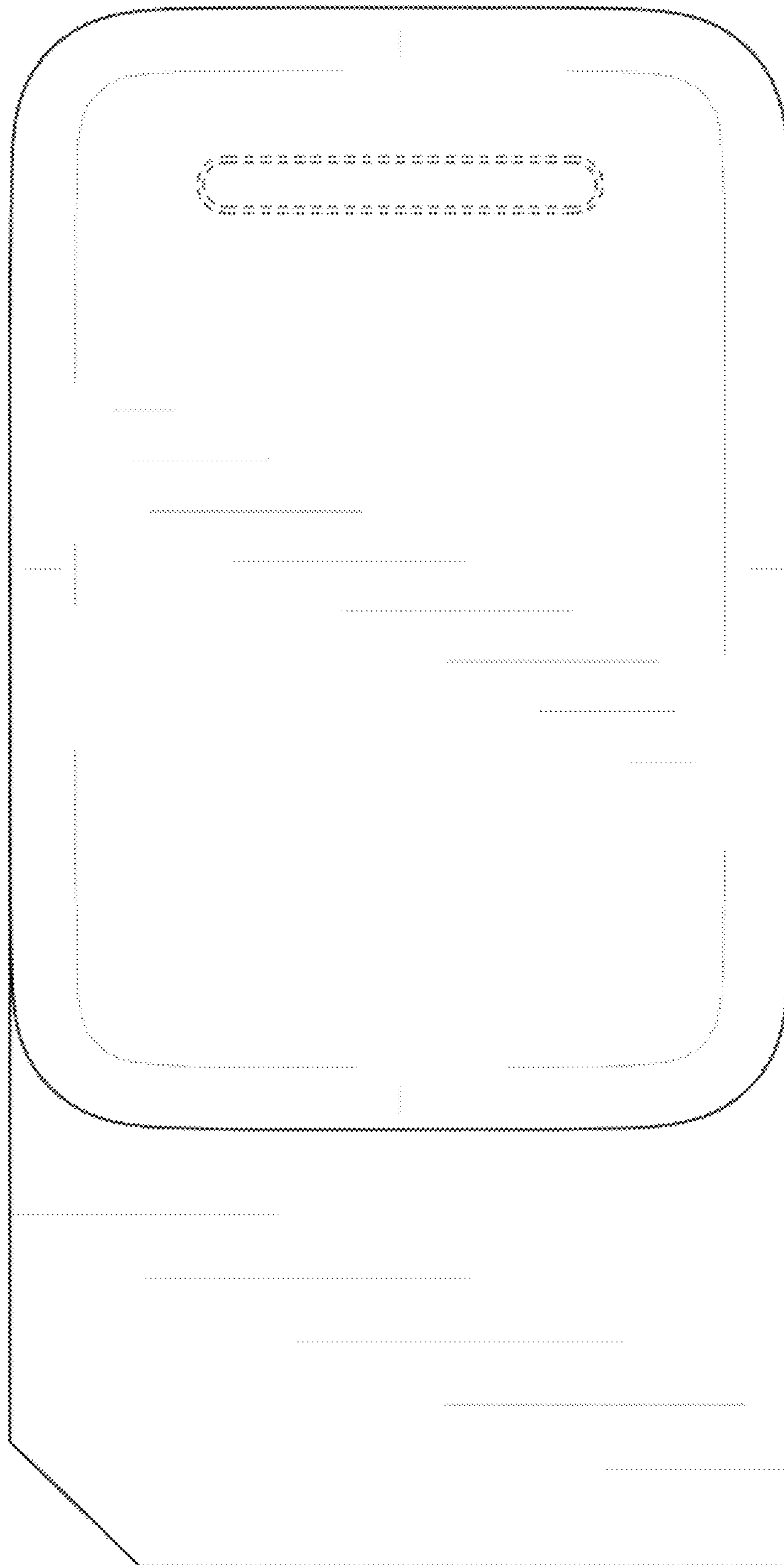

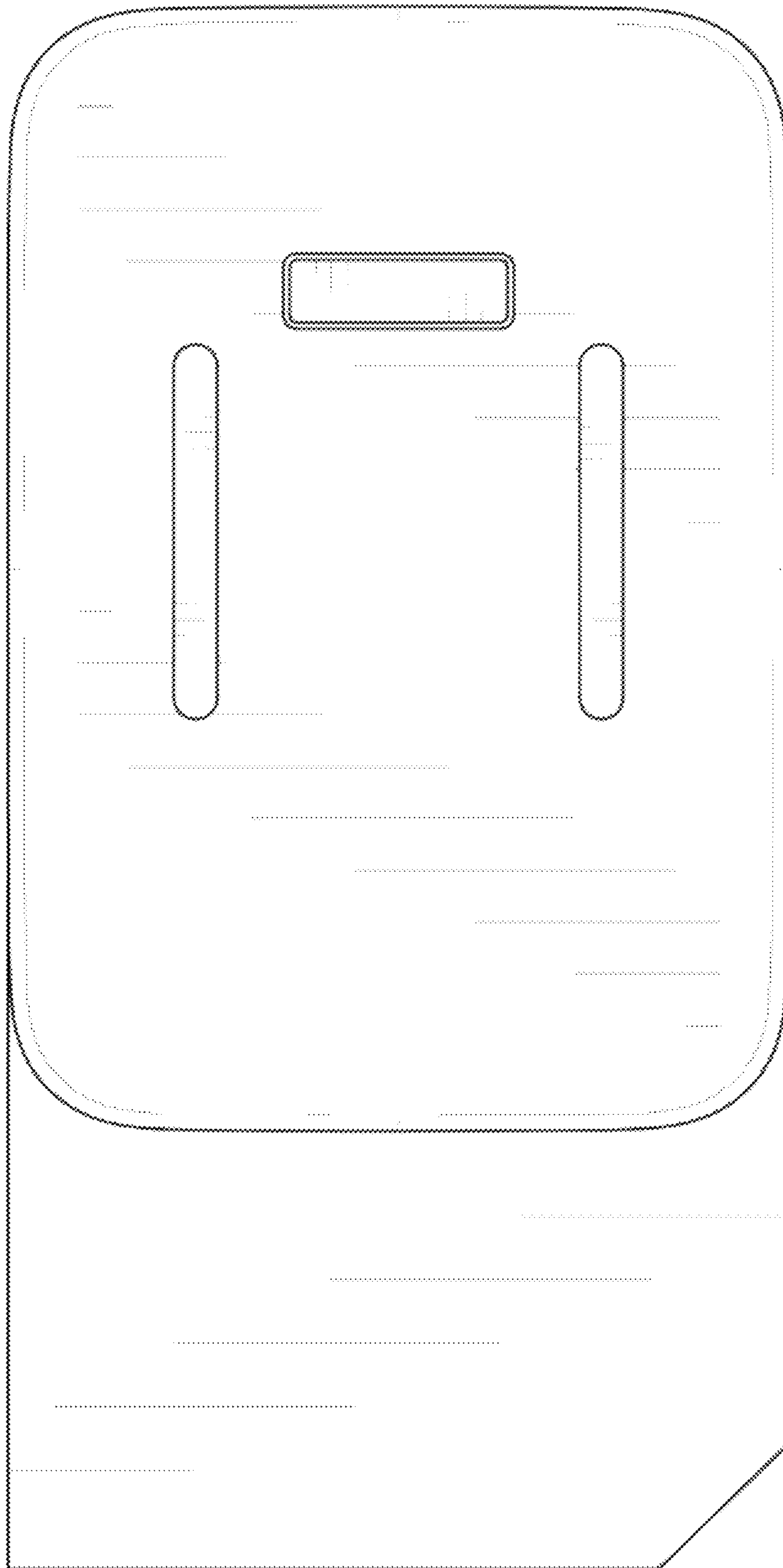

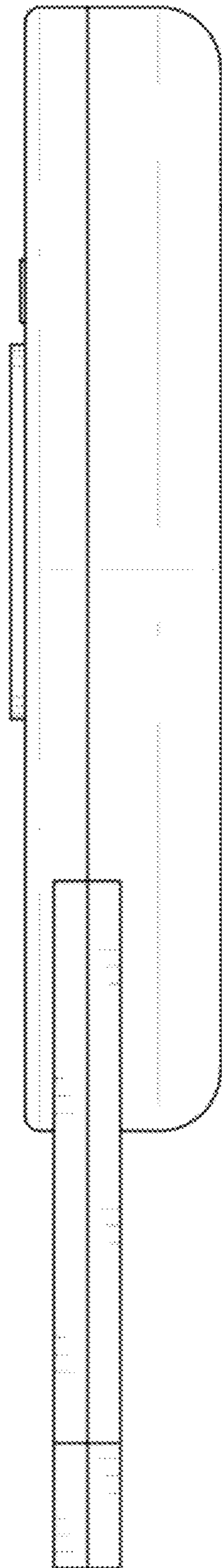

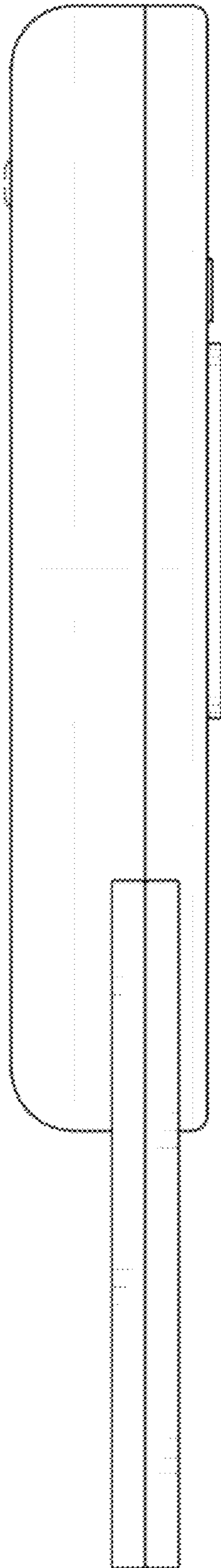

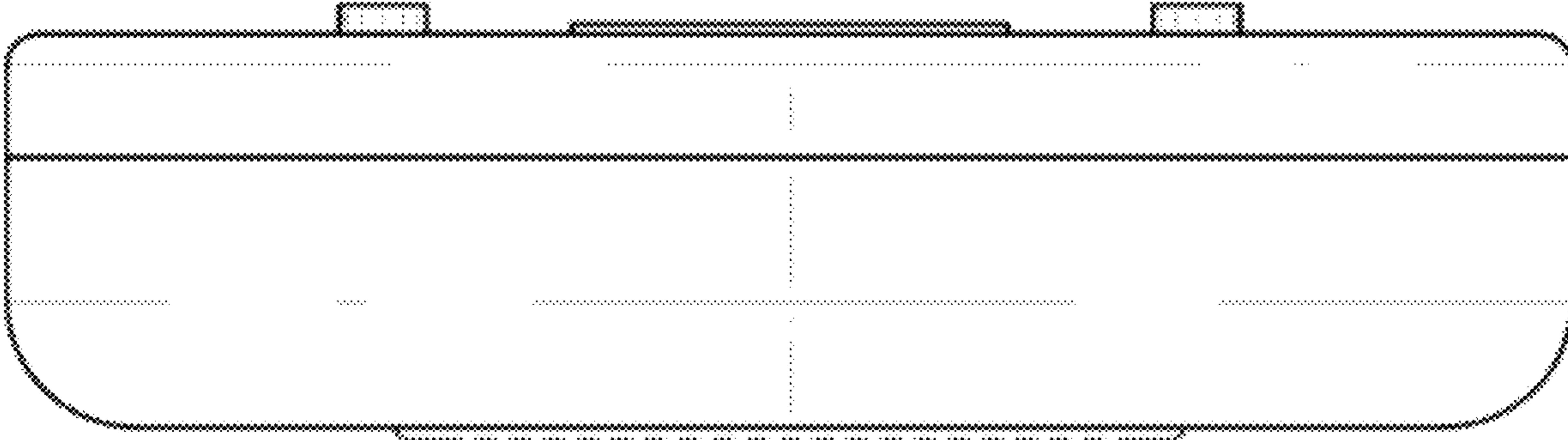
