DESCRIPTION

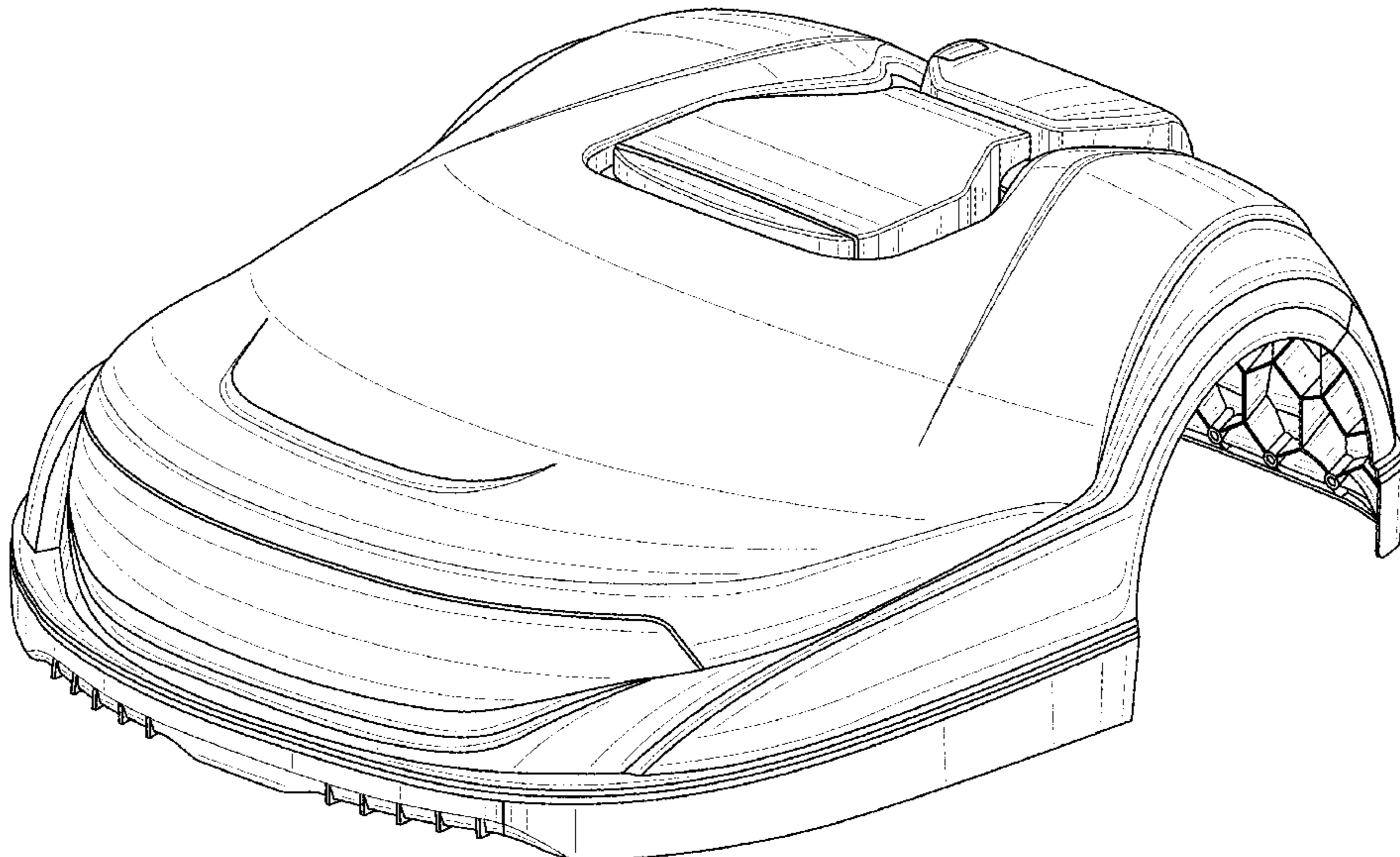
FIG. 1 is a top front perspective view of a robotic mower body showing our new design;

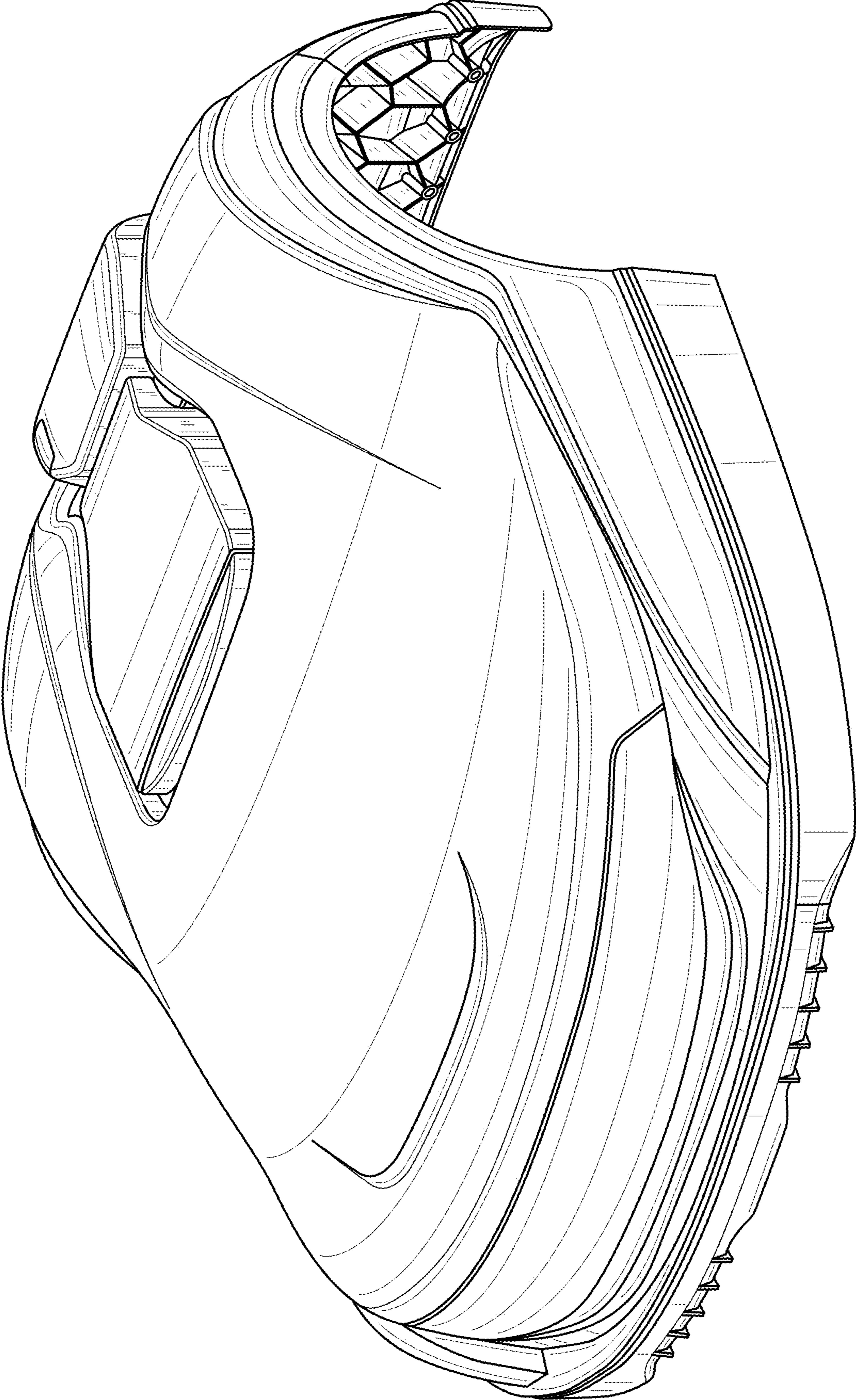

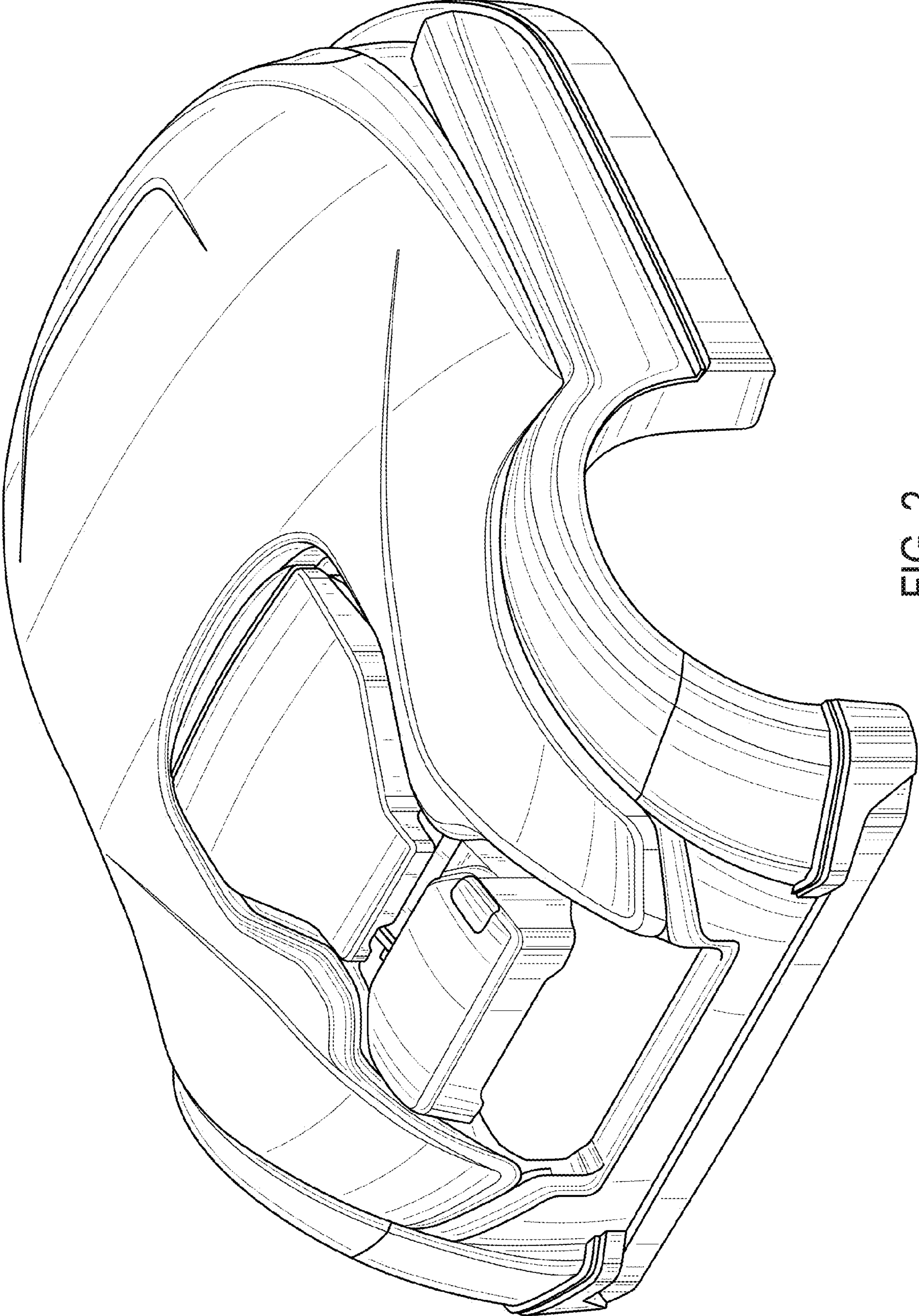

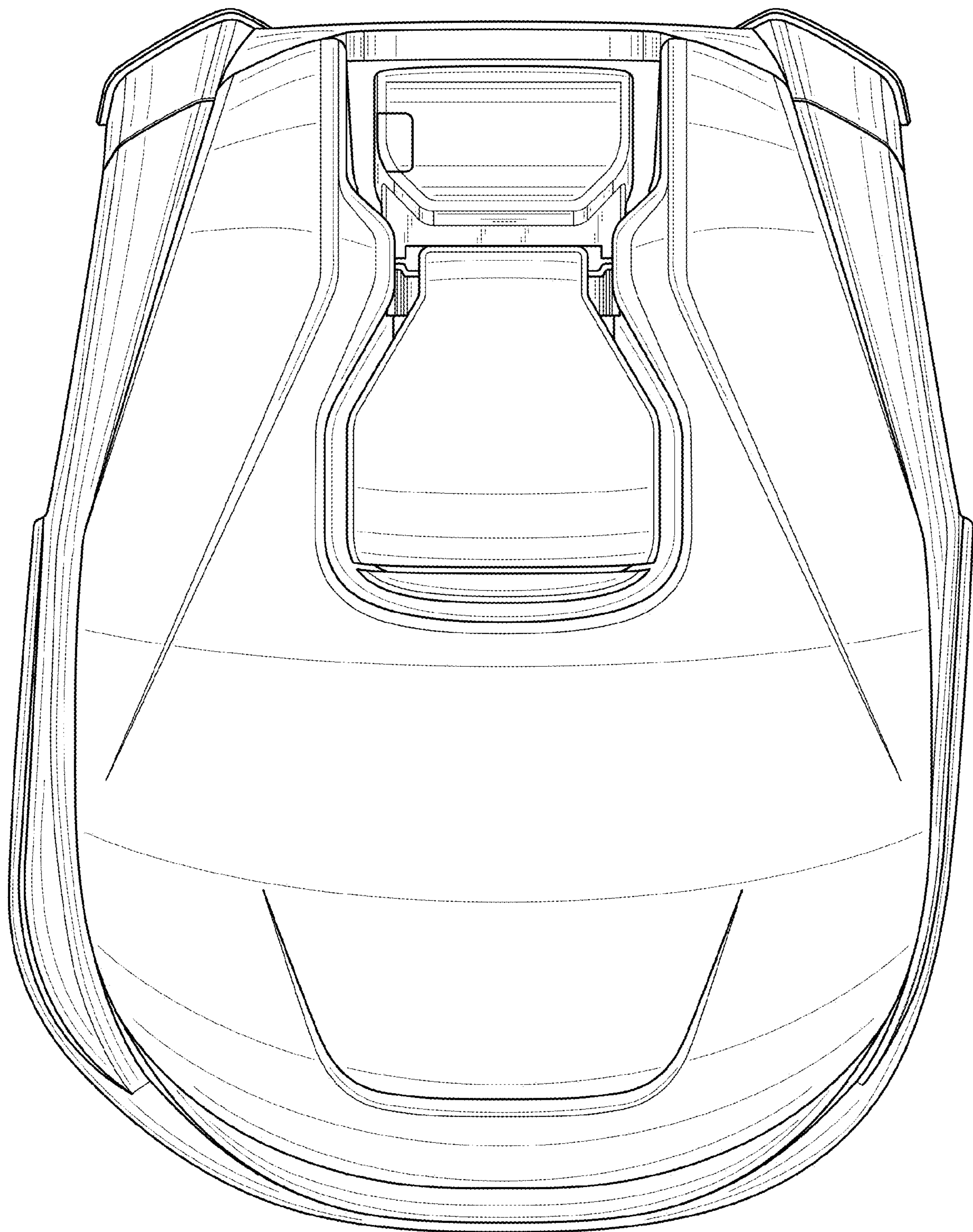

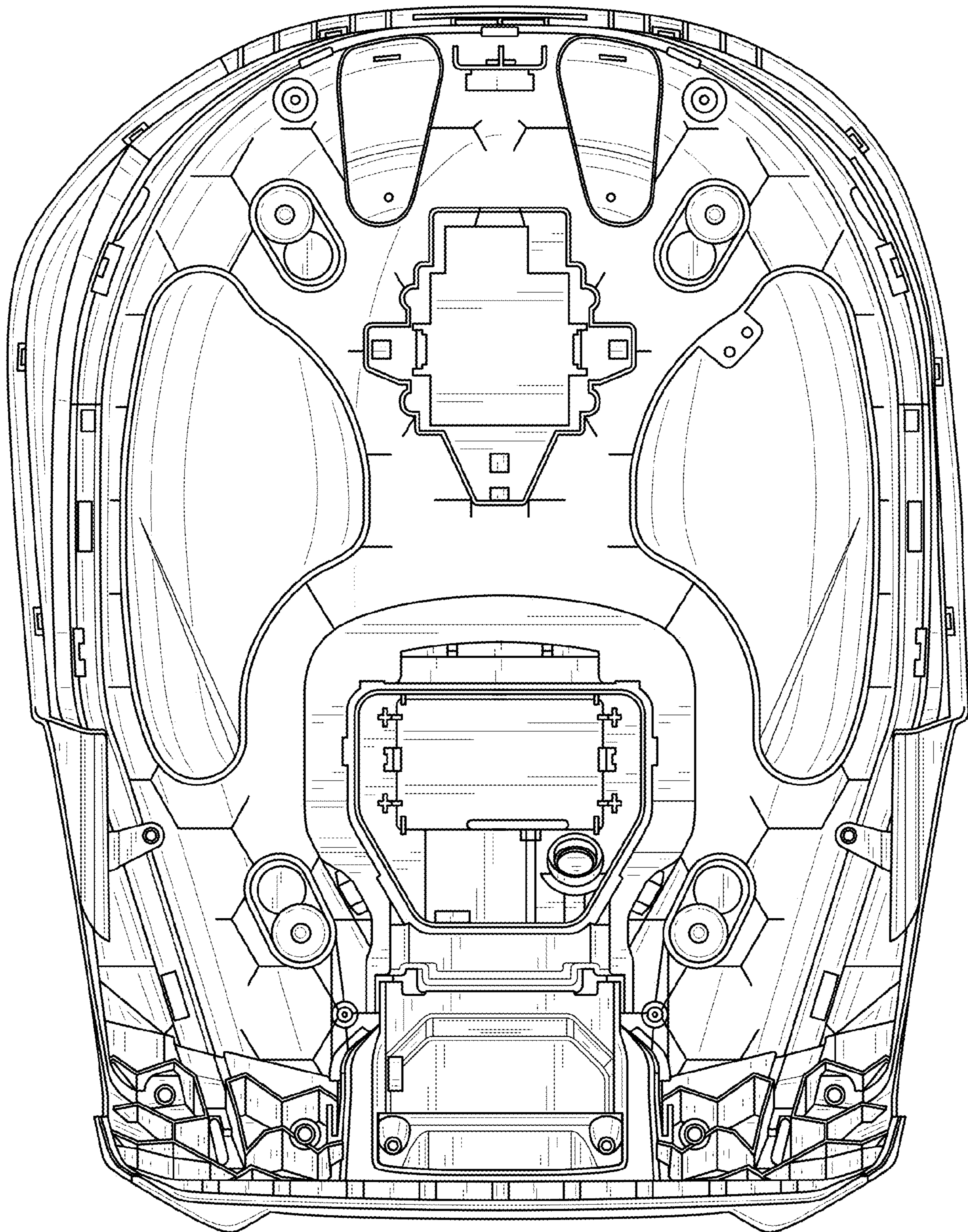

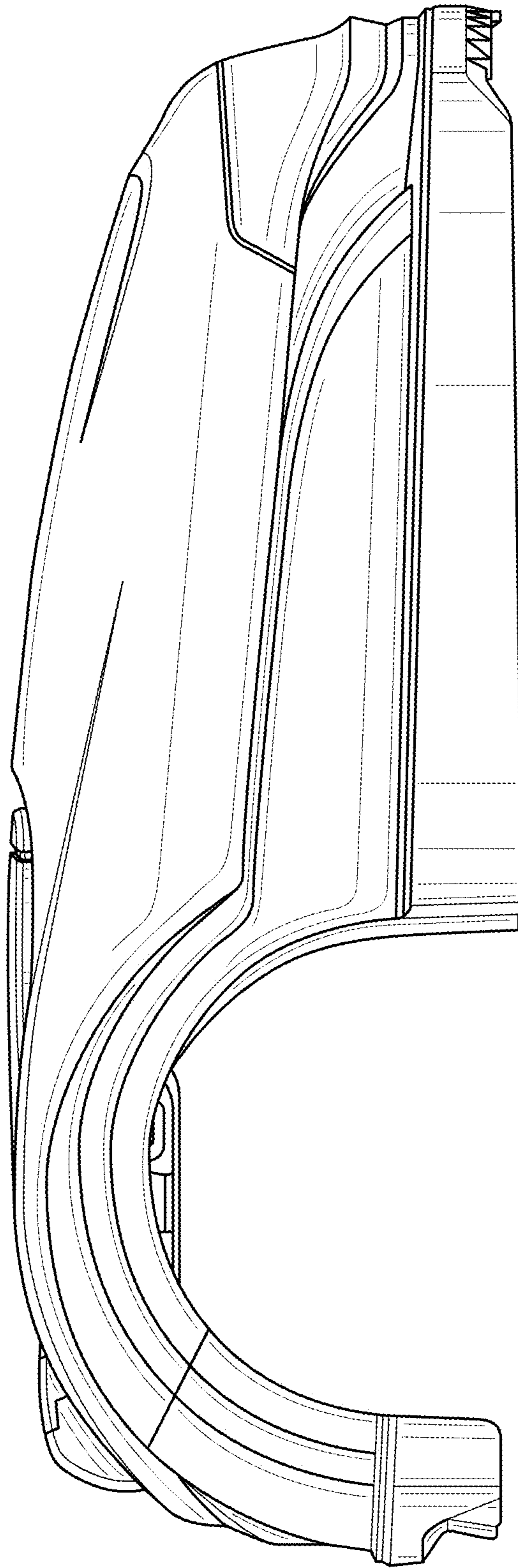

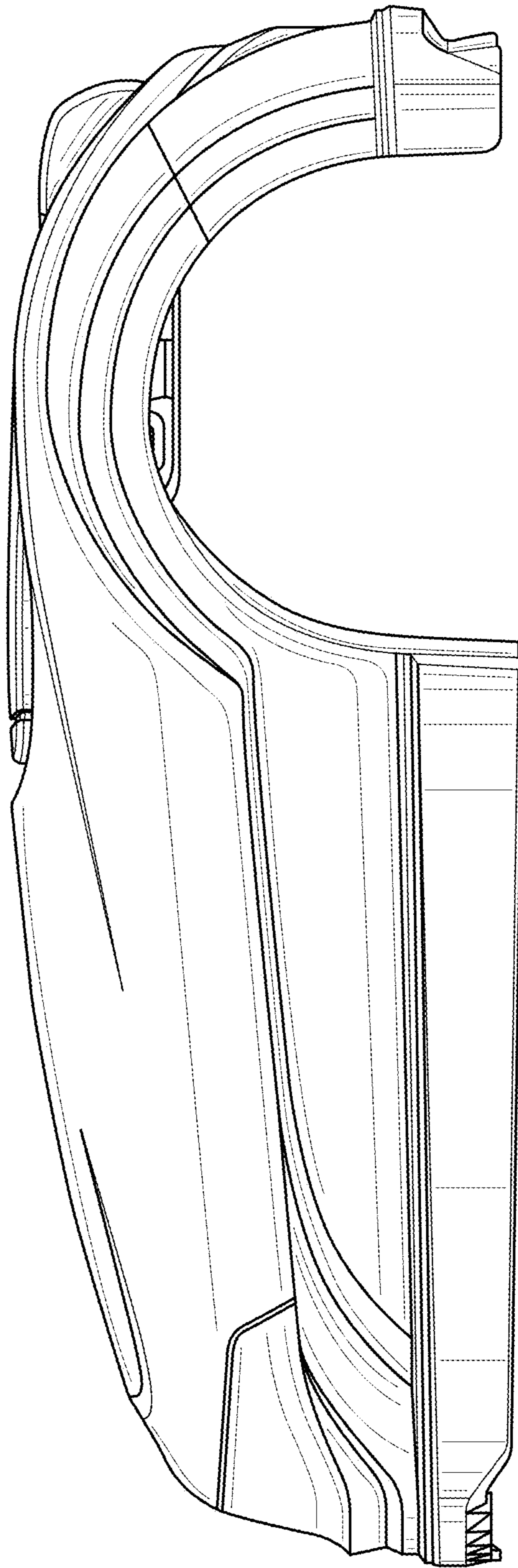

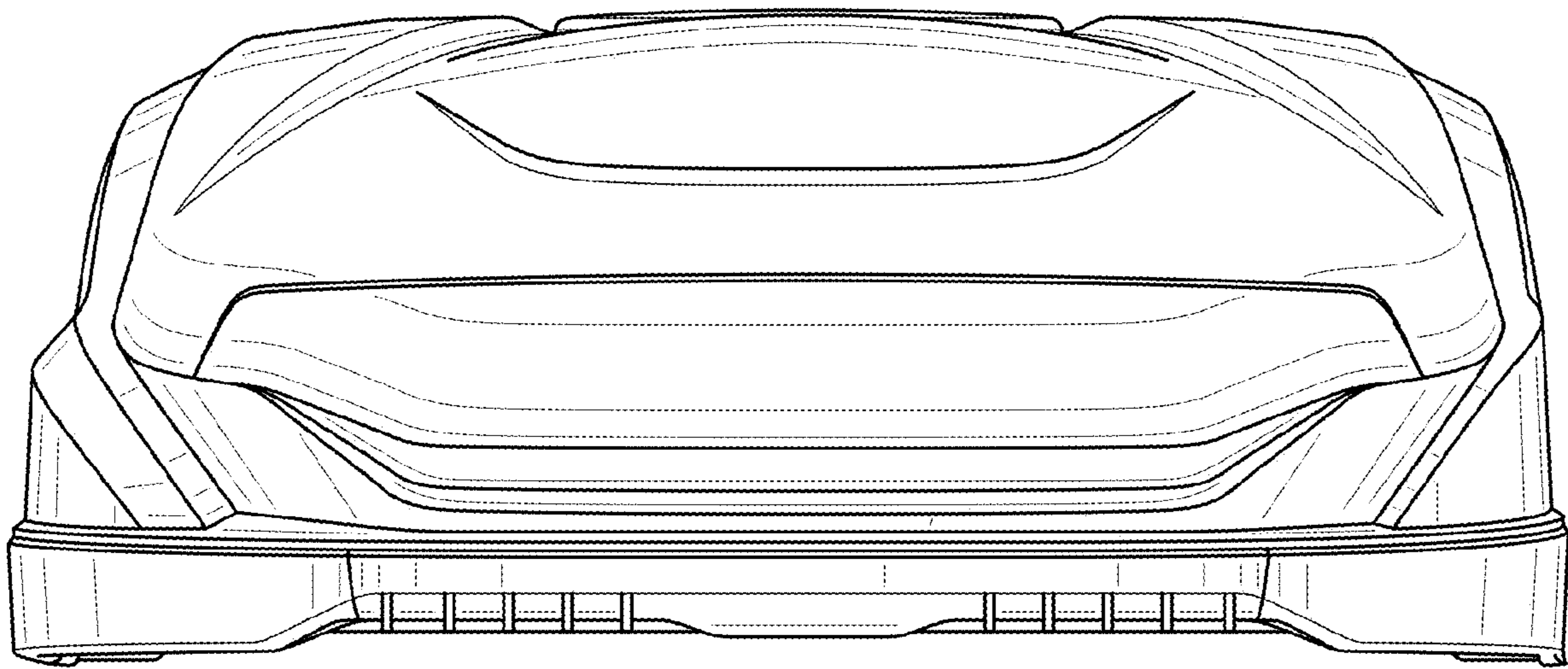

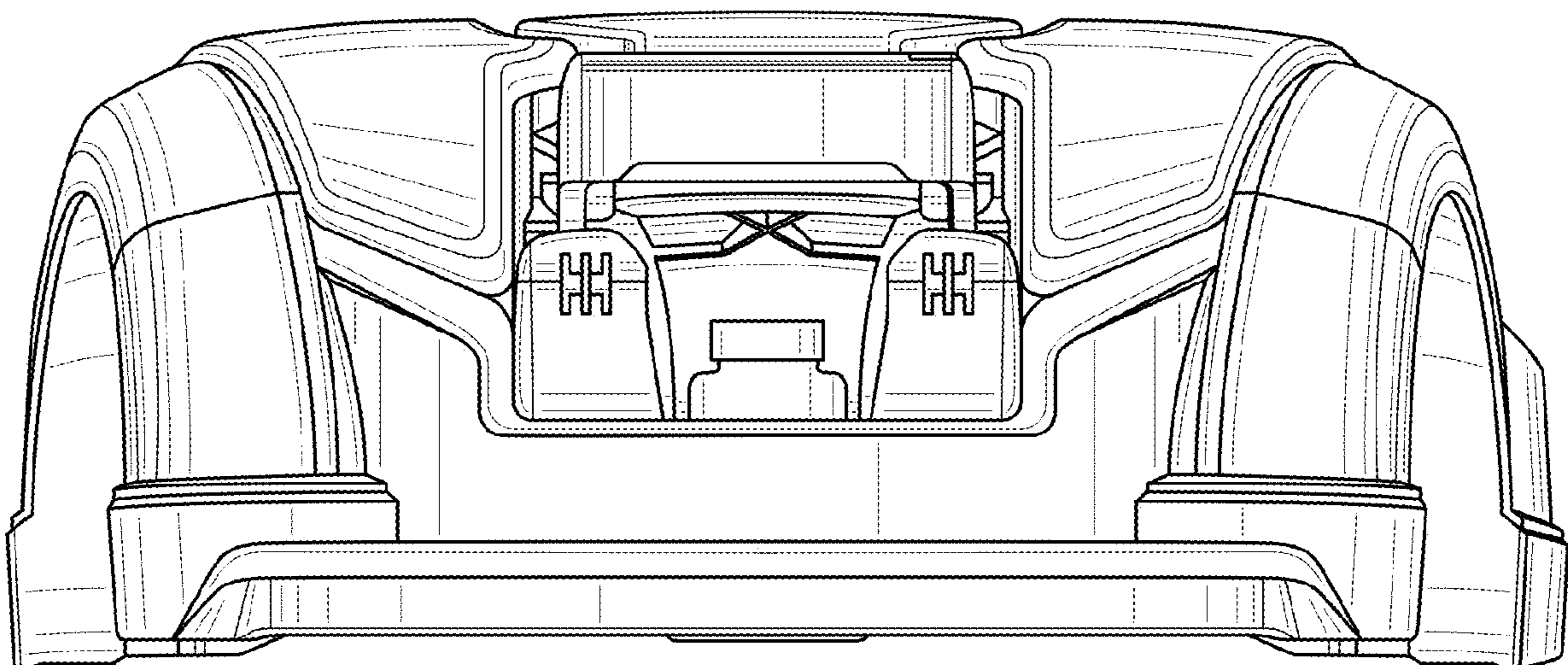
