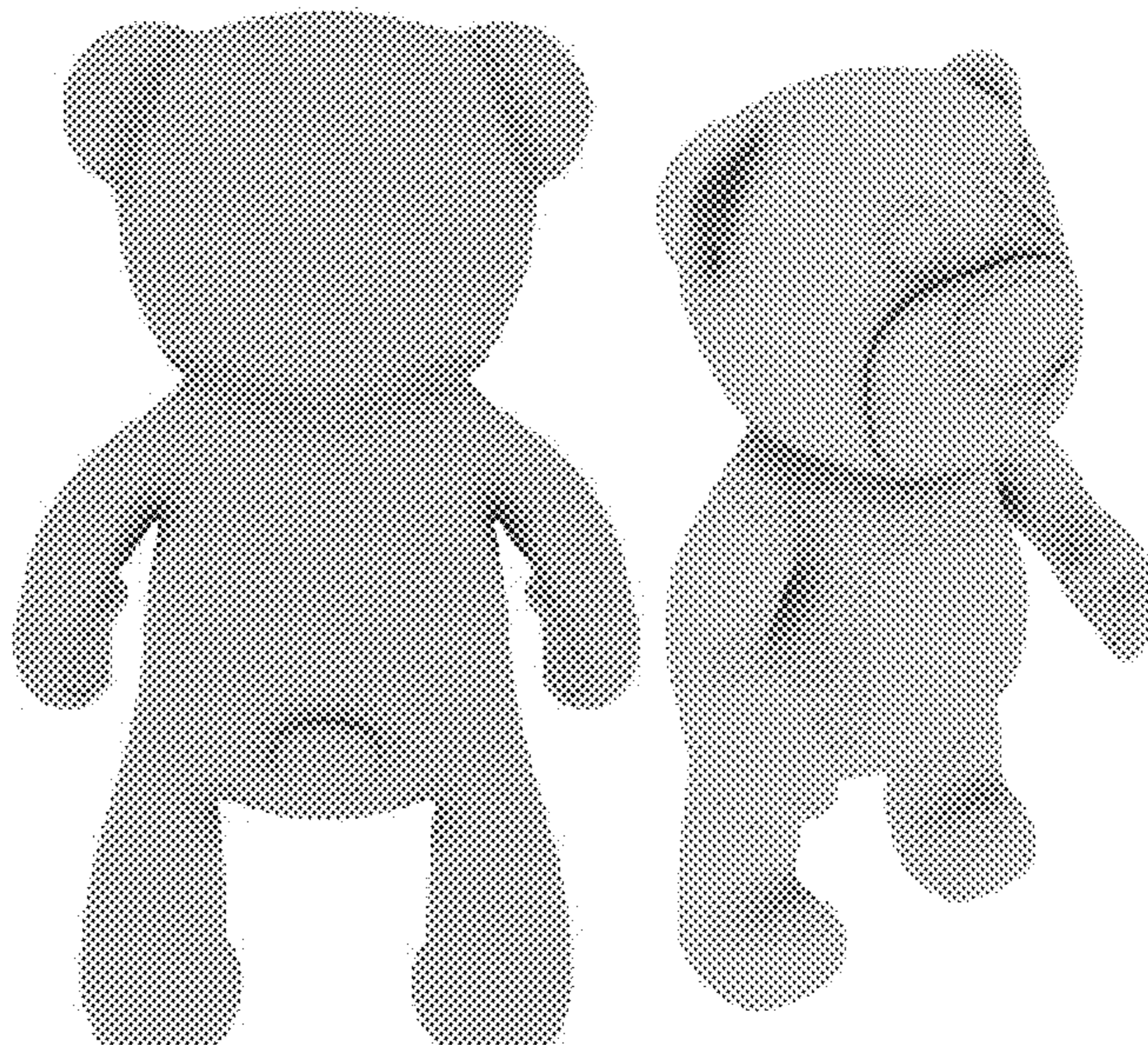

The ornamental design for a toy, as shown and described.

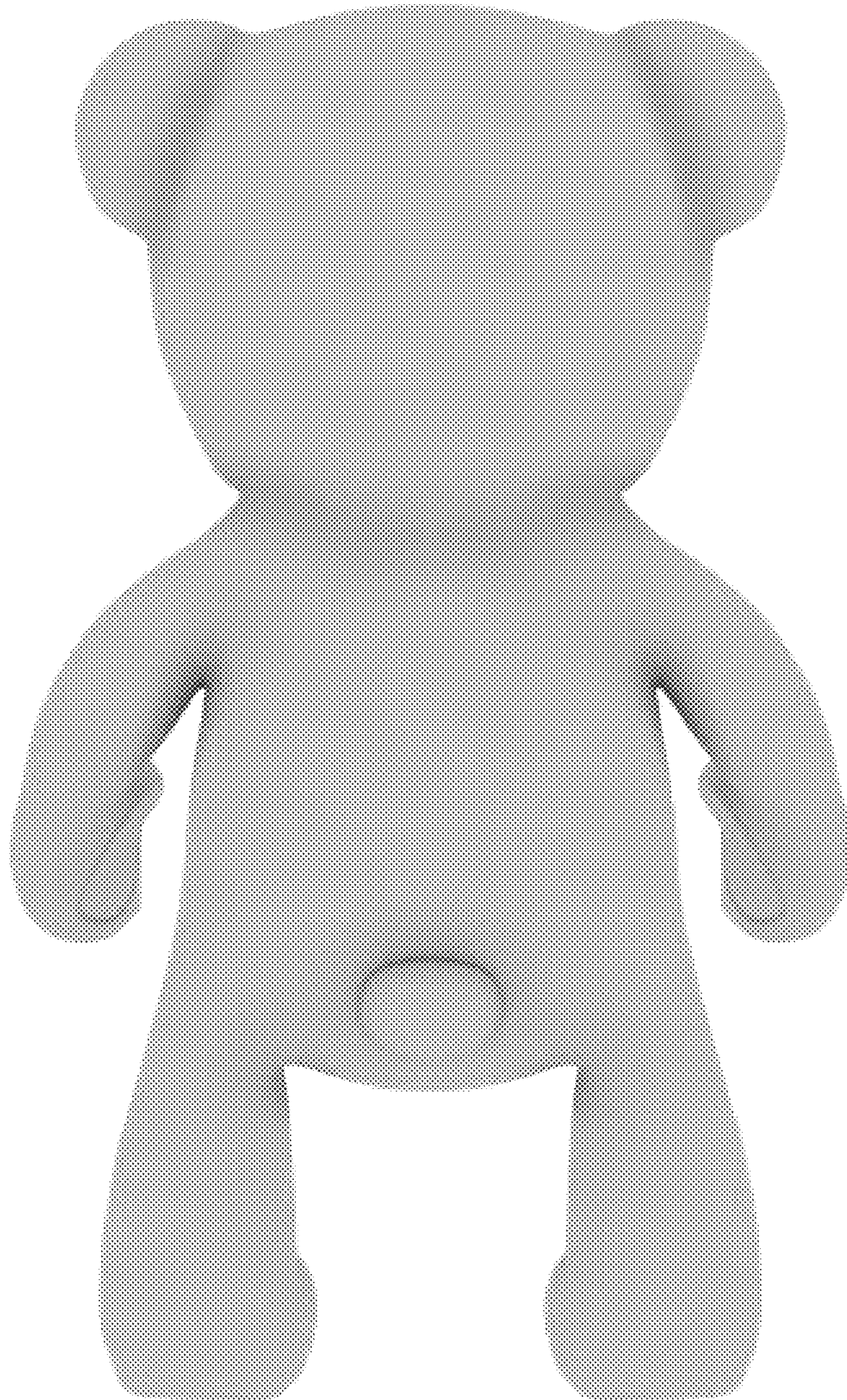
DESCRIPTION

- No. 1.8. show the toy from a top right angle.

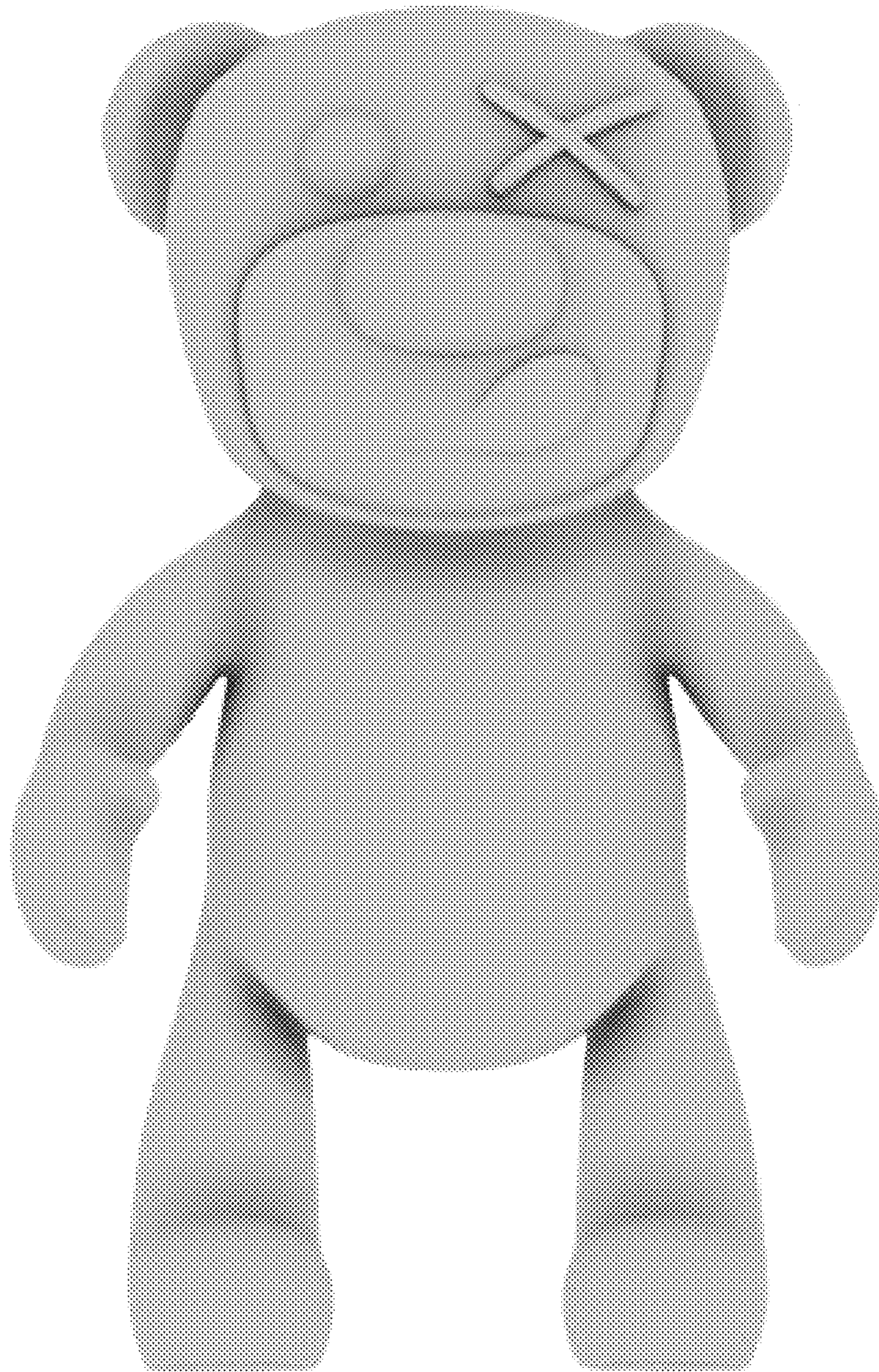

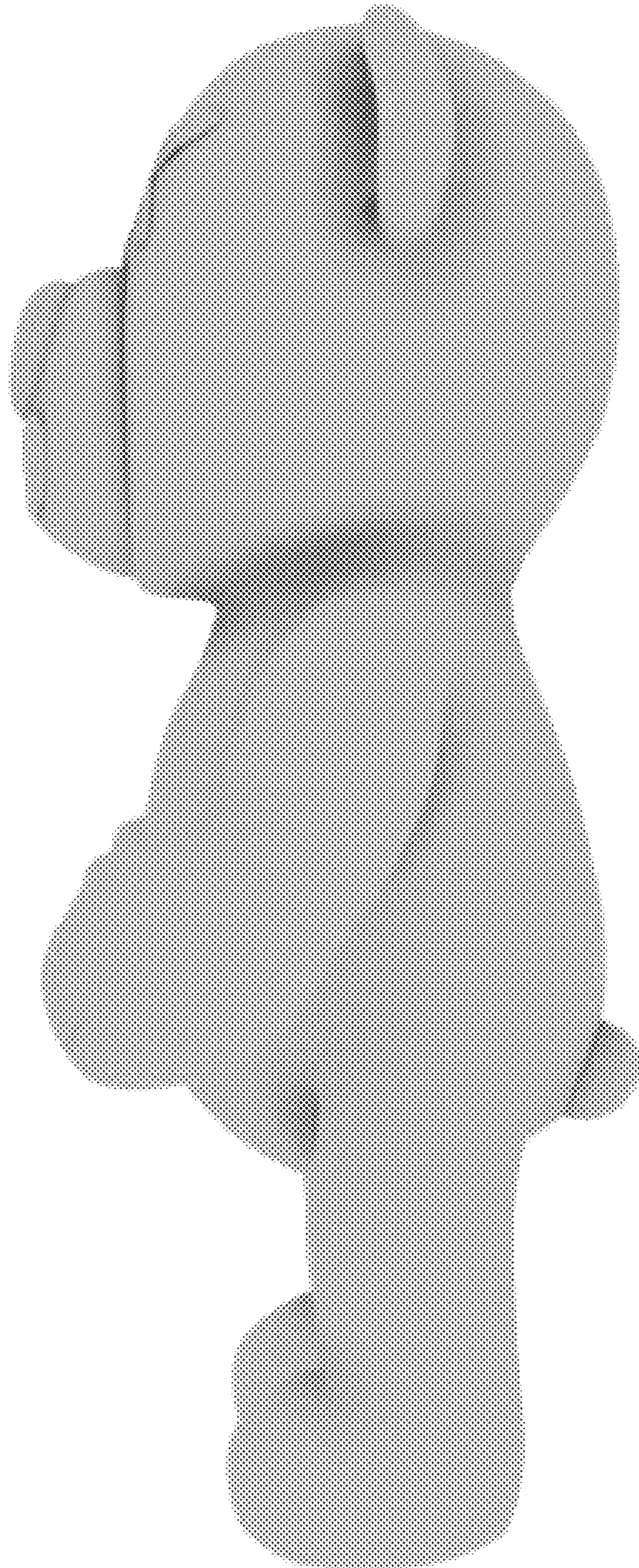

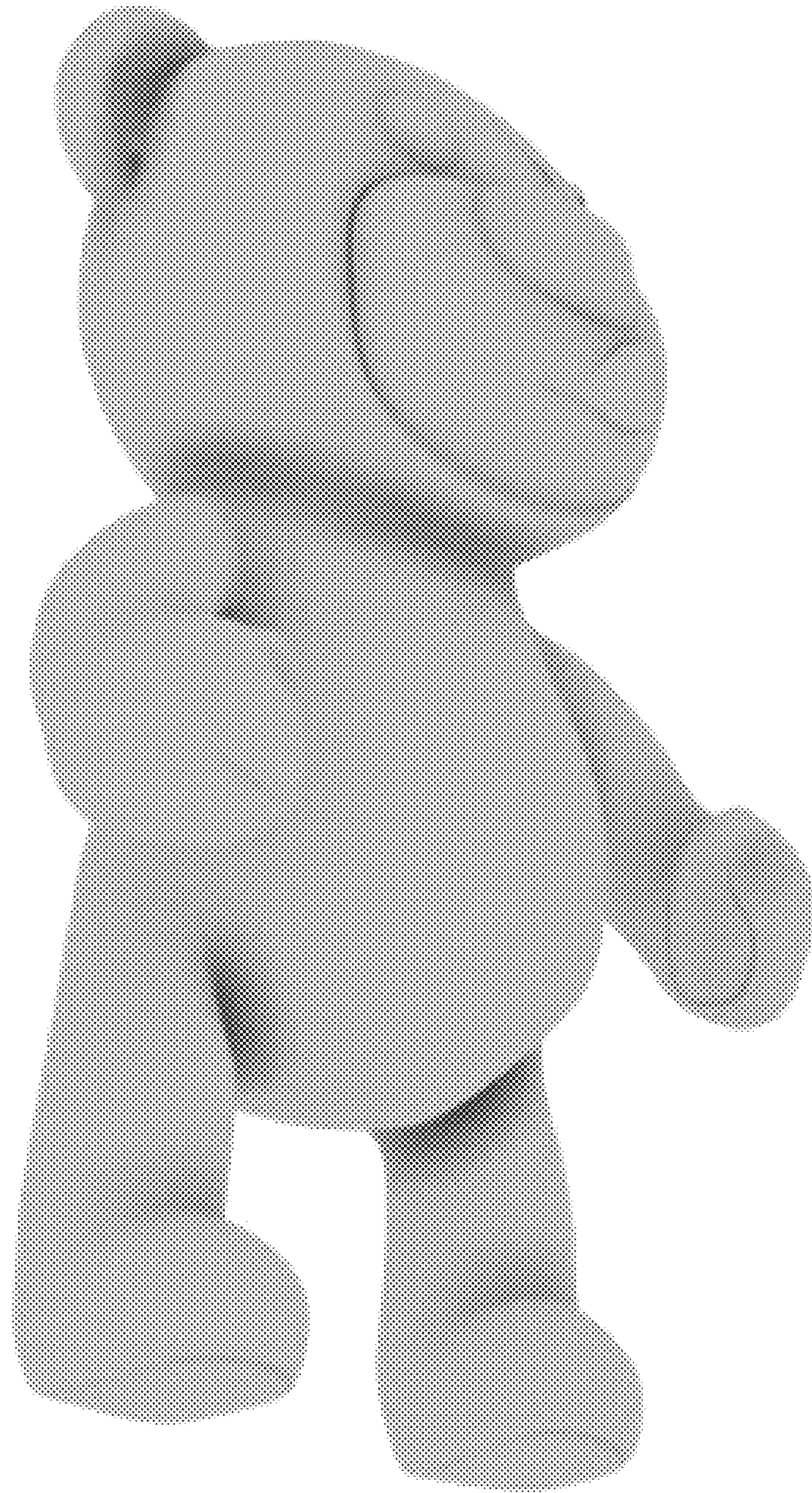

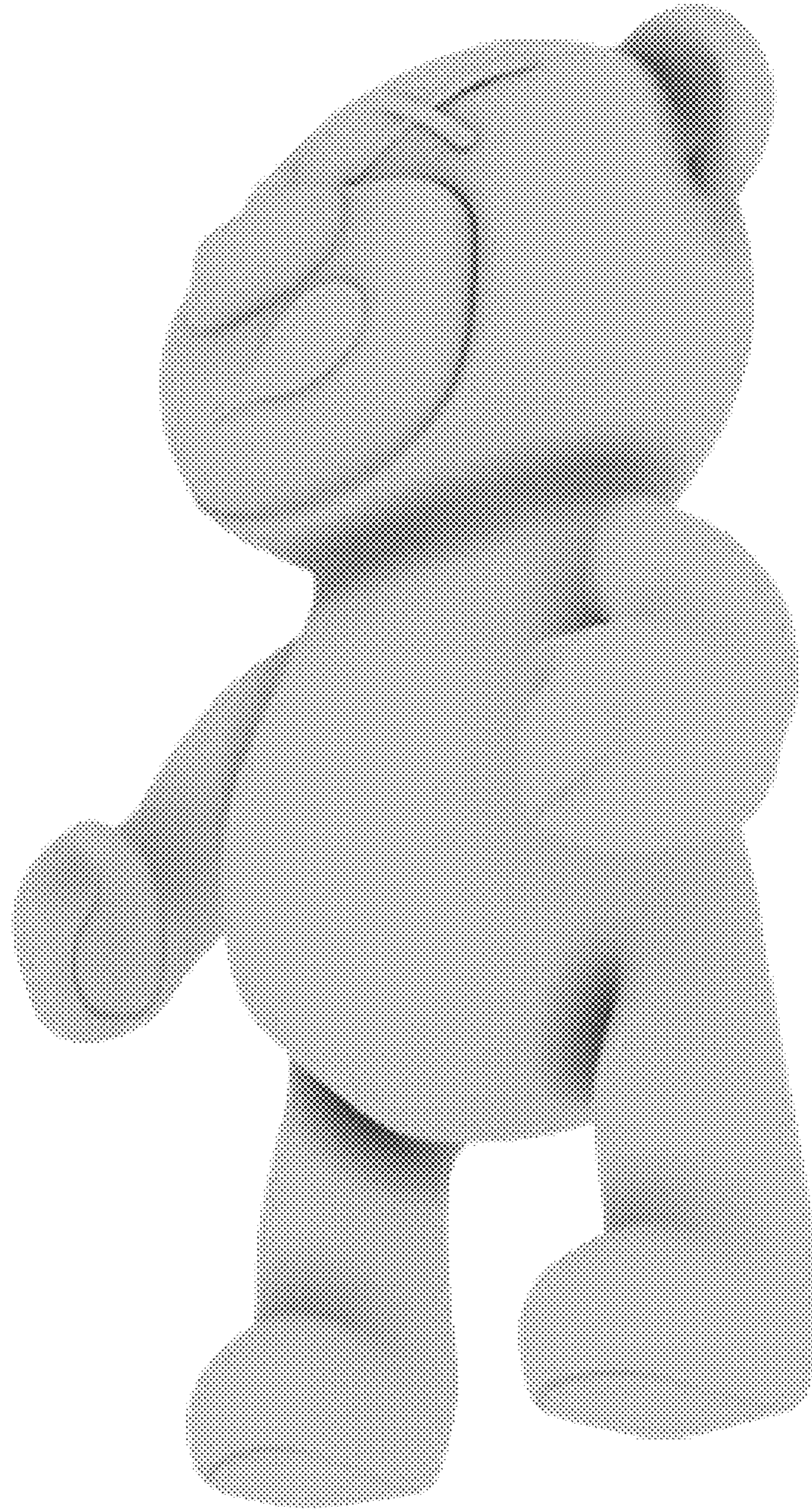

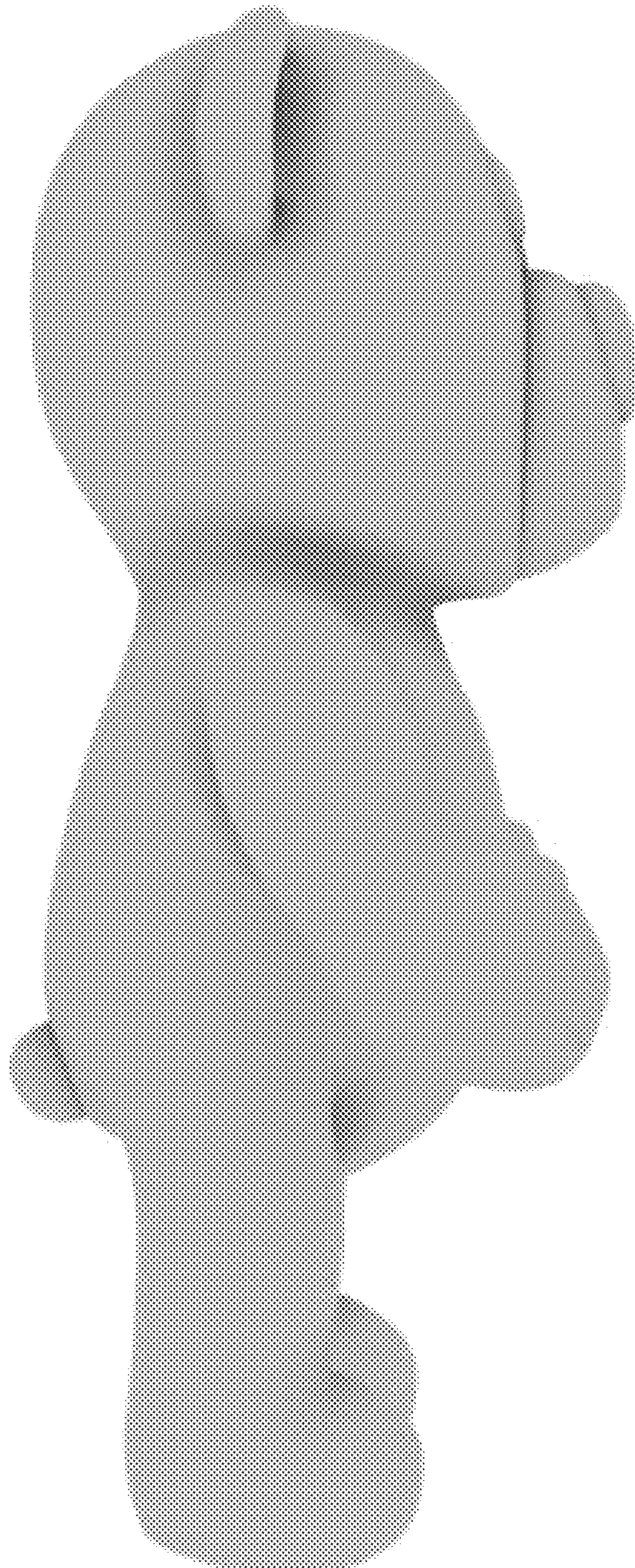

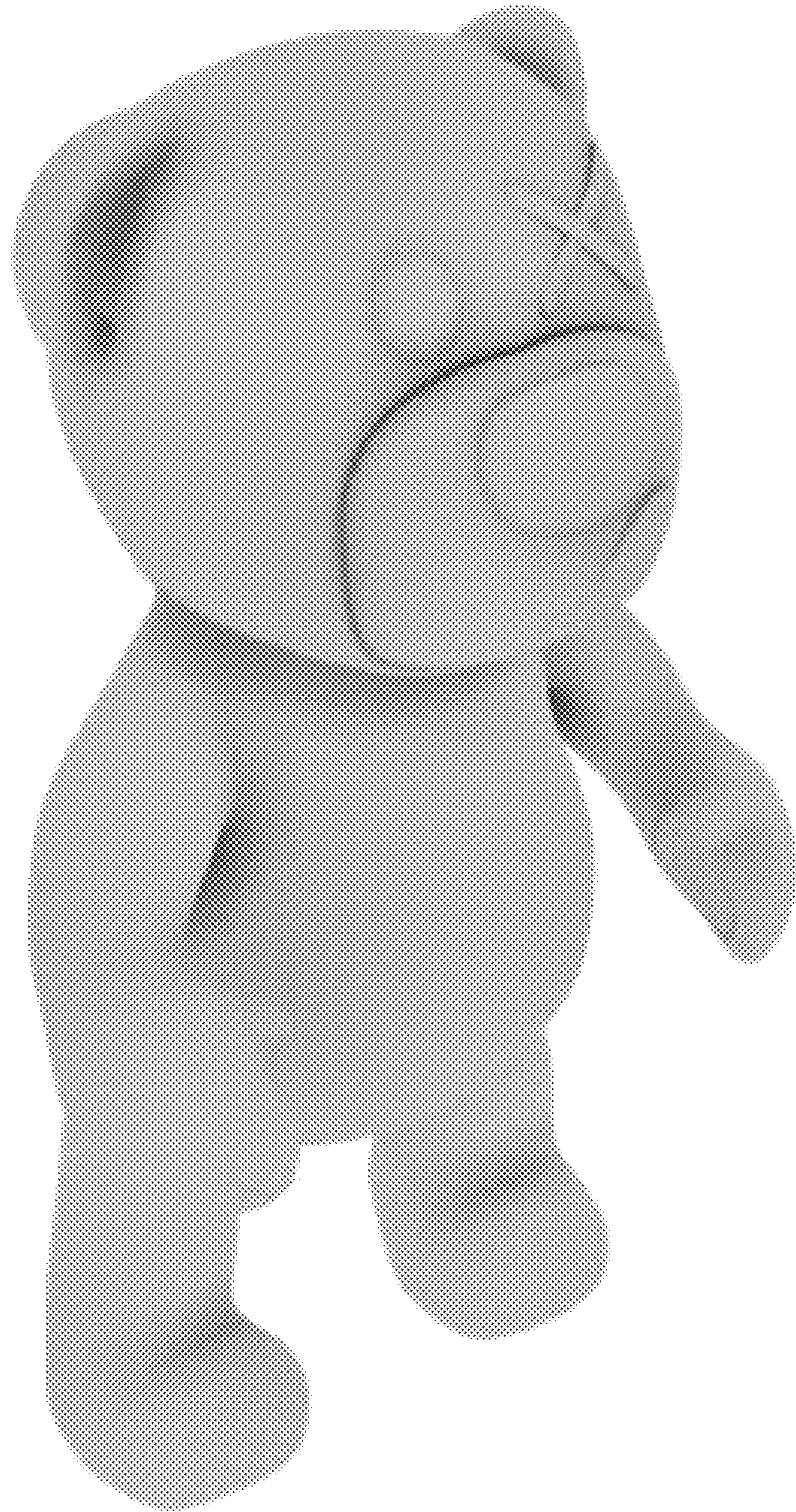
