DESCRIPTION

FIG. 1 is a perspective view of a beach tent showing my new design;

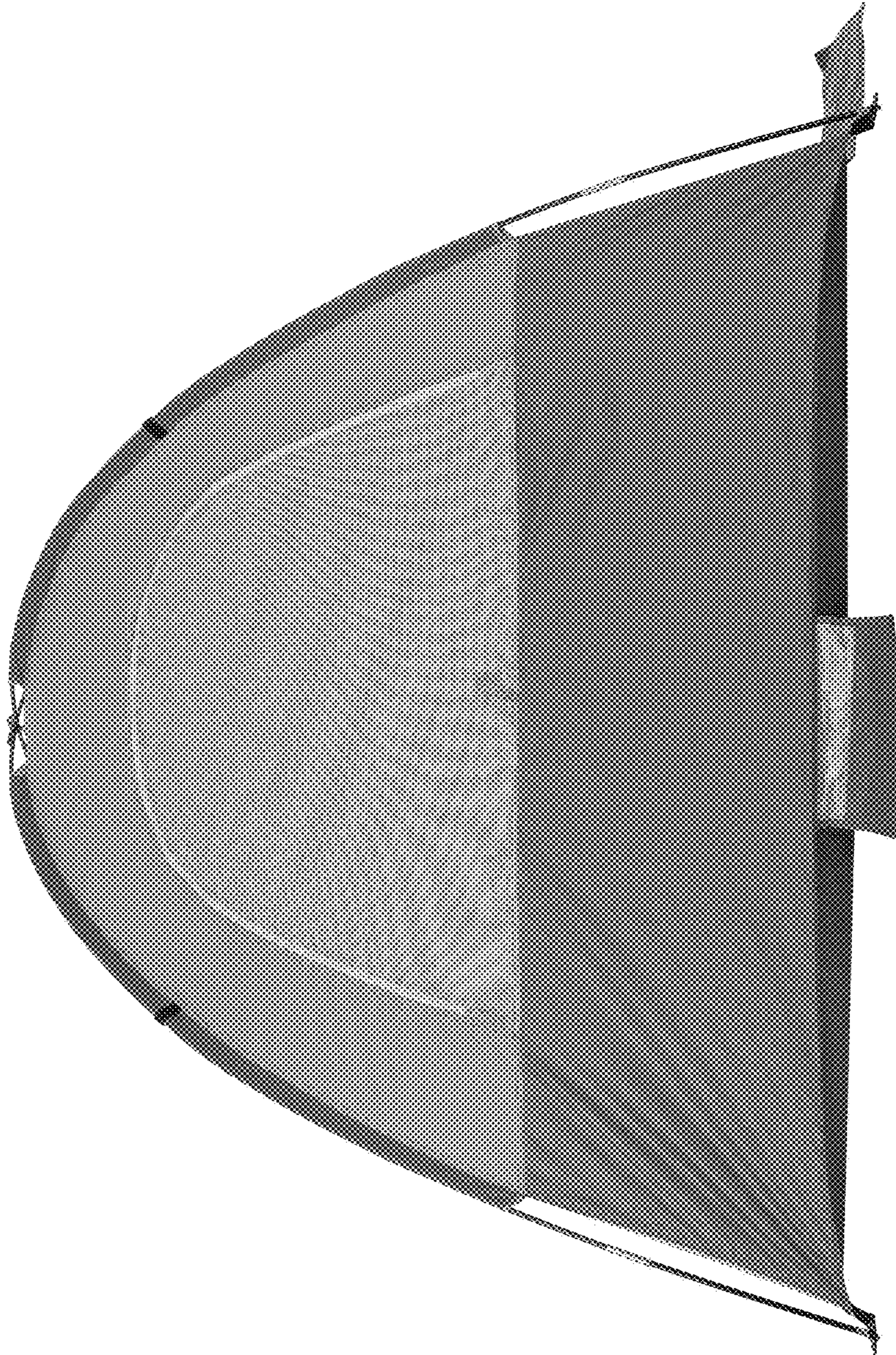

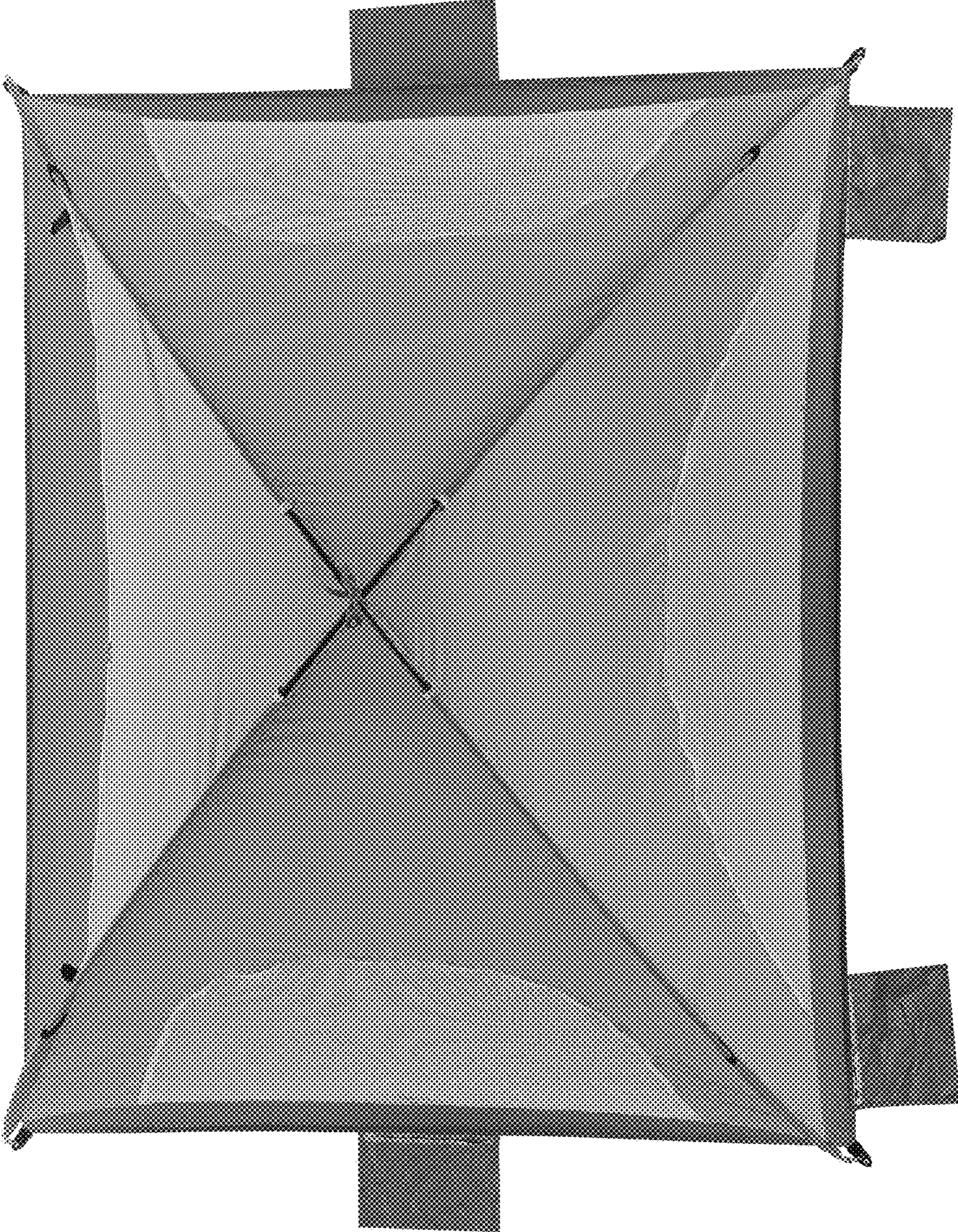

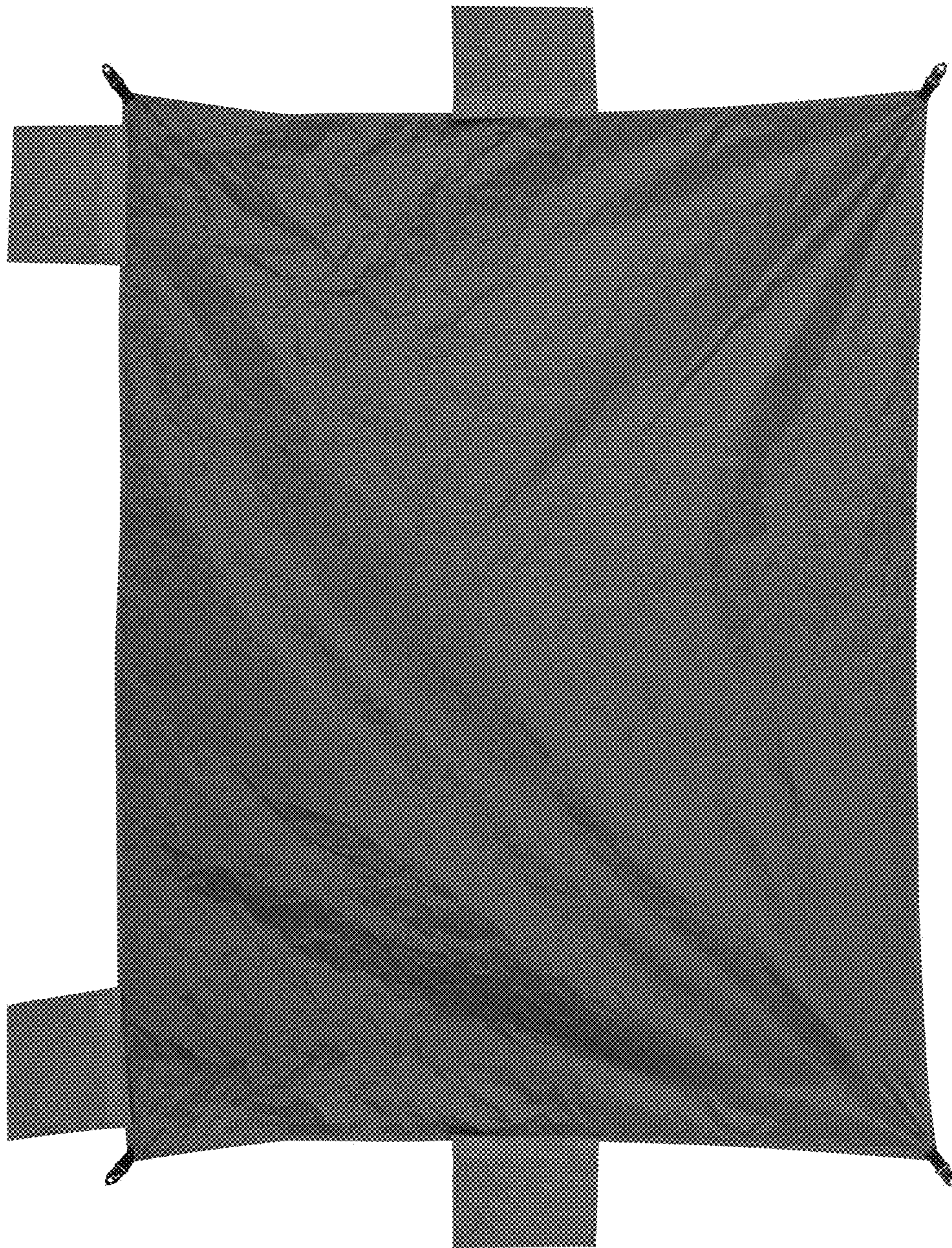
