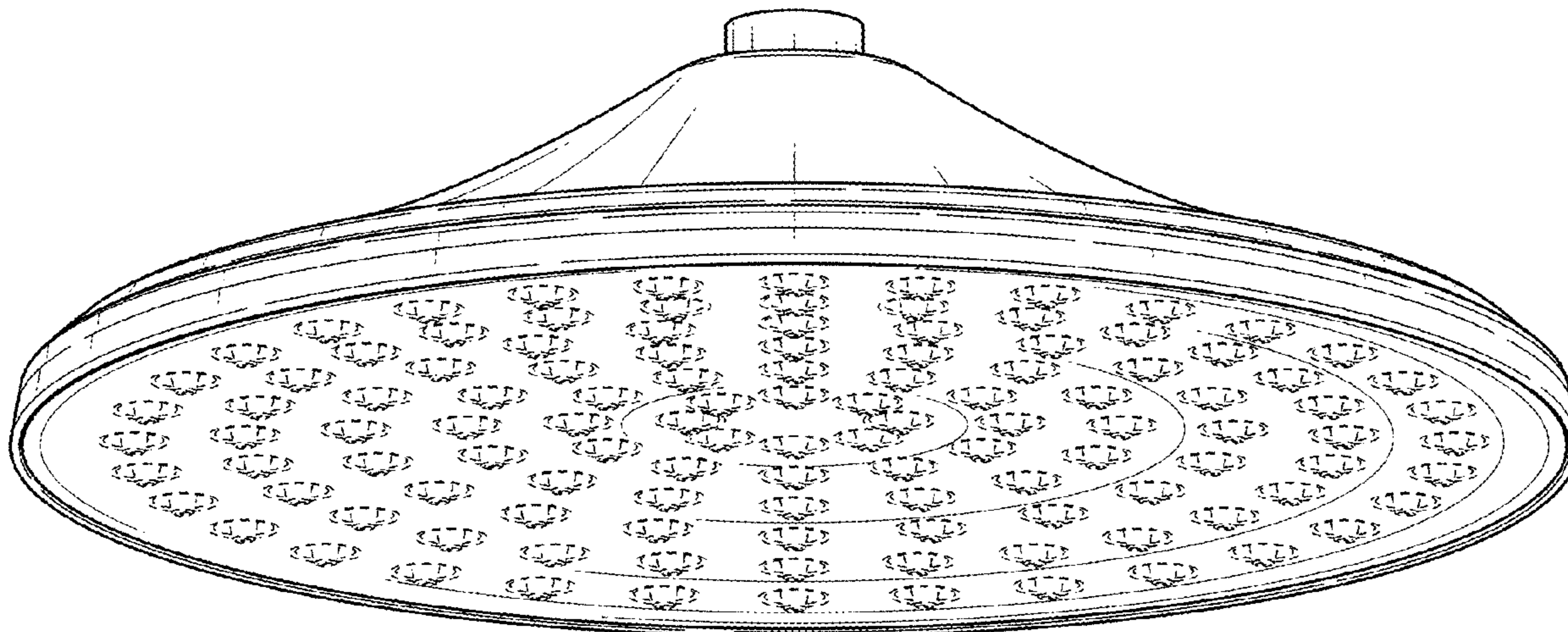
(57) **CLAIM**

I claim the ornamental design for a showerhead, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of a showerhead showing my new design;

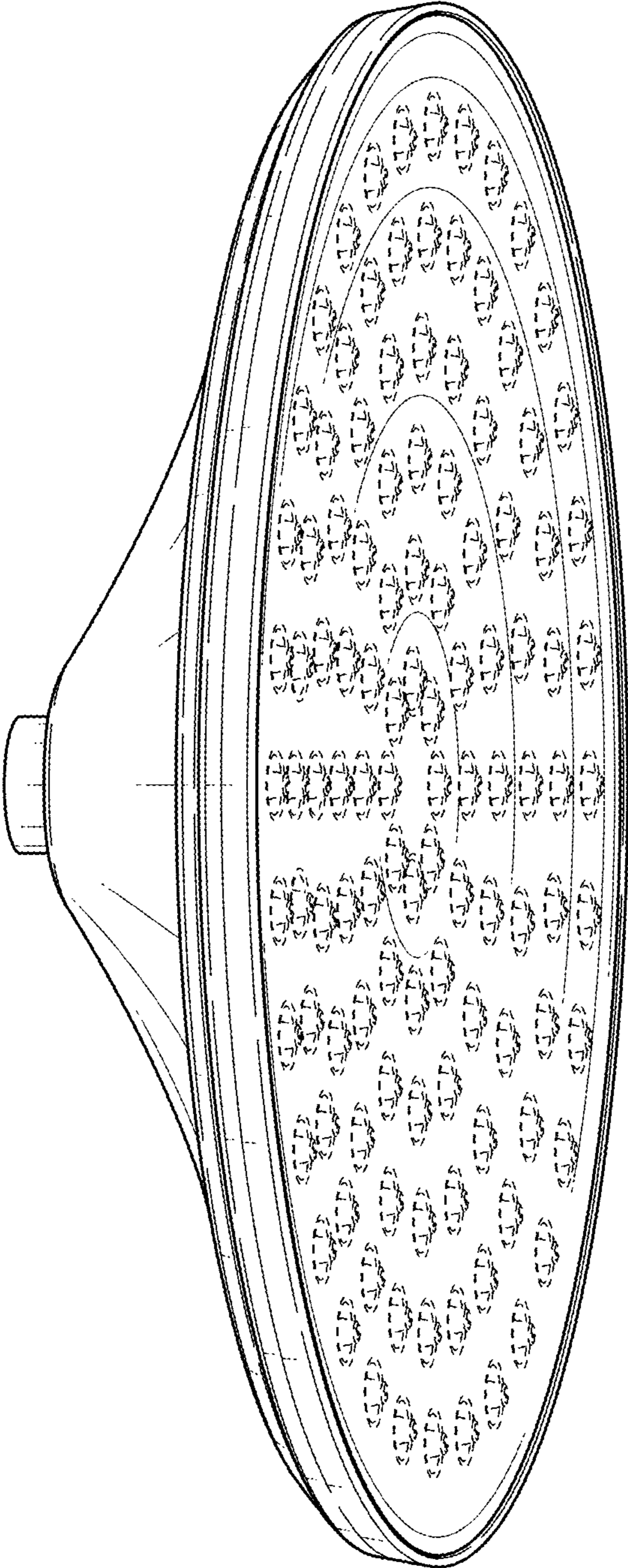

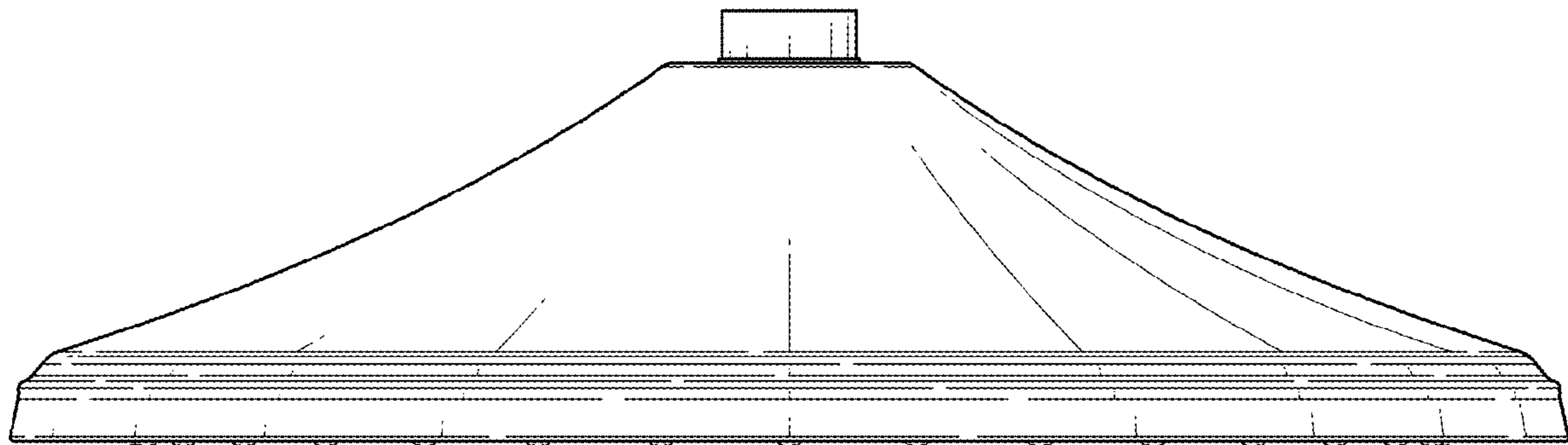

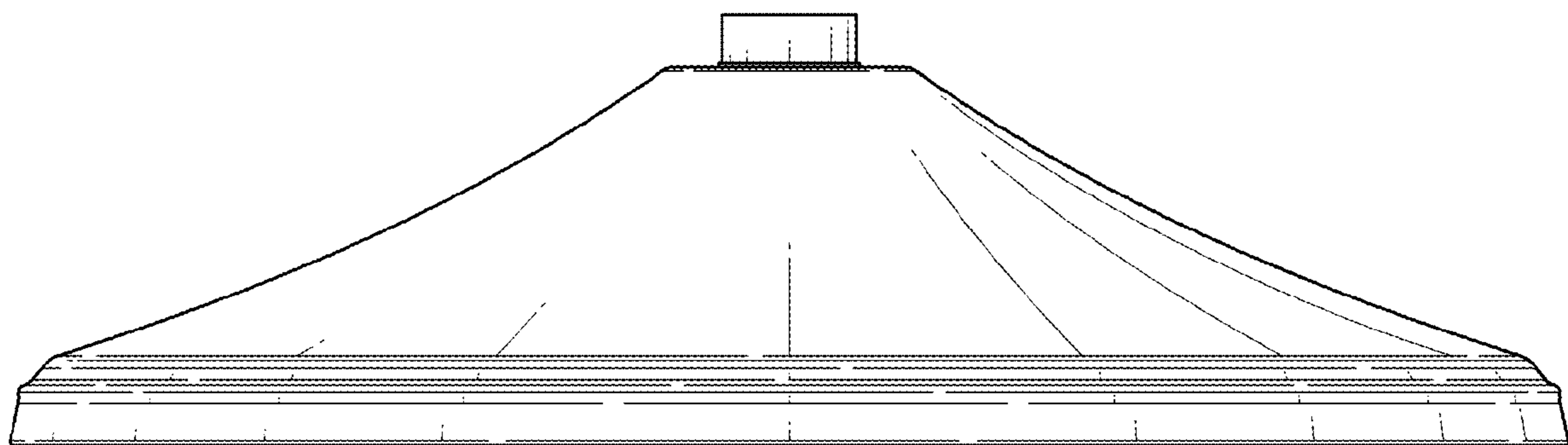

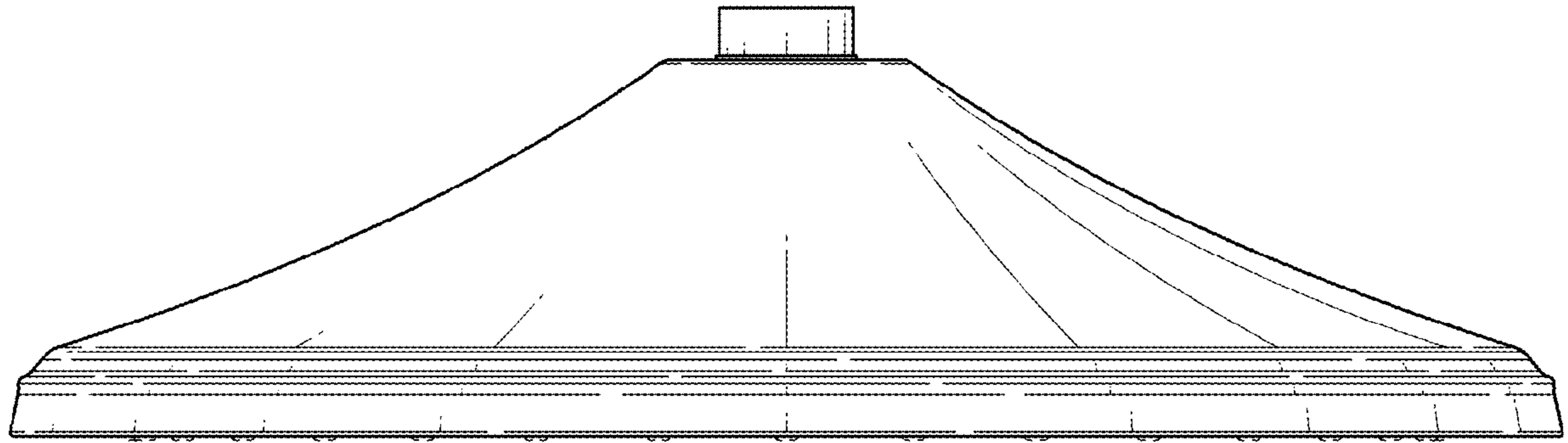

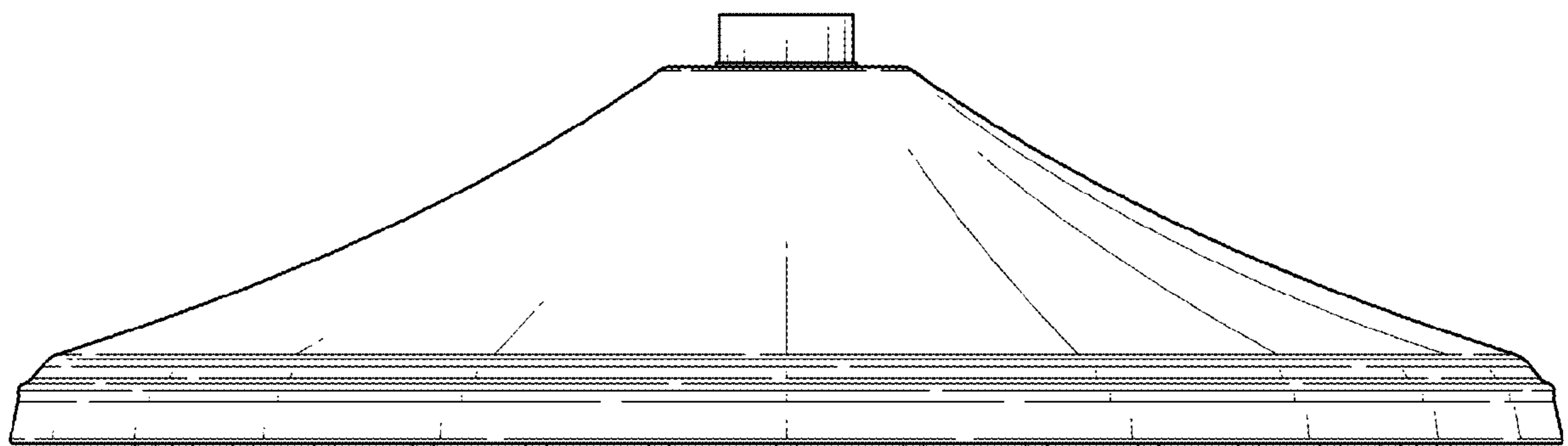

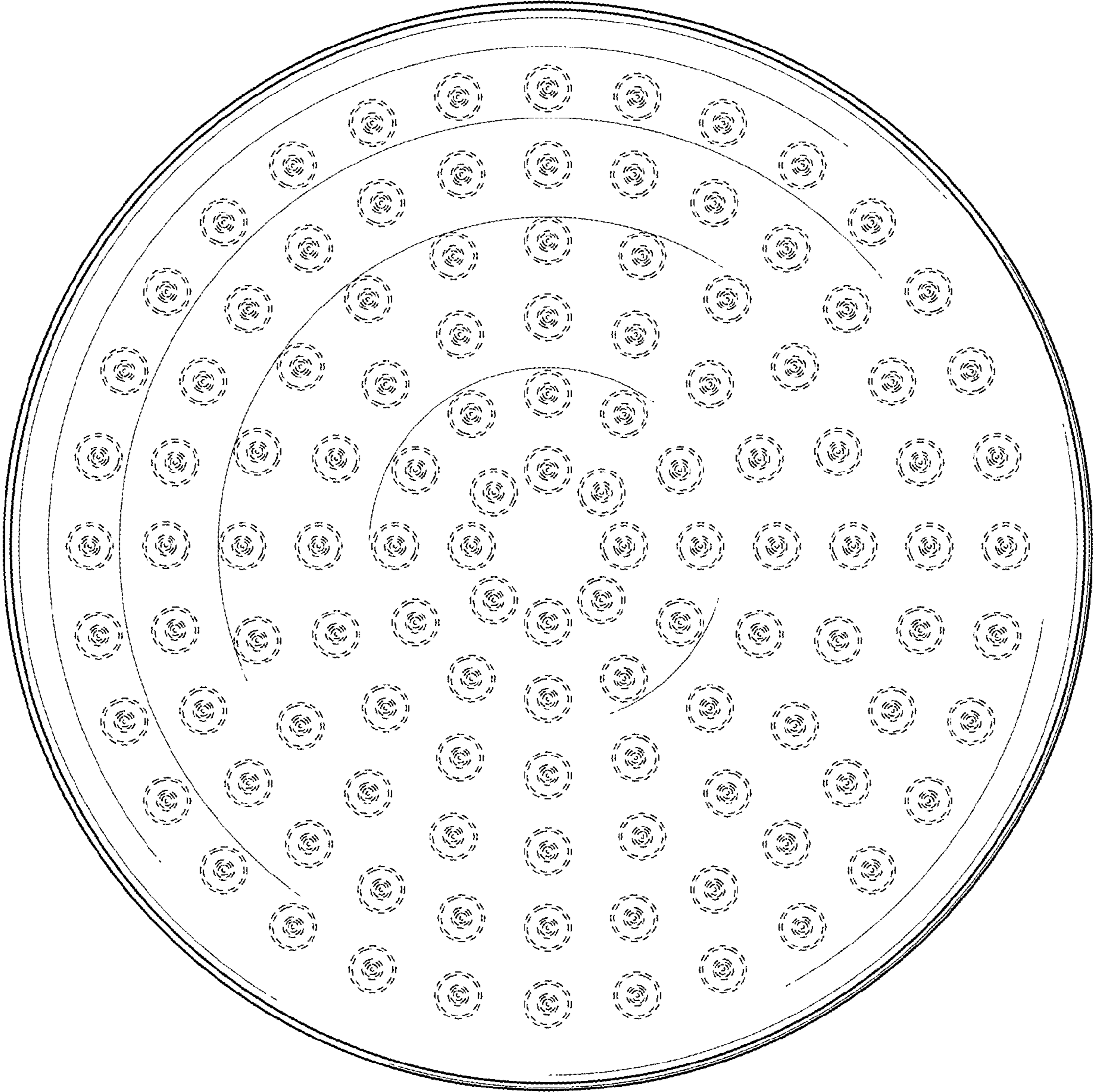

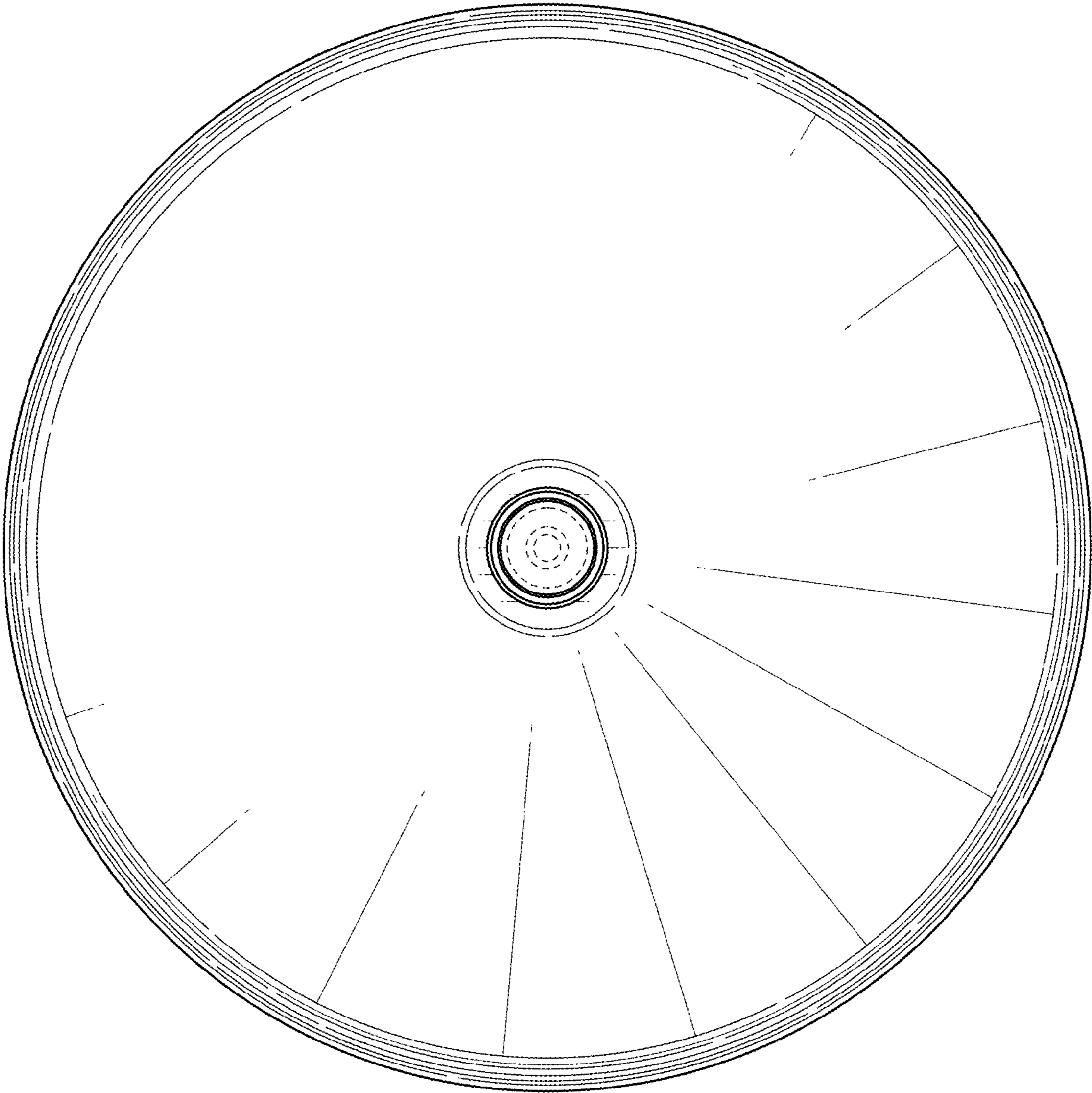

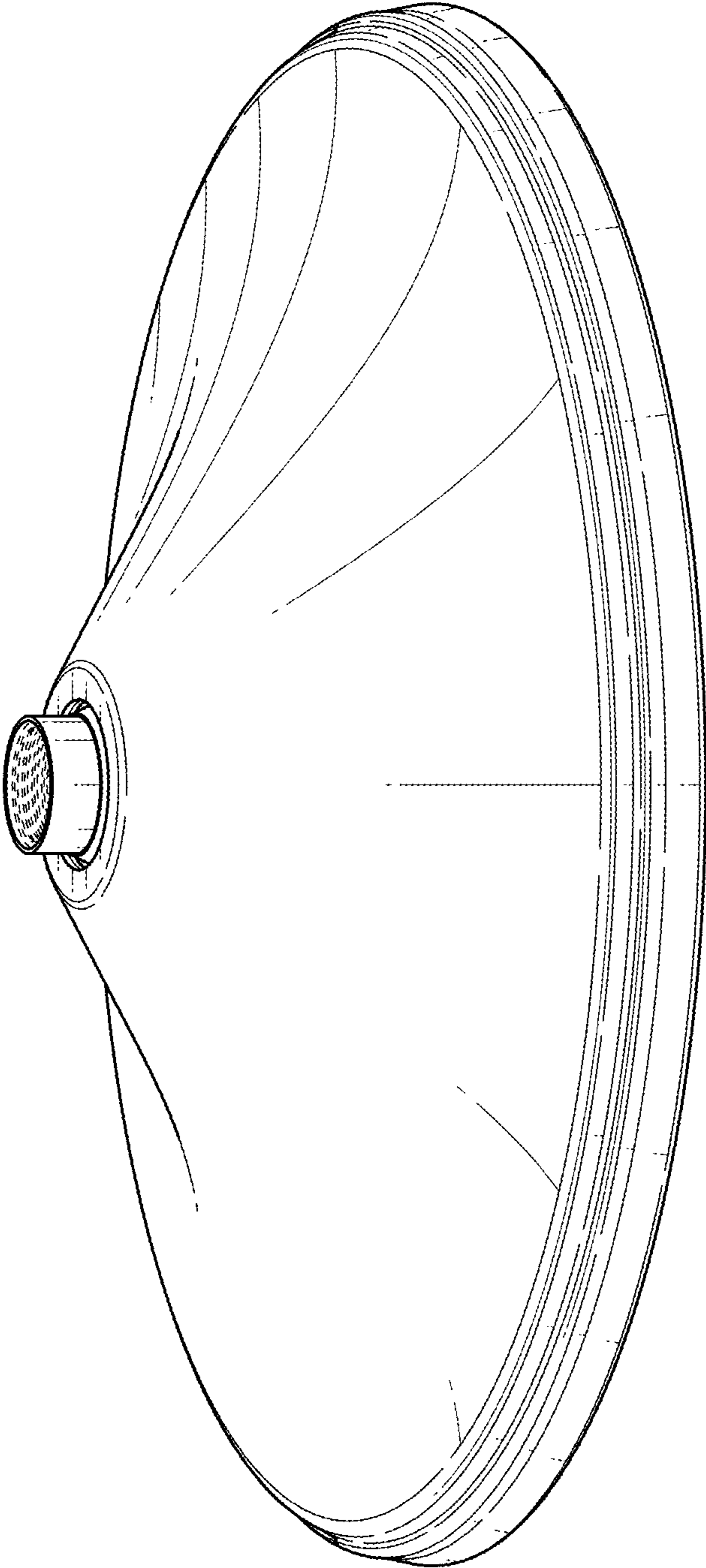
