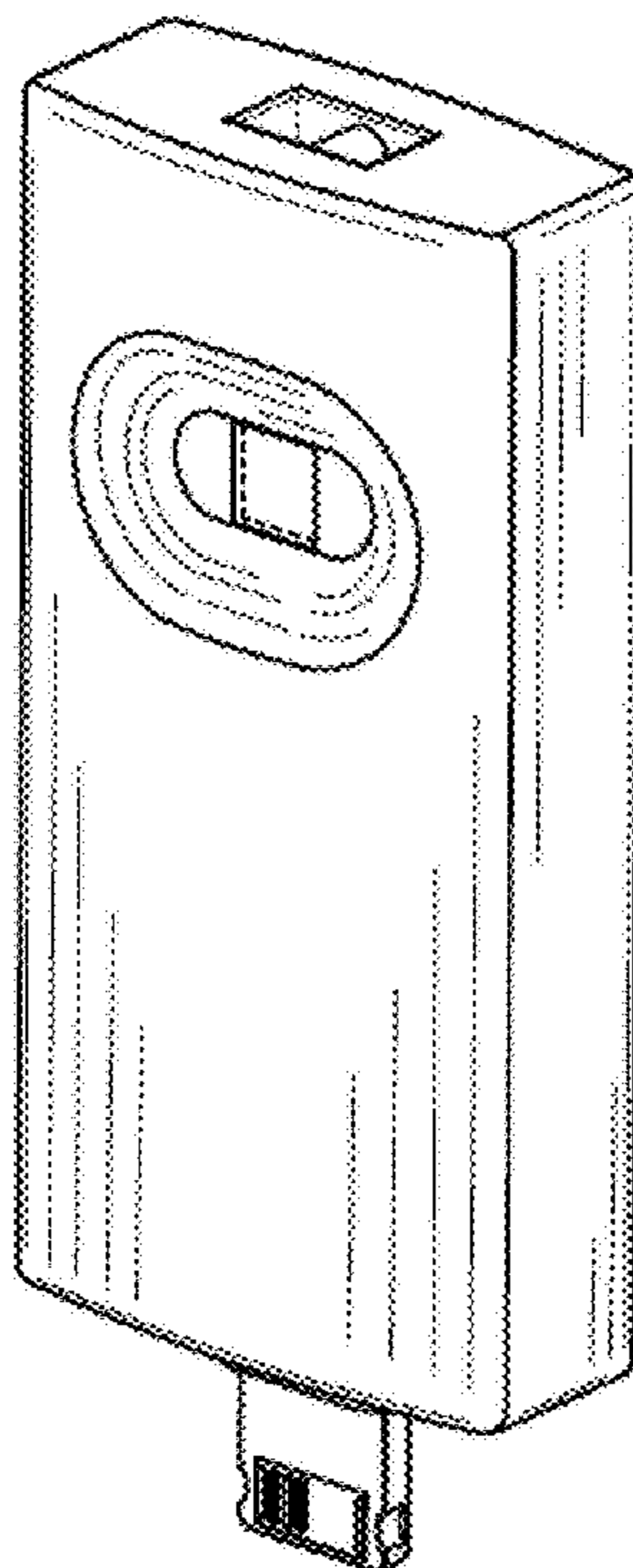
The ornamental design for a double tip mobile UV sanitizer, as shown and described.

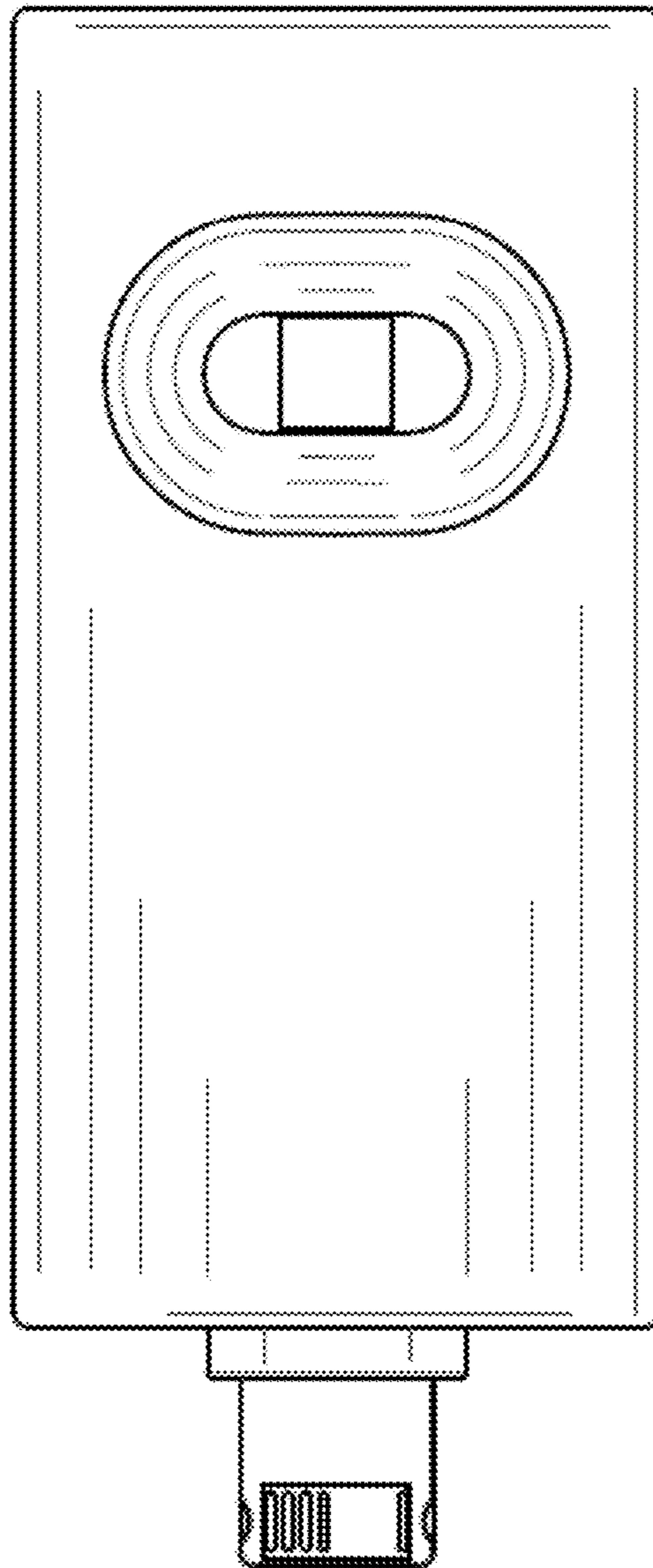

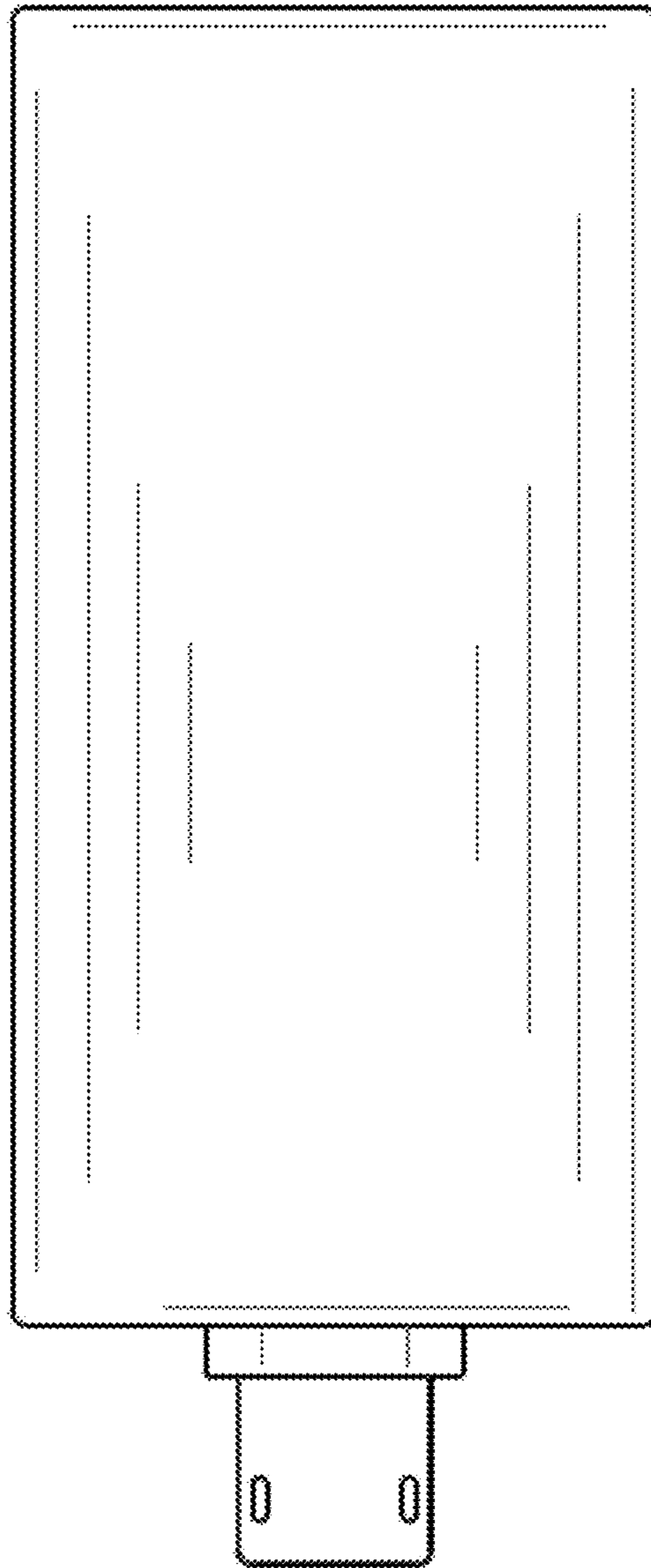

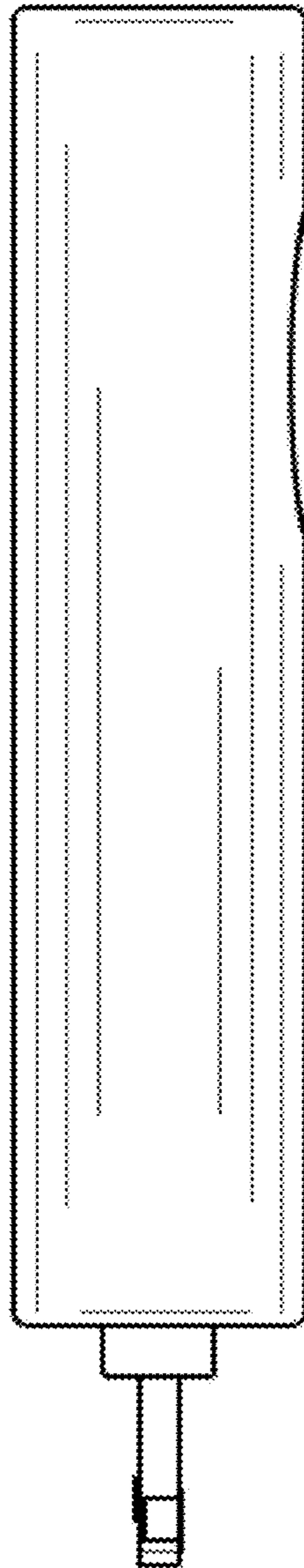

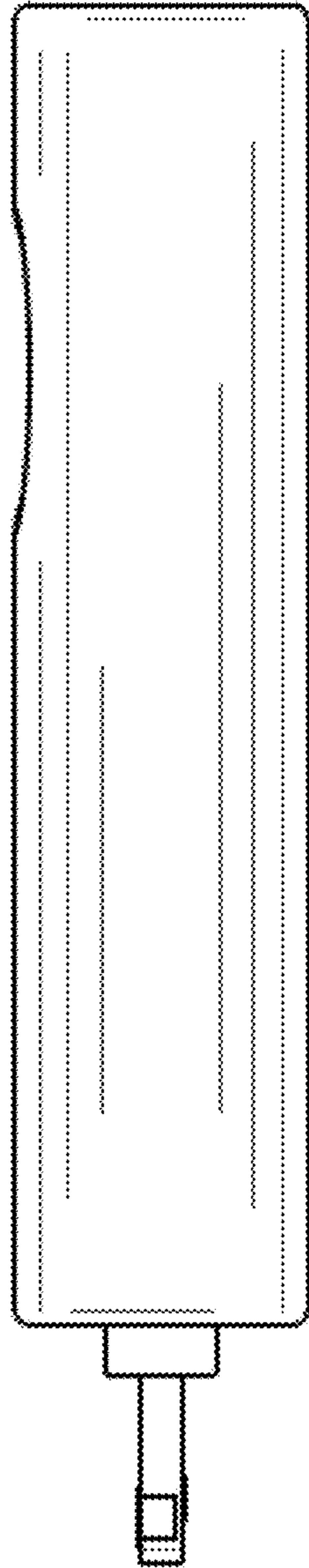

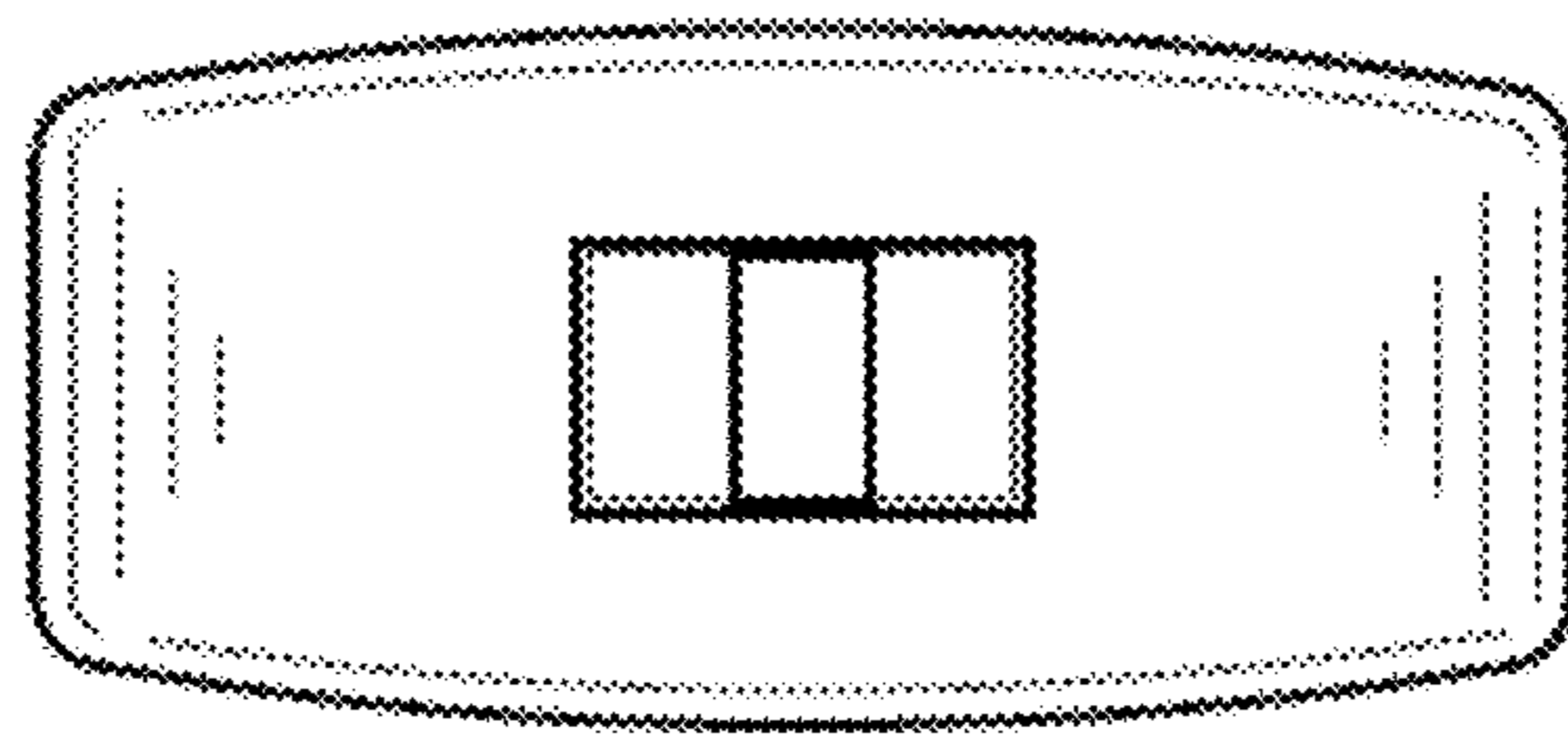

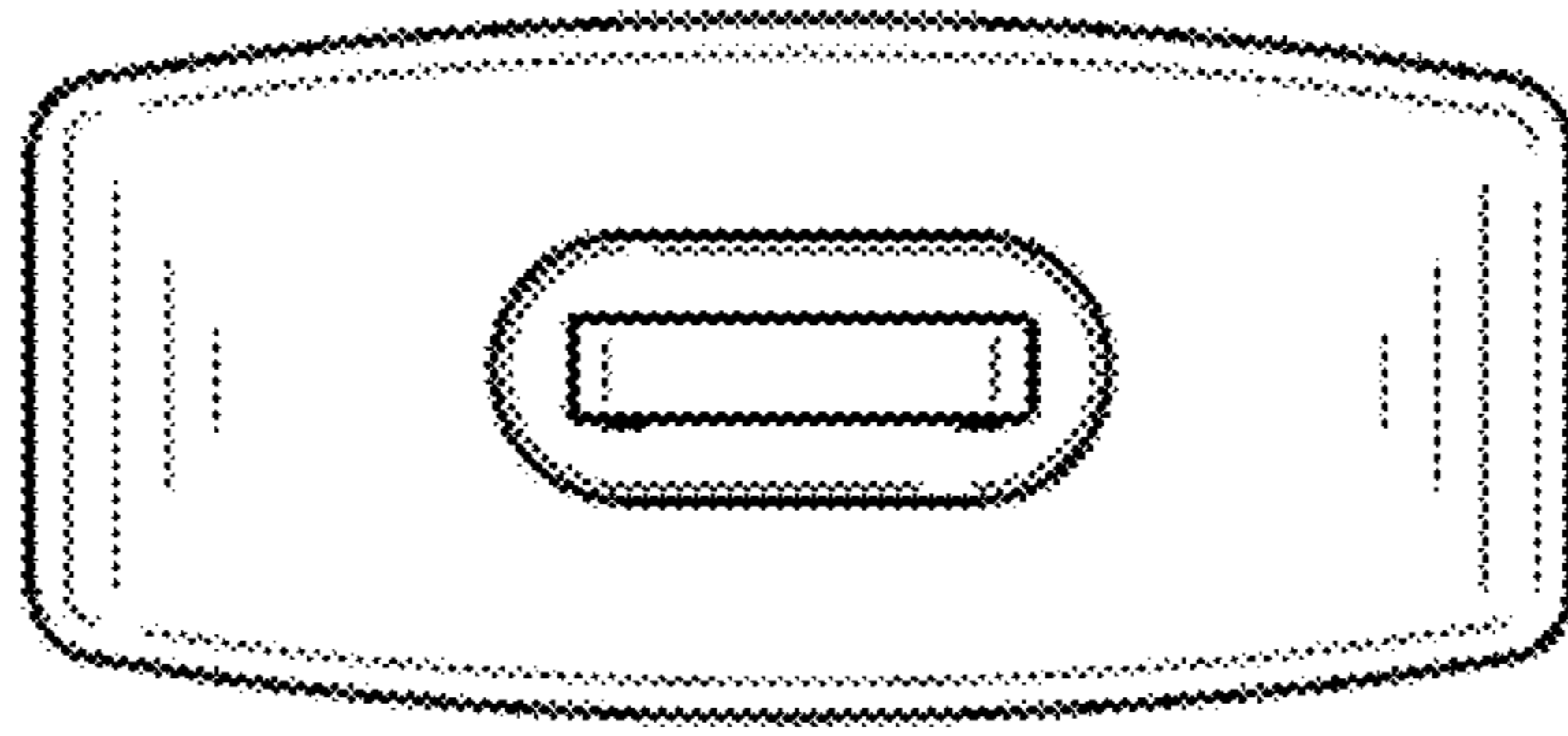

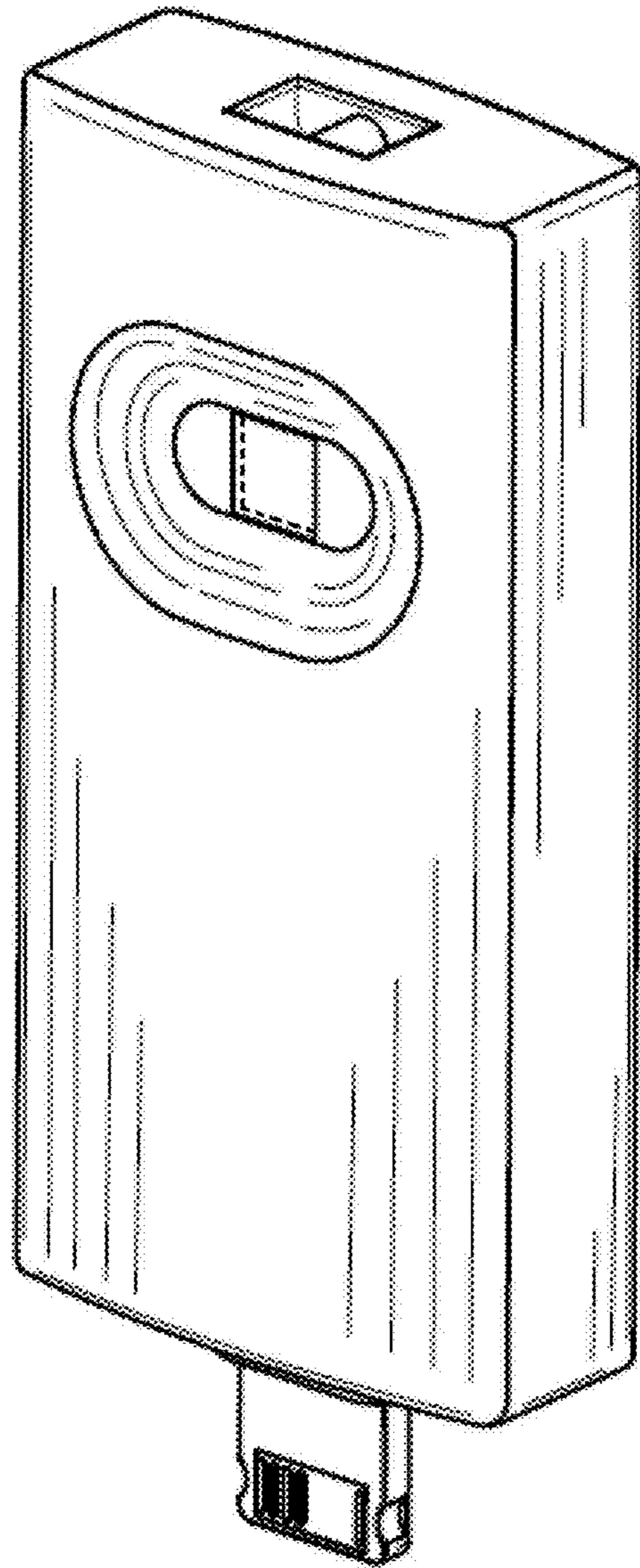
