**DESCRIPTION**

FIG. 24 is a bottom plan view thereof;

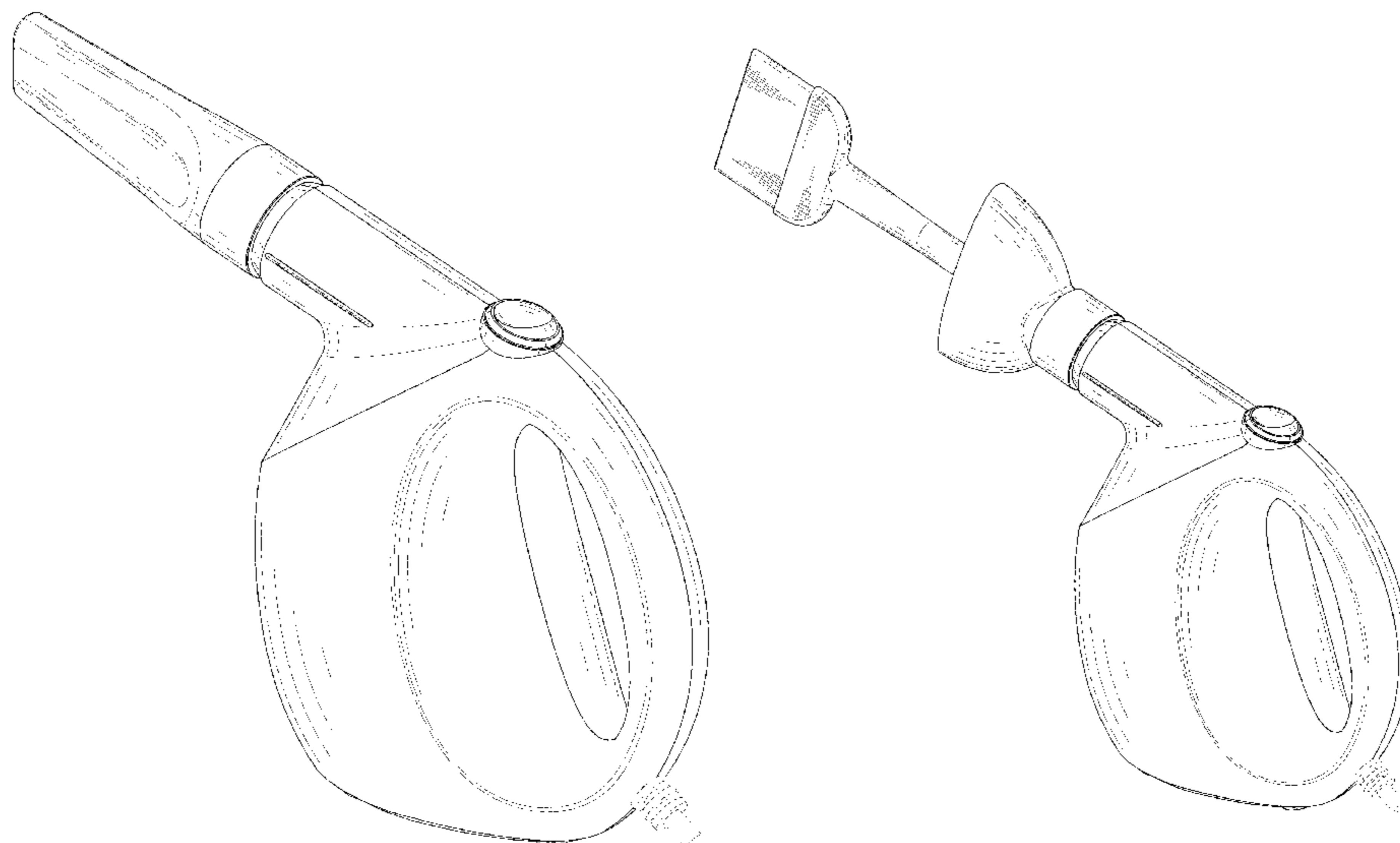
FIG. 25 is a perspective view of the second head component and the main body where the second head component is assembled with the main body;

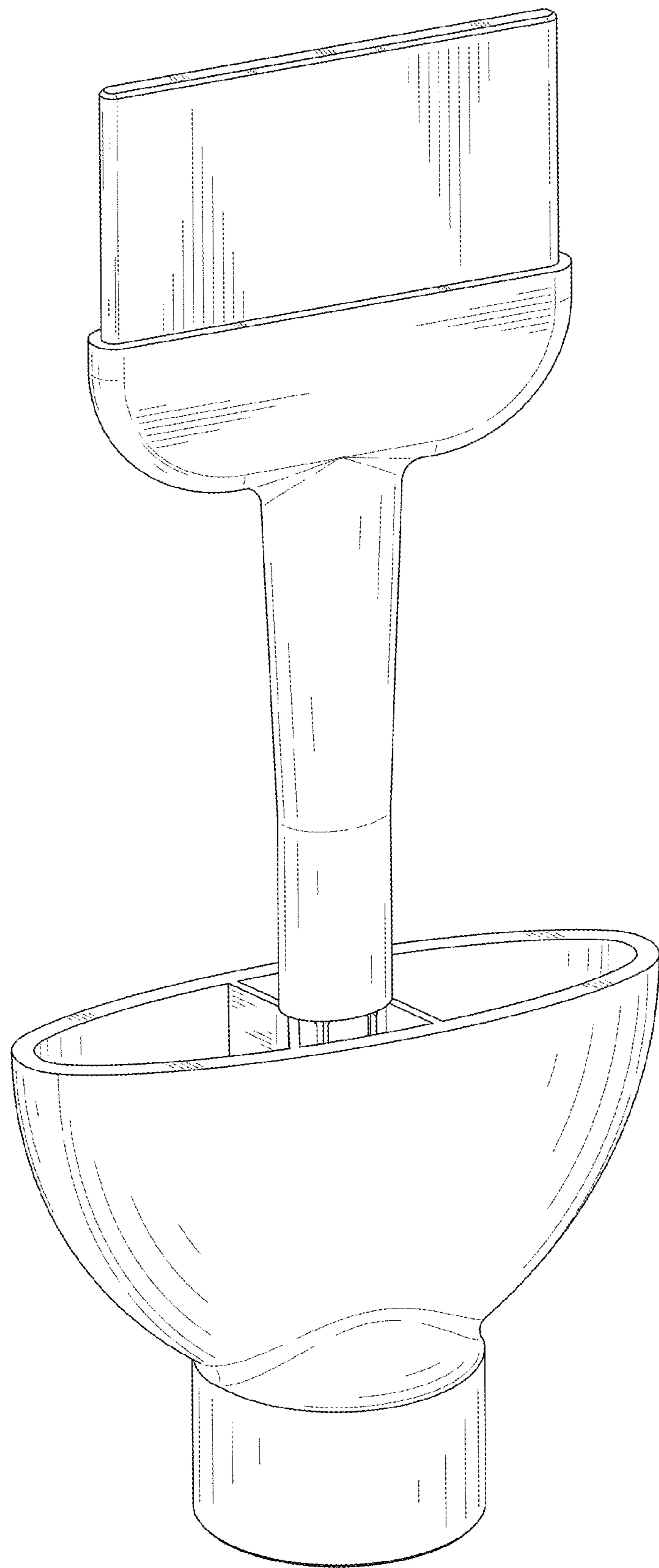

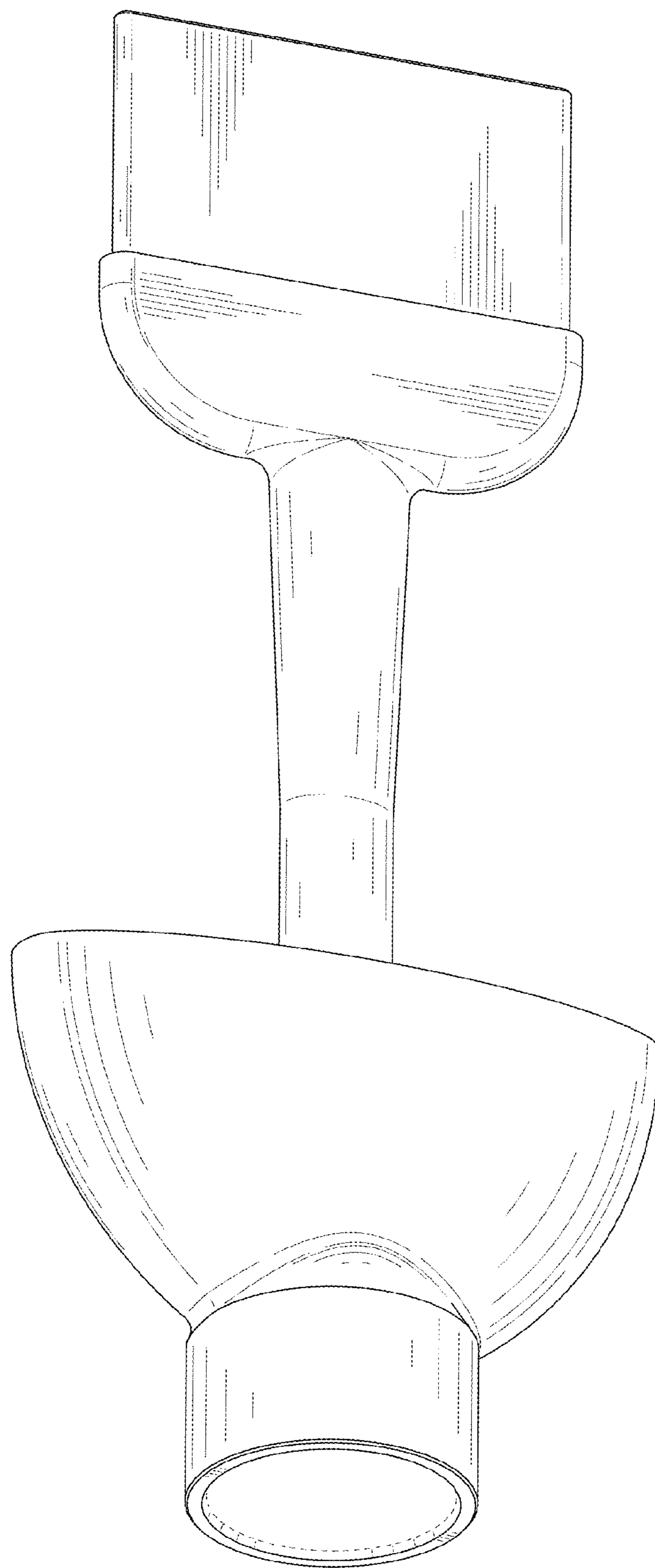

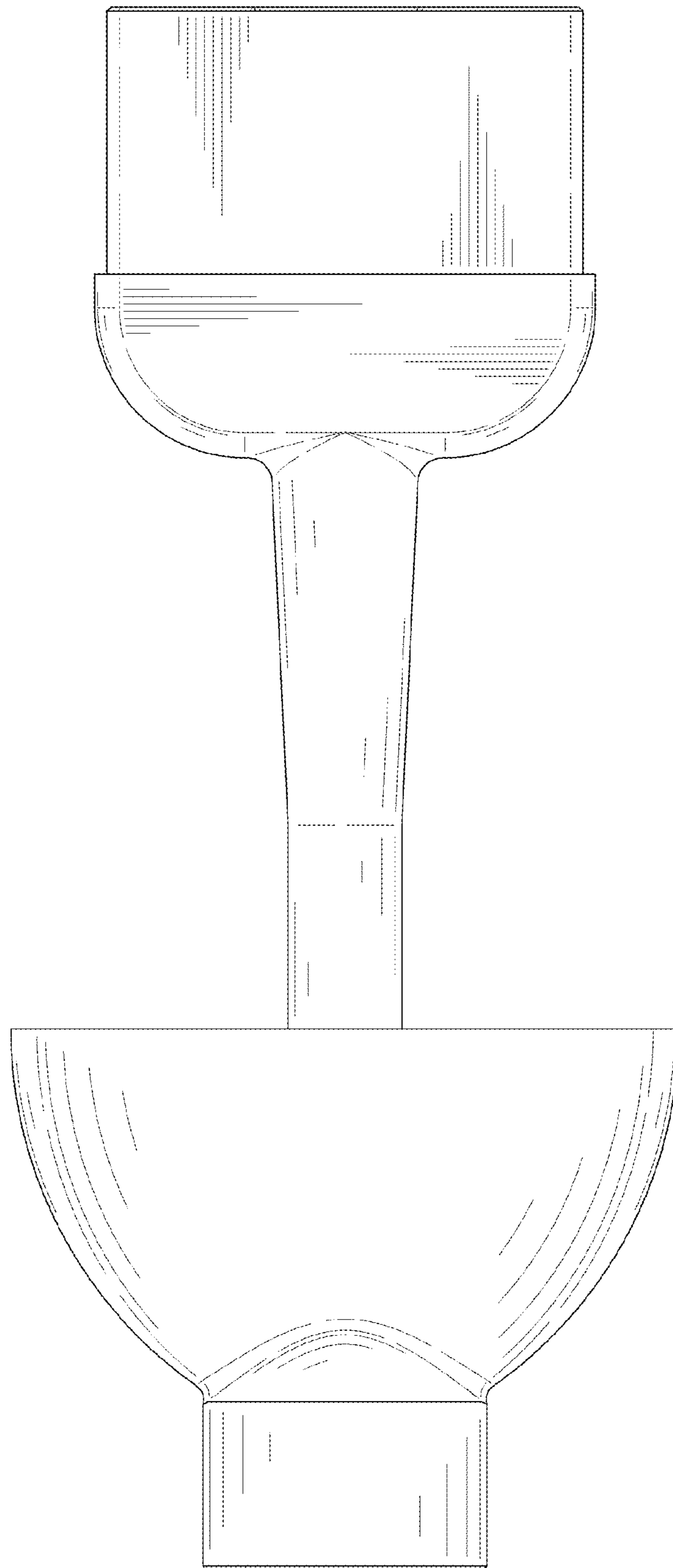

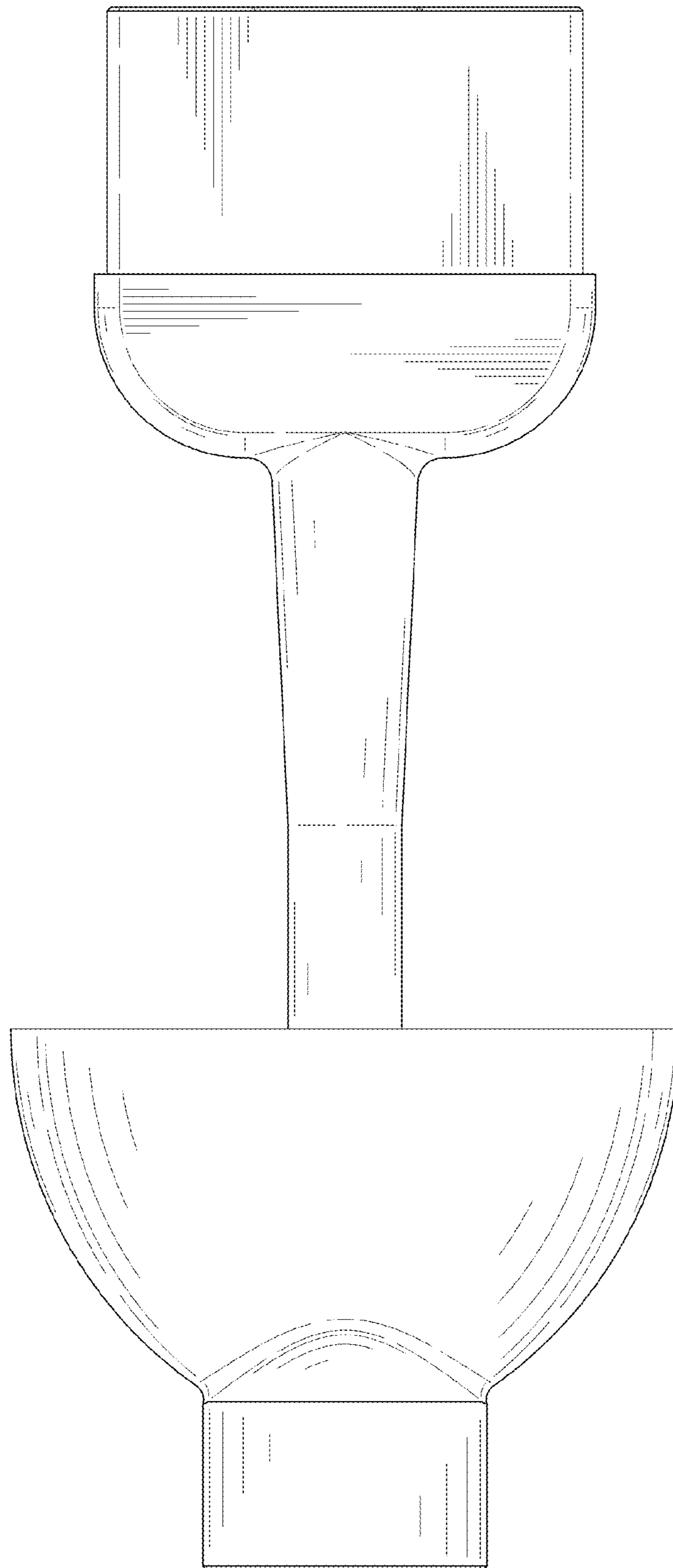

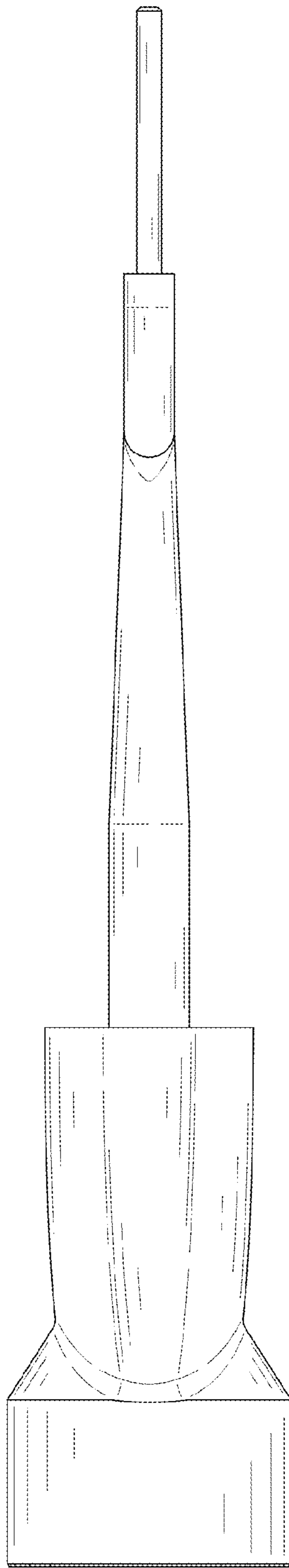

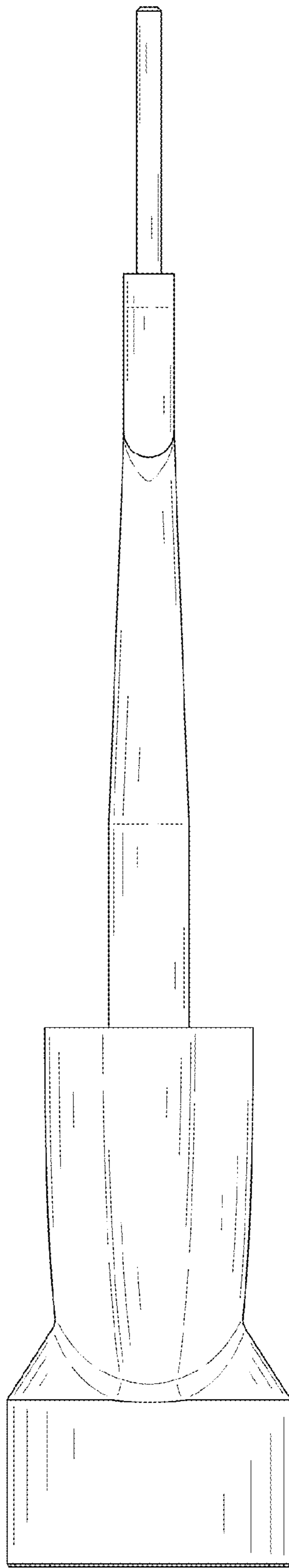

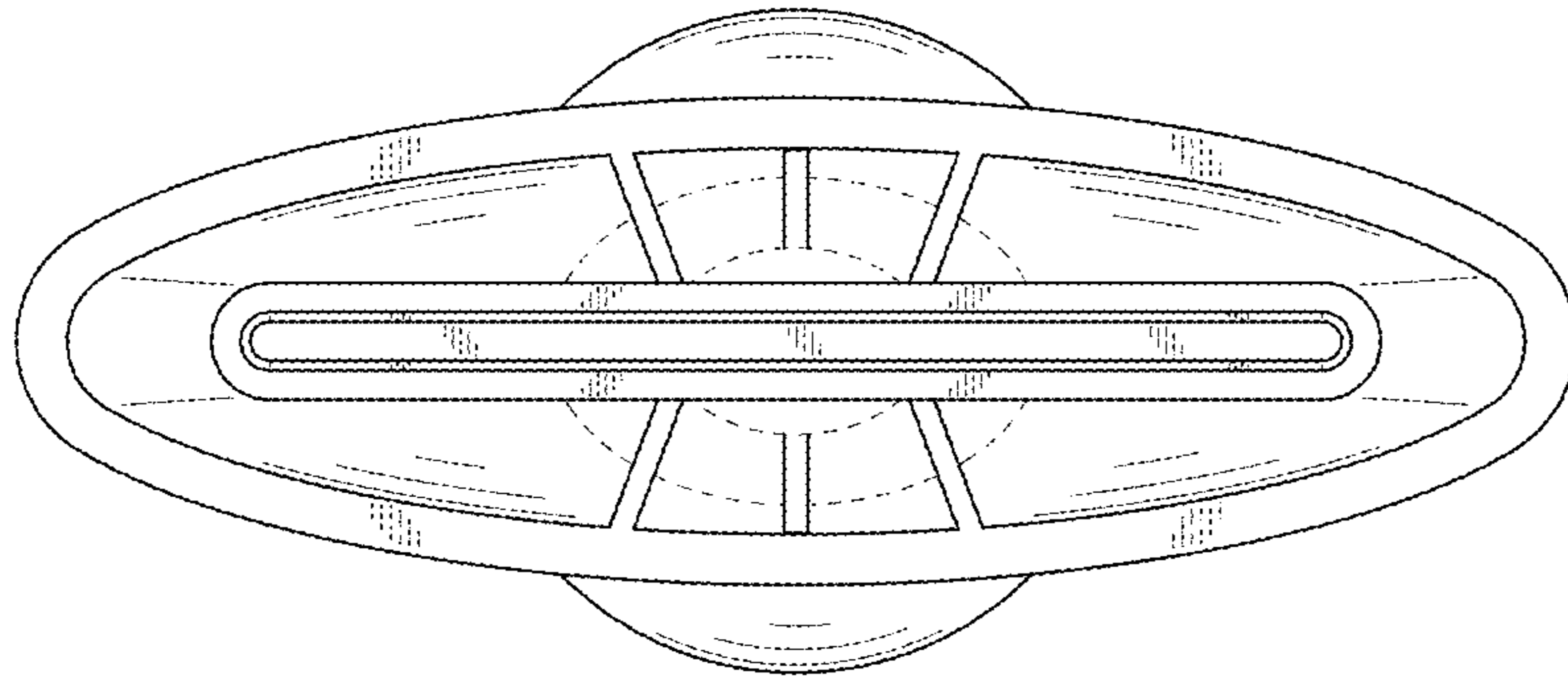

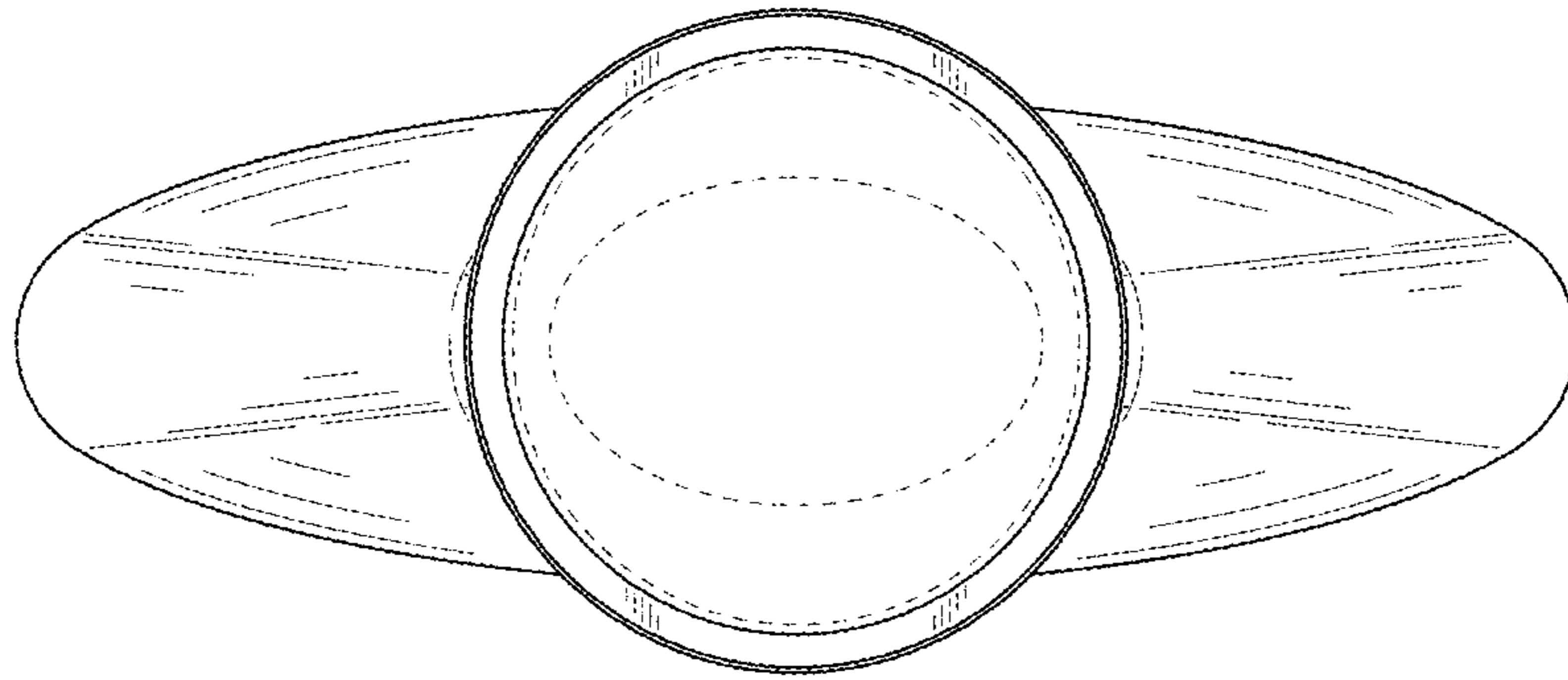

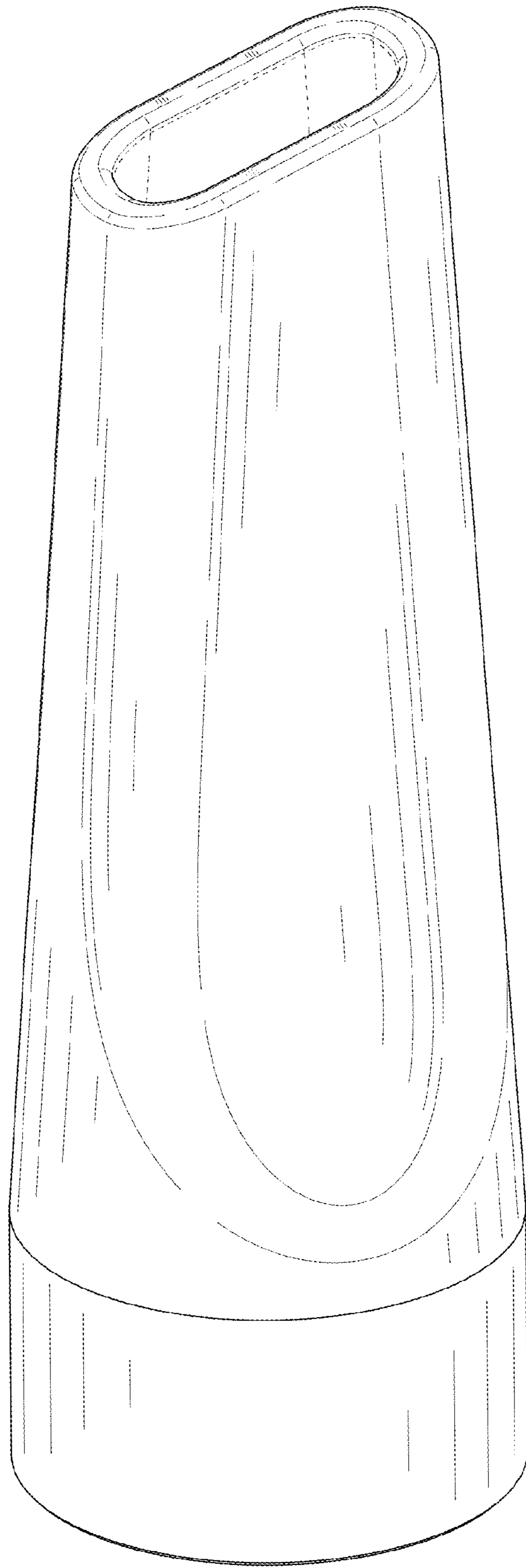

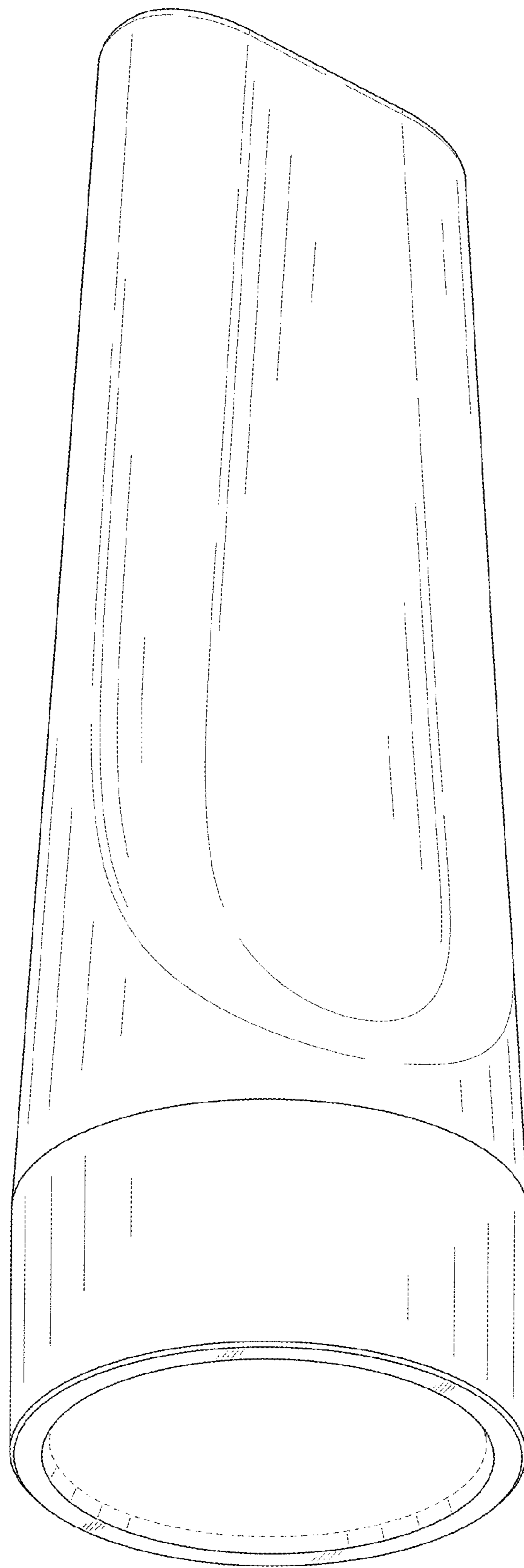

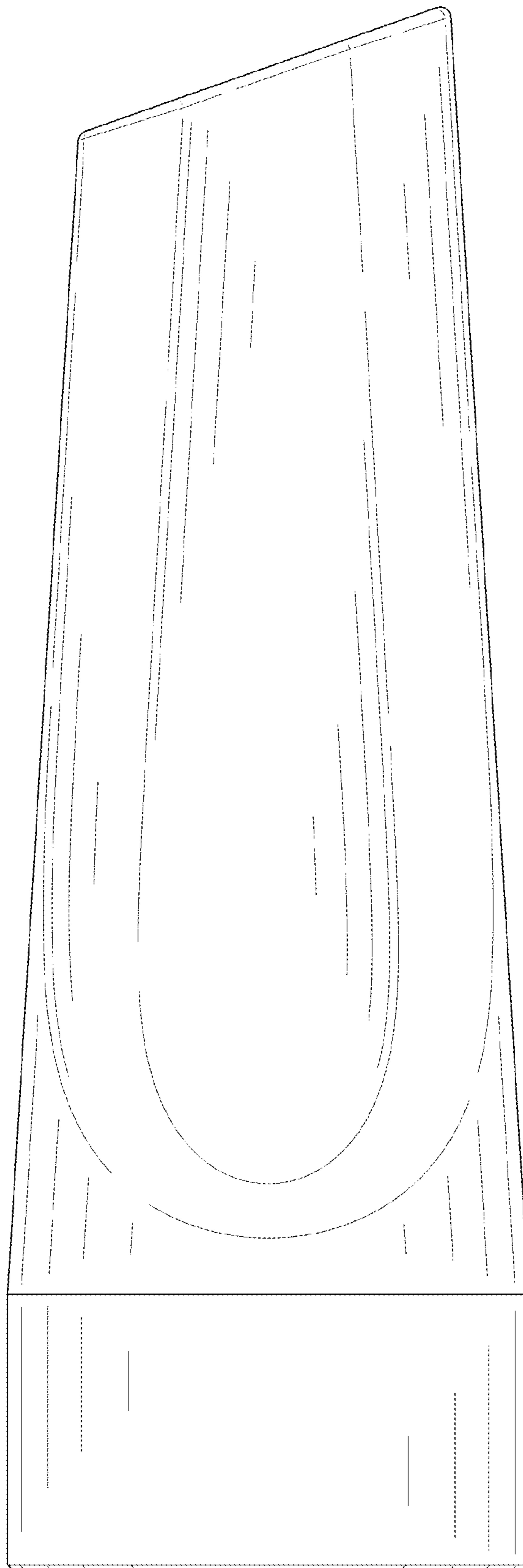

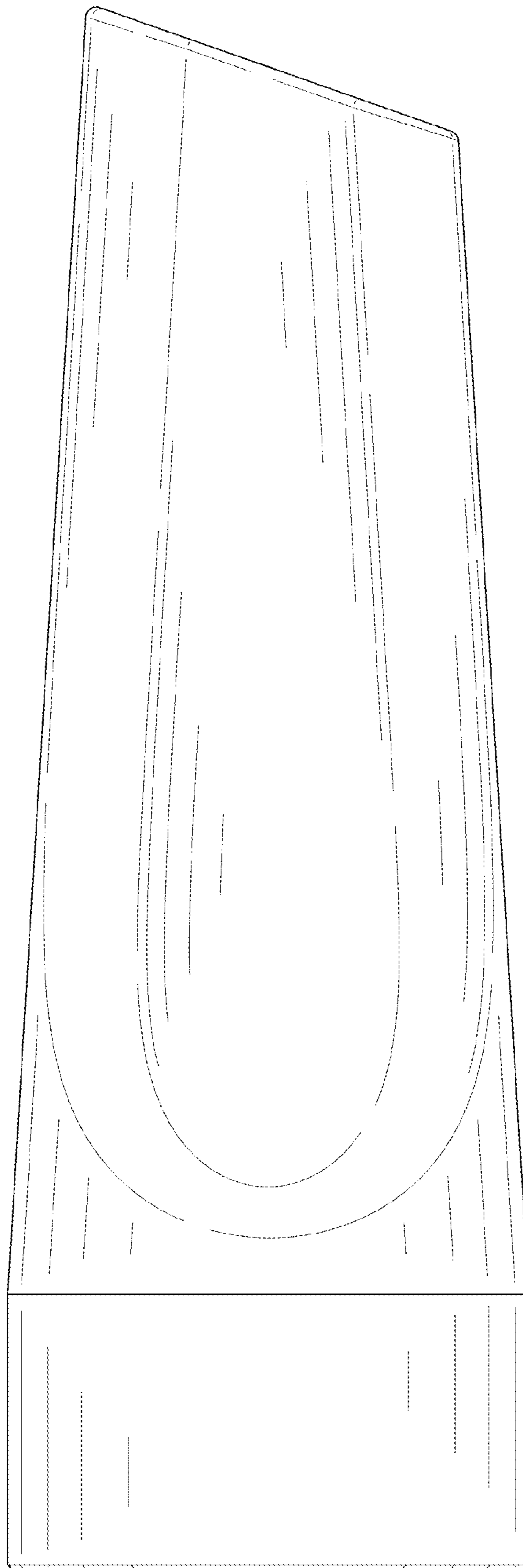

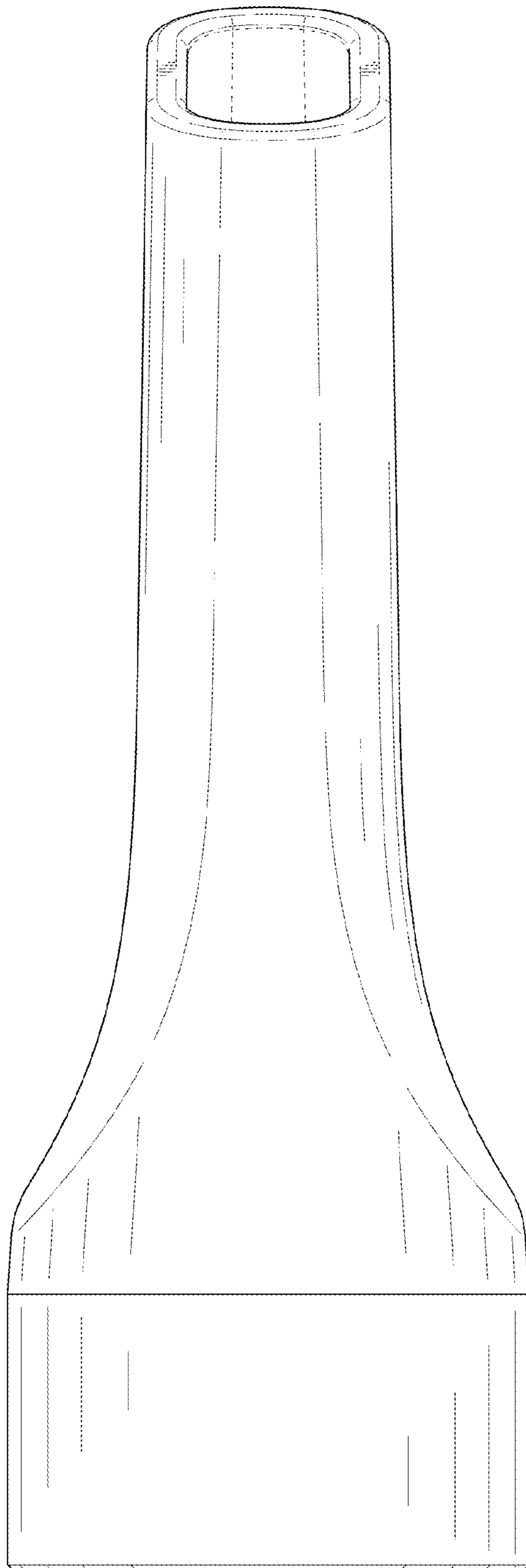

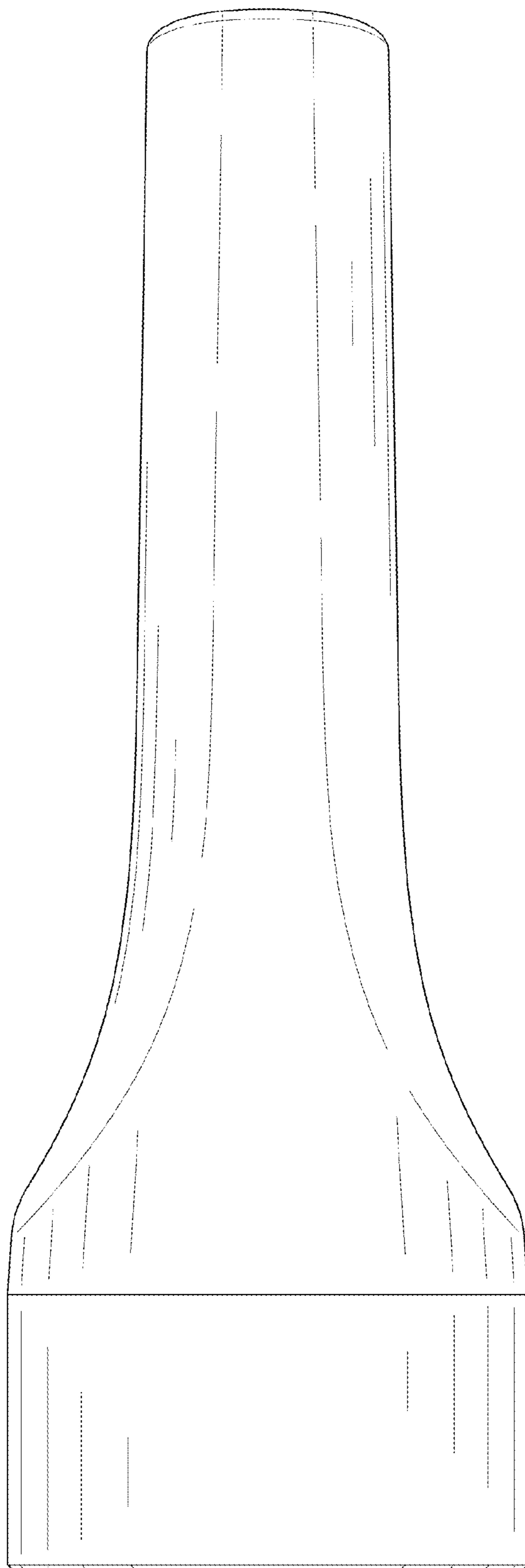

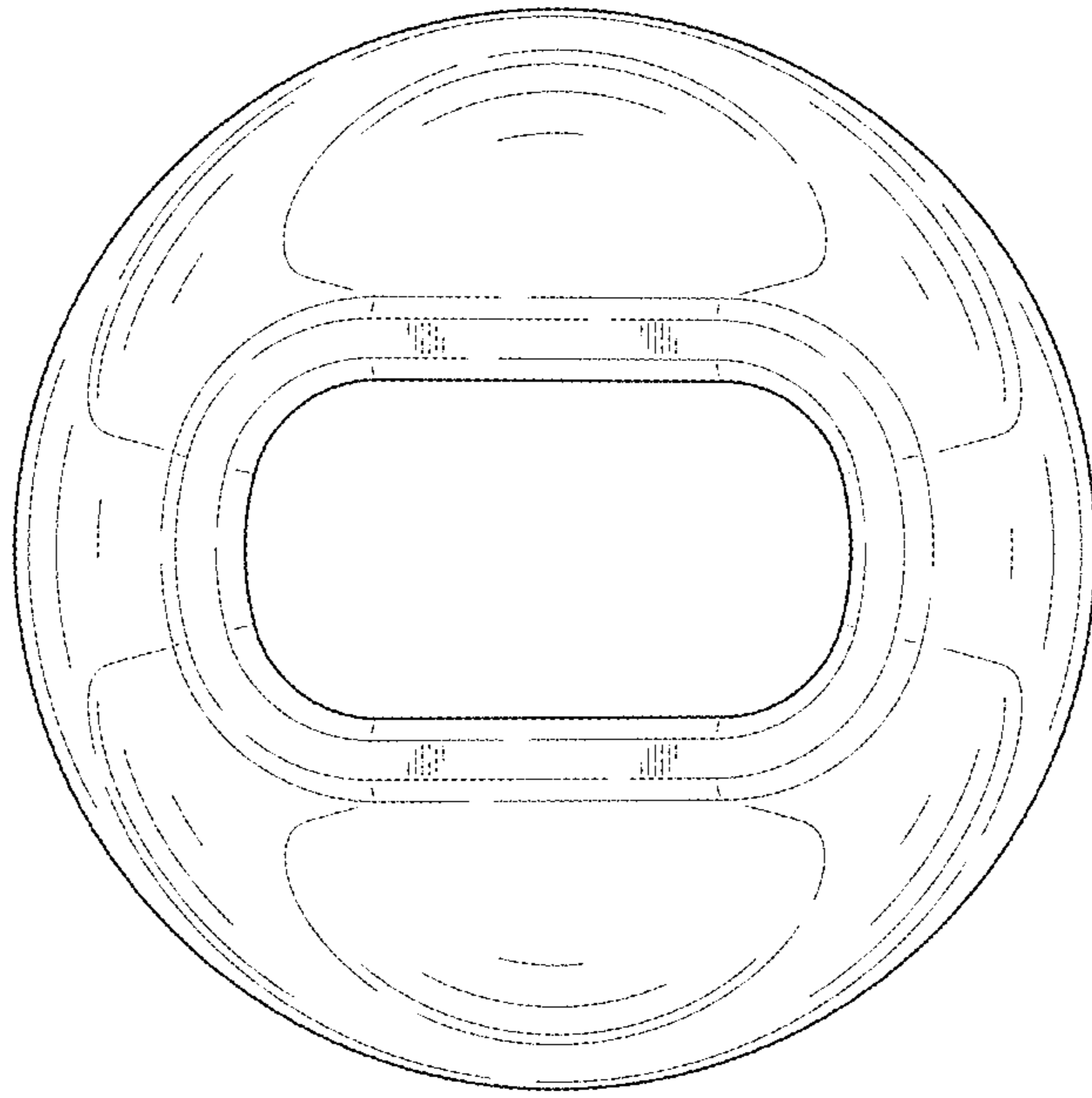

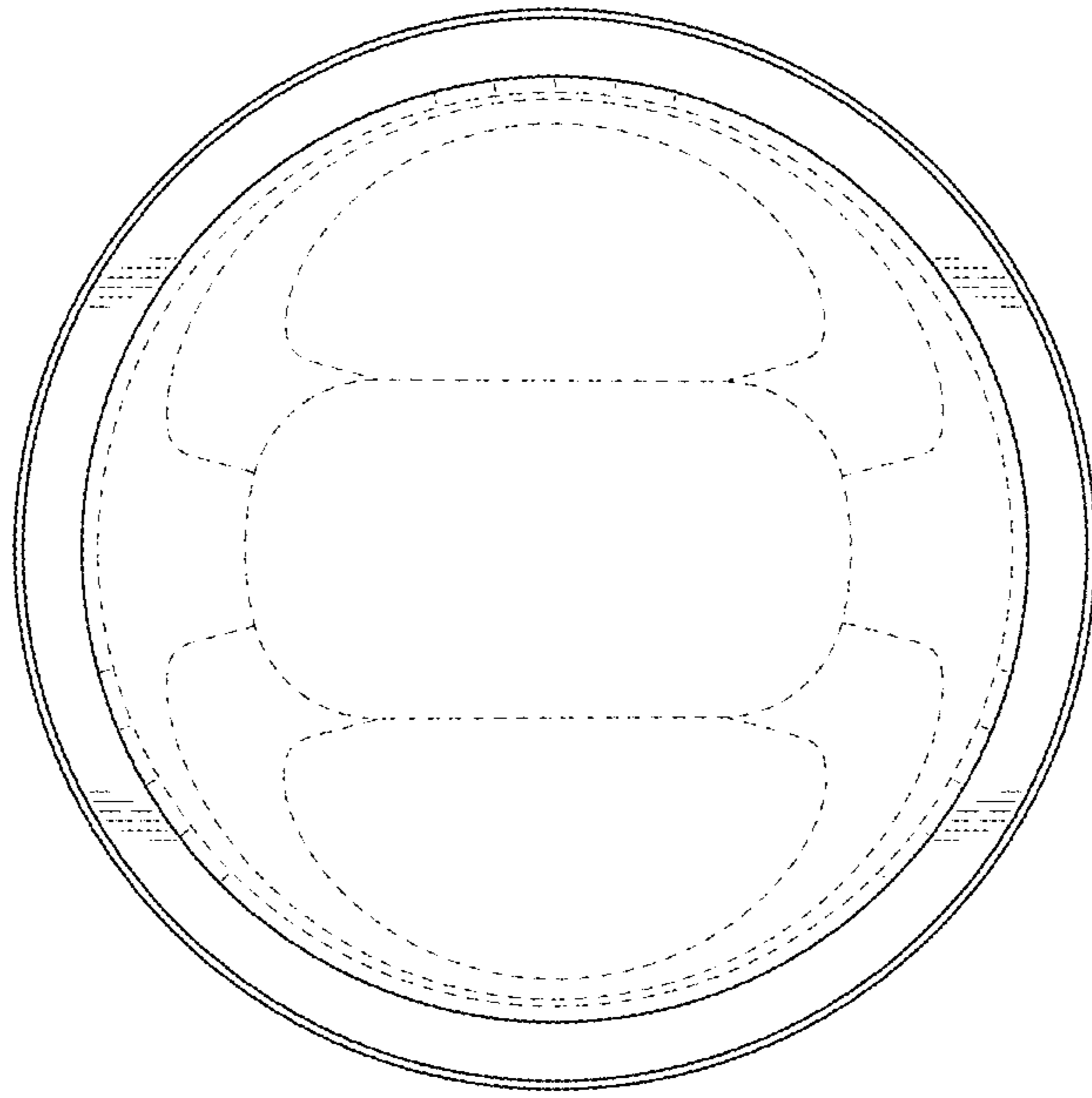

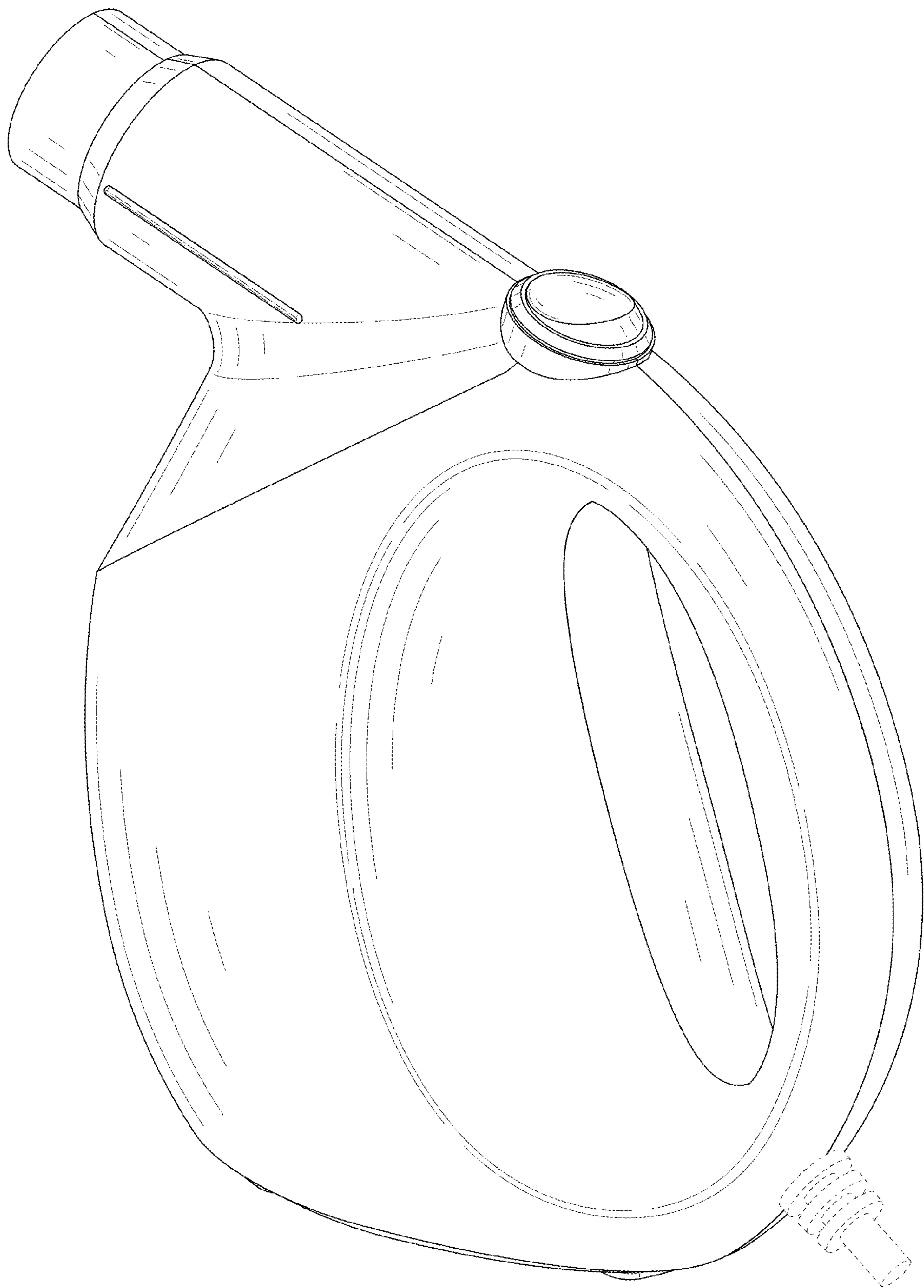

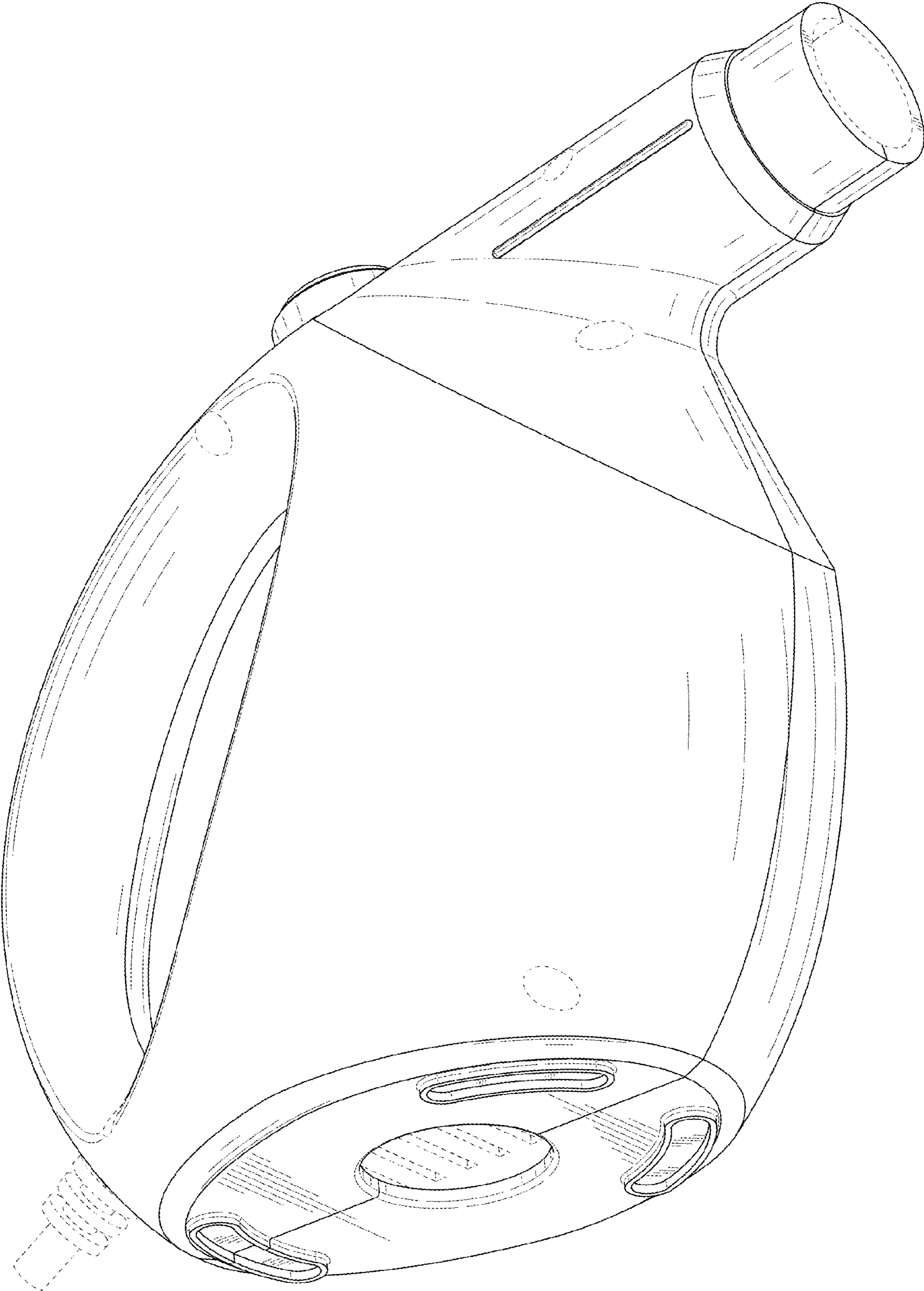

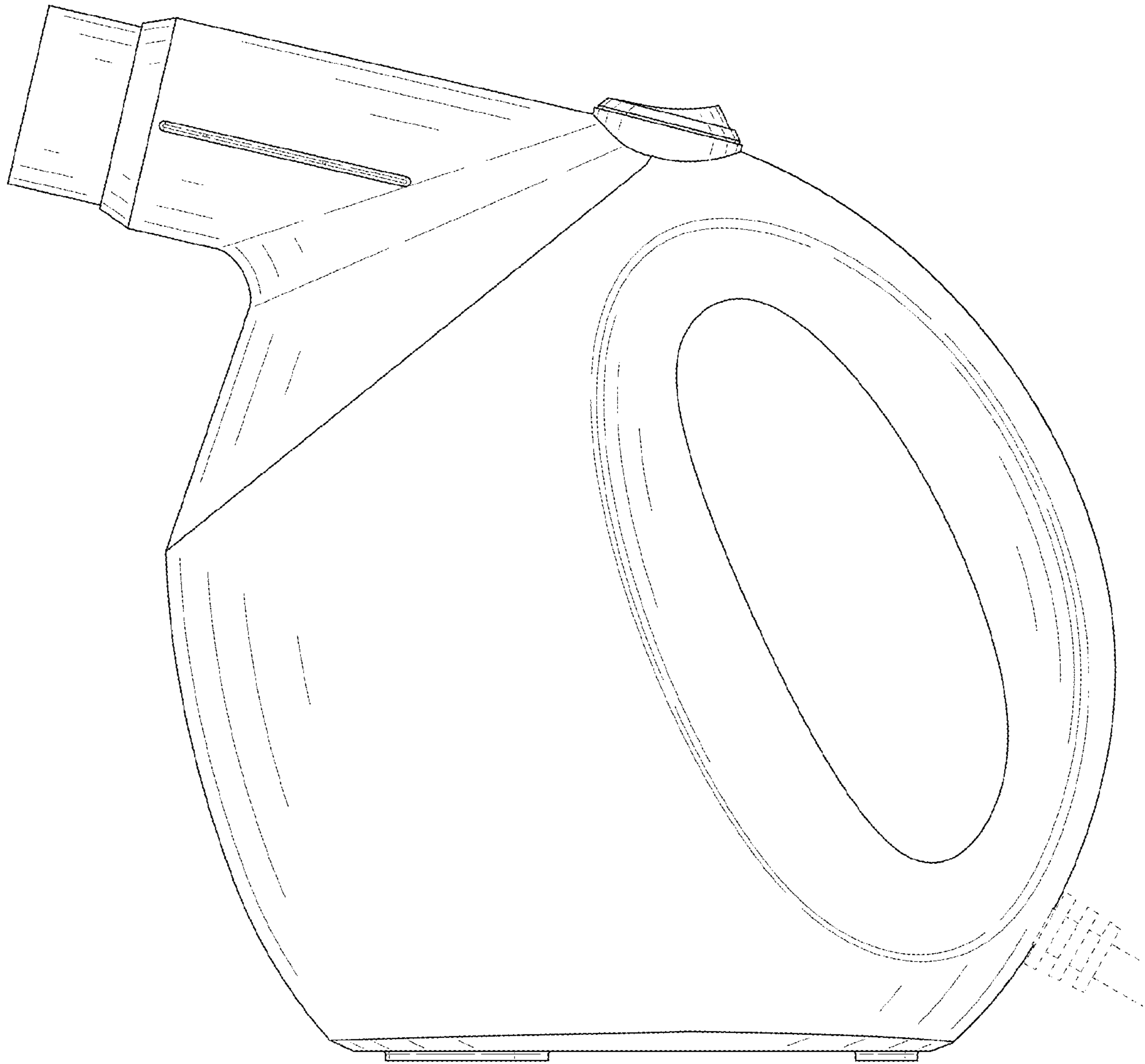

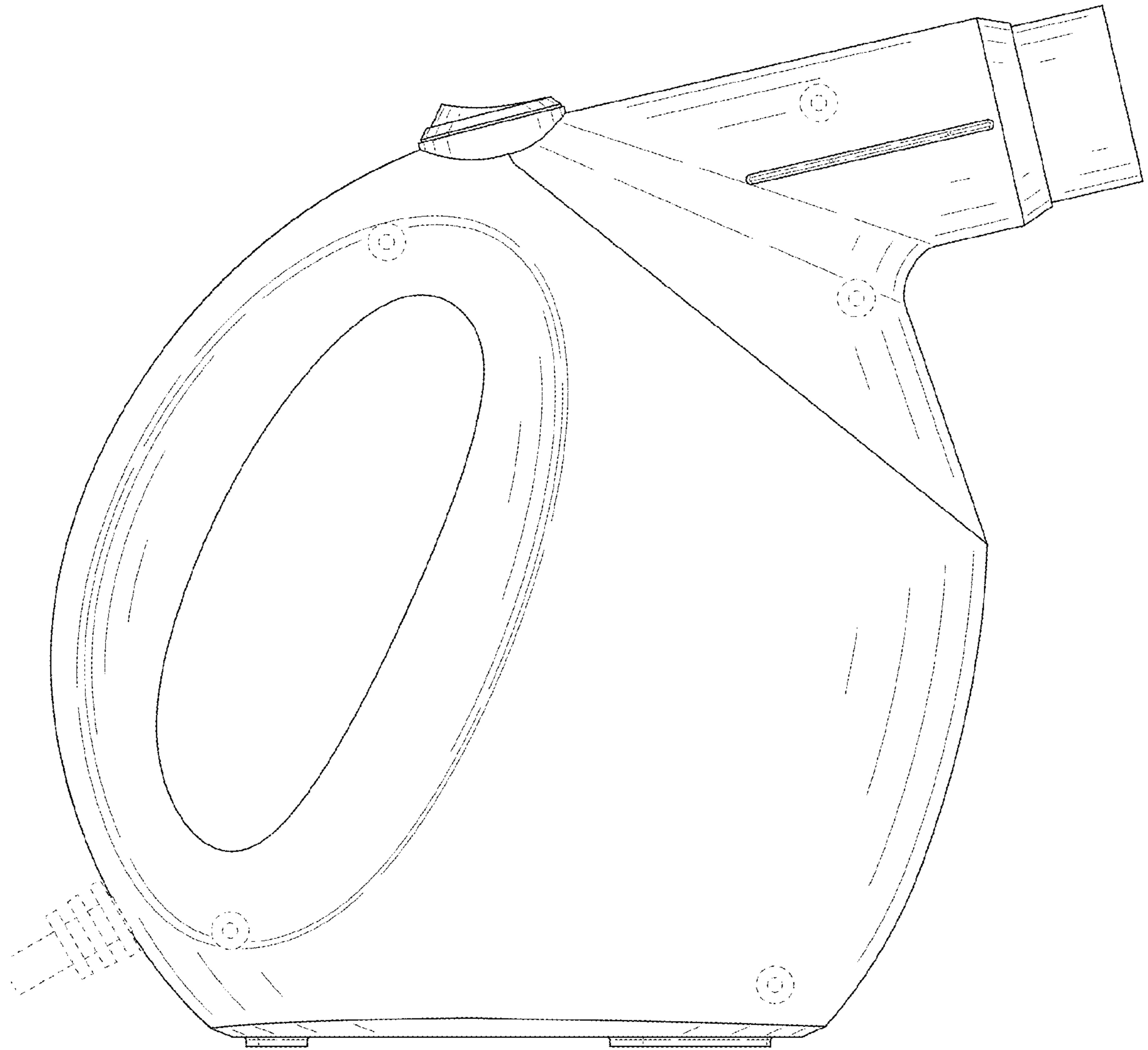

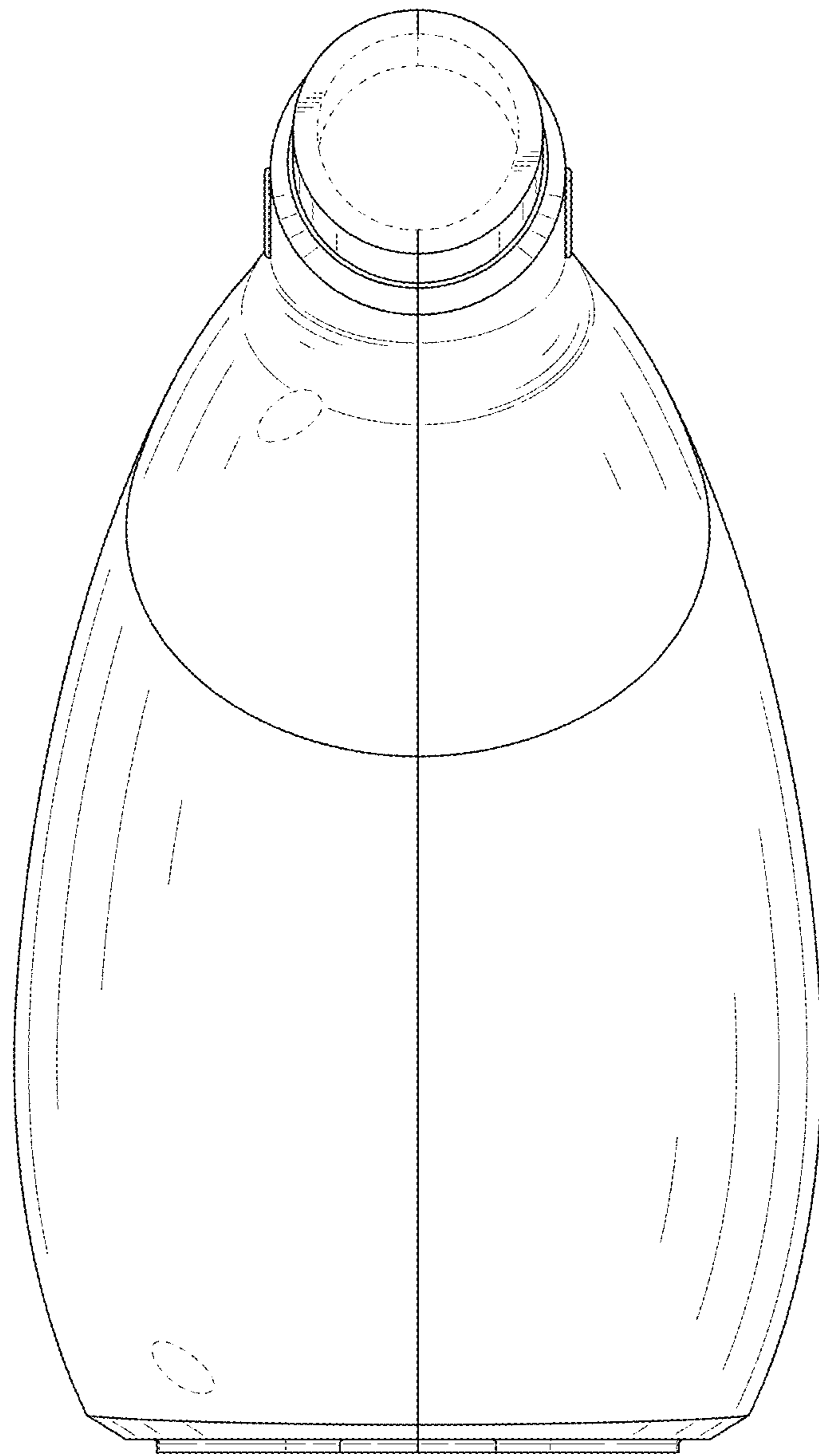

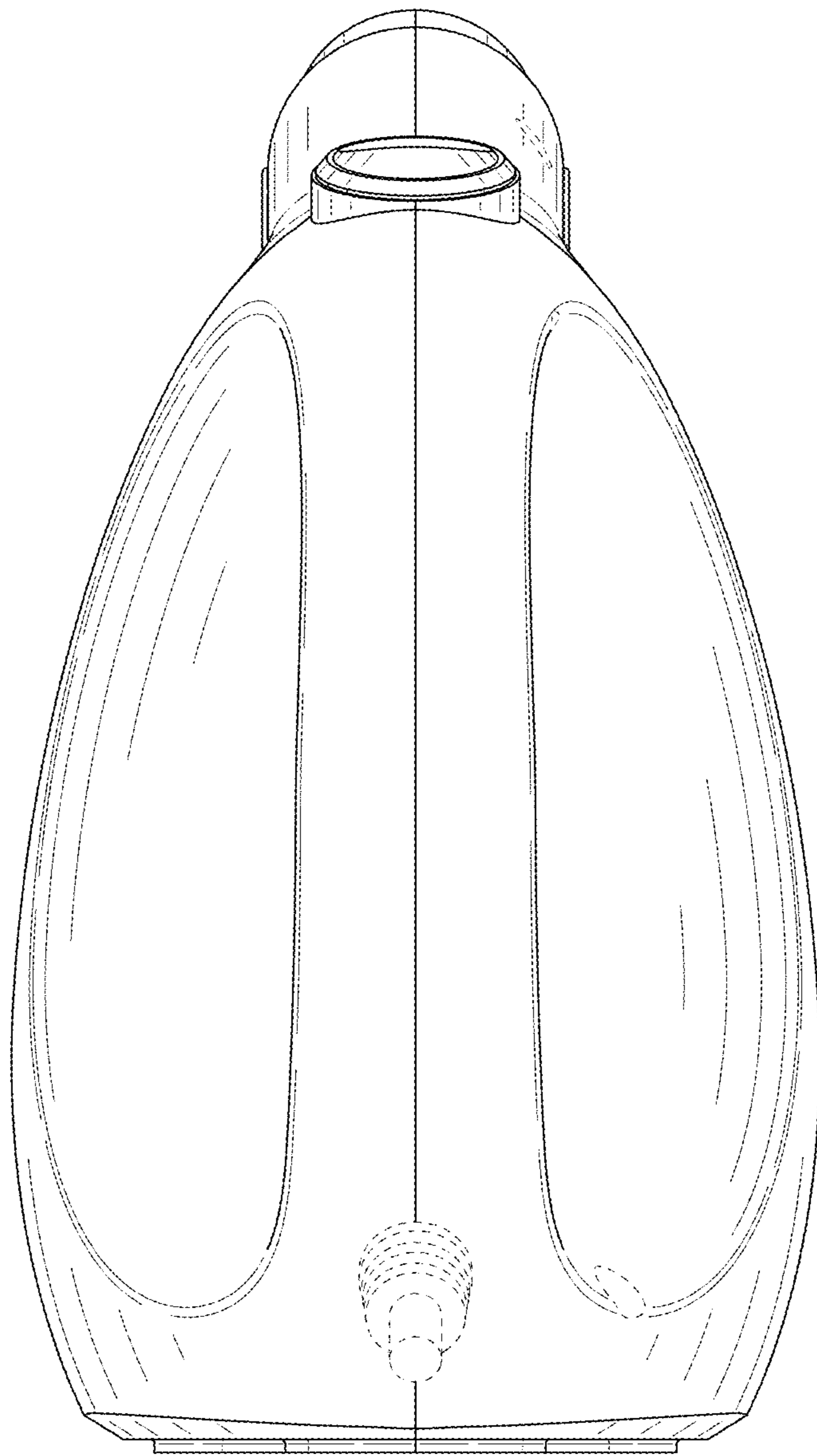

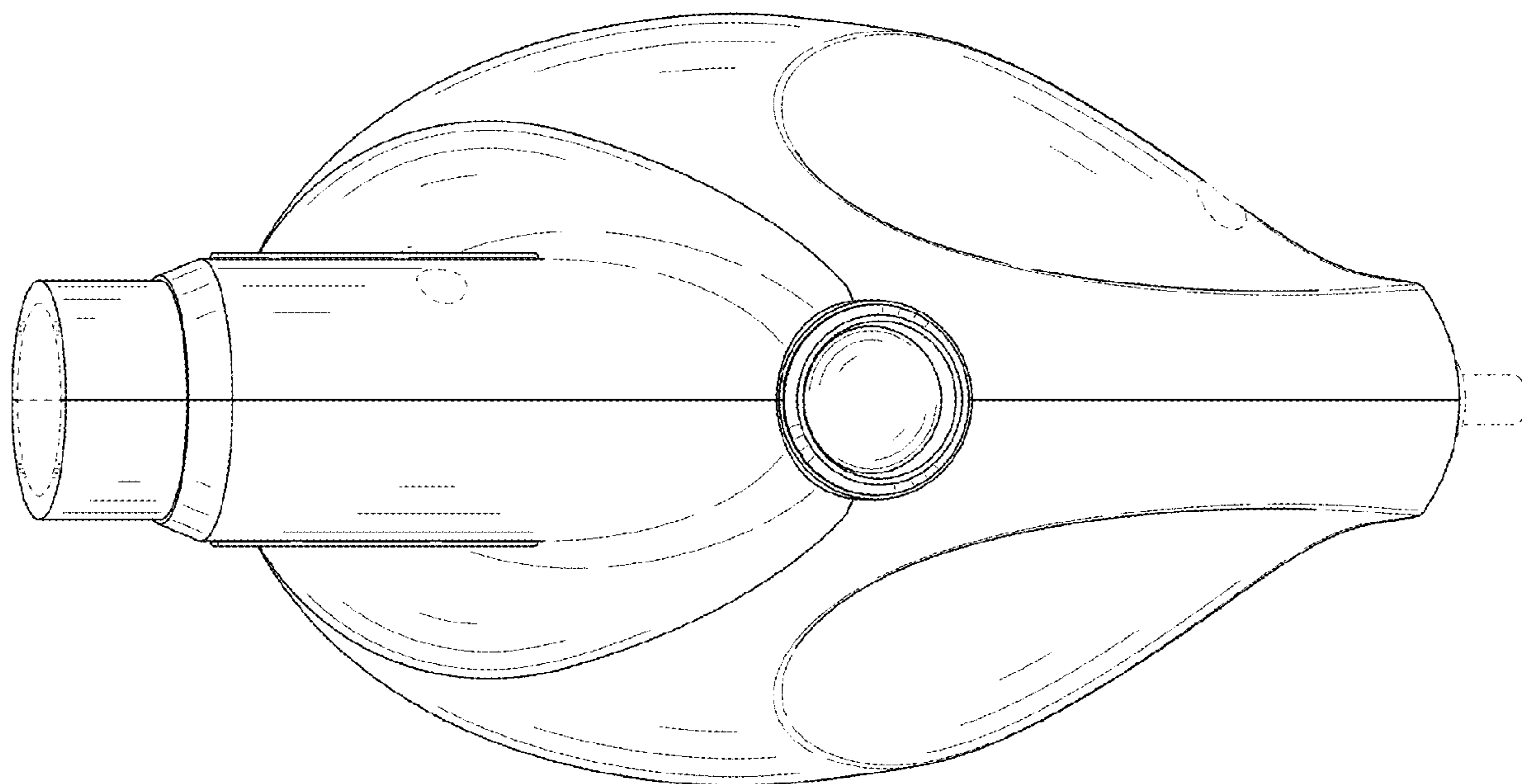

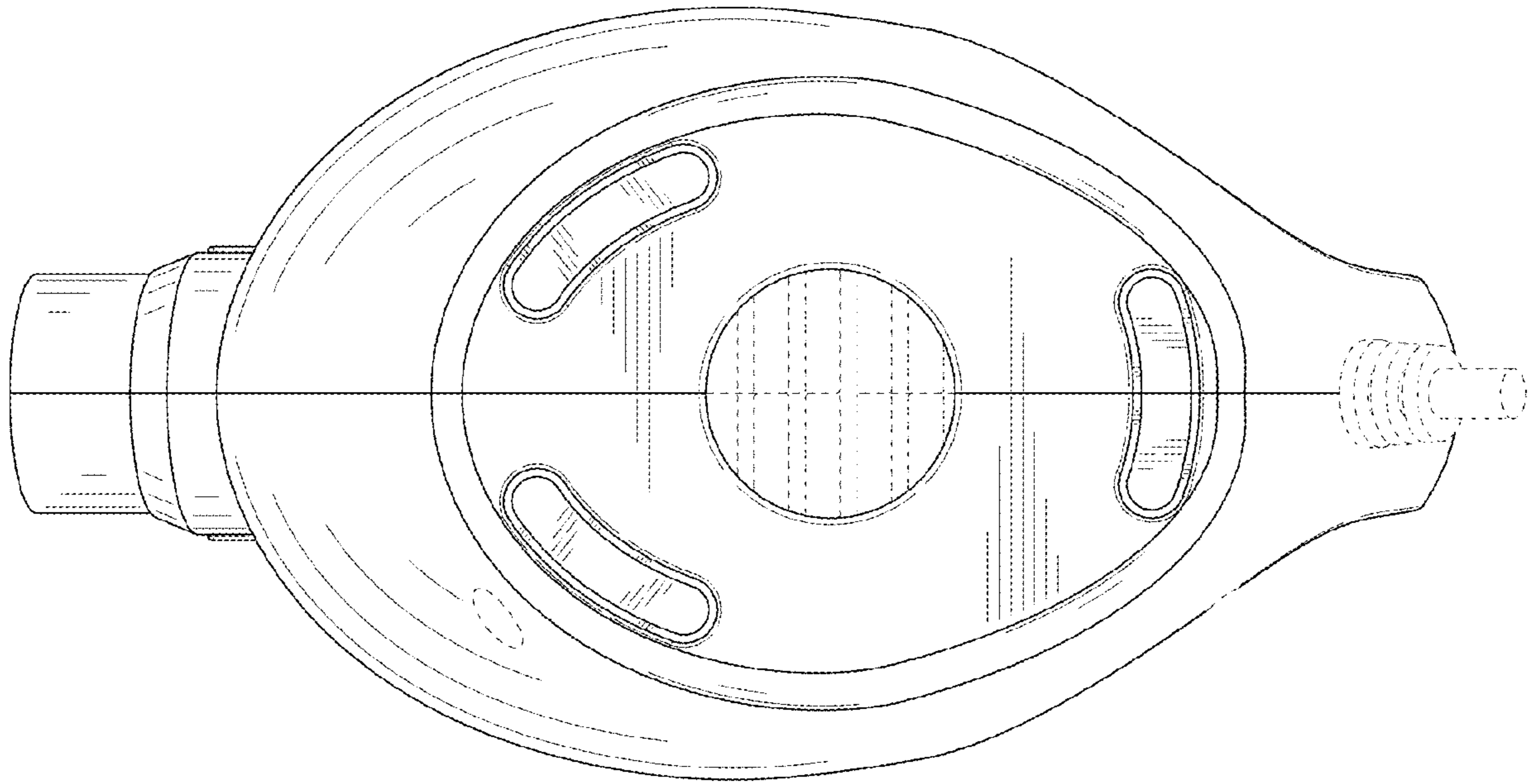

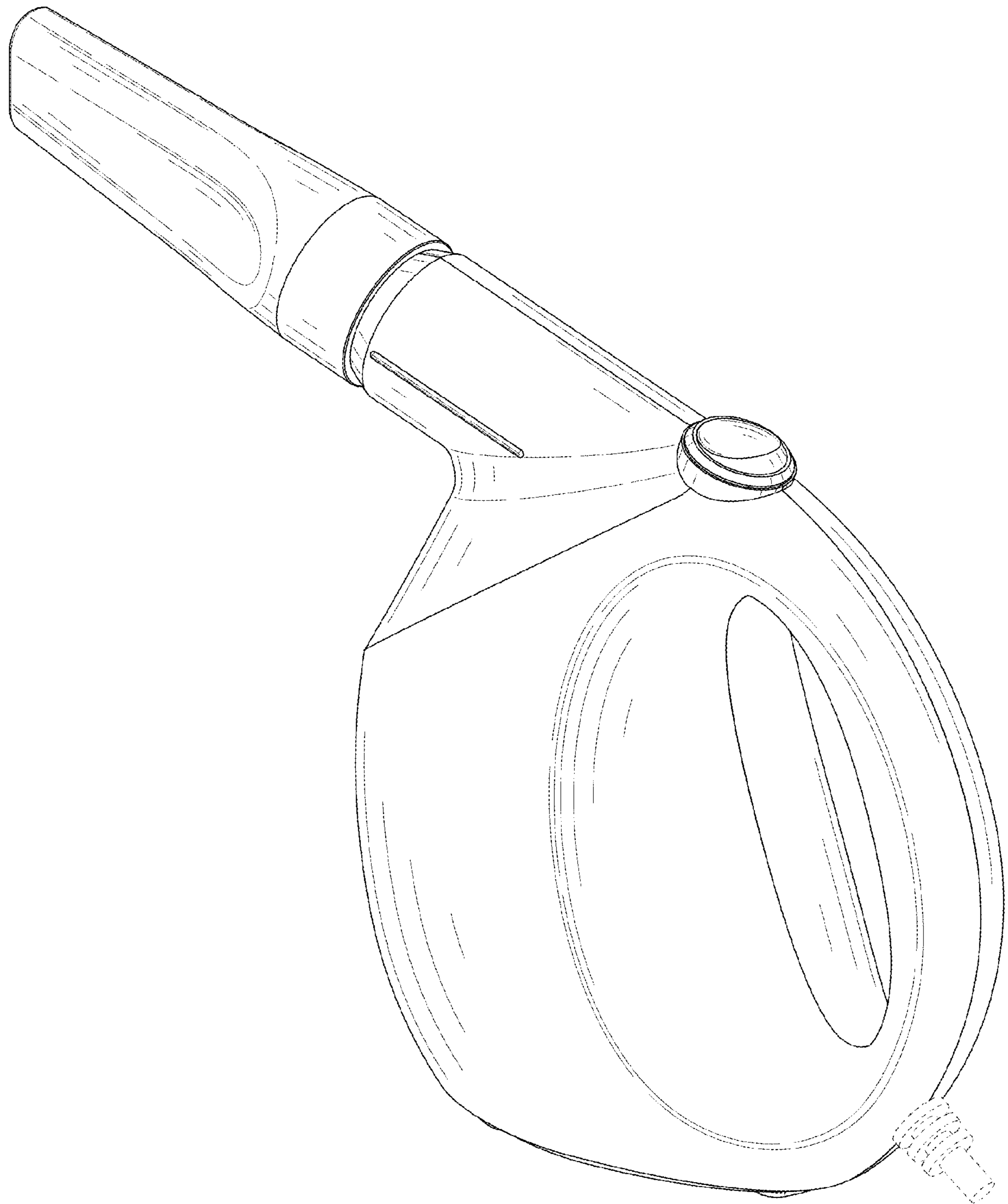

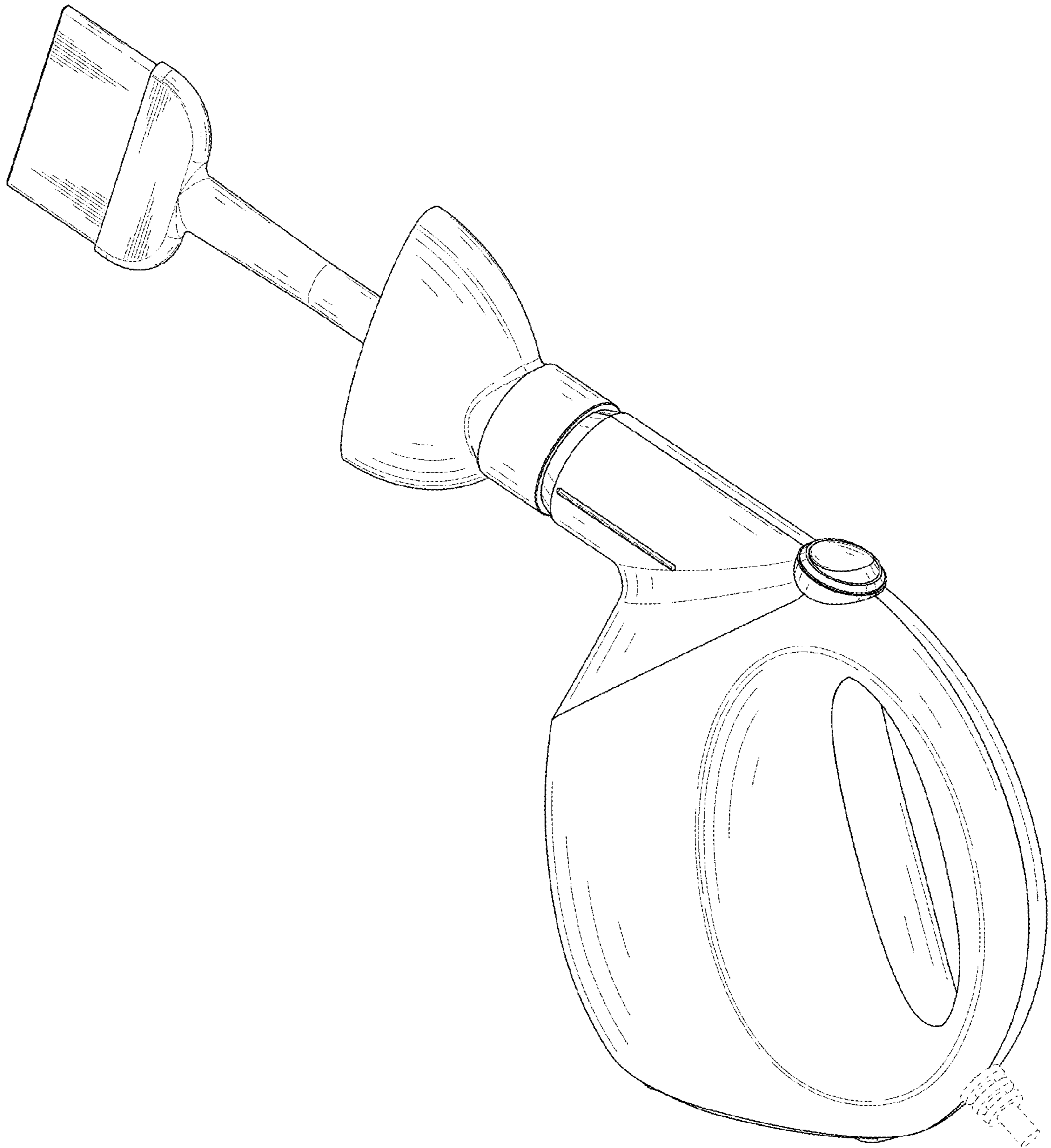
