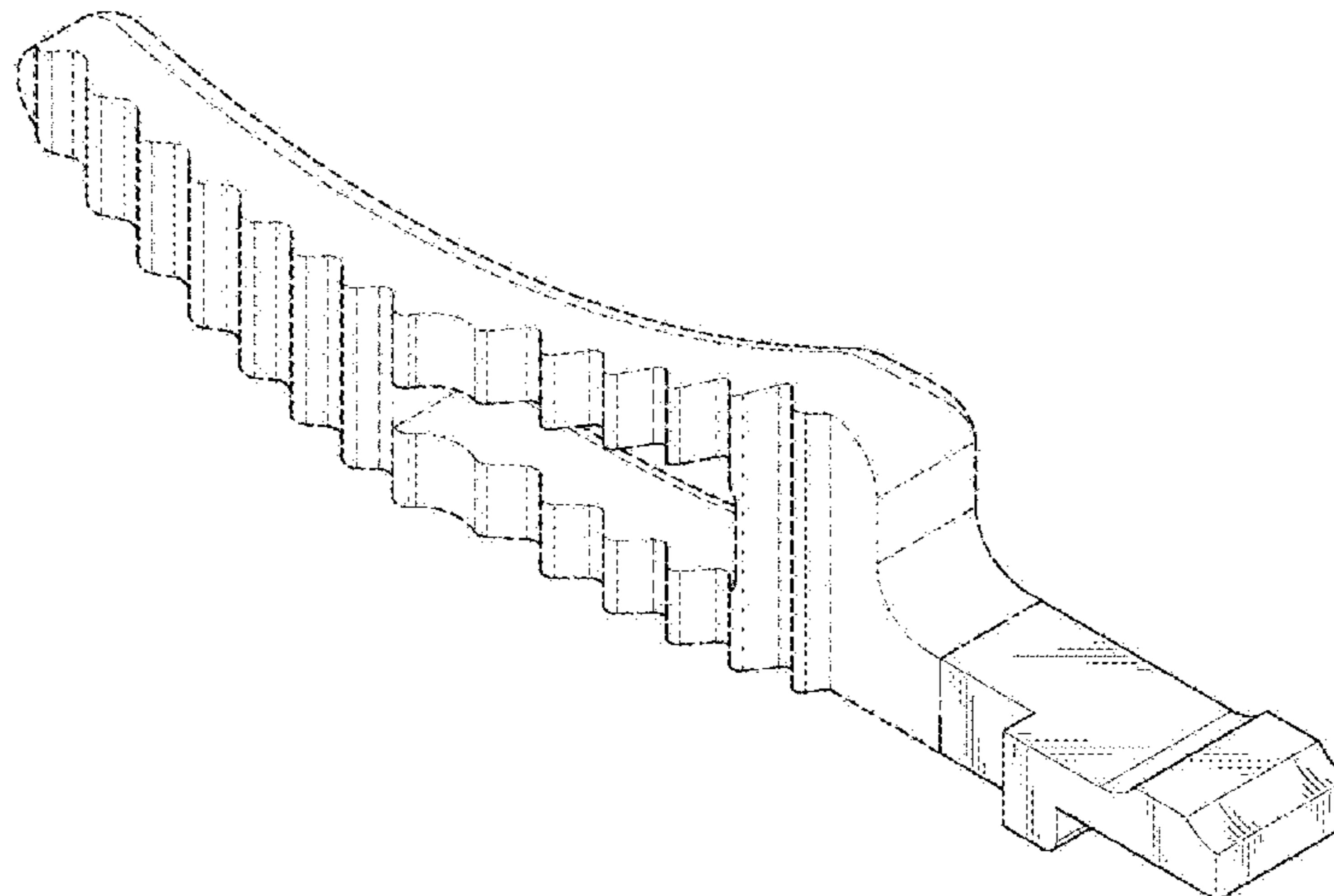
DESCRIPTION

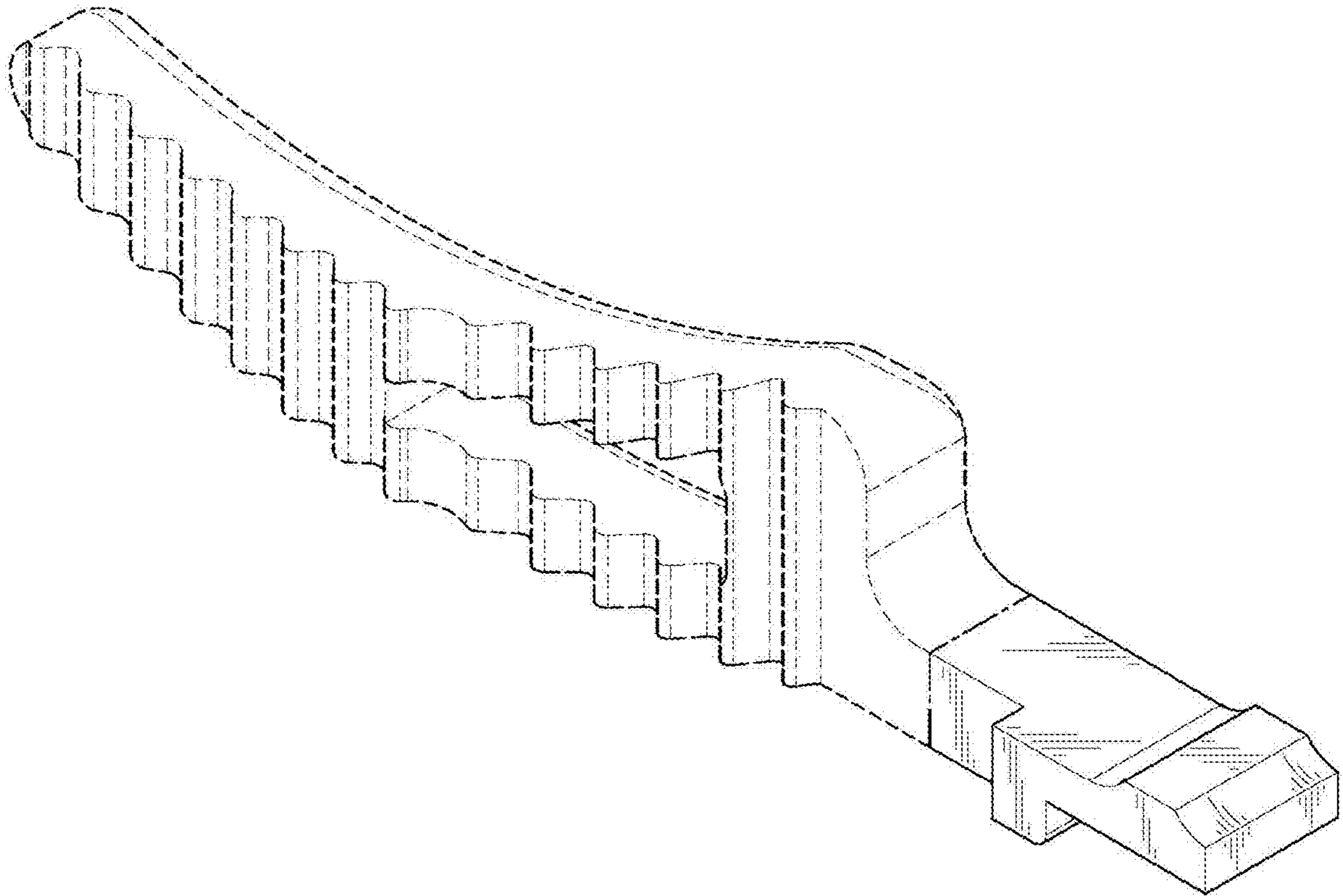

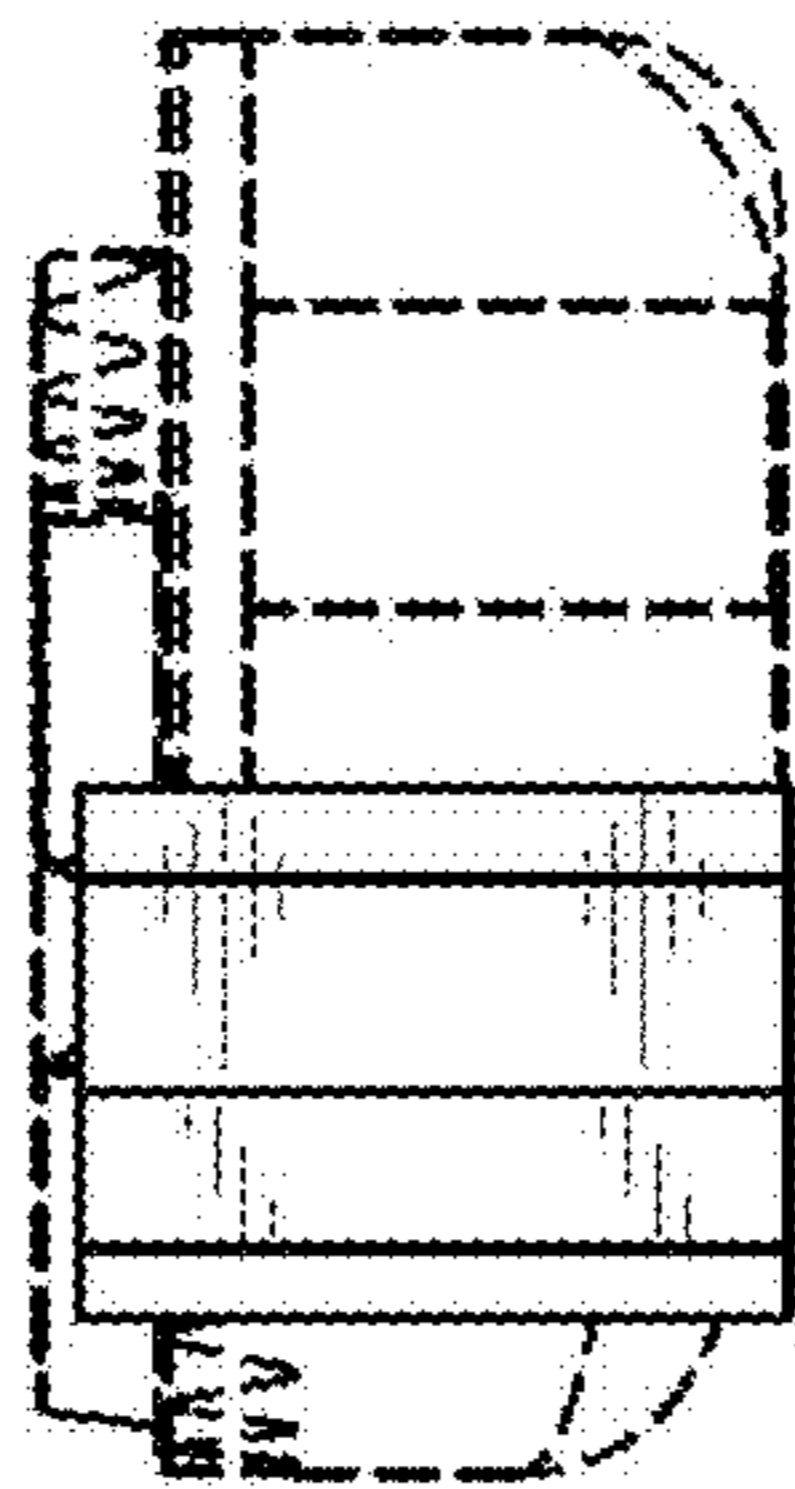

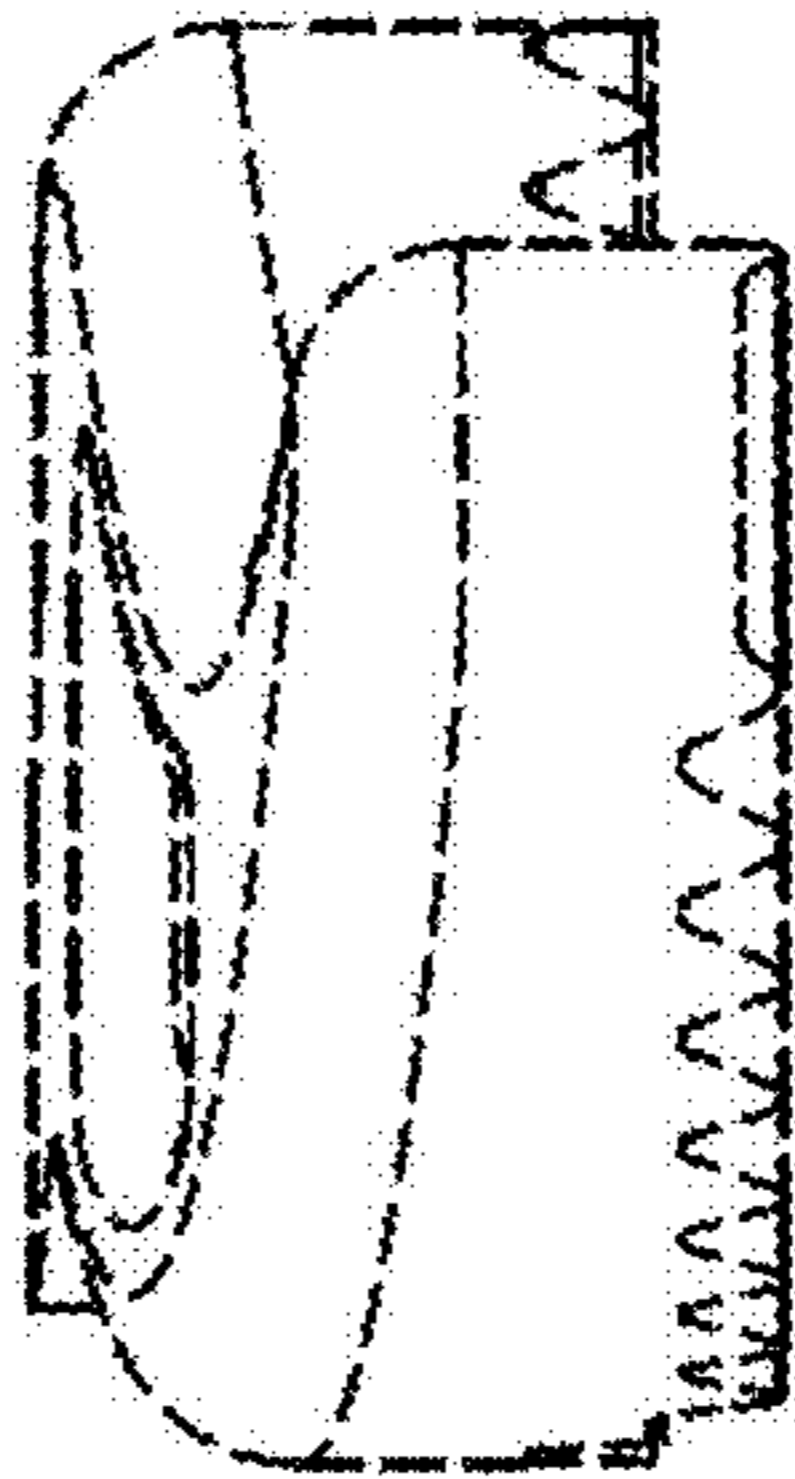

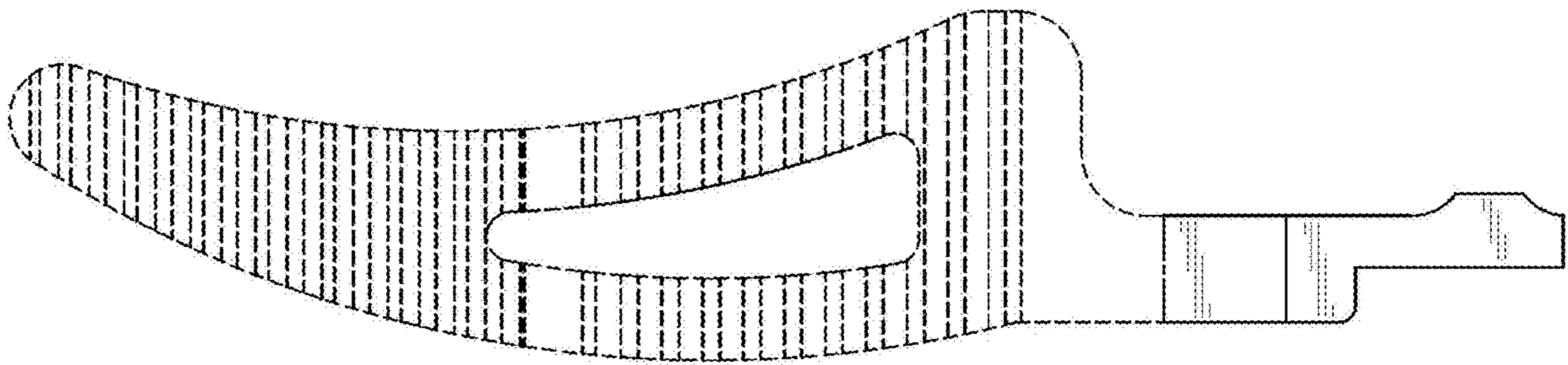

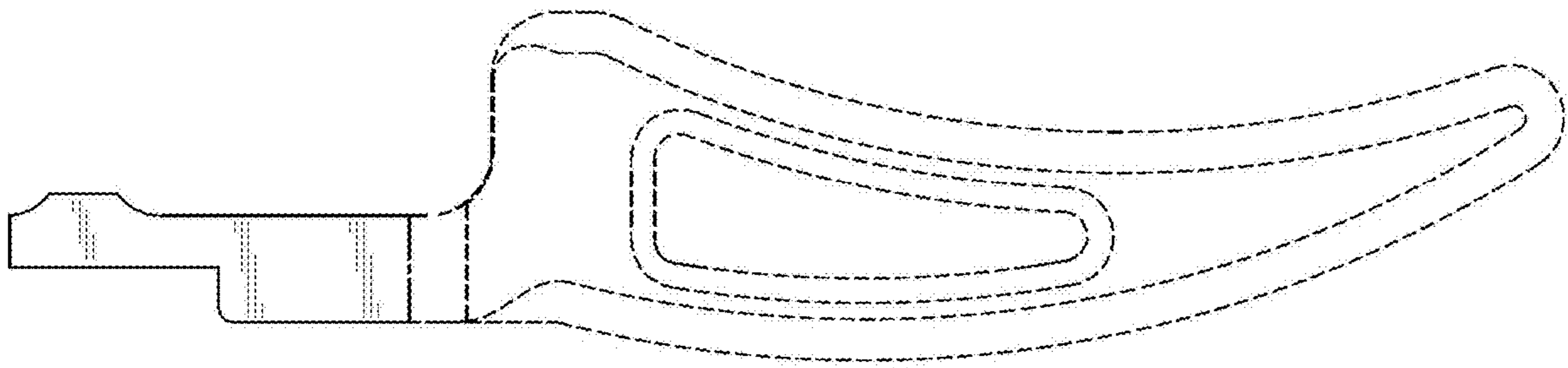

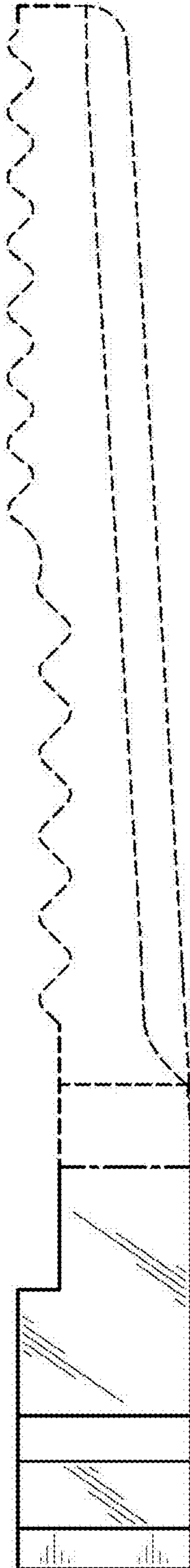
