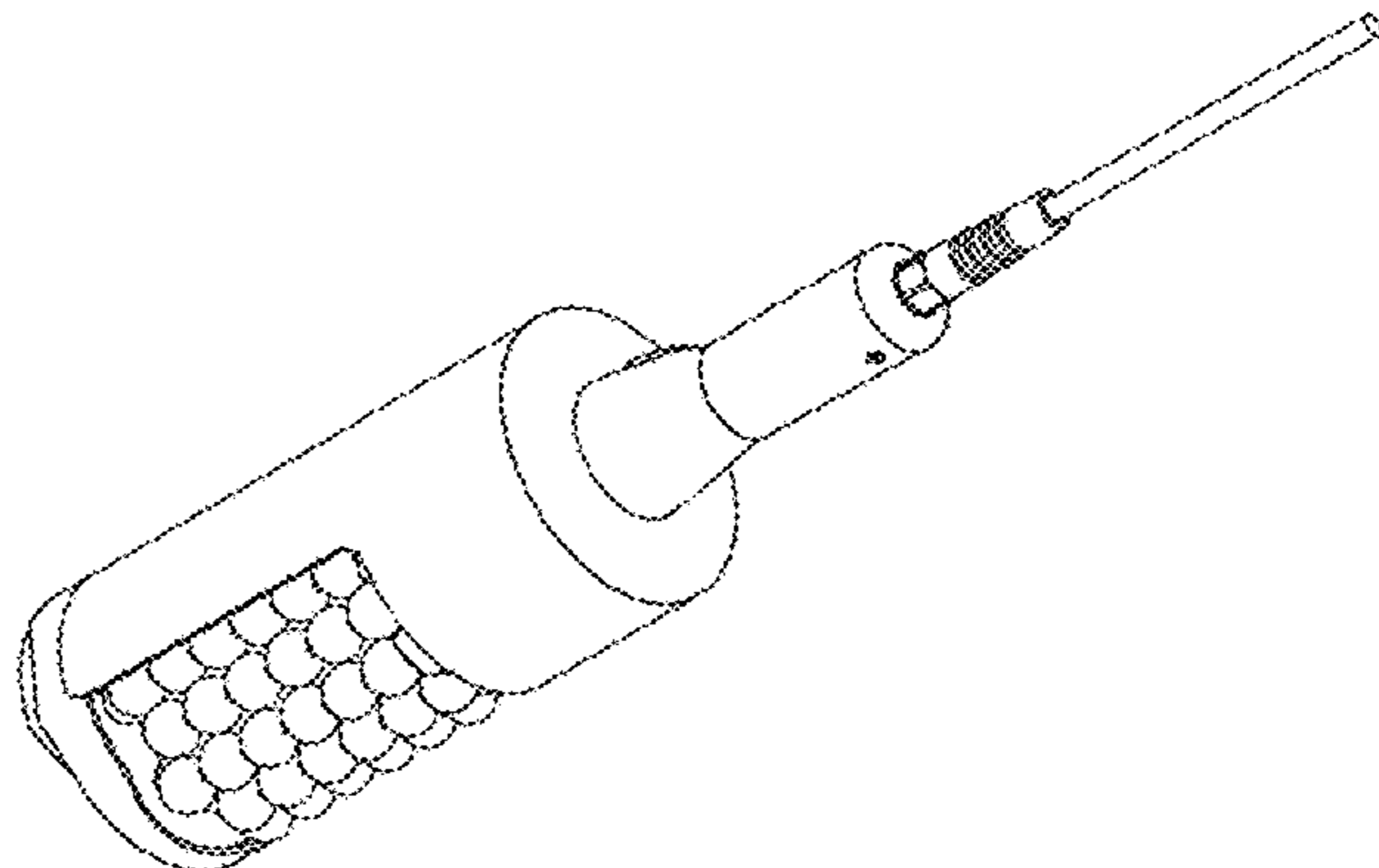
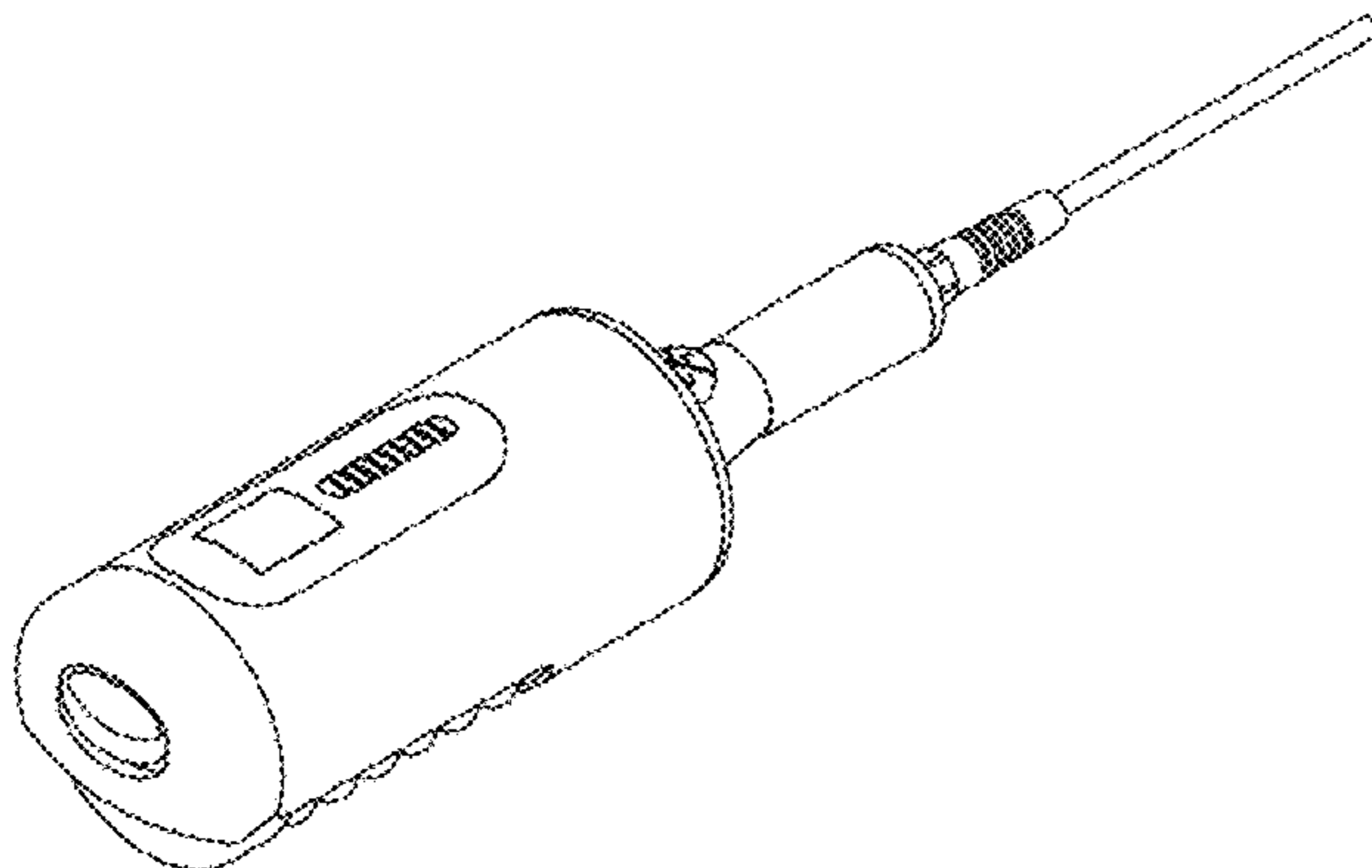

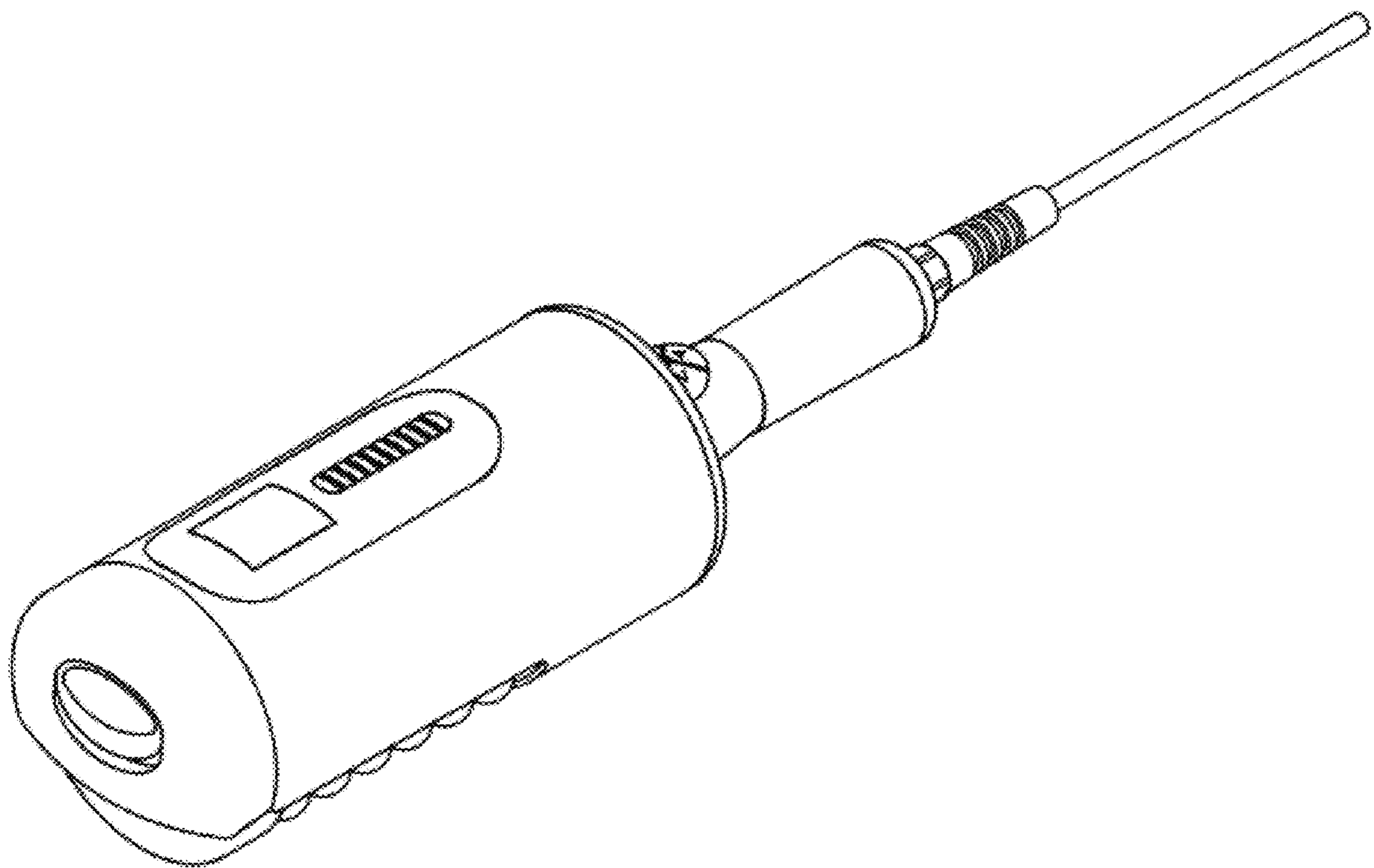

and a handle with joystick button in the back.

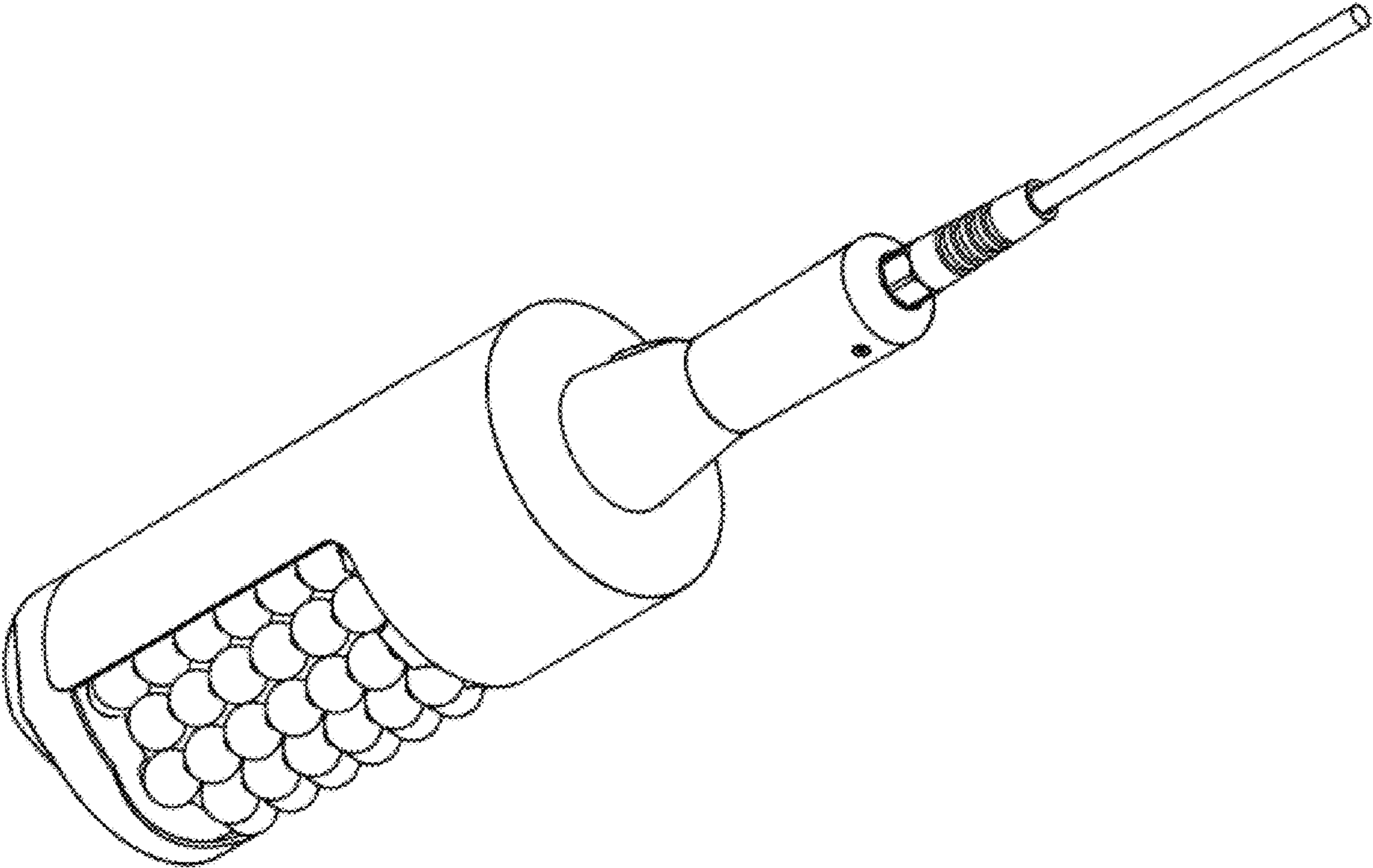

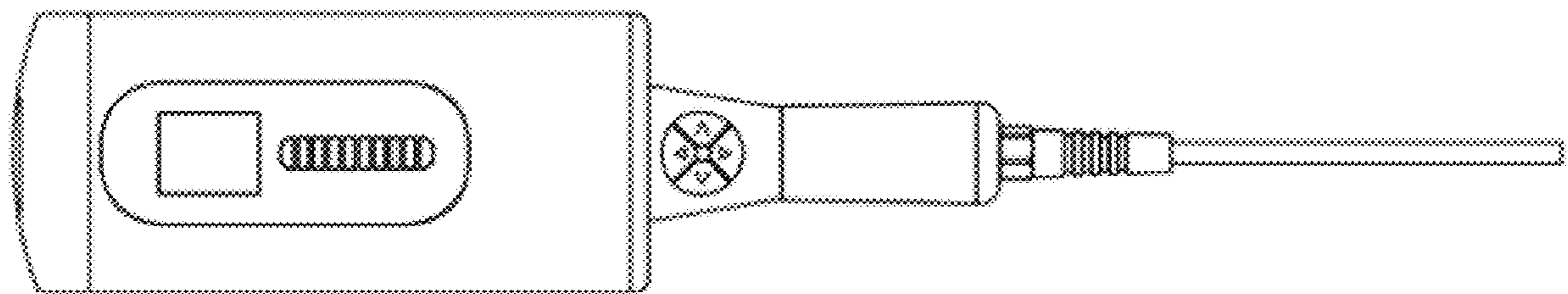

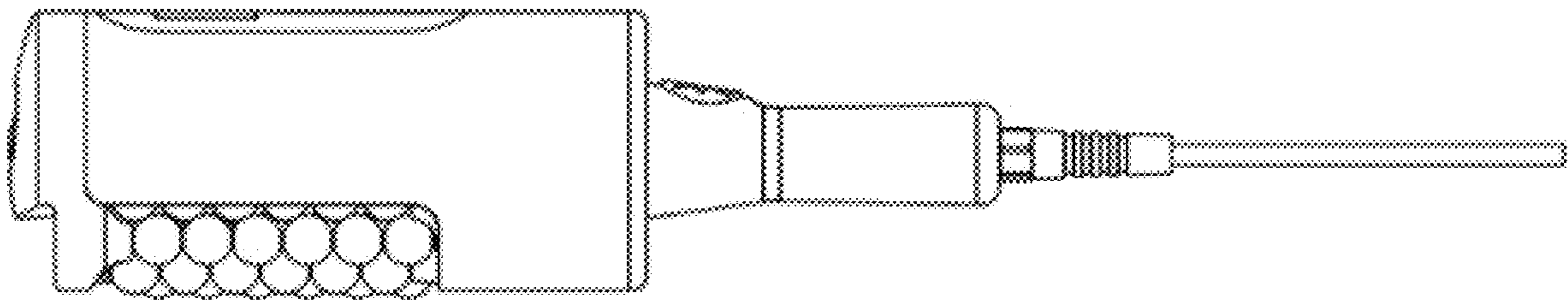

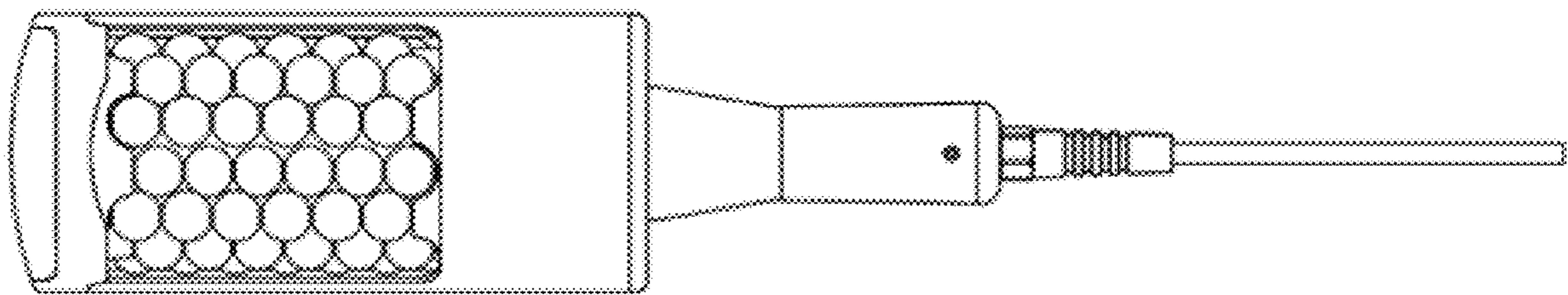

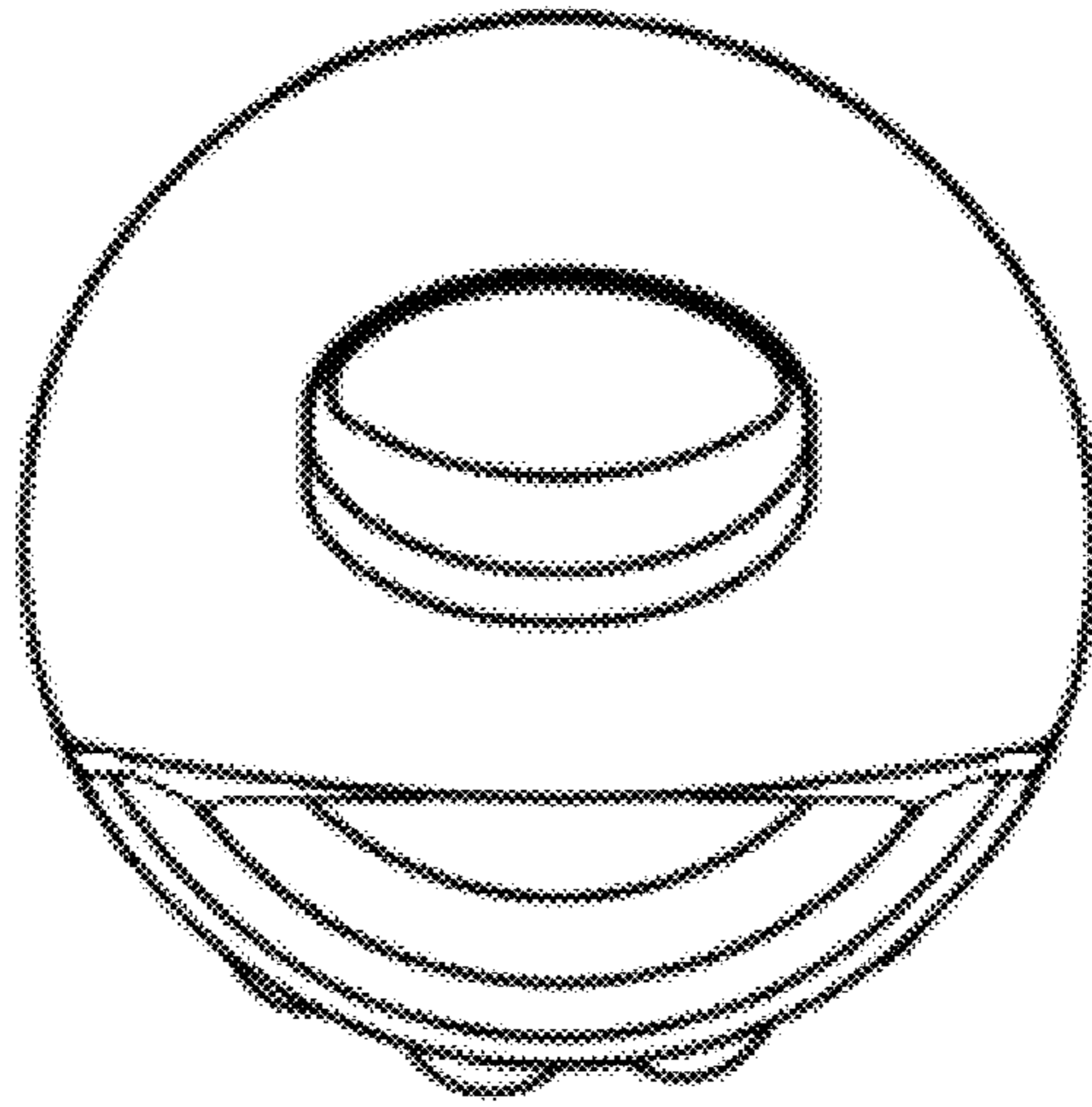
