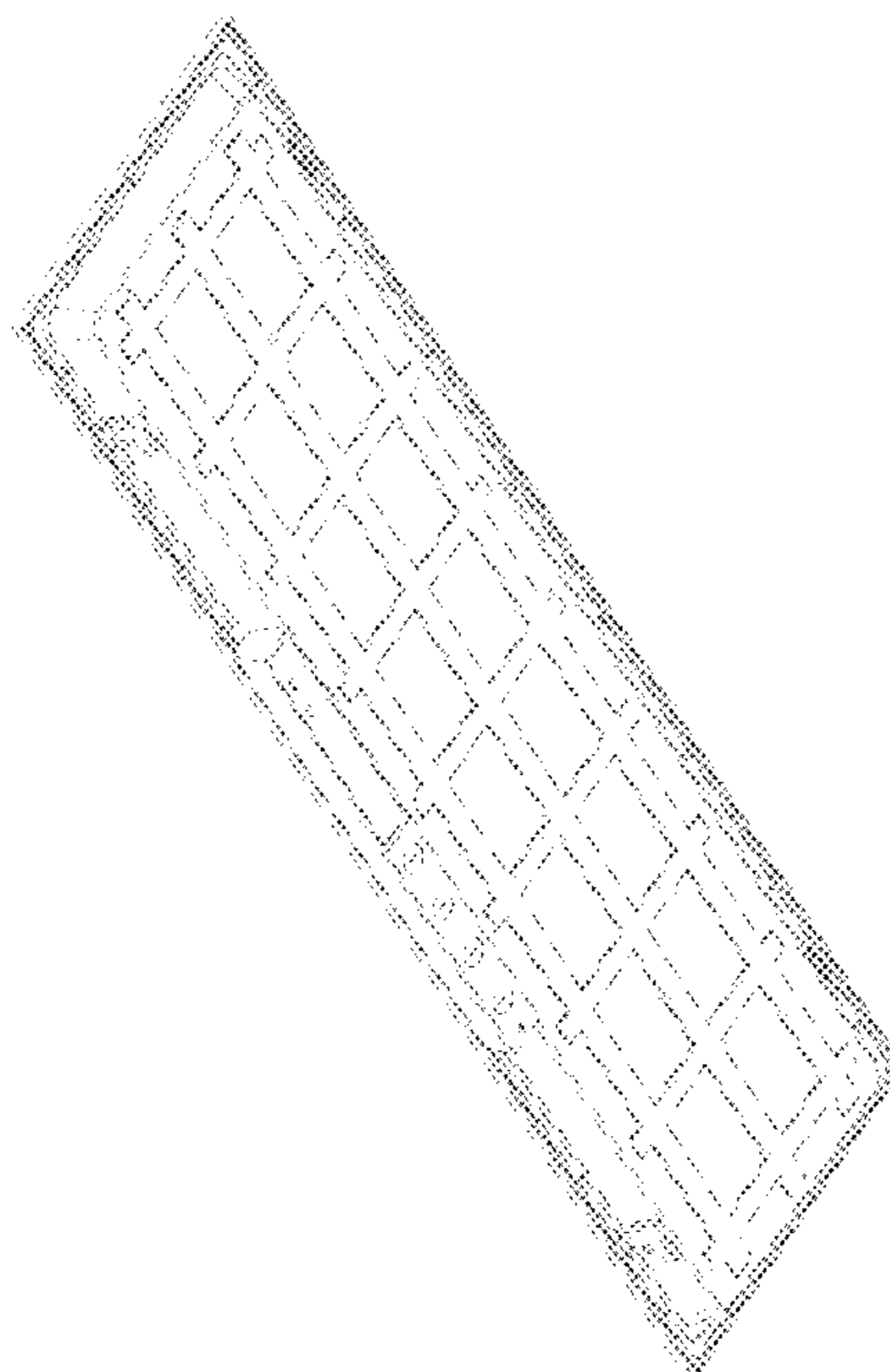
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the panel light showing my new design;
FIG. 2 is the front view thereof;

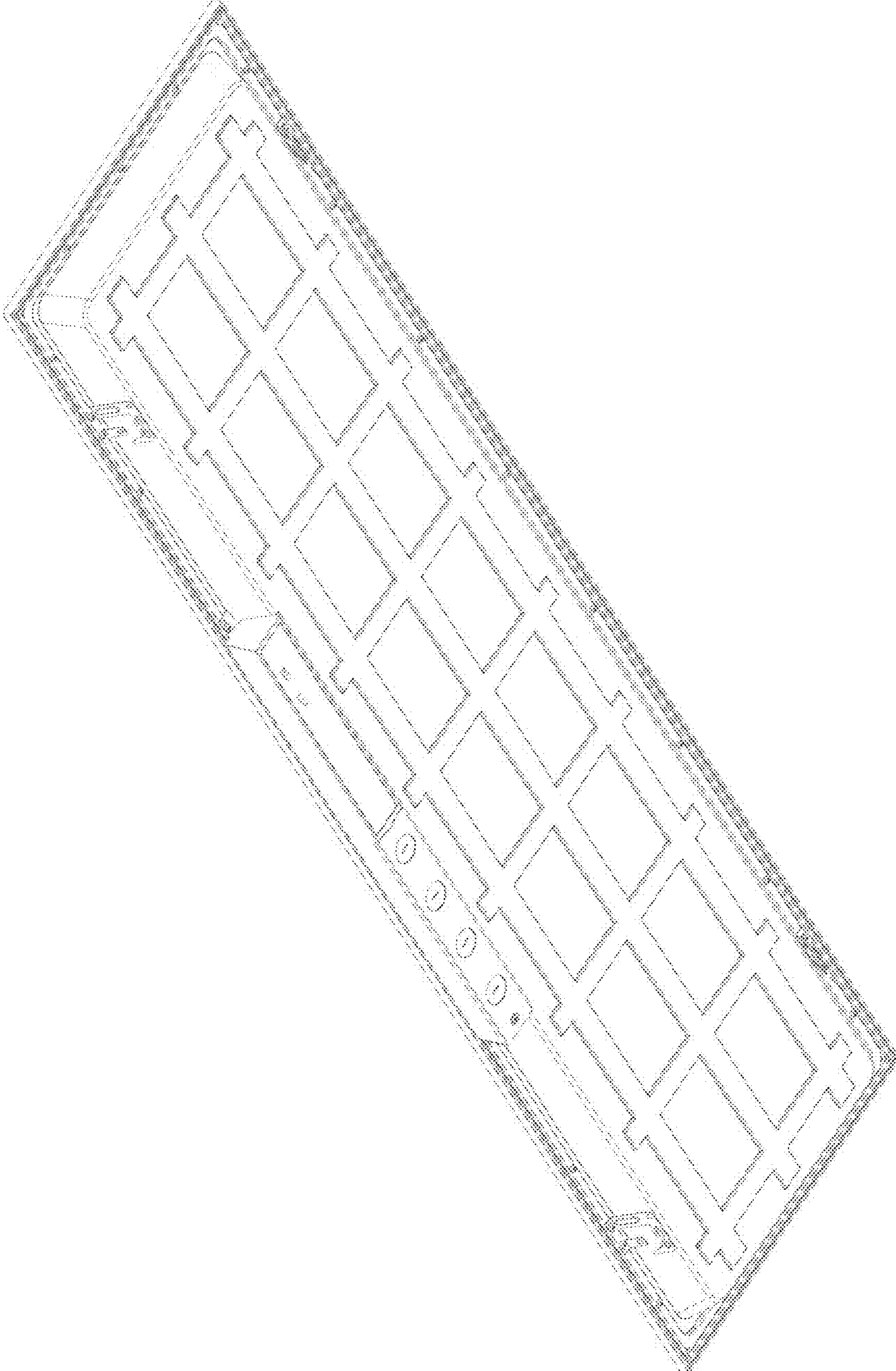

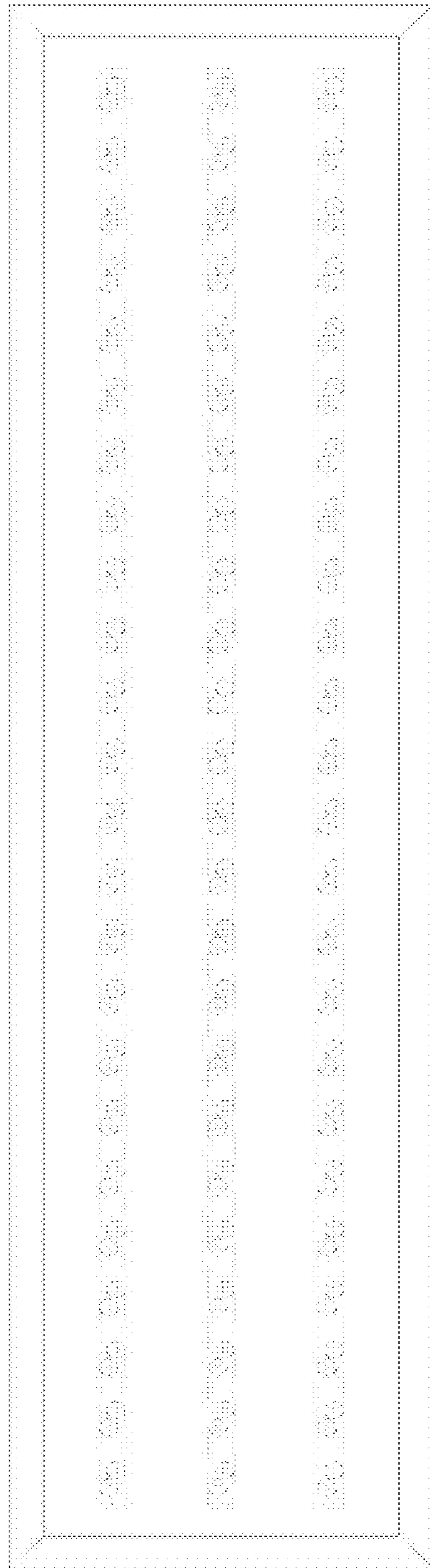

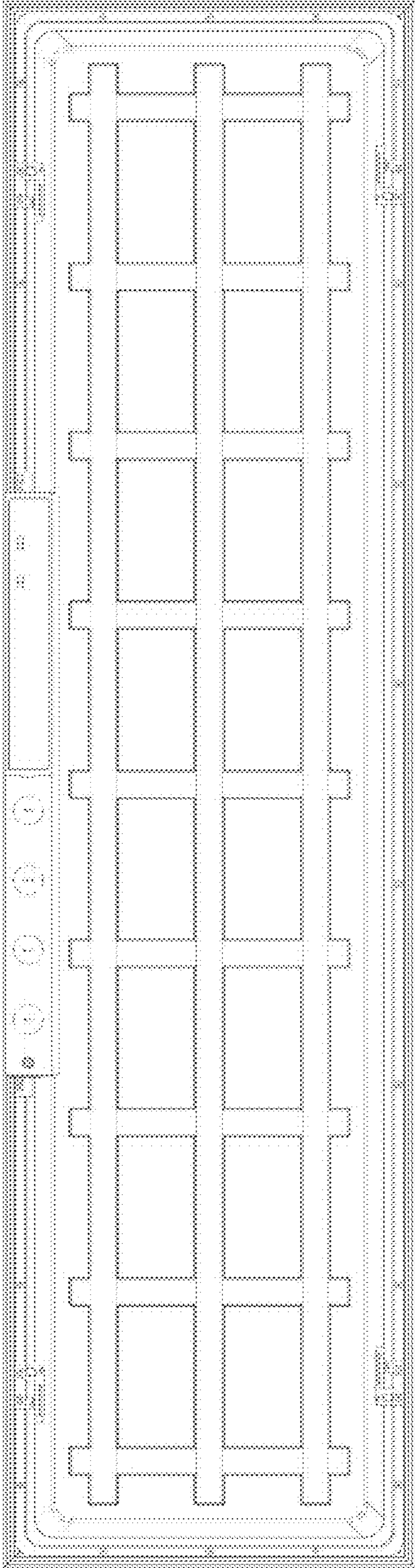

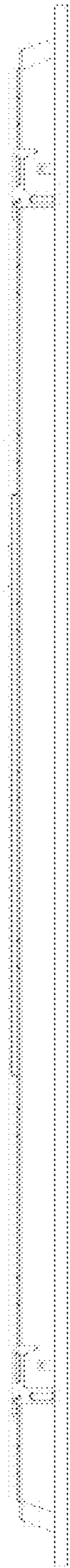

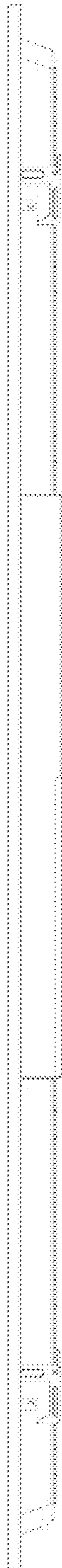

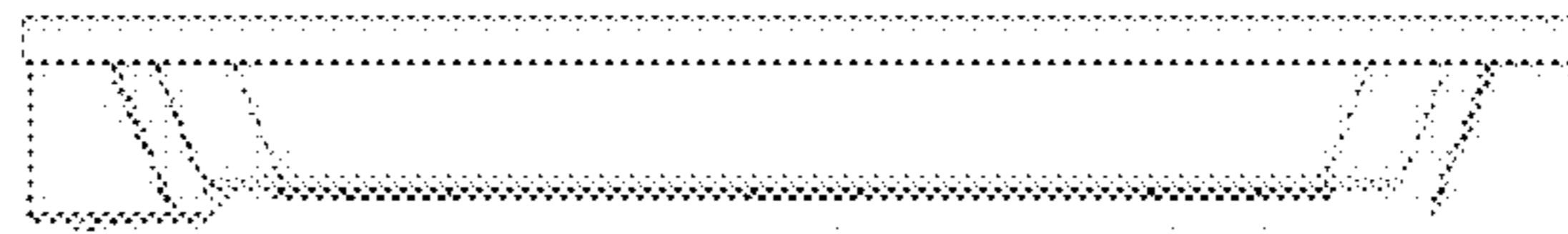

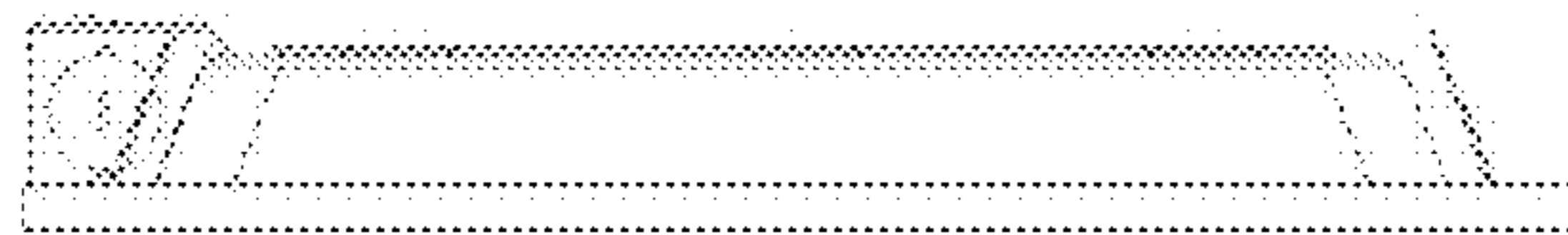
