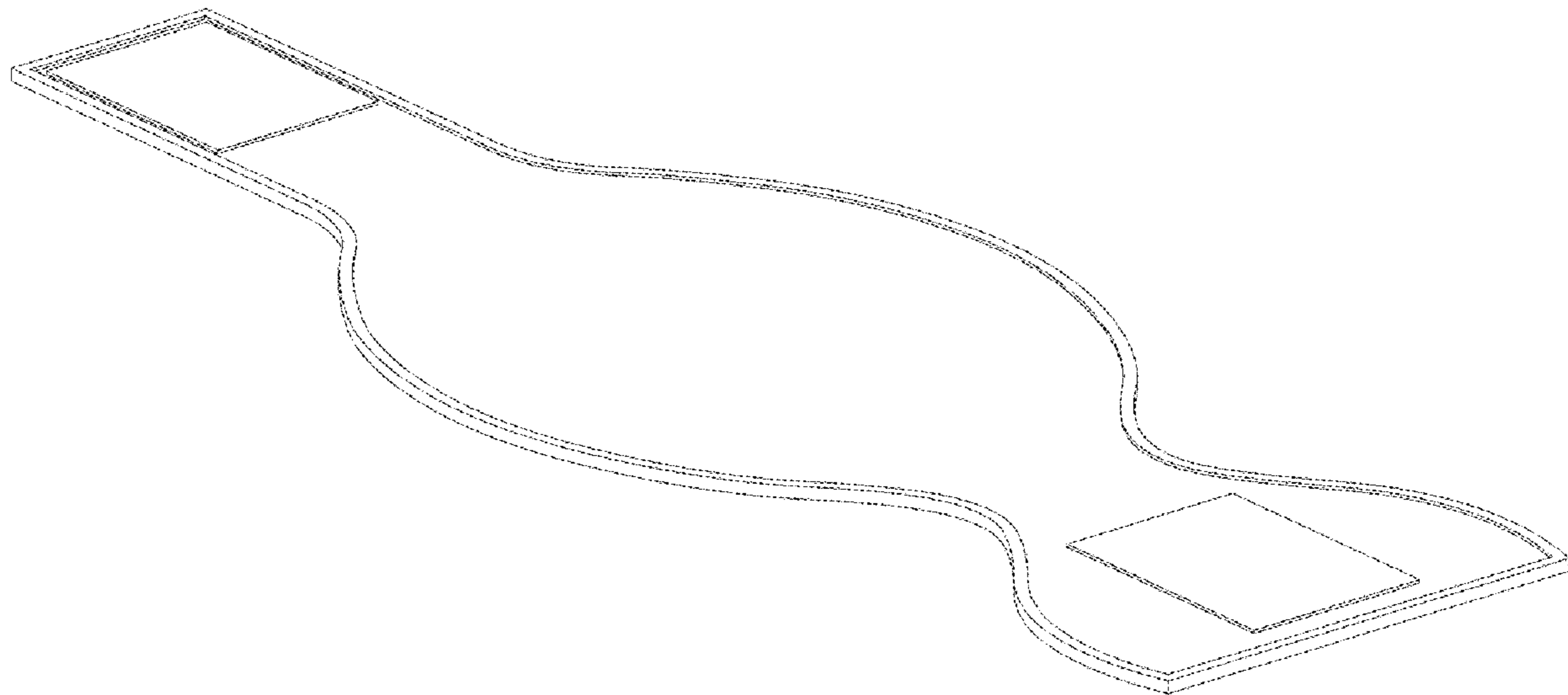
(57) **CLAIM**

The ornamental design for a washable diaper for female dogs, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a washable diaper for female dogs showing the claimed design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a front elevational view thereof;
FIG. 6 is a right side view thereof; and,
FIG. 7 is a bottom plan view thereof.

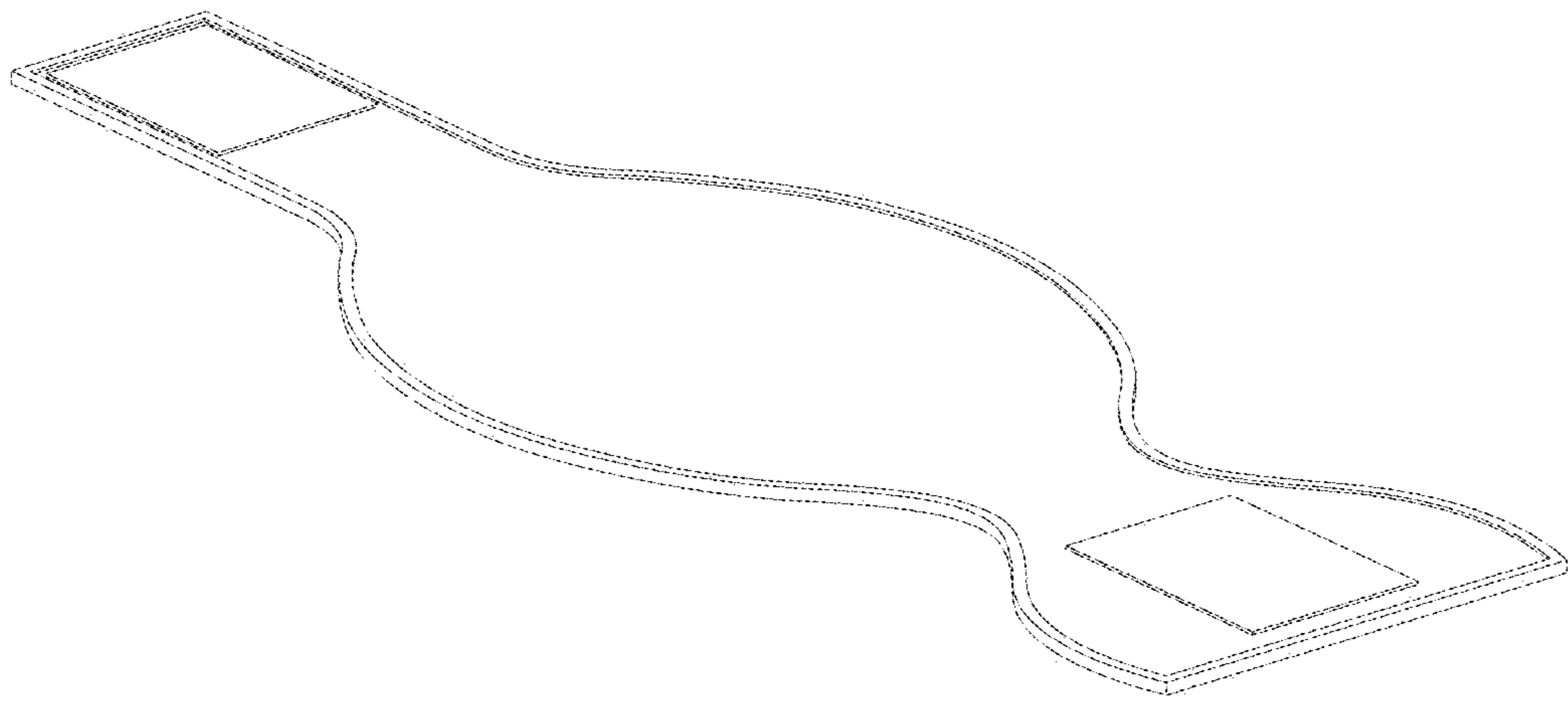

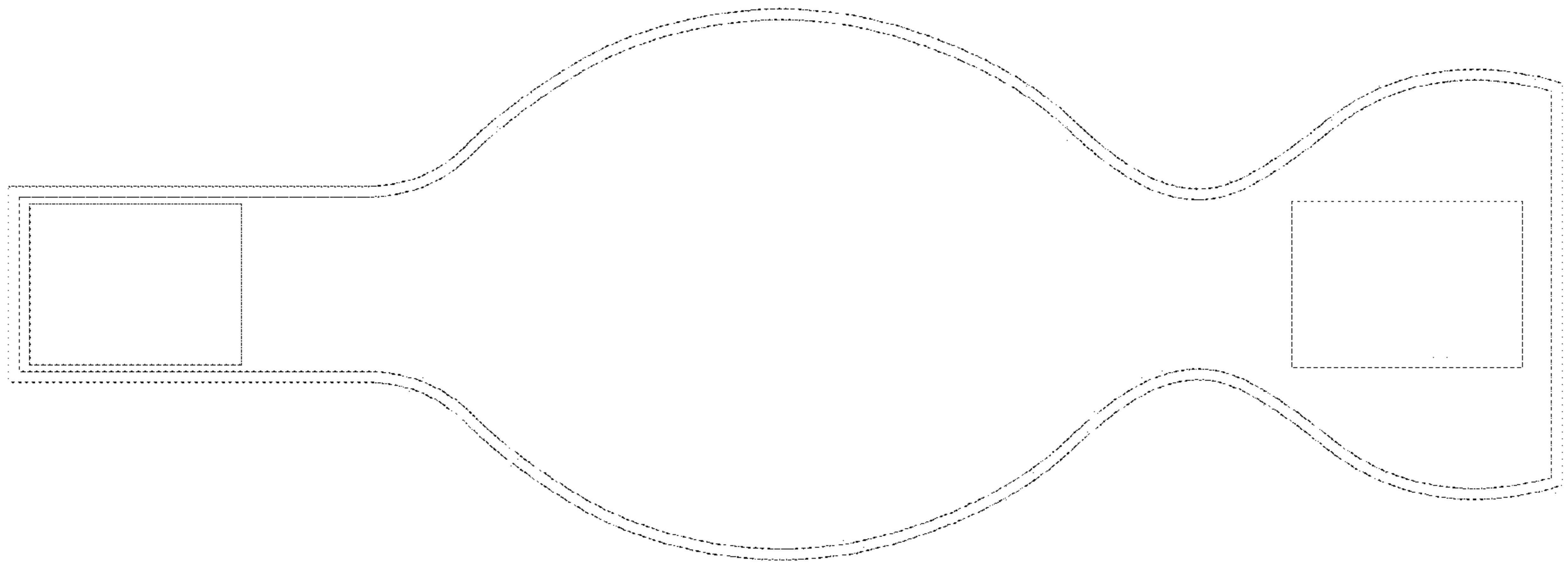

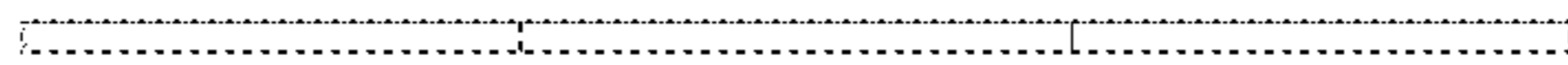

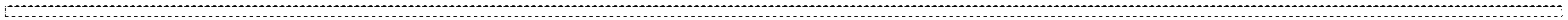

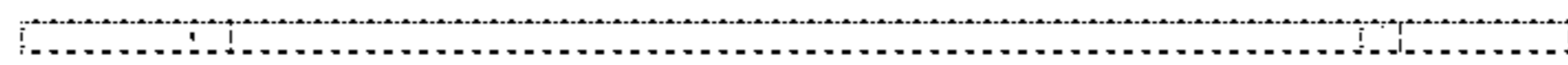

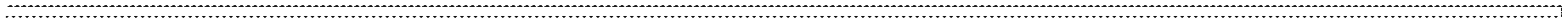

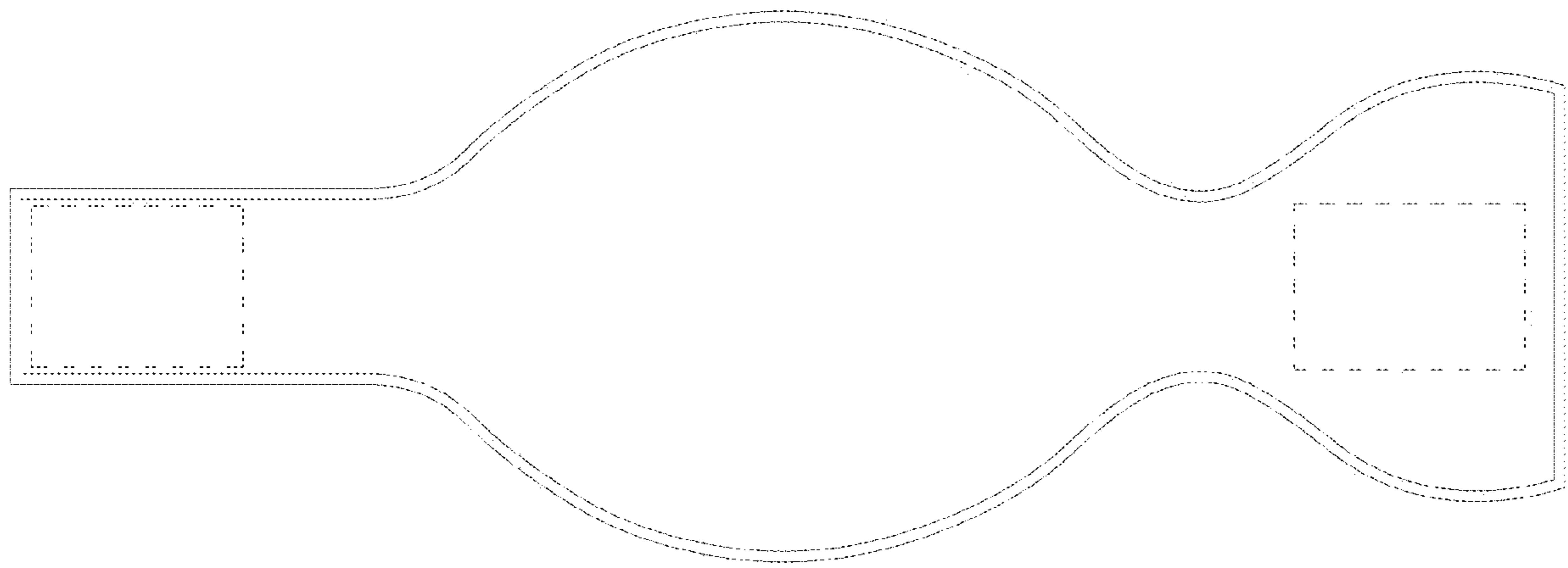
