DESCRIPTION

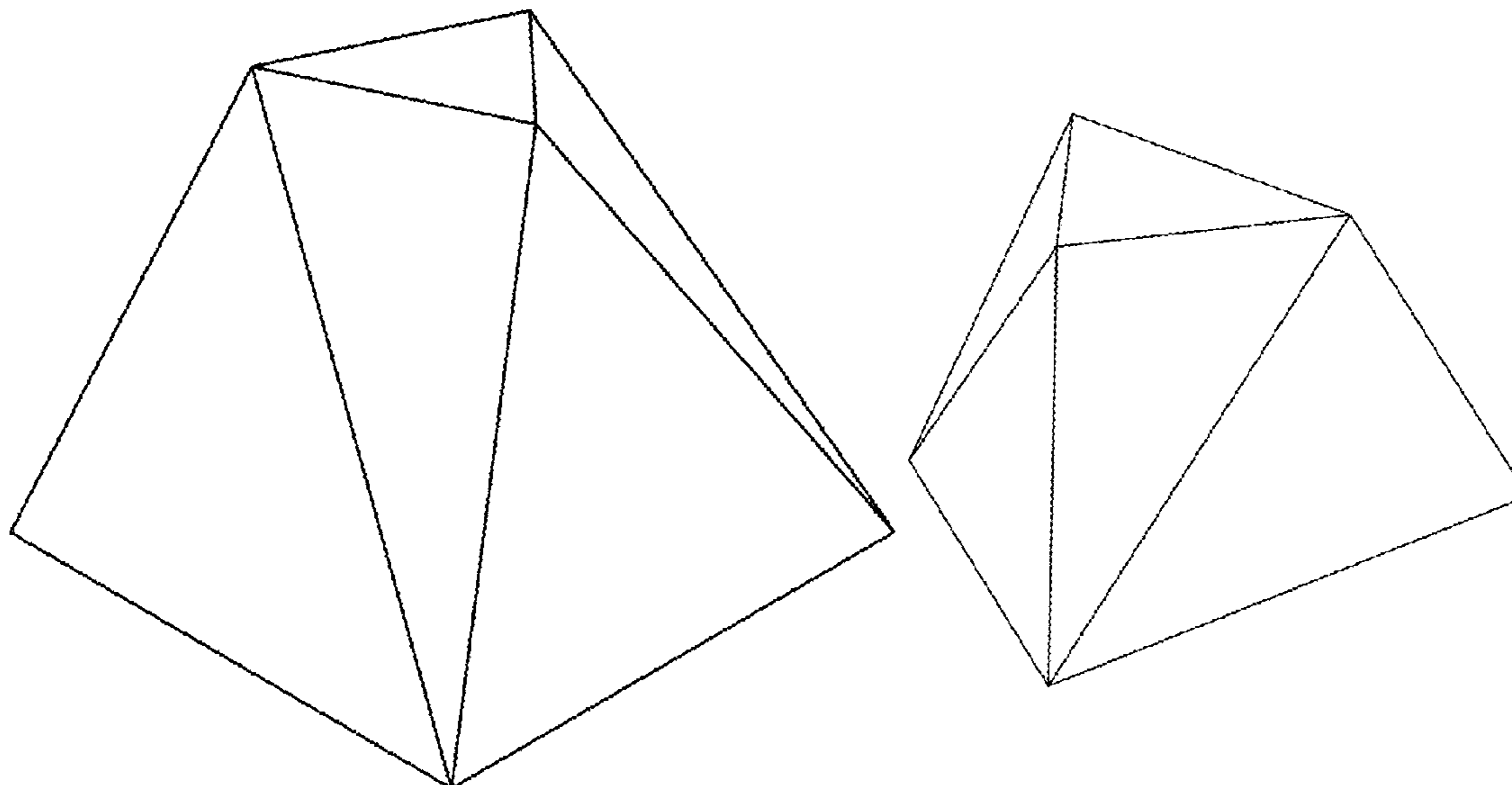
FIG. 1 is a top plan view of a first embodiment of a confectionary;

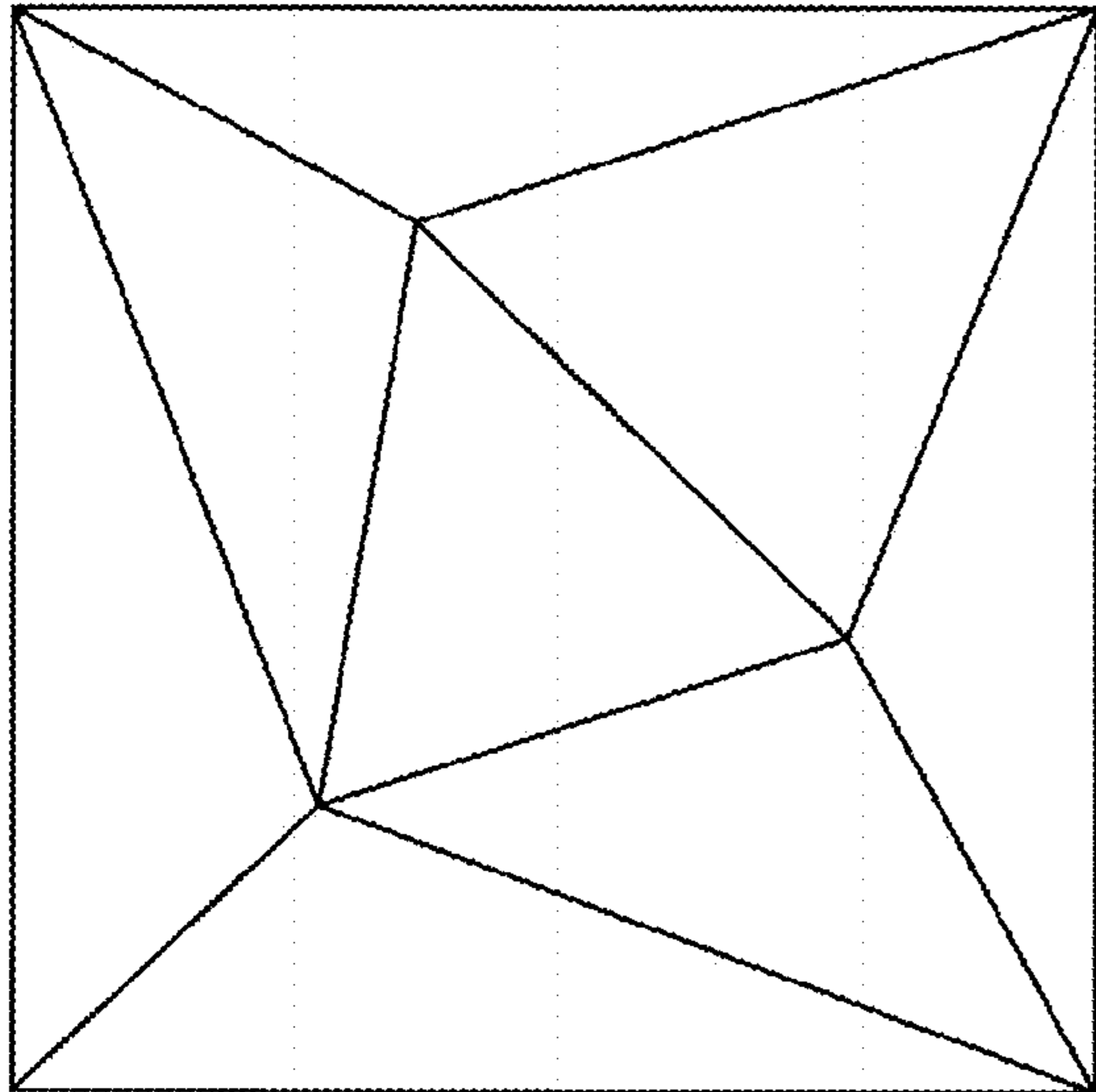

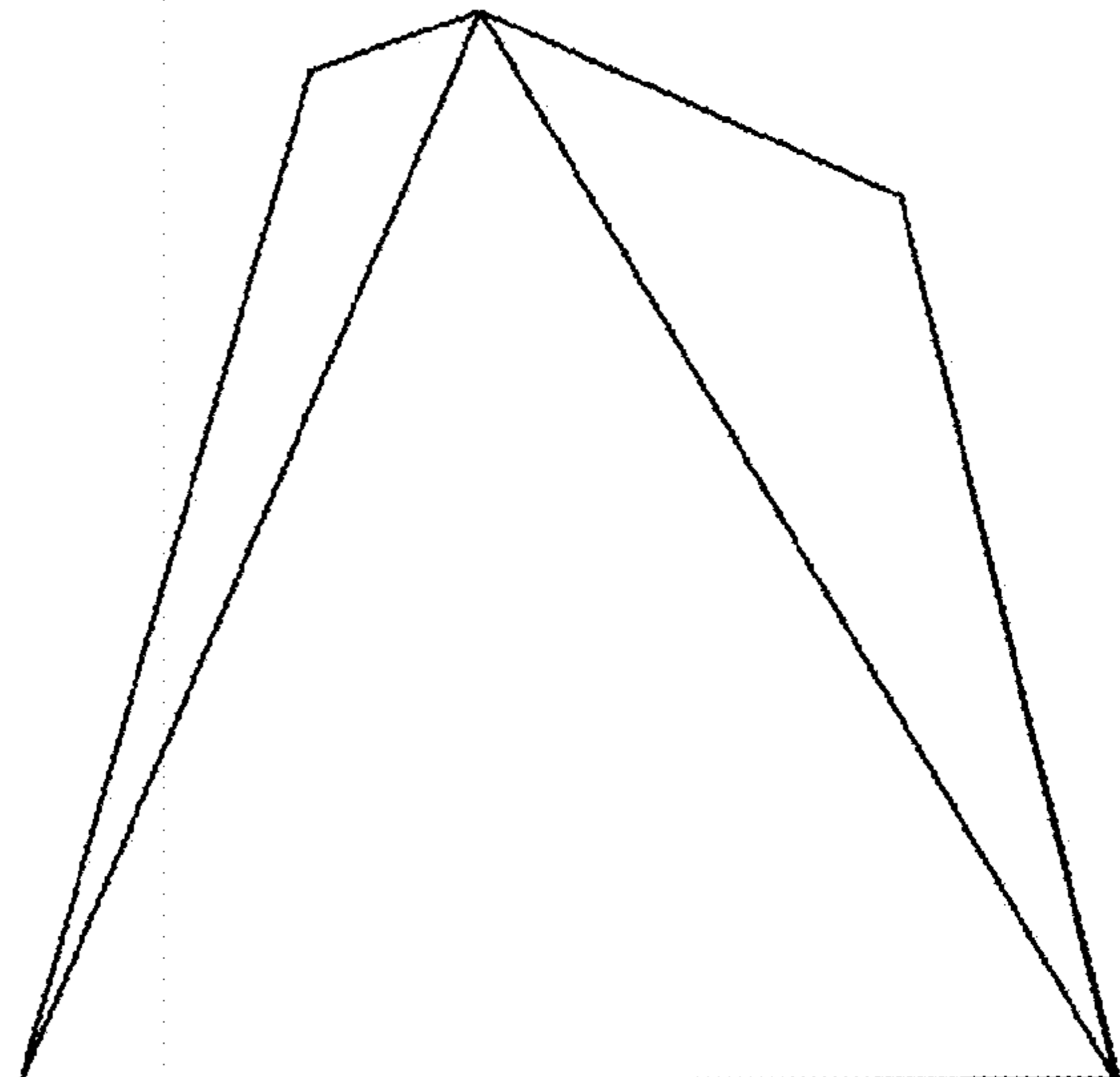

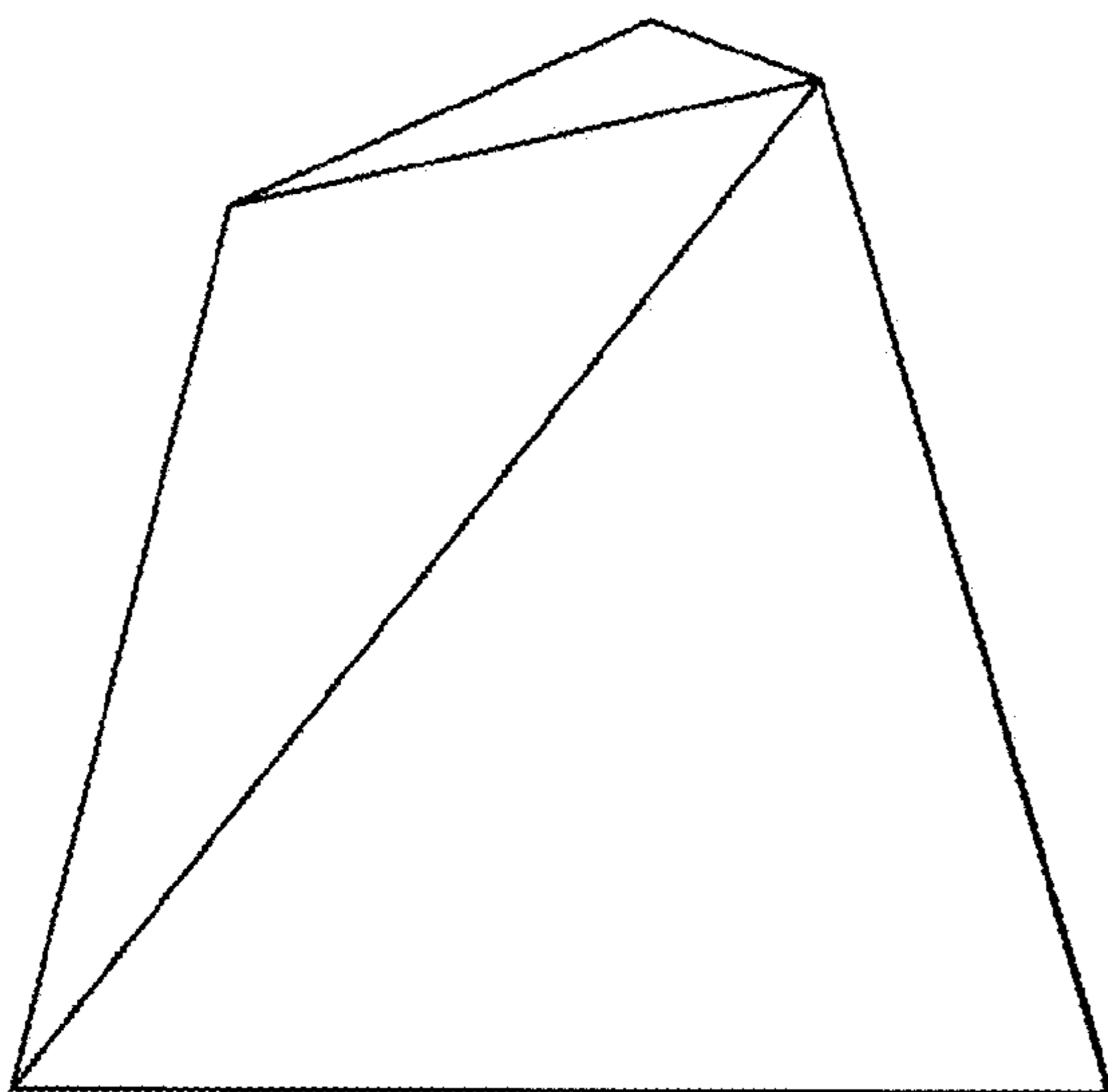

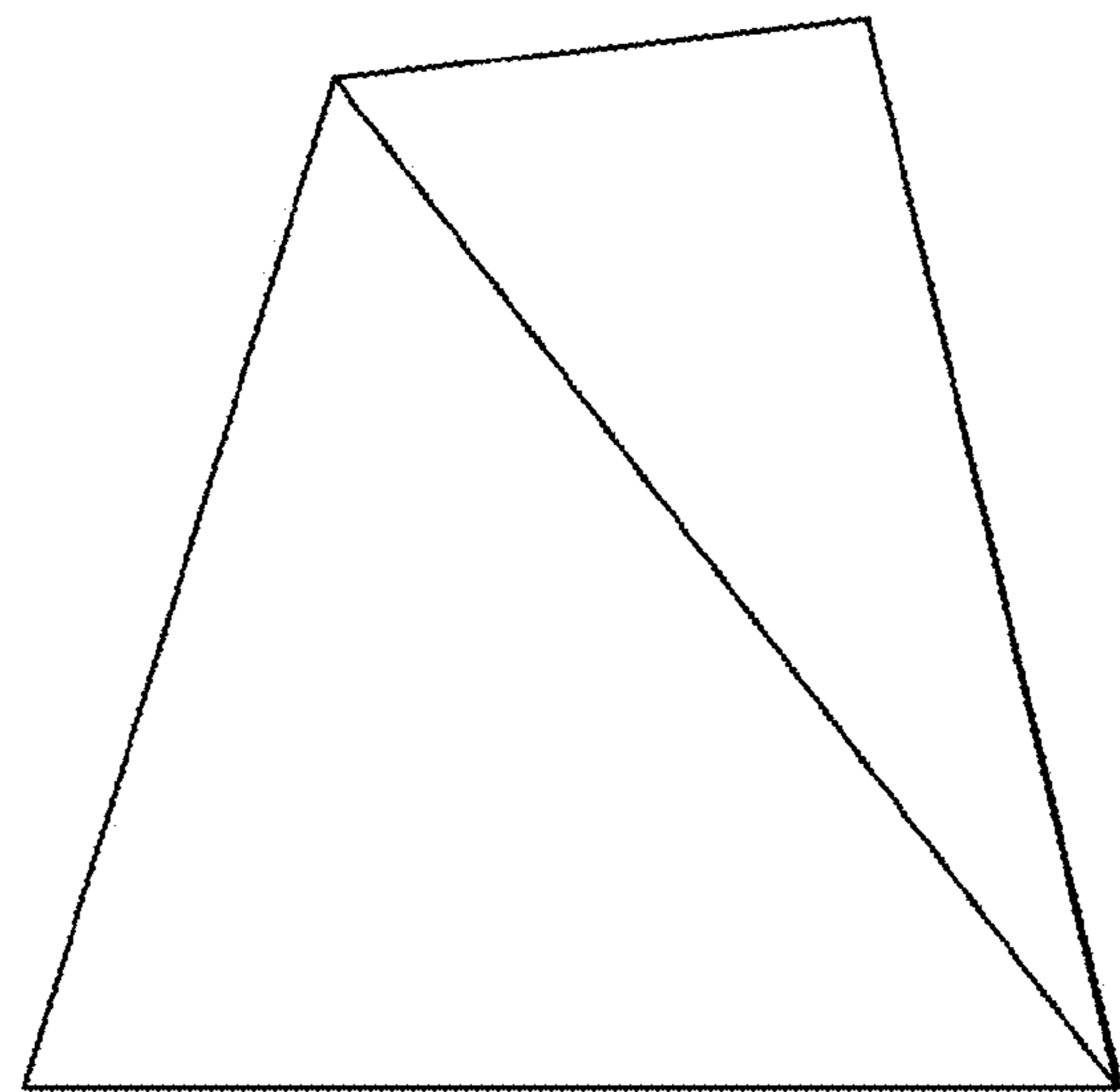

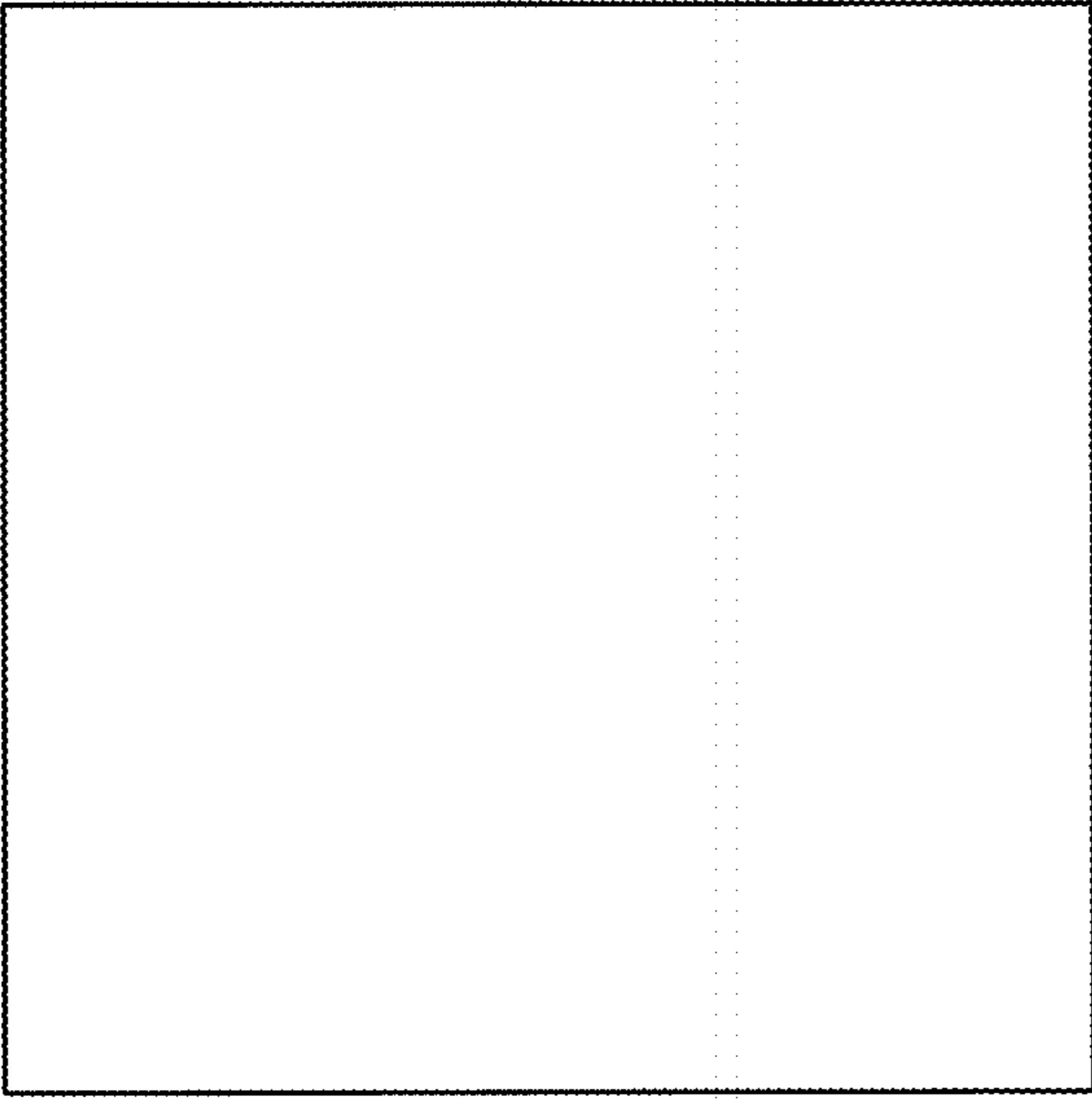

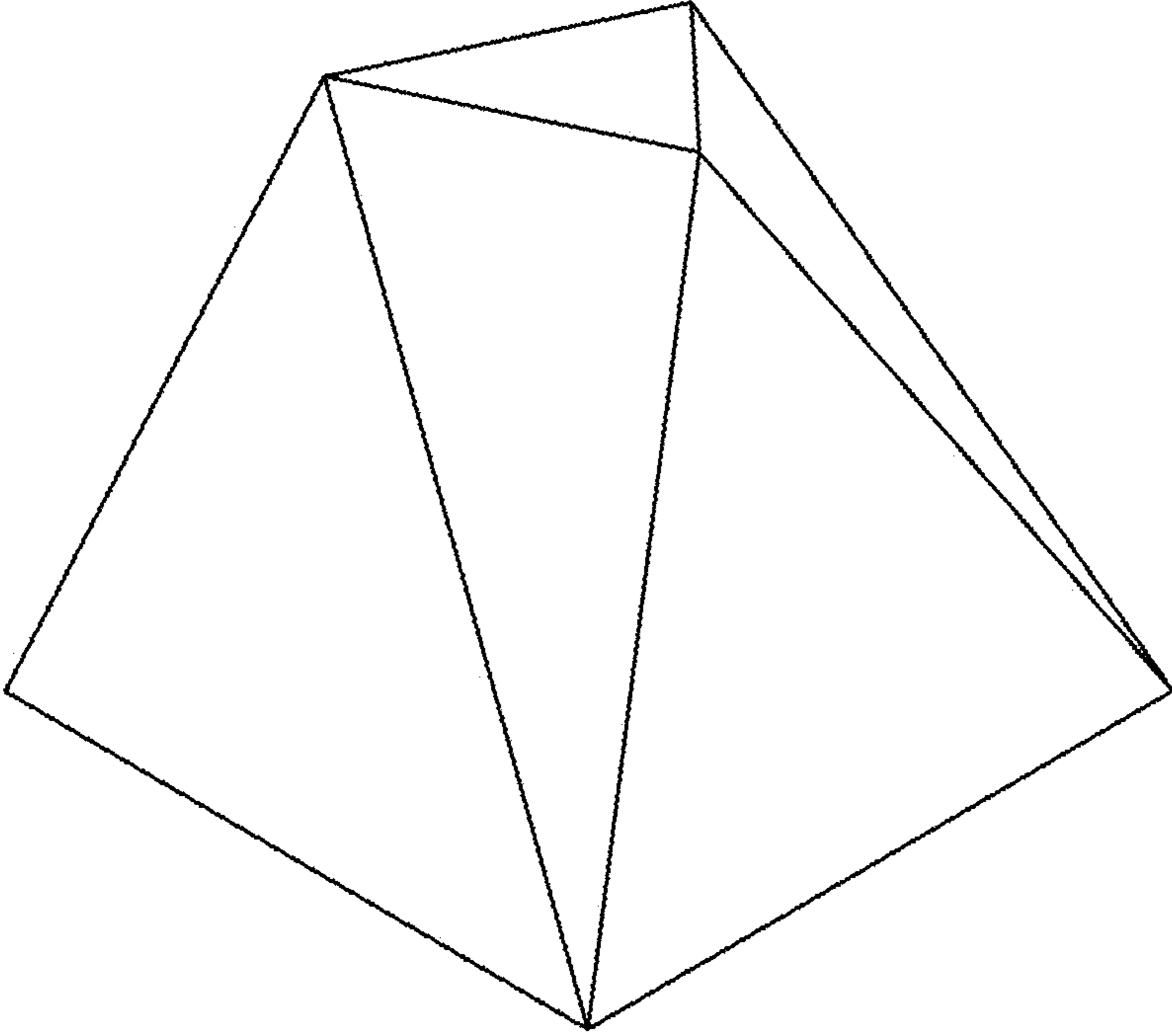

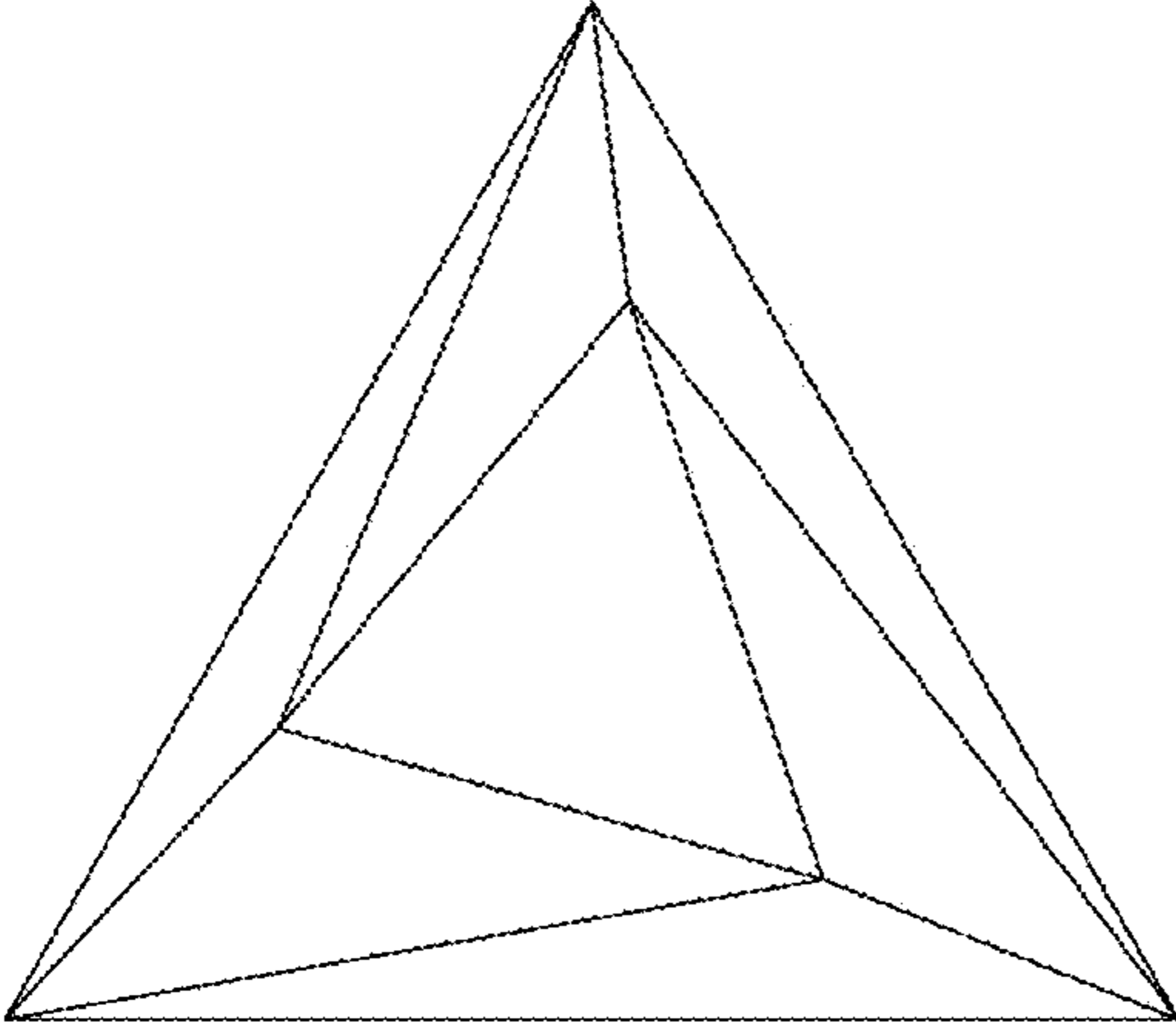

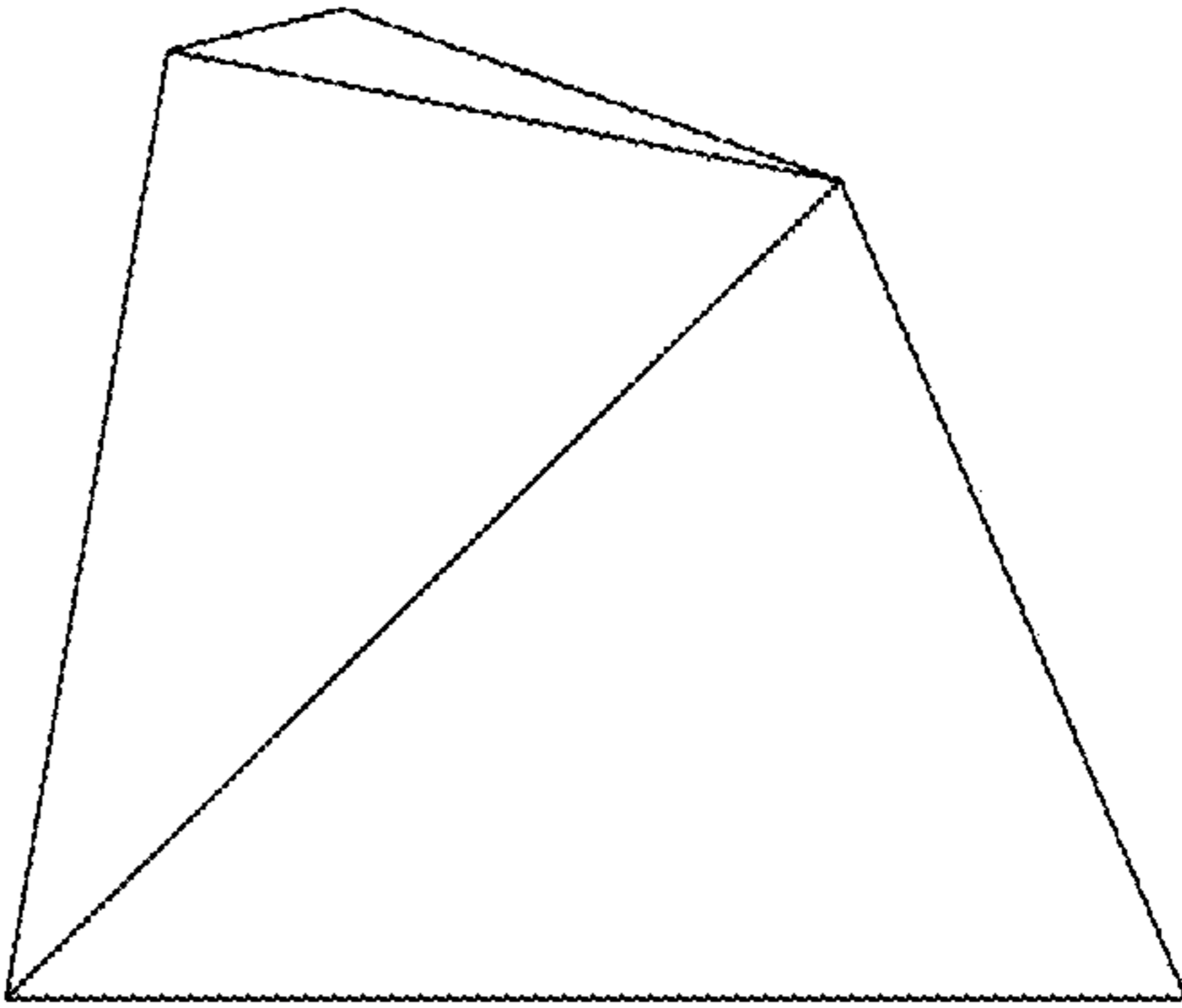

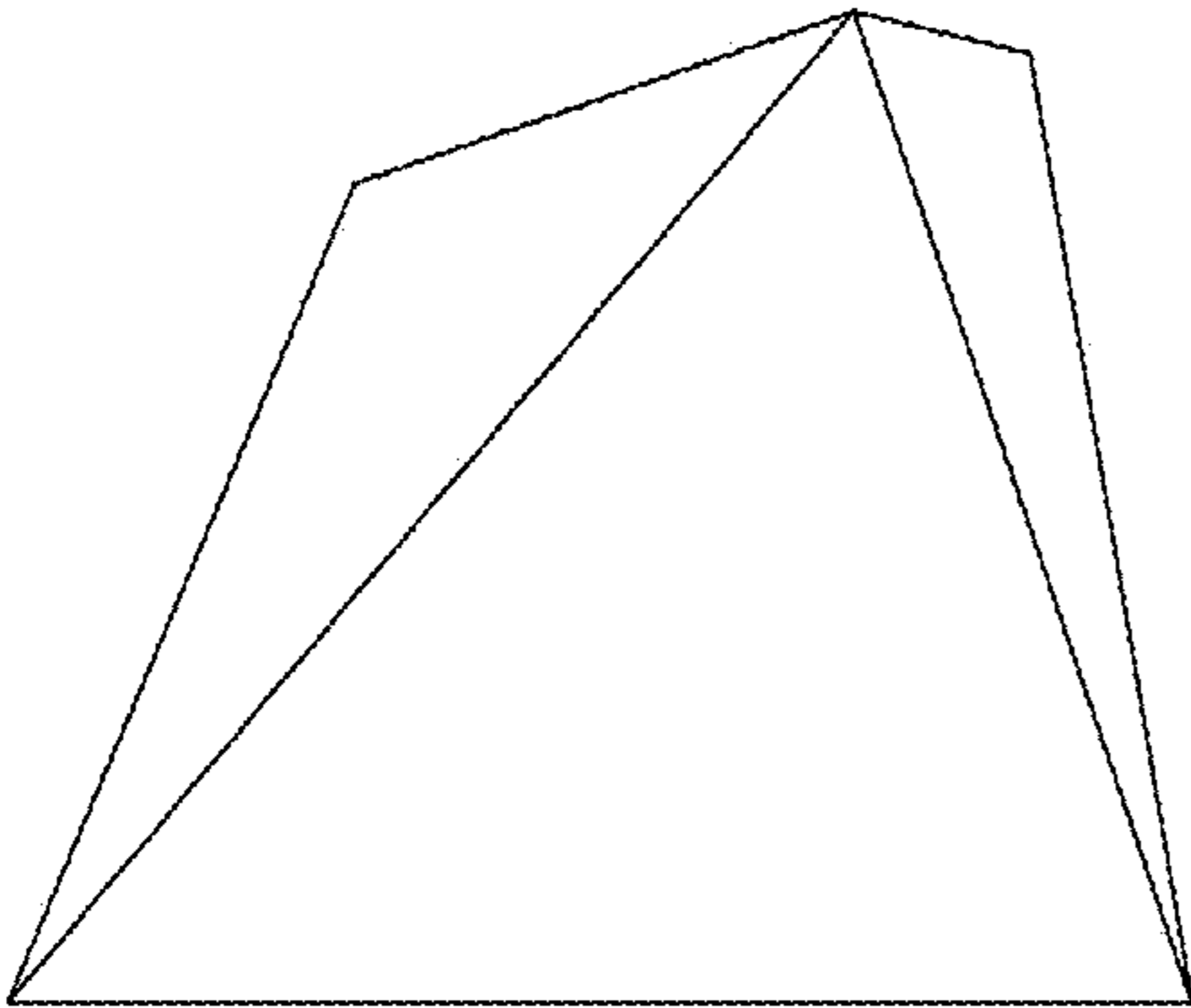

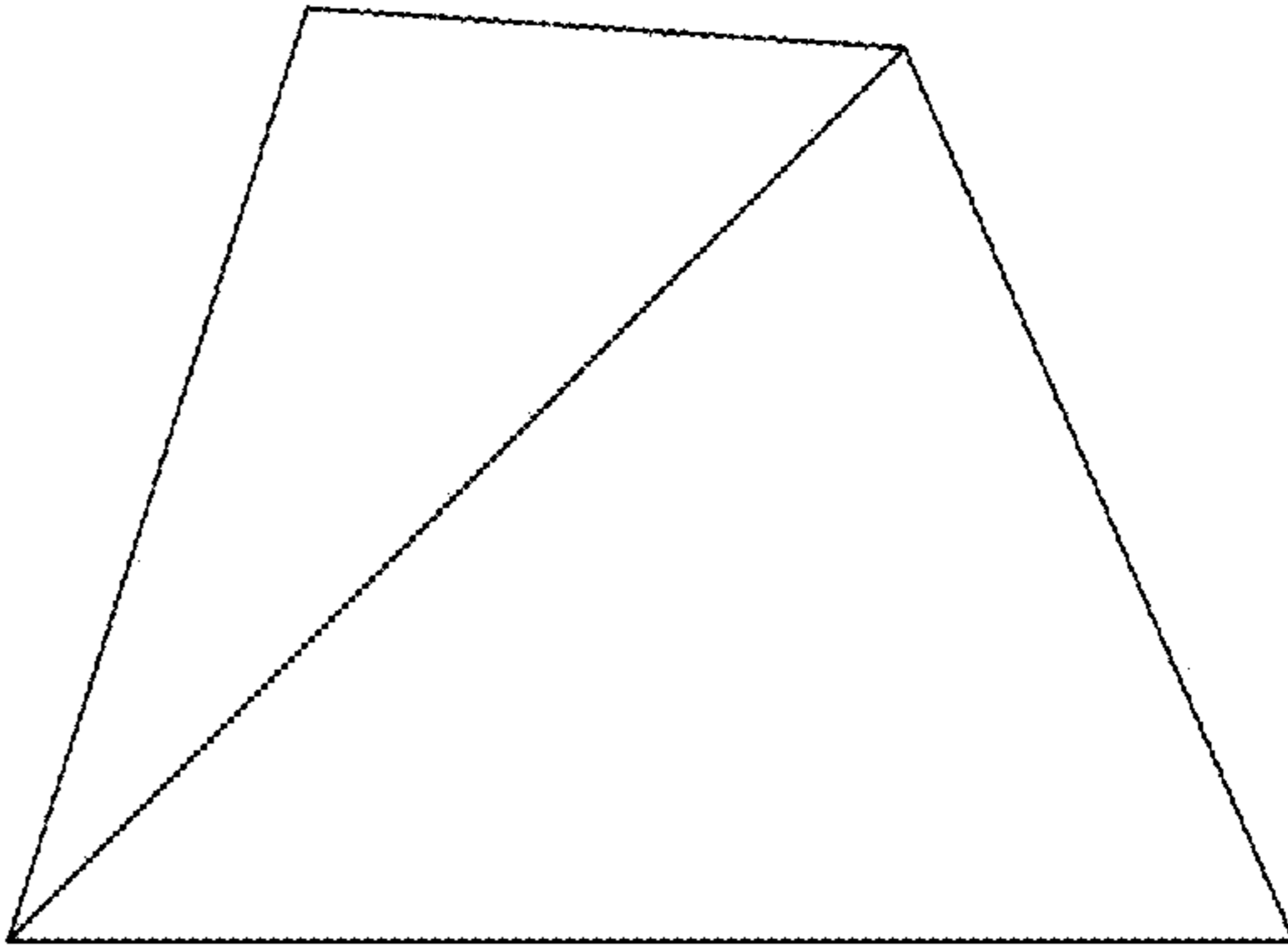

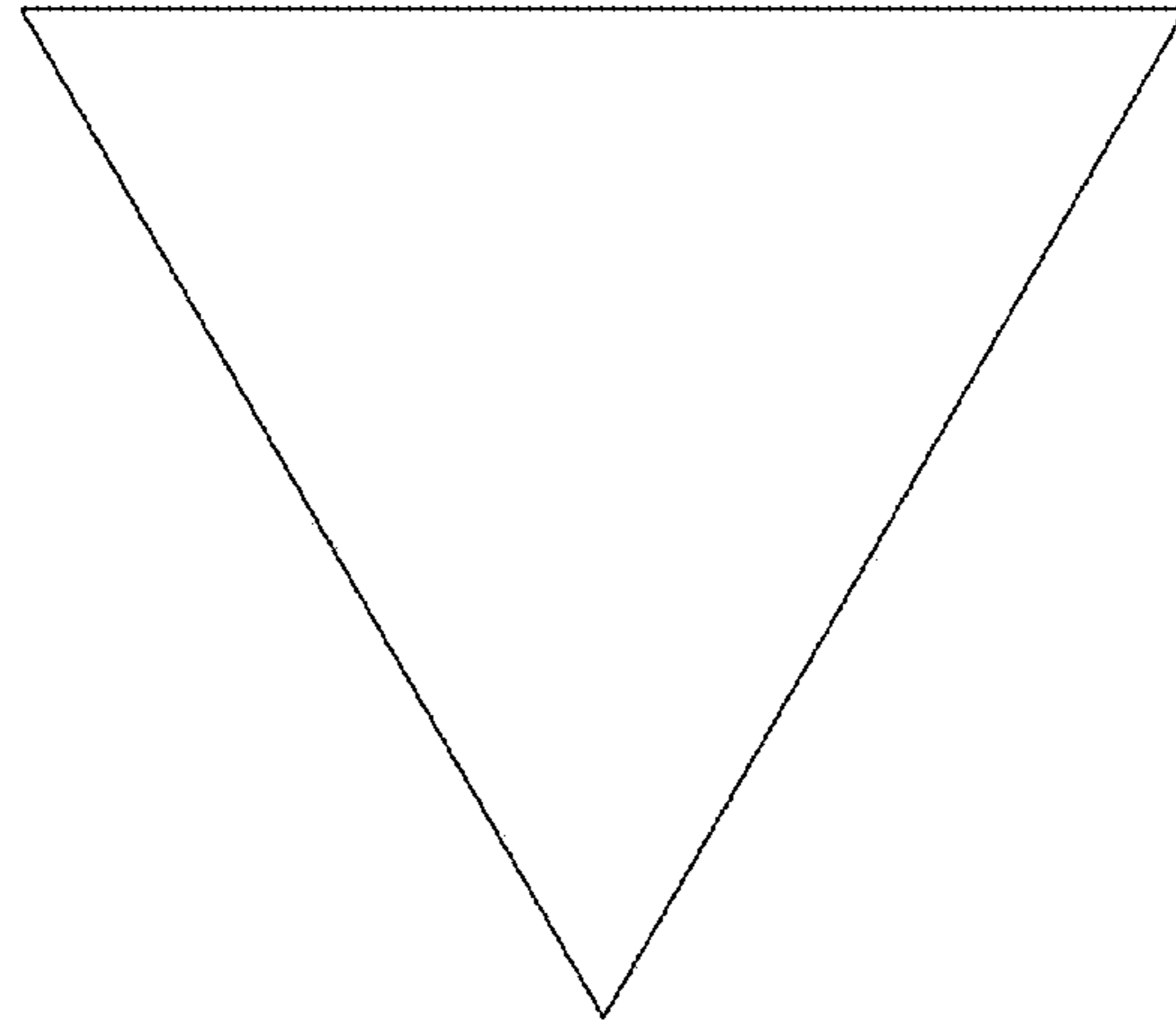

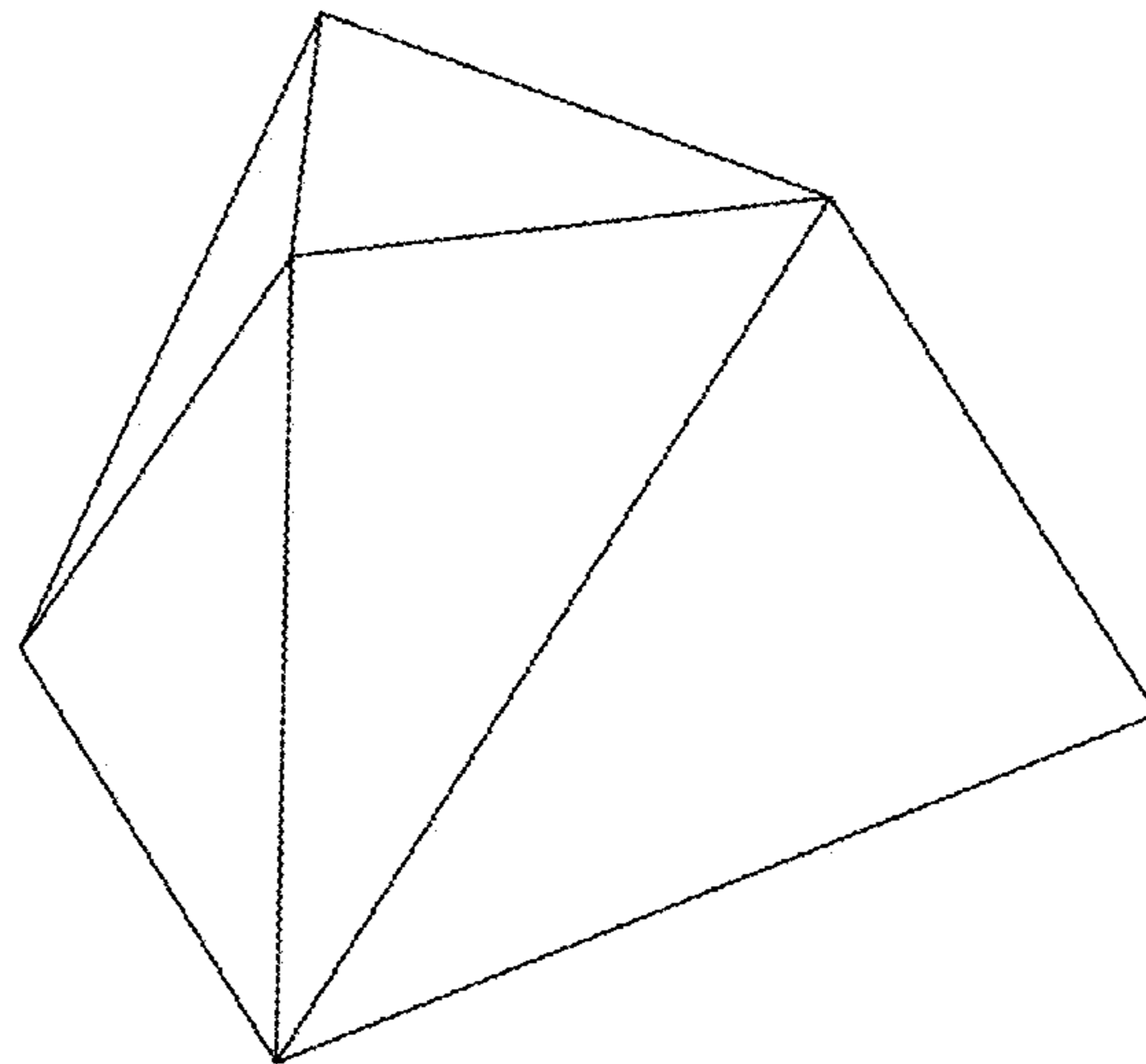
