(57) **CLAIM**

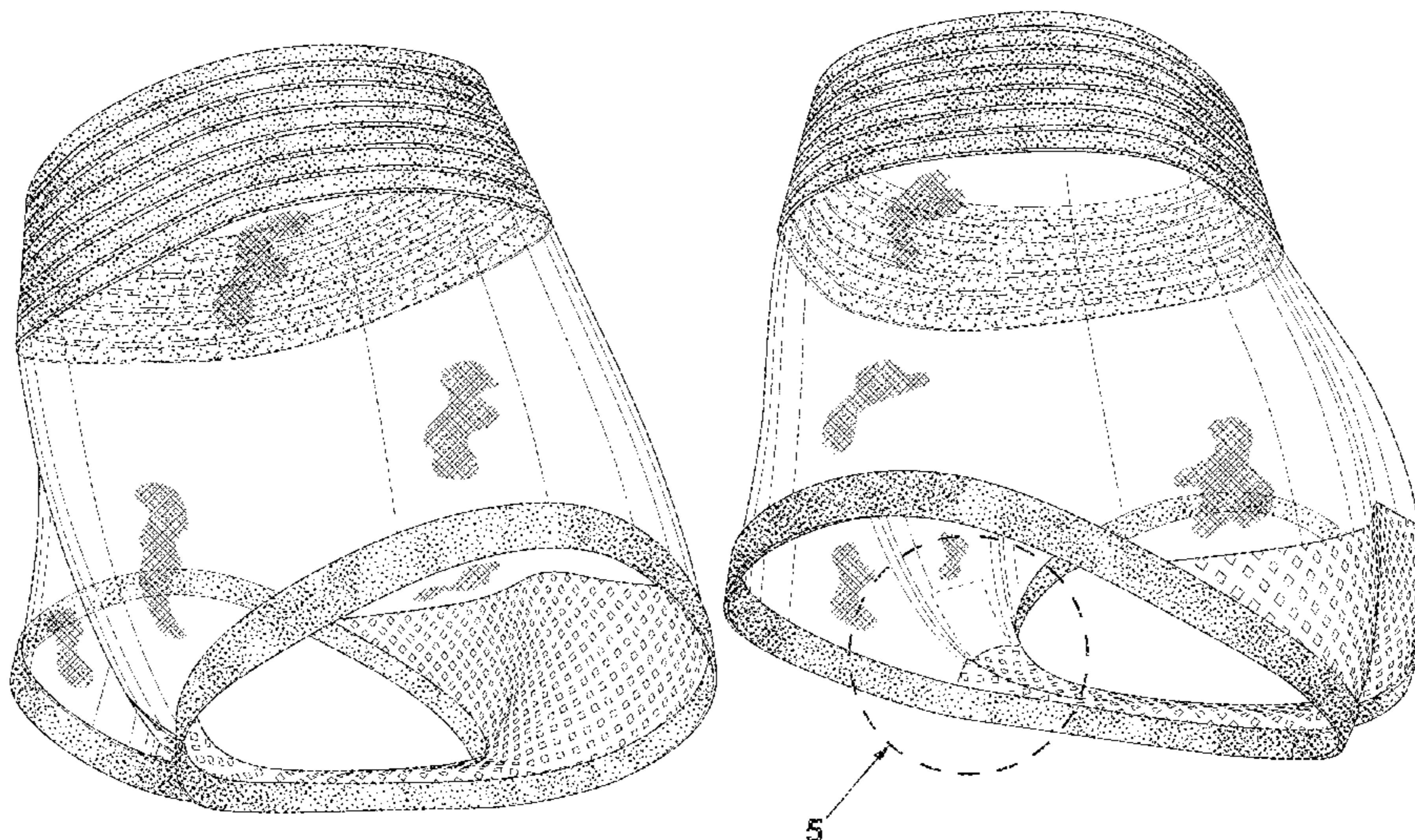
The ornamental design for a women's undergarment, as shown and described.

DESCRIPTION

FIG. 1 is a bottom front perspective view of a women's undergarment showing my new design; FIG. 2 is a bottom rear perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is an enlarged view of a portion of the women's undergarment encircled in FIG. 2; and, FIG. 6 is a perspective of the women's undergarment shown in a state of use.

The broken lines depict portions of the women's undergarment that form no part of the claimed design. The broken line showing of the hot/cold pack in FIGS. 2 and 5 and the broken line showing a user in FIG. 6 depict environmental structure and forms no part of the claimed design. The broken lines encircling portions of the women's undergarment in FIG. 2 and illustrated in enlarged views in FIG. 5 form no part of the claimed design.

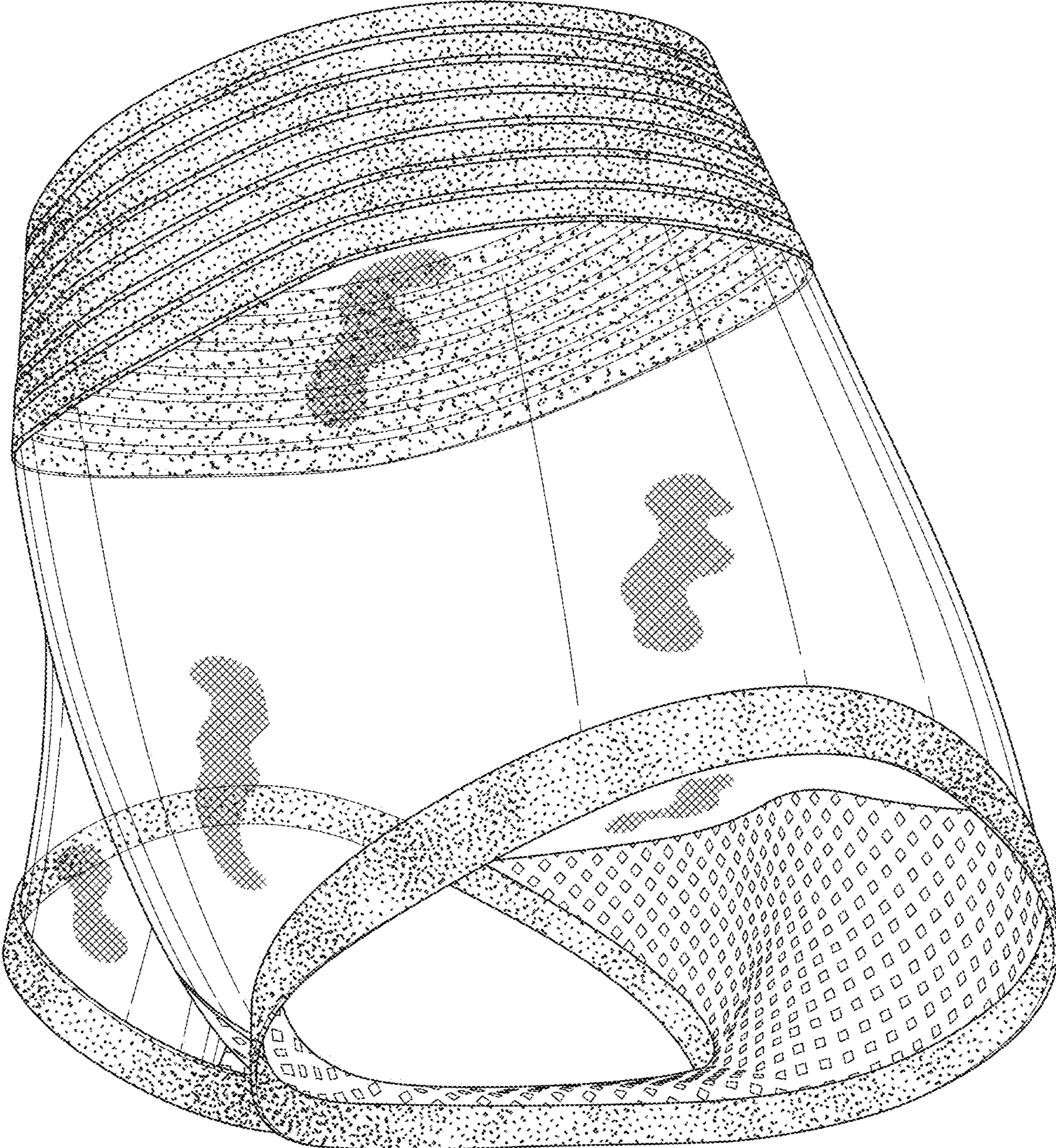

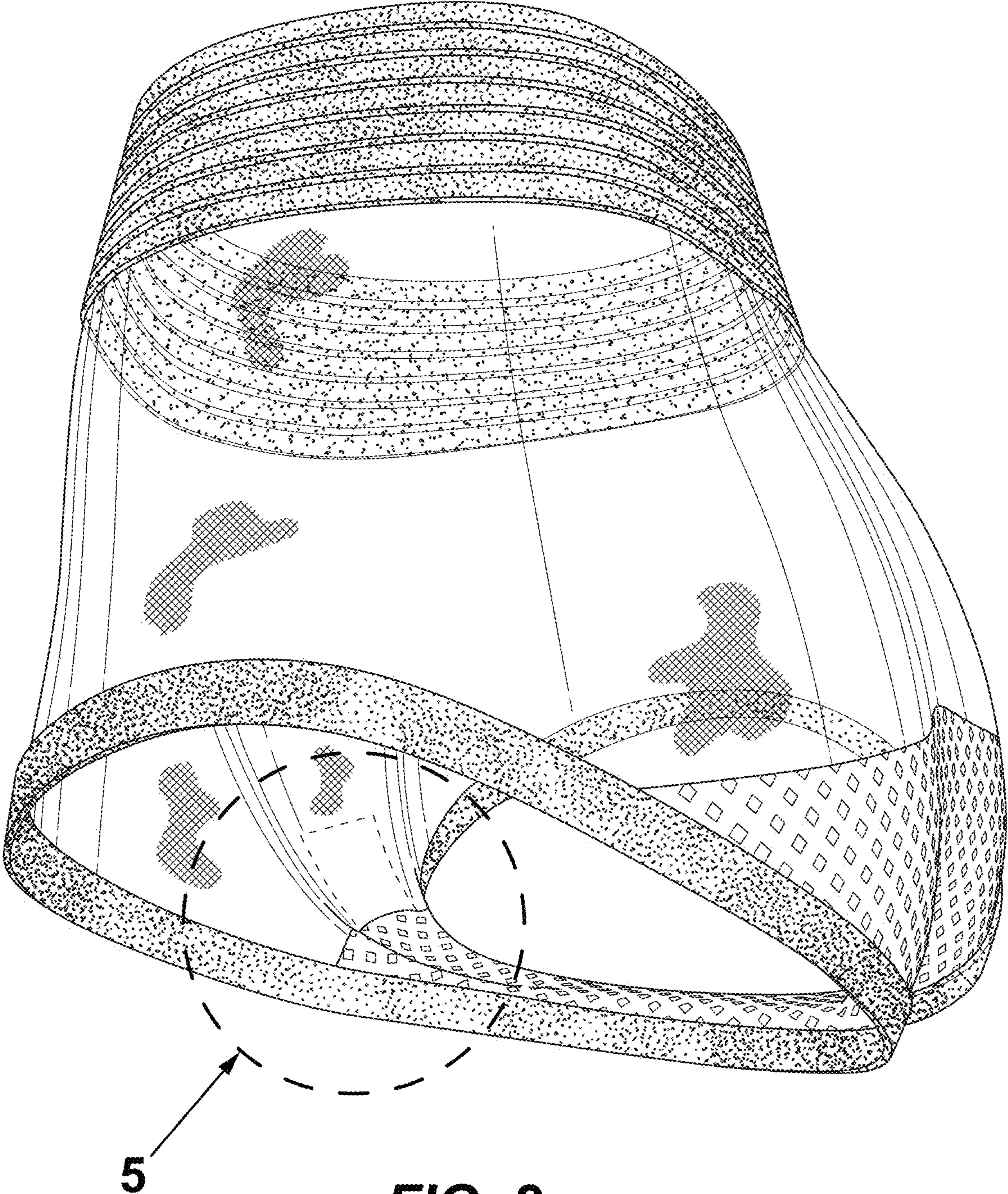

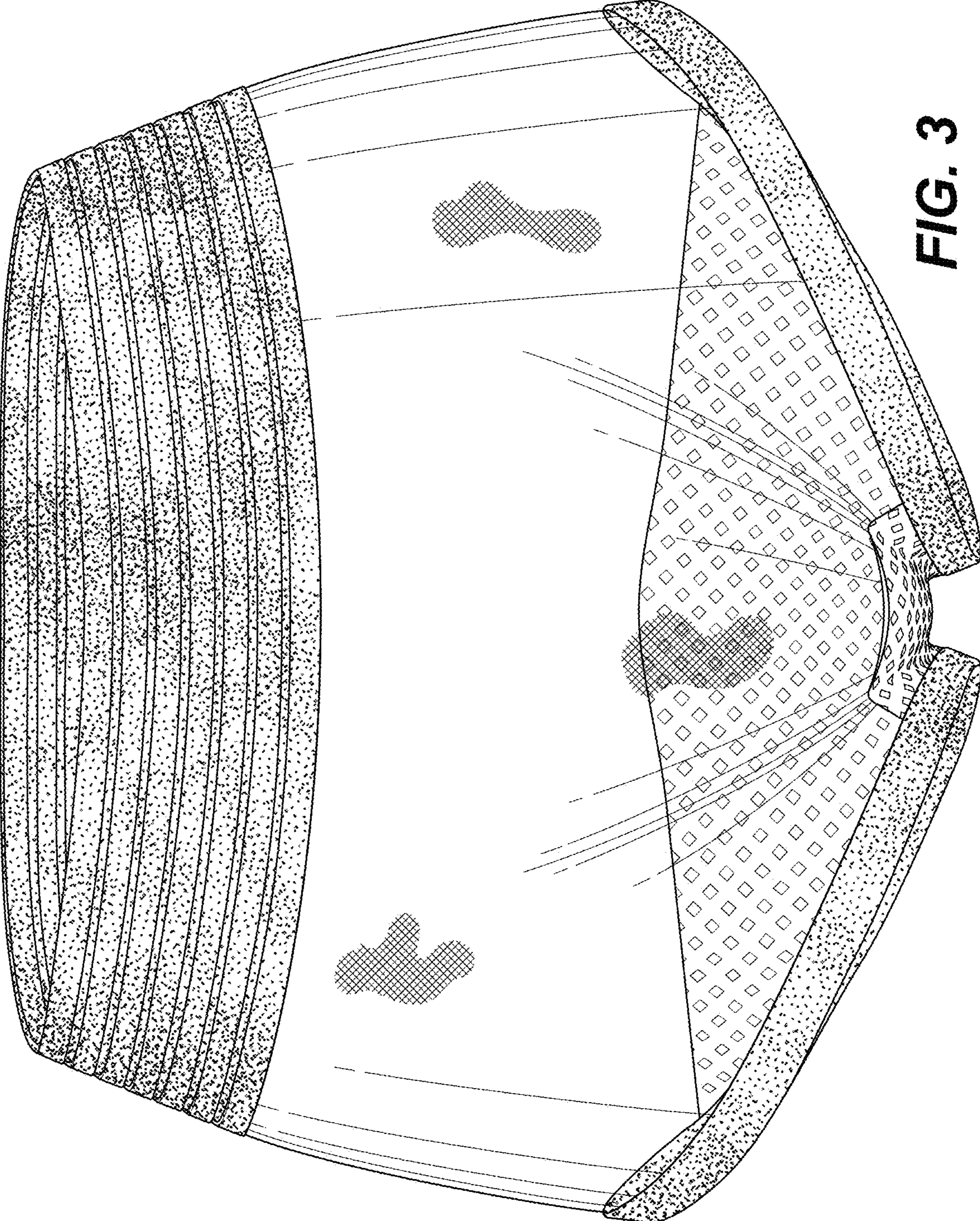

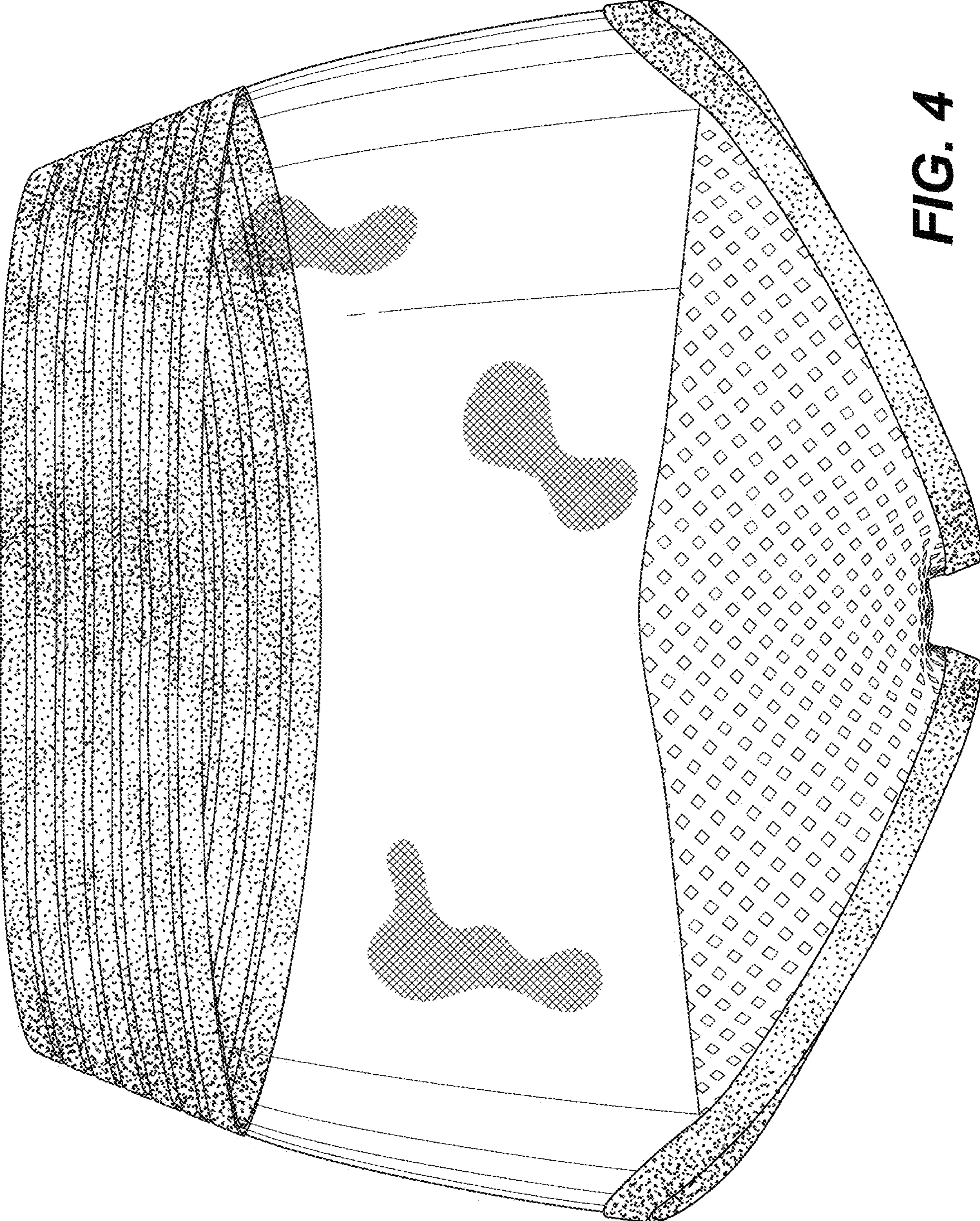

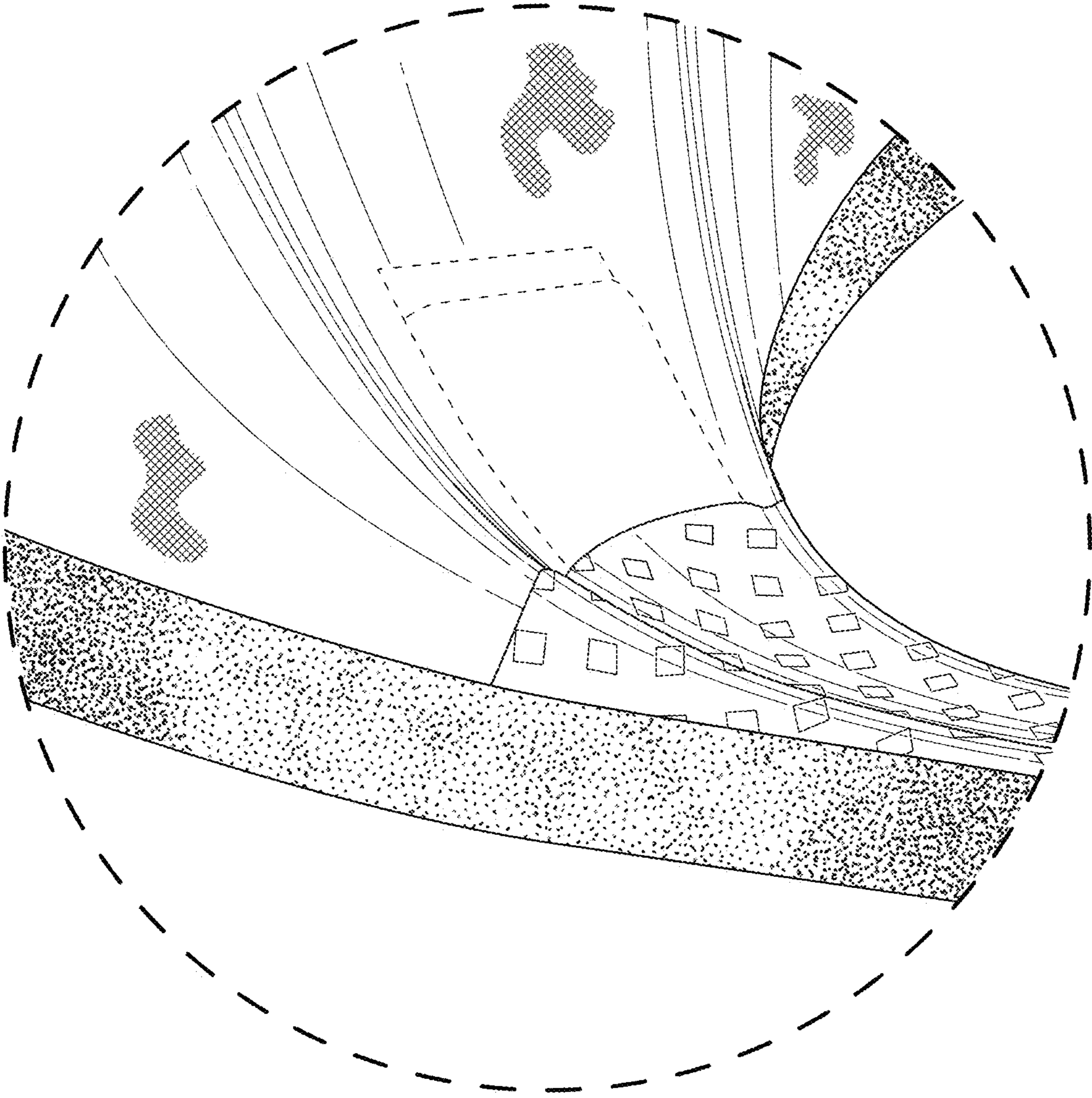

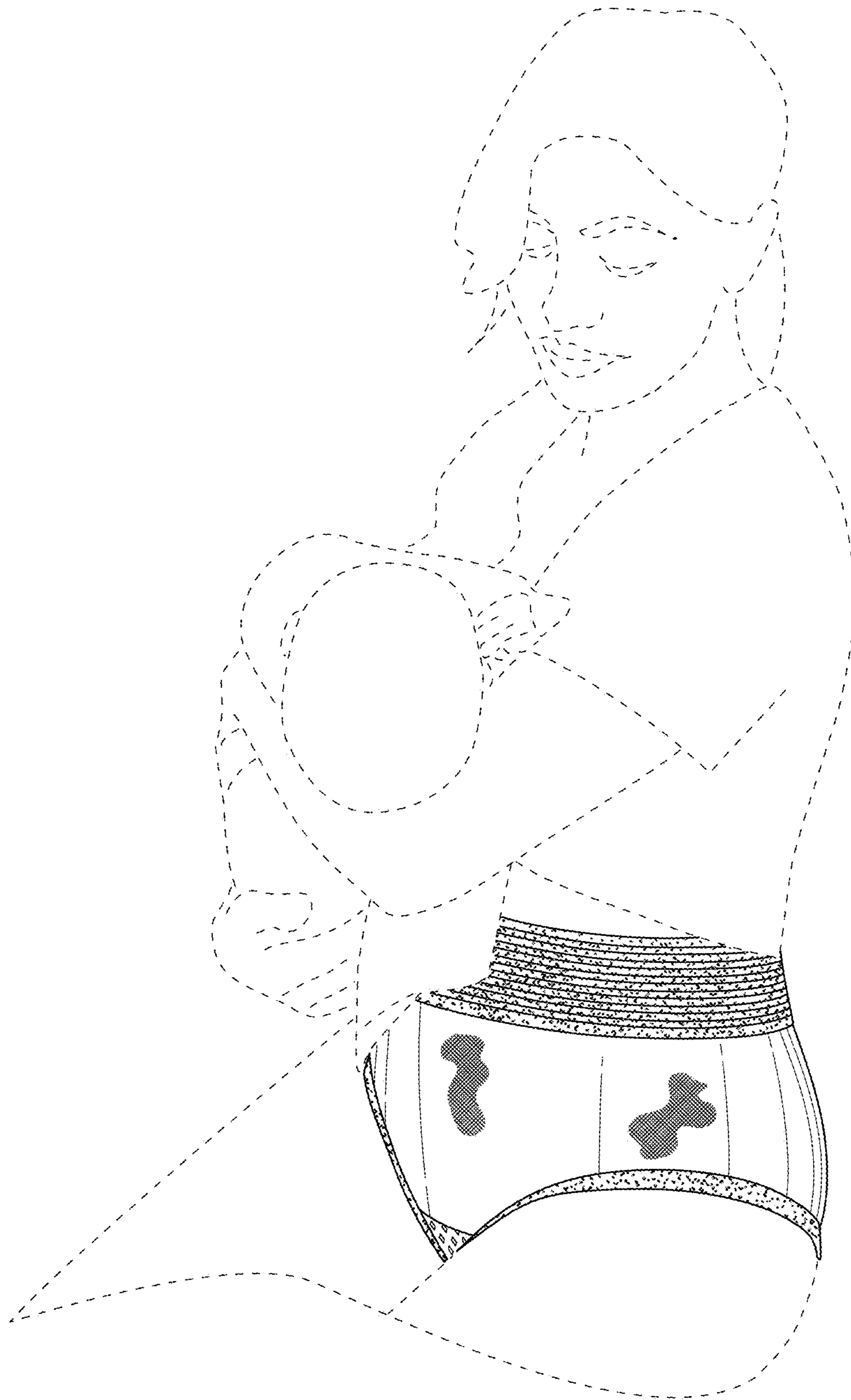
