(57) **CLAIM**

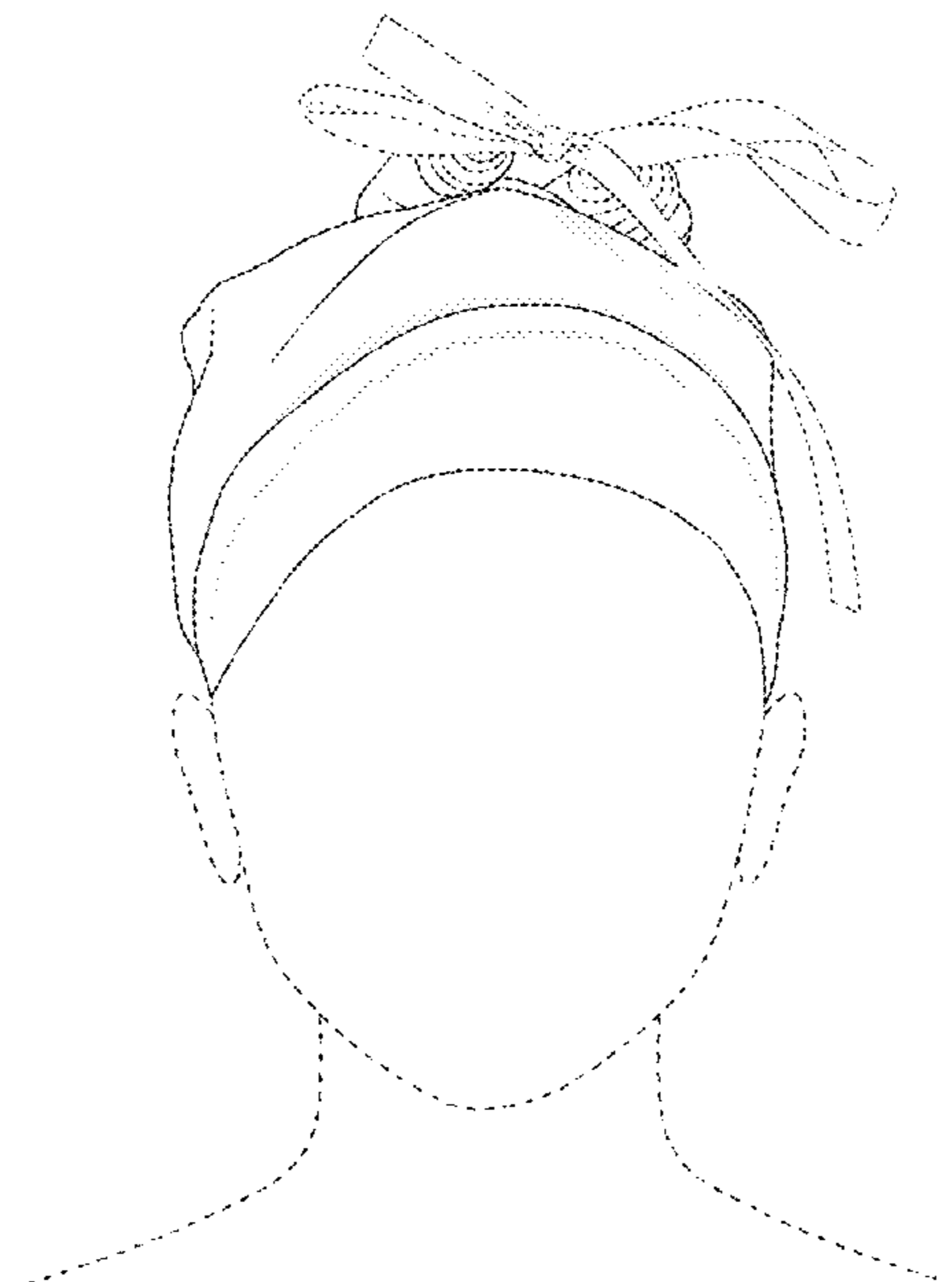
The ornamental design for a hair buff, as shown and described.

DESCRIPTION

- 1. Hair buff
- 1.1 : View of product in use on head-front
- 1.2 : View of product in use on head-back
- 1.3 : Front
- 1.4 : Back
- 1.5 : Left

Reproductions **1.1** and **1.2** are special views, showing the product in use, placed over the hair/head; the parts shown by means of broken lines in reproductions **1.1** (front view on head) and **1.2** (back view on head) are not part of the claimed design, whereas in reproductions **1.3** (front view), **1.4** (back view) and **1.5** (side view) the dotted lines along the top of the design indicate stitching and do form part of the claimed design; the shading and the radial thin lines in the reproductions represent contours and creases only and do not illustrate ornamentation or decoration on the surface of the product; both side views are identical, and accordingly one side view is omitted.

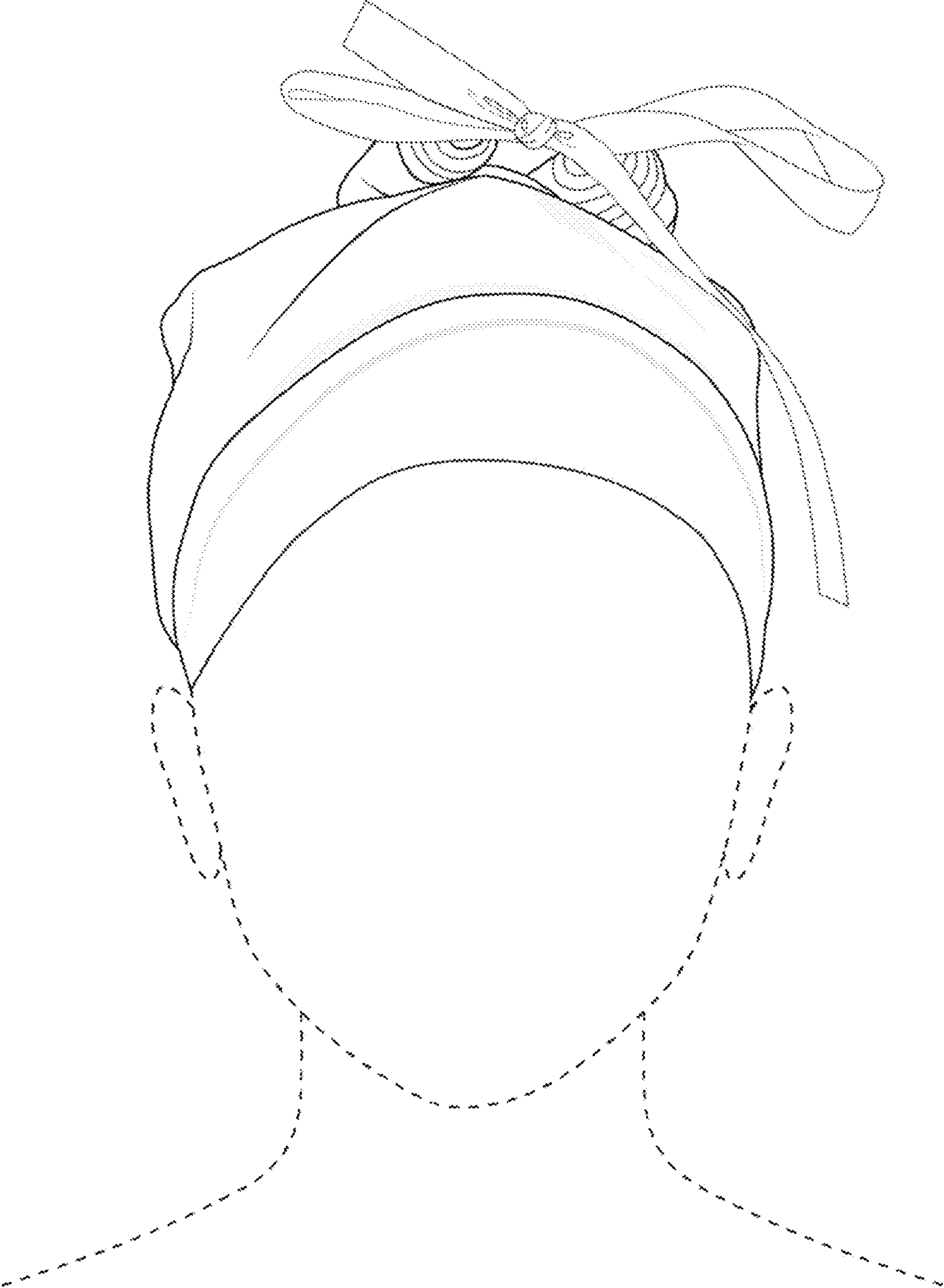

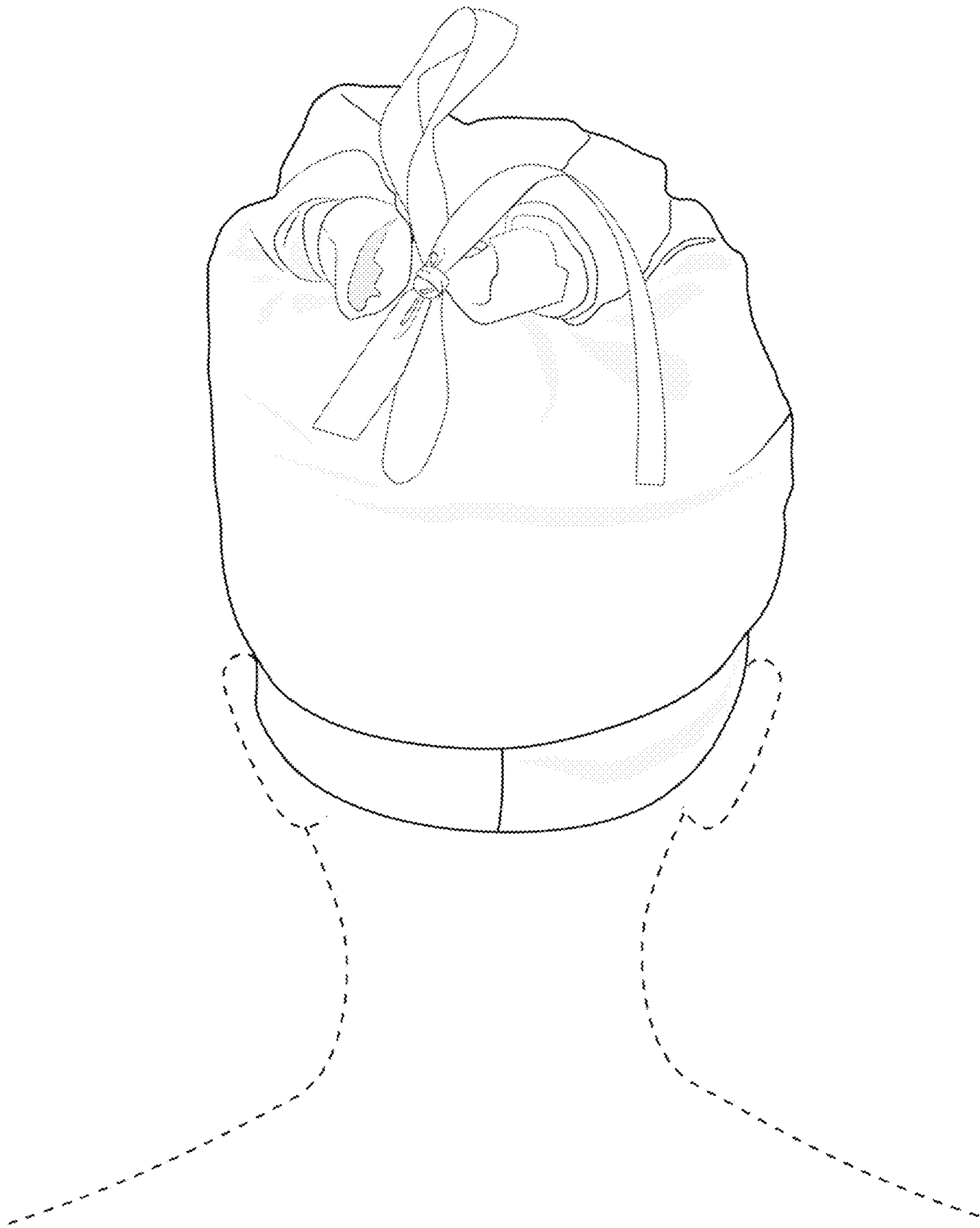

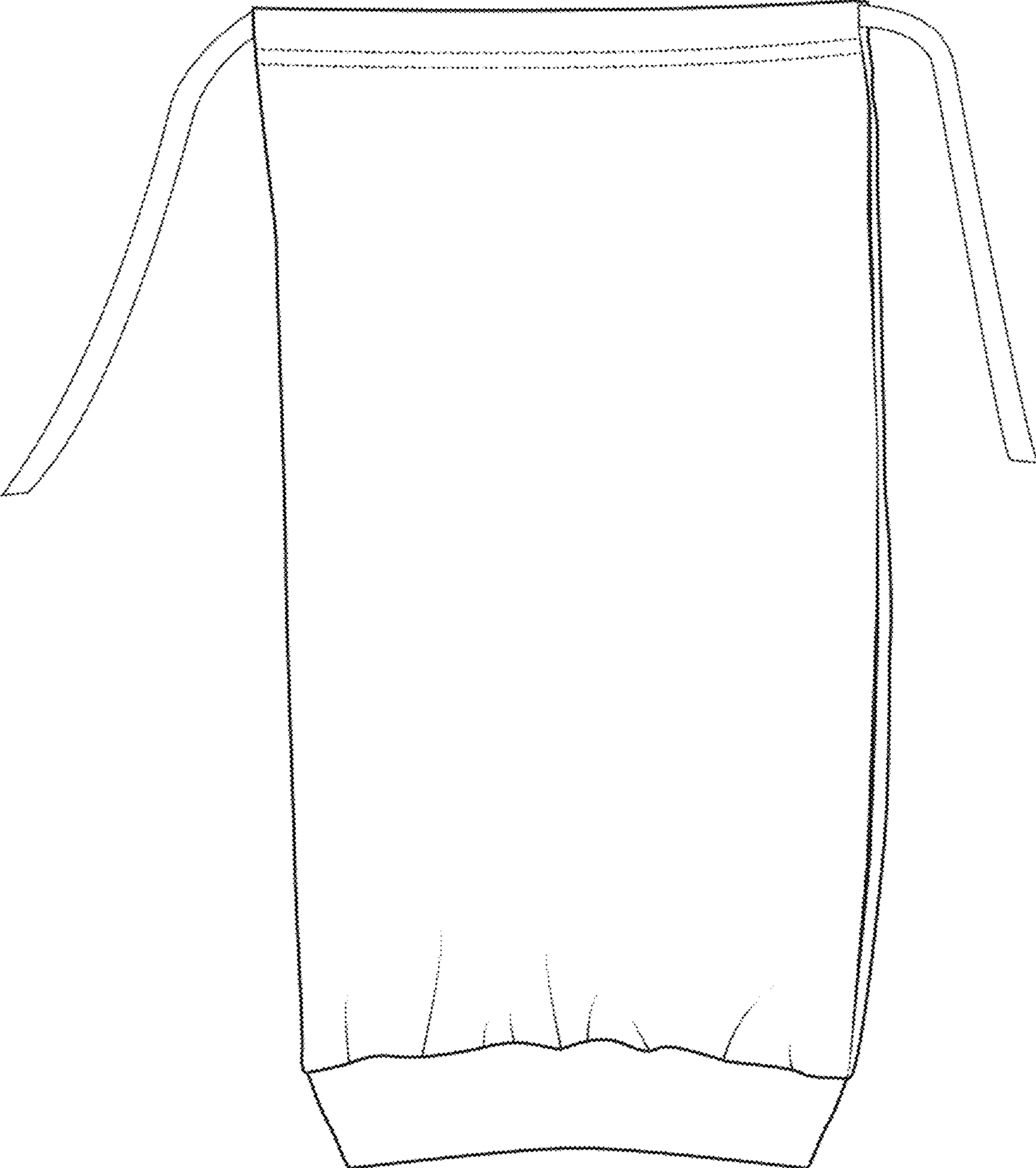

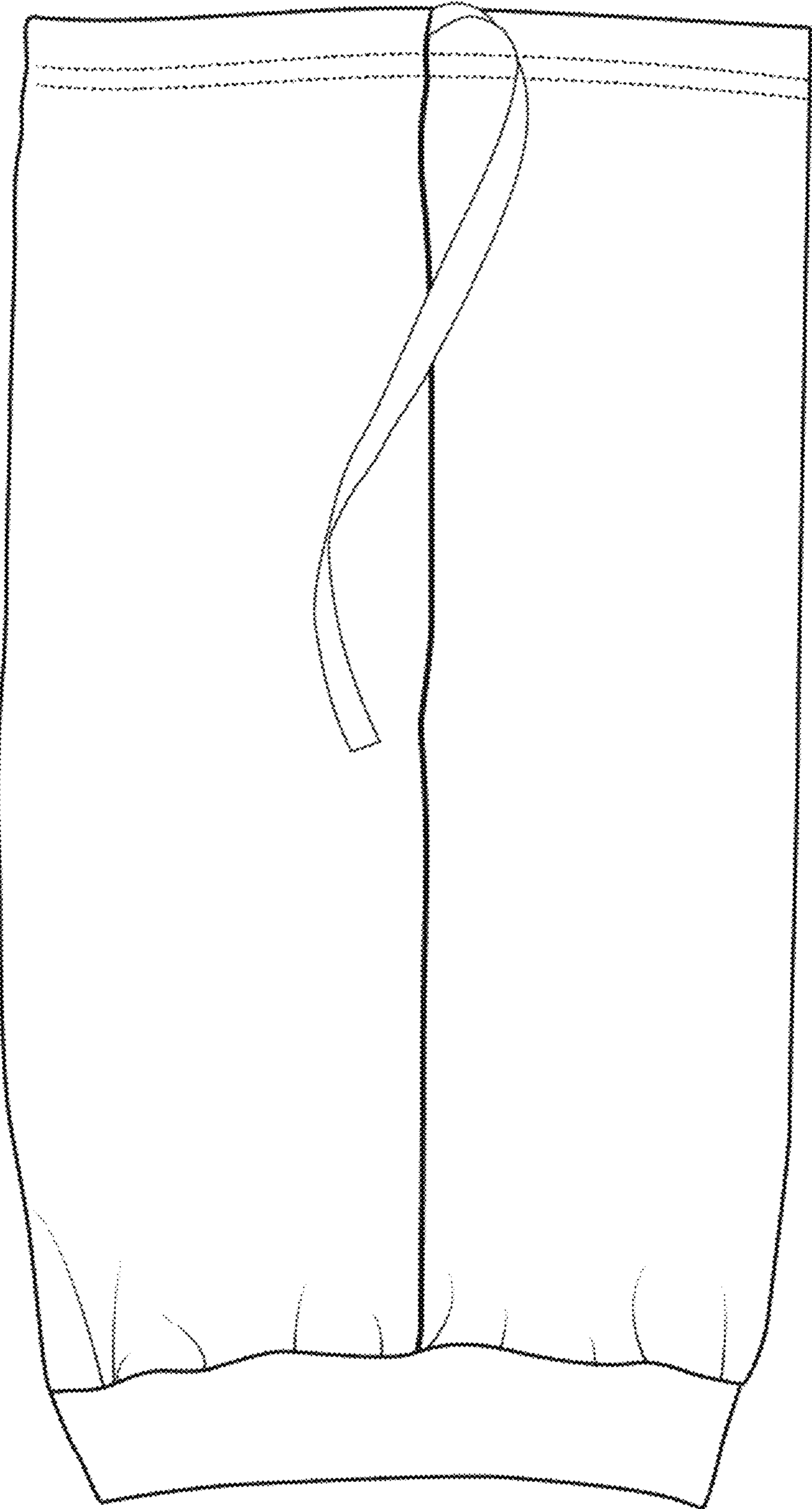
